## [57] CLAIM

The ornamental design for a combined sandbox and bench, as shown and described.

## DESCRIPTION

FIG. 1 is a top and rear perspective view of a combined sandbox and bench showing our new design; FIG. 2 is a top and front perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a sectional elevational view thereof taken along line 7—7 of FIG. 3. FIGS. 3-7 inclusive are shown in an enlarged scale for clarity of illustration.

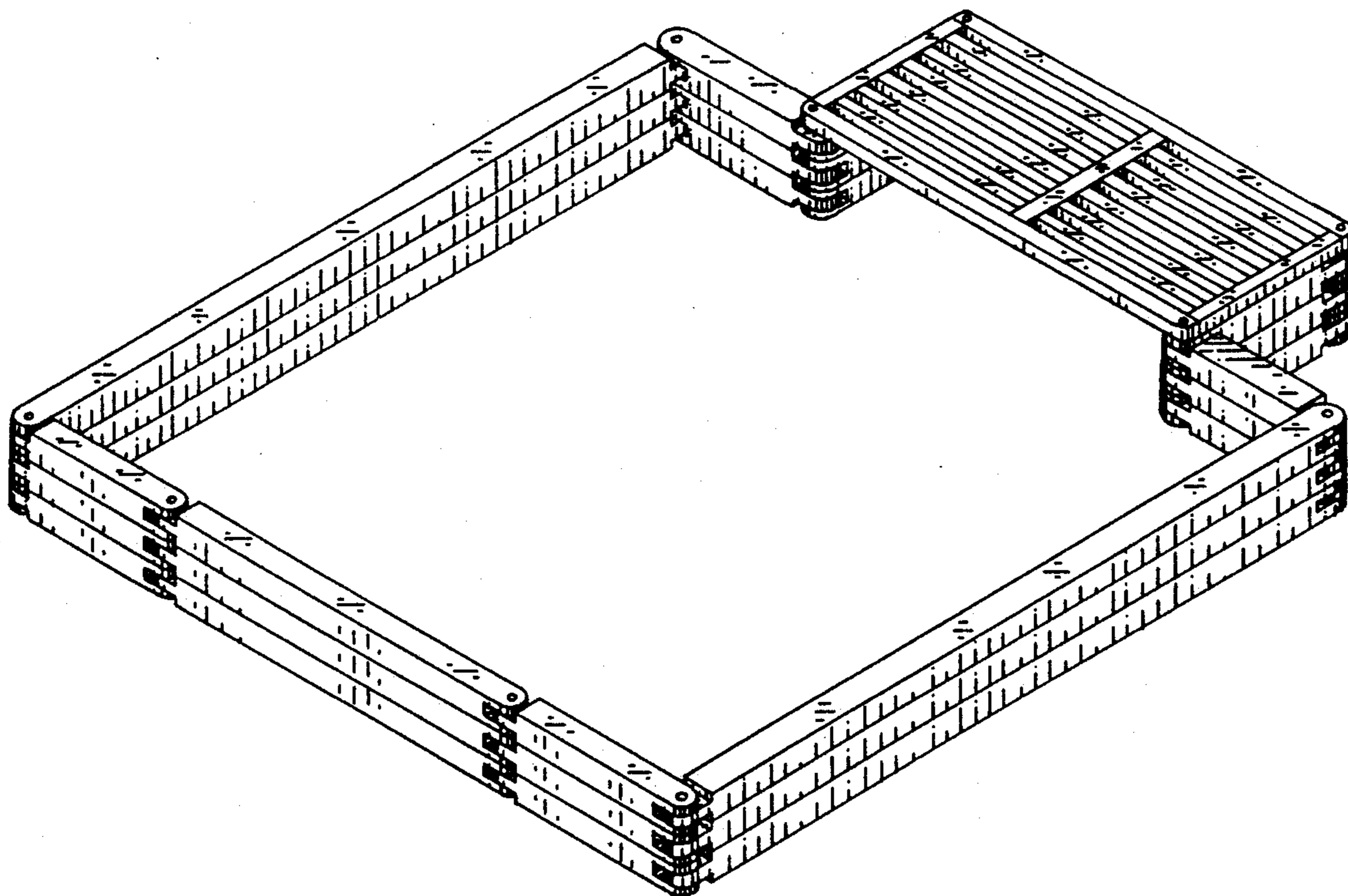

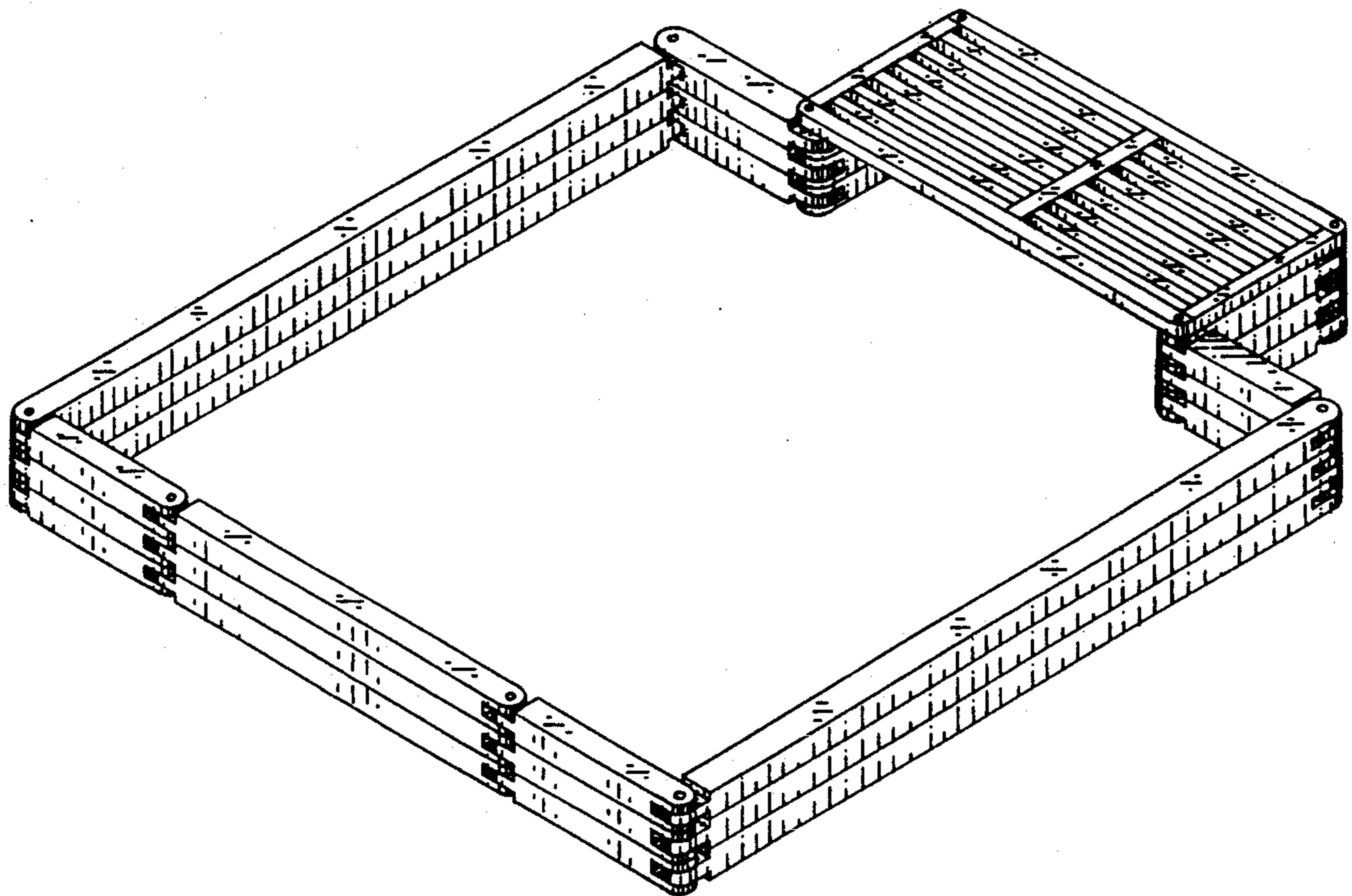

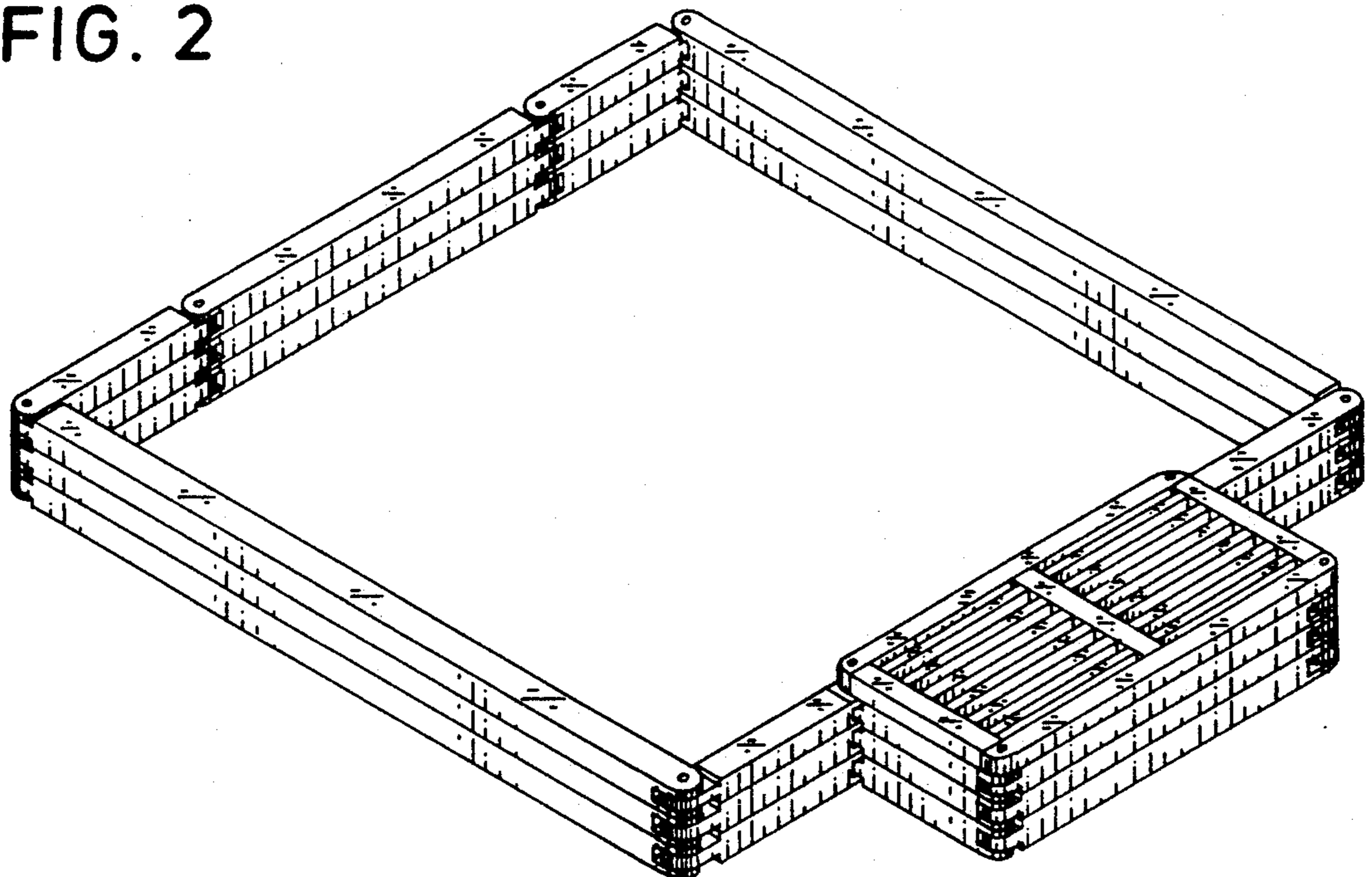

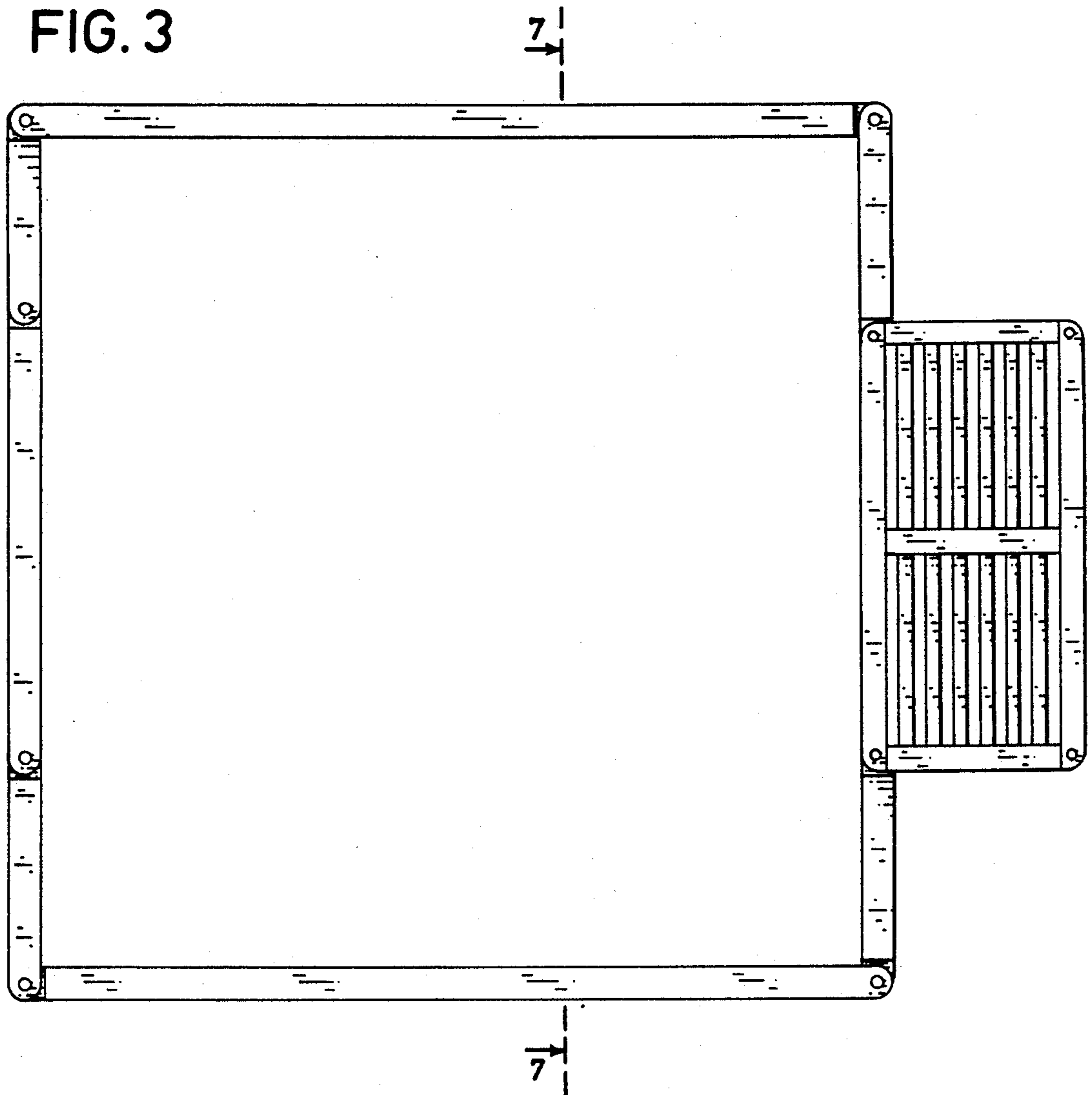

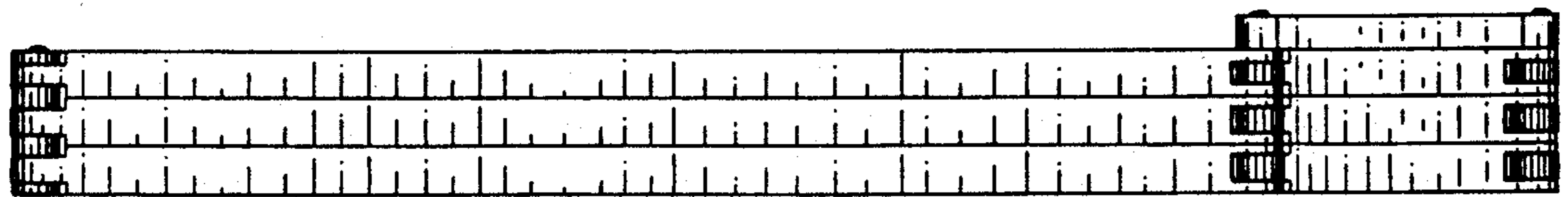

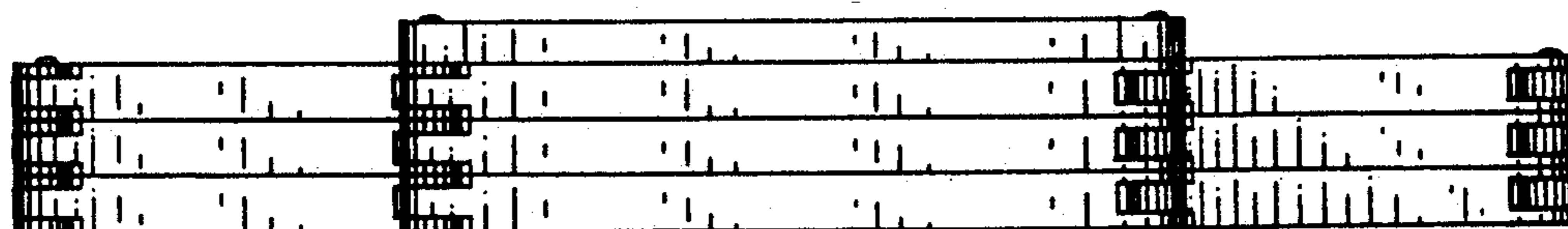

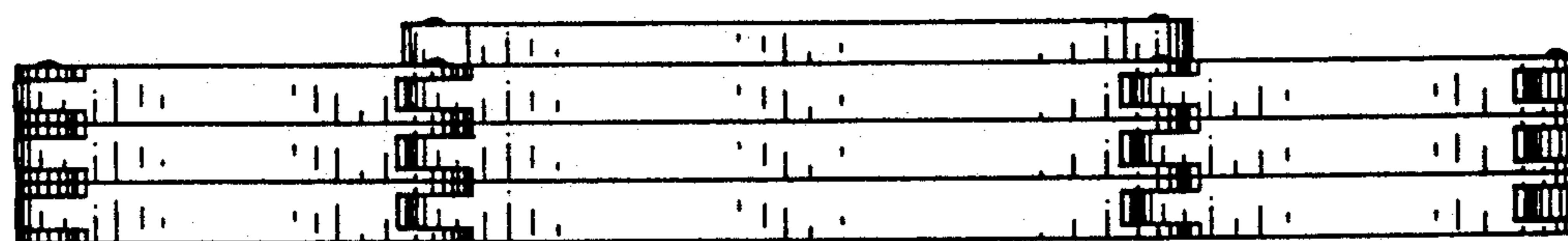
