FIG. 1 is a top plan view of a garment stand showing my new design;

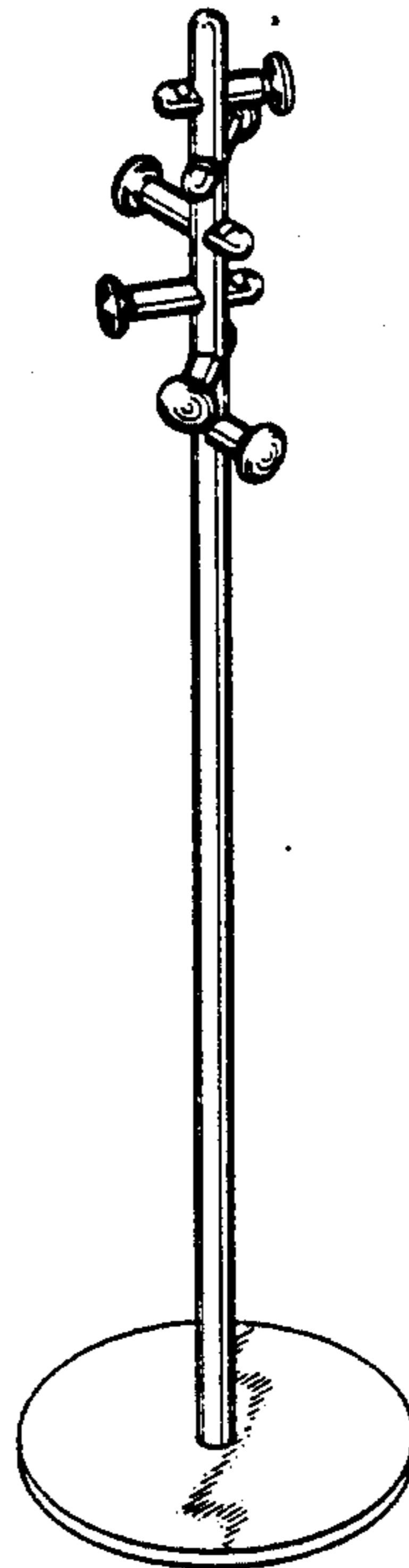
FIG. 2 is a bottom plan view;

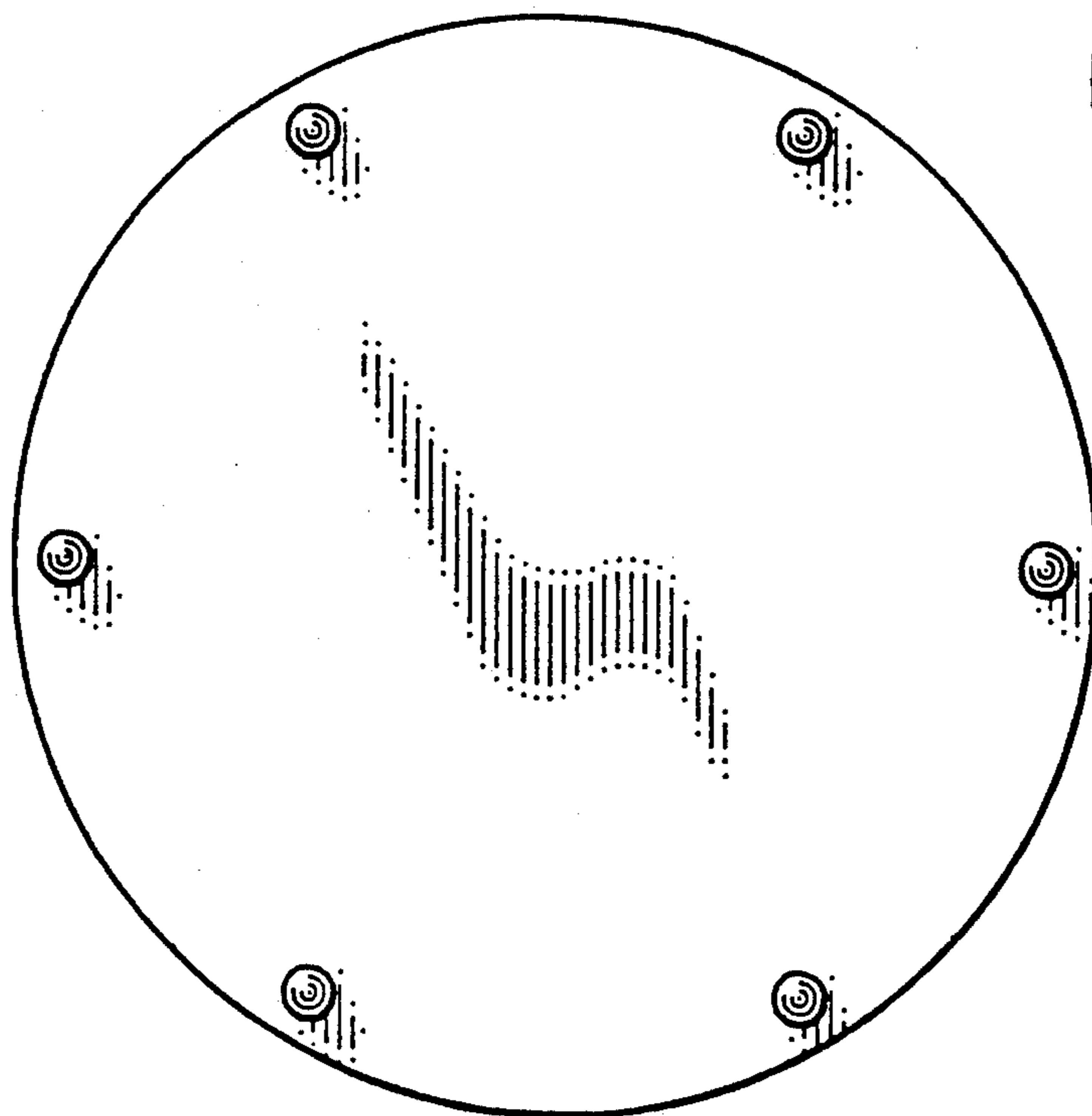
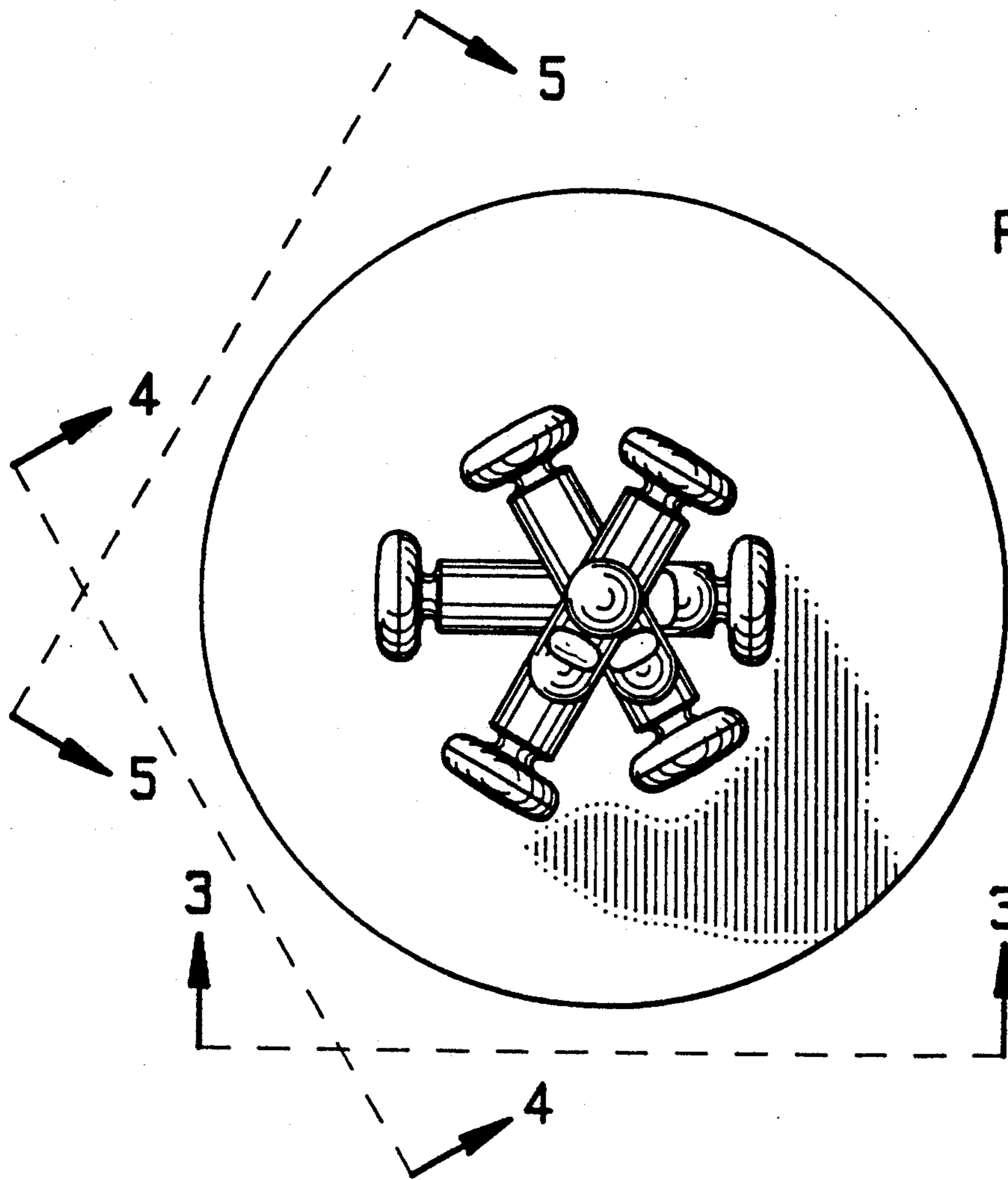
FIG. 3 is a side elevational view taken at section line 3-3 of FIG. 1;

FIG. 6 is a perspective view thereof.





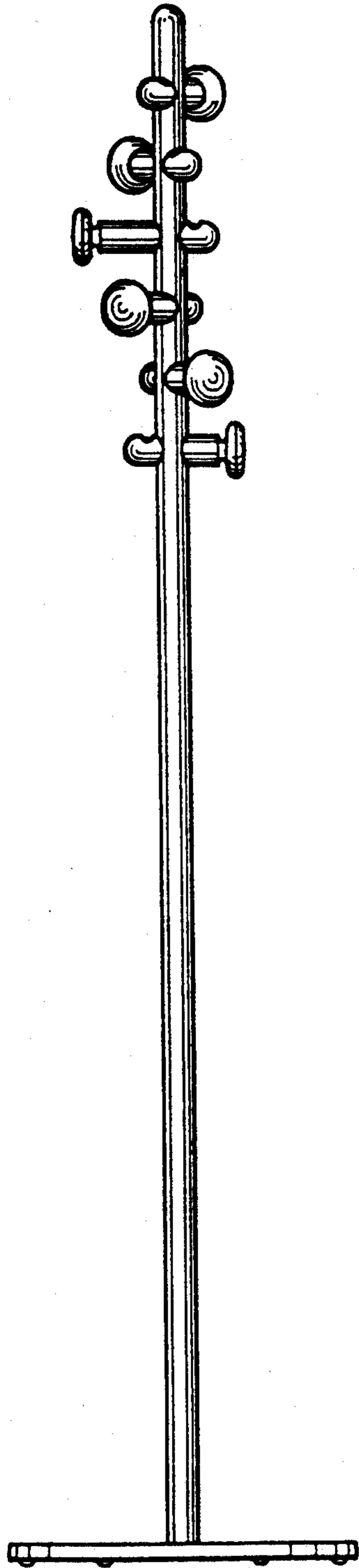

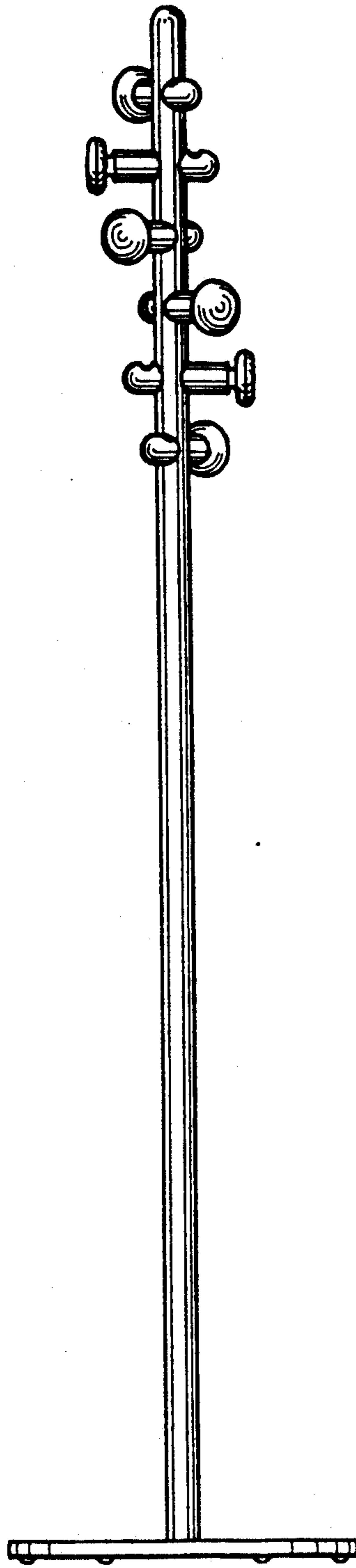

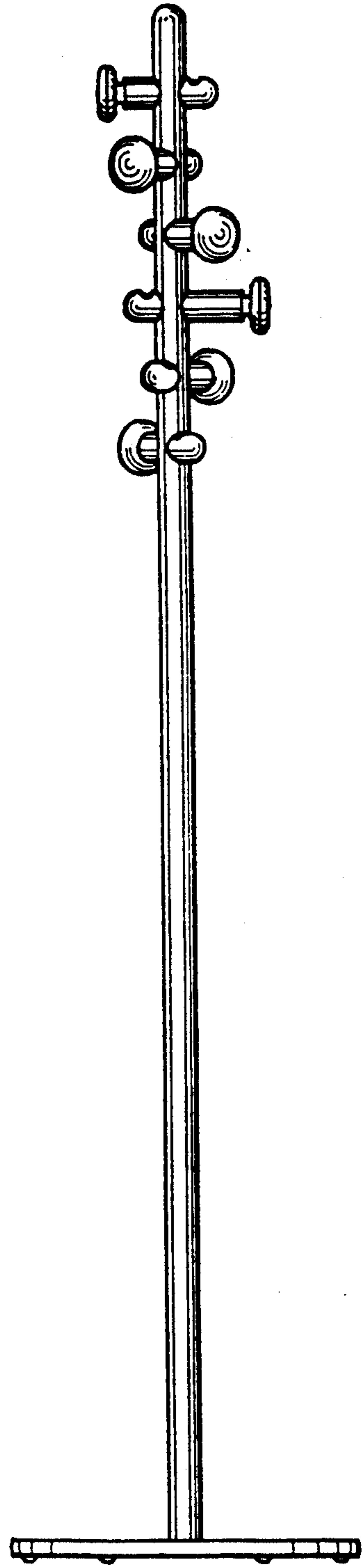

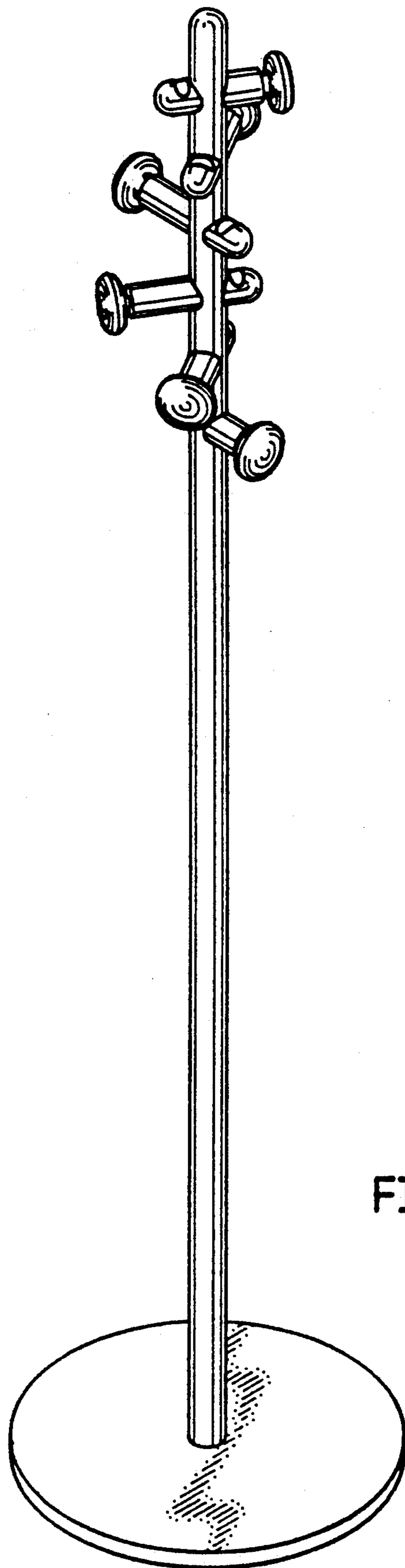
