The ornamental design for a portable computer housing, as shown and described.

## DESCRIPTION

FIG. 1 is a right front and top perspective view of the portable computer housing with the cover in the opened position;

FIG. 12 is a rear elevational view thereof;

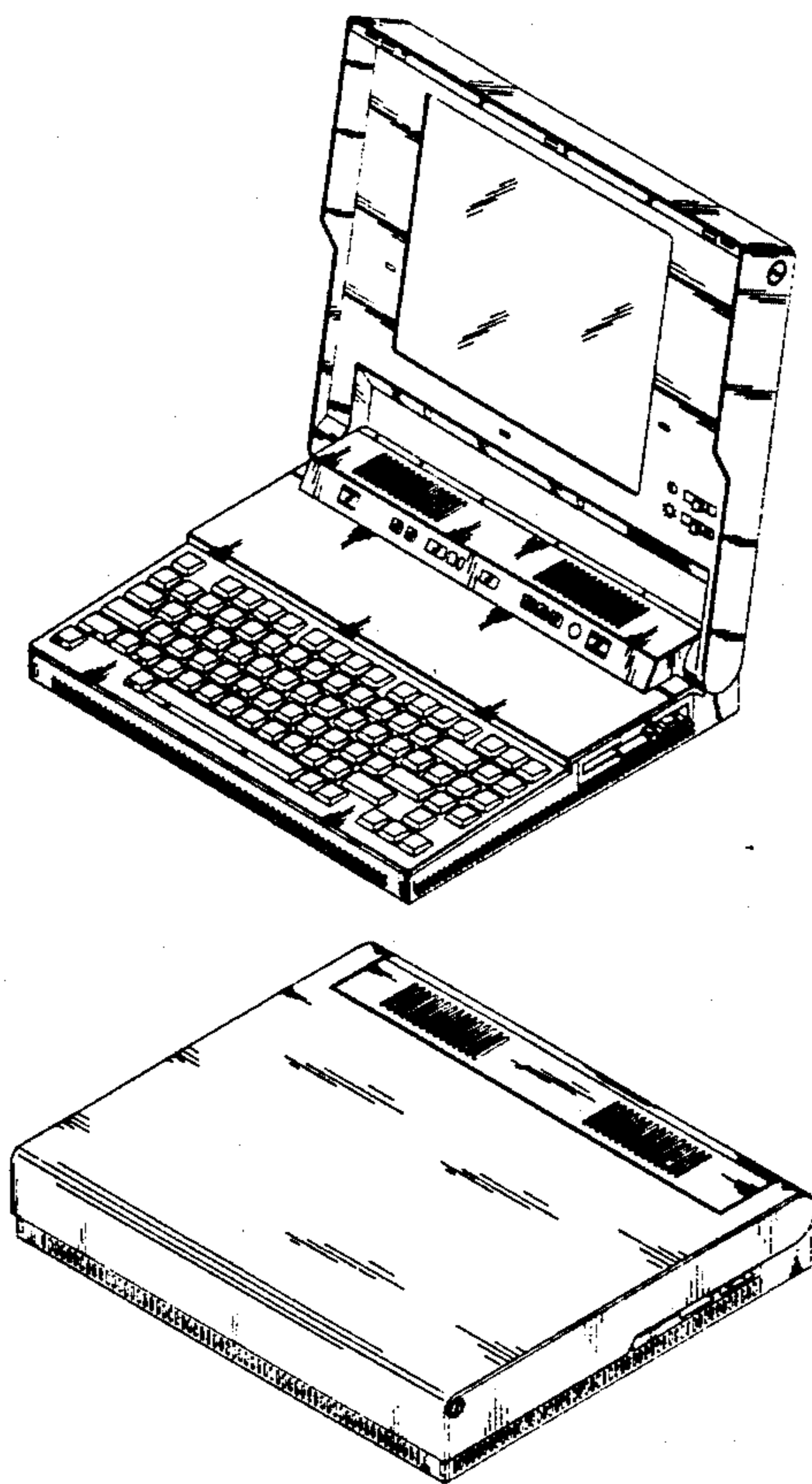
FIG. 13 is a right side elevational view thereof;

FIGS. 1 and 2 are drawn on a reduced scale.



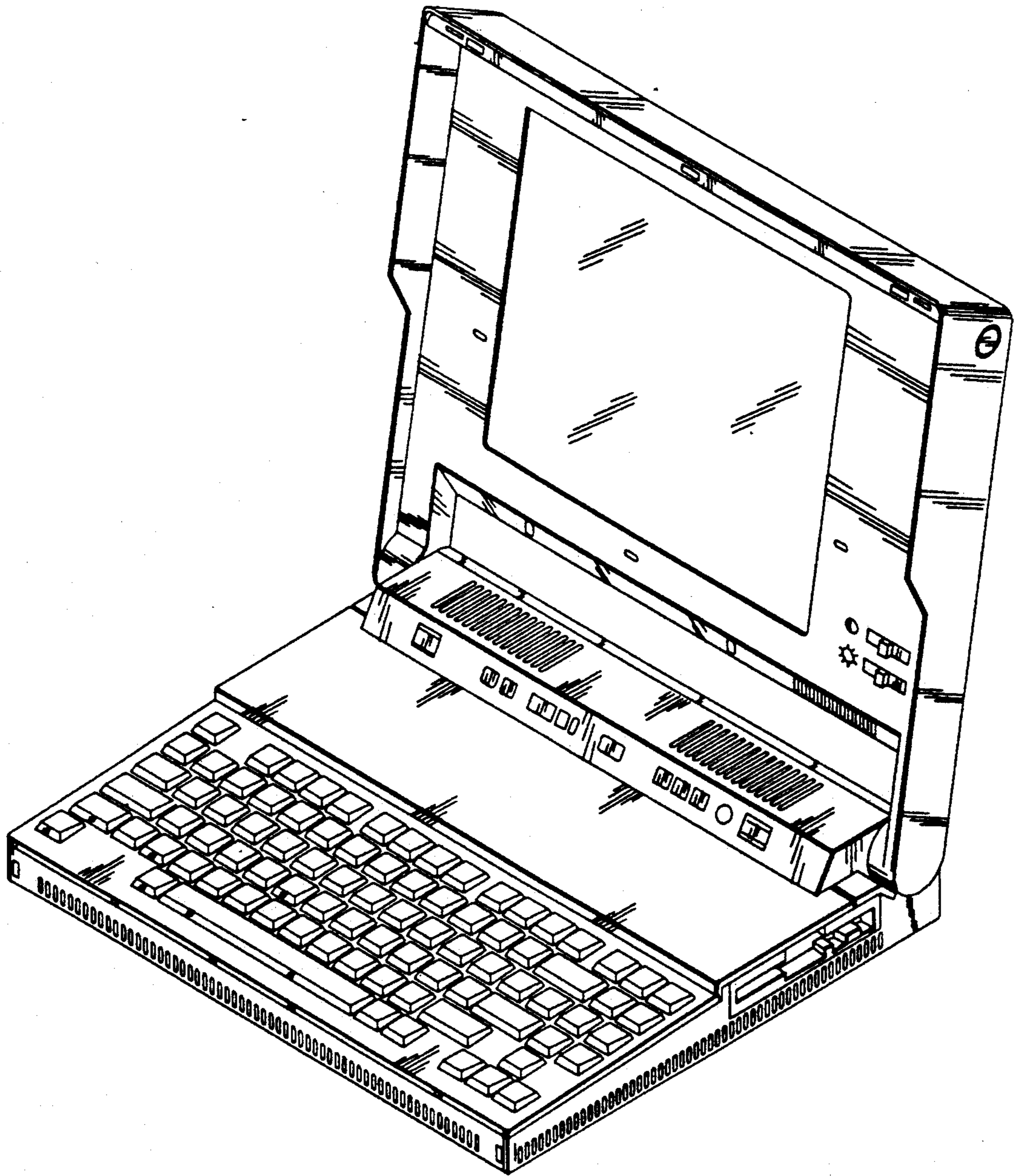

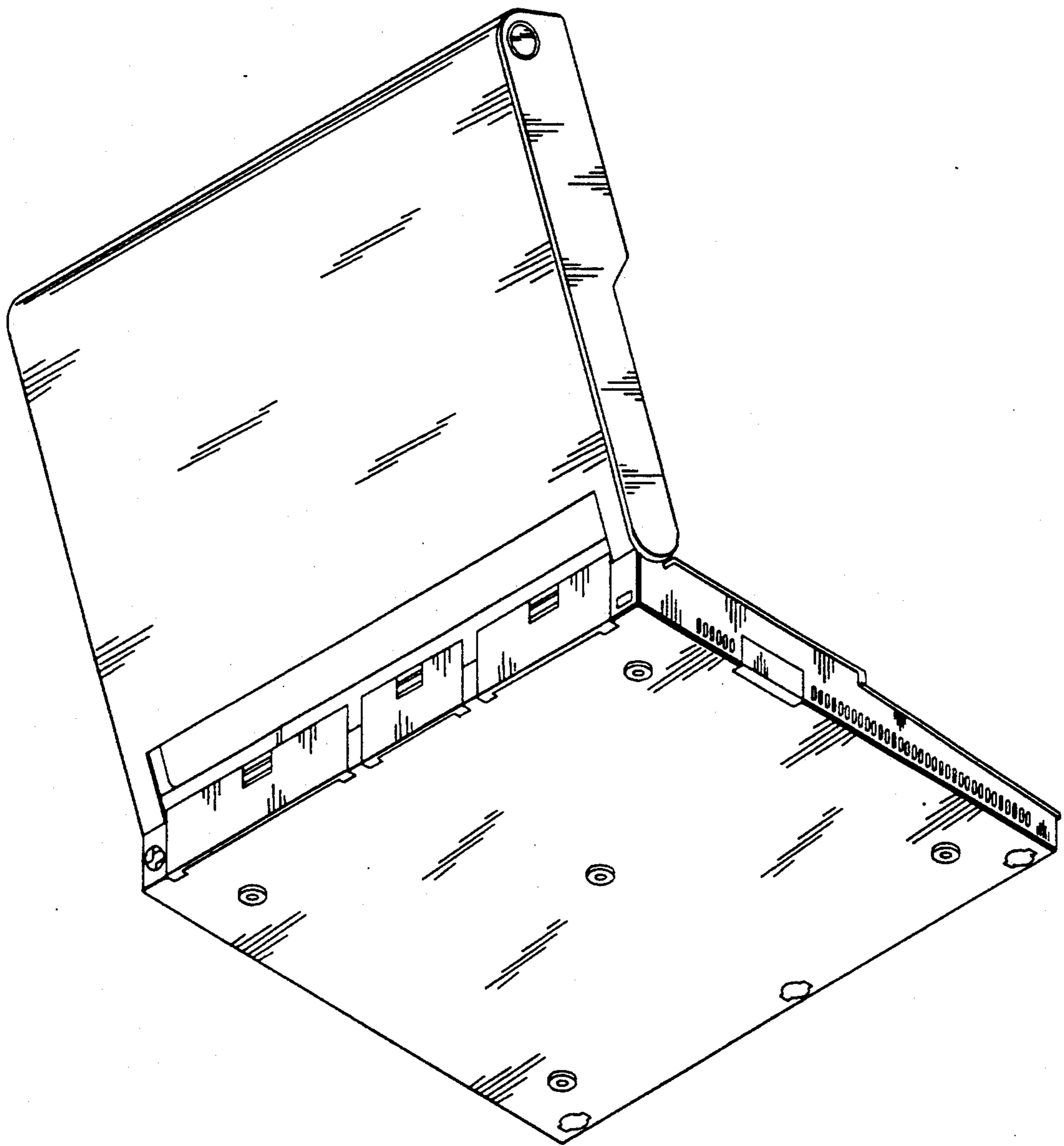

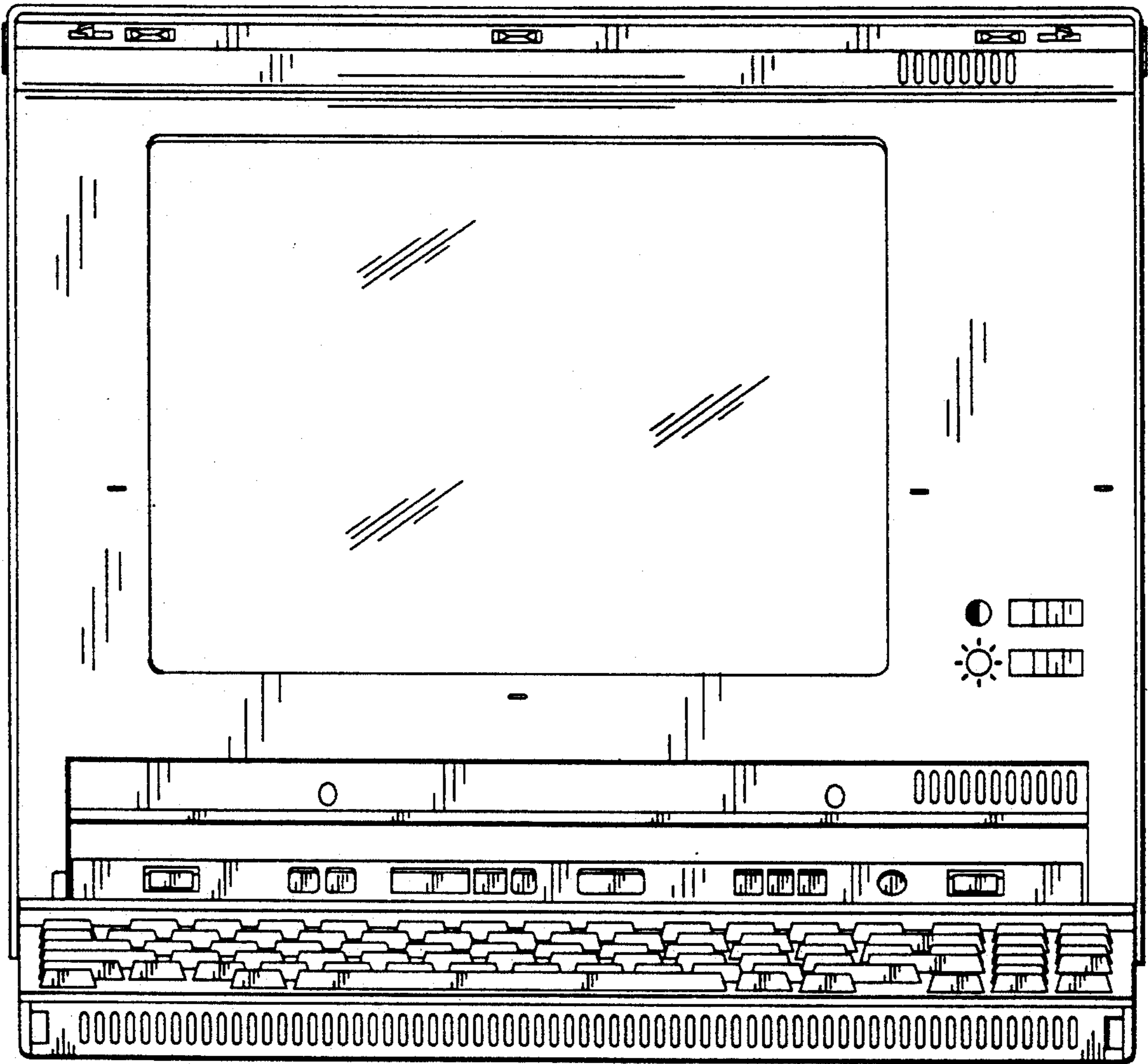

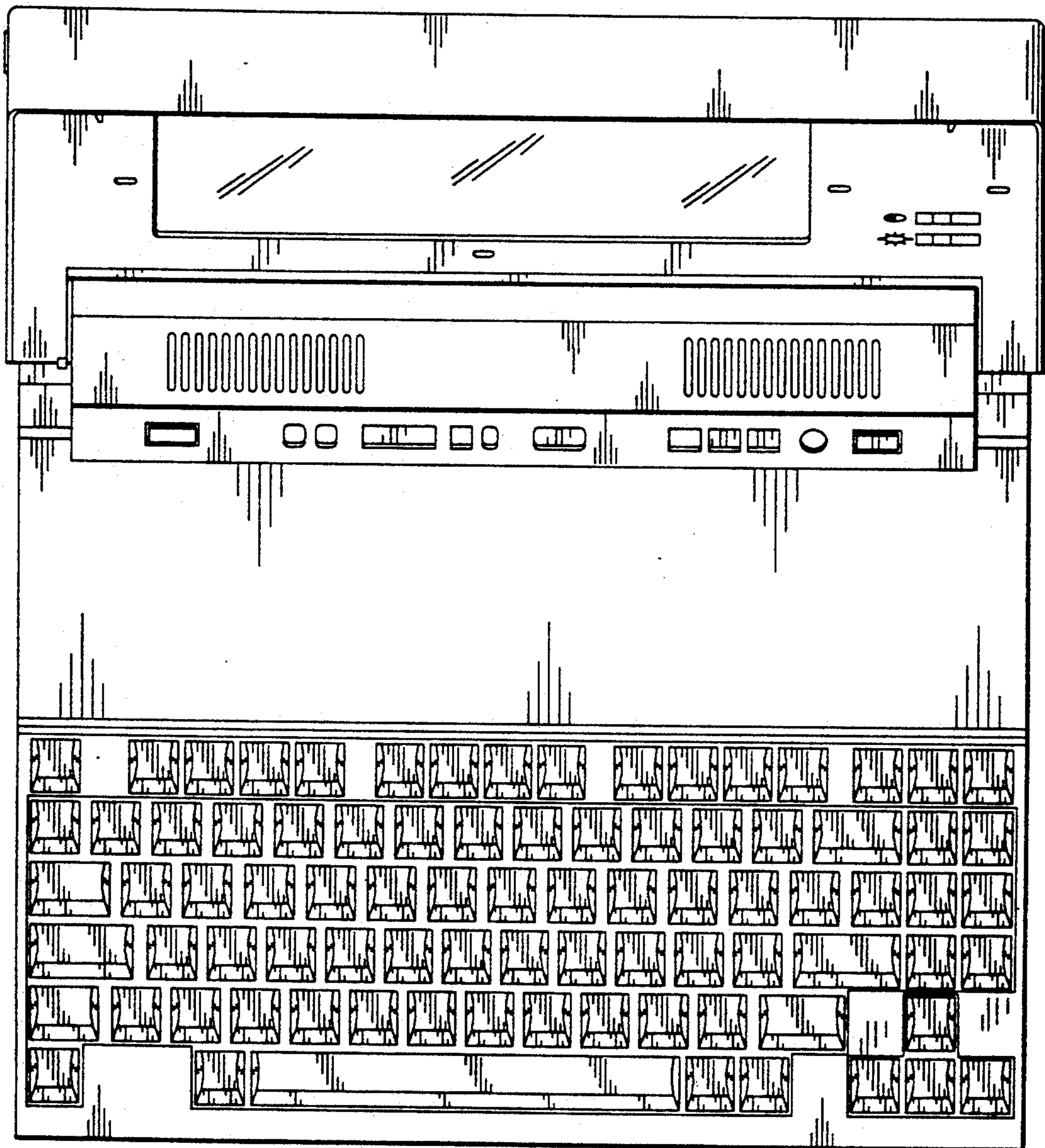

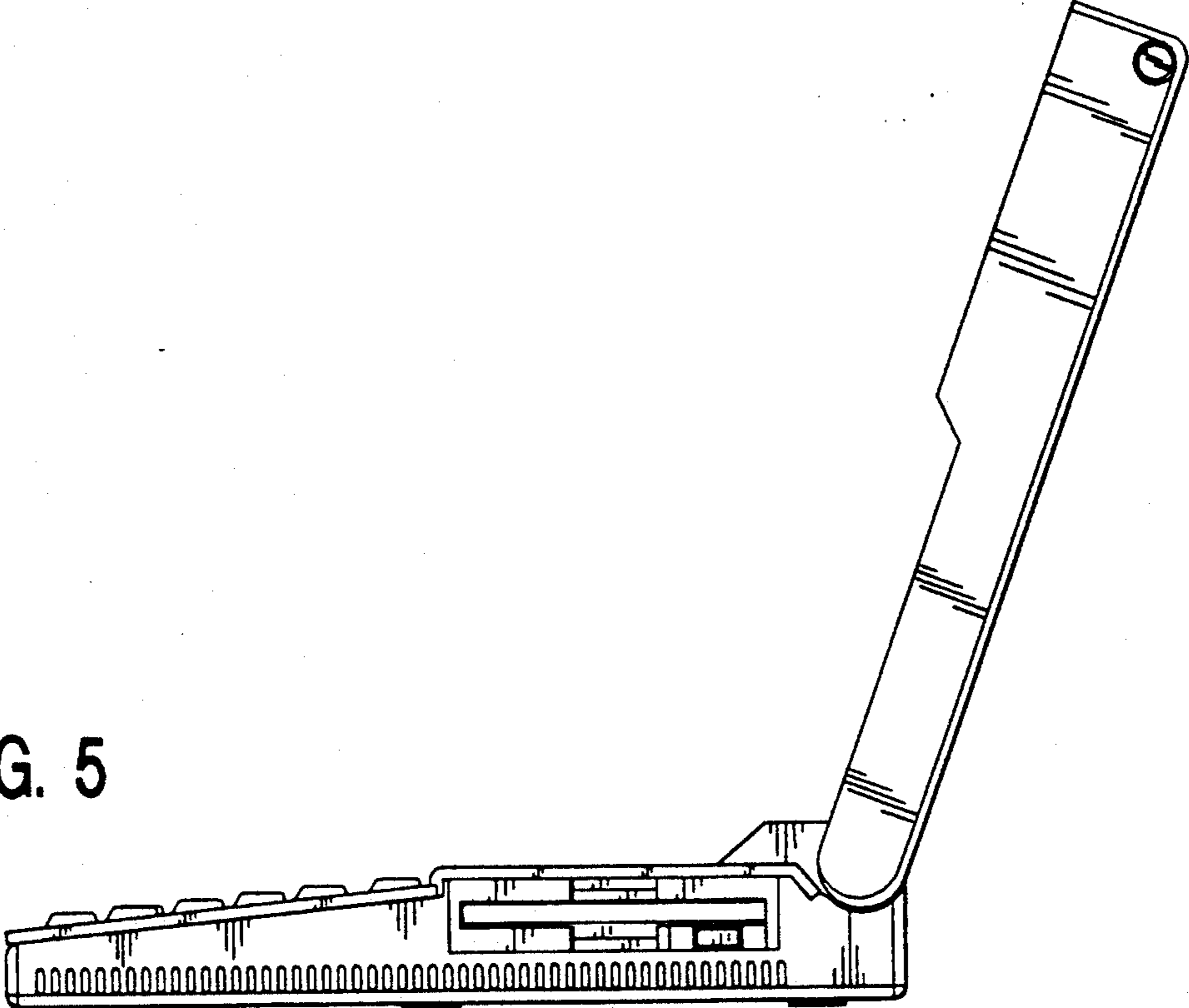
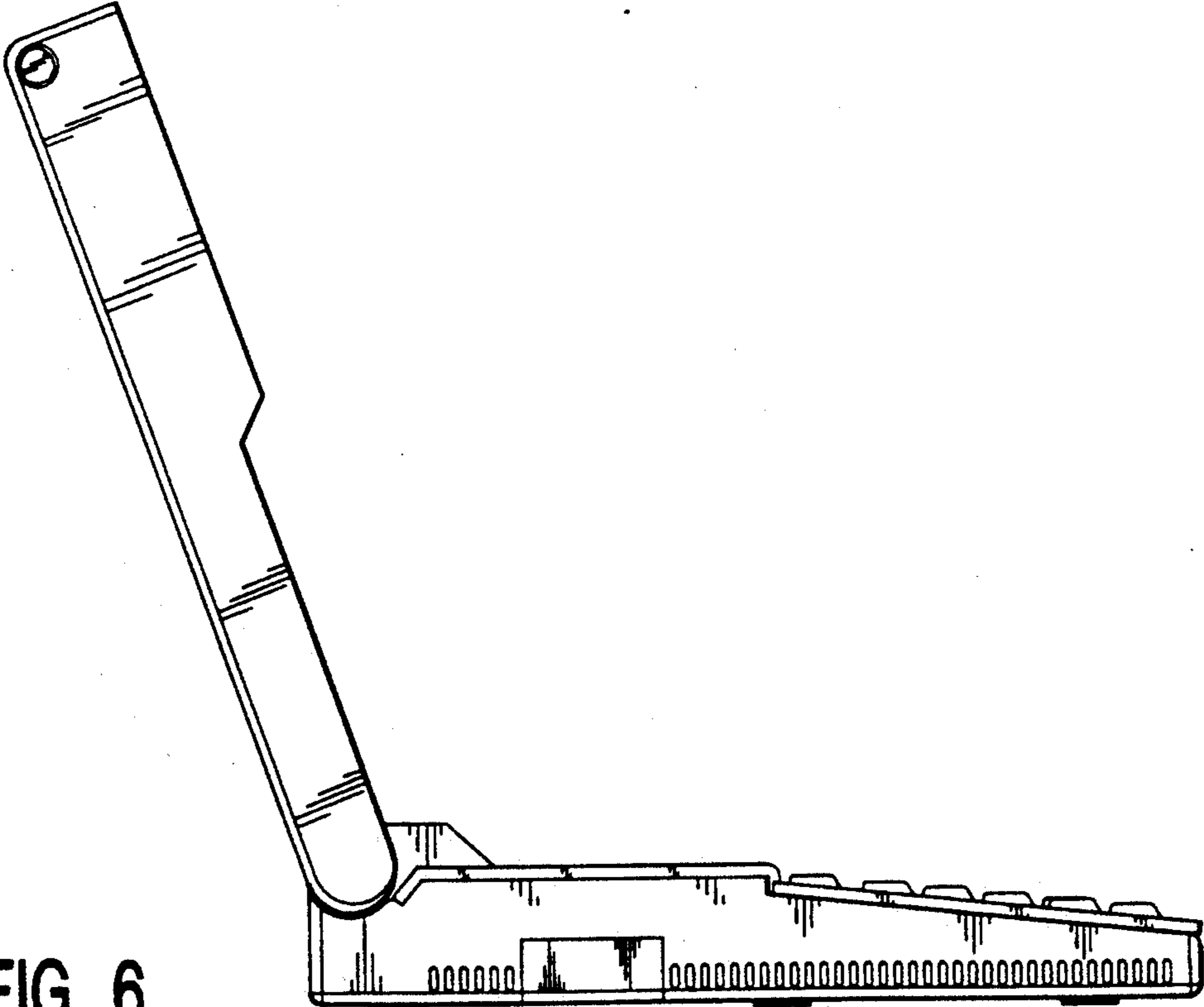

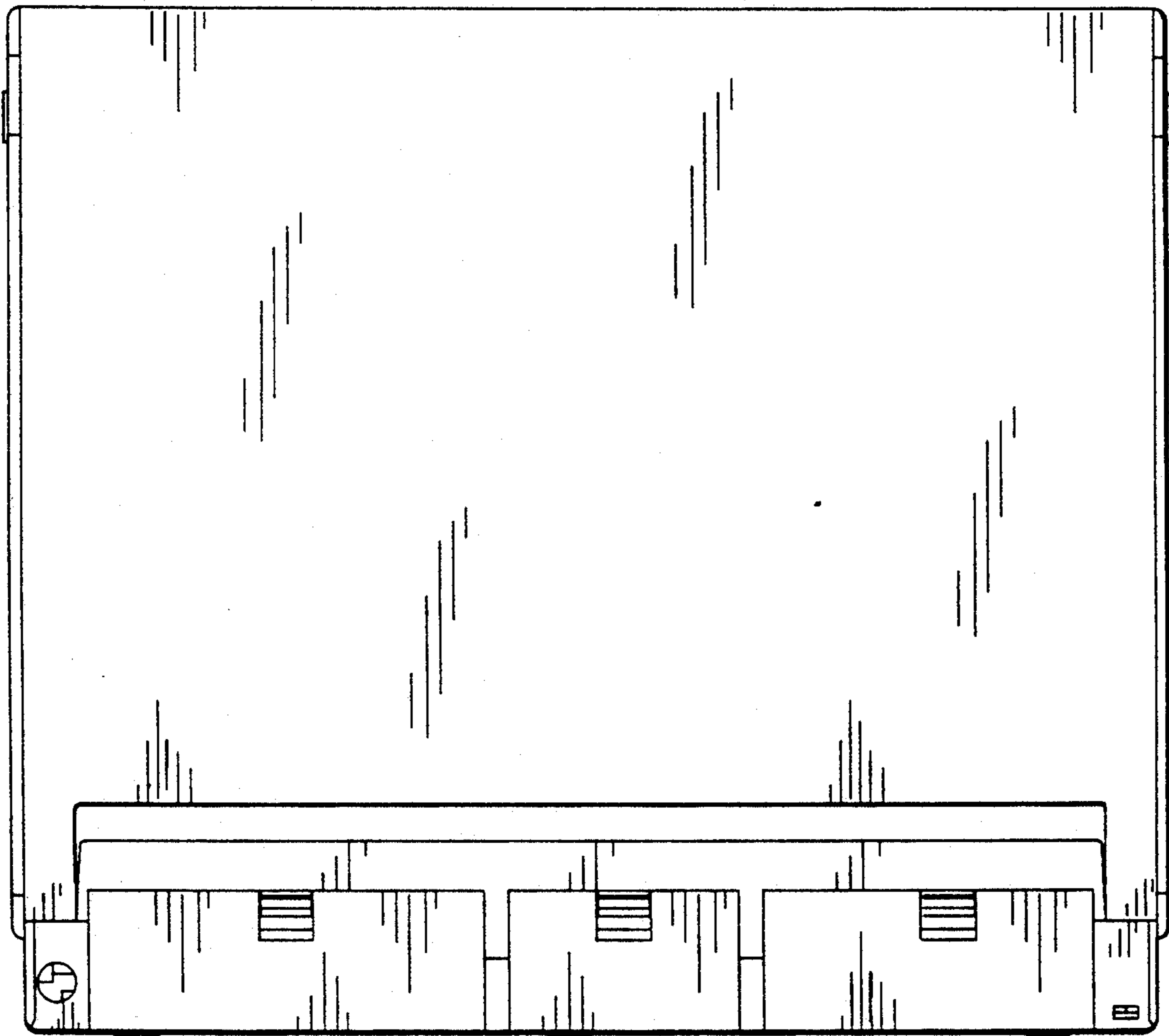

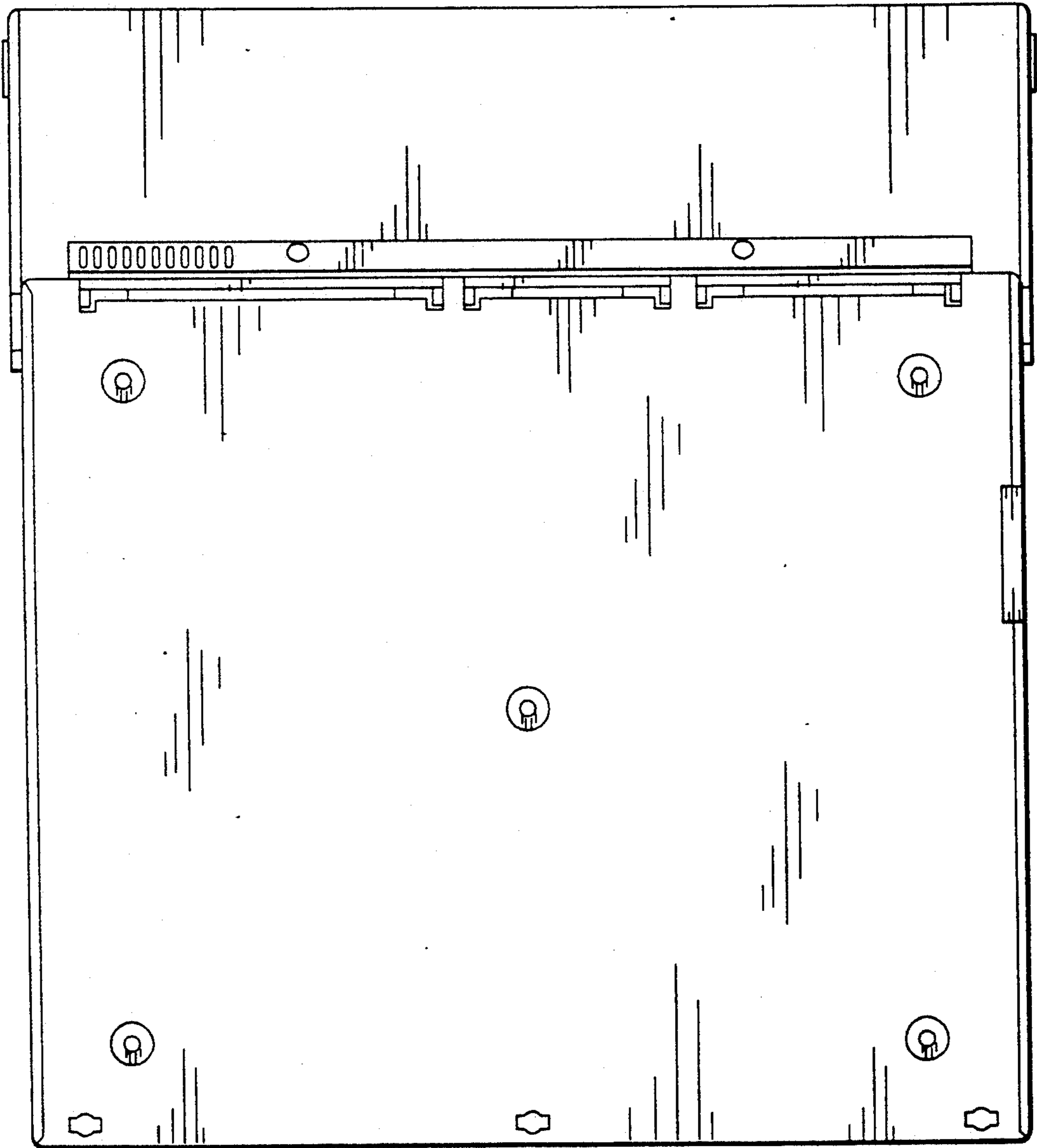

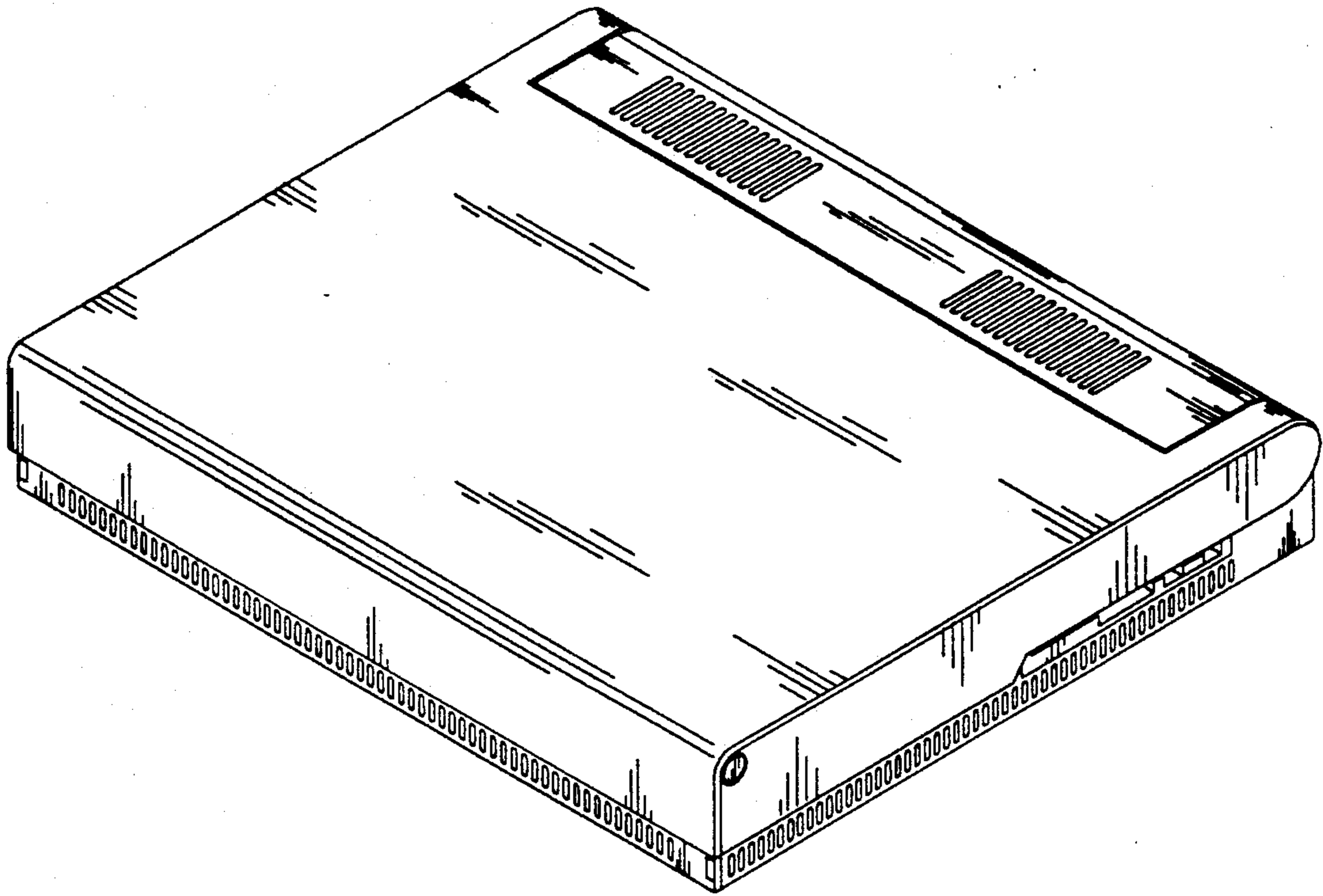

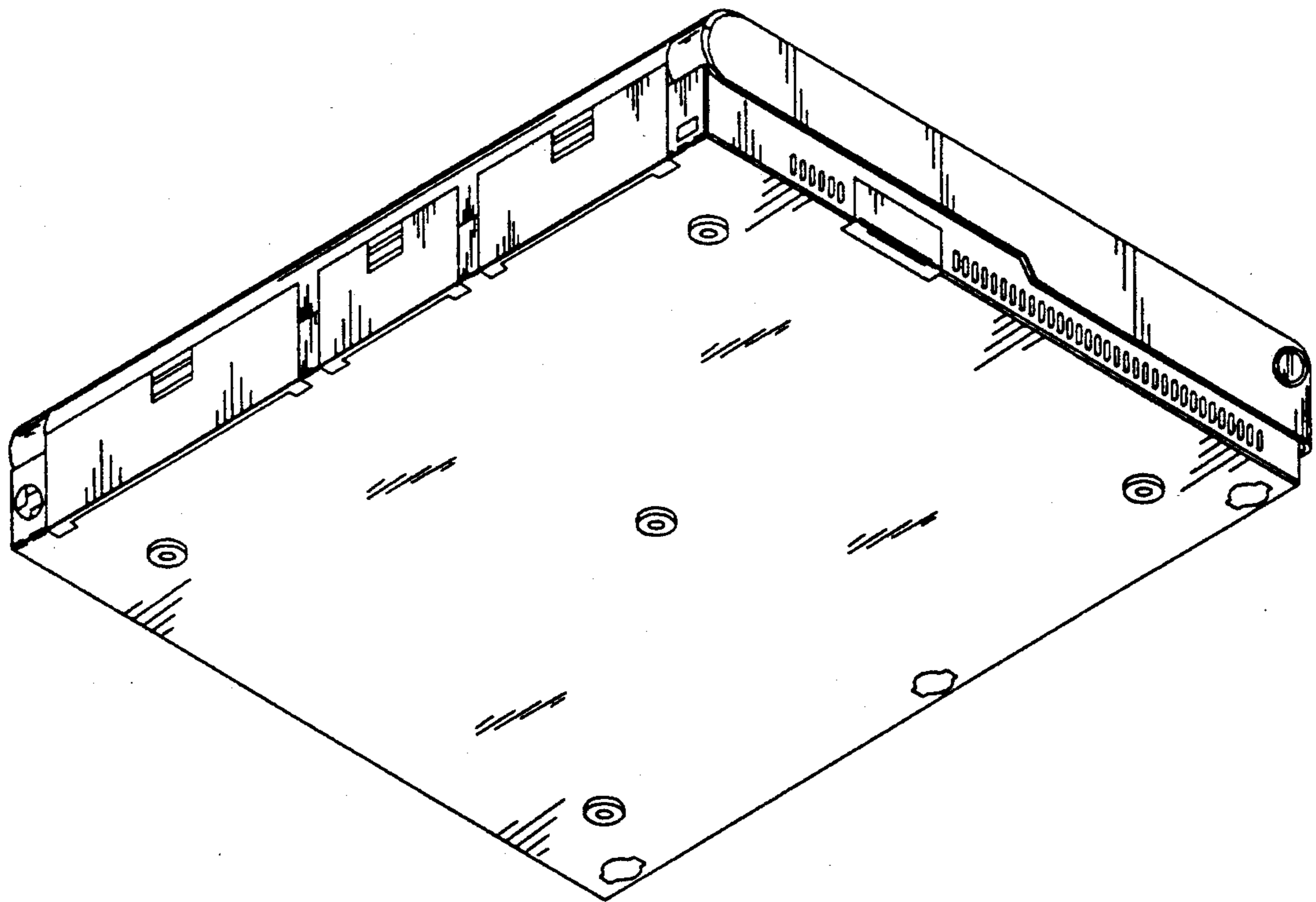

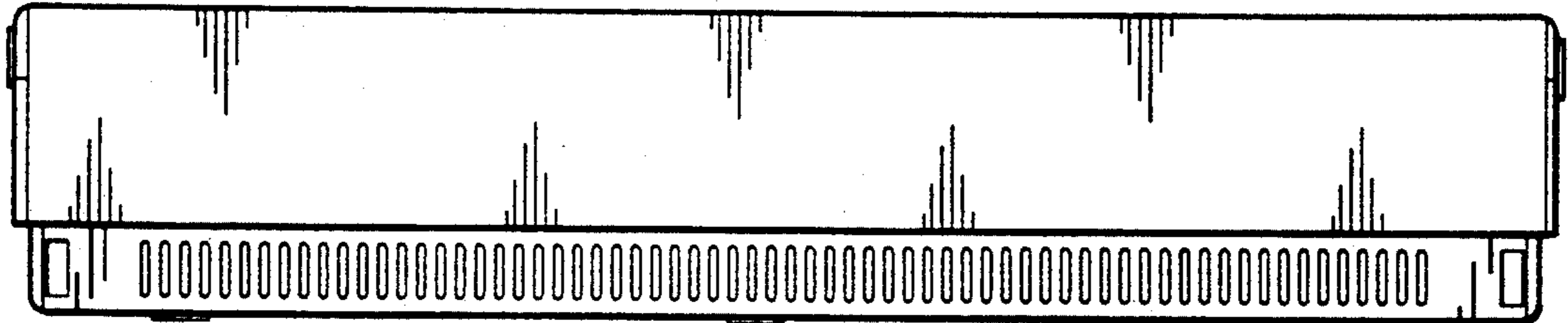

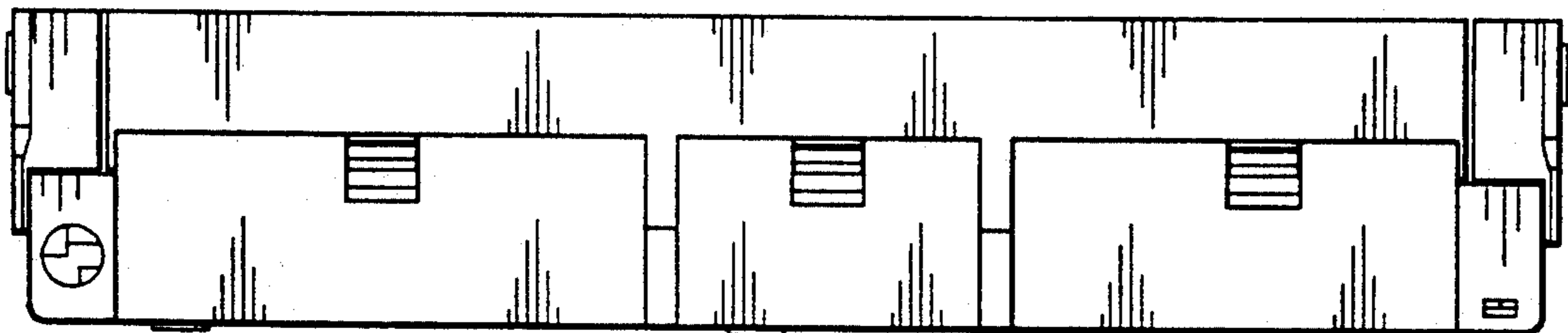

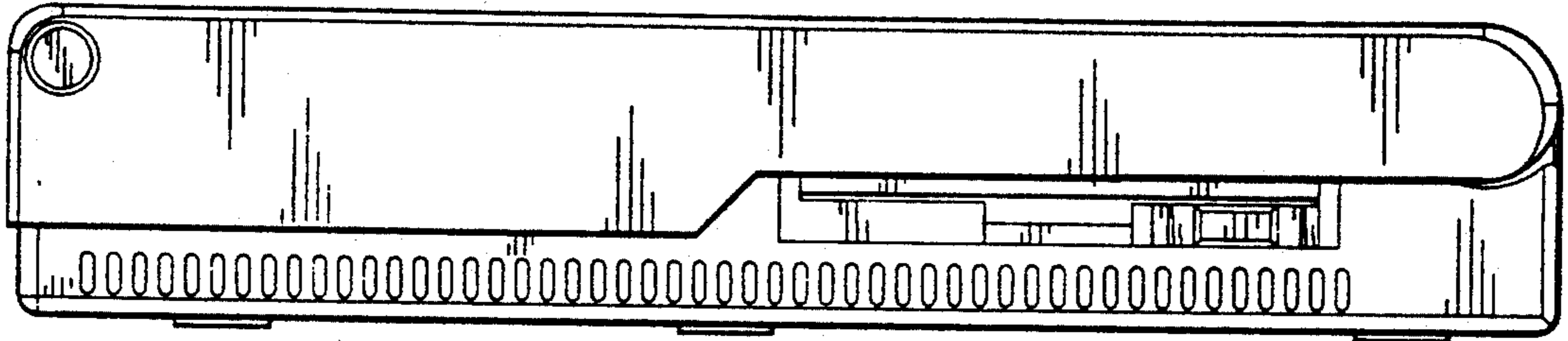

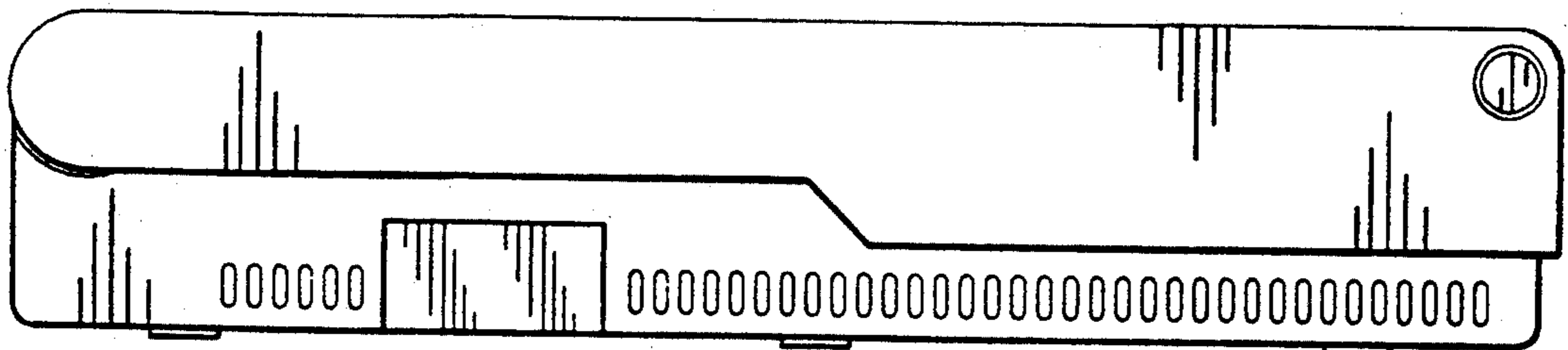

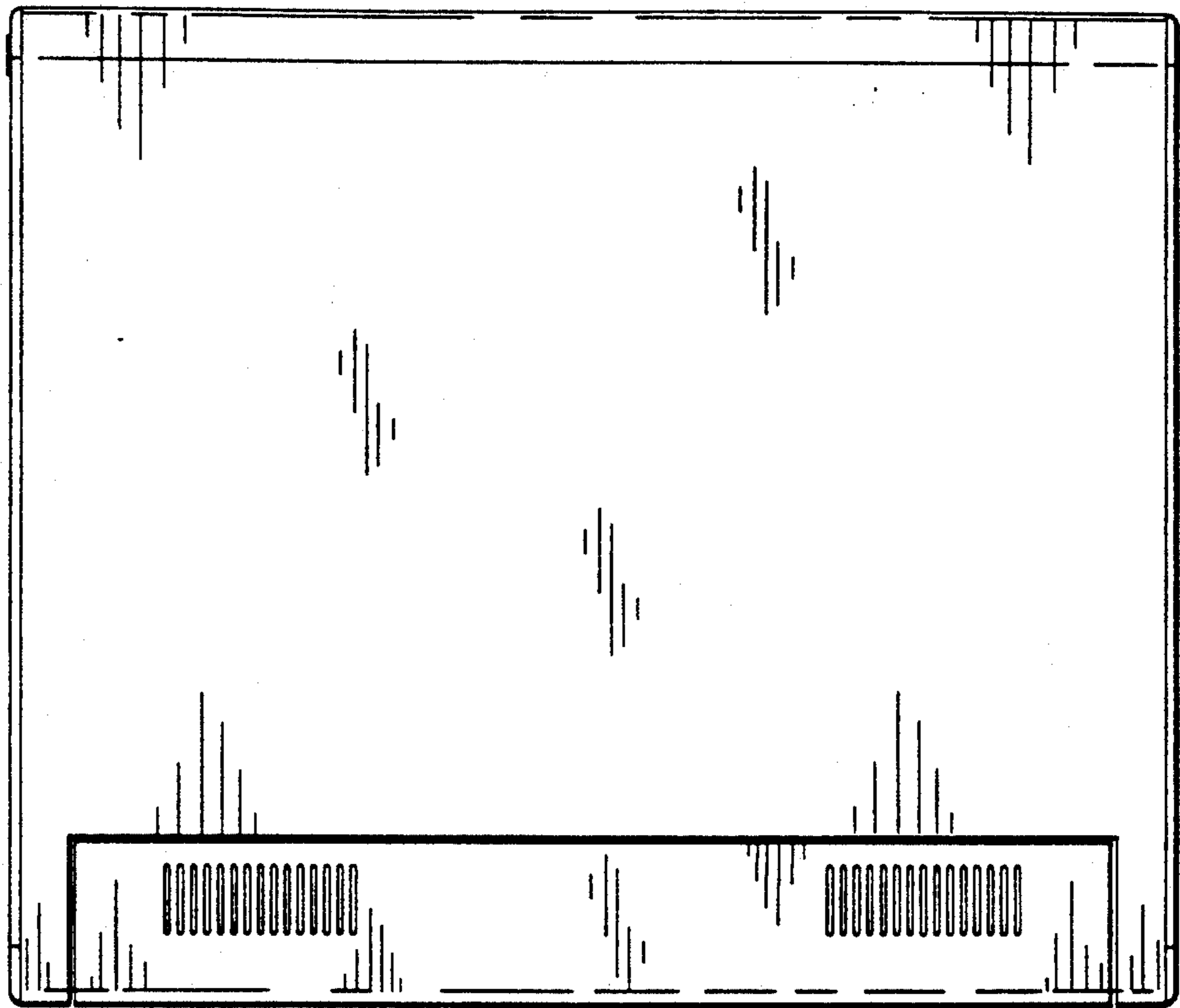

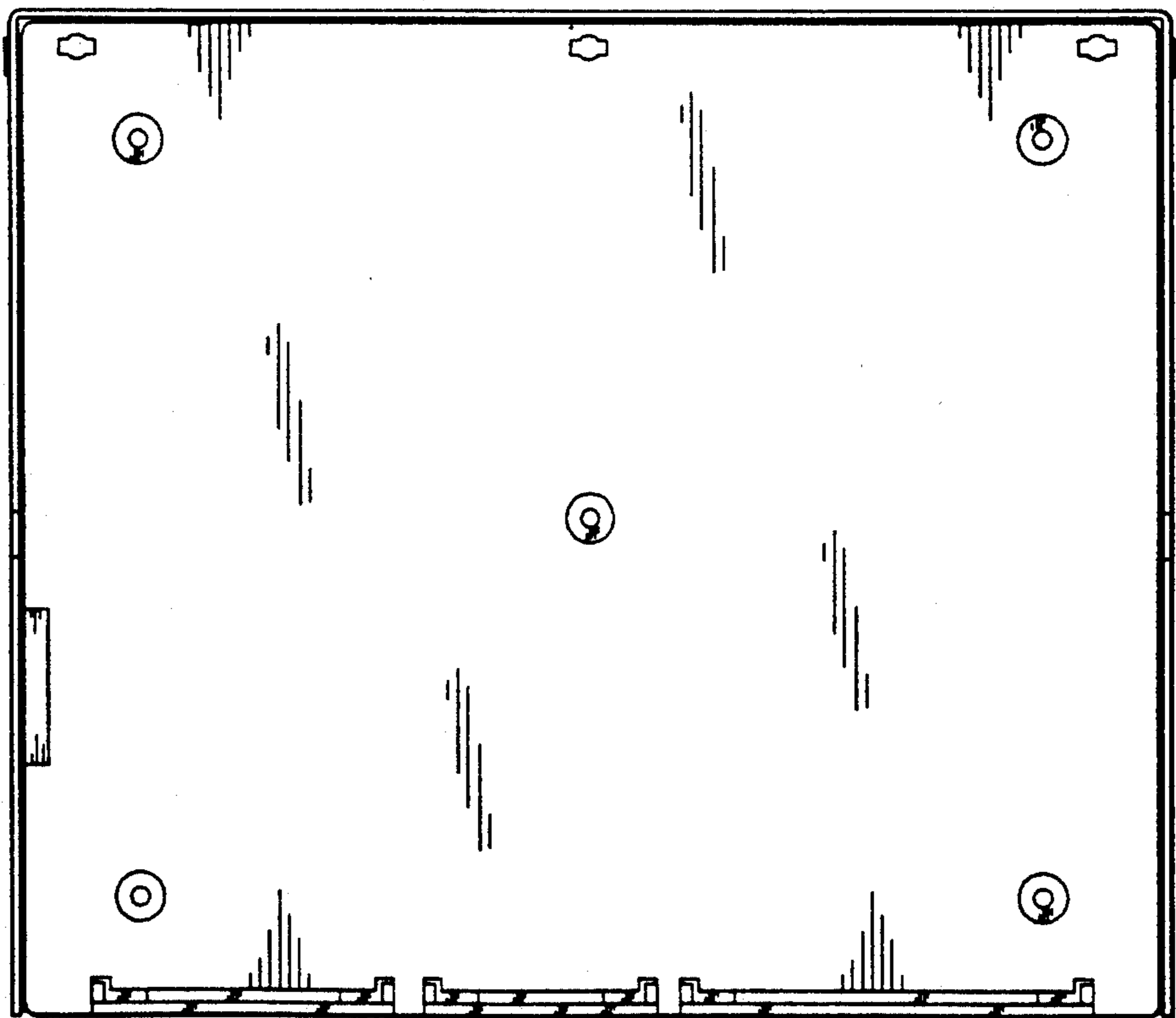
