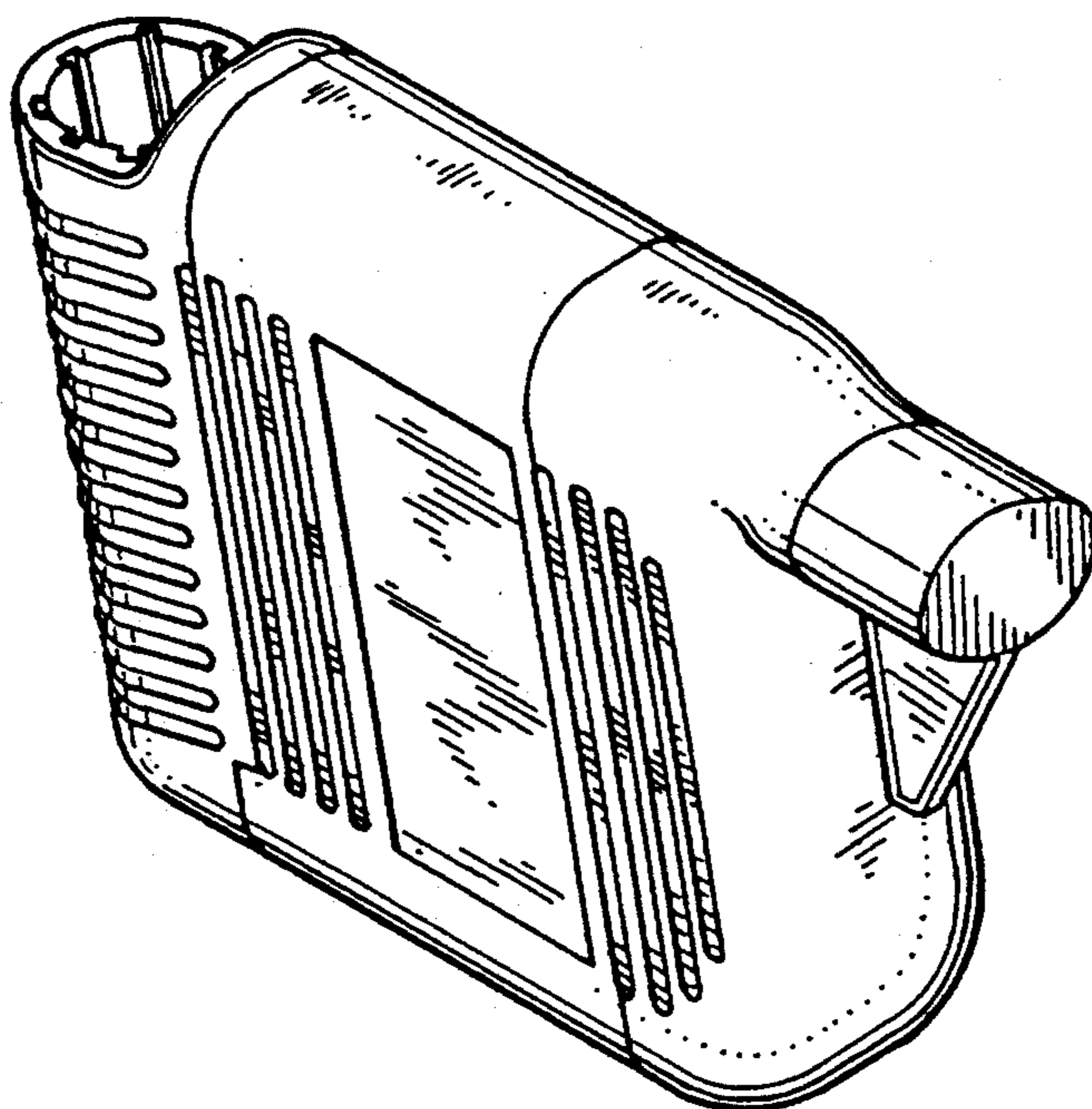
**DESCRIPTION**

FIG. 1 is a perspective view of an aerosol inhalation aid showing our new design;  
FIG. 2 is a front elevational view thereof, the rear elevational view being identical thereto;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a front elevational view thereof in extended position, the rear elevational view being identical thereto.  
The broken line showing in FIGS. 1, 2, 5, 6 and 7 is for illustrative purposes only and forms no part of the claimed design.

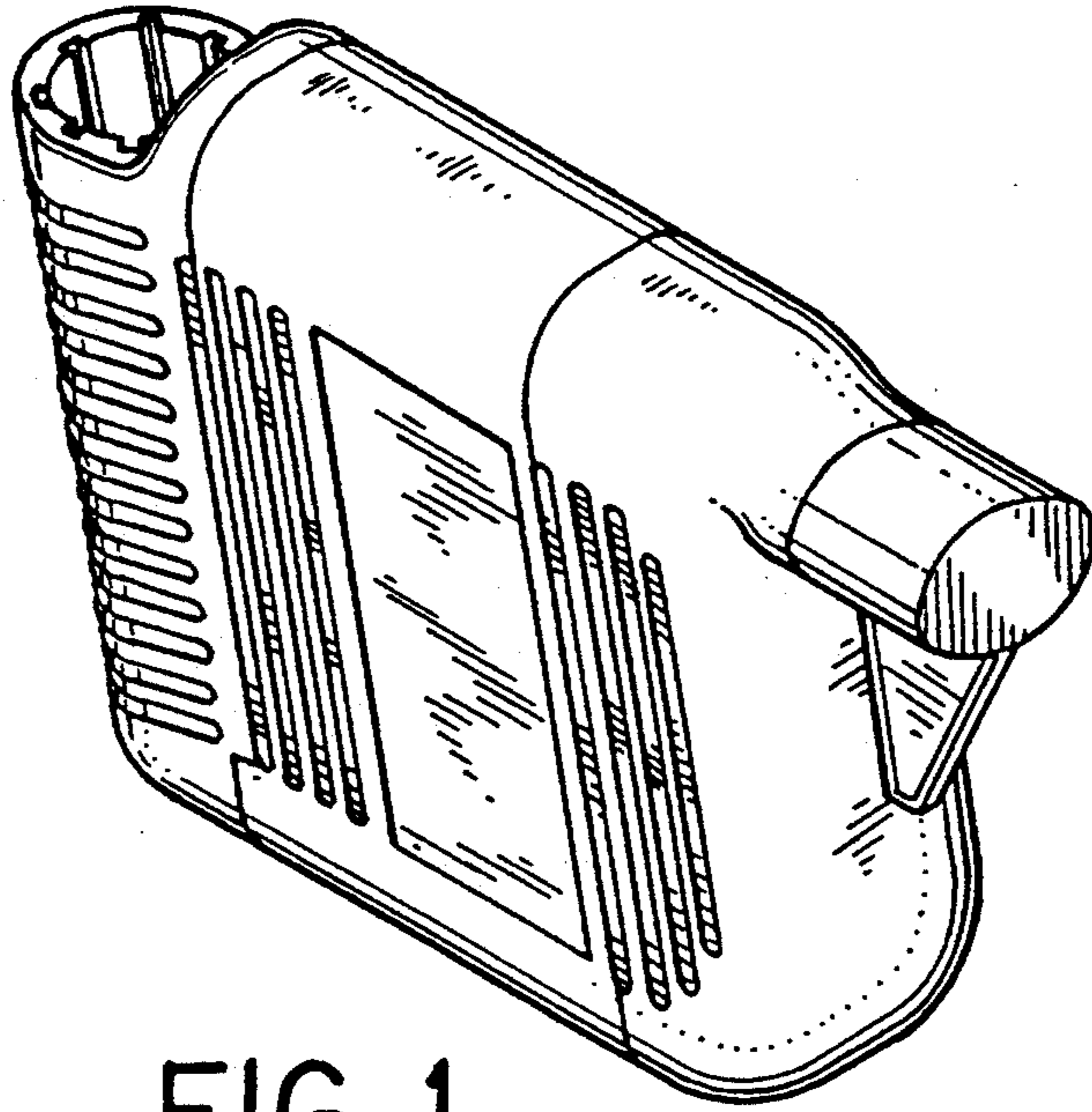

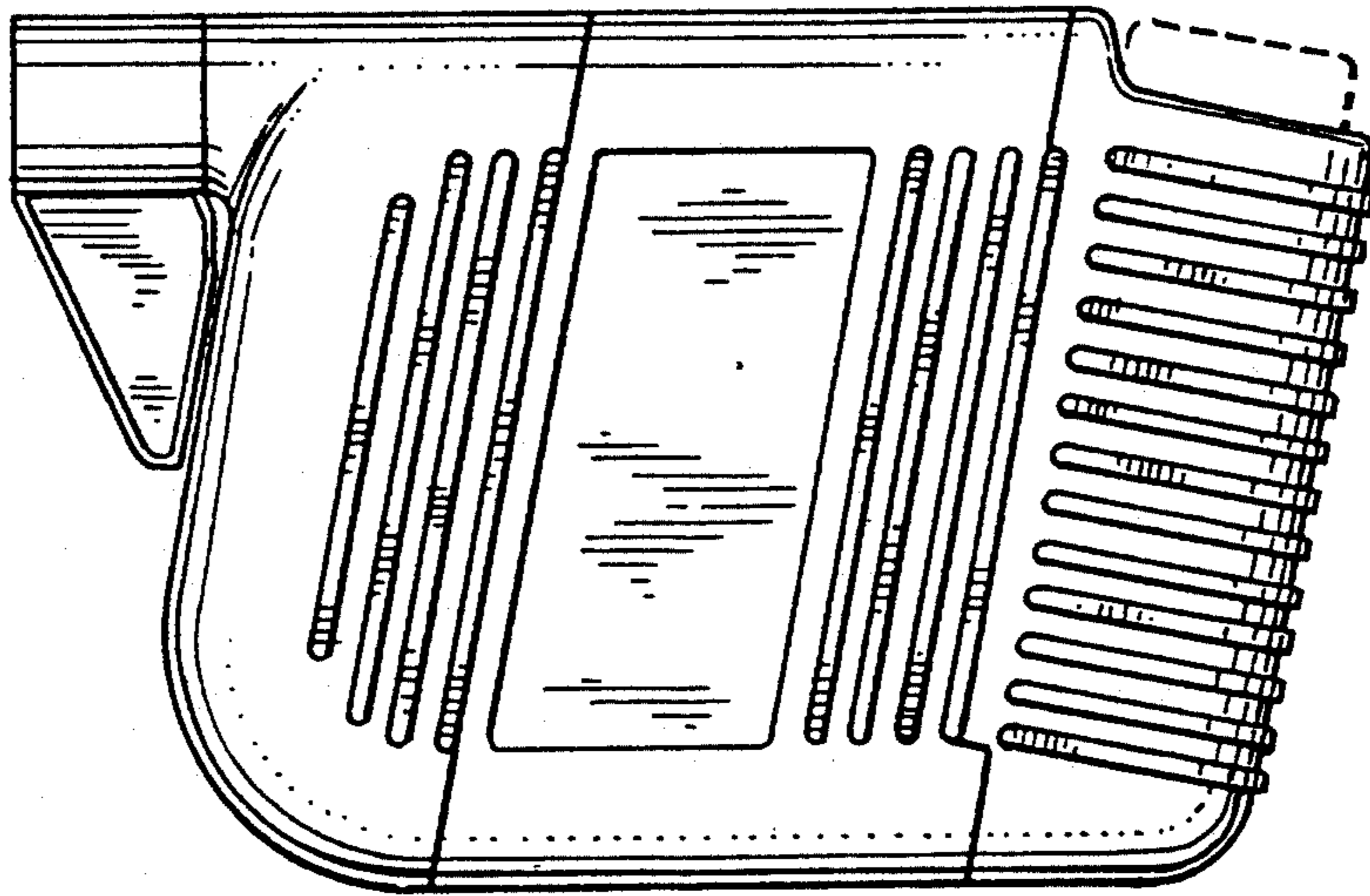

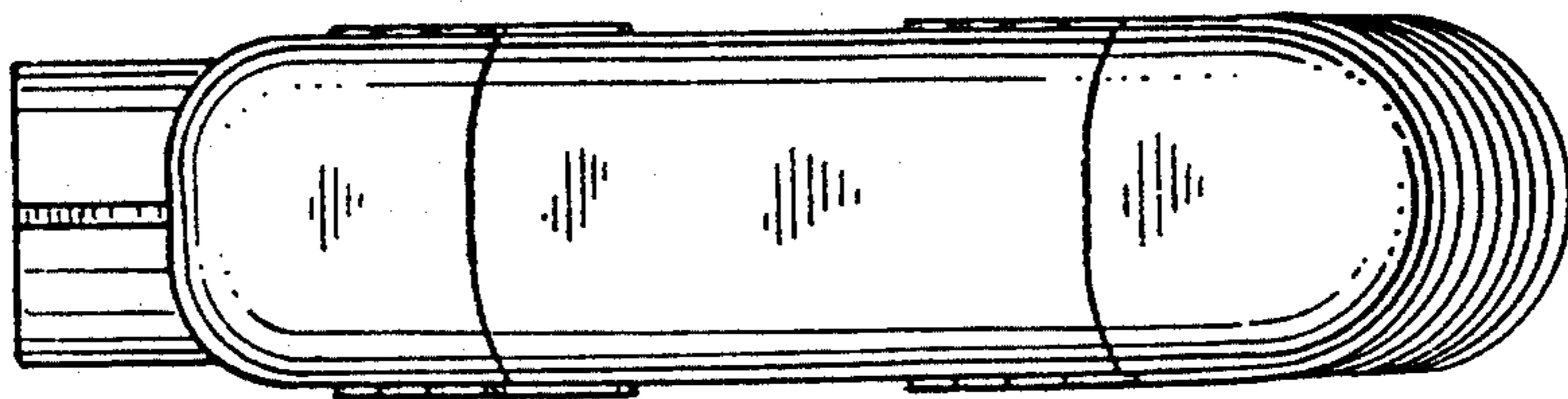

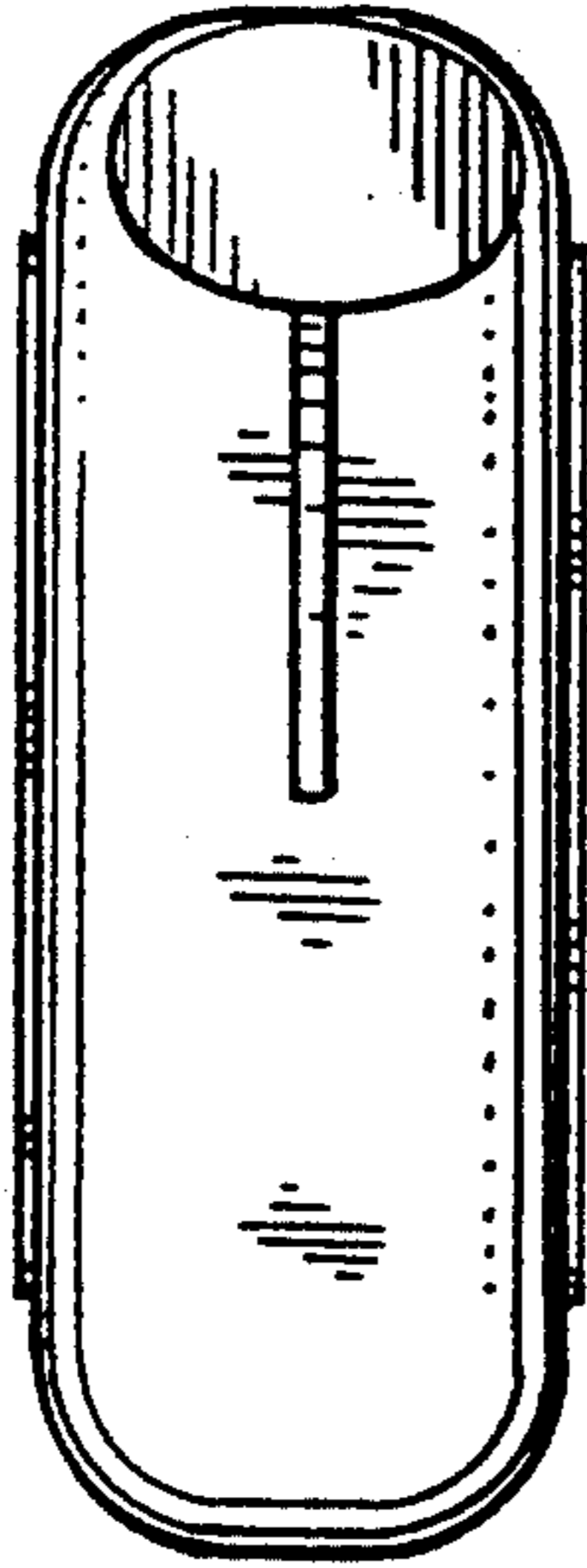

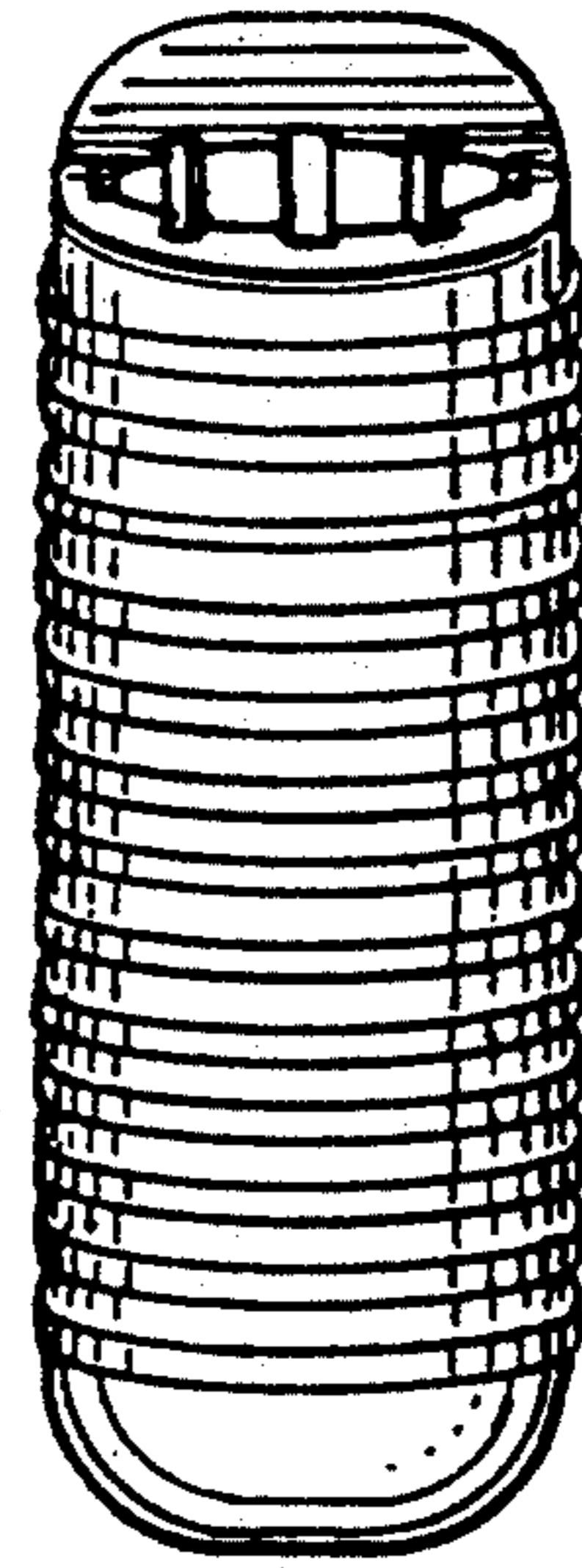

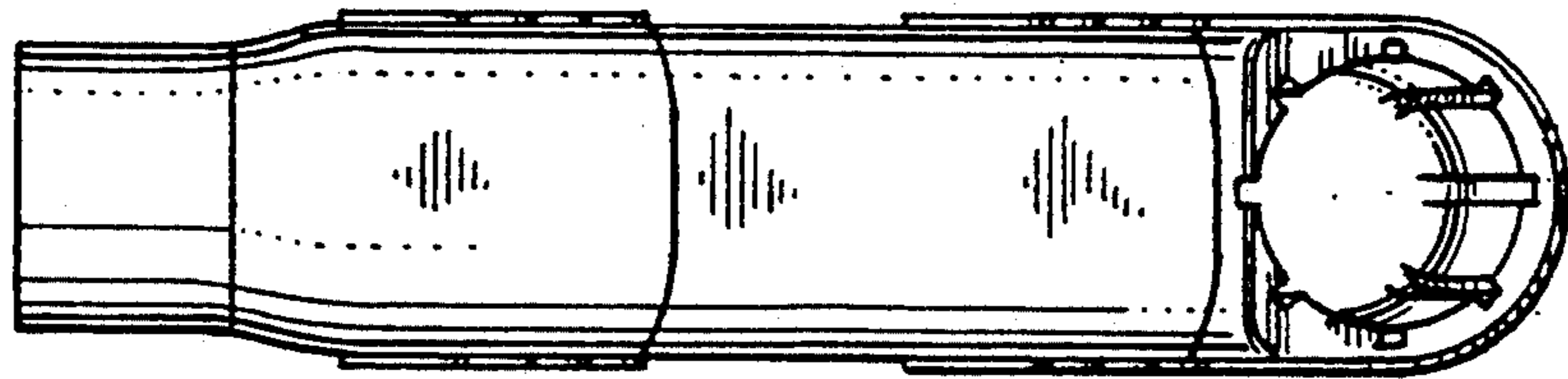

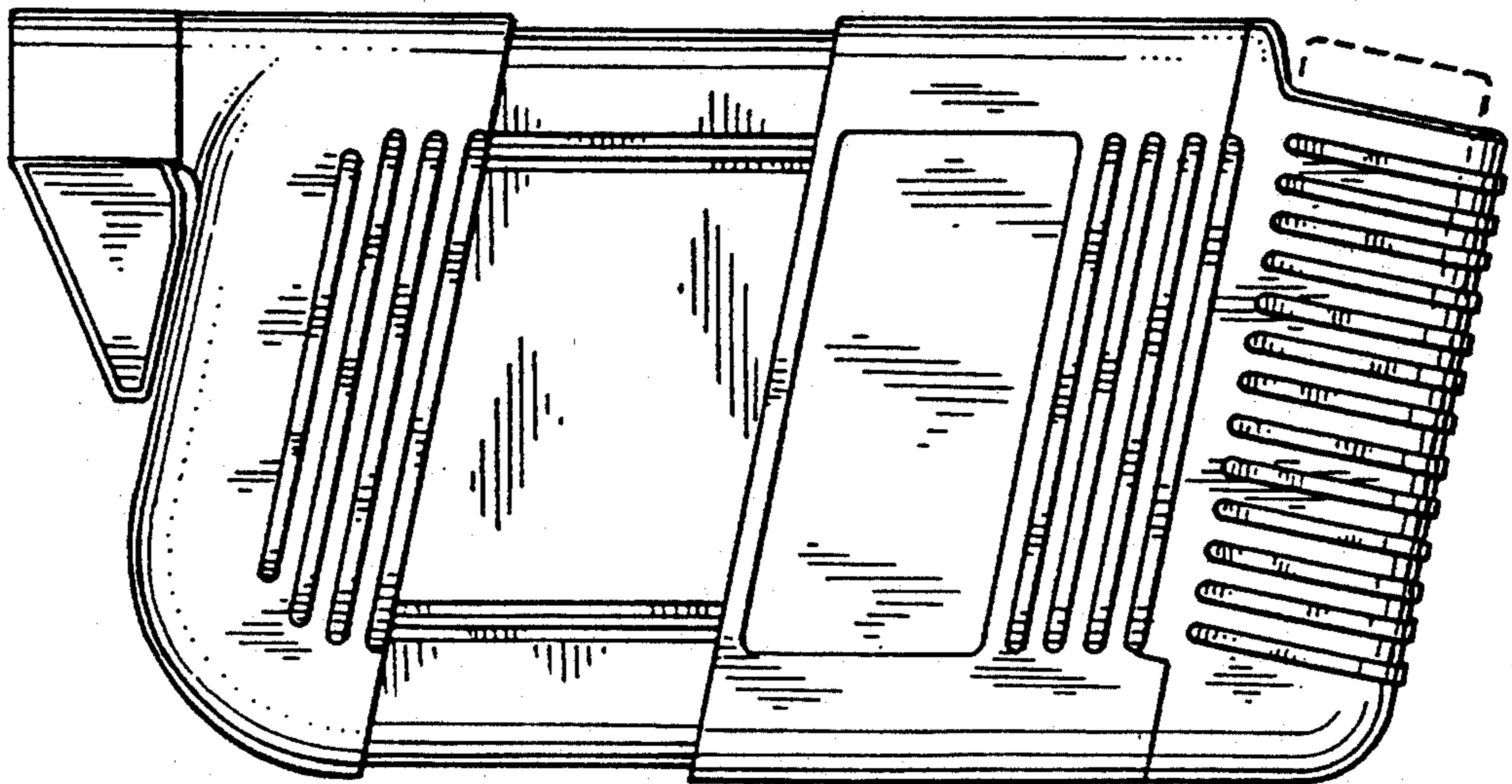
