FIG. 7 is a right-hand perspective view of a modified air brush;

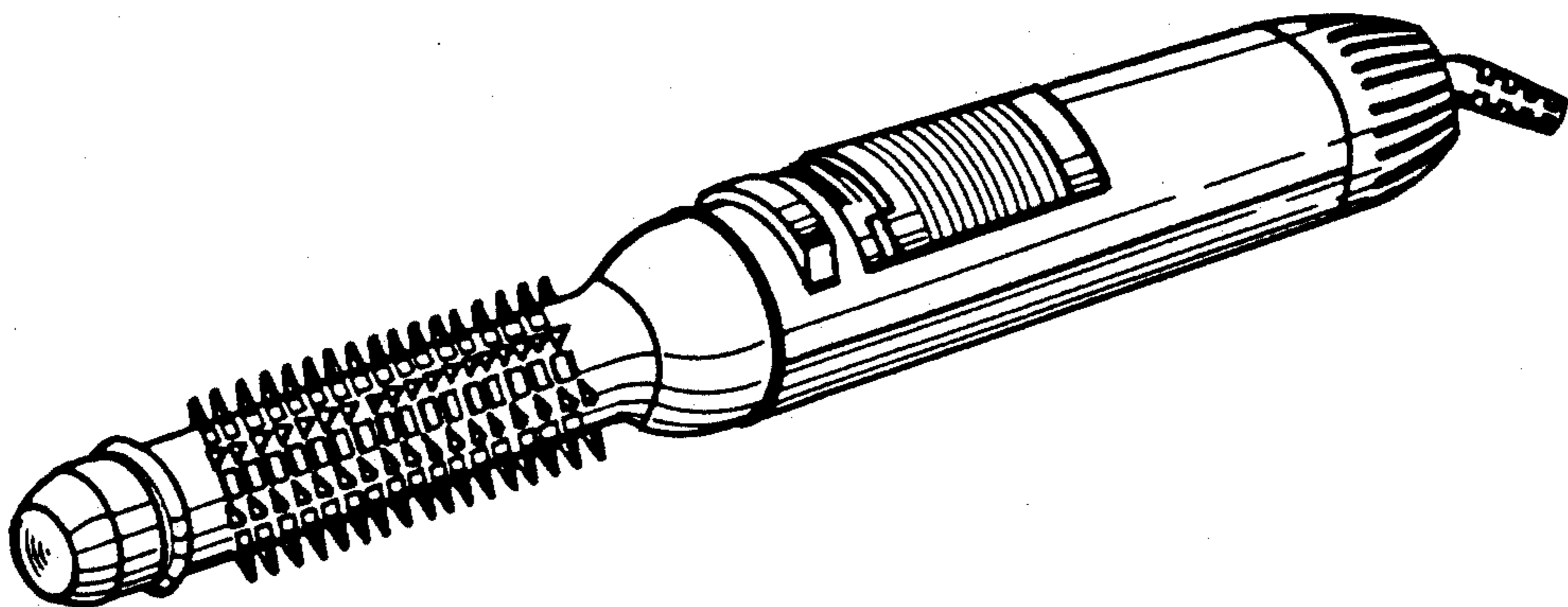
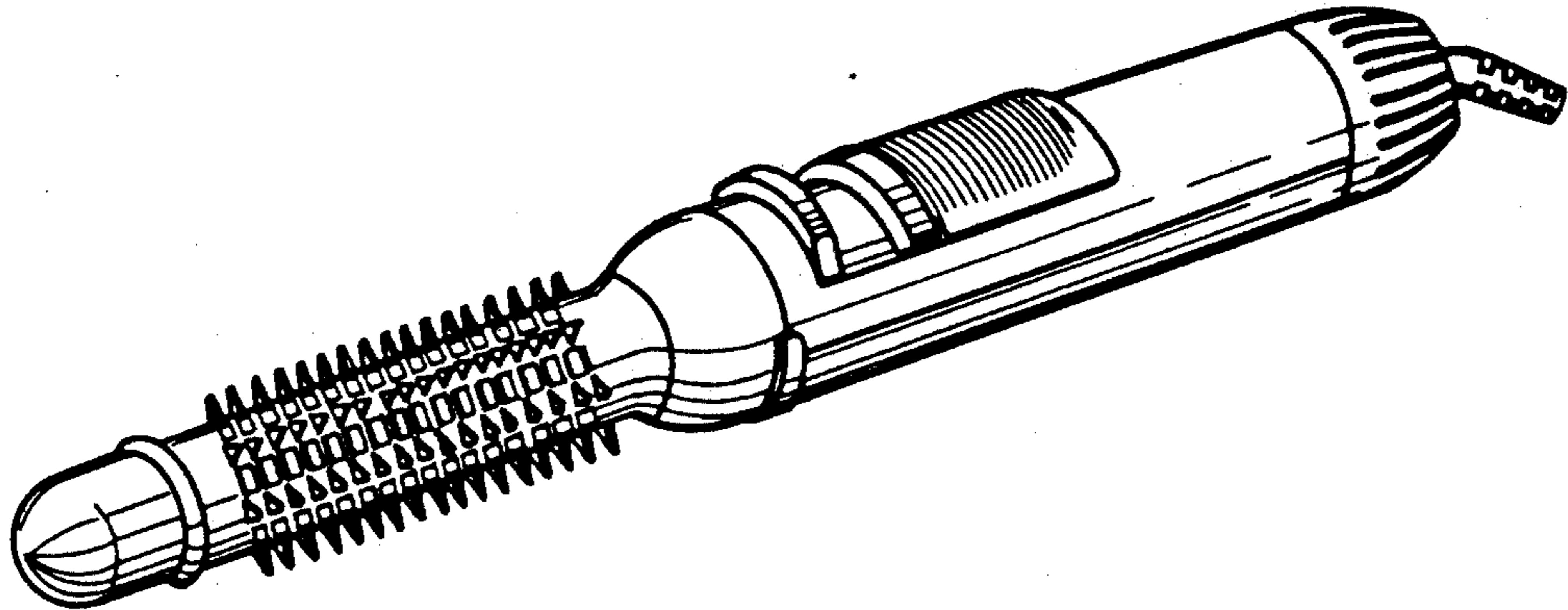
FIG. 8 is a side elevational view thereof;

FIG. 12 is a rear elevational view thereof.



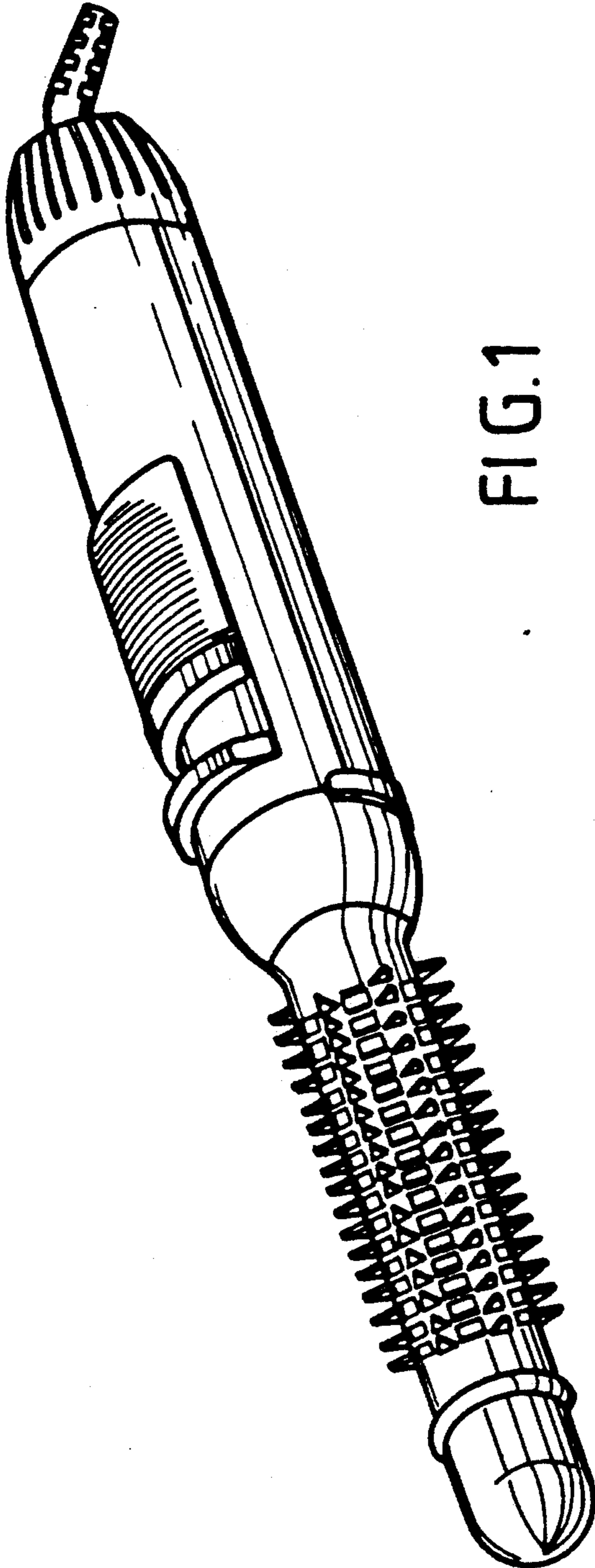

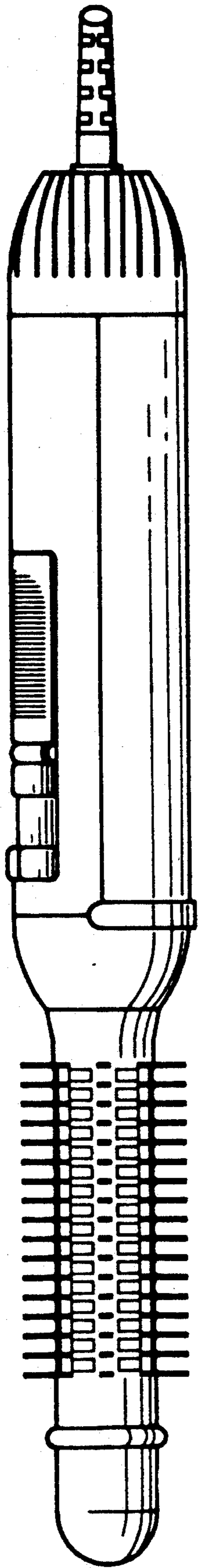

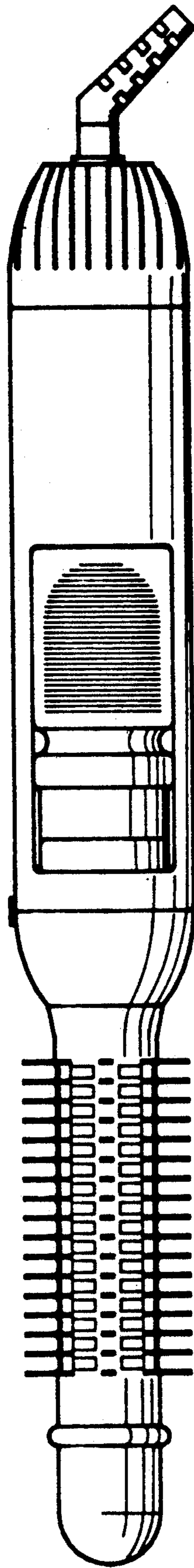

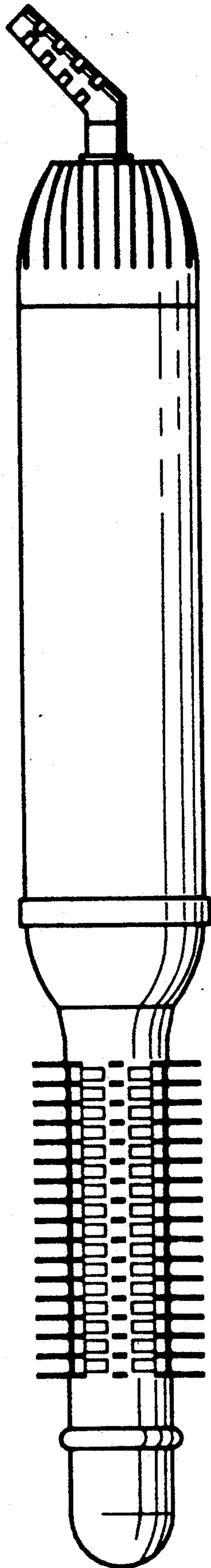

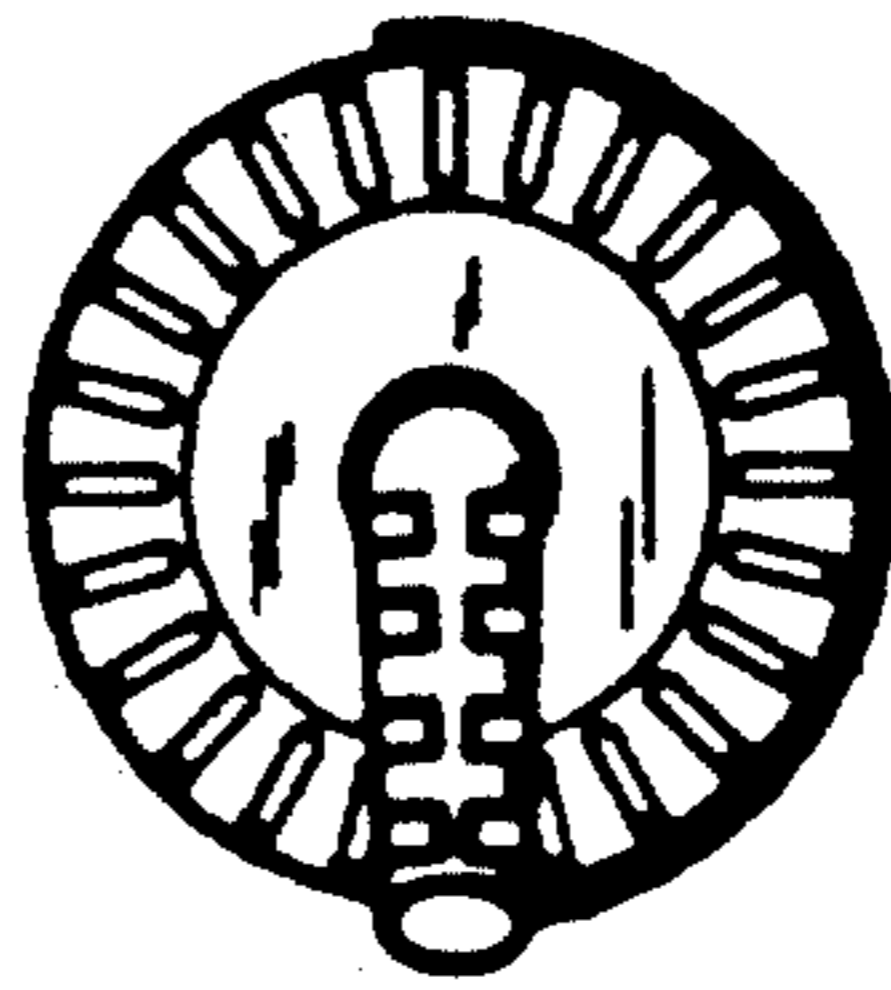

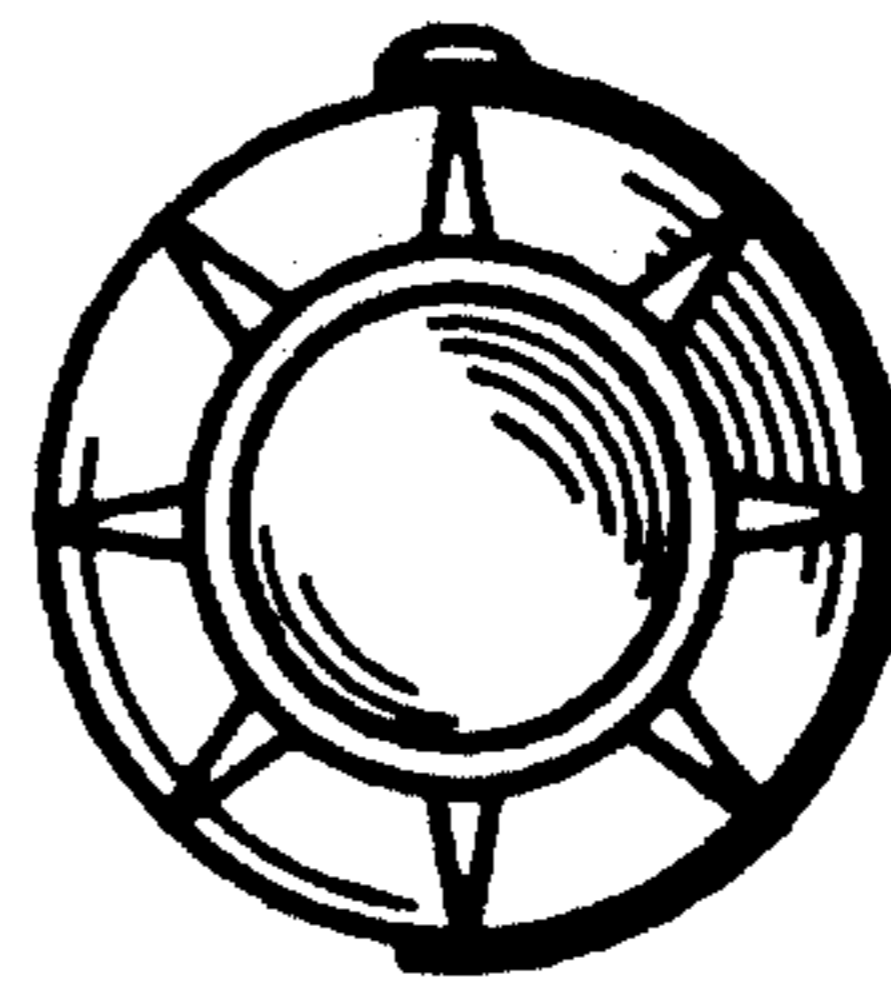

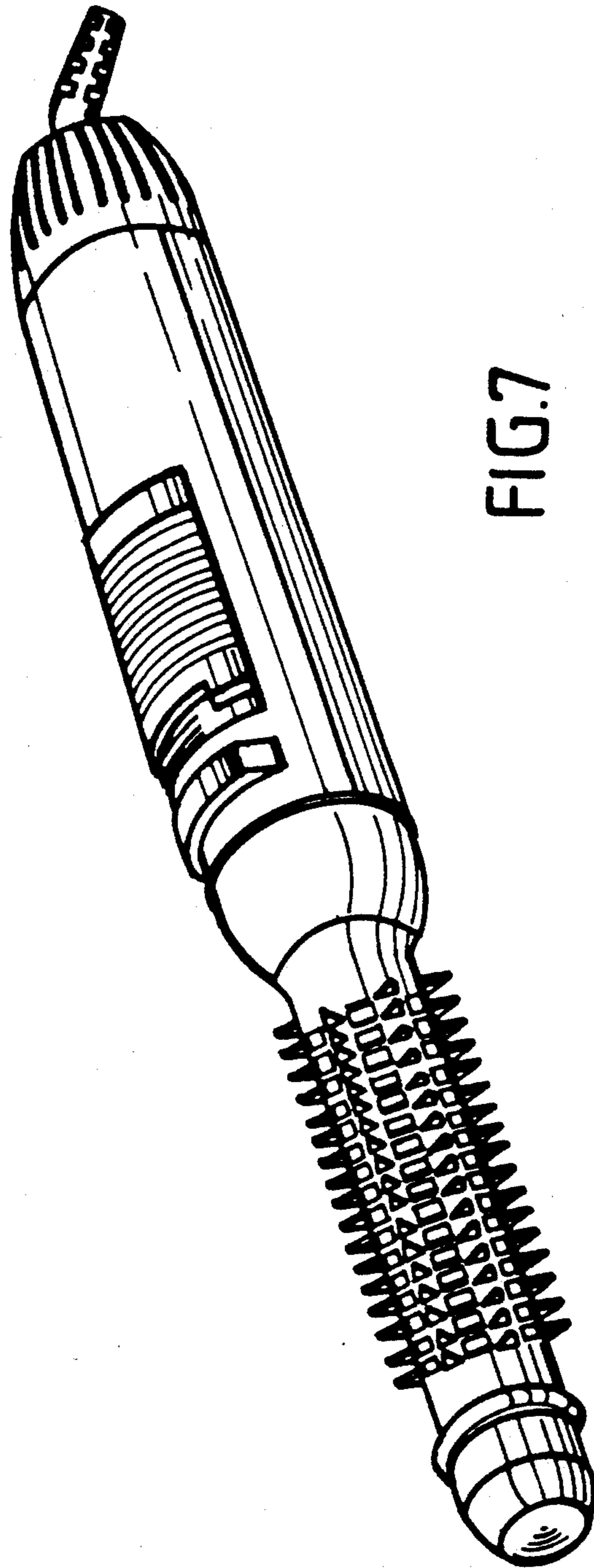

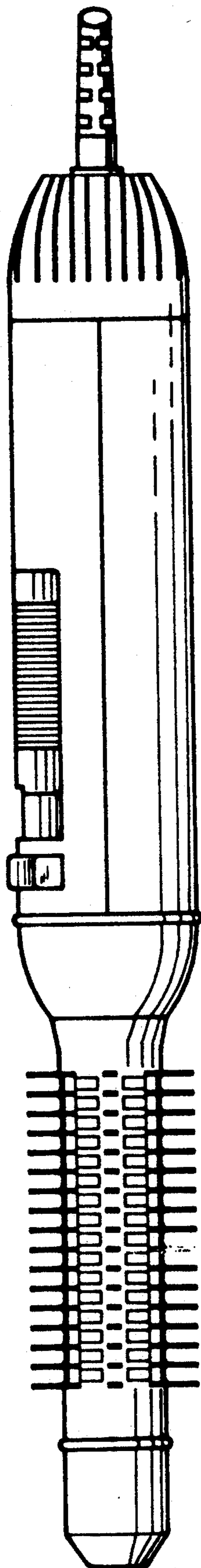

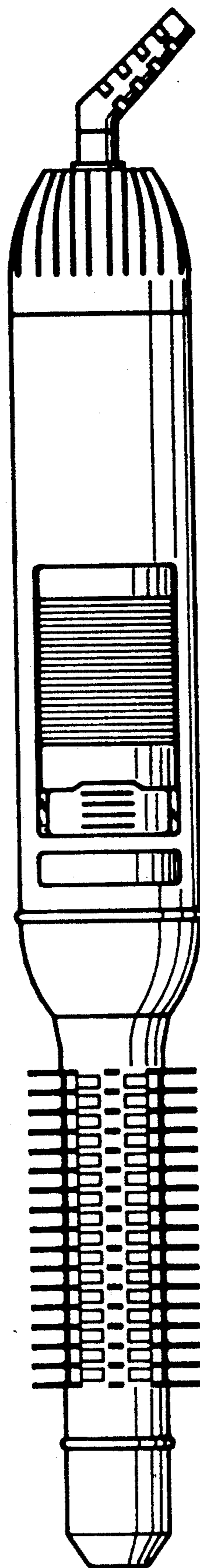

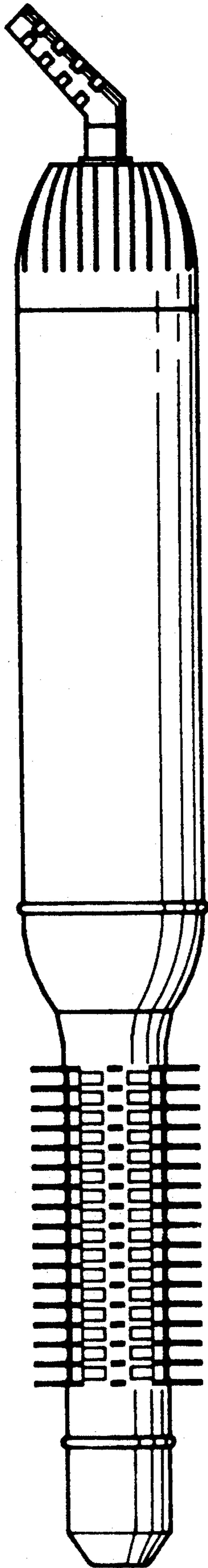

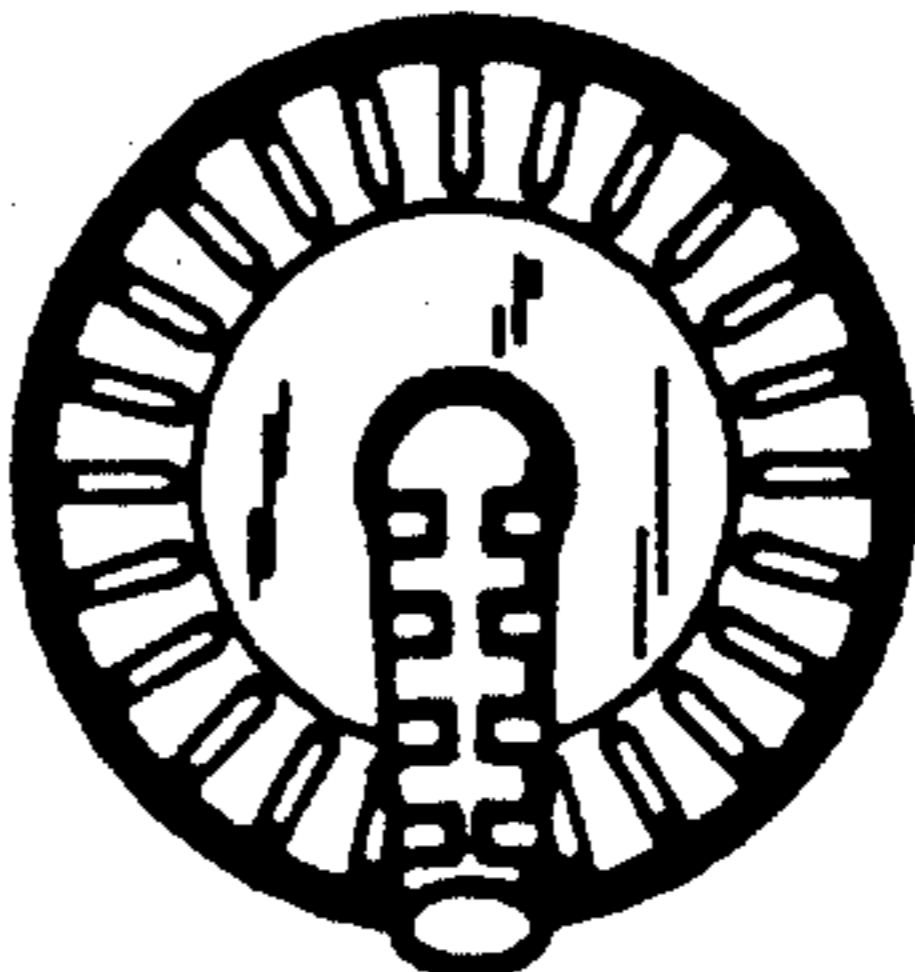

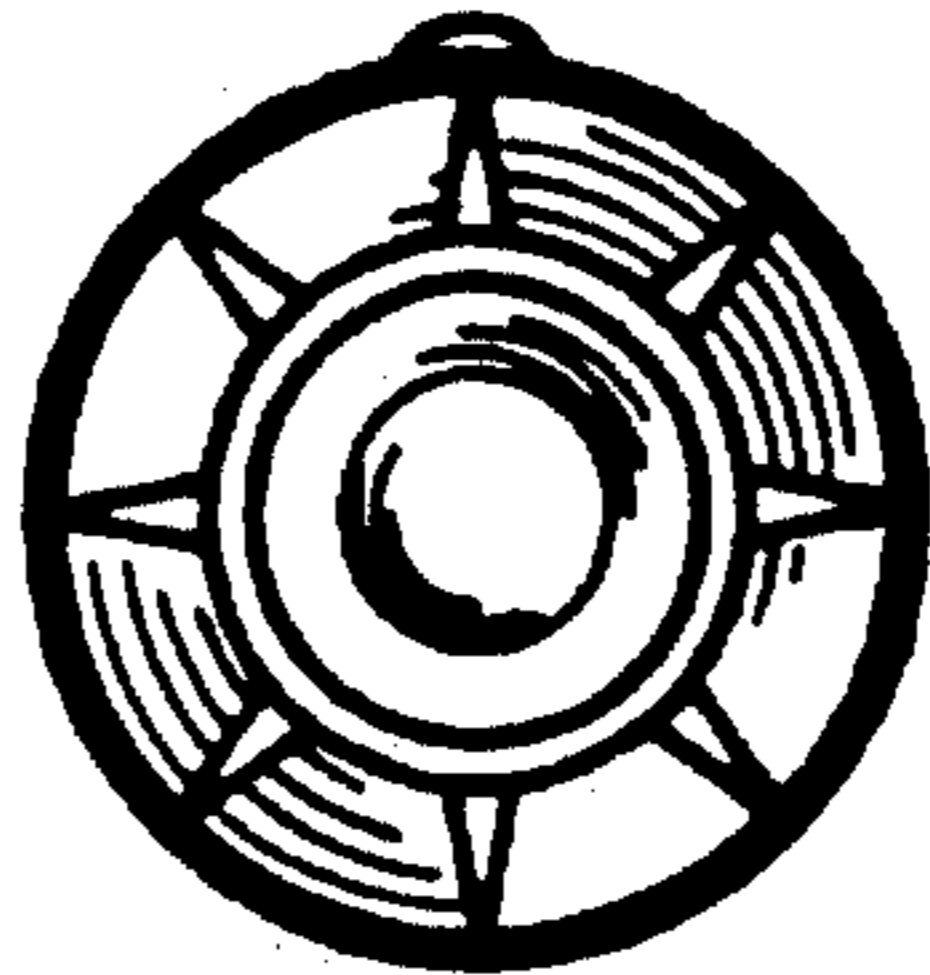
