[57] **CLAIM**

The ornamental design for a battery operated fingernail file, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a battery operated fingernail file showing my new design;  
FIG. 2 is a front end elevational view thereof;  
FIG. 3 is a rear end elevational view thereof;  
FIG. 4 is a side elevational view thereof, the side opposite being a mirror image of the side shown;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom view thereof.

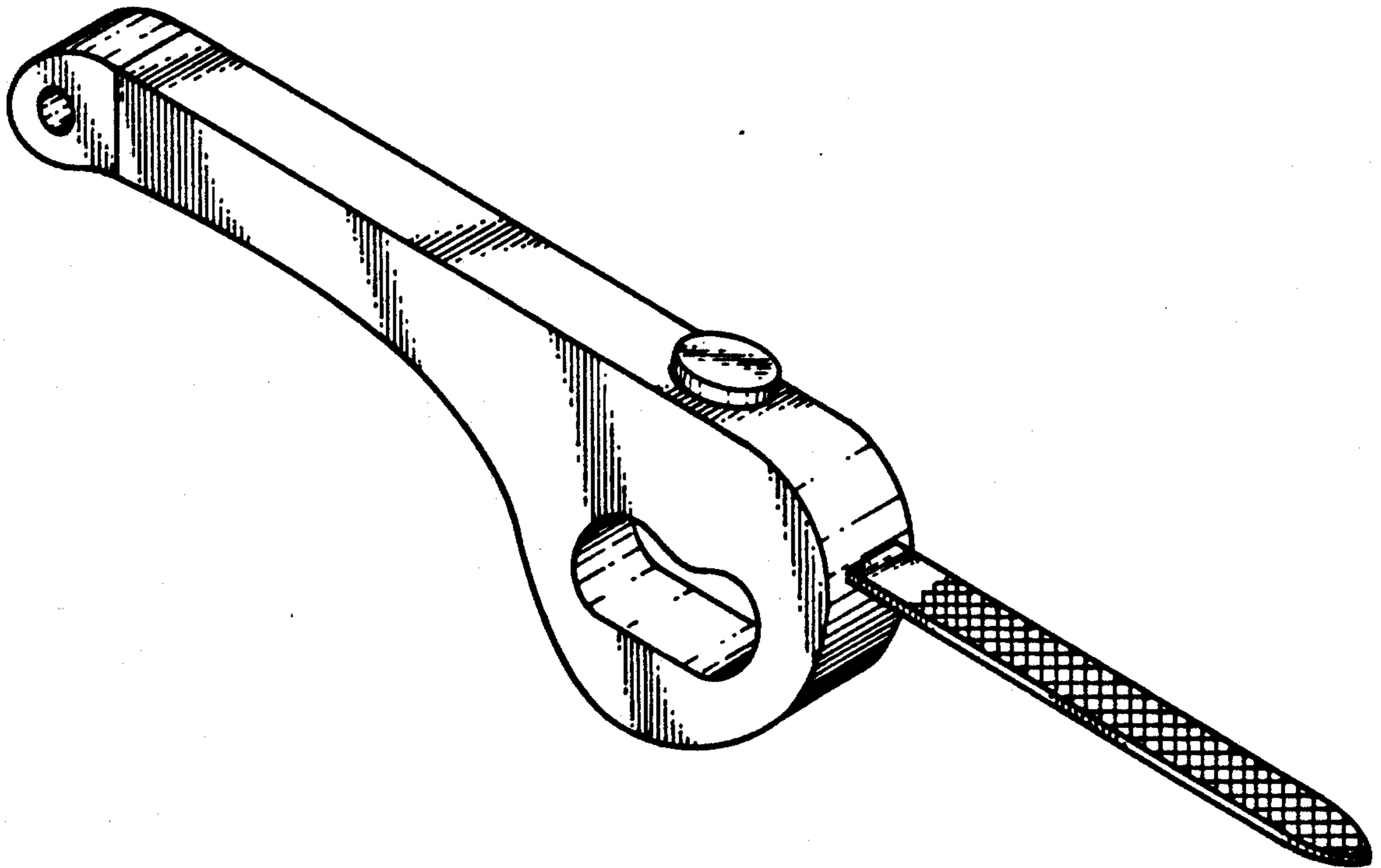
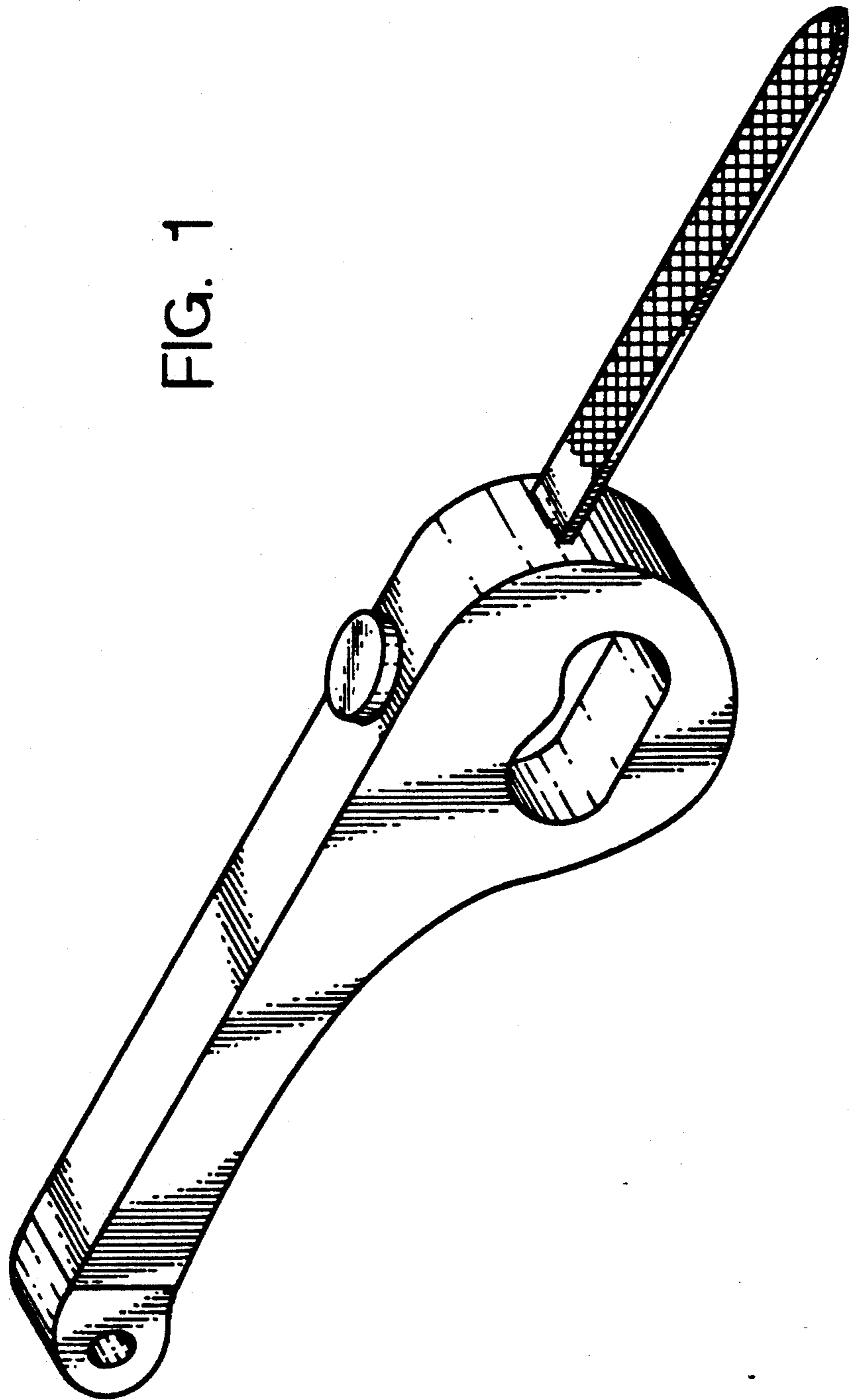

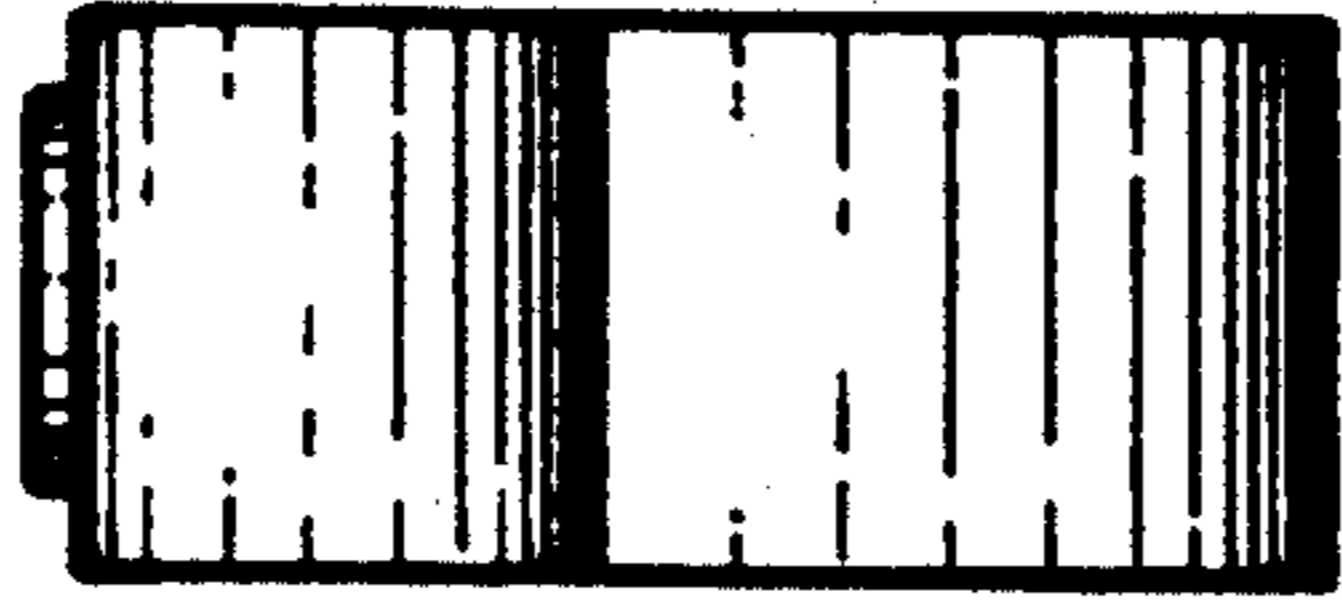

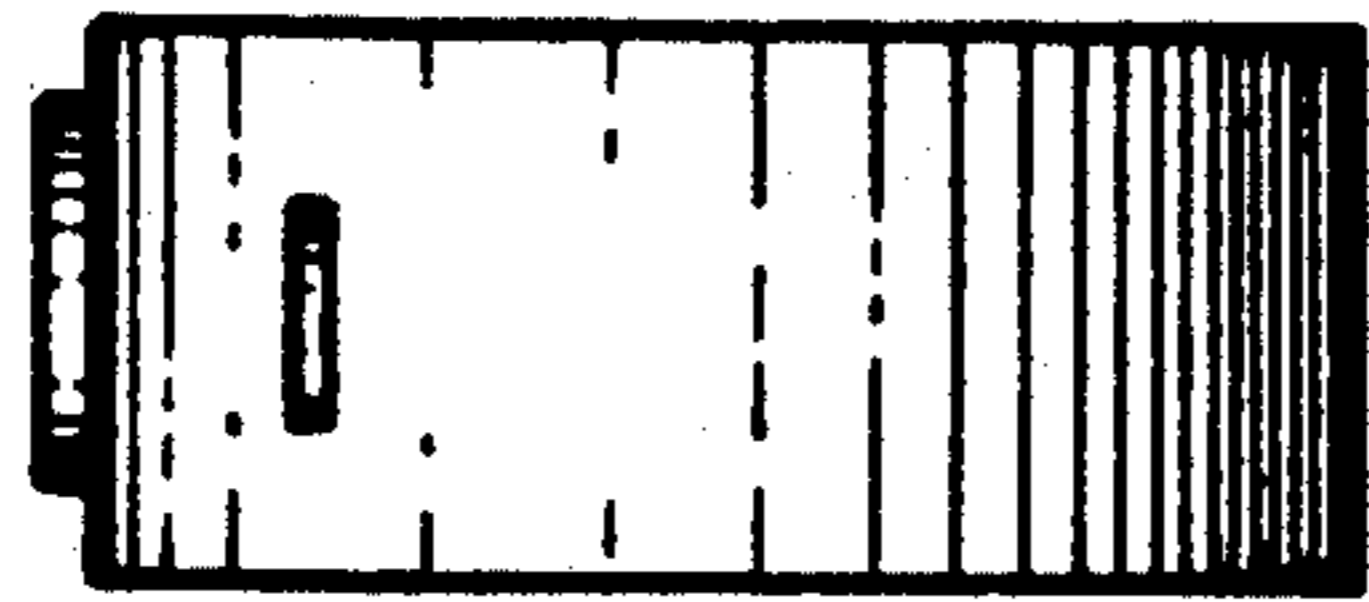

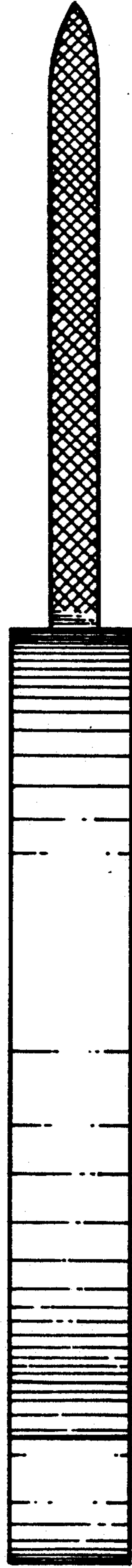

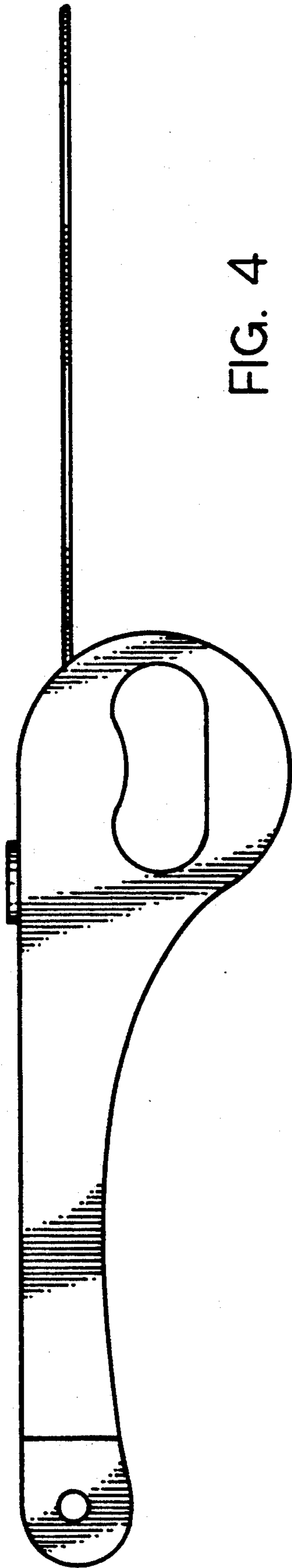

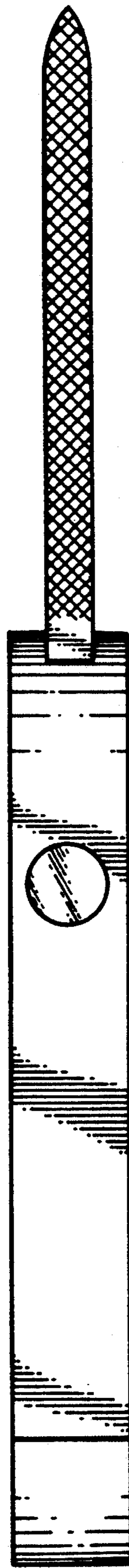
