FIG. 9 is a perspective view of a 4-tier, 6-wing (60° angle) embodiment of a media storage and display unit showing my new design; FIG. 10 is a cross-sectional view of the wing of FIG. 9, taken along lines 10-10 in FIG. 9; FIG. 11 is a perspective view of a 5-tier, 4-wing (90° angle) embodiment of a media storage and display unit showing my new design; FIG. 12 is a perspective view of a 5-tier, 3-wing (120°) angle) embodiment of a media storage and display unit showing my new design; FIG. 13 is a perspective view of a 5-tier, 5-wing (72° angle) embodiment of a media storage and display unit showing my new design; FIG. 14 is a perspective view of a 5-tier, 6-wing (60° angle) embodiment of a media storage and display unit showing my new design; FIG. 15 is a cross-sectional view of the wing of FIG. 14, taken along lines 15-15 in FIG. 14; FIG. 16 is a perspective view of a 6-tier, 4-wing (90° angle) embodiment of a media storage and display unit showing my new design; FIG. 17 is a perspective view of a 6-tier, 3-wing (120° angle) embodiment of a media storage and display unit showing my new design; FIG. 18 is a perspective view of a 6-tier, 5-wing (72° angle) embodiment of a media storage and display unit showing my new design; FIG. 19 is a perspective view of a 6-tier, 6-wing (60° angle) embodiment of a media storage and display unit showing my new design; and, FIG. 20 is a cross-sectional view of the wing of FIG. 19, taken along lines 20–20 in FIG. 19. Each embodiment of the media storage and display unit is the same in appearance throughout its periphery and each cross-sectional view represents the cross-section through any of the wings of the four embodiments it follows.
