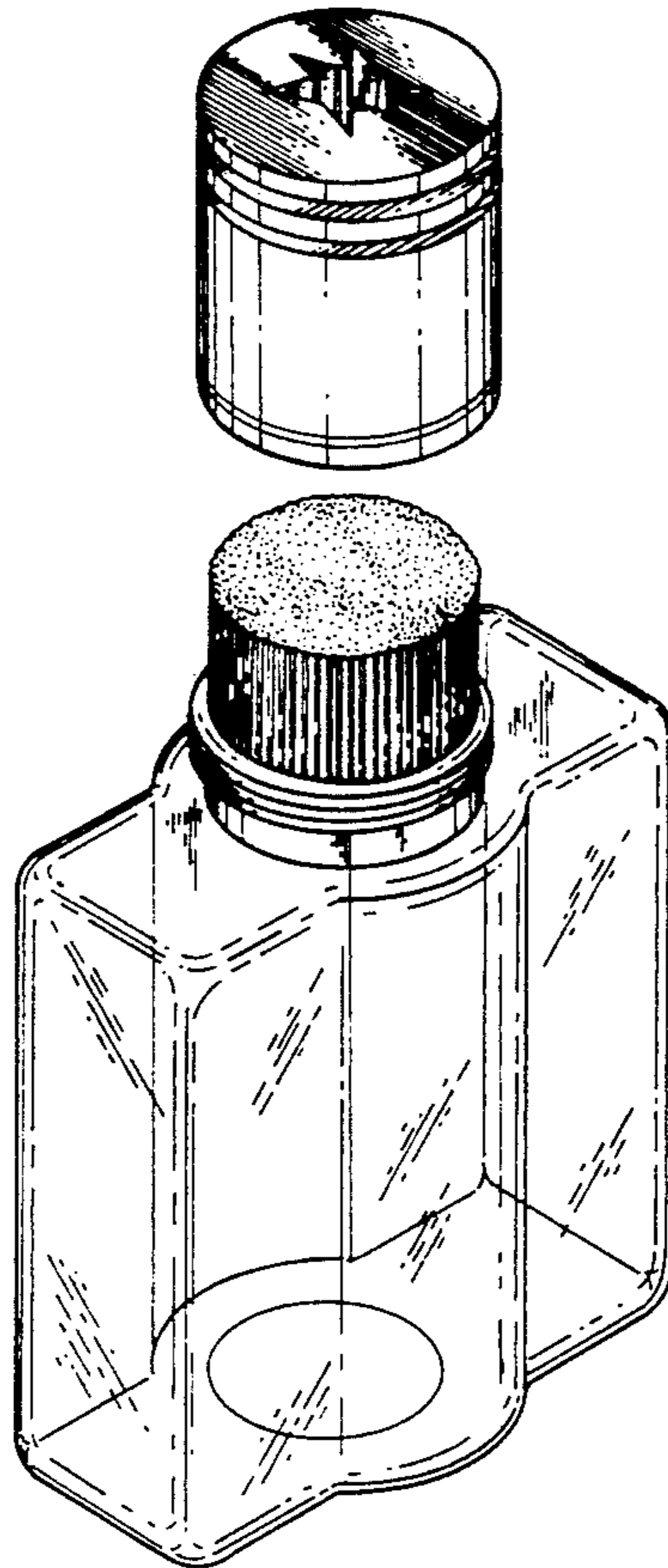

FIG. 6 is a fragmentary front elevational view shown without the cap for clarity of illustration.



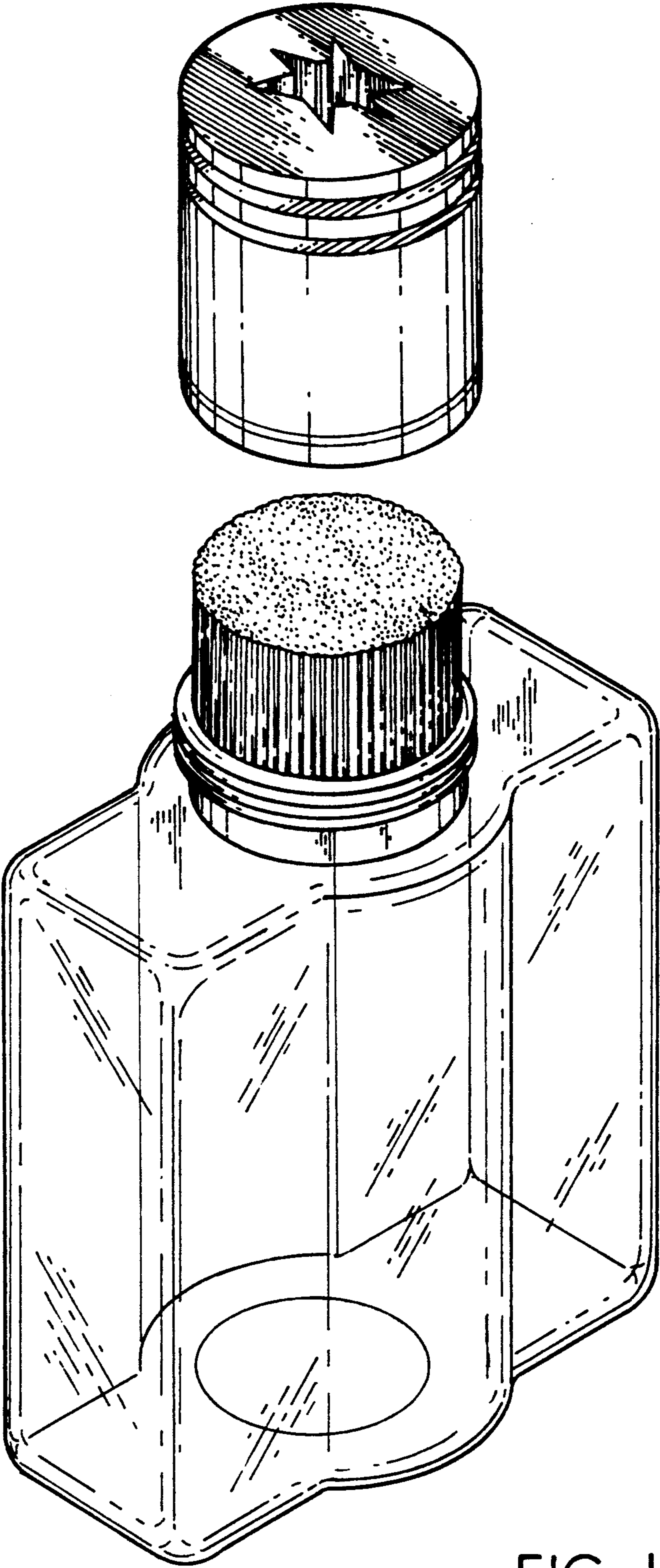

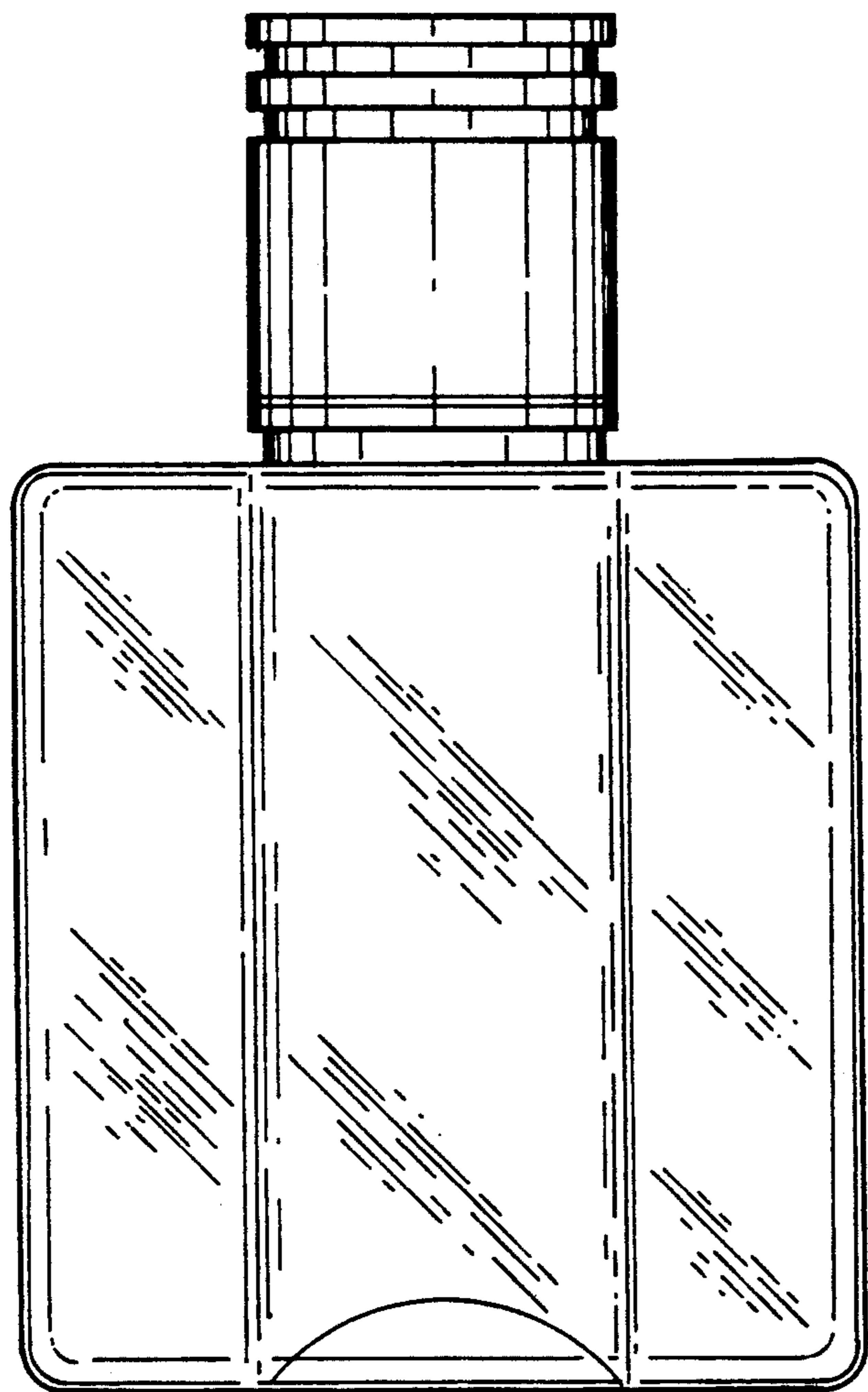

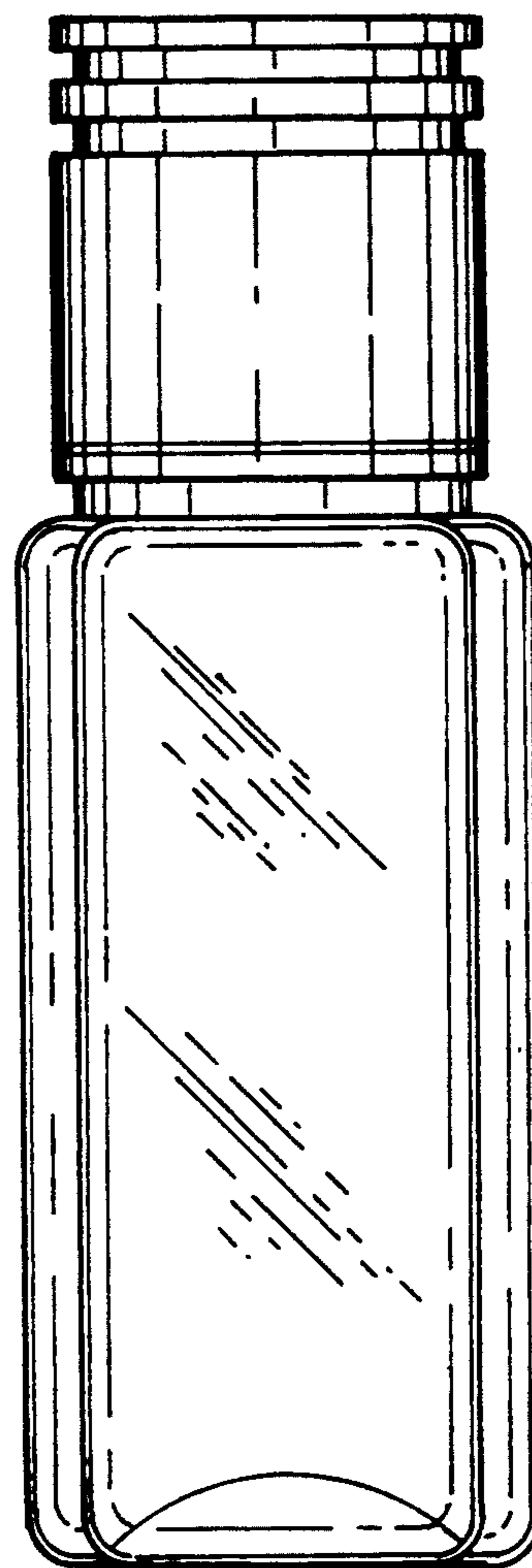

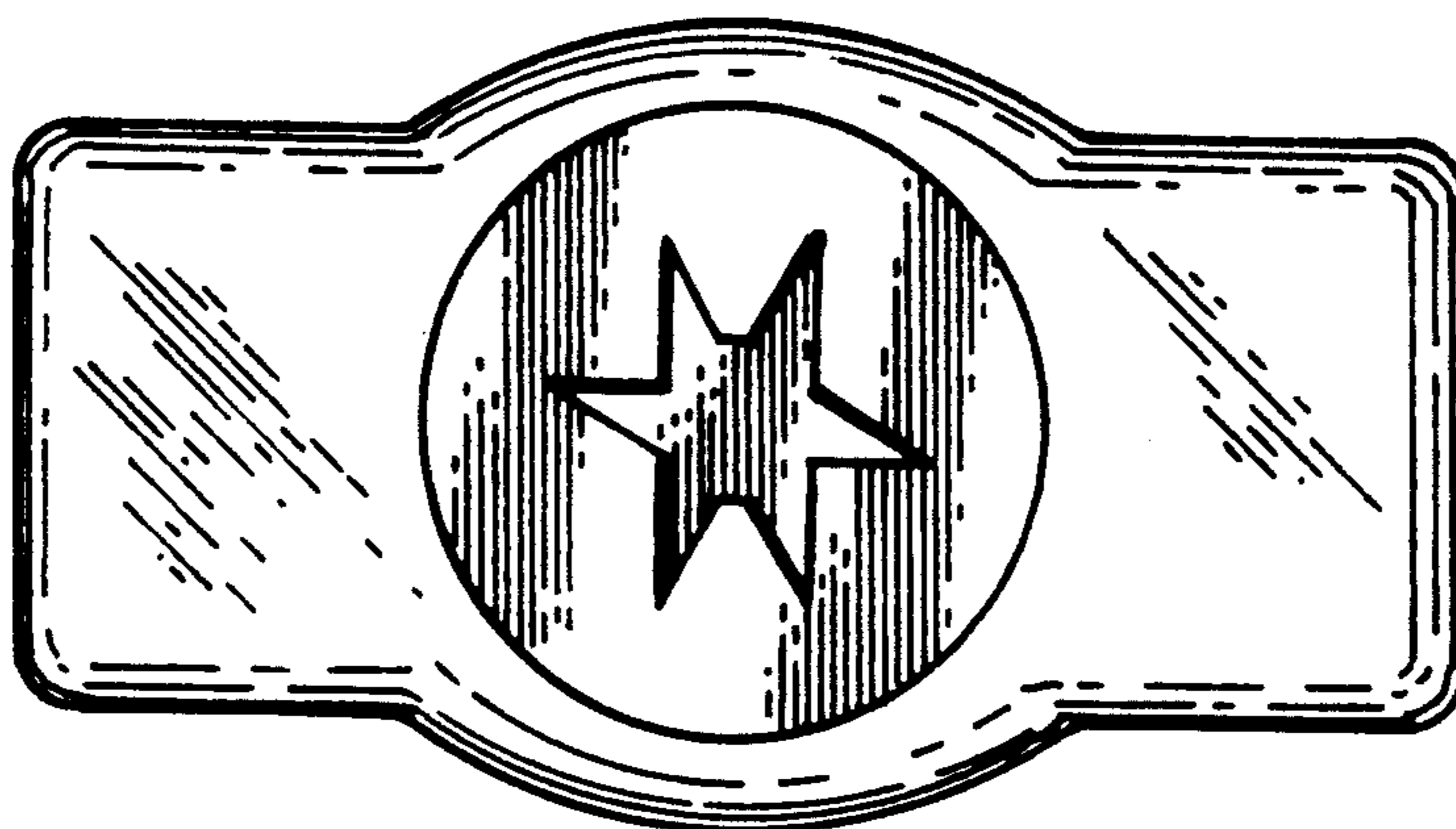

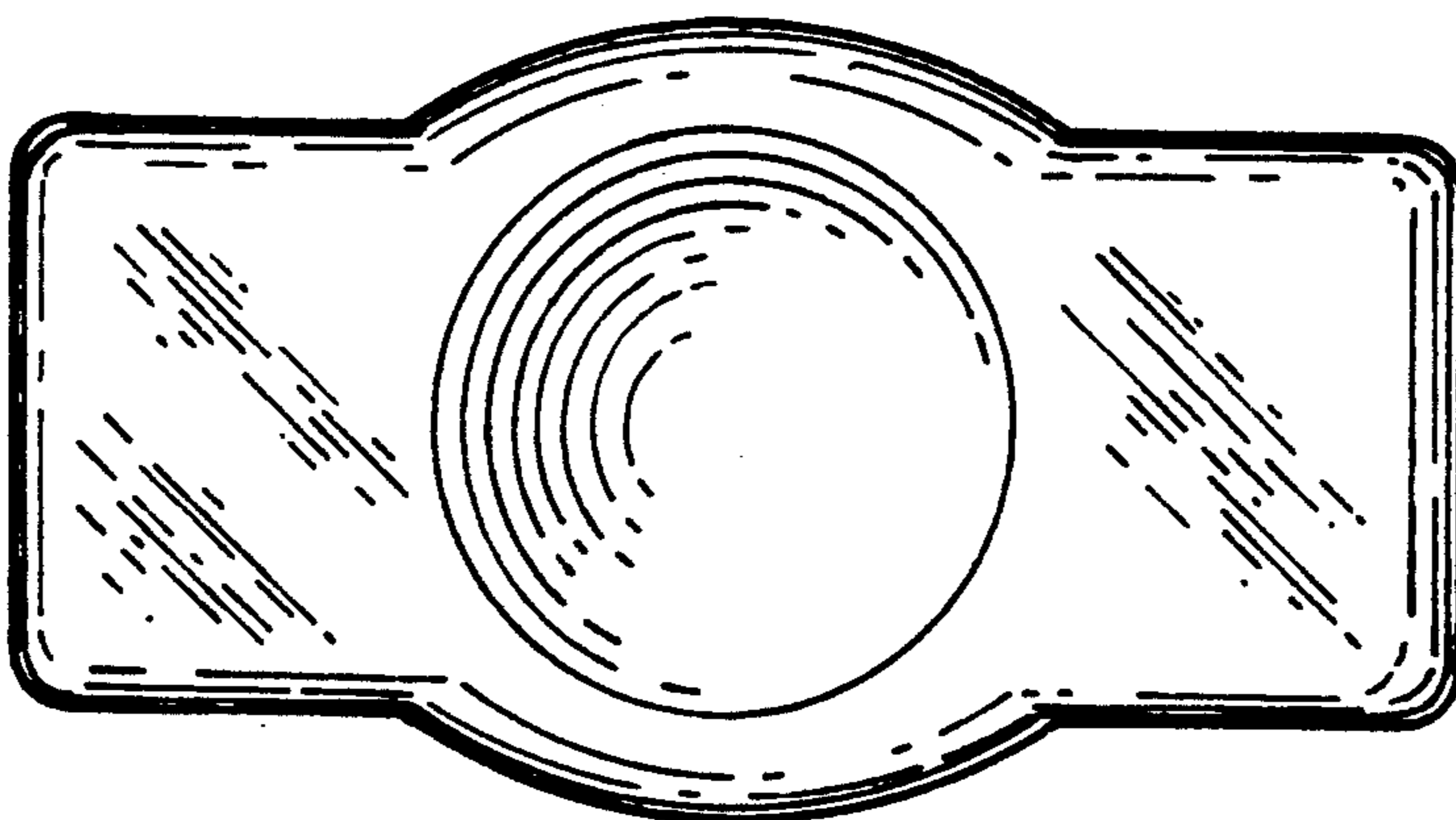

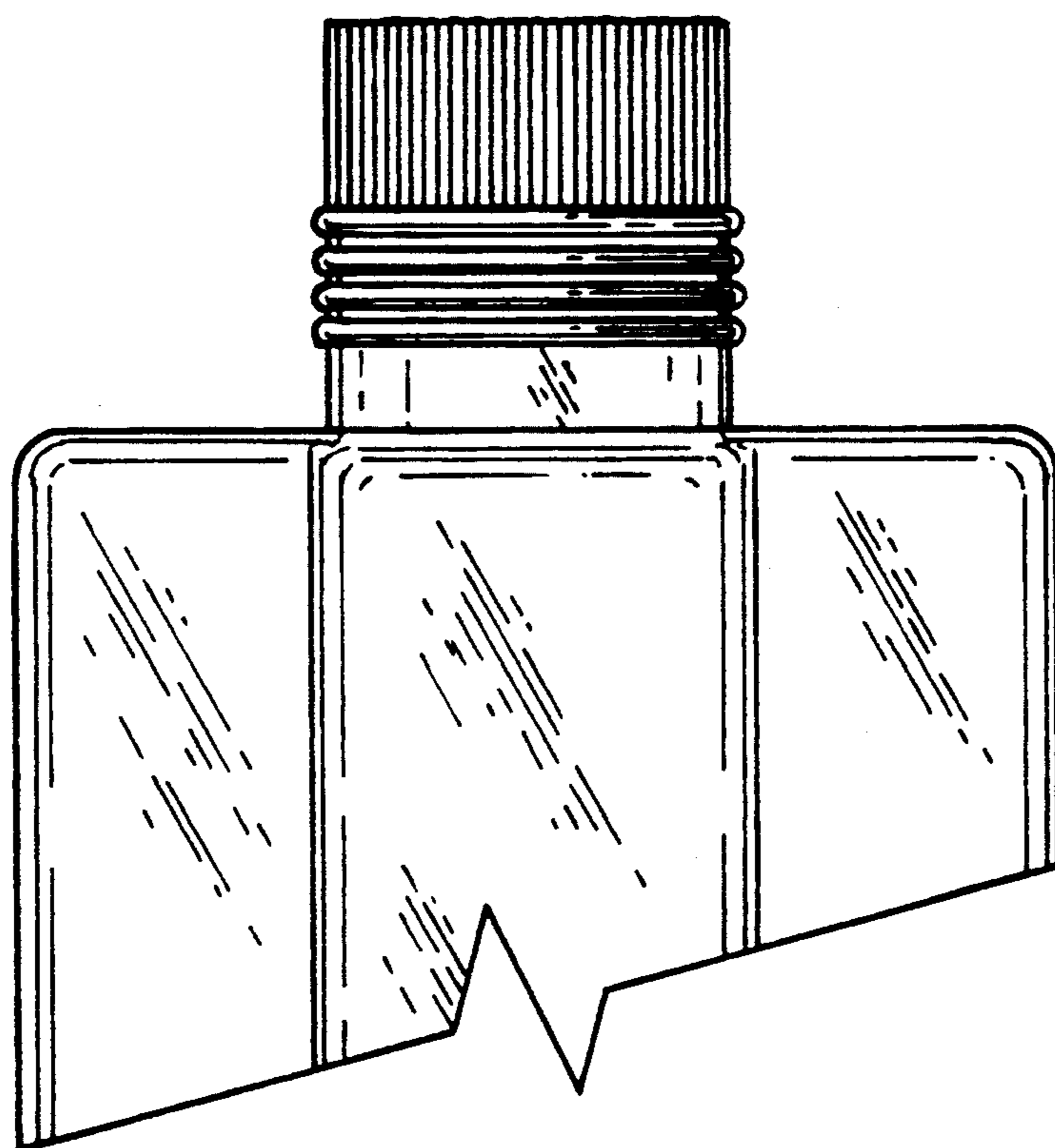
