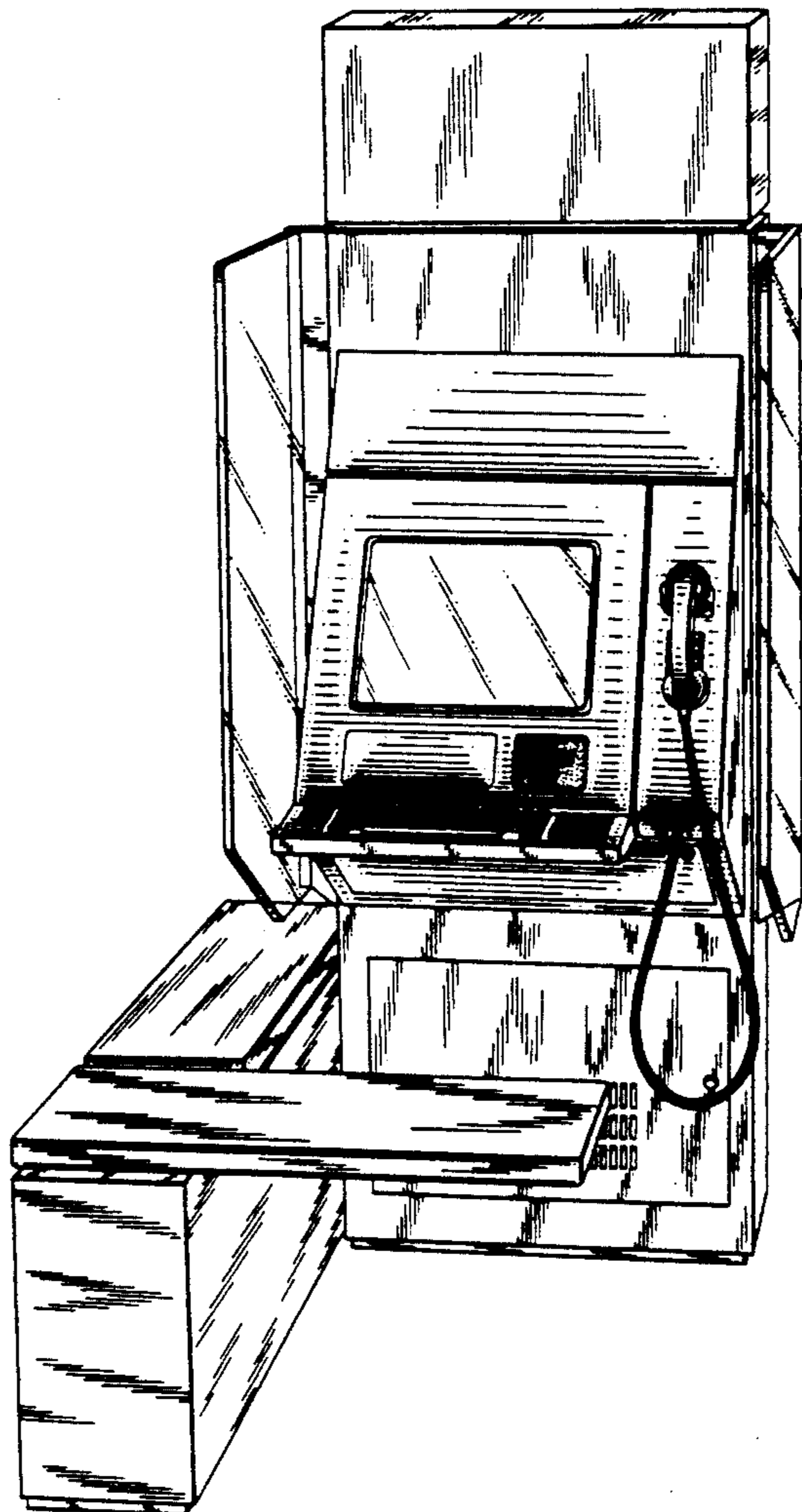
FIG. 1 is an isometric view of an ornamental public information access terminal or similar article showing my new design;

FIG. 5 is back elevation view thereof.



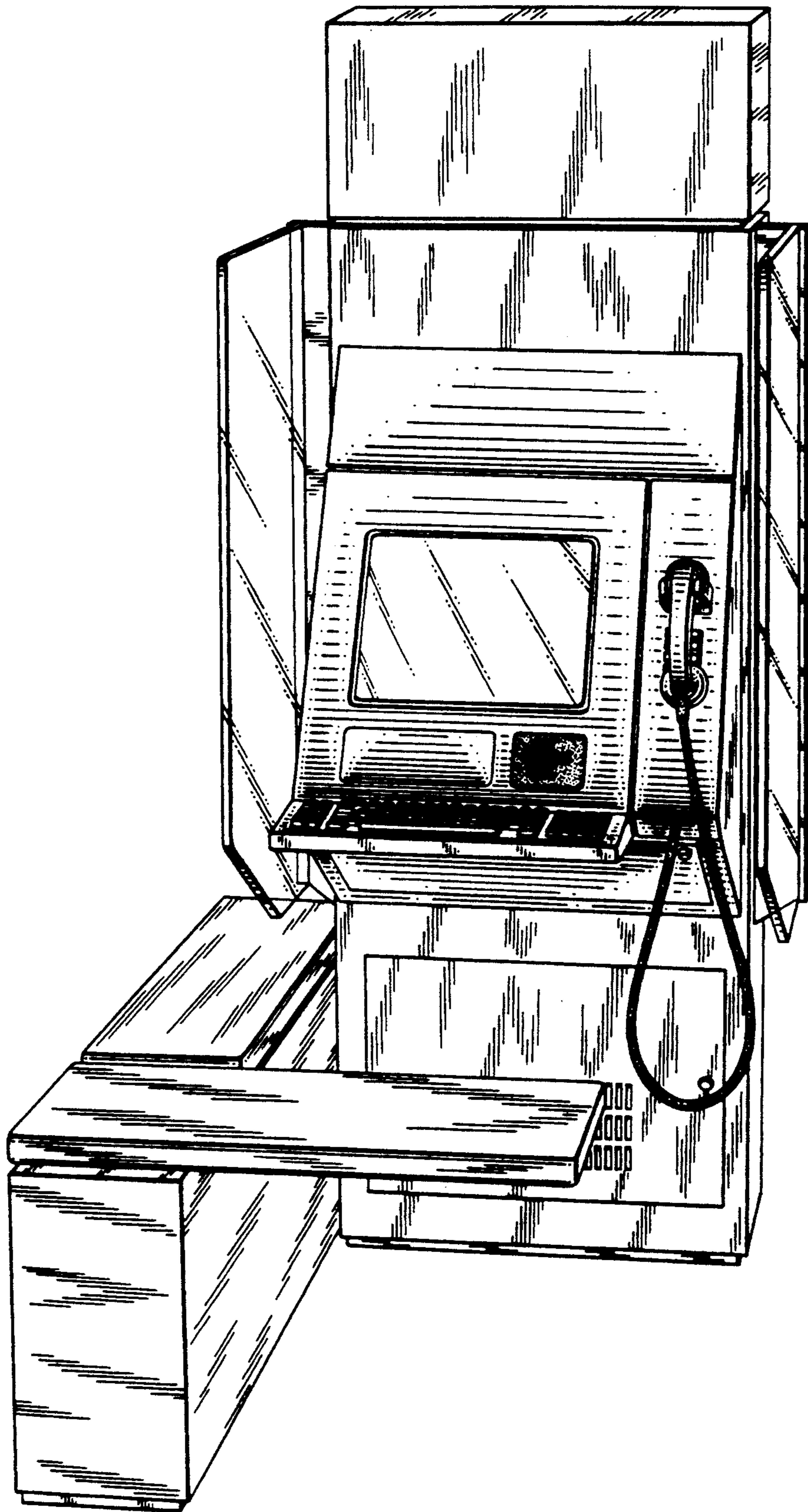

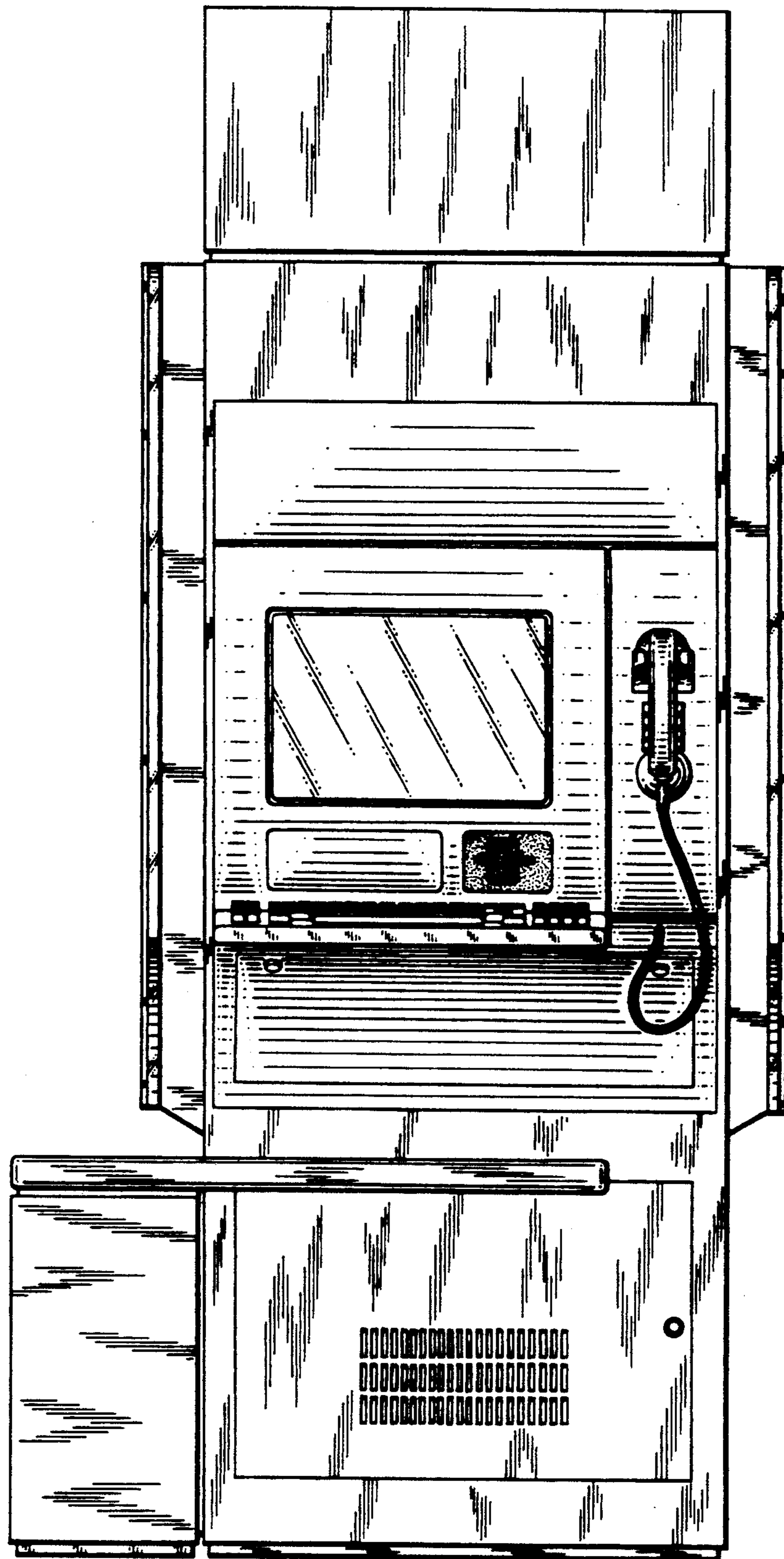

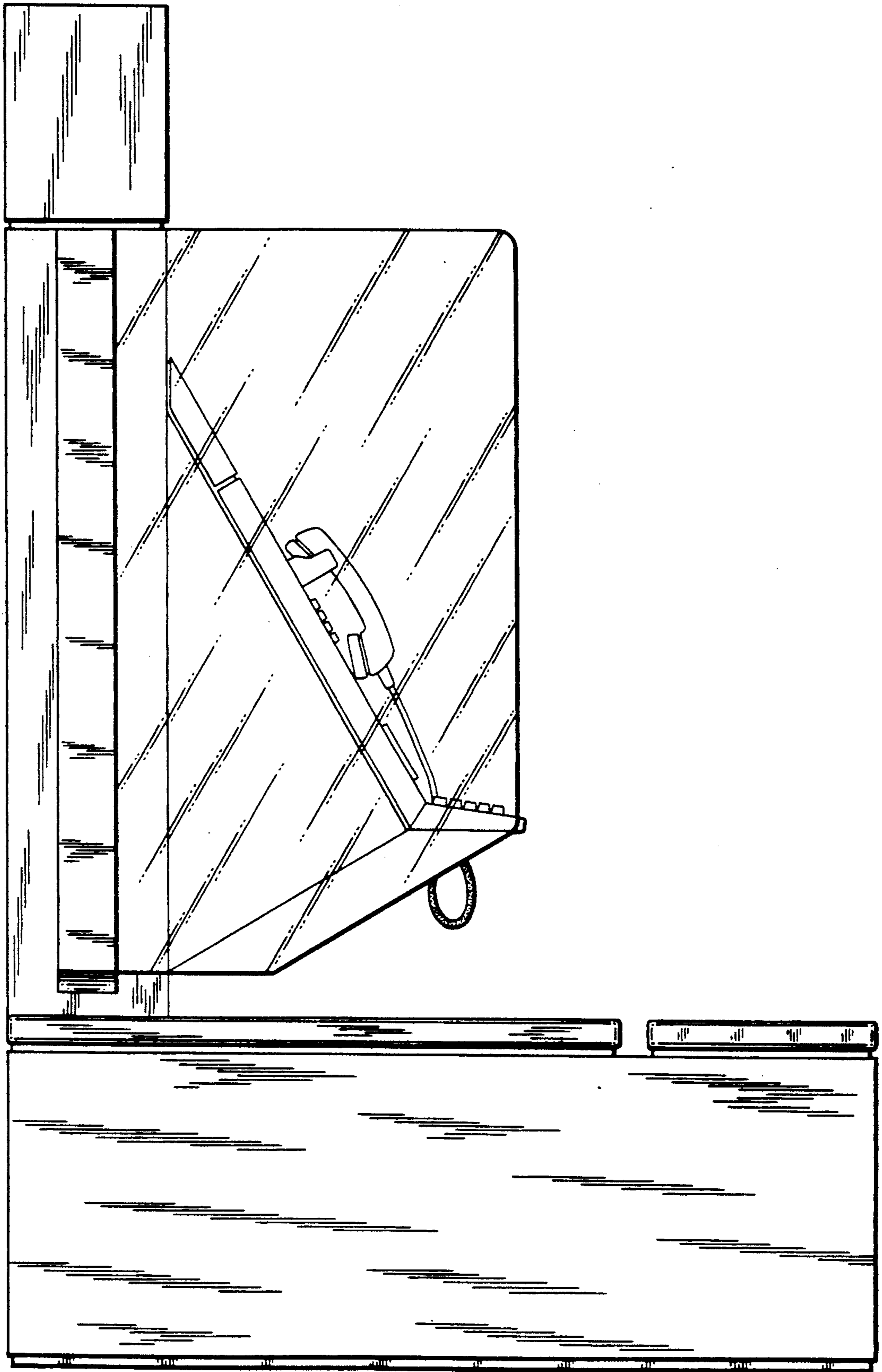

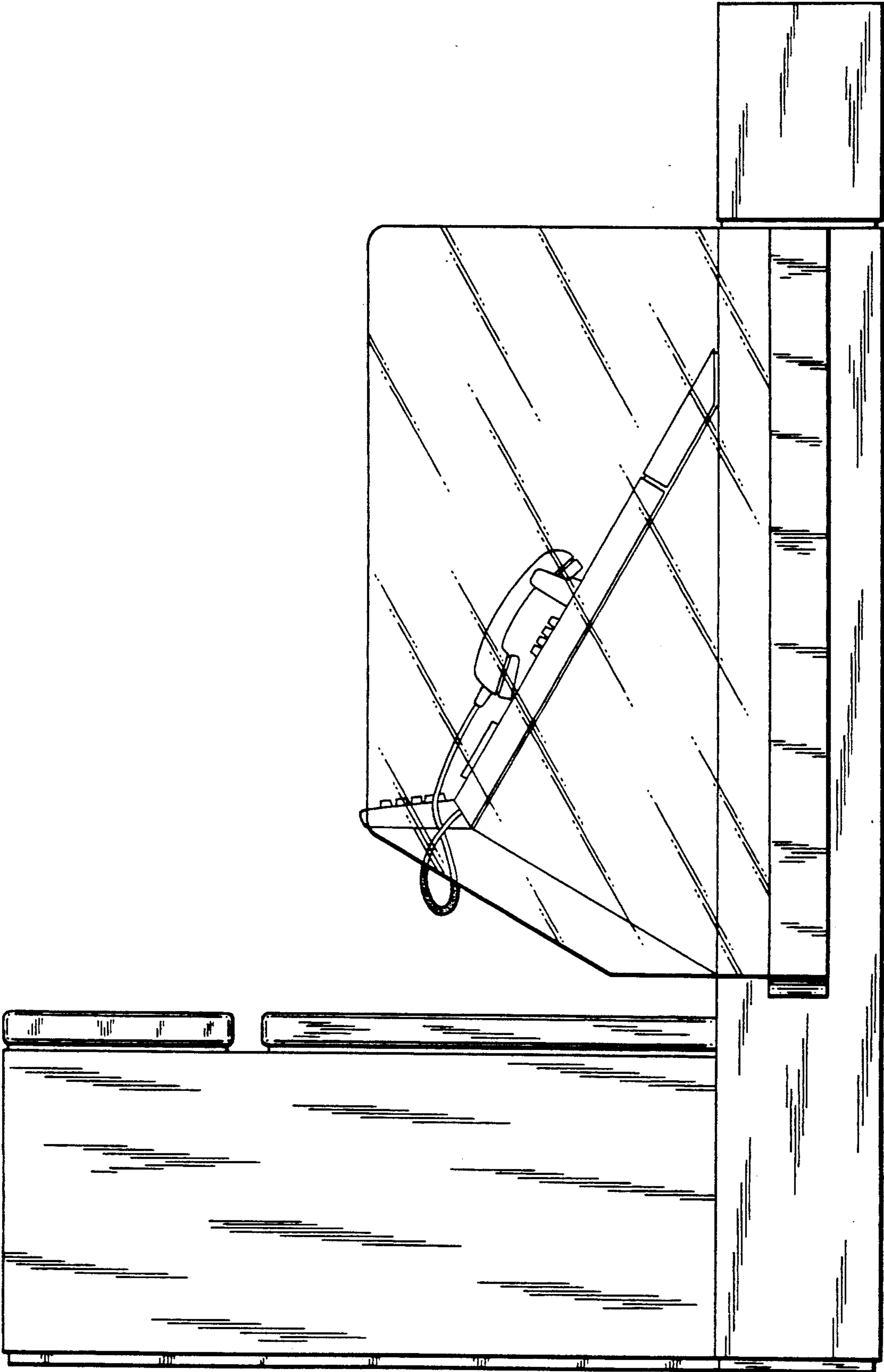

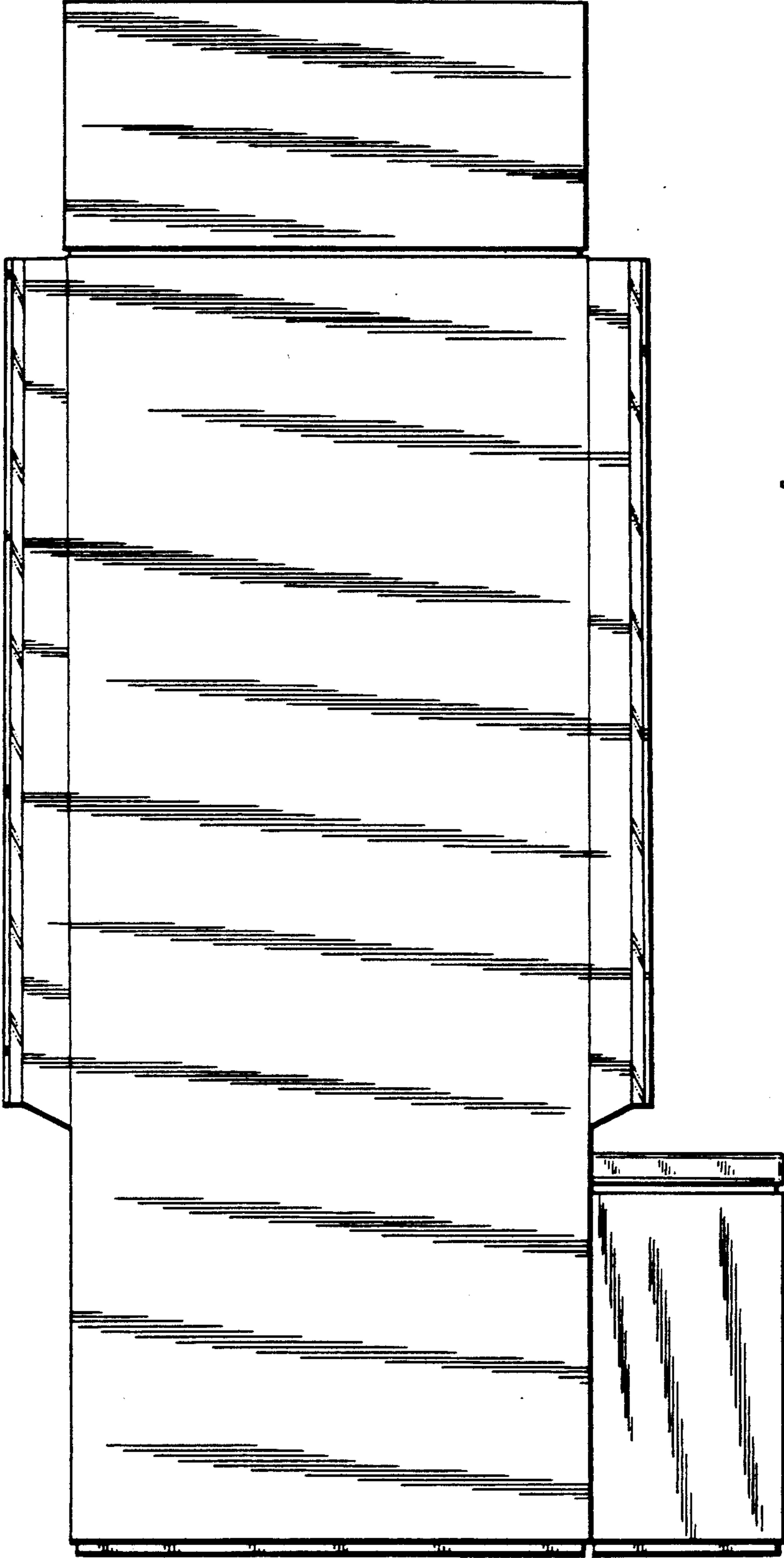
