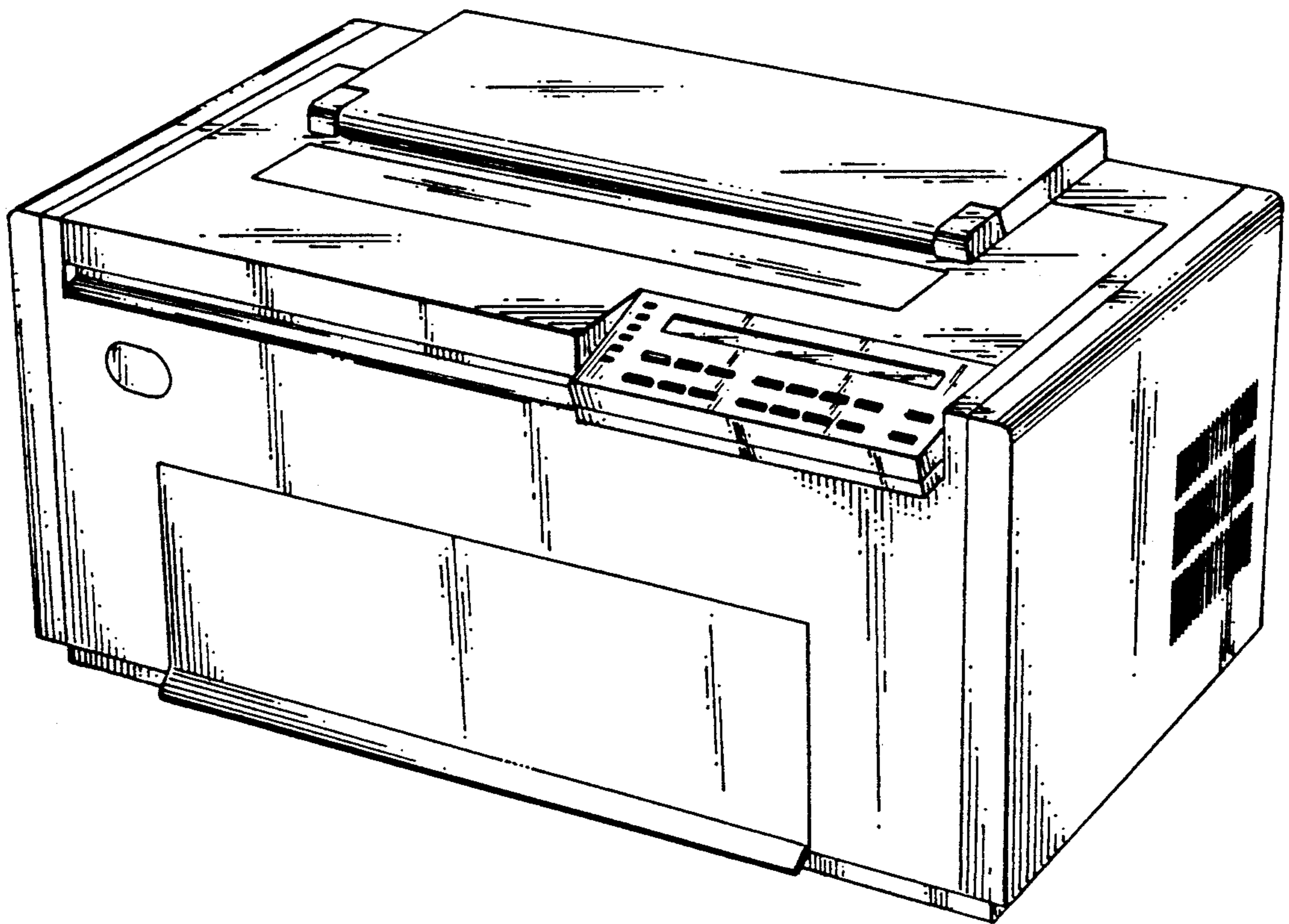

The ornamental design for a printer cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a right perspective view of the printer cover showing our design;

FIG. 7 is a bottom plan view thereof.



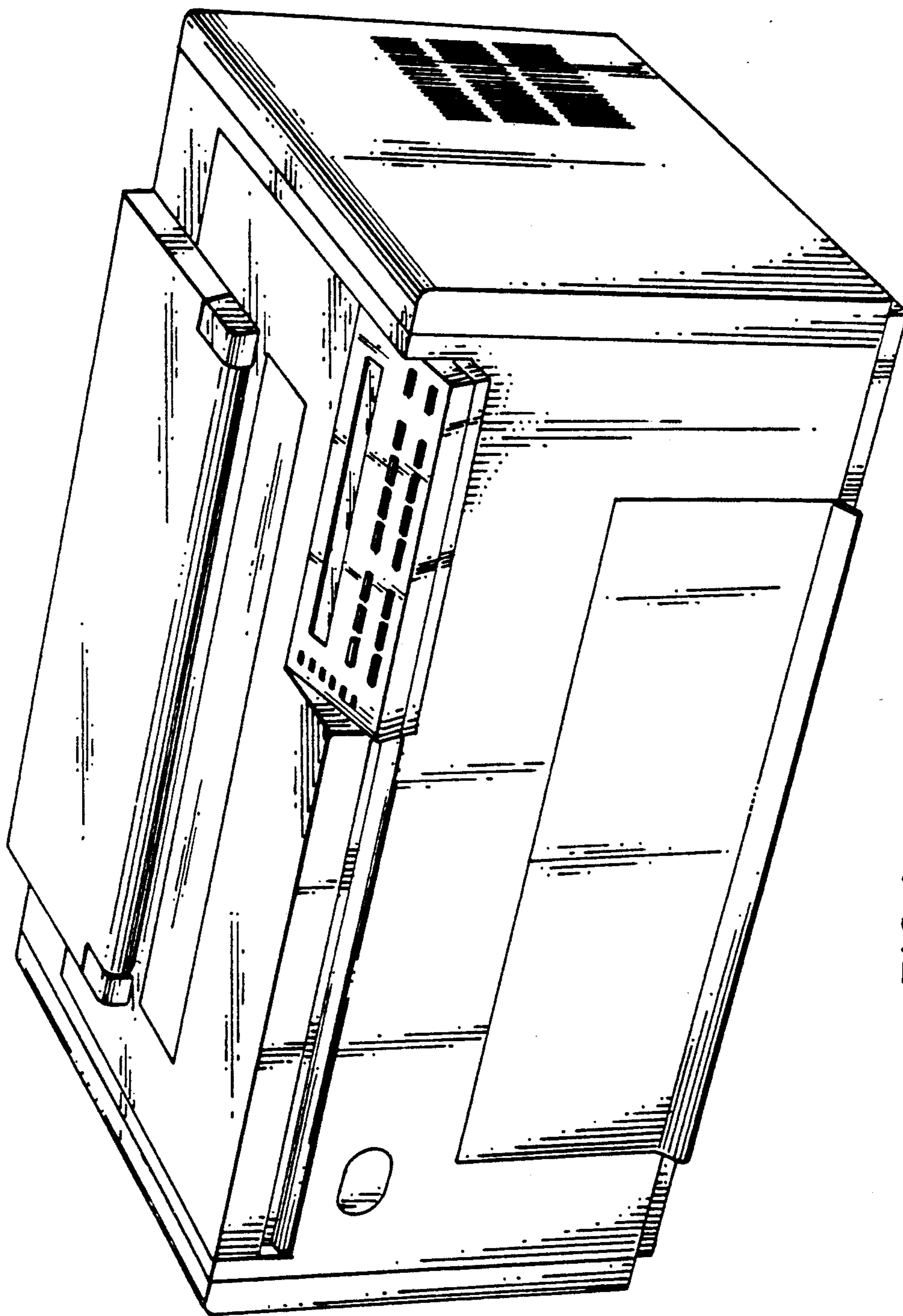

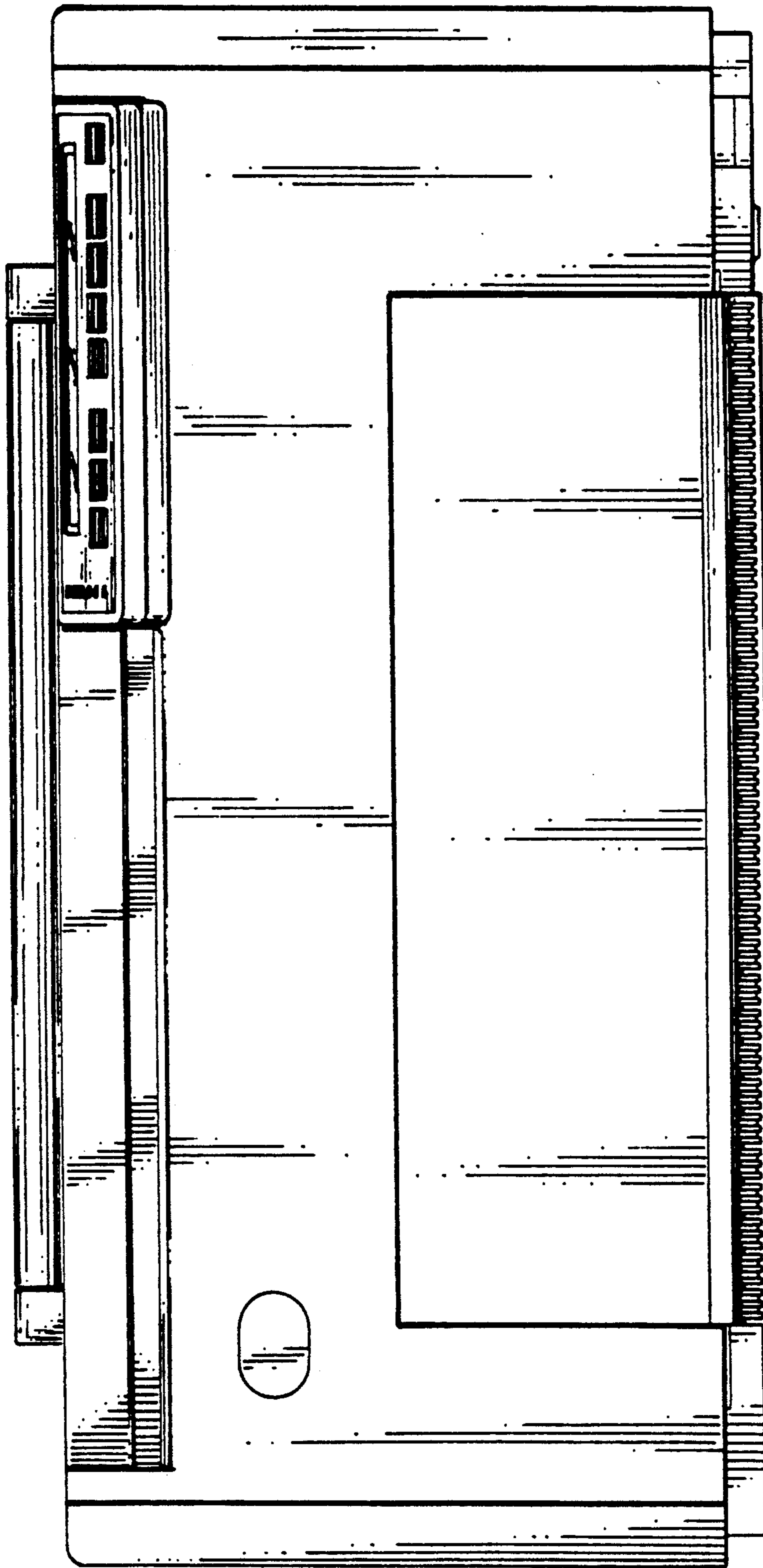

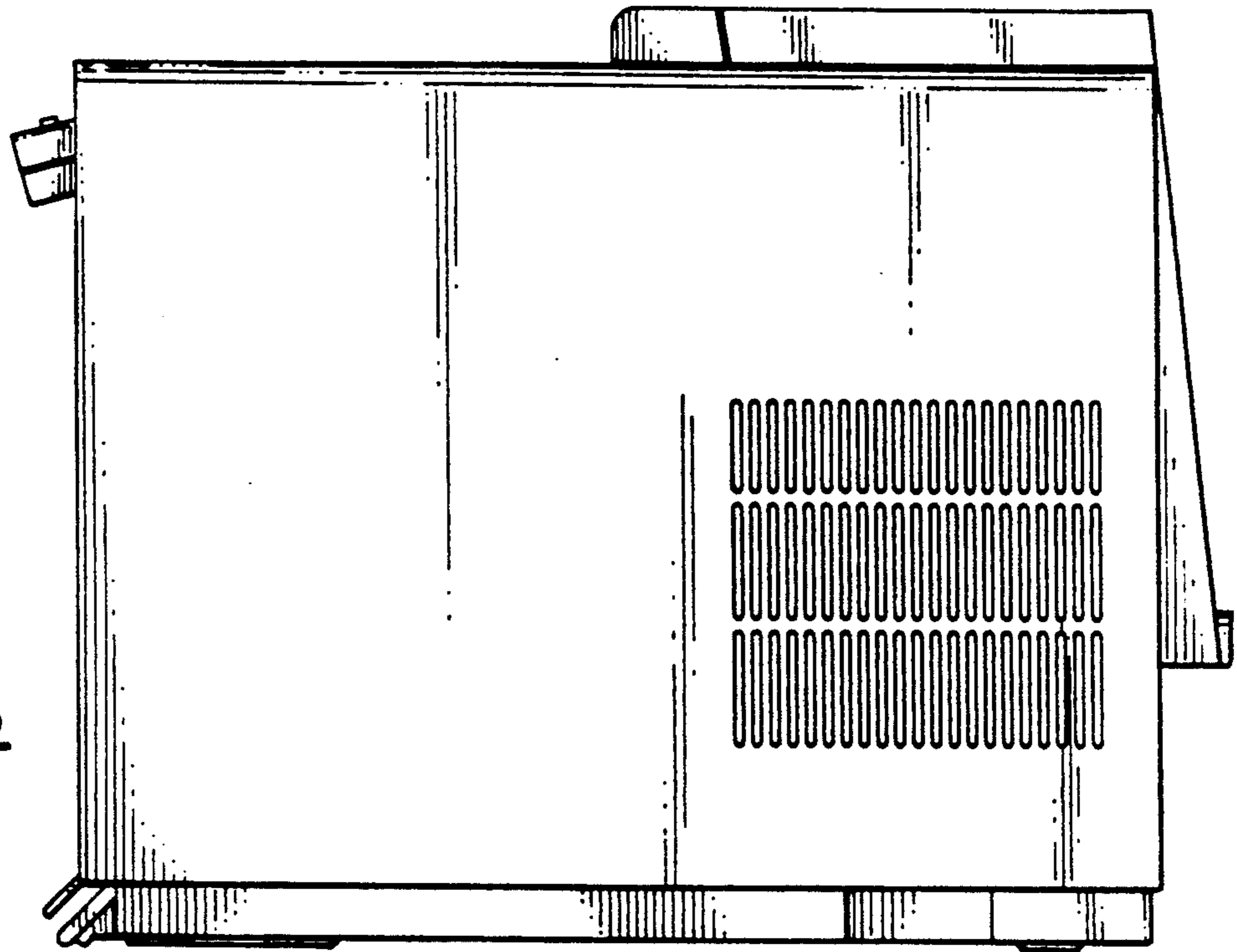
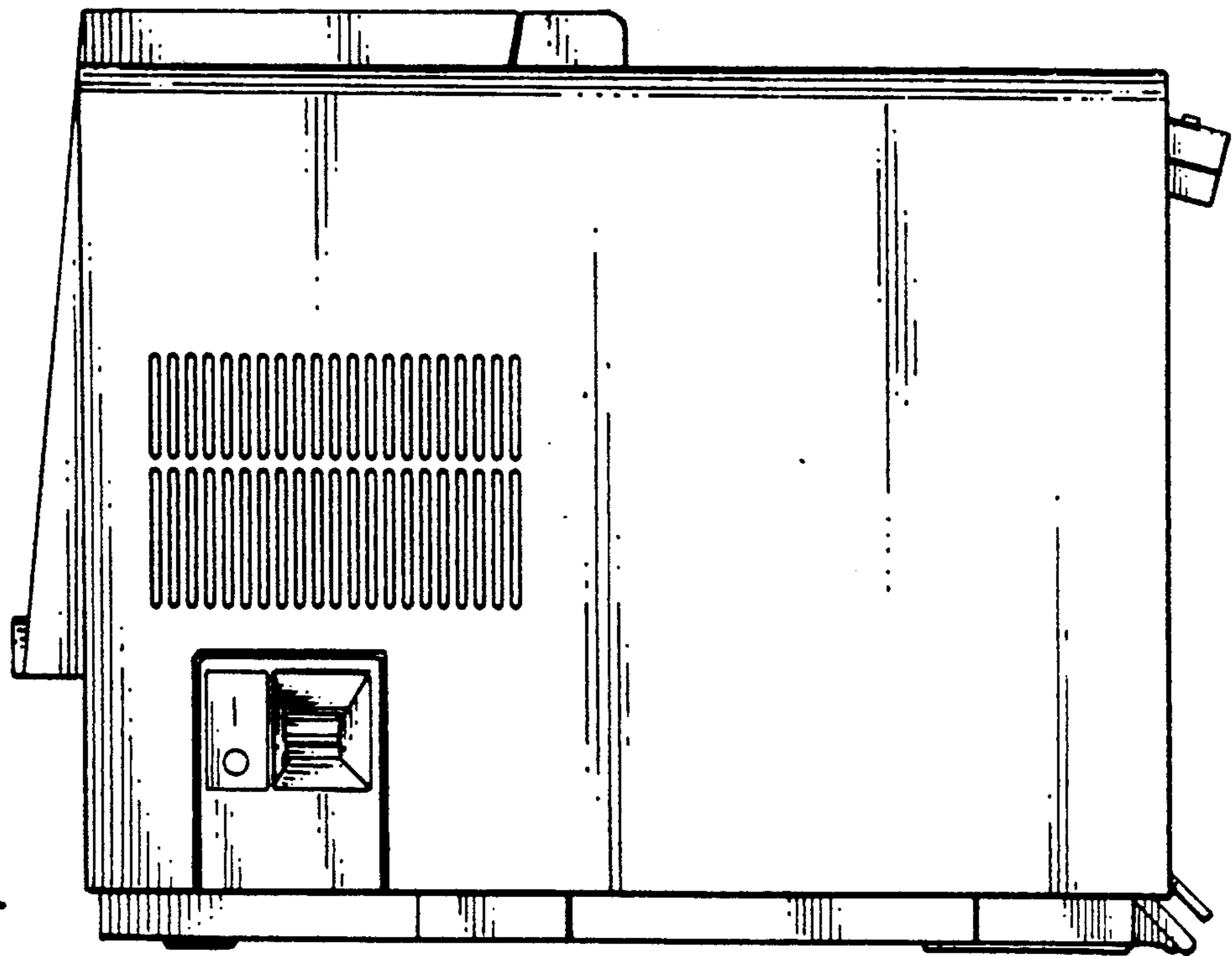

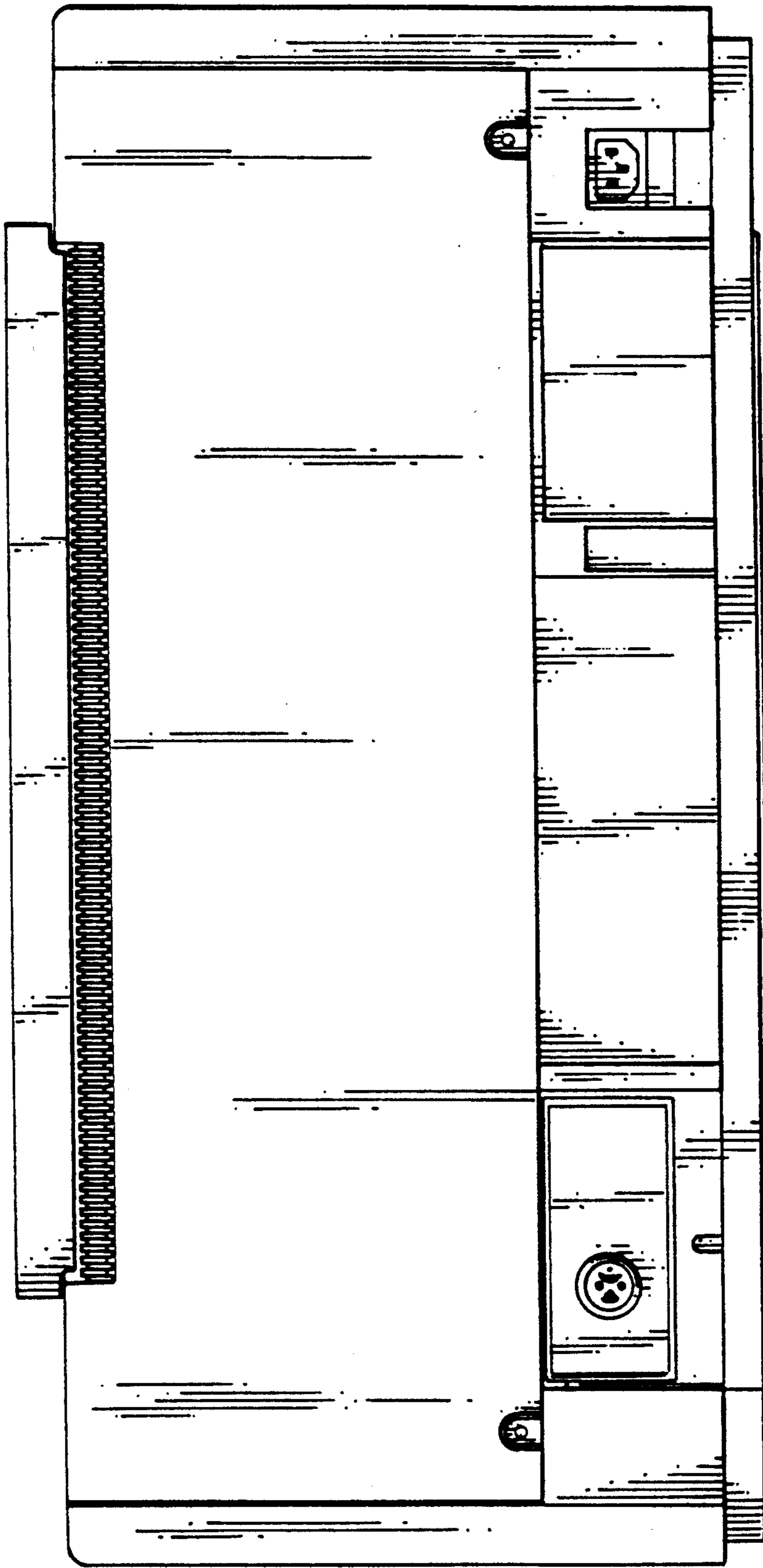

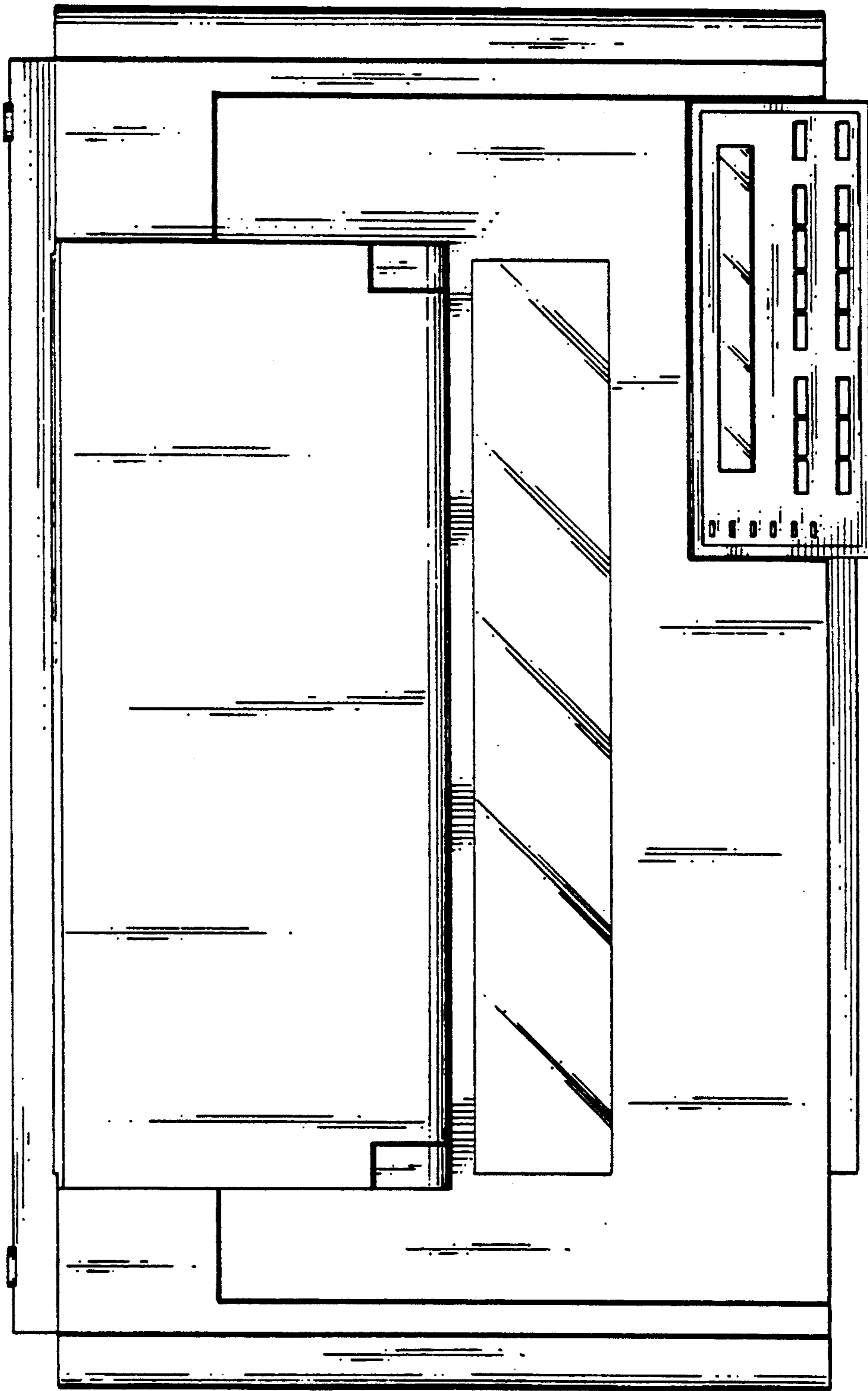

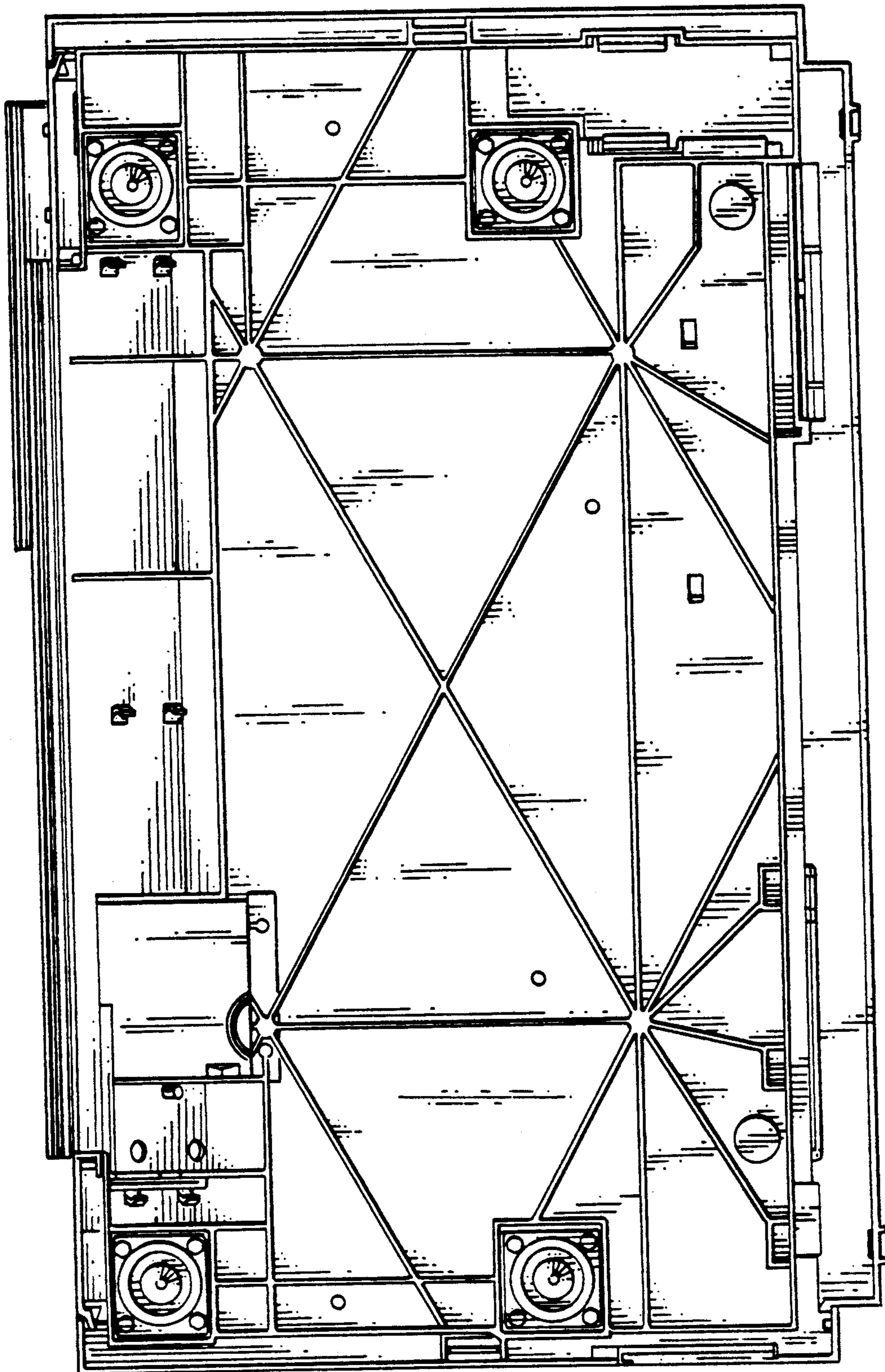
