FIG. 27 is a top plan view of view of FIG. 22; and,

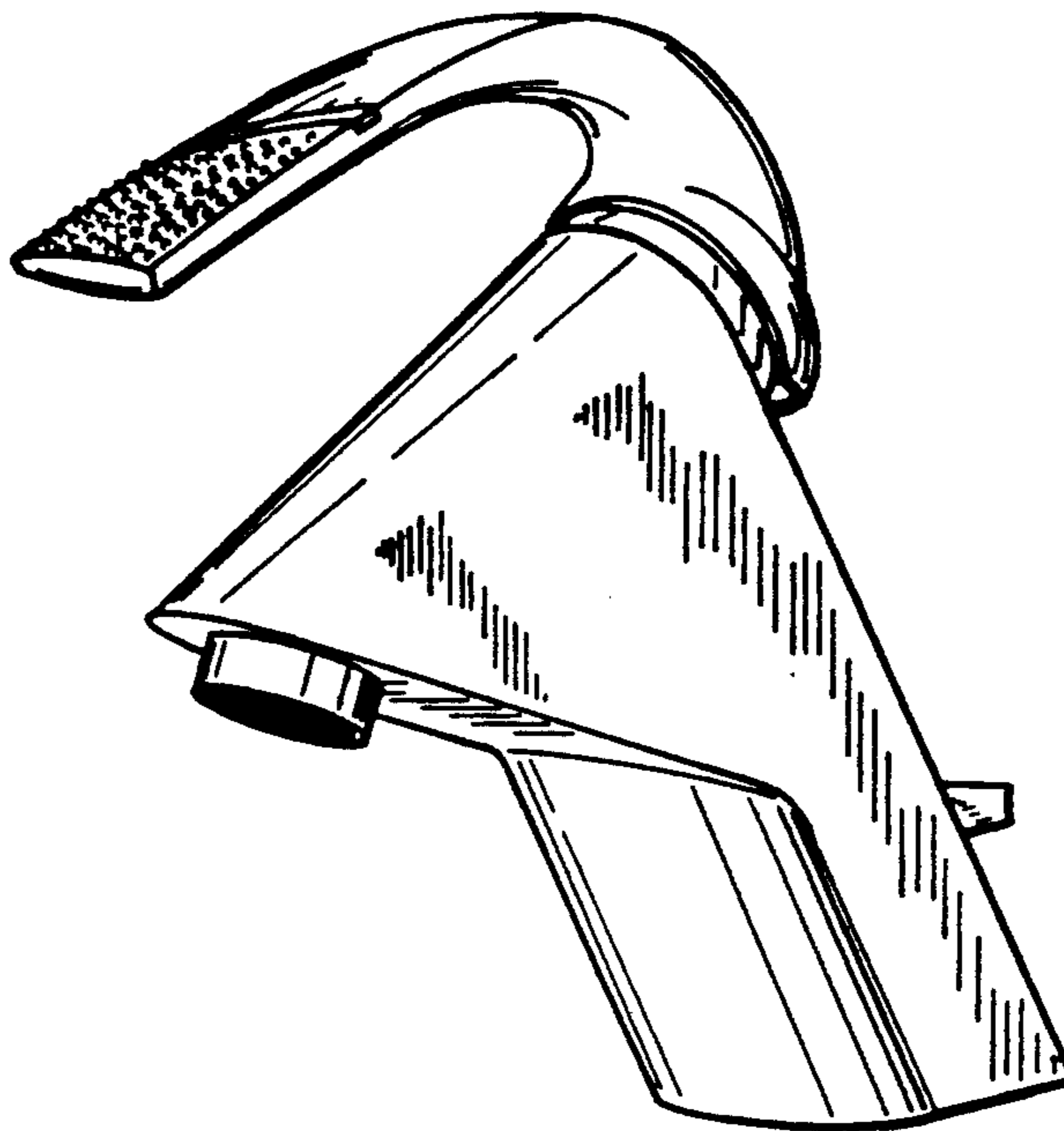
FIG. 28 is a bottom plan view of FIG. 22.

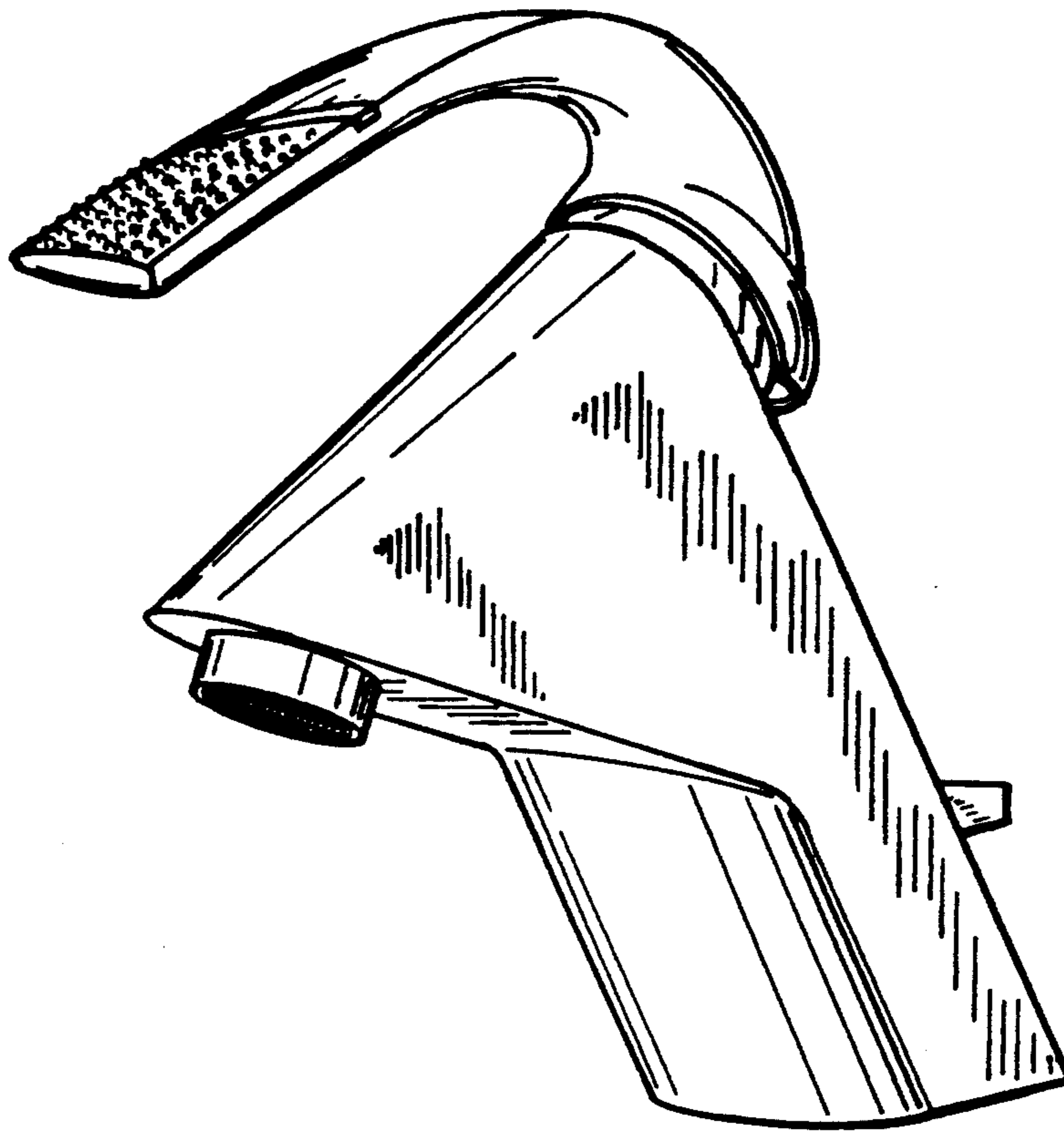

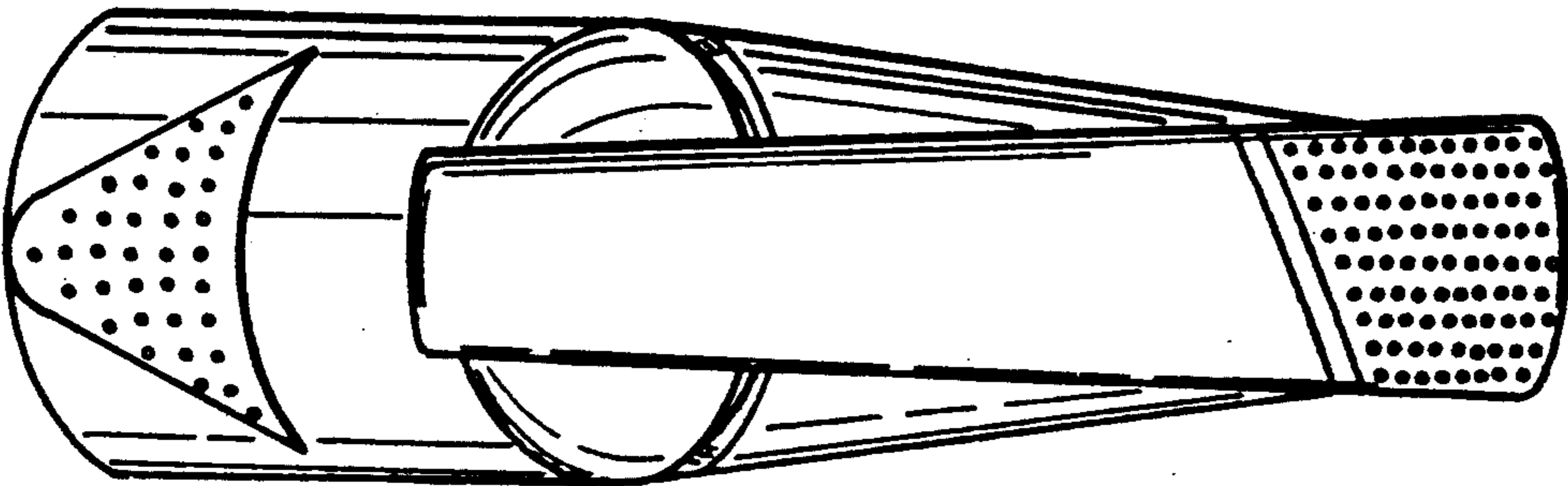

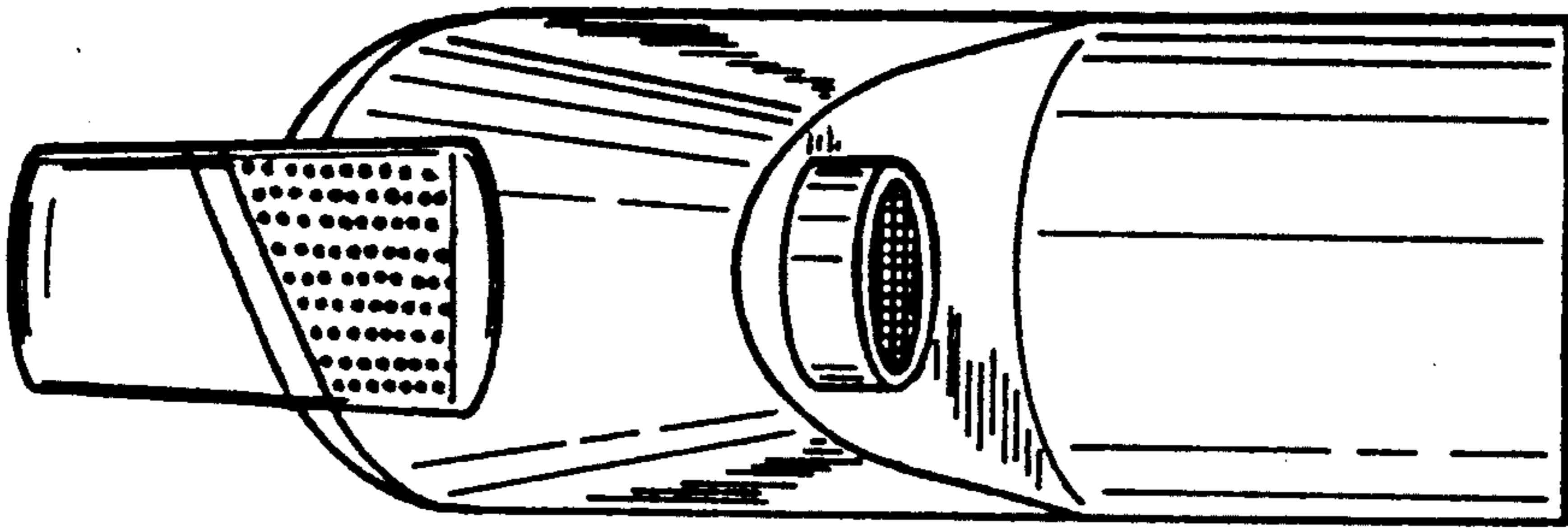

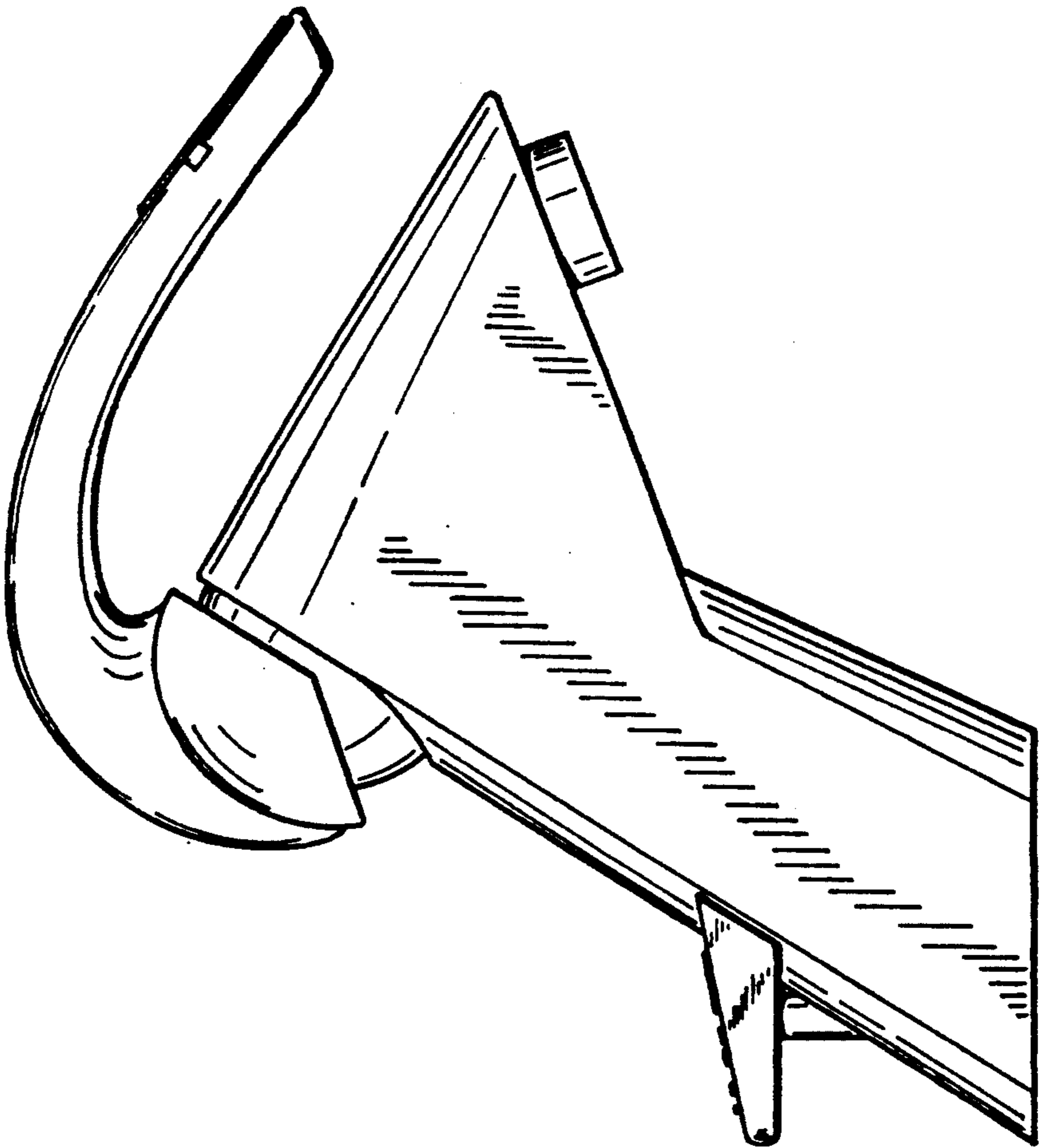

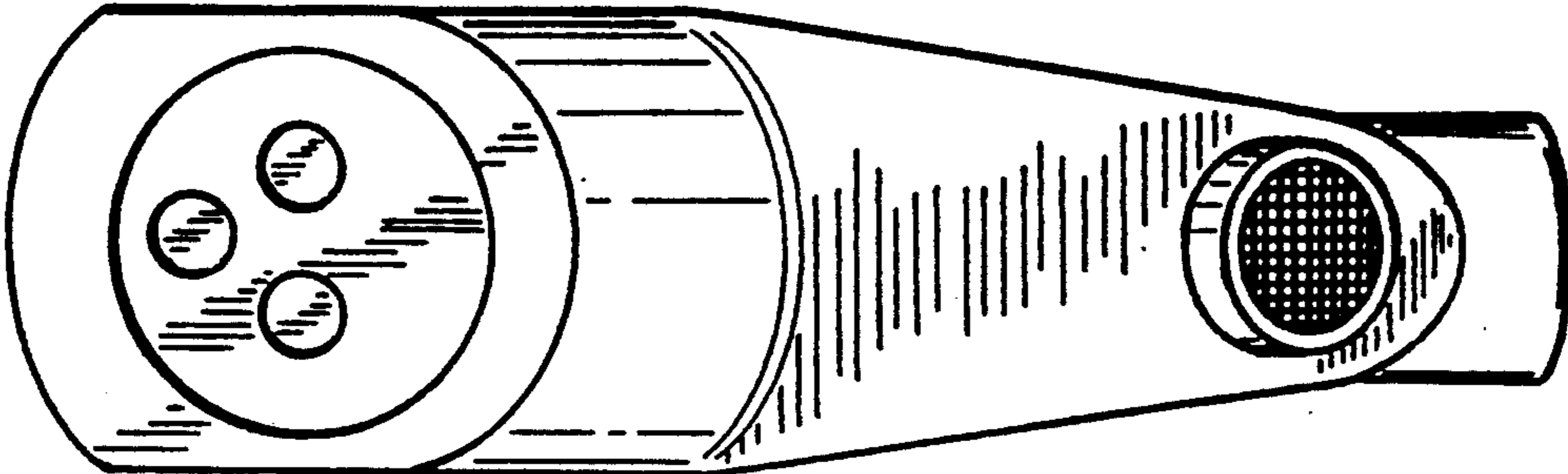

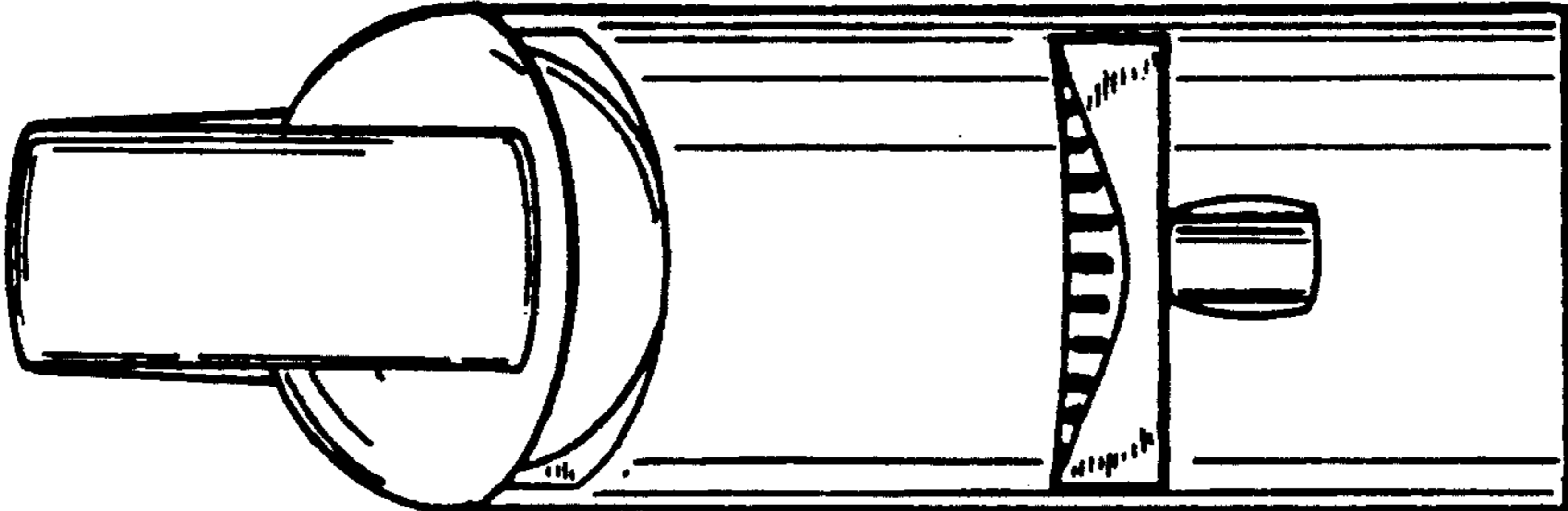

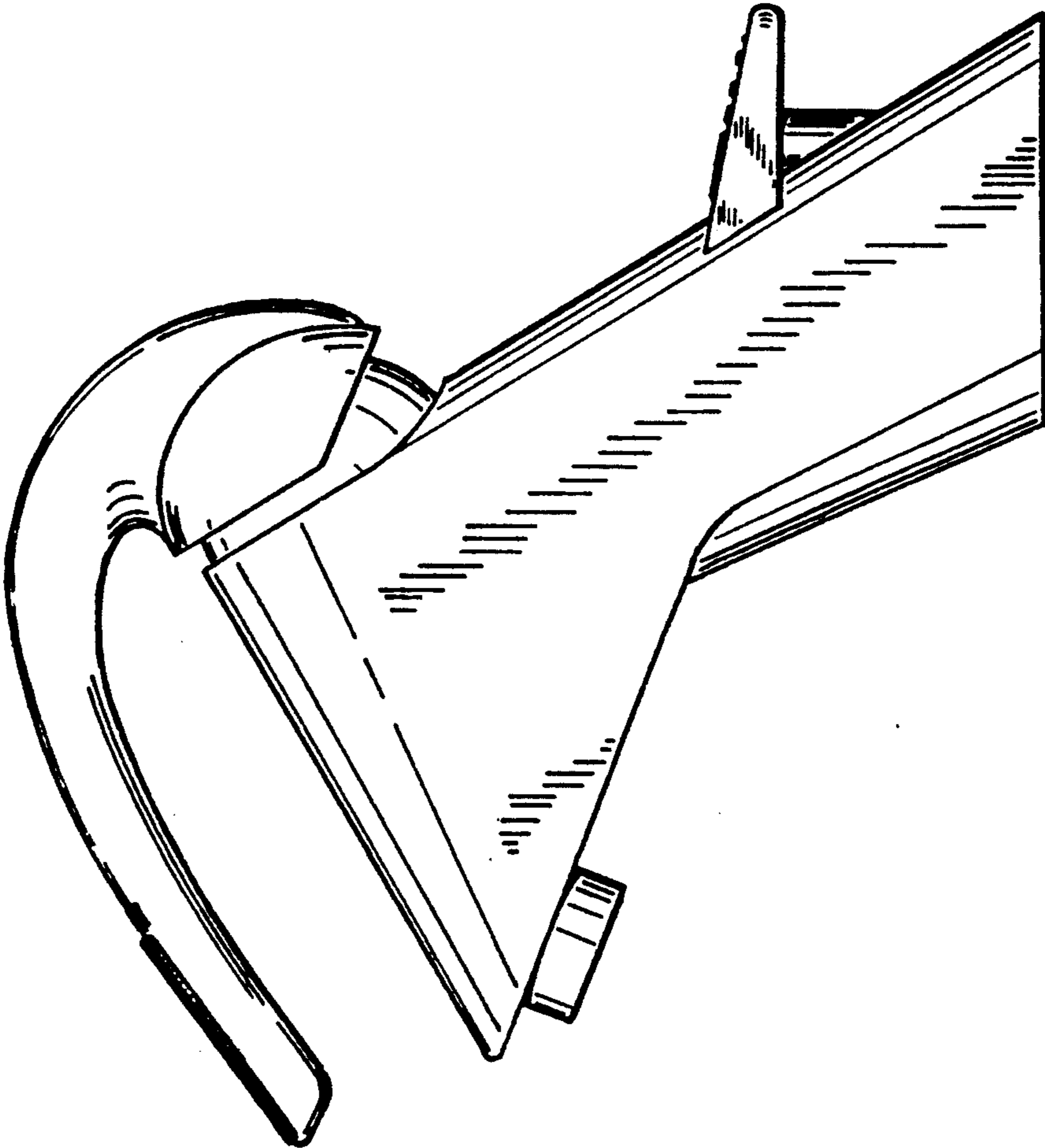
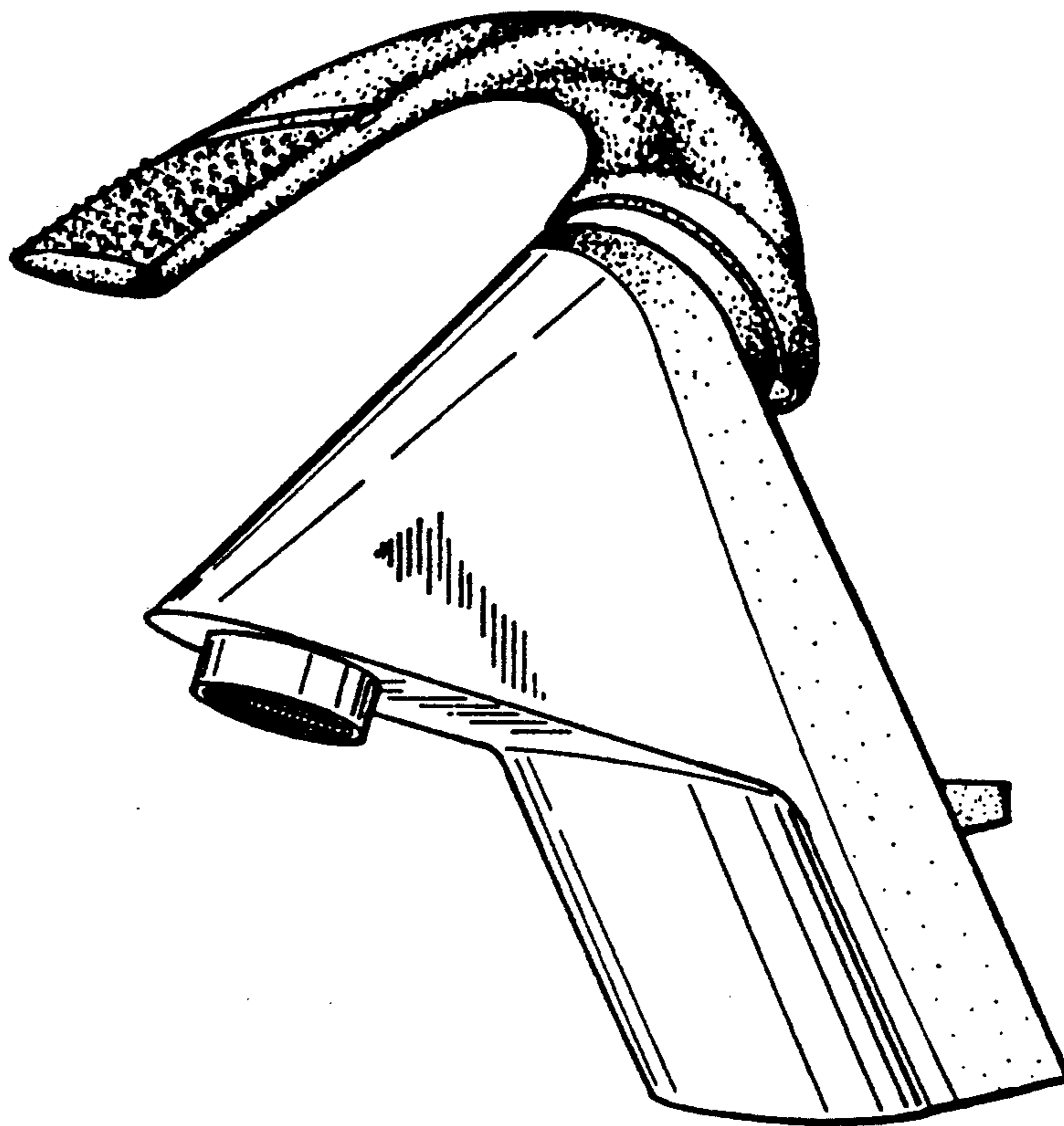

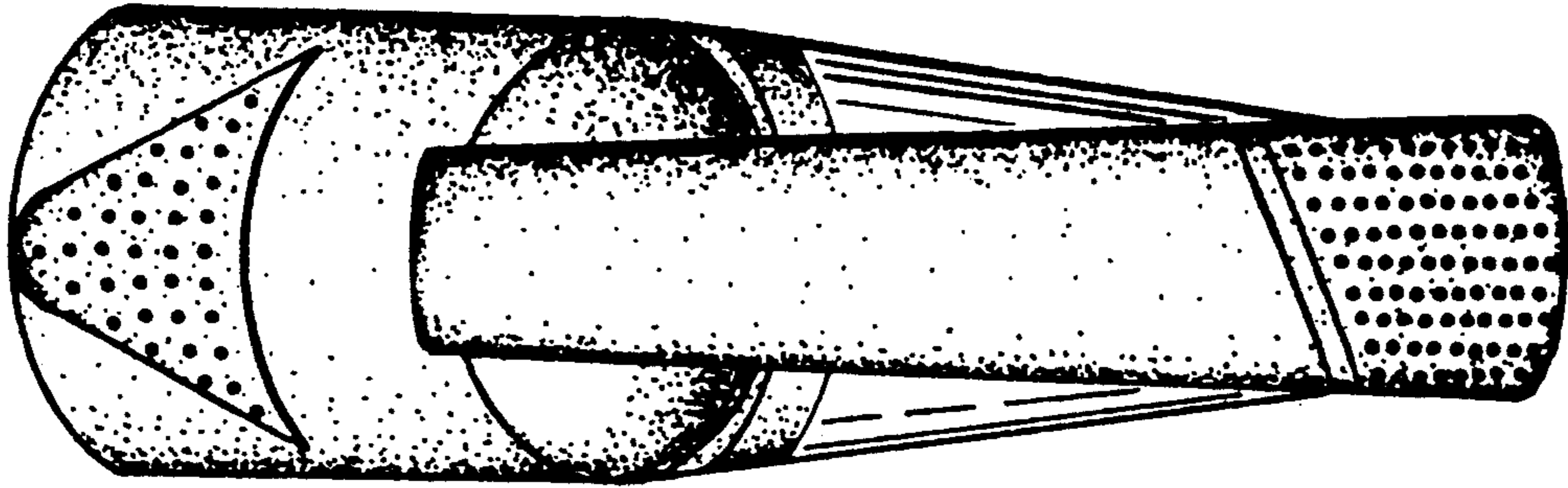

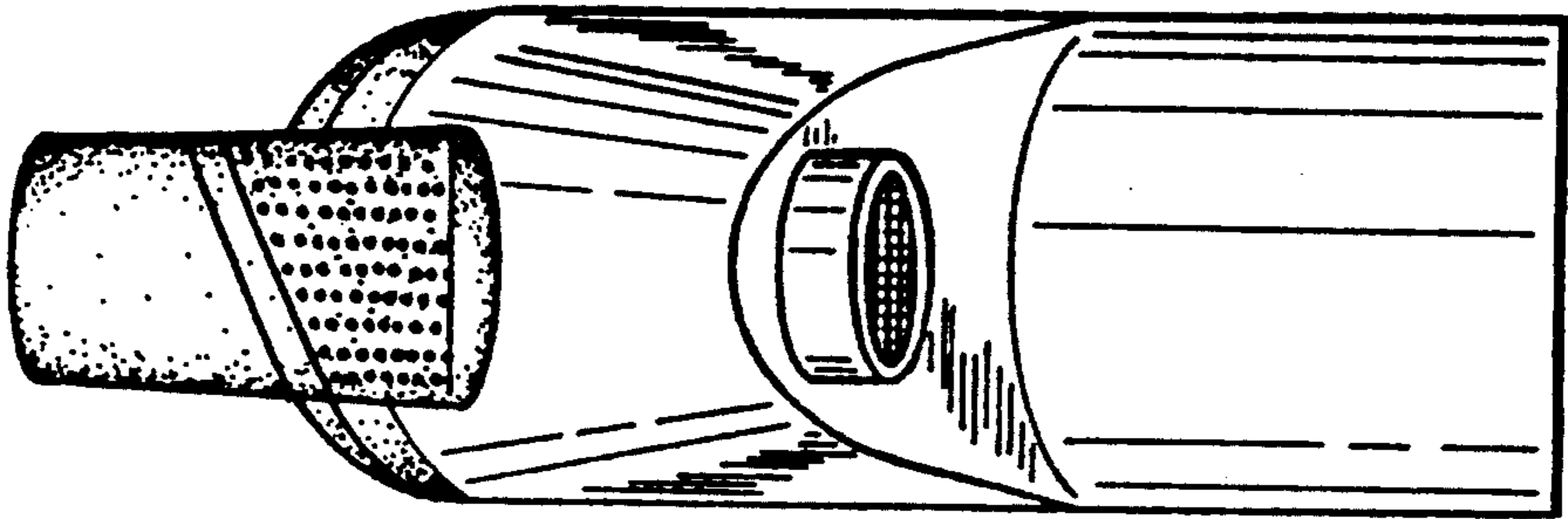

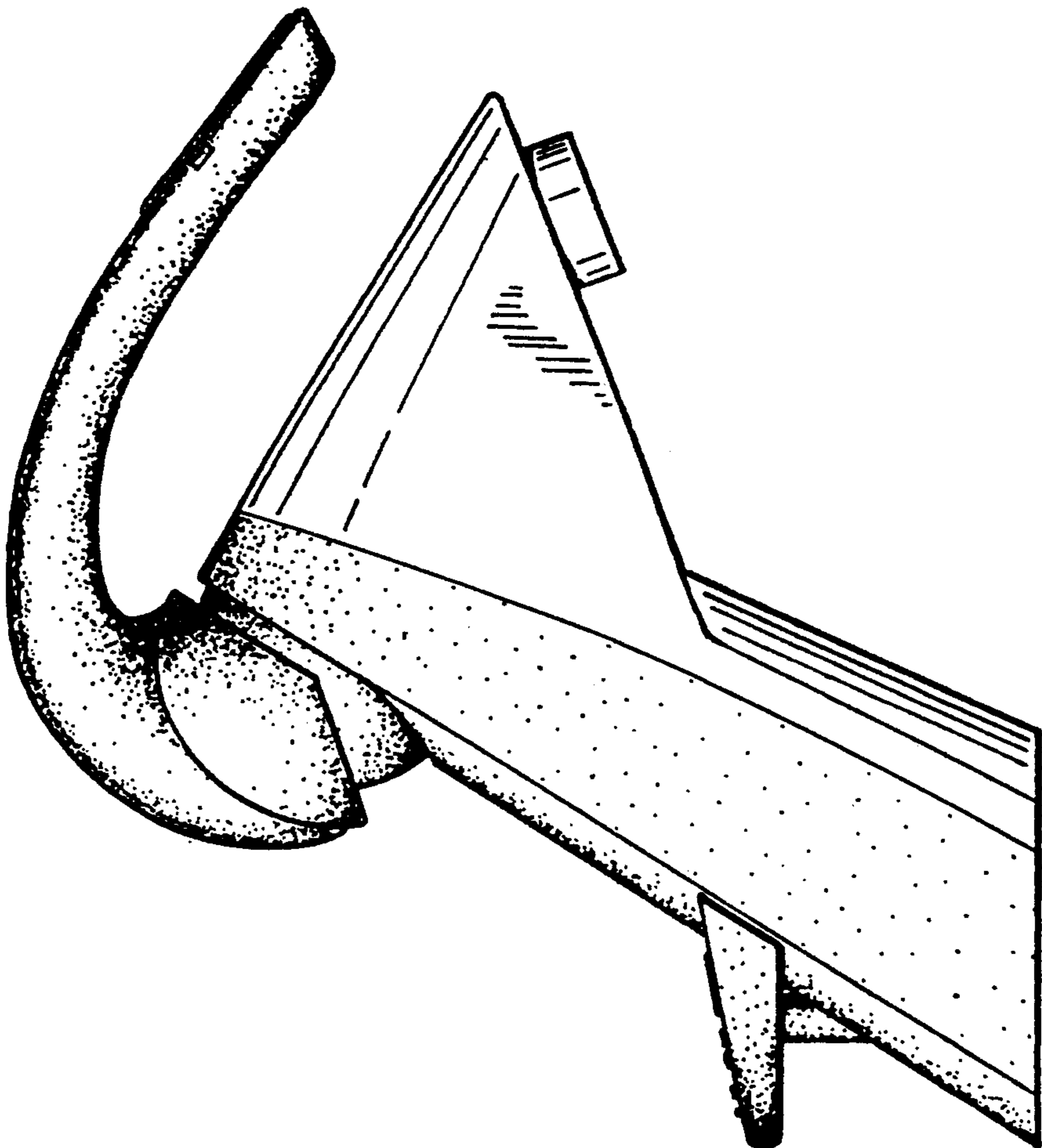

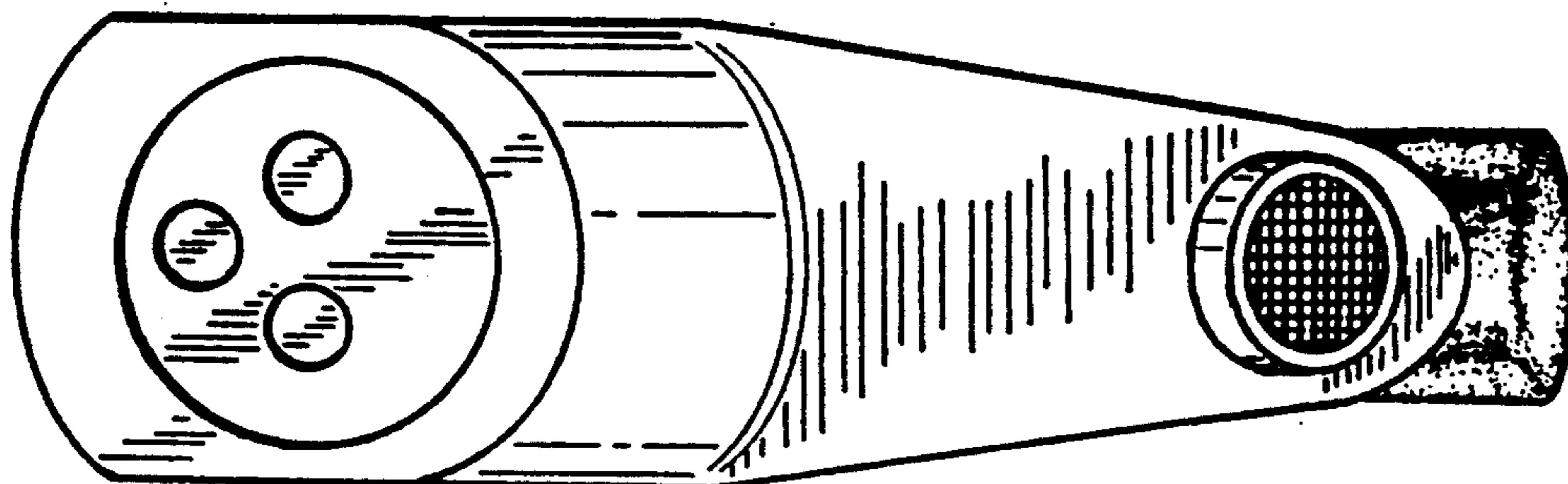

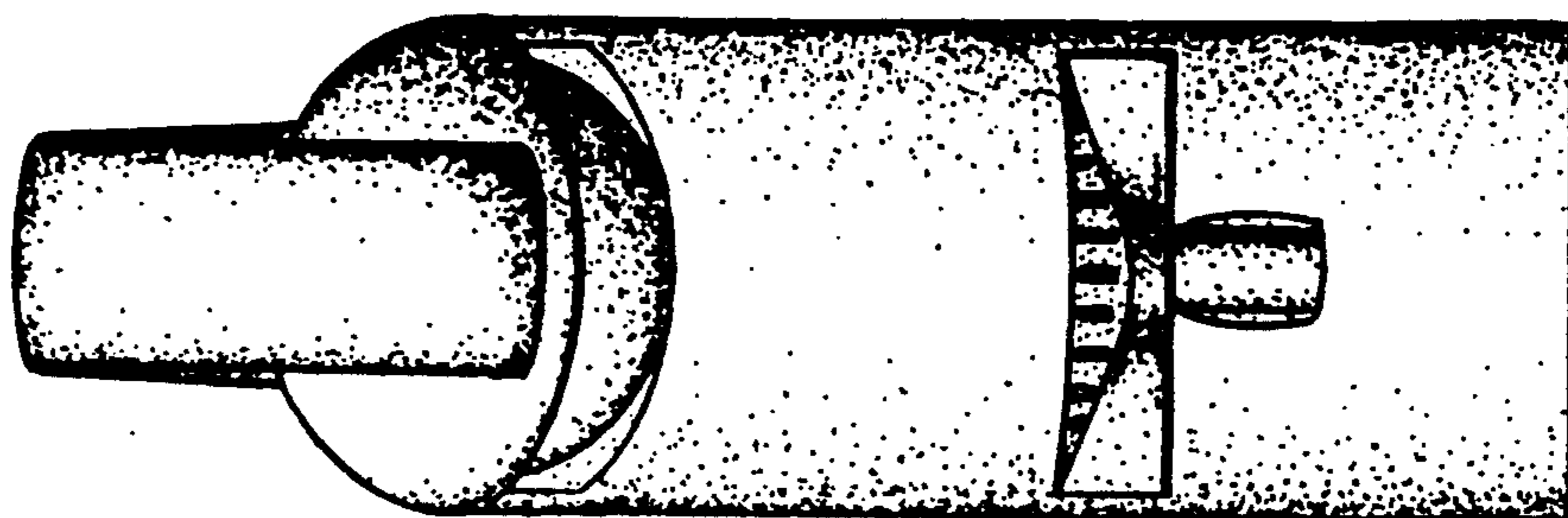

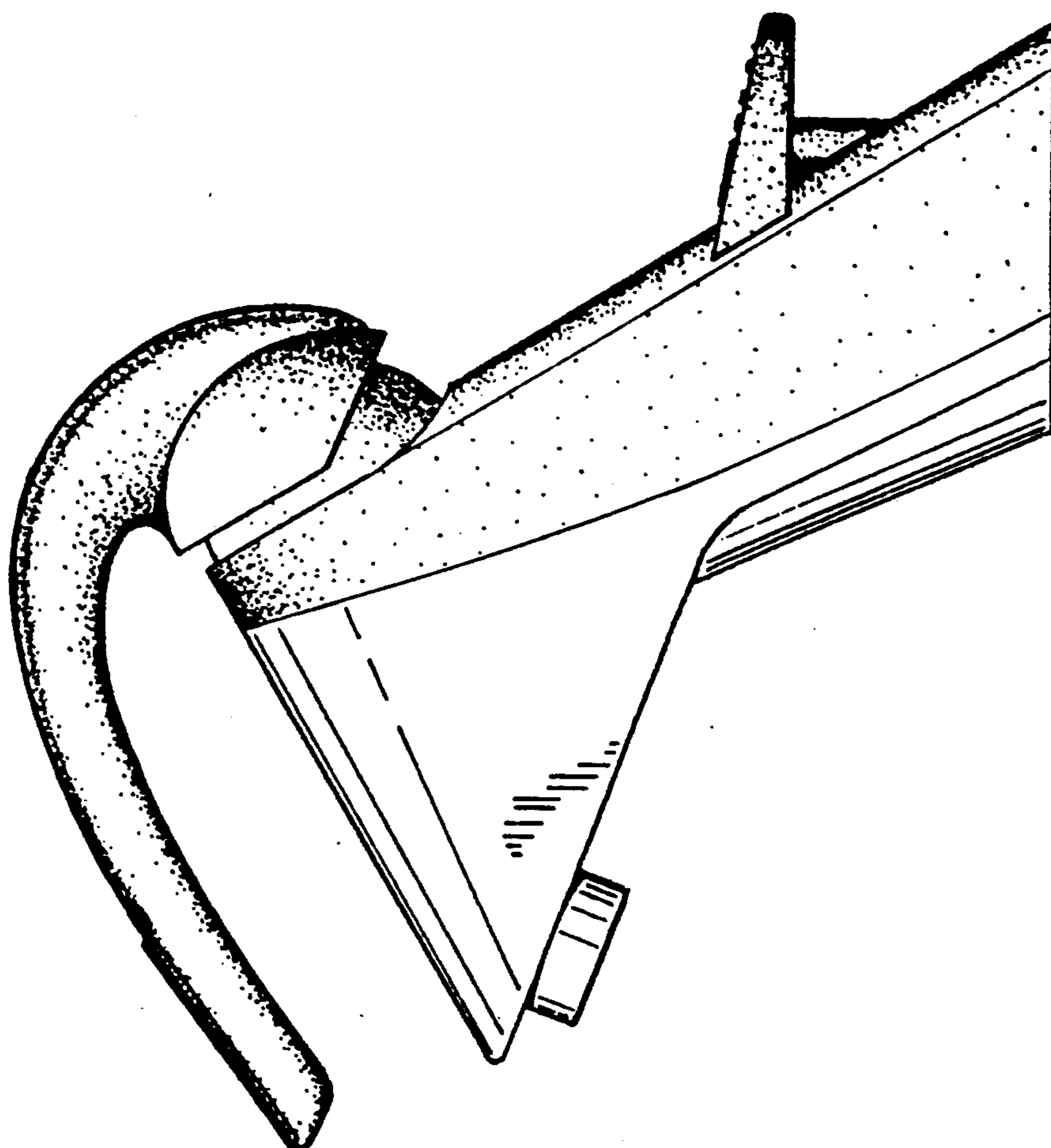
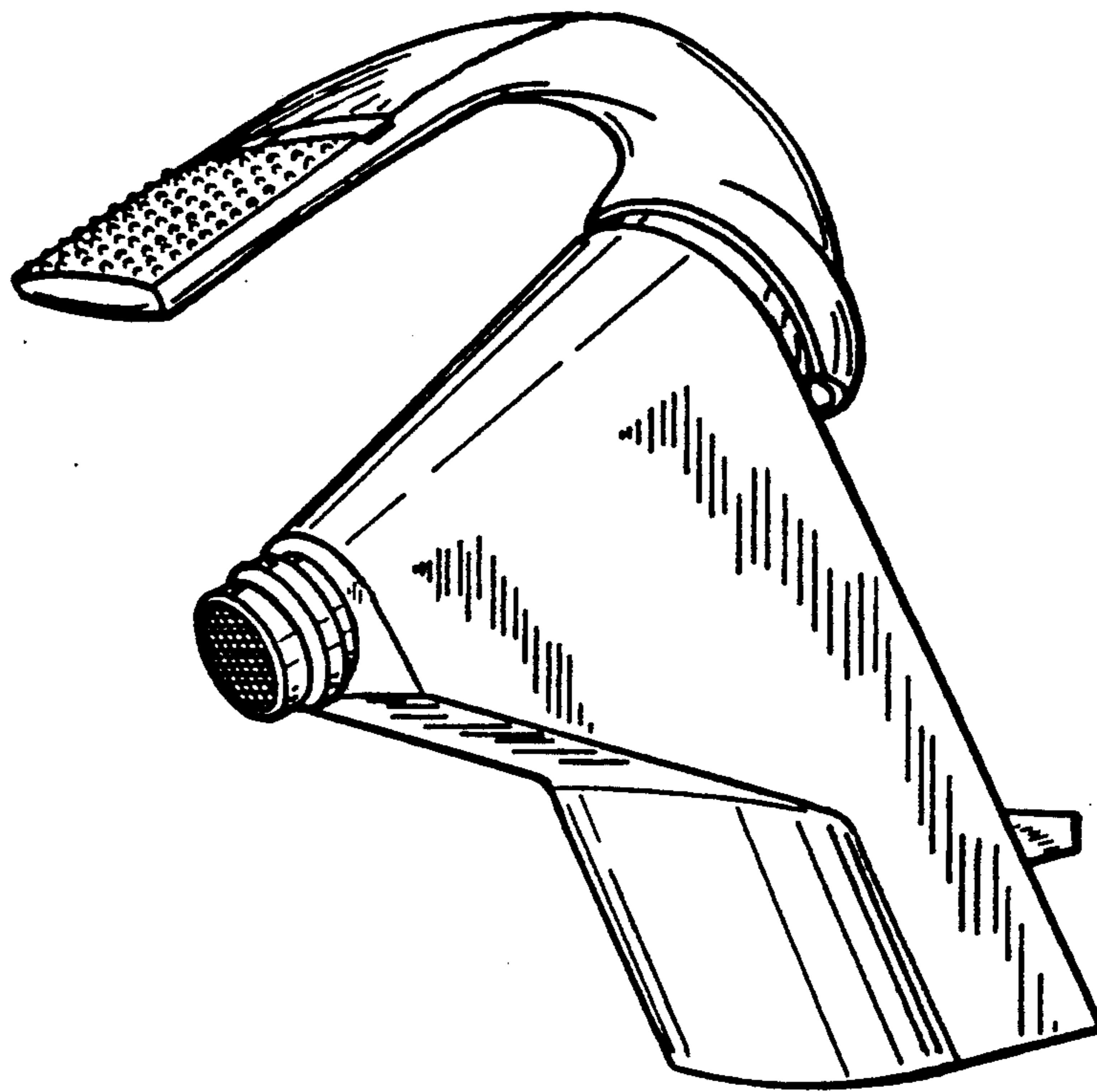

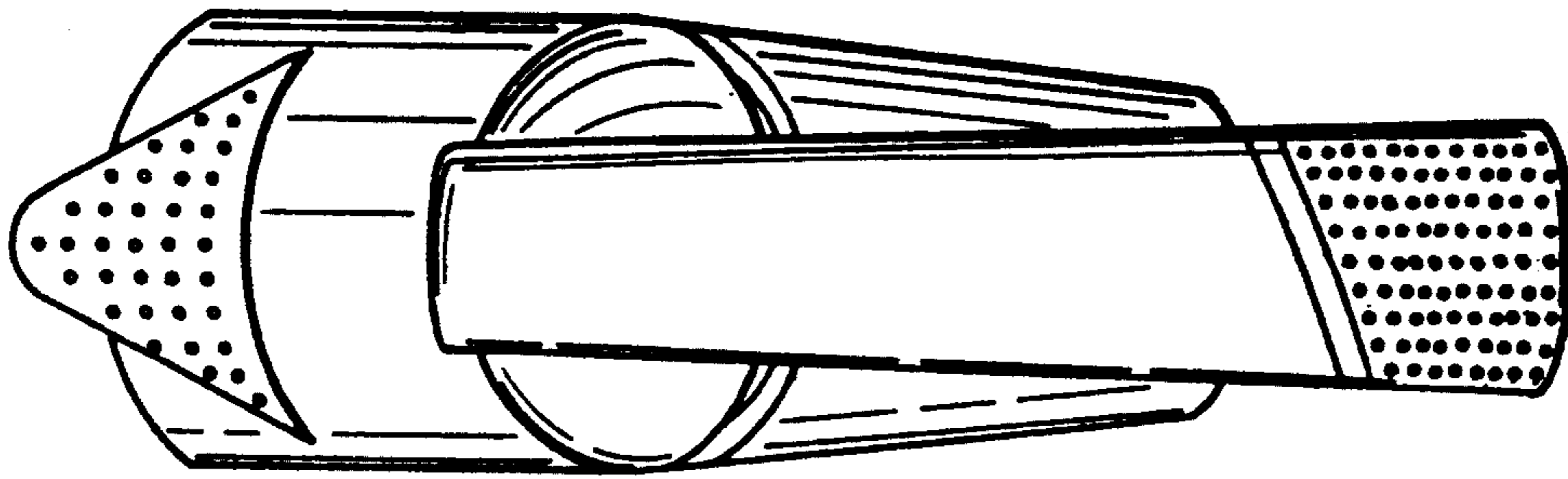

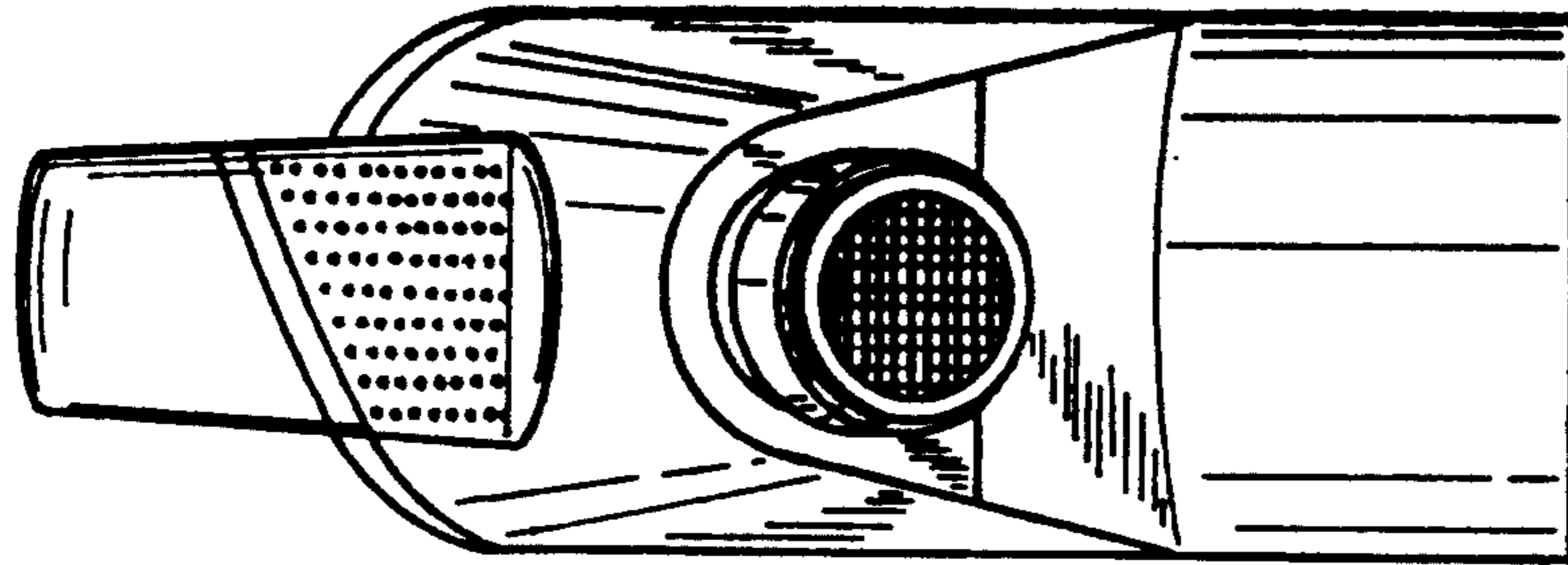

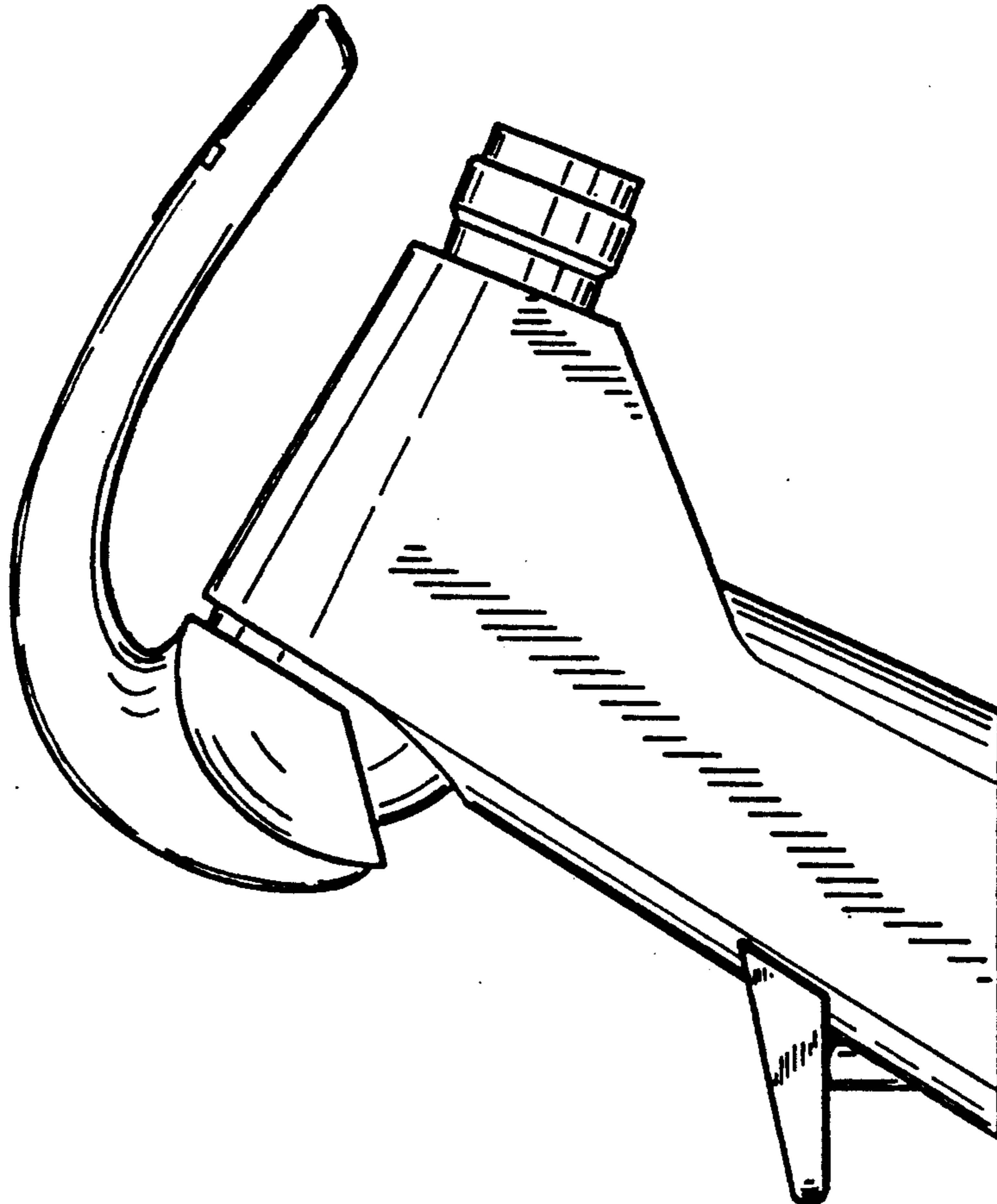

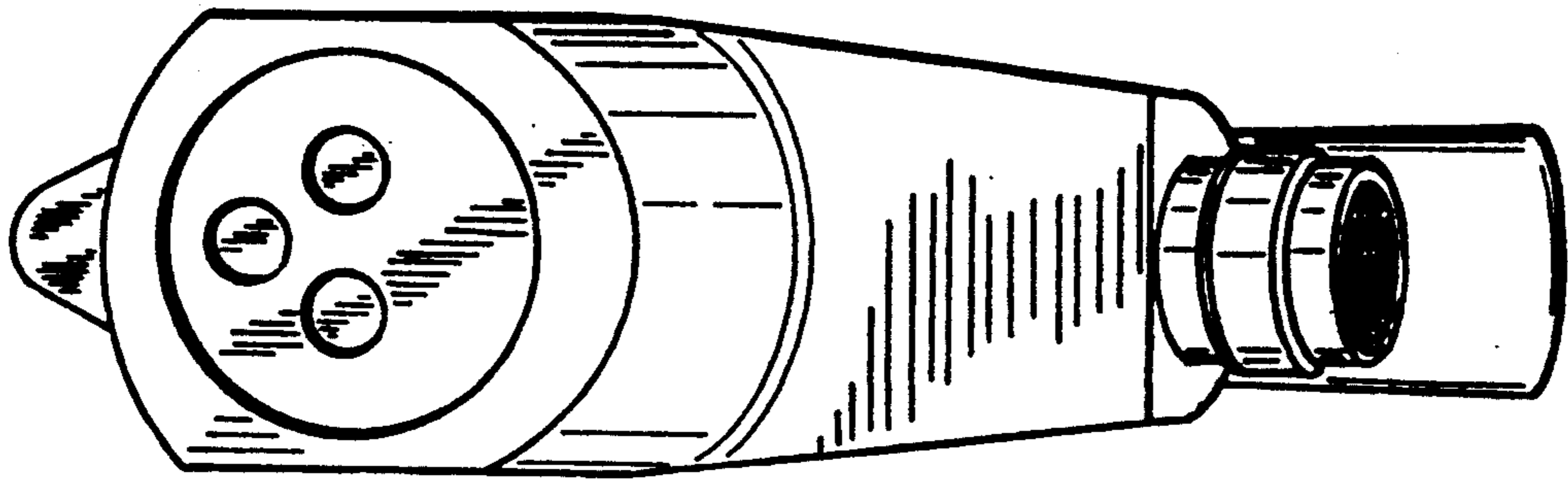

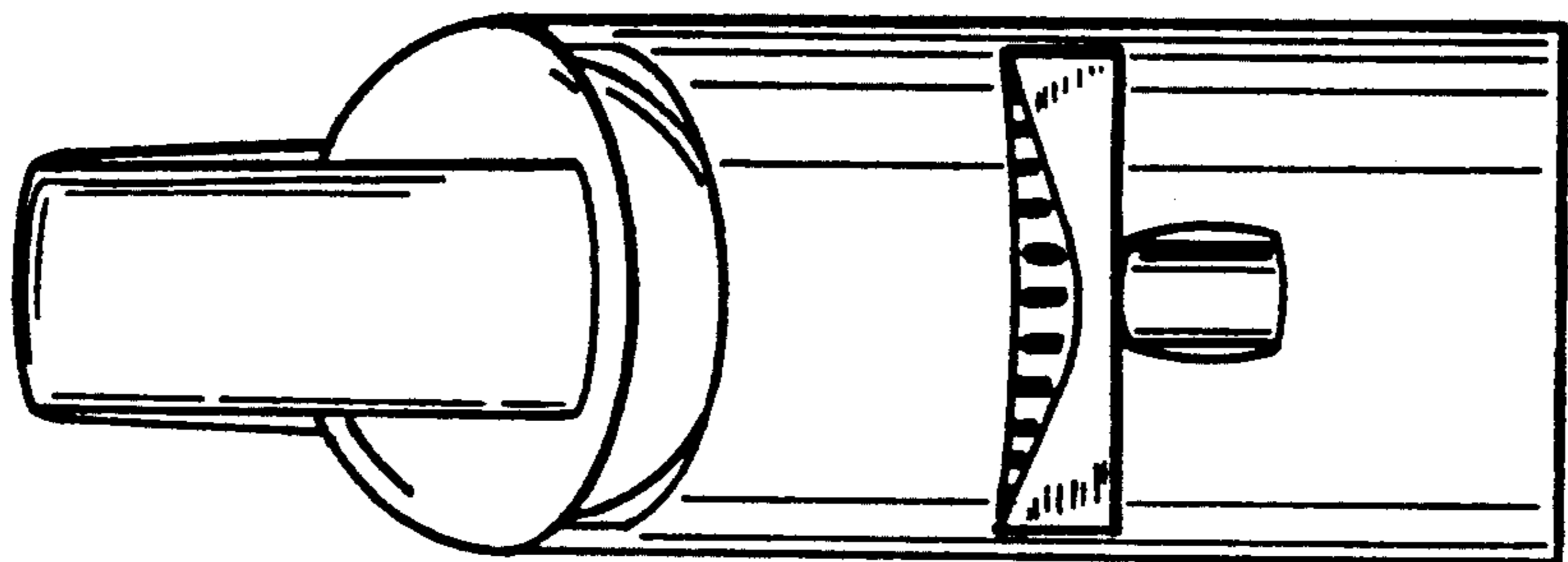

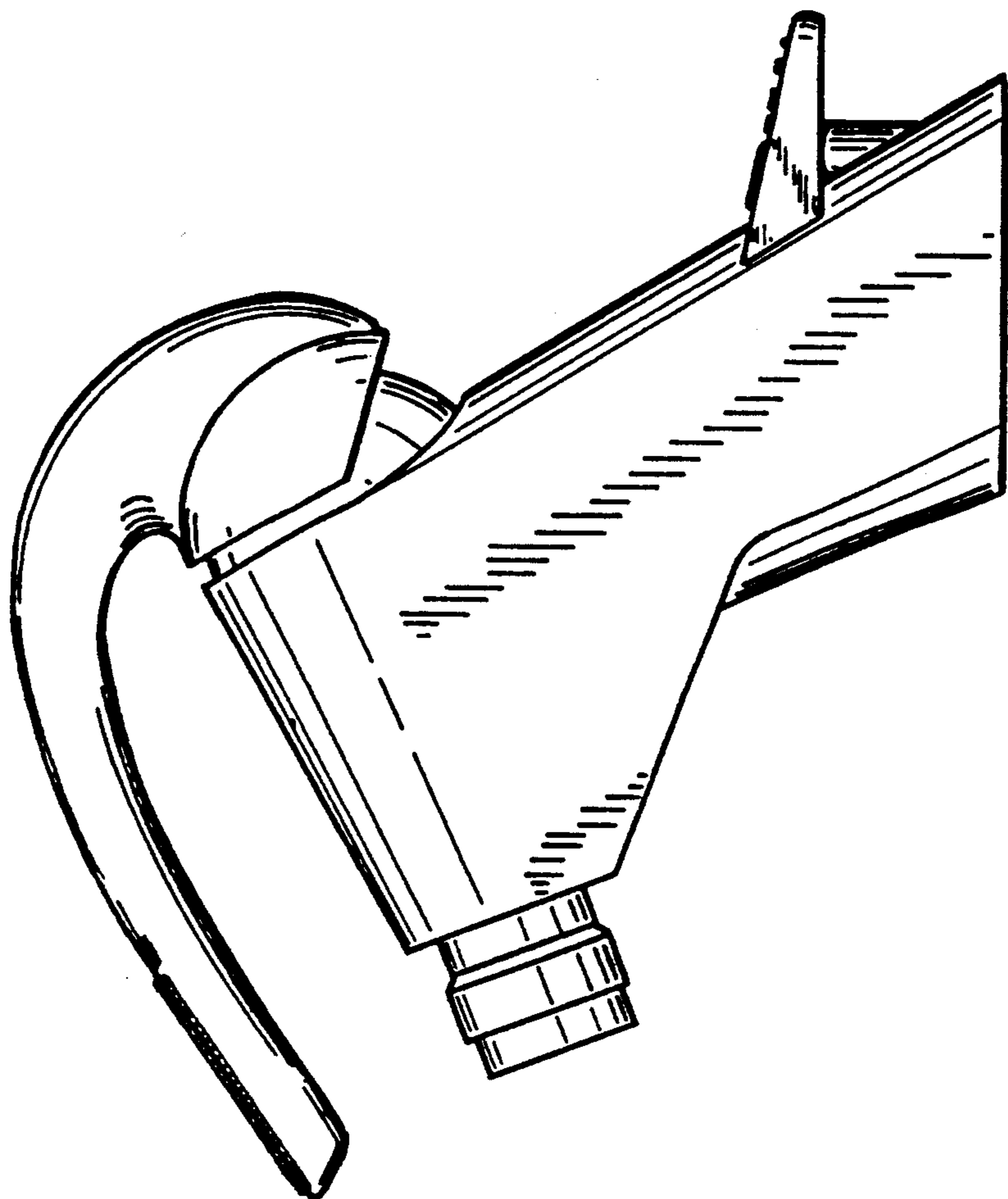
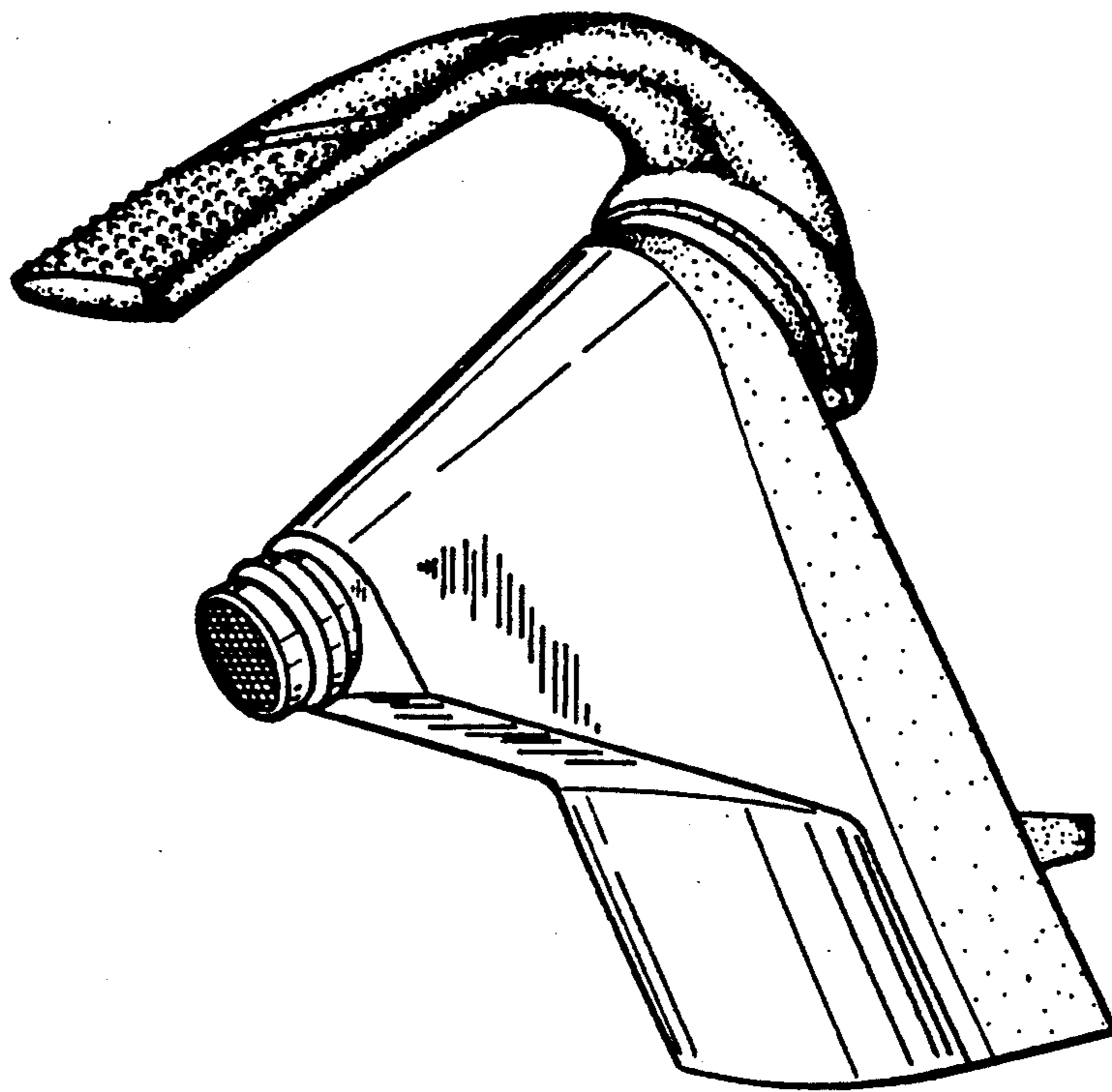

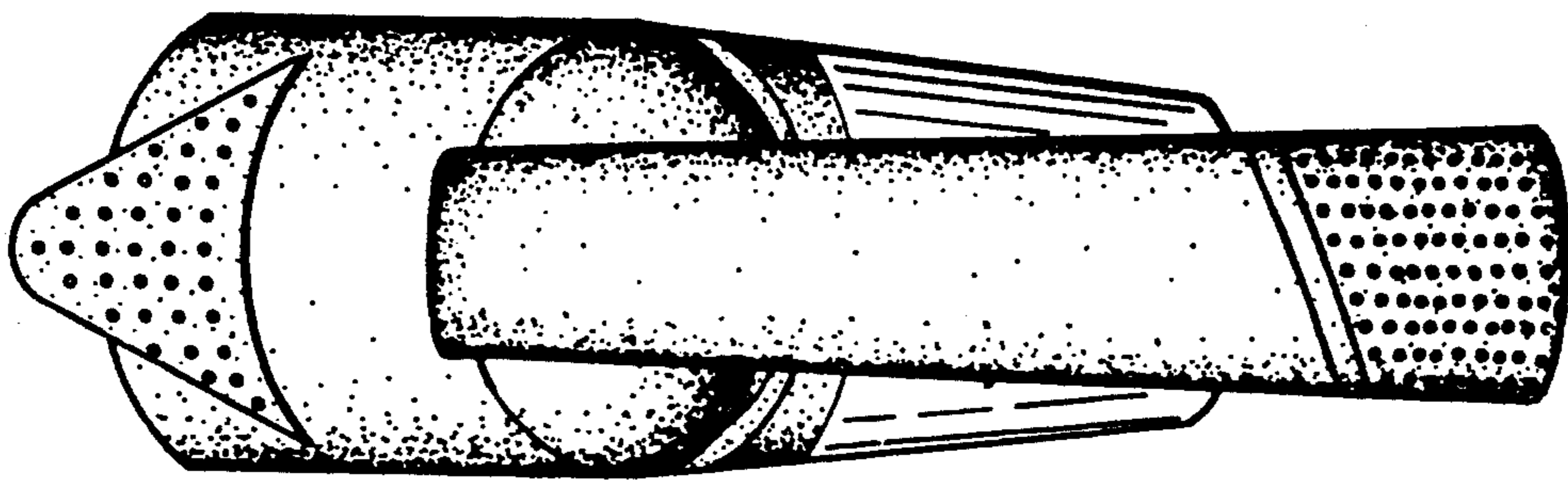

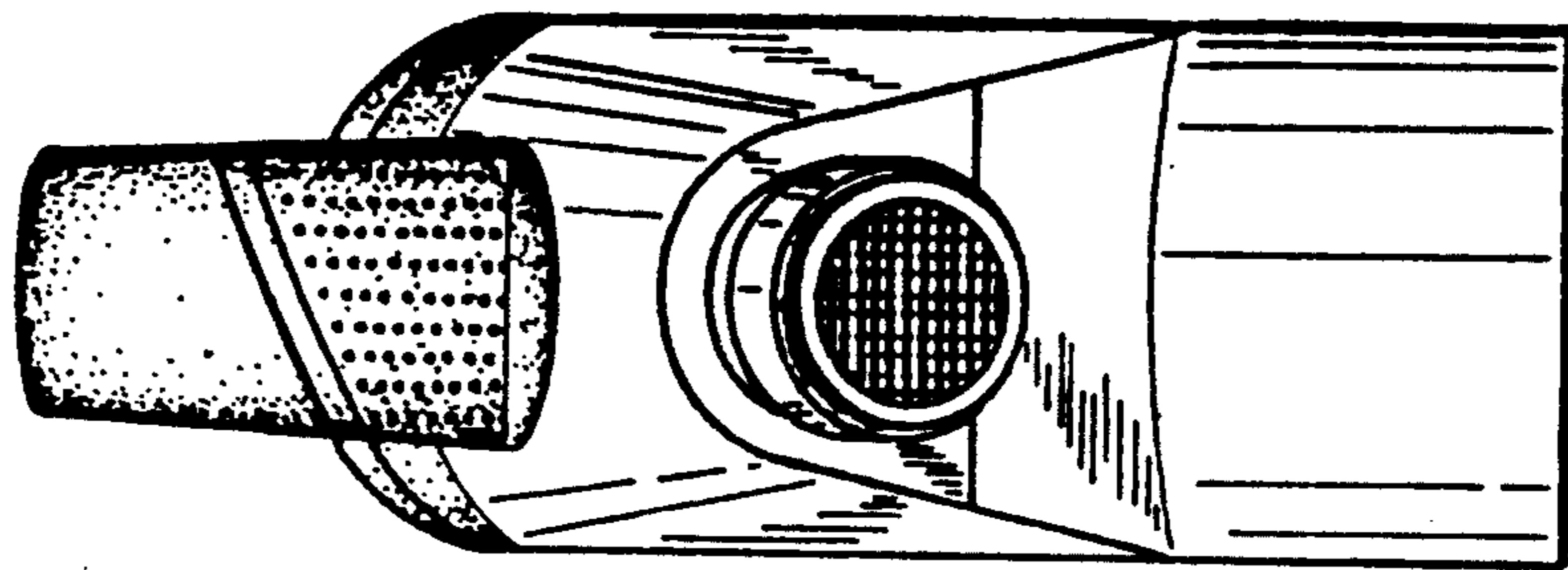

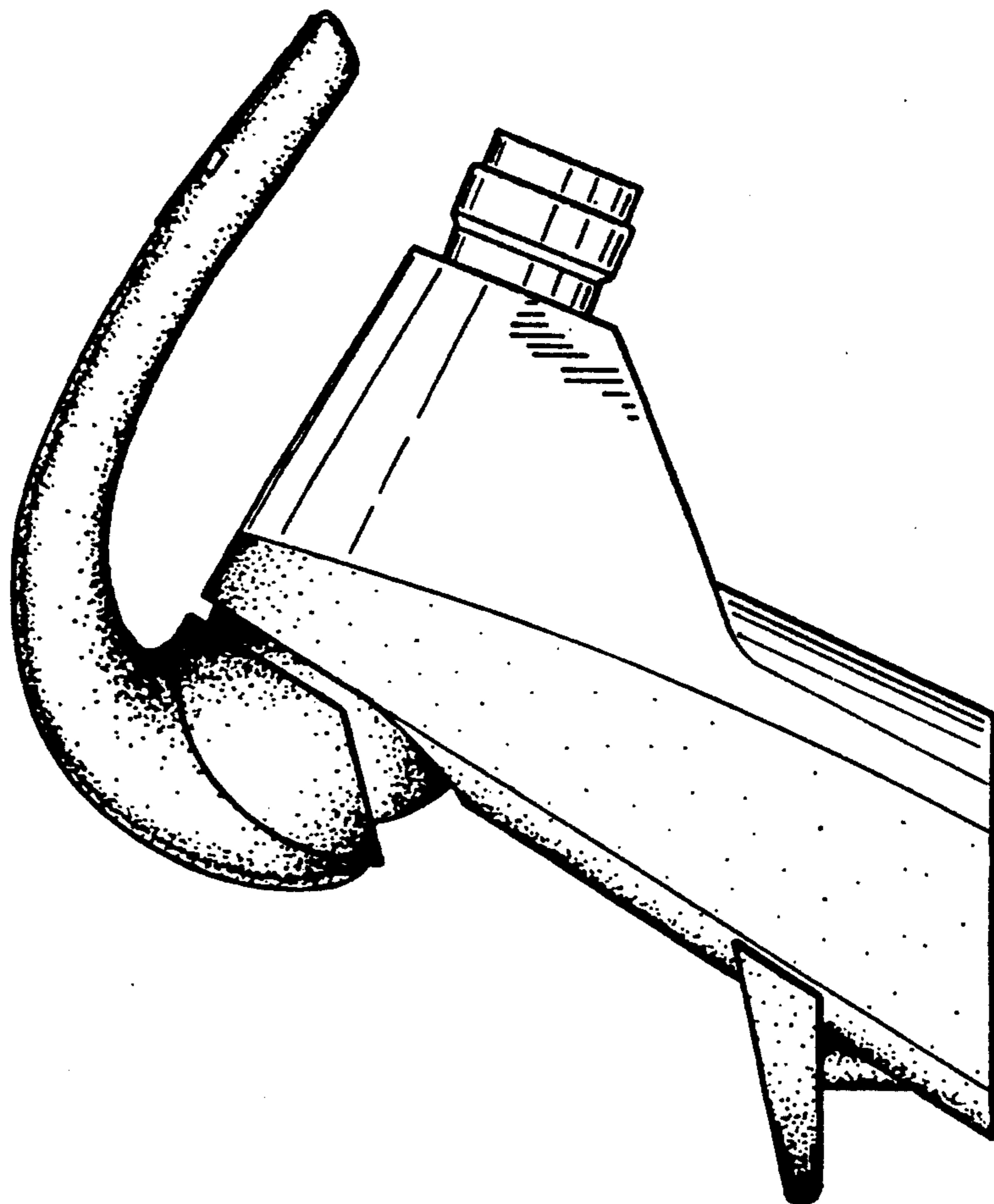

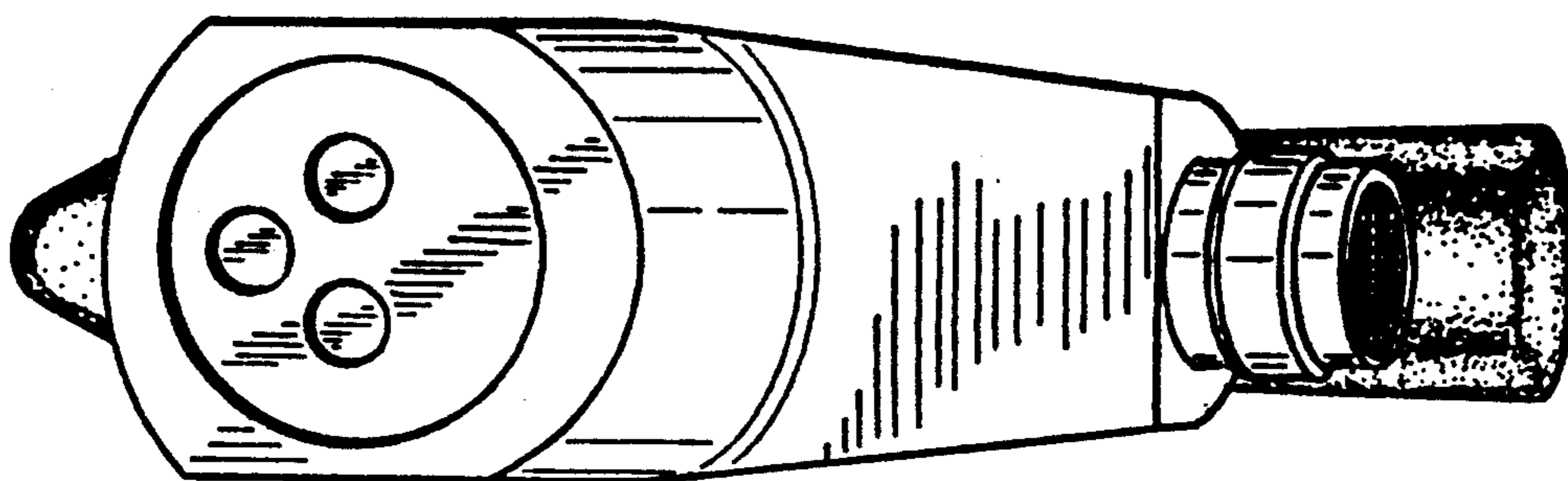

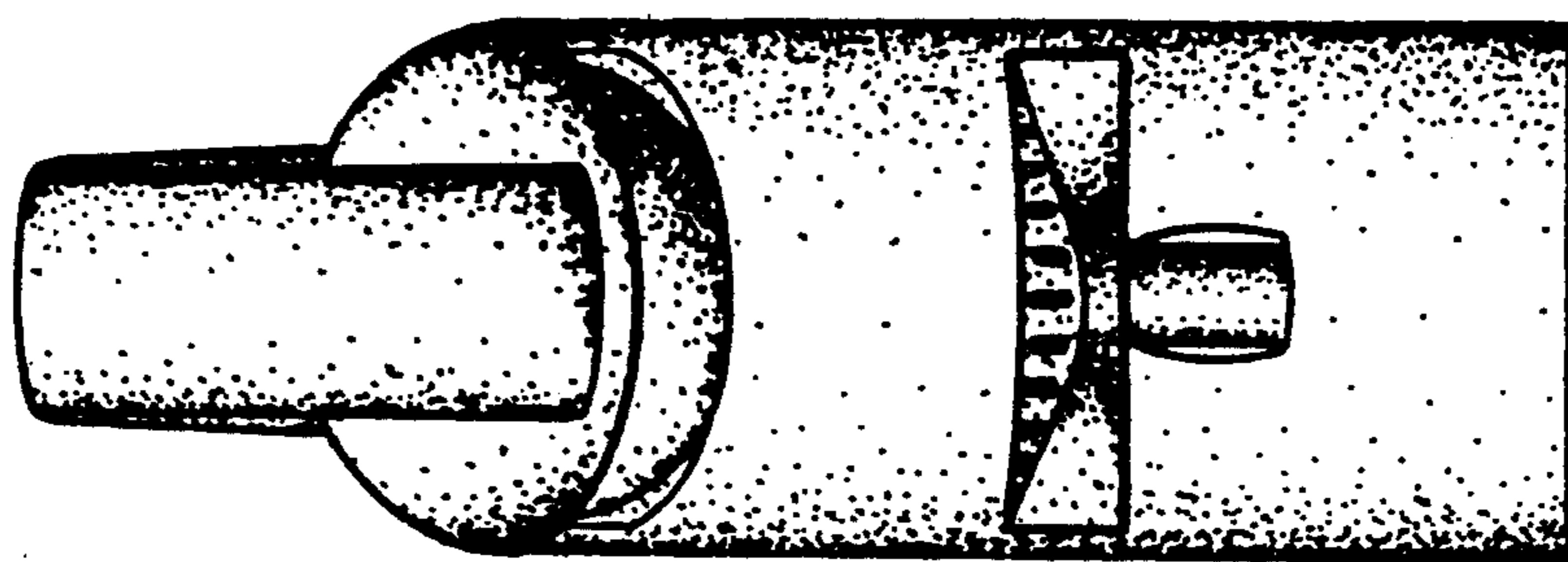

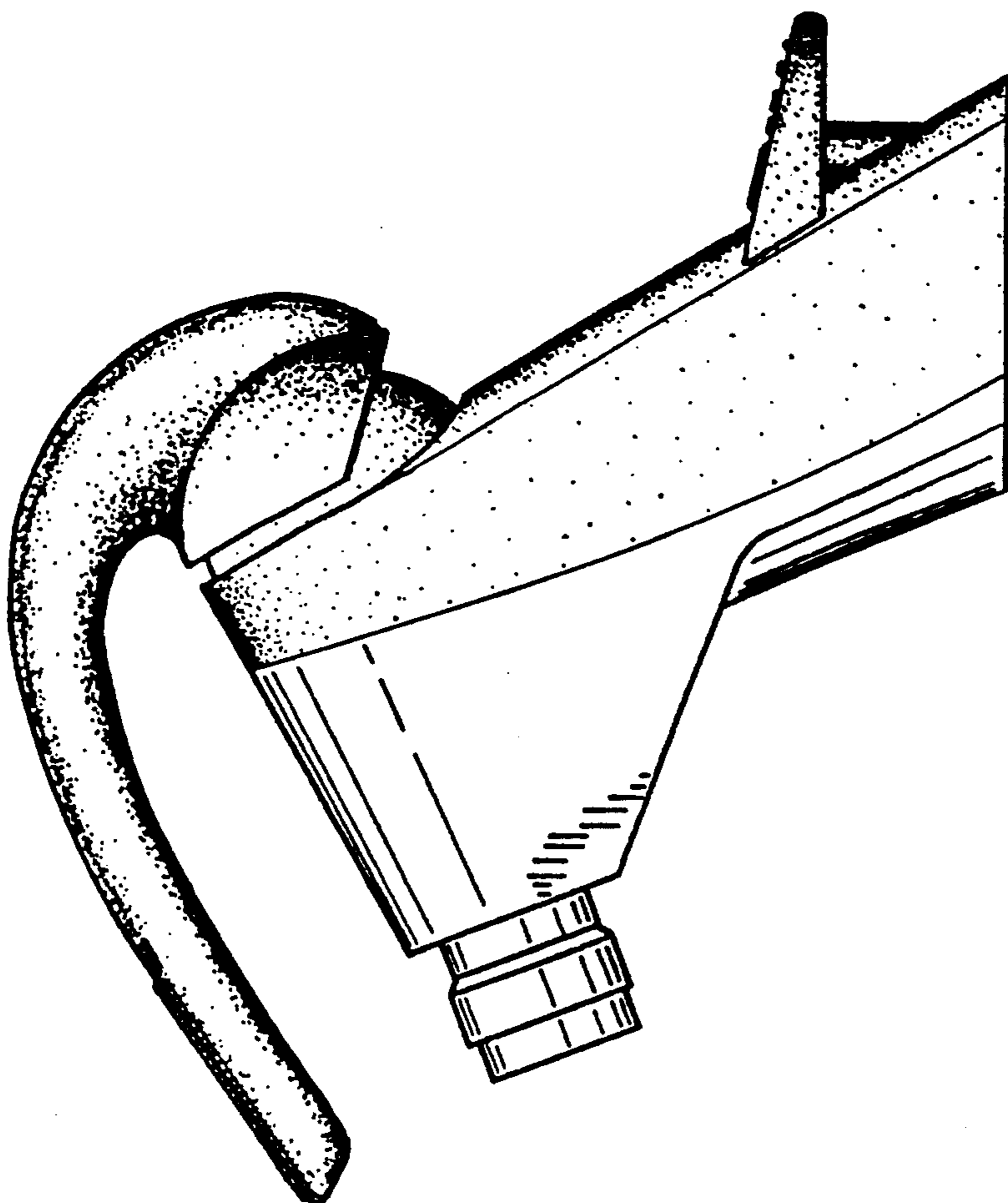
