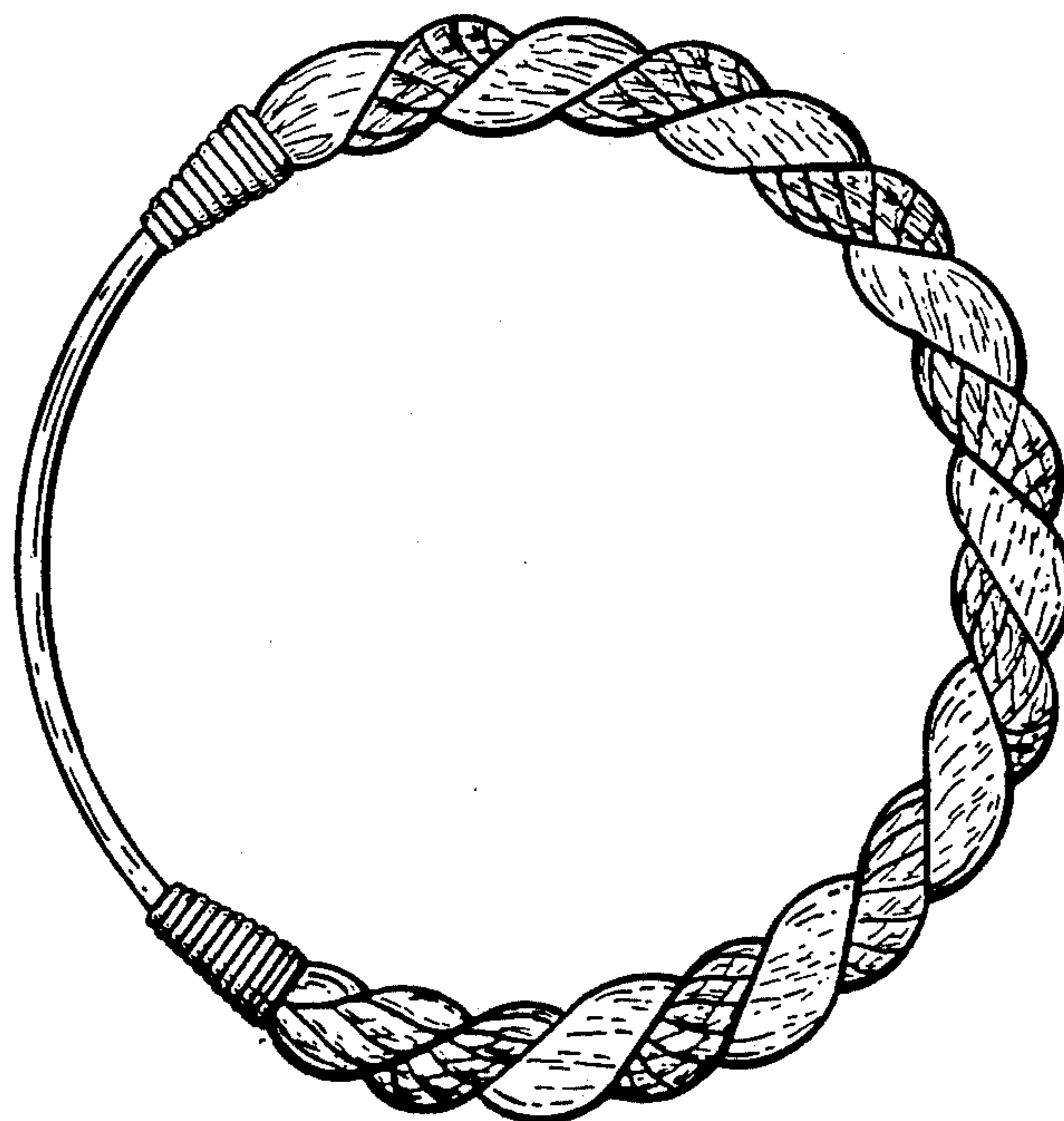

DESCRIPTION

FIG. 1 is a top plan view of a headband showing my new design;

FIG. 4 is a rear elevational view thereof.



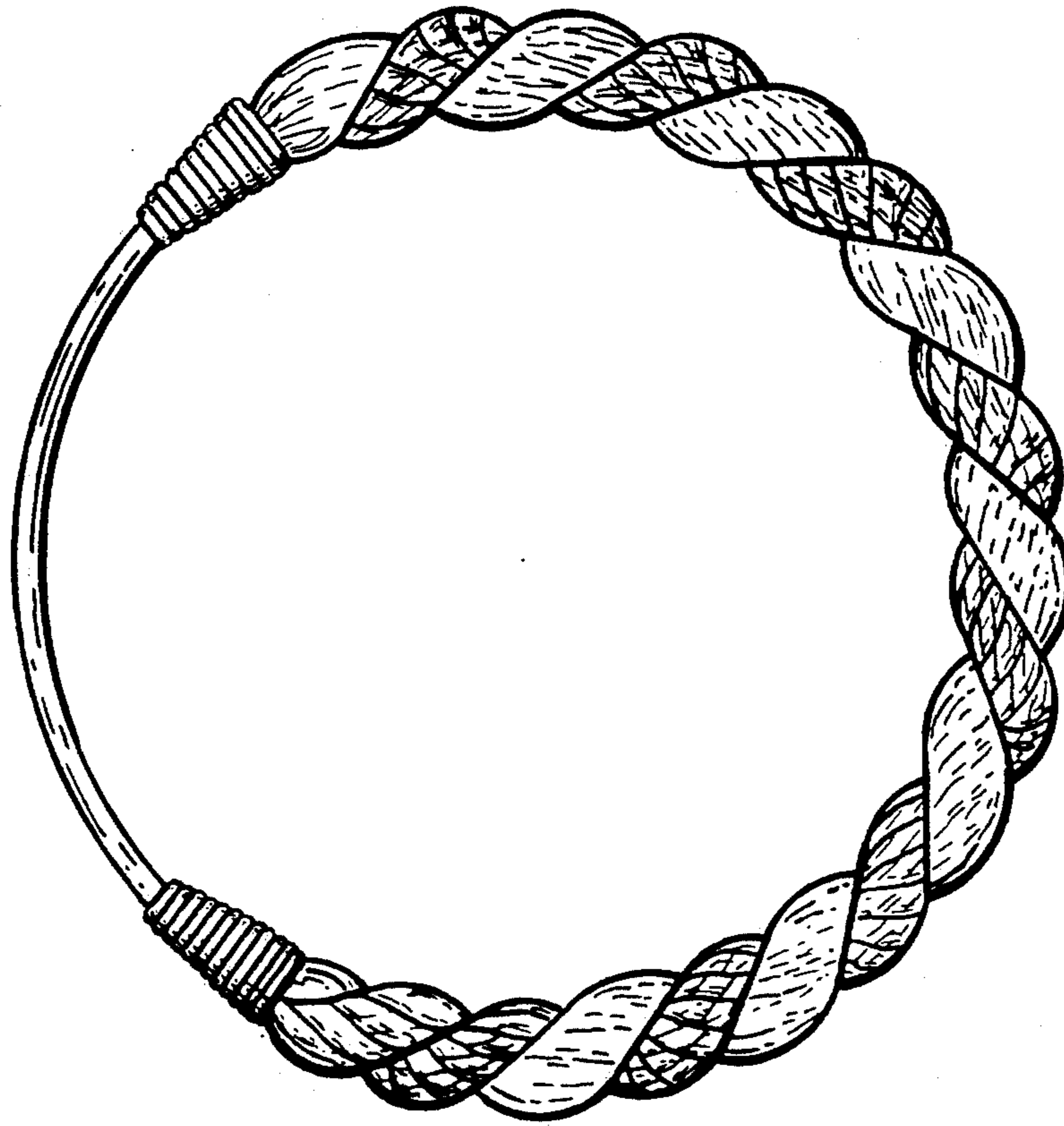
