The ornamental design for a telephone handset panel, as shown and described.

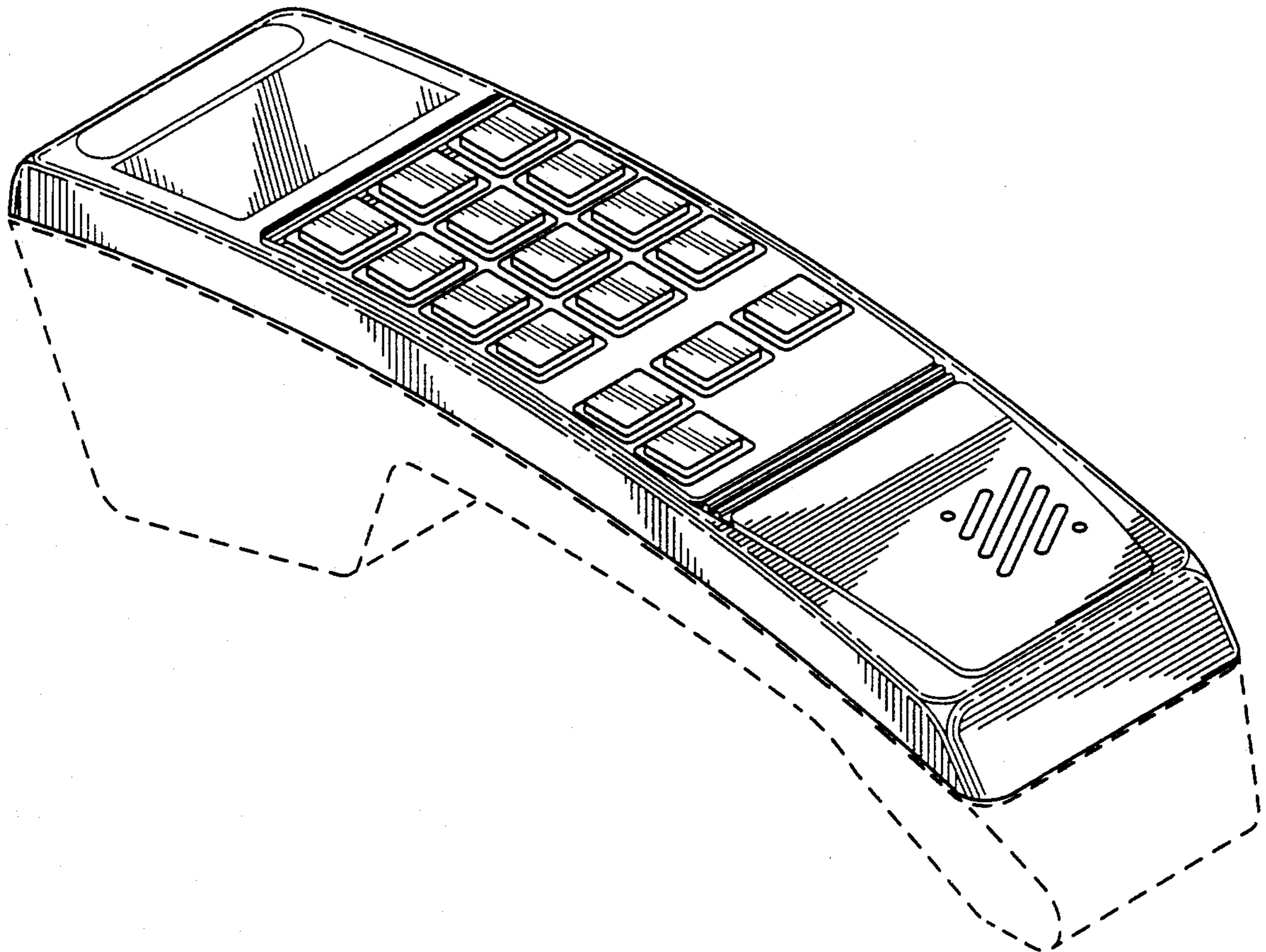
**DESCRIPTION**

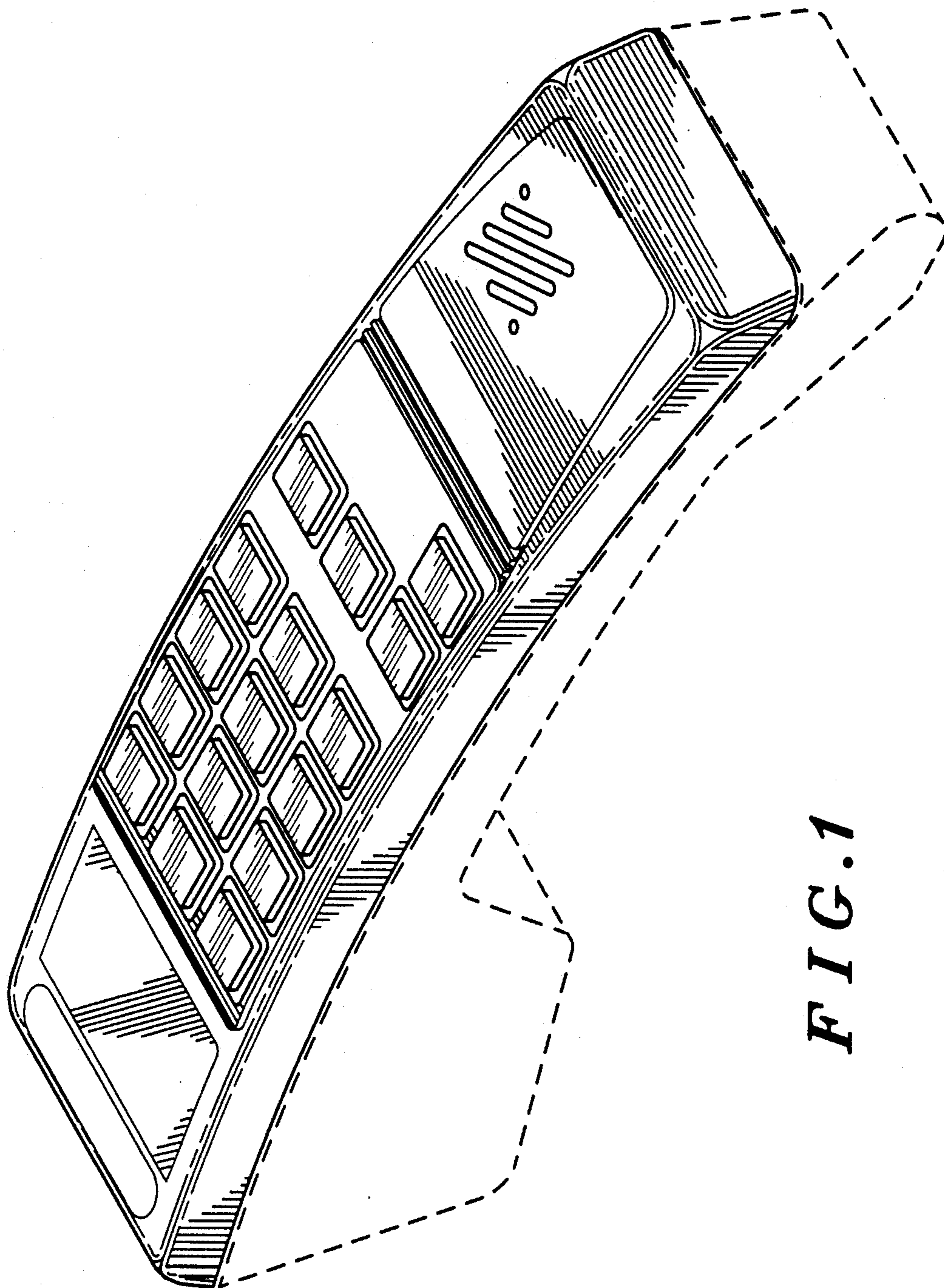
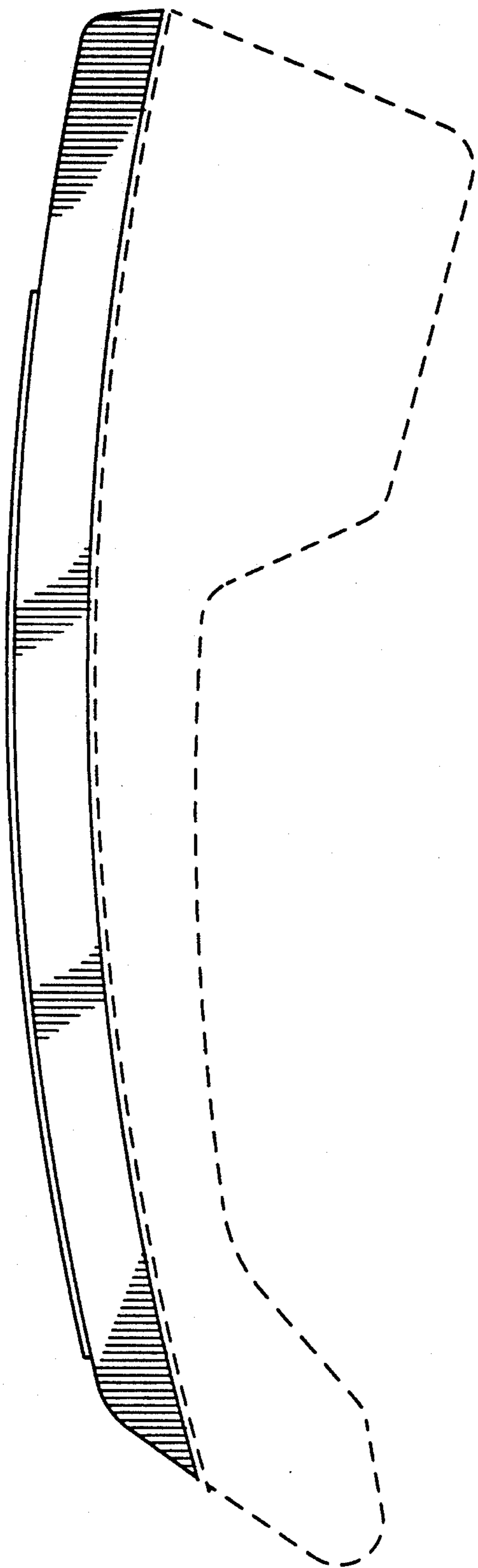
