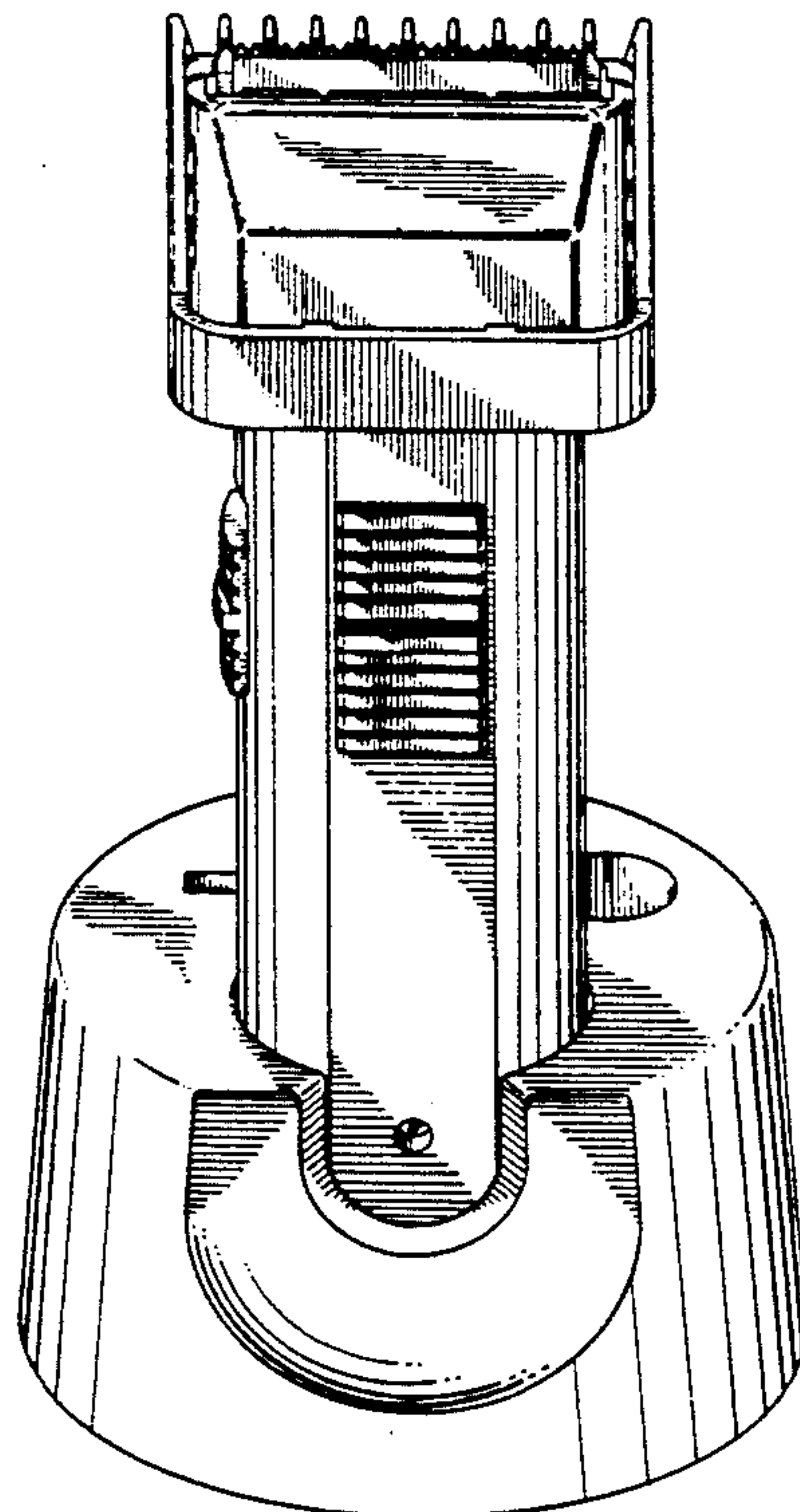

[57] CLAIM

The ornamental design for a hair trimmer and support base assembly, as shown and described.

DESCRIPTION

FIG. 1 is a partially exploded front elevational view of a hair trimmer and support base assembly showing my new design;
 FIG. 2 is a front elevational view of the clipper element, shown separately for clarity of illustration;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a top plan view of the hair length controller attachment, shown separately for clarity of illustration;
 FIG. 9 is a front elevational view thereof;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a rear elevational view thereof;
 FIG. 12 is a right side elevational view thereof, the side opposite being a mirror image of the side shown;
 FIG. 13 is a top plan view of the support base element, shown separately for clarity of illustration;
 FIG. 14 is a front elevational view thereof;
 FIG. 15 is a right side elevational view thereof, the side opposite being a mirror image of the side shown;
 FIG. 16 is a bottom plan view thereof;
 FIG. 17 is a rear elevational view thereof;
 FIG. 18 is a rear perspective view of the fully assembled hair trimmer and support base assembly; and,
 FIG. 19 is a front perspective view of the fully assembled hair trimmer and support base assembly.



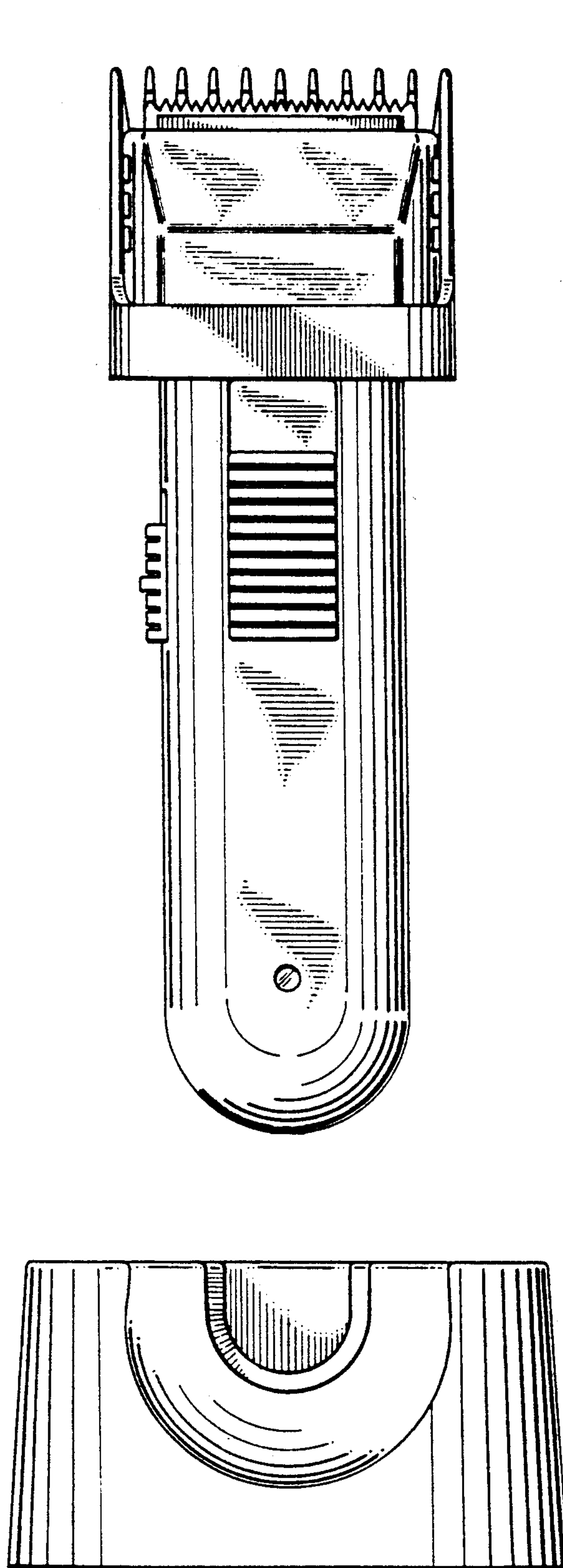

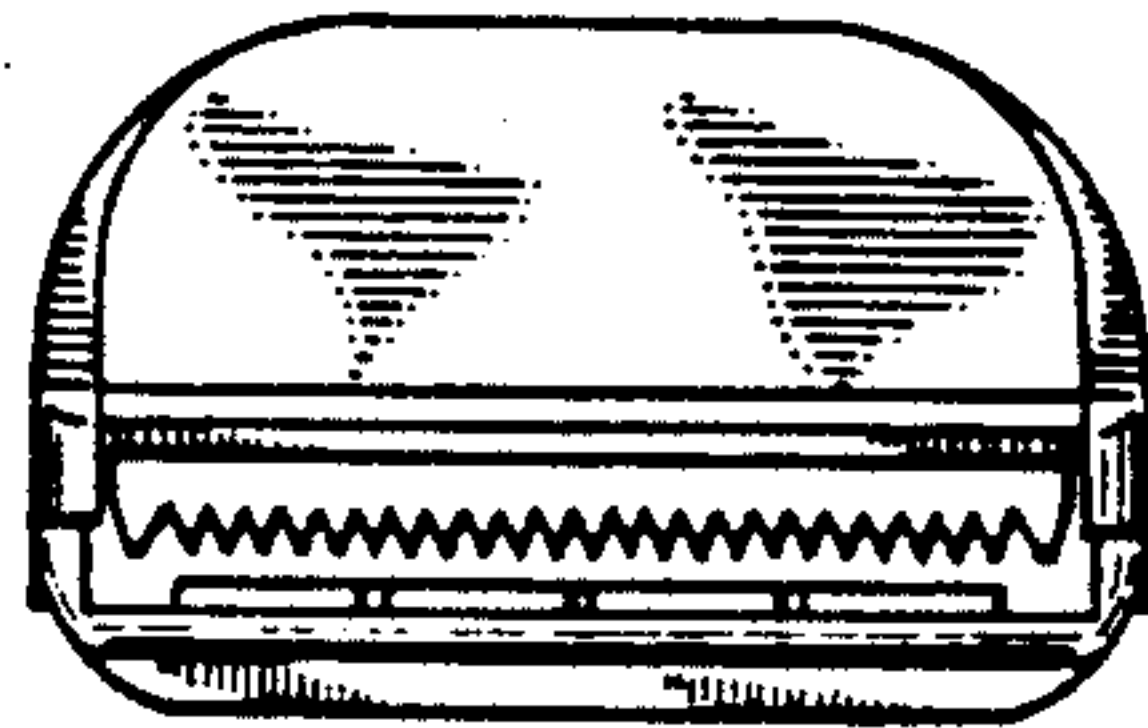

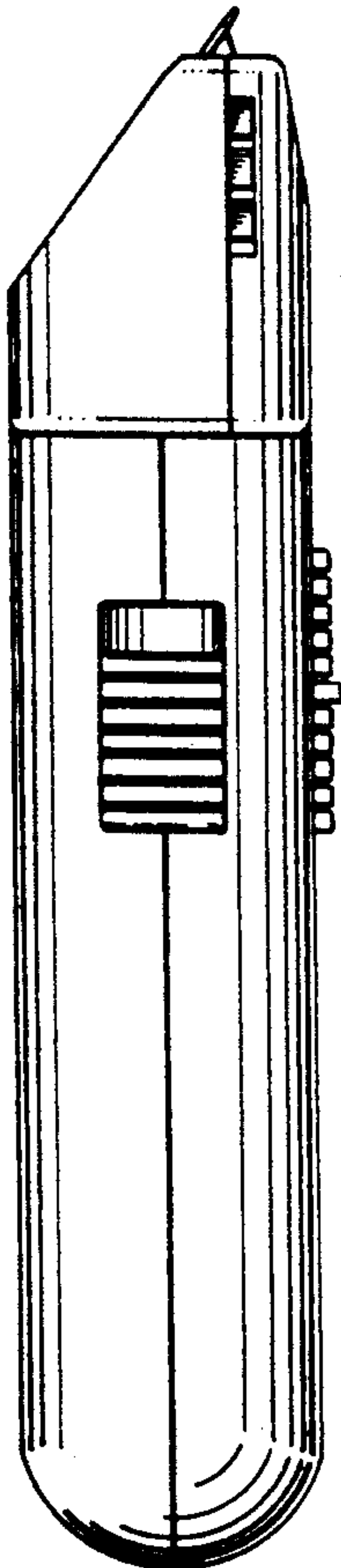

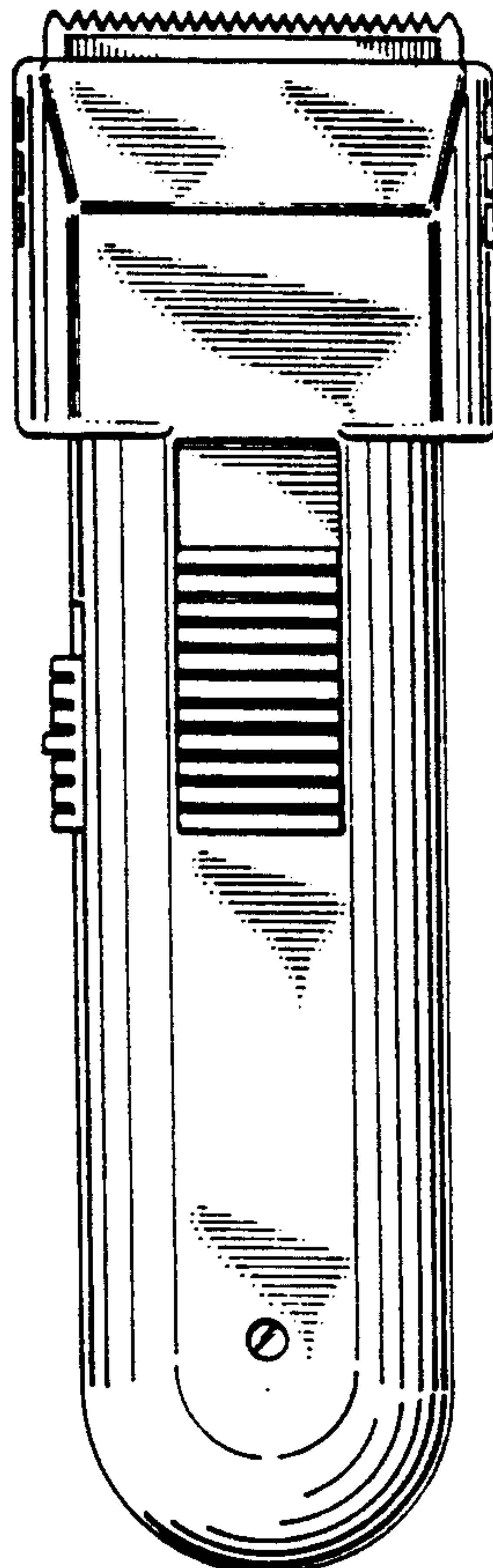

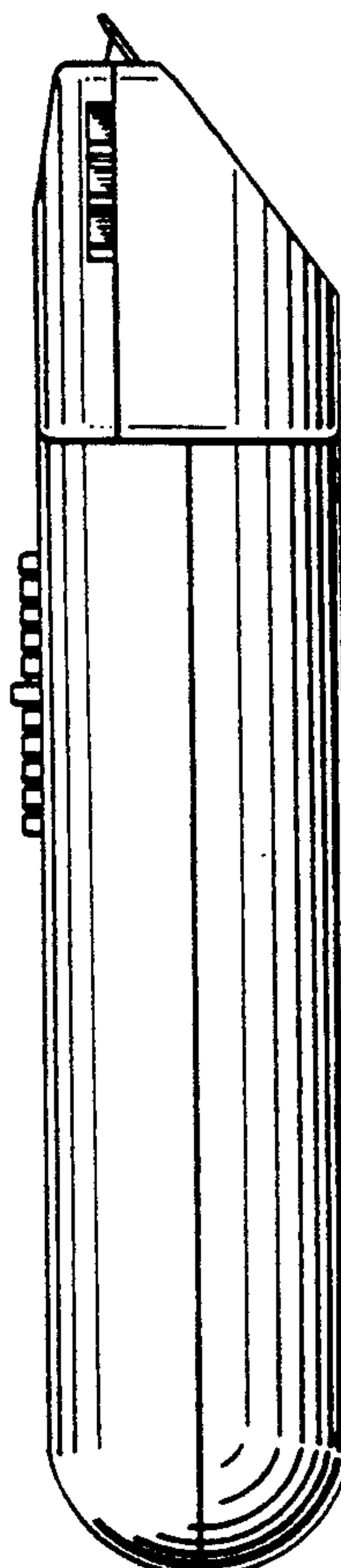

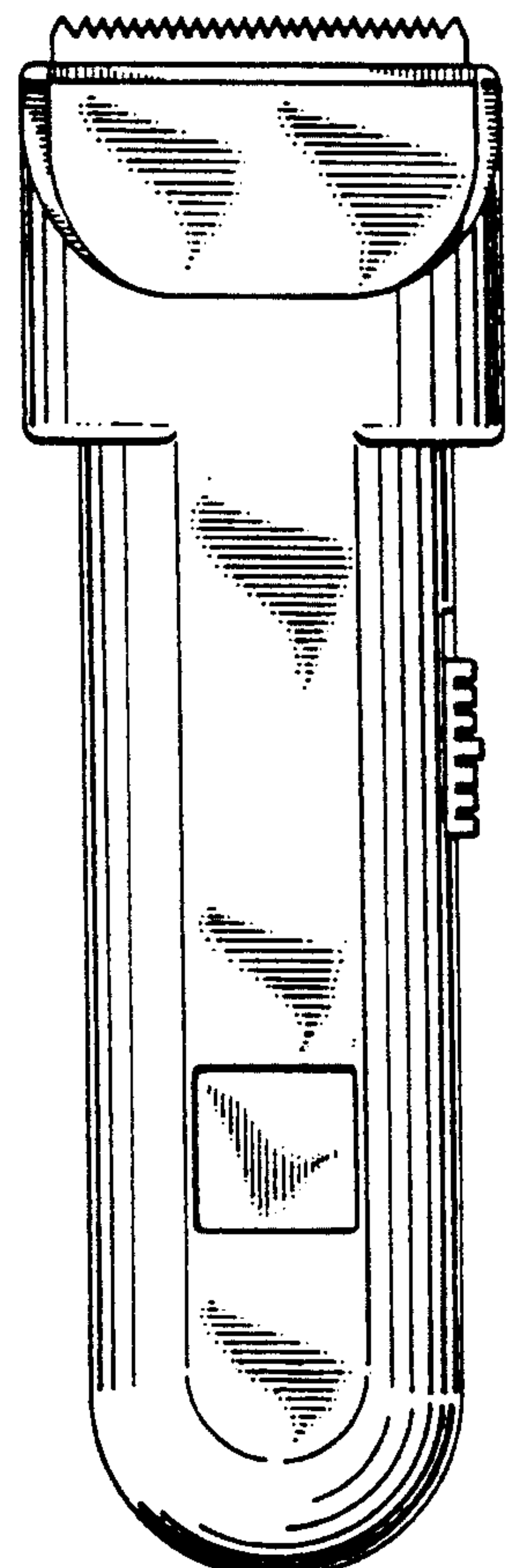

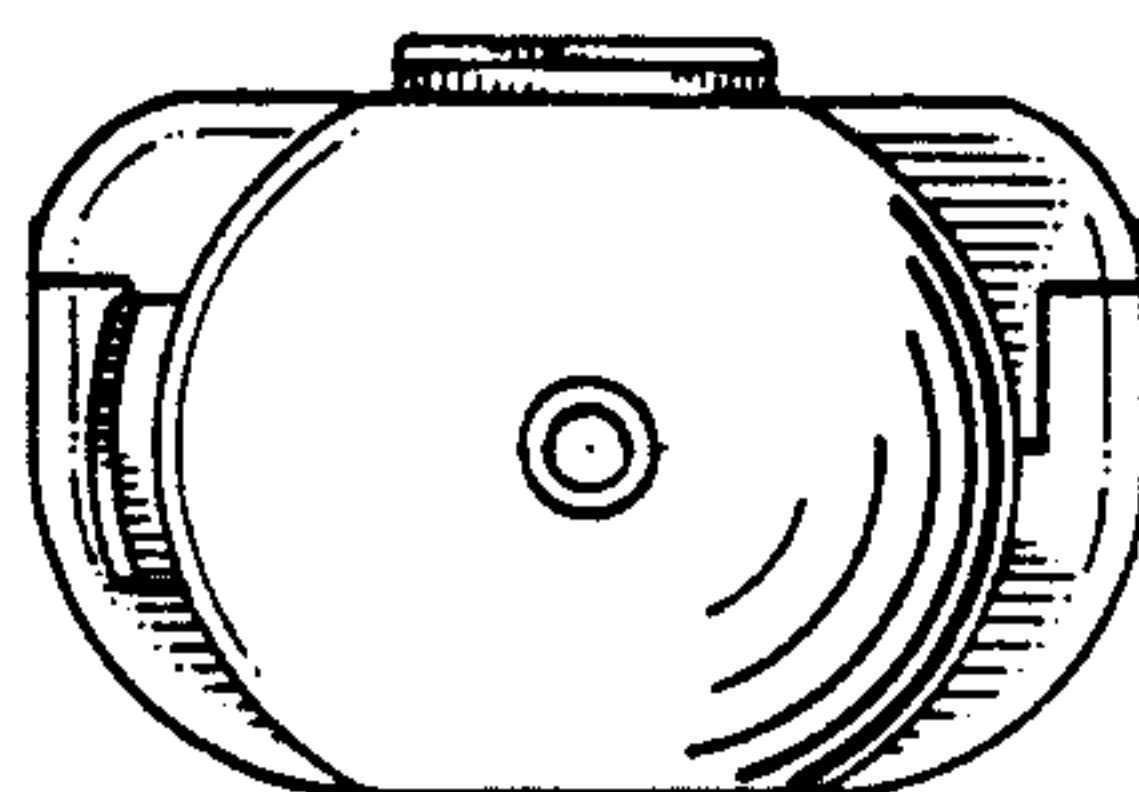

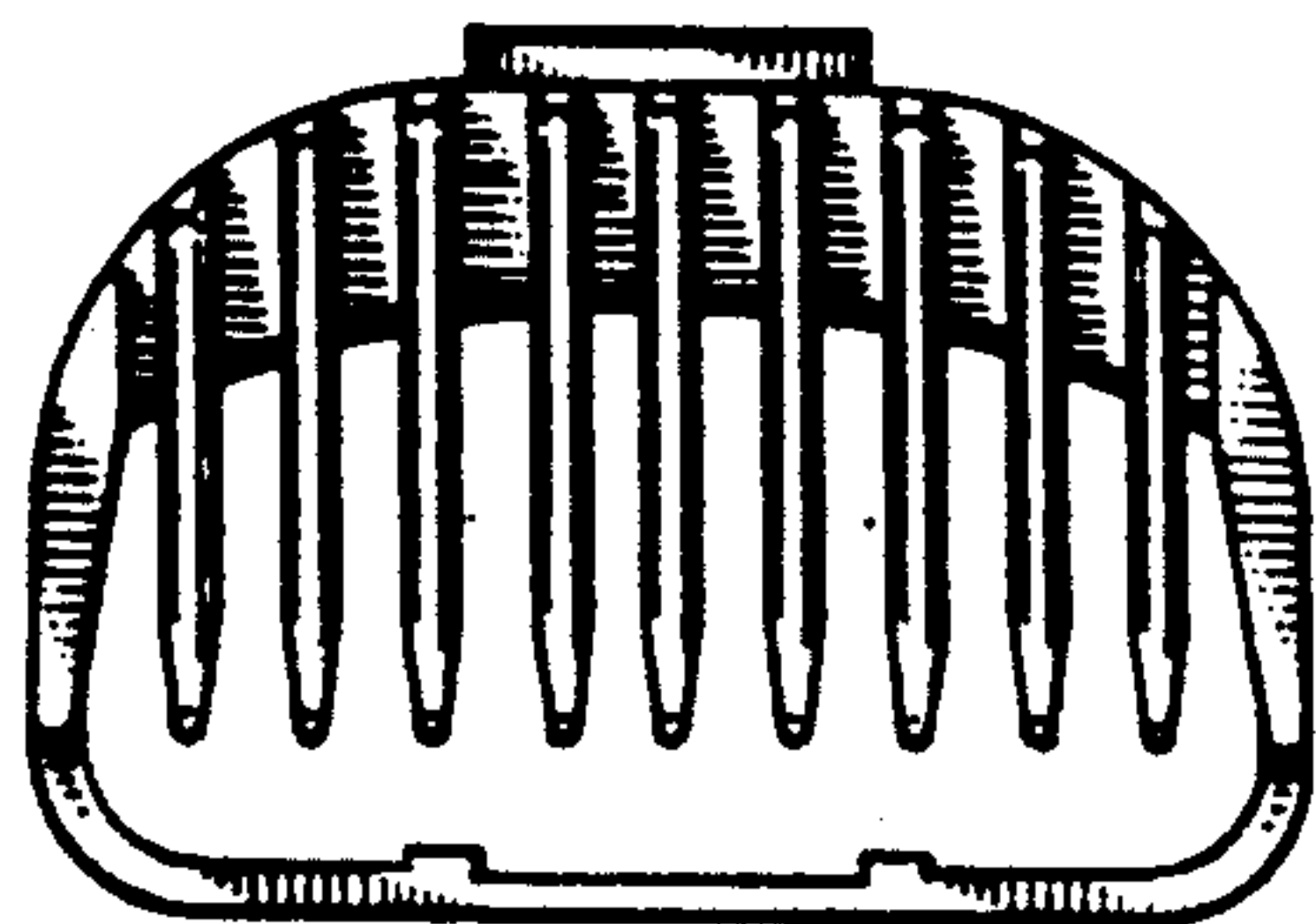

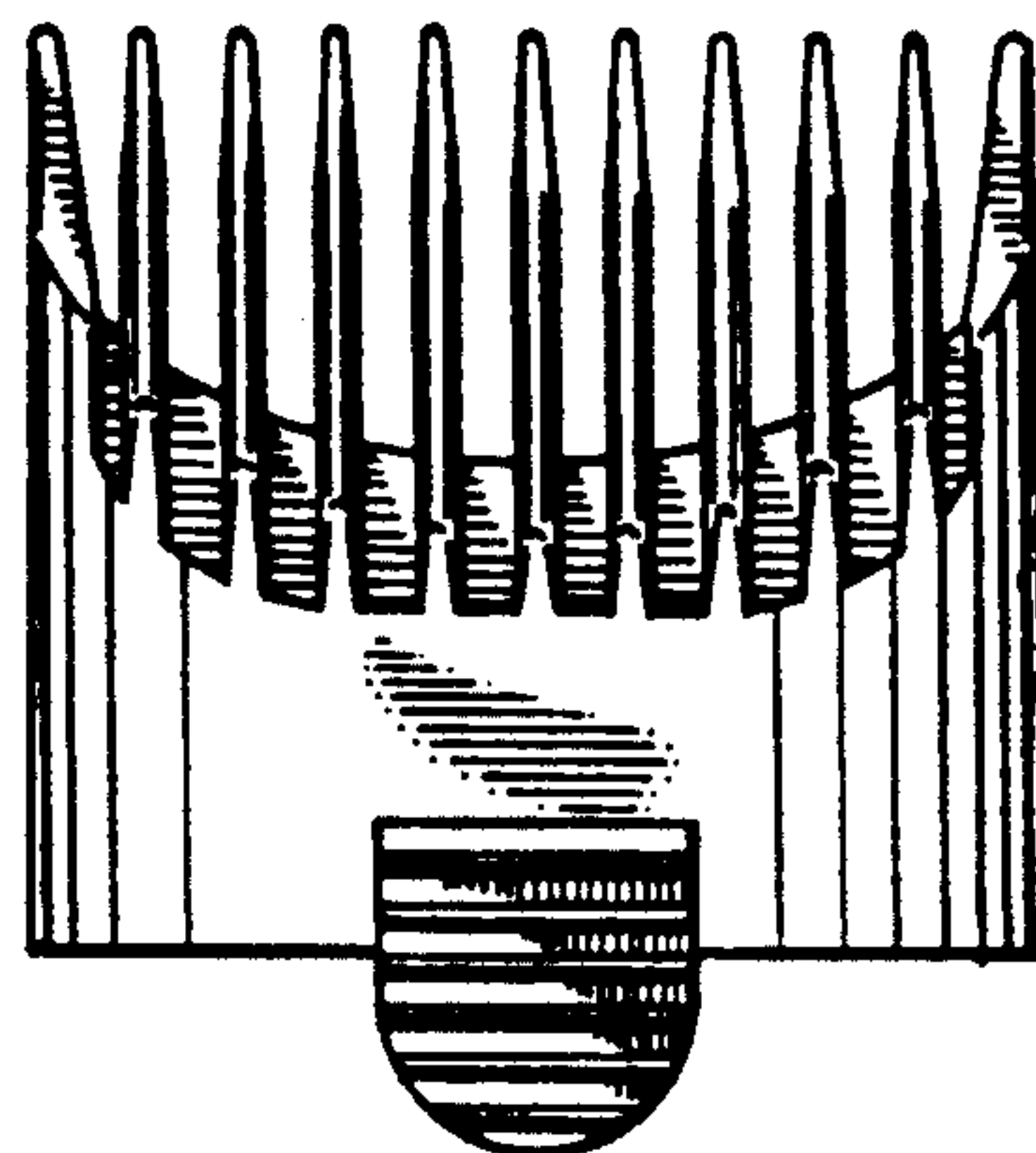

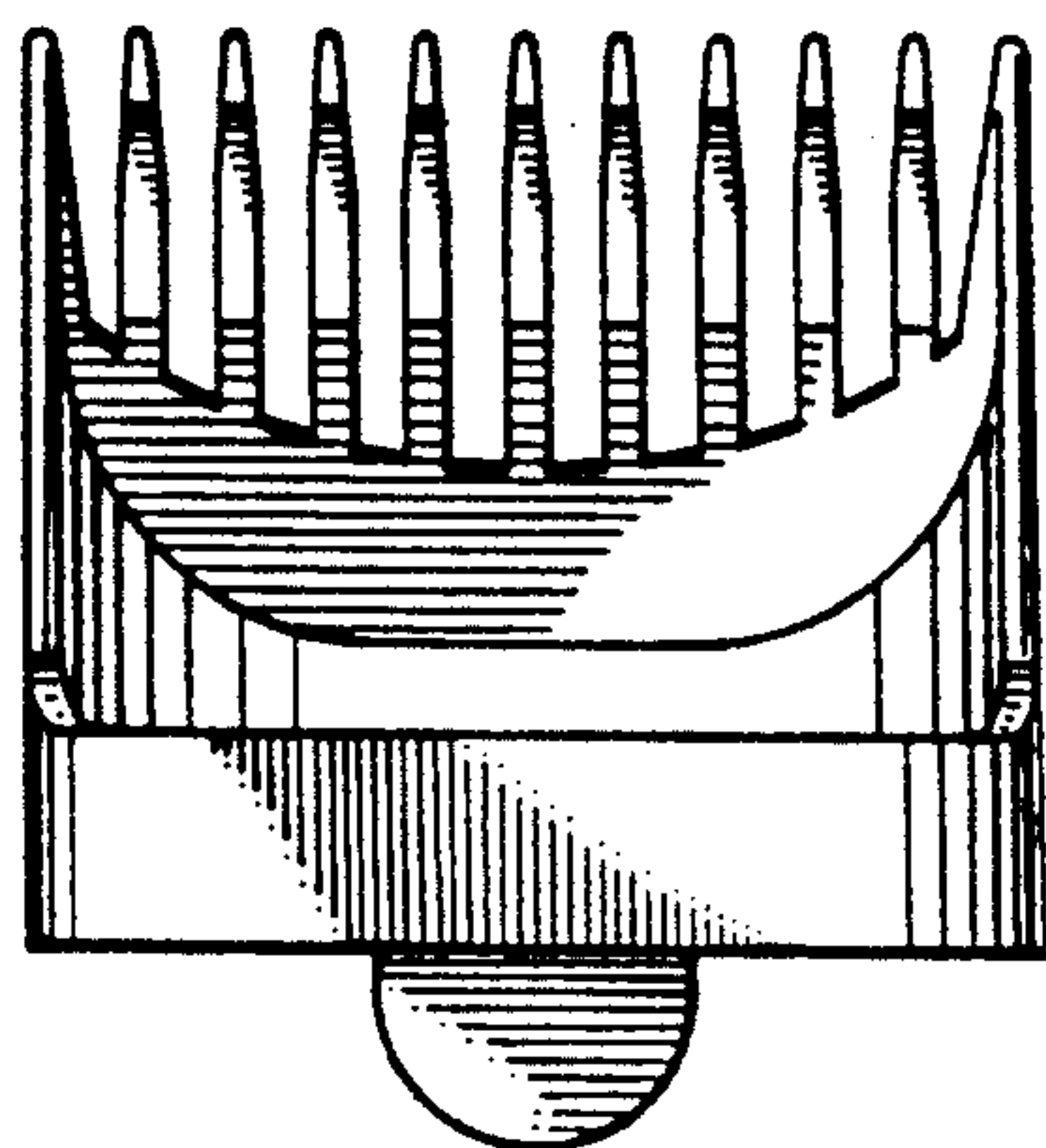

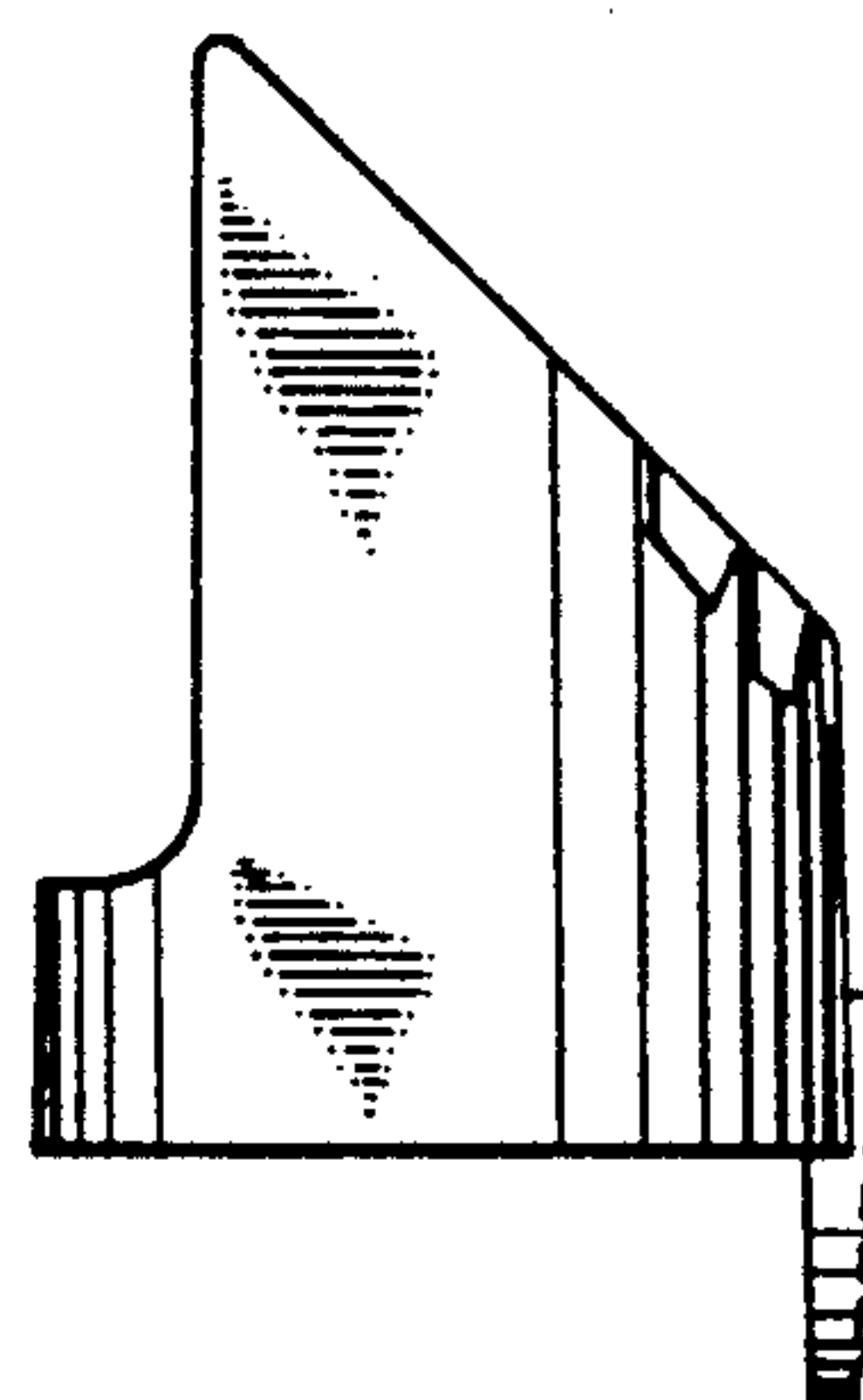

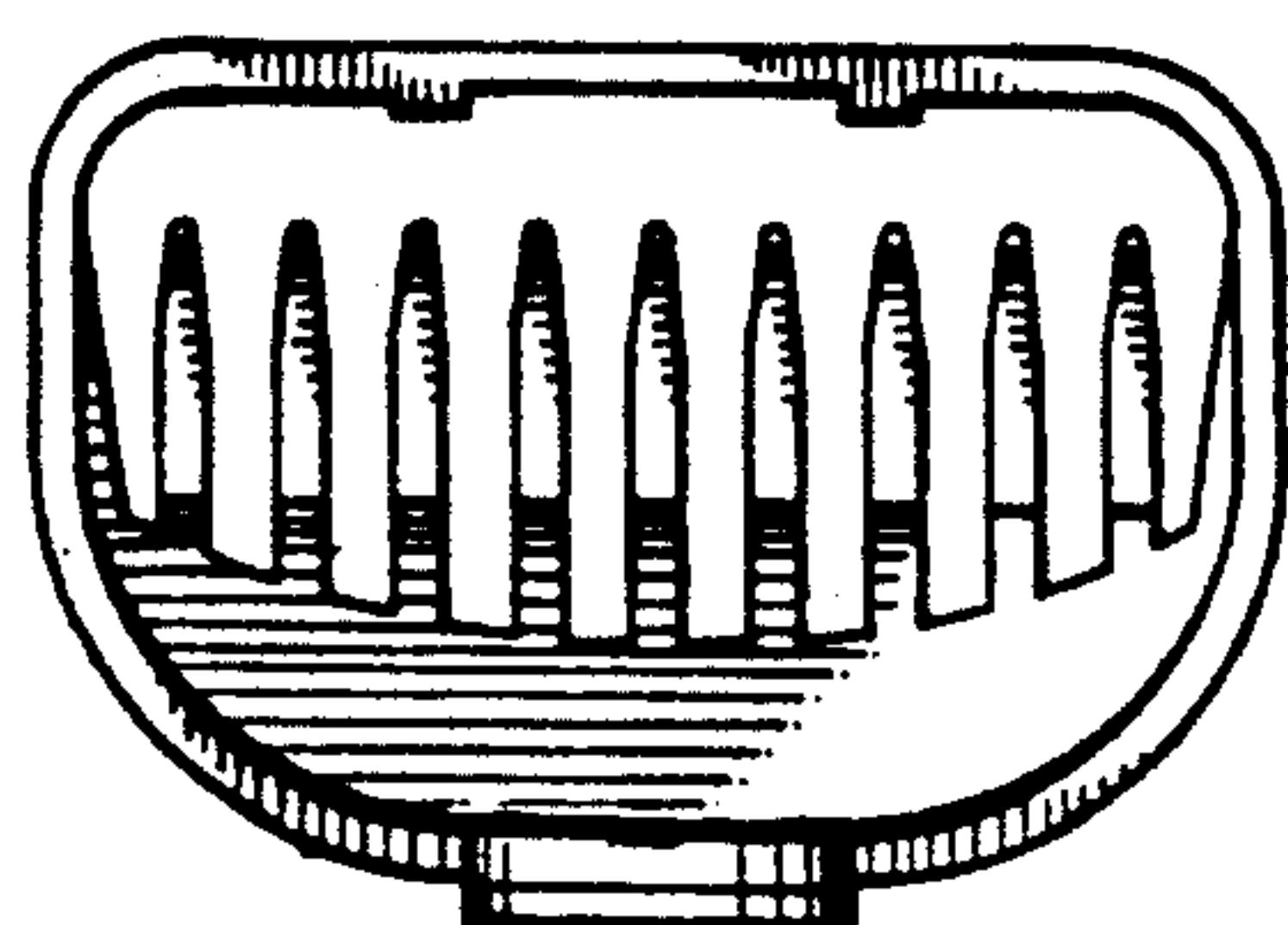

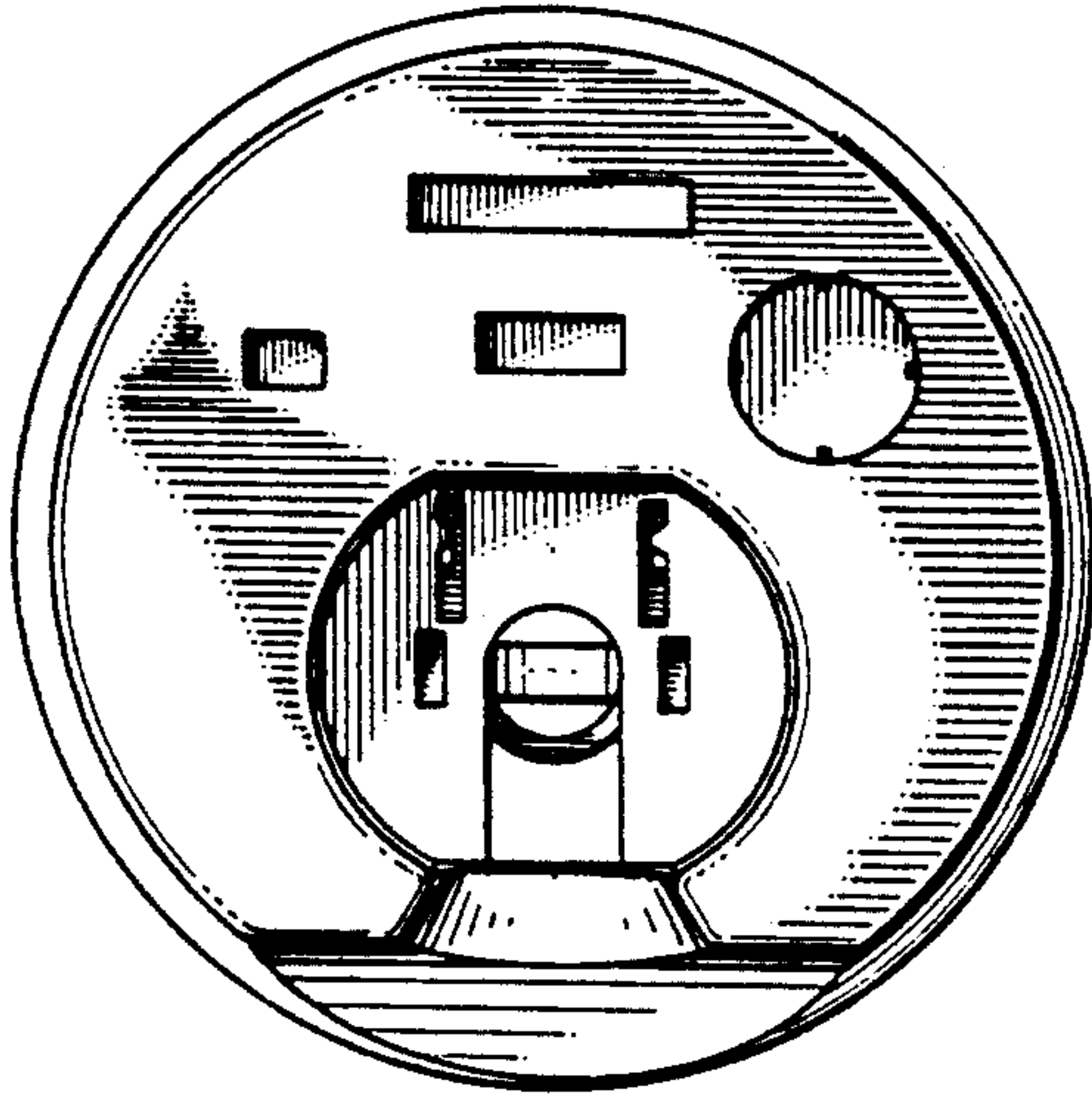

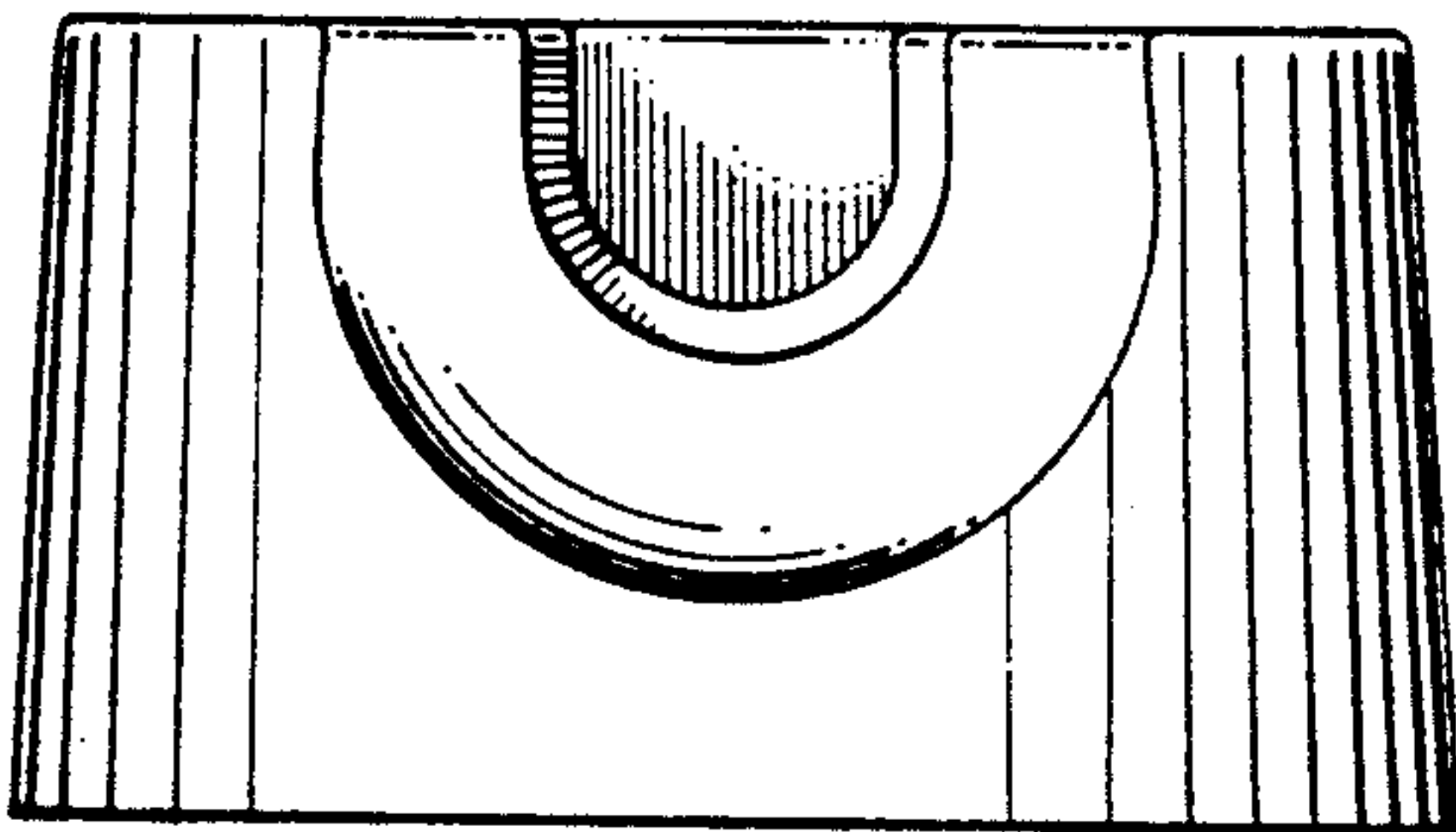

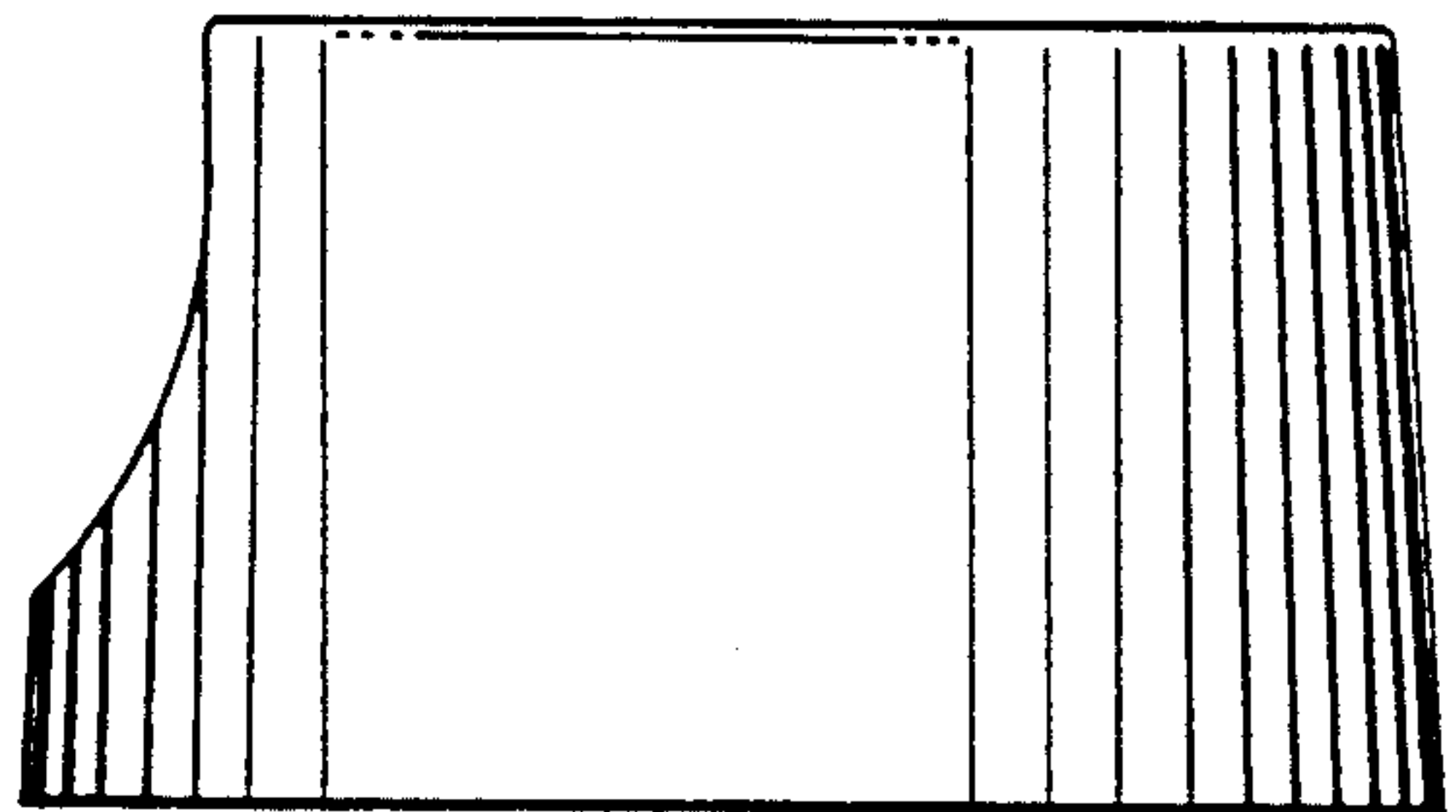

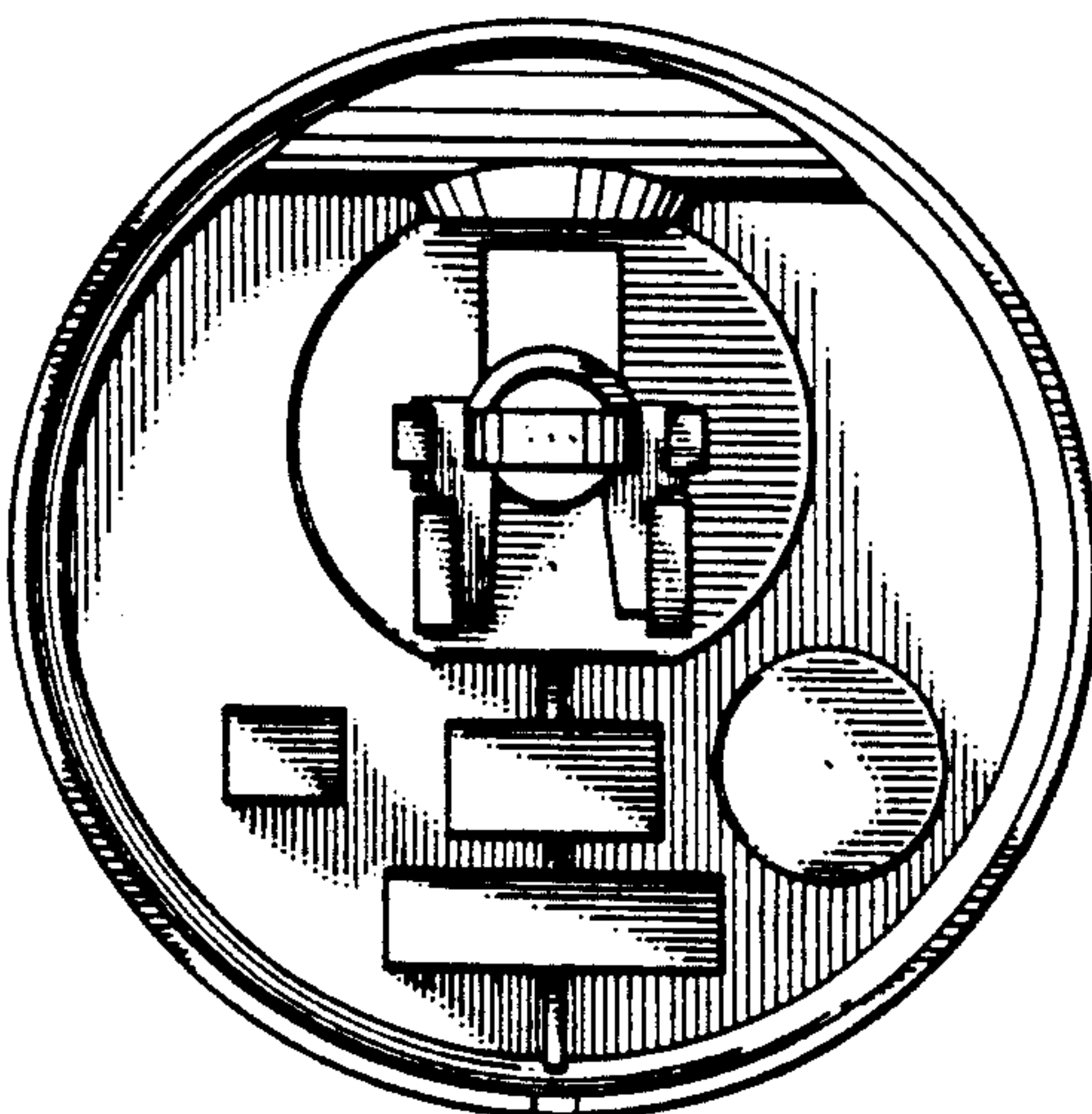

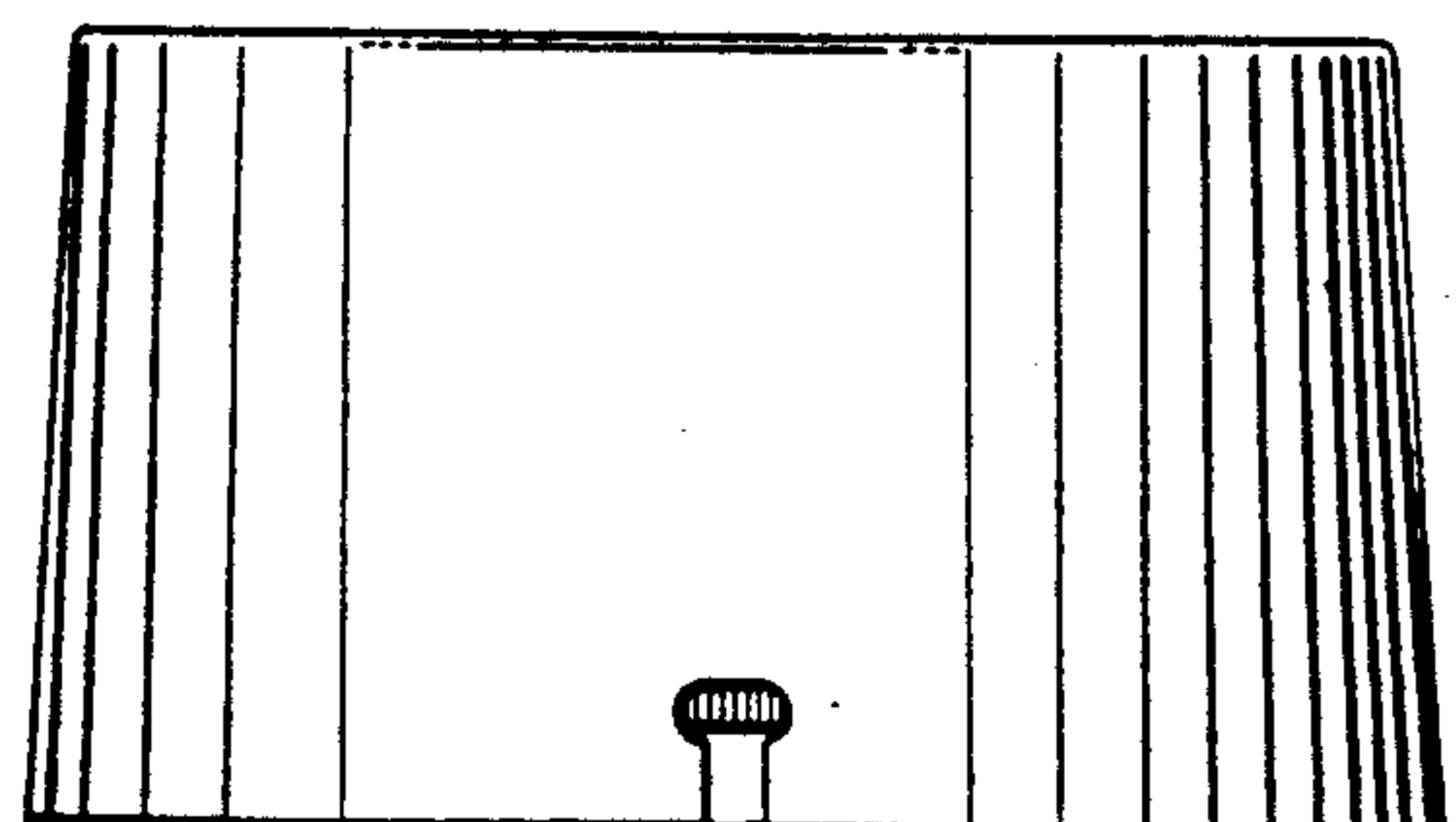

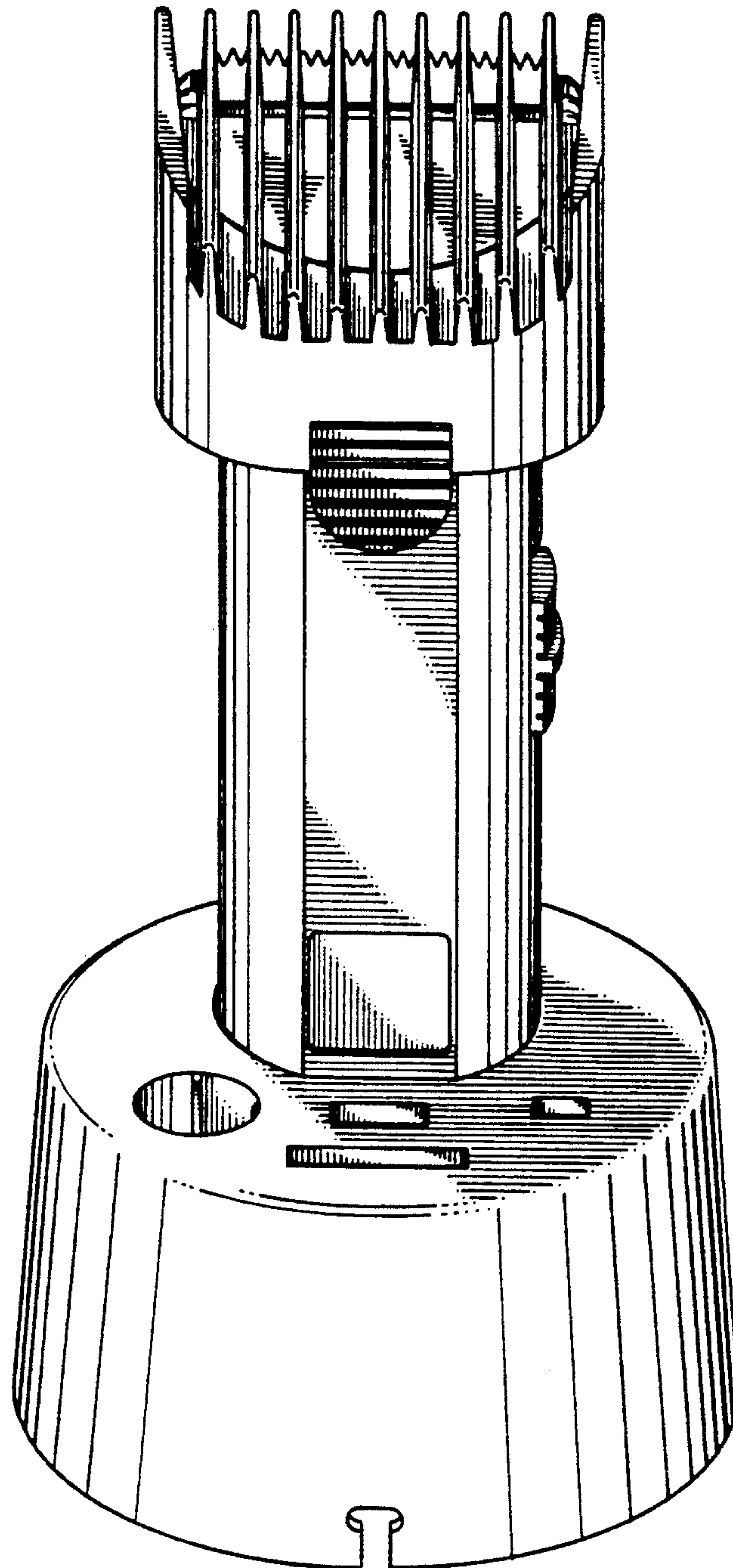
