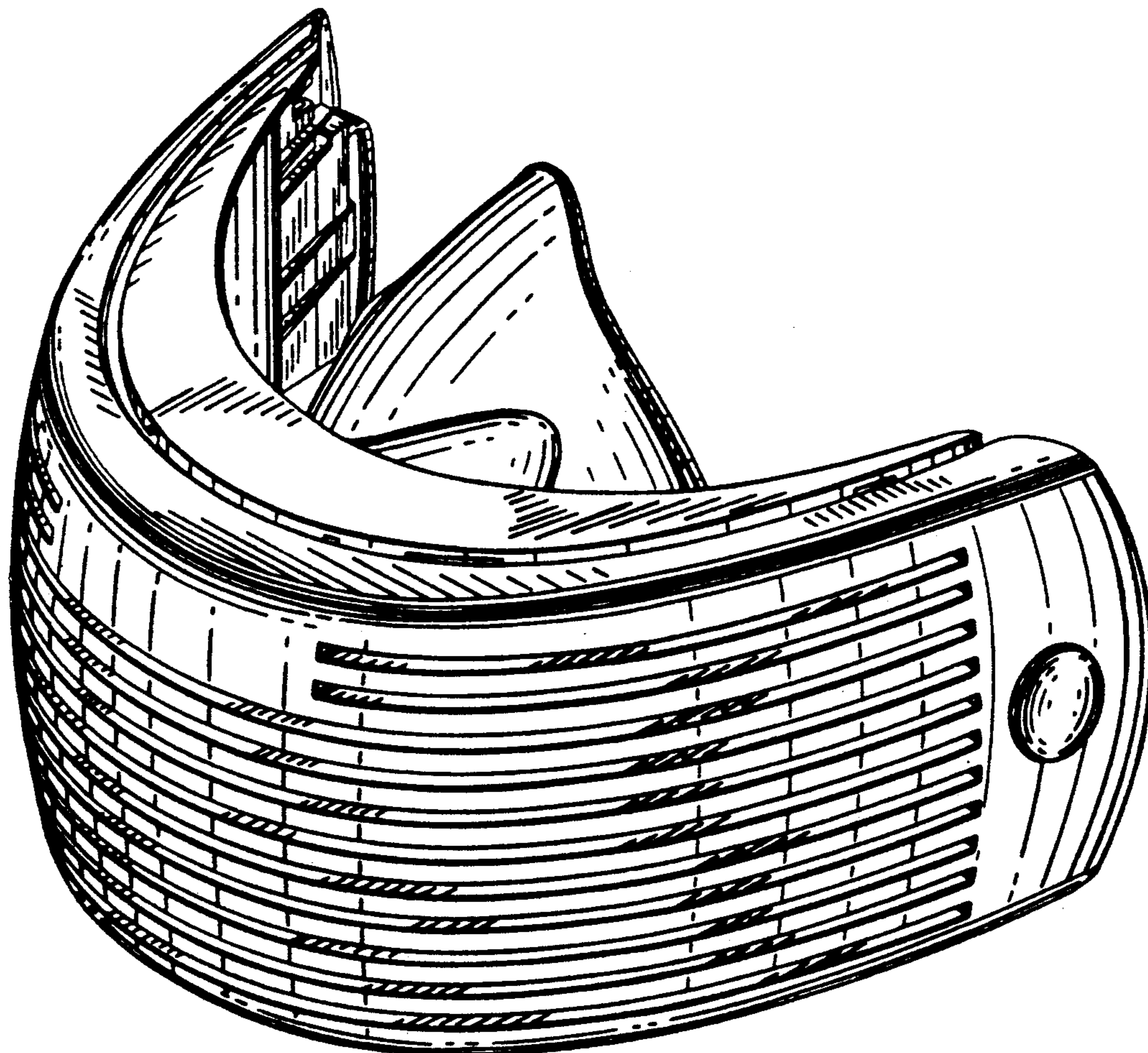

DESCRIPTION

FIG. 1 is a front elevational view of a respirator or similar article showing our design; FIG. 2 is a top plan view thereof; FIG. 3 is a left end view thereof; FIG. 4 is a right end view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a front perspective view thereof.



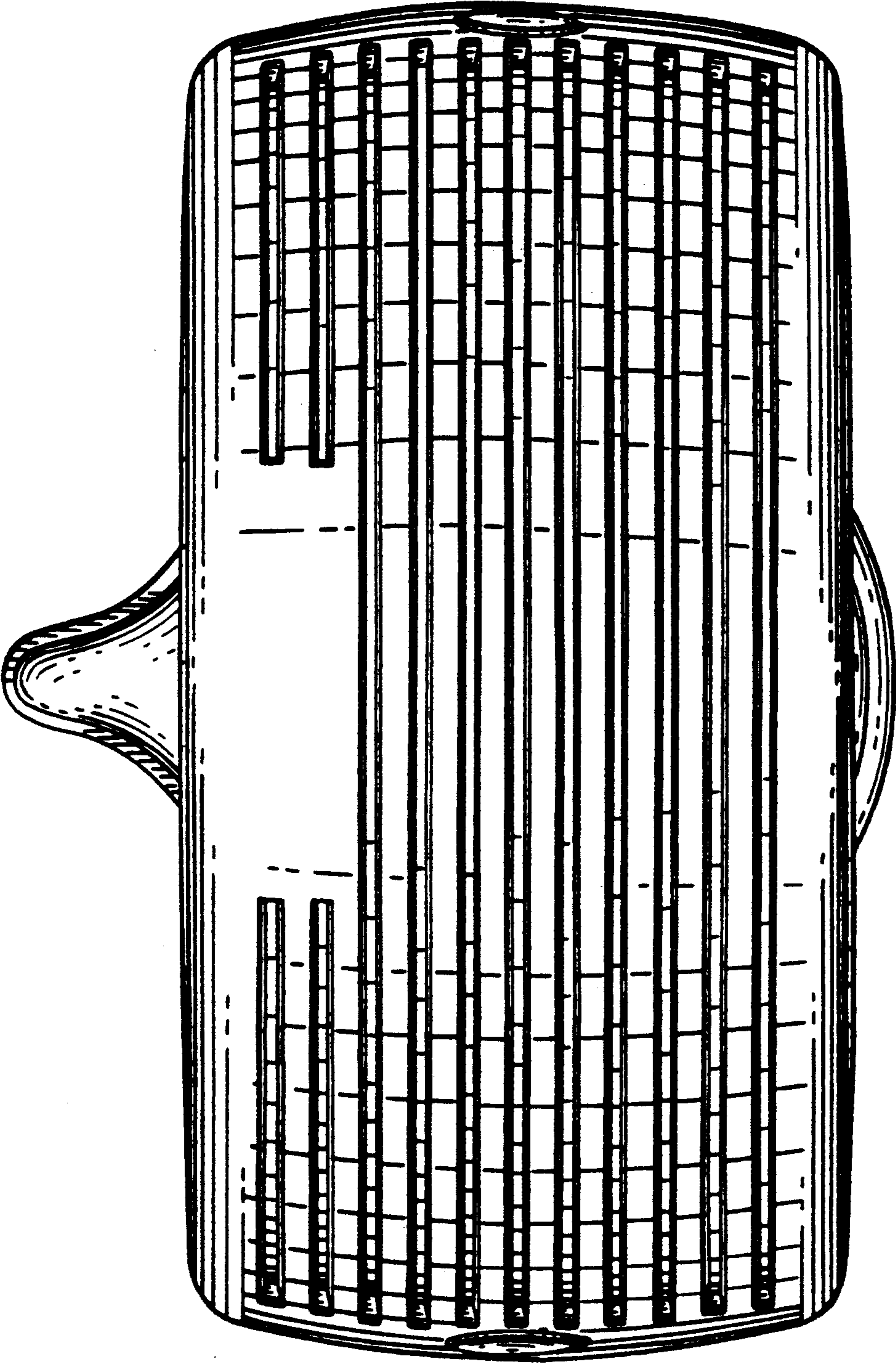

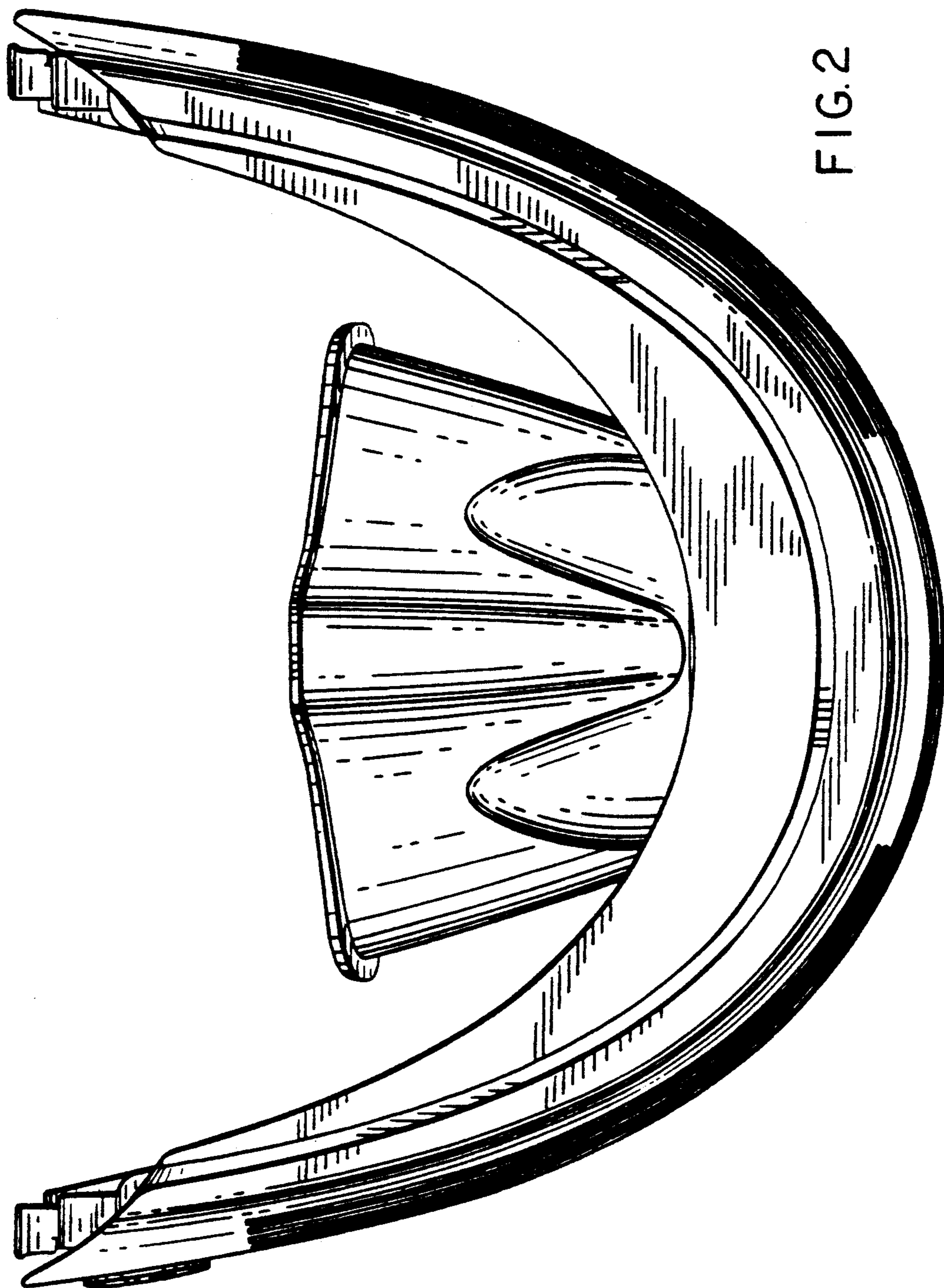

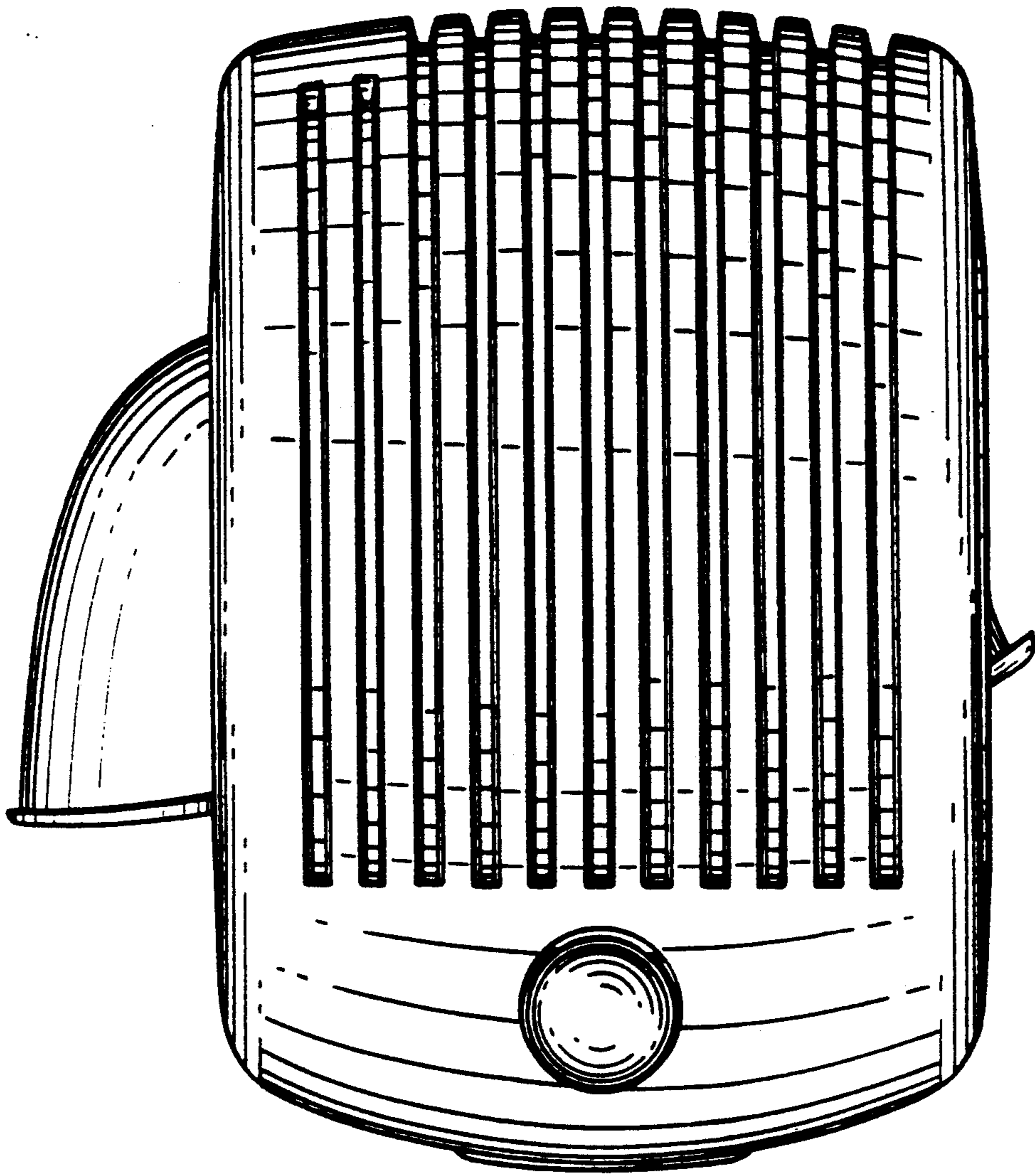

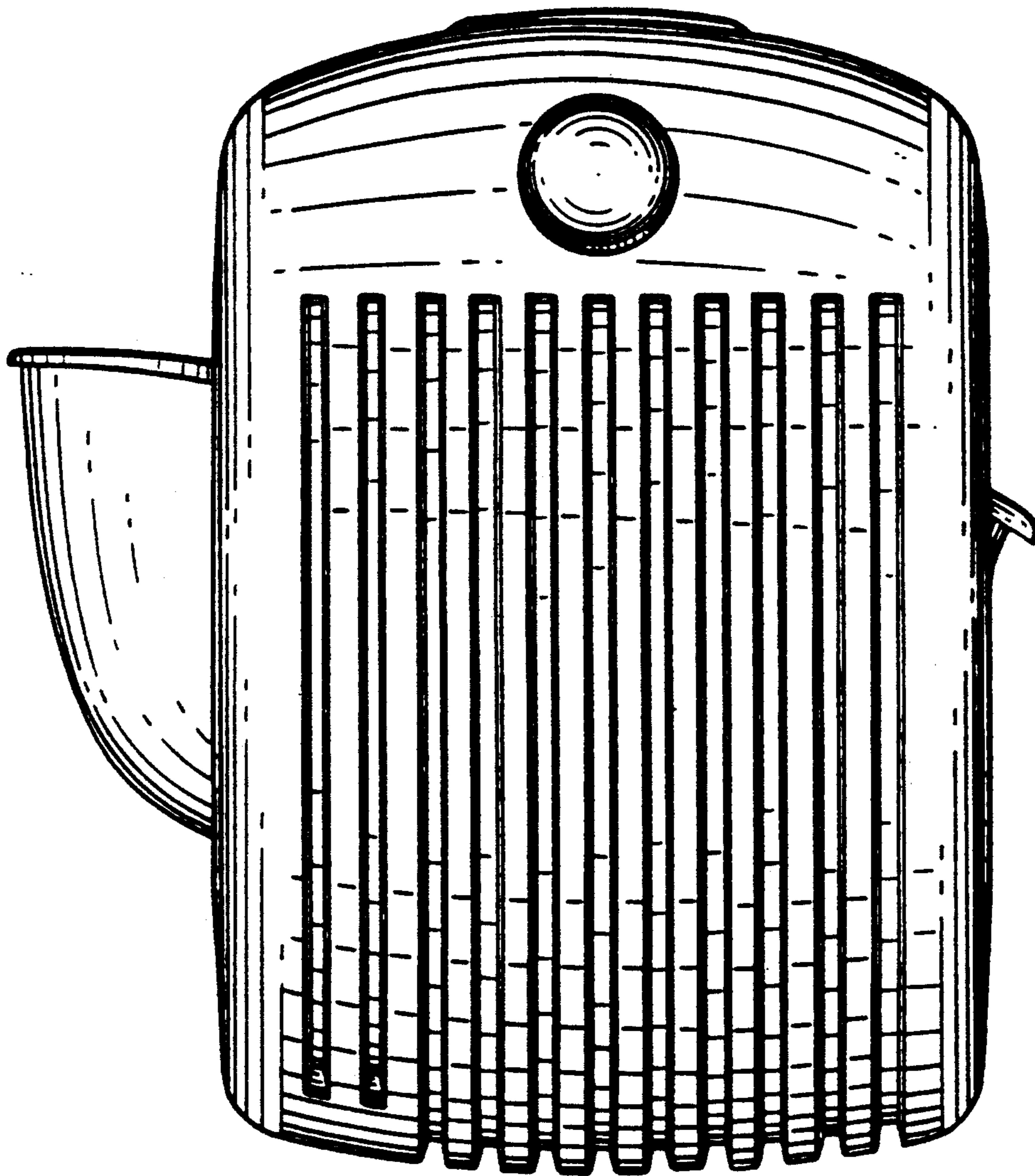

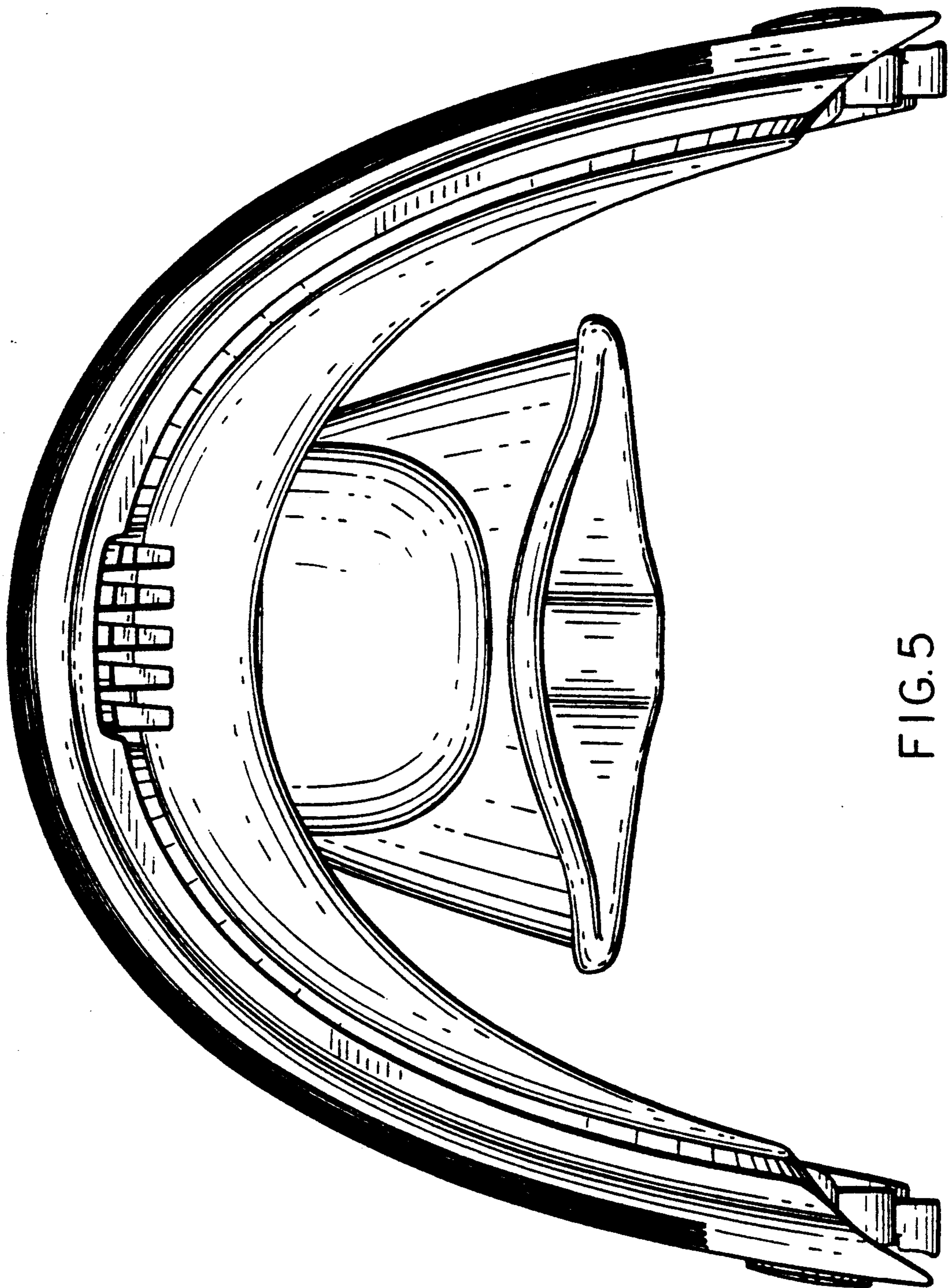

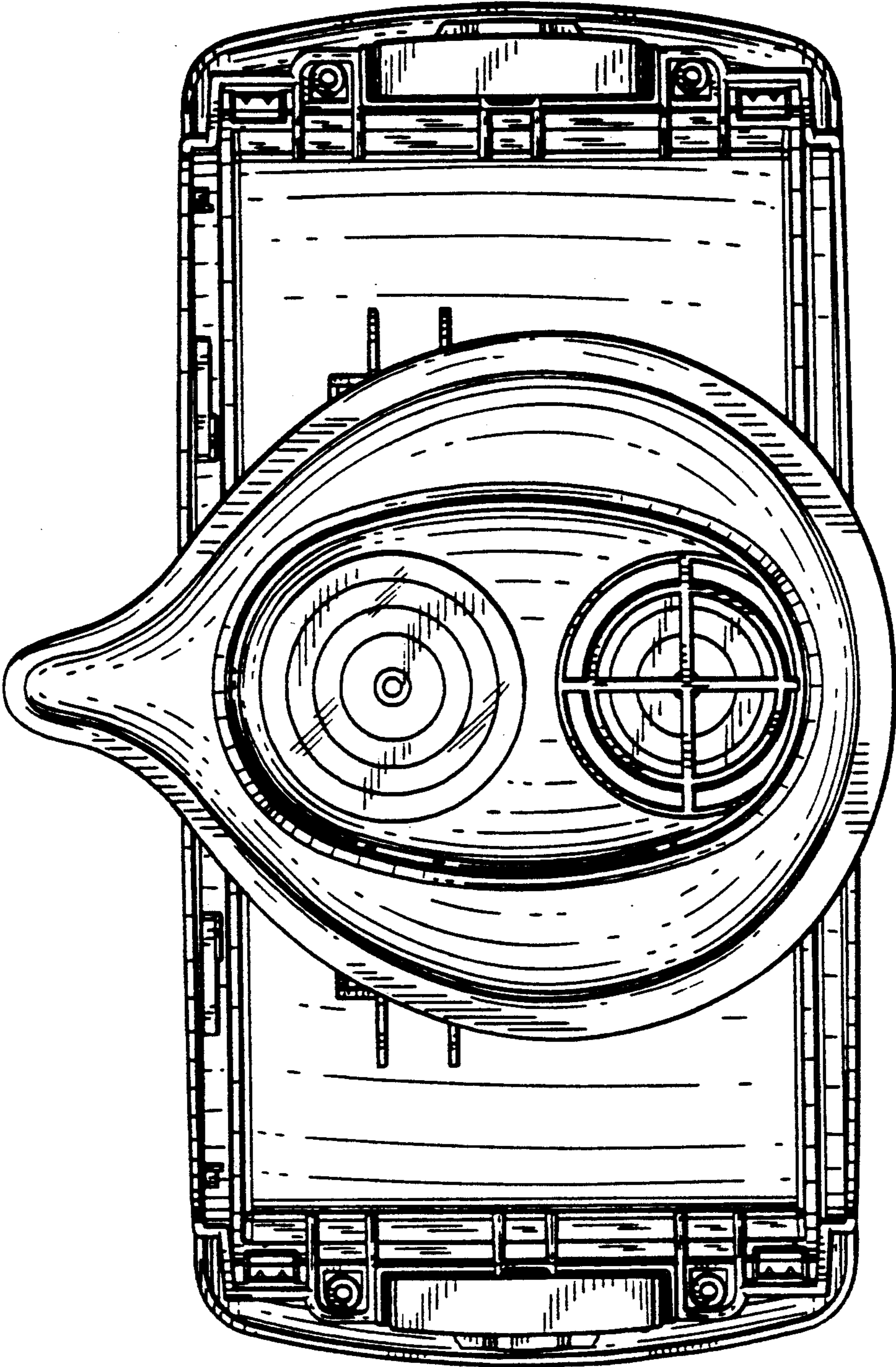
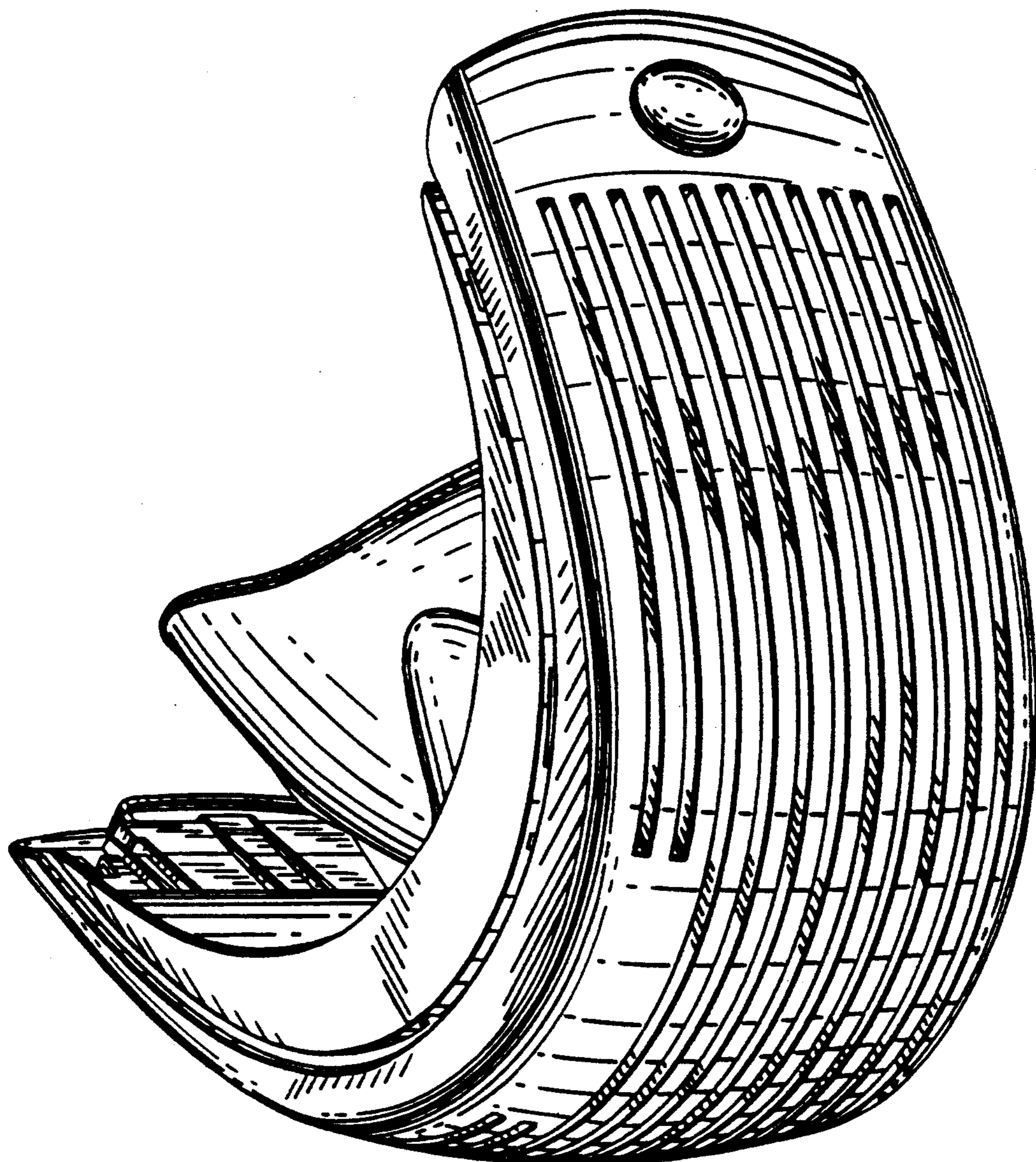
