[57] **CLAIM**

The ornamental design for a wireless telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and left side elevational perspective view of a wireless telephone showing our new design;  
FIG. 2 is a right elevational view thereof;  
FIG. 3 is a left elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a top plan elevational view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a rear elevational view thereof; and,  
FIG. 8 is a front, top and left side elevational perspective view thereof in condition that the mouthpiece is put back to the fixed place.

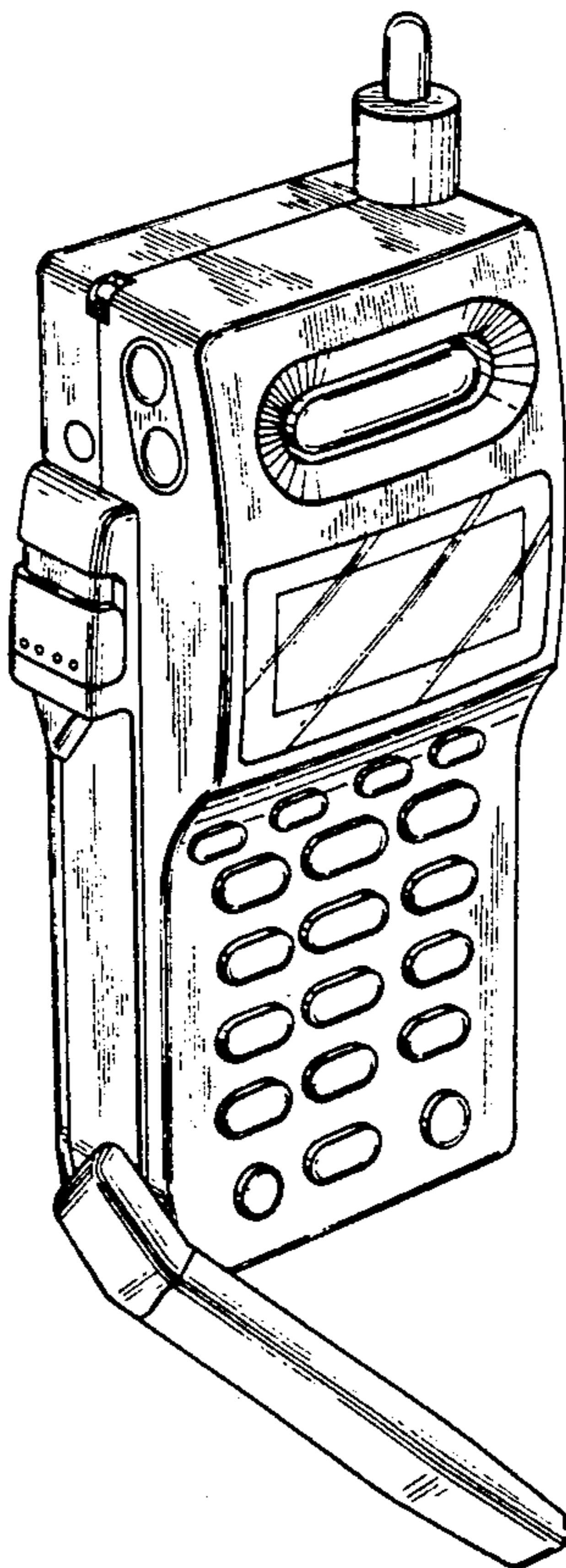

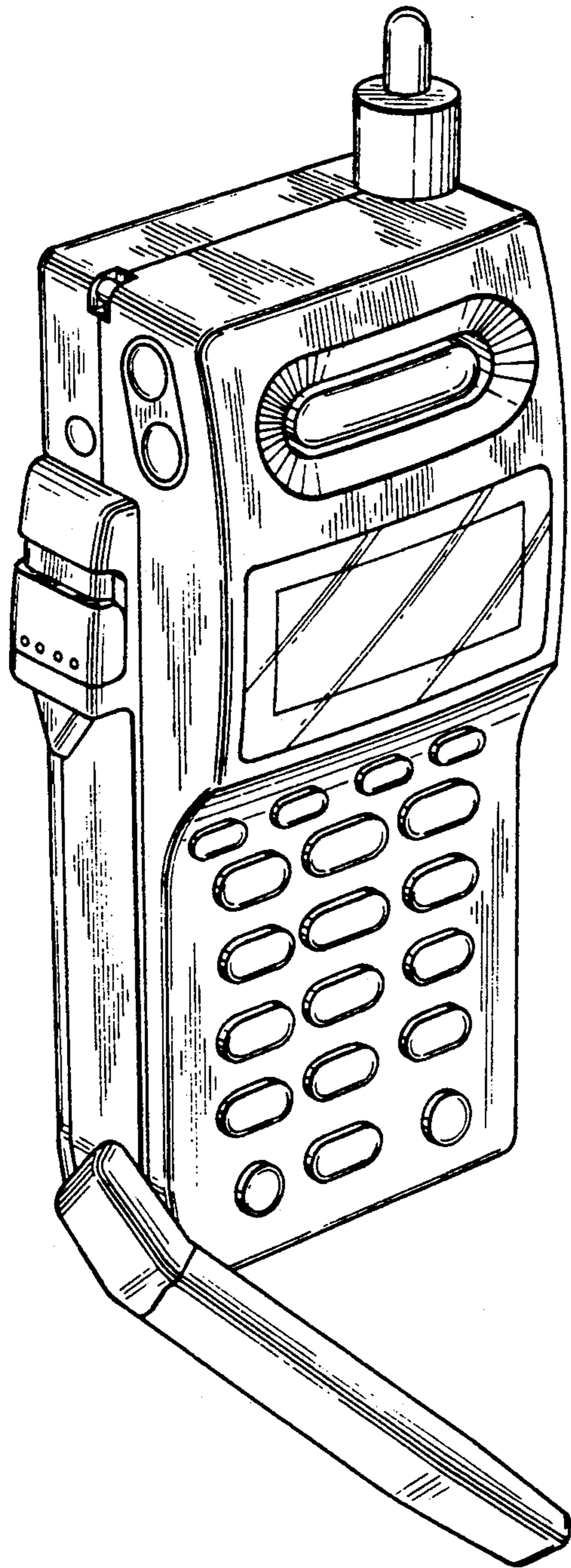

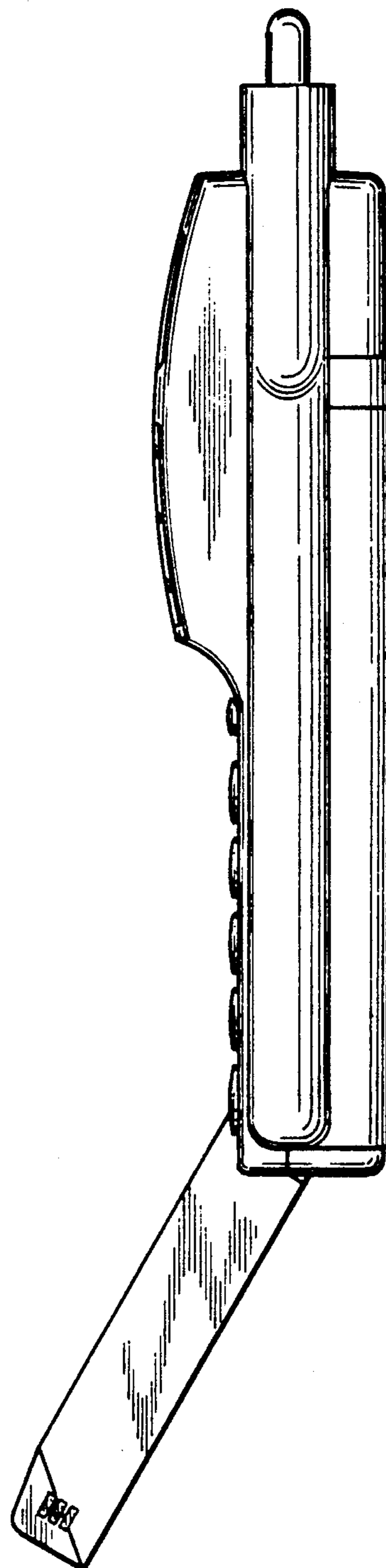

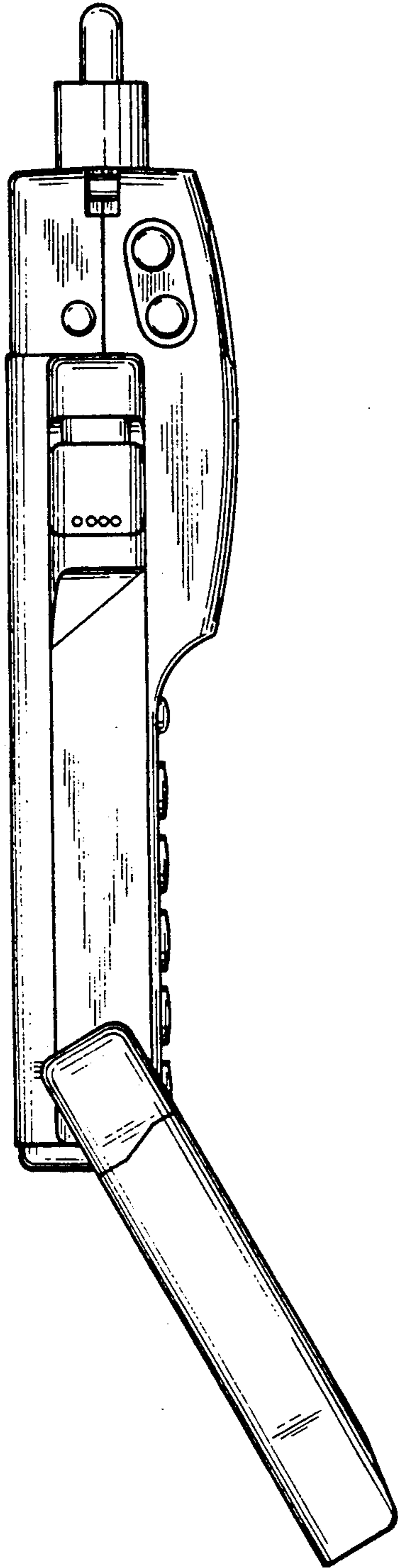

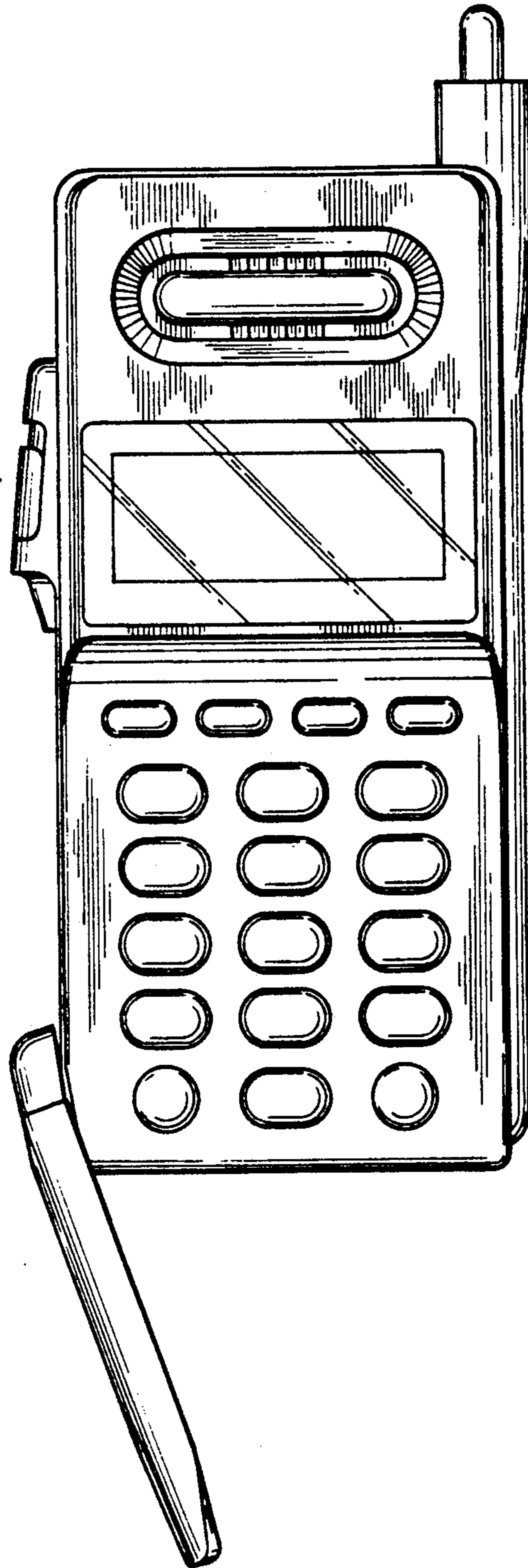

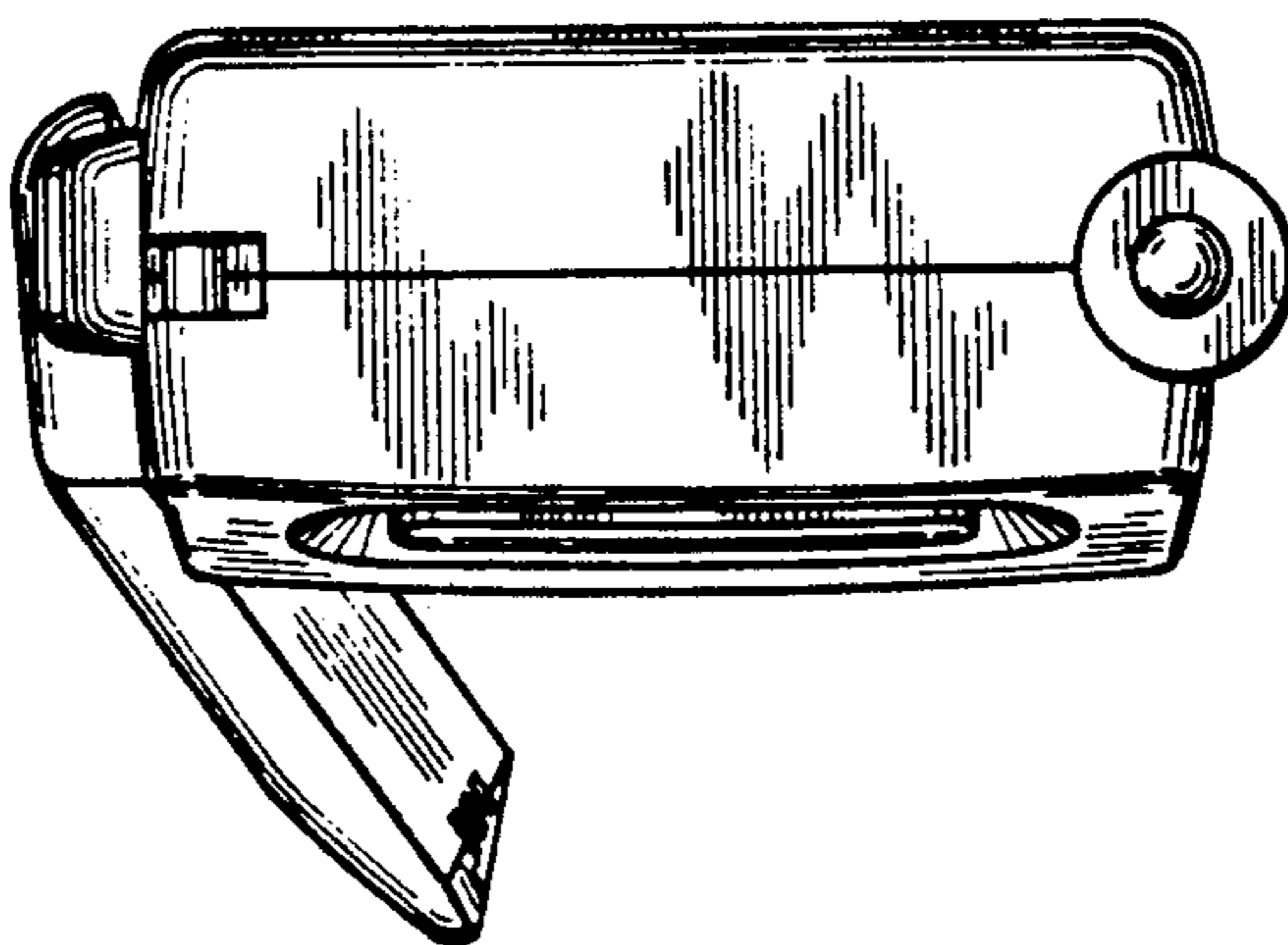

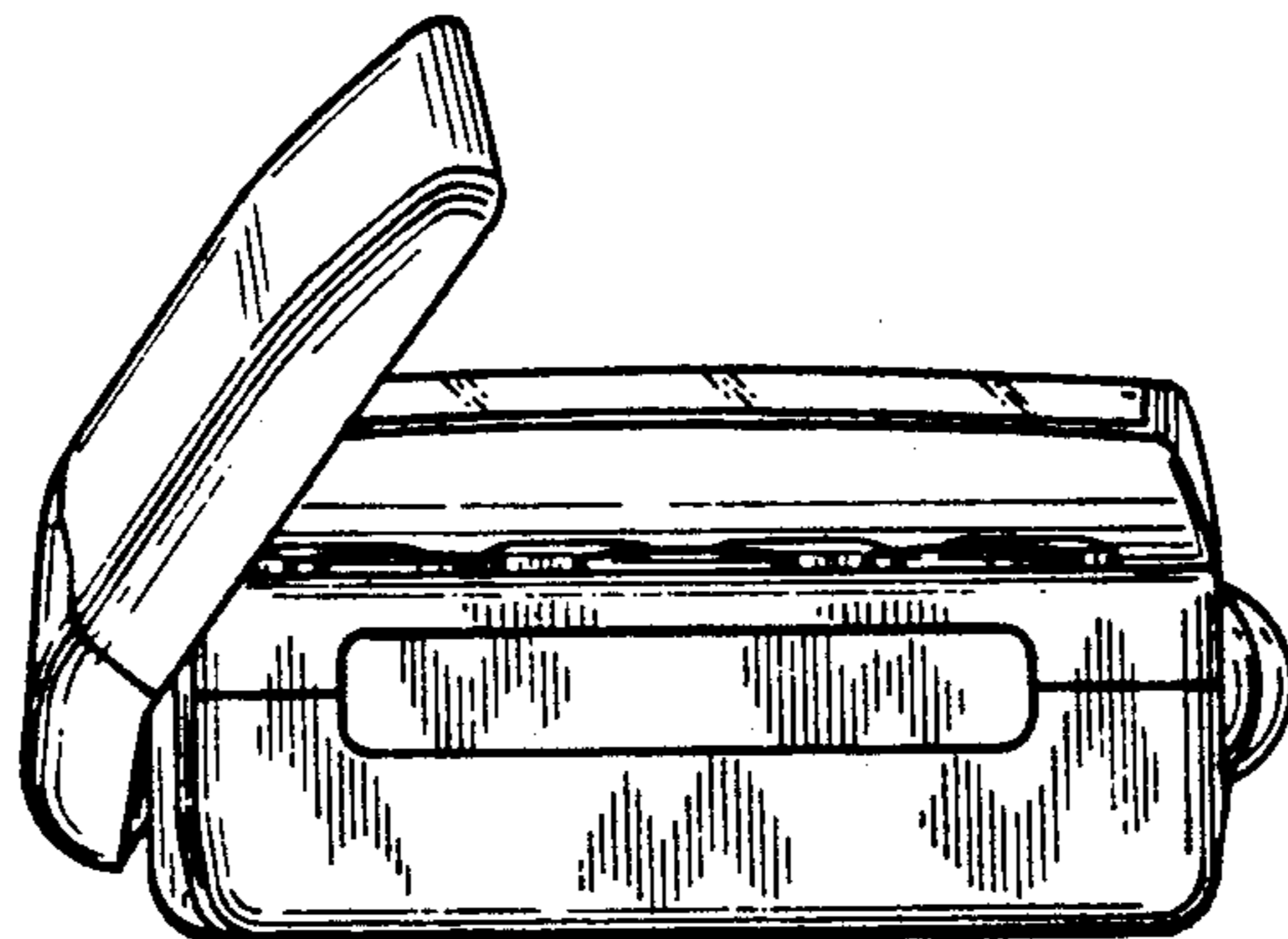

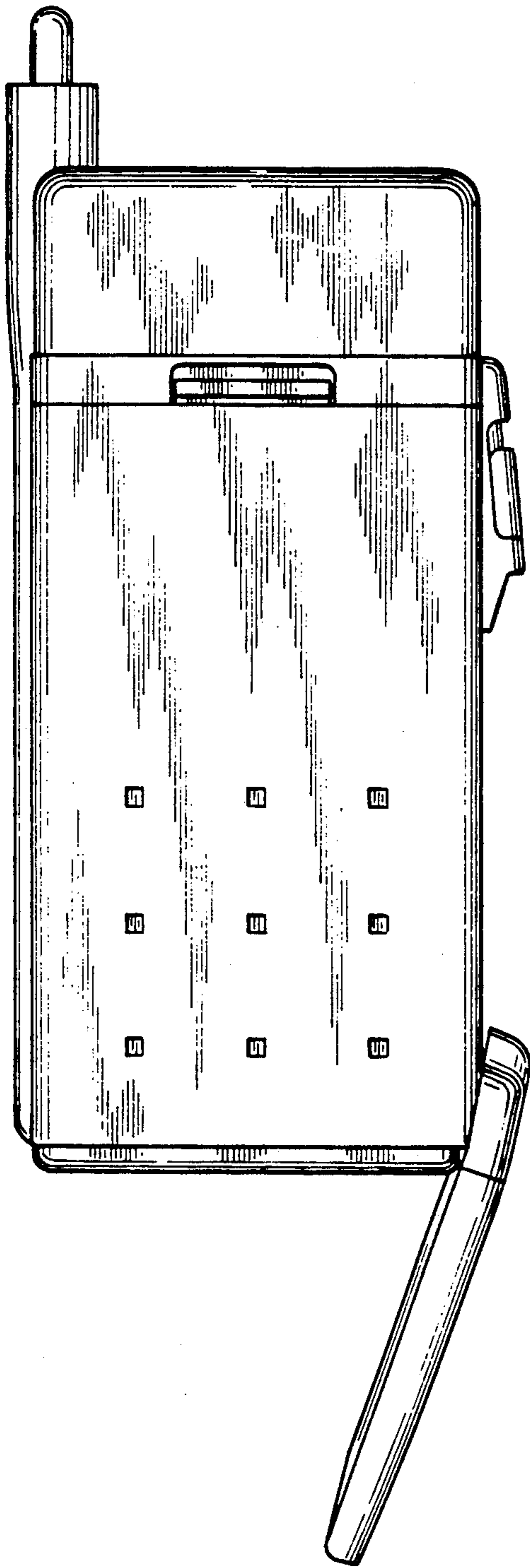
