[57] **CLAIM**

The ornamental design for a handset holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handset holder, showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a perspective view of a second embodiment of our new design;  
FIG. 9 is a front elevational view thereof;  
FIG. 10 is a right side elevation view thereof;  
FIG. 11 is a rear elevational view thereof;  
FIG. 12 is a left side elevational view thereof;  
FIG. 13 is a top plan view thereof;  
FIG. 14 is a bottom plan view thereof; and,  
FIG. 15 is a perspective view of the second embodiment of our new design, showing the telephone handset spaced away from the handset holder.  
The handset, telephone cord, and mounting slots shown in broken lines are for illustrative purposes only and form no part of the claimed design.

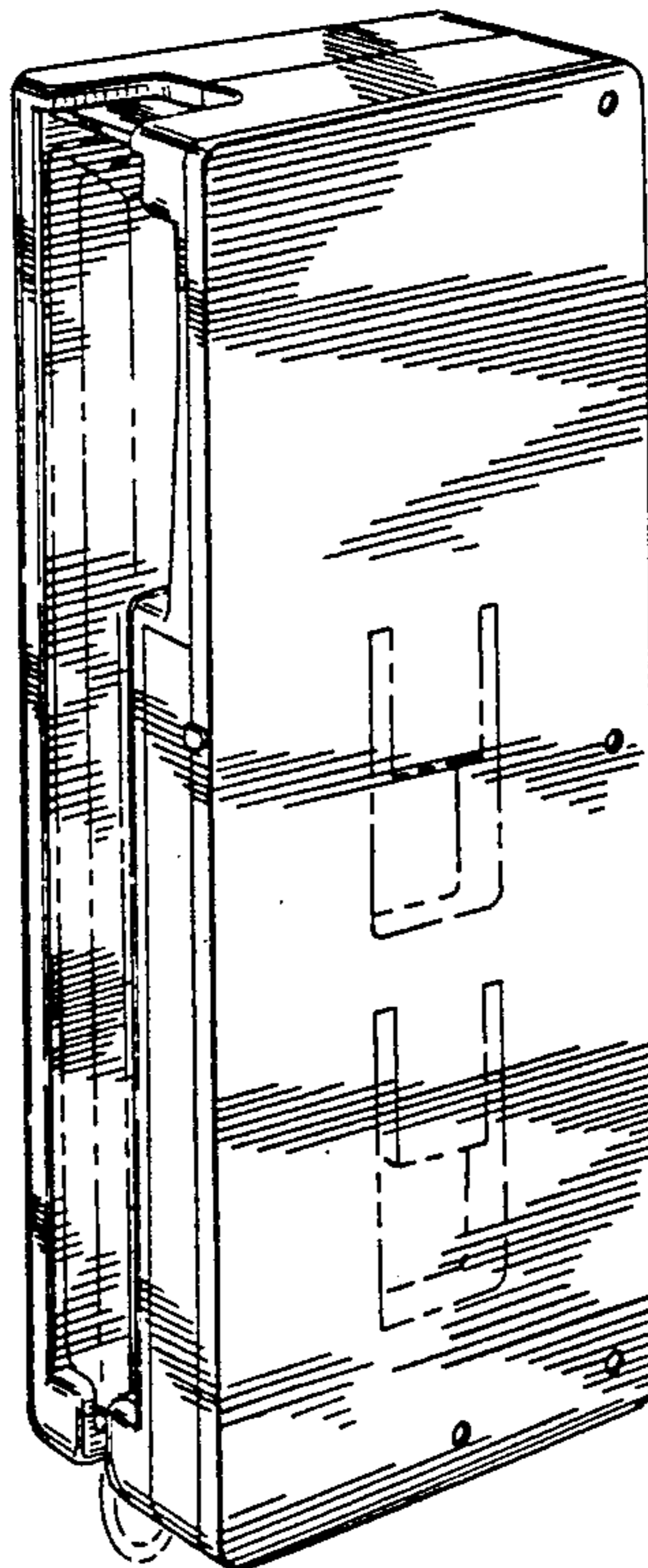

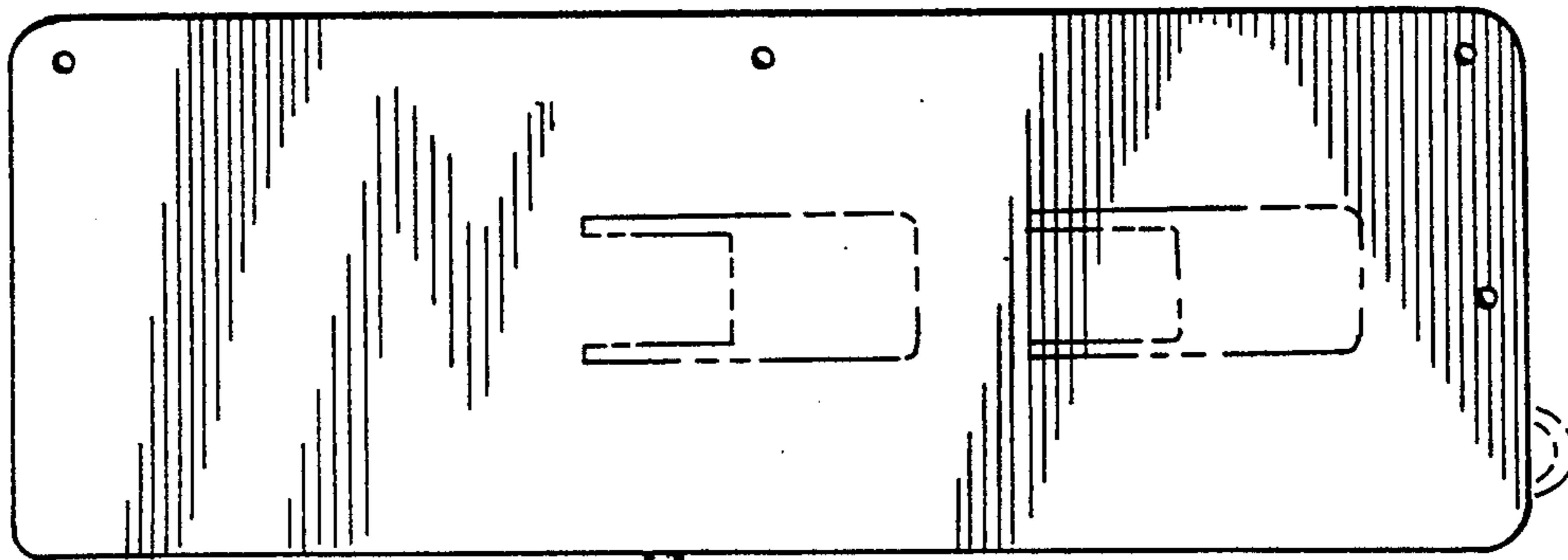

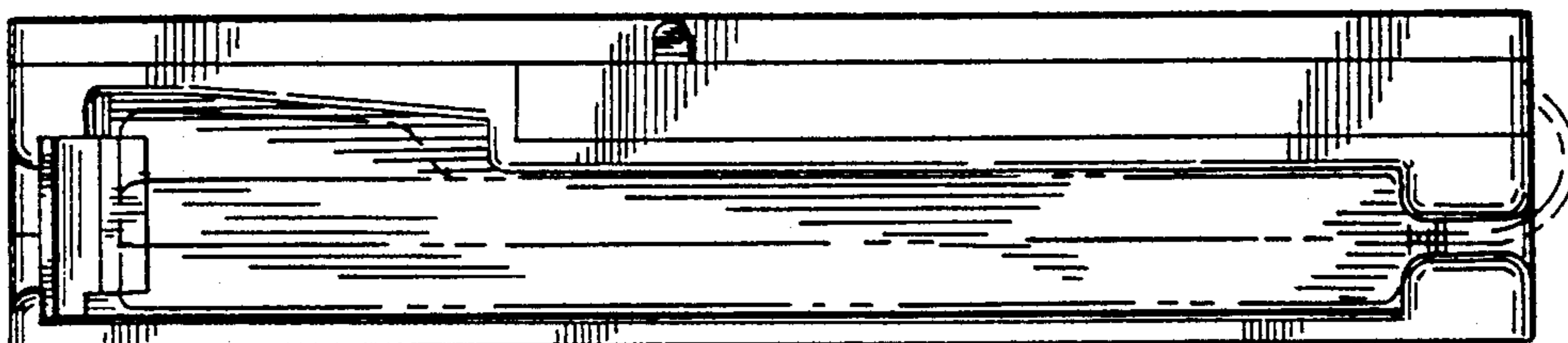

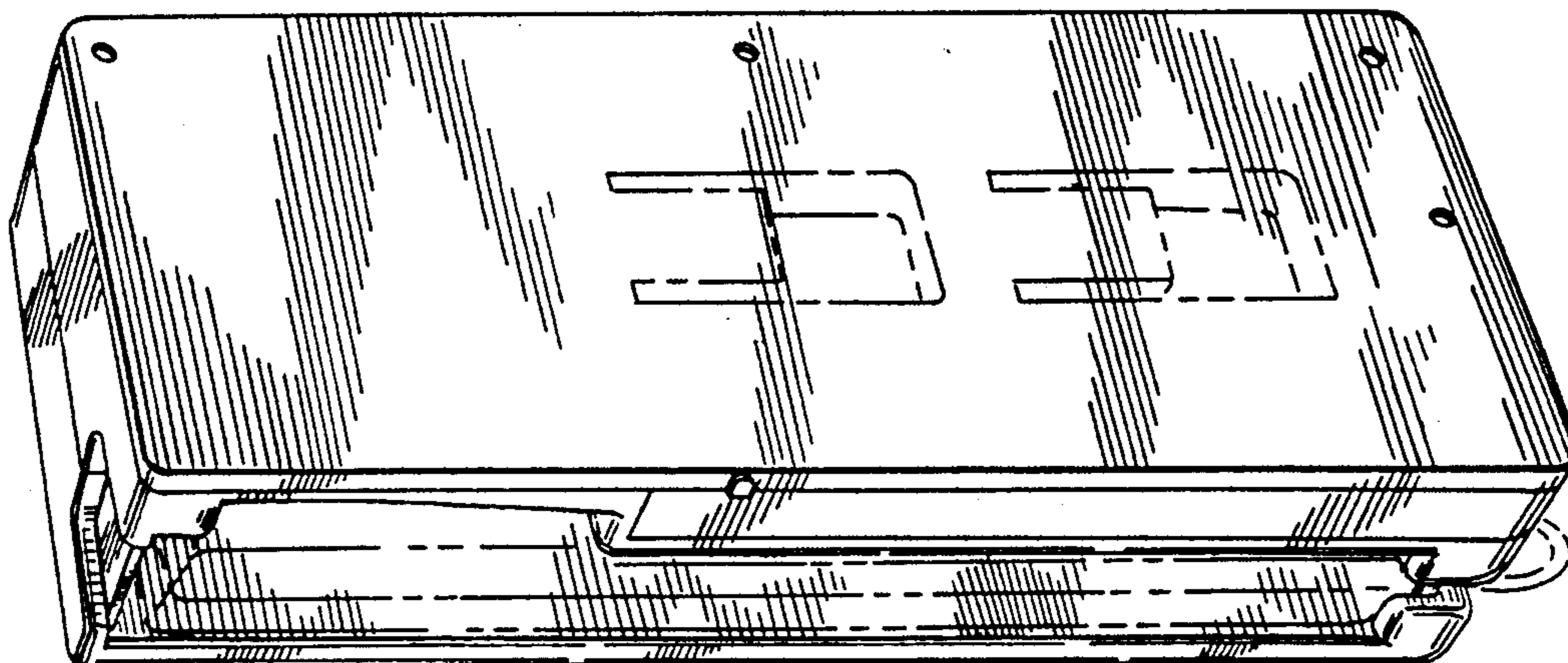

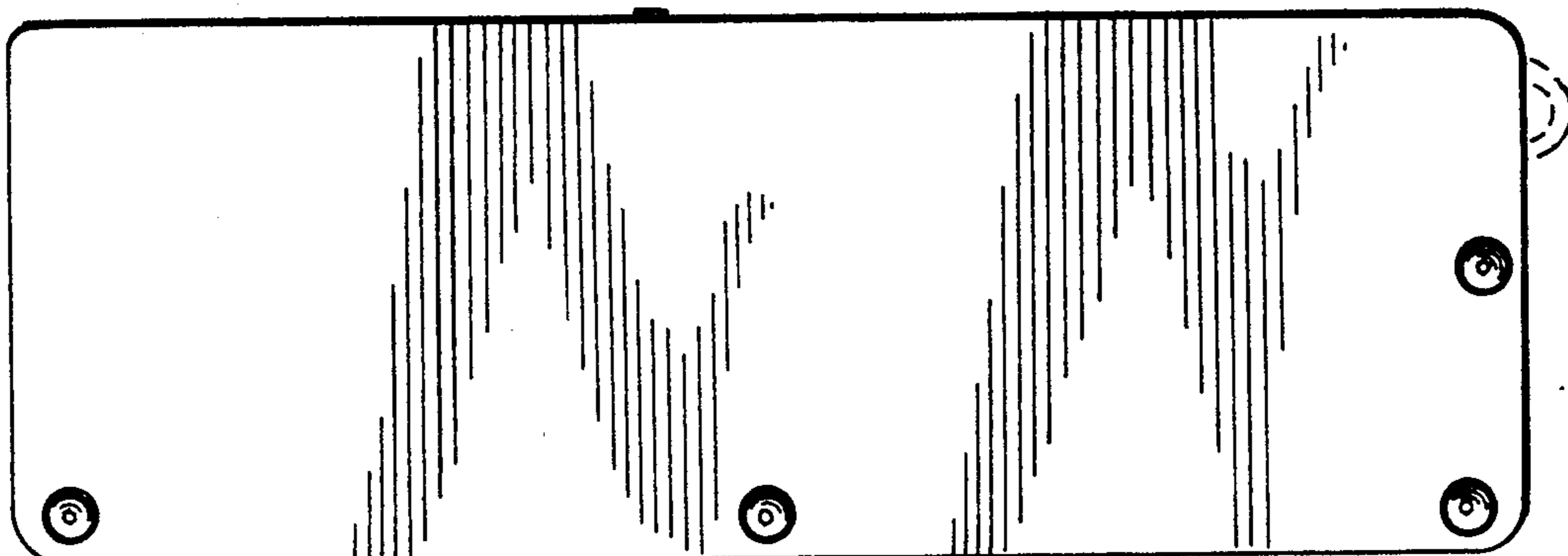

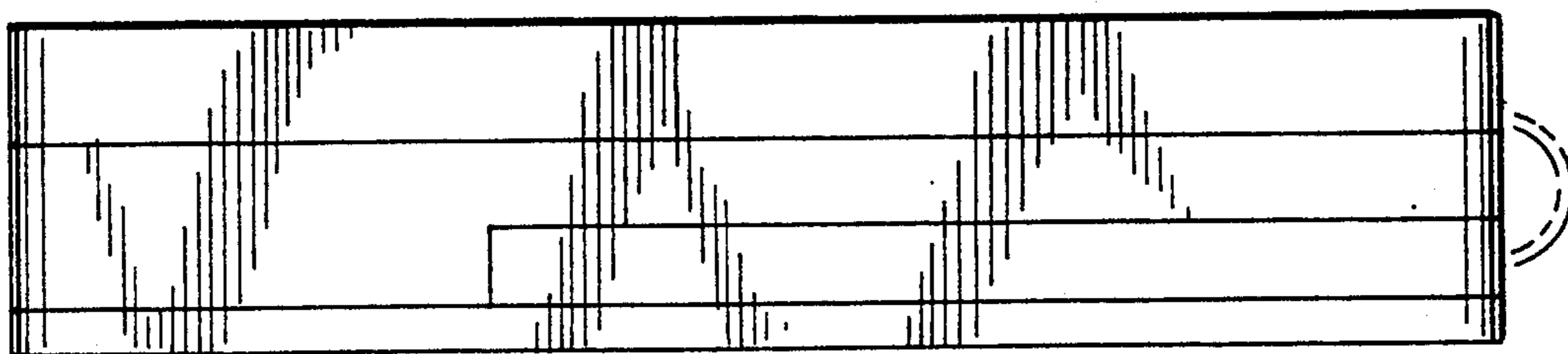

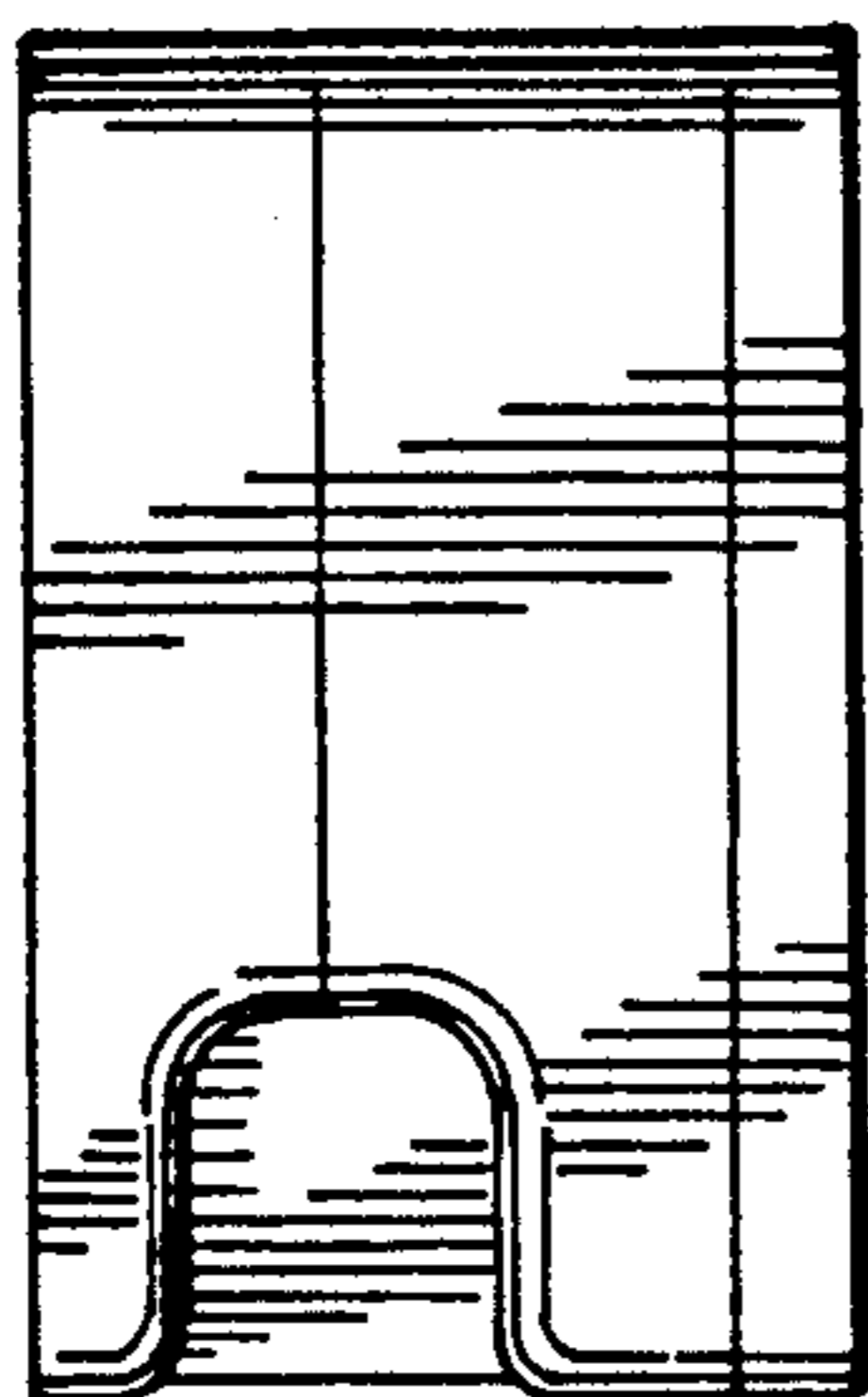

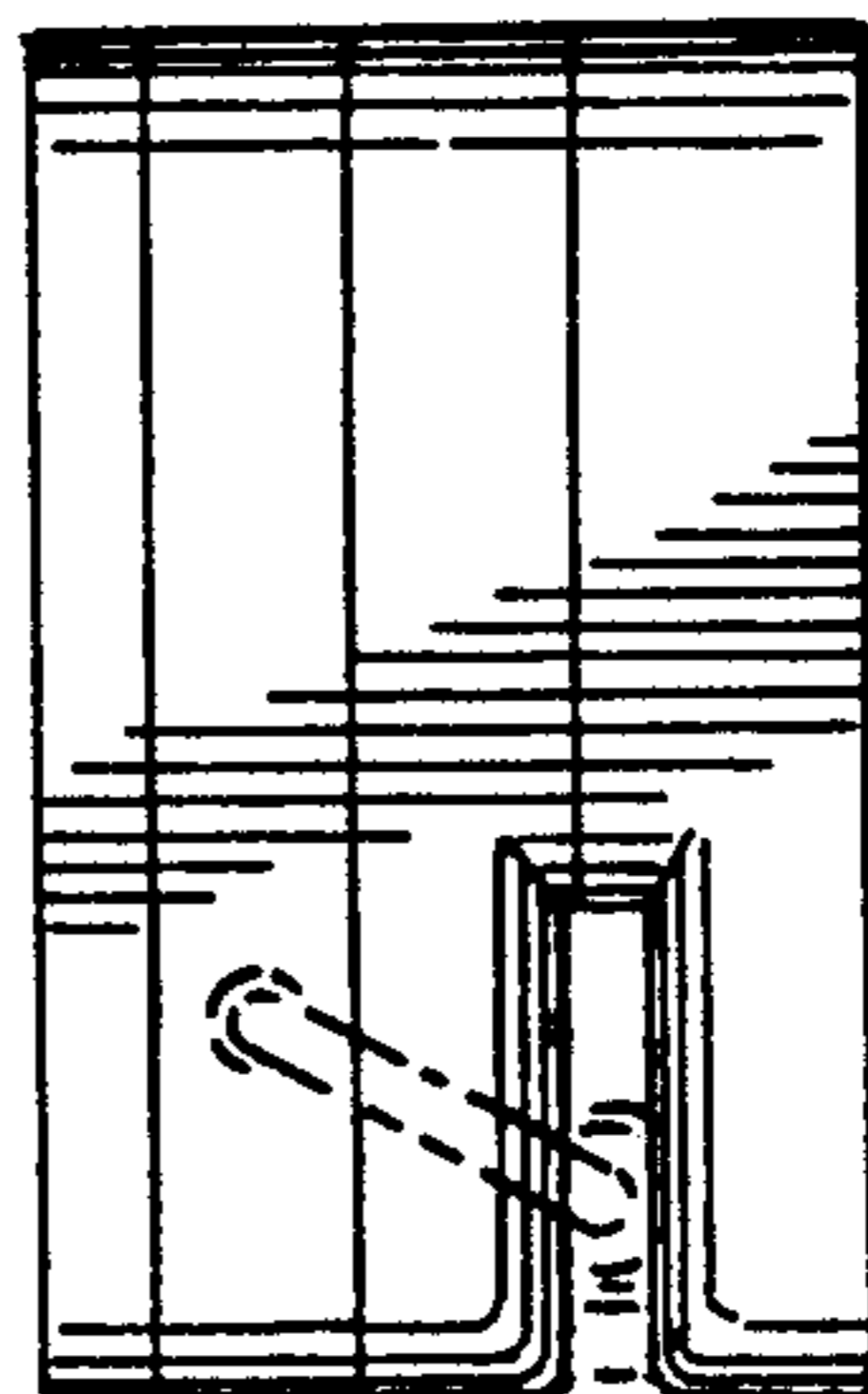

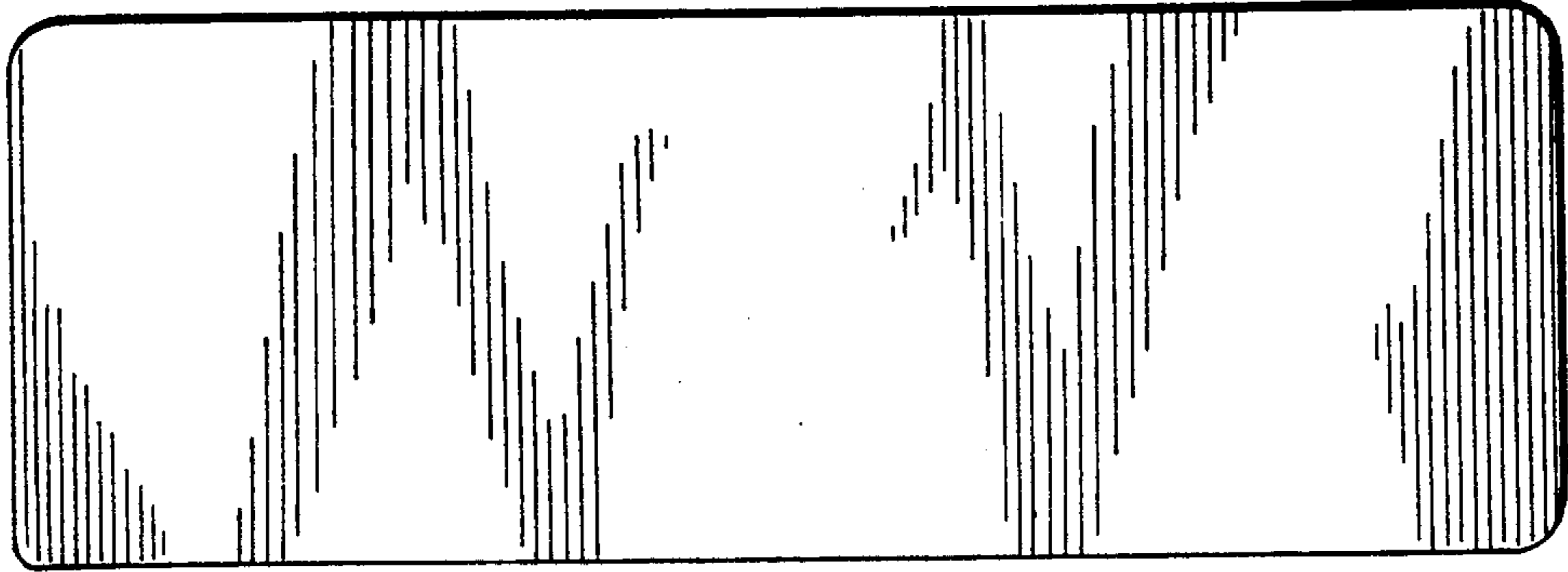

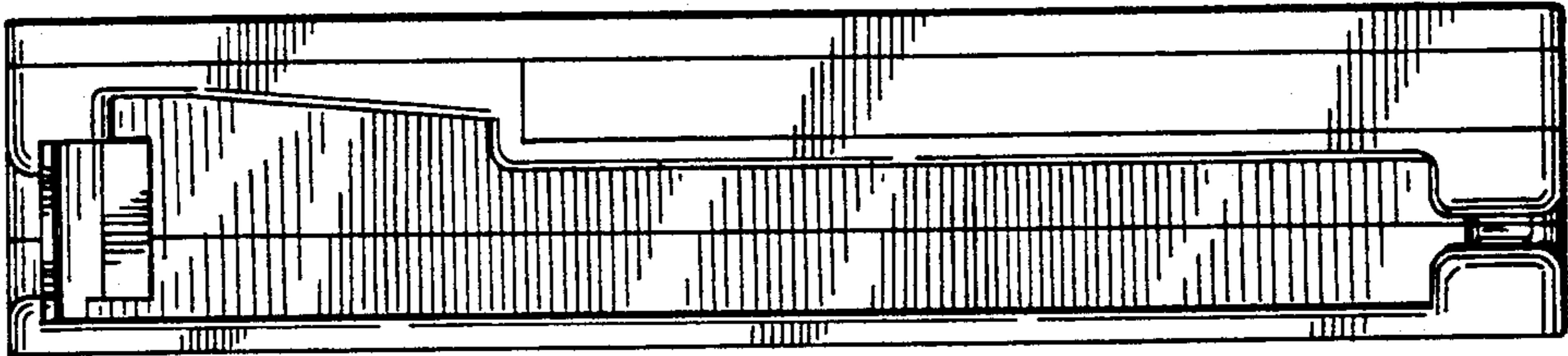

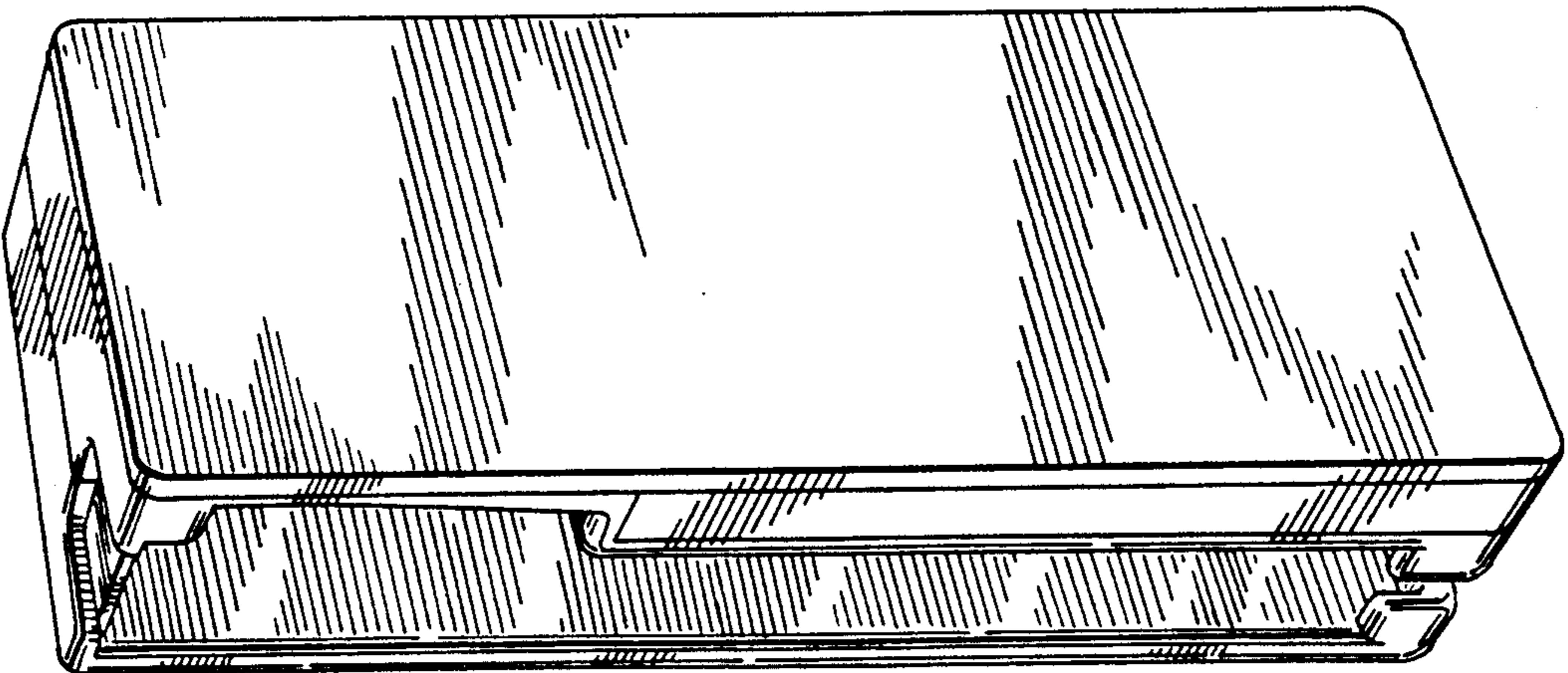

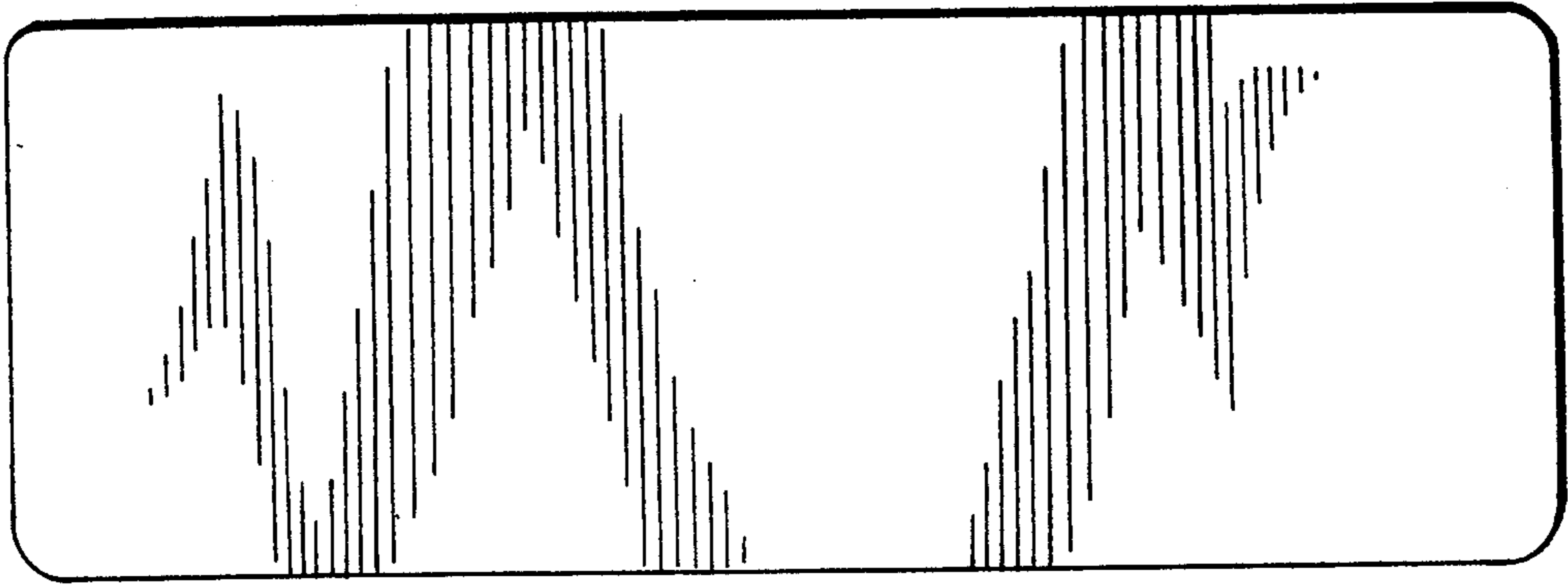

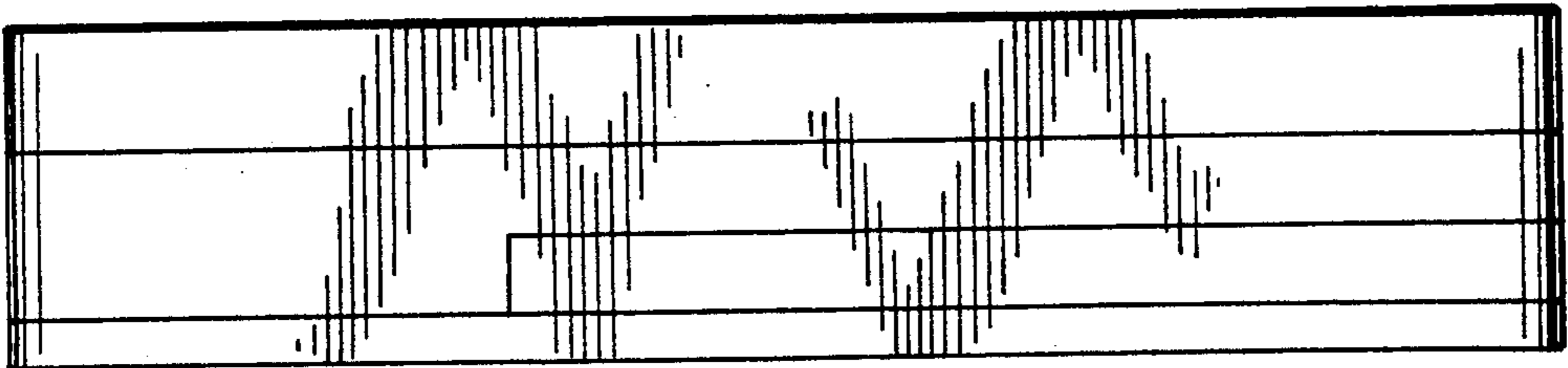

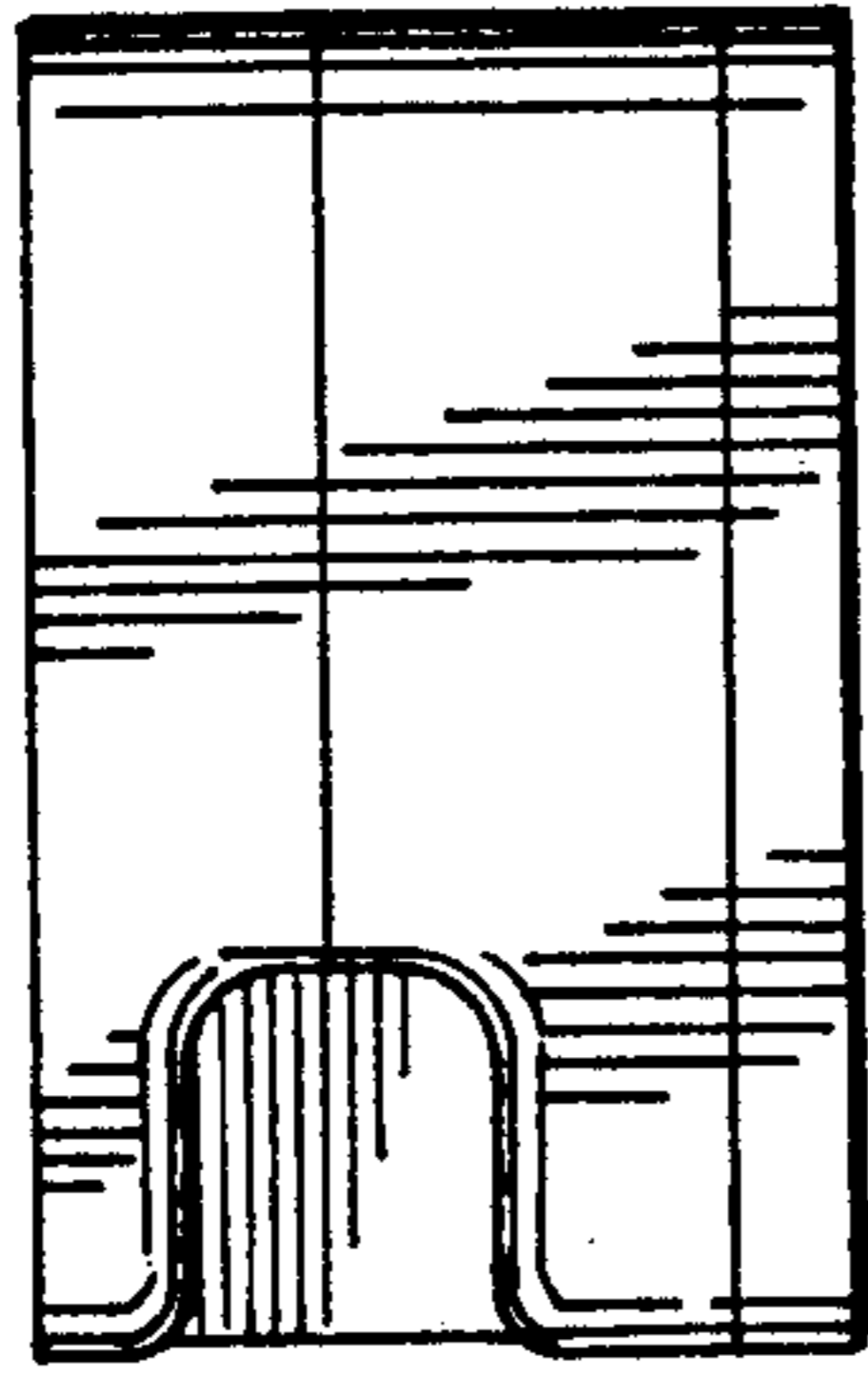

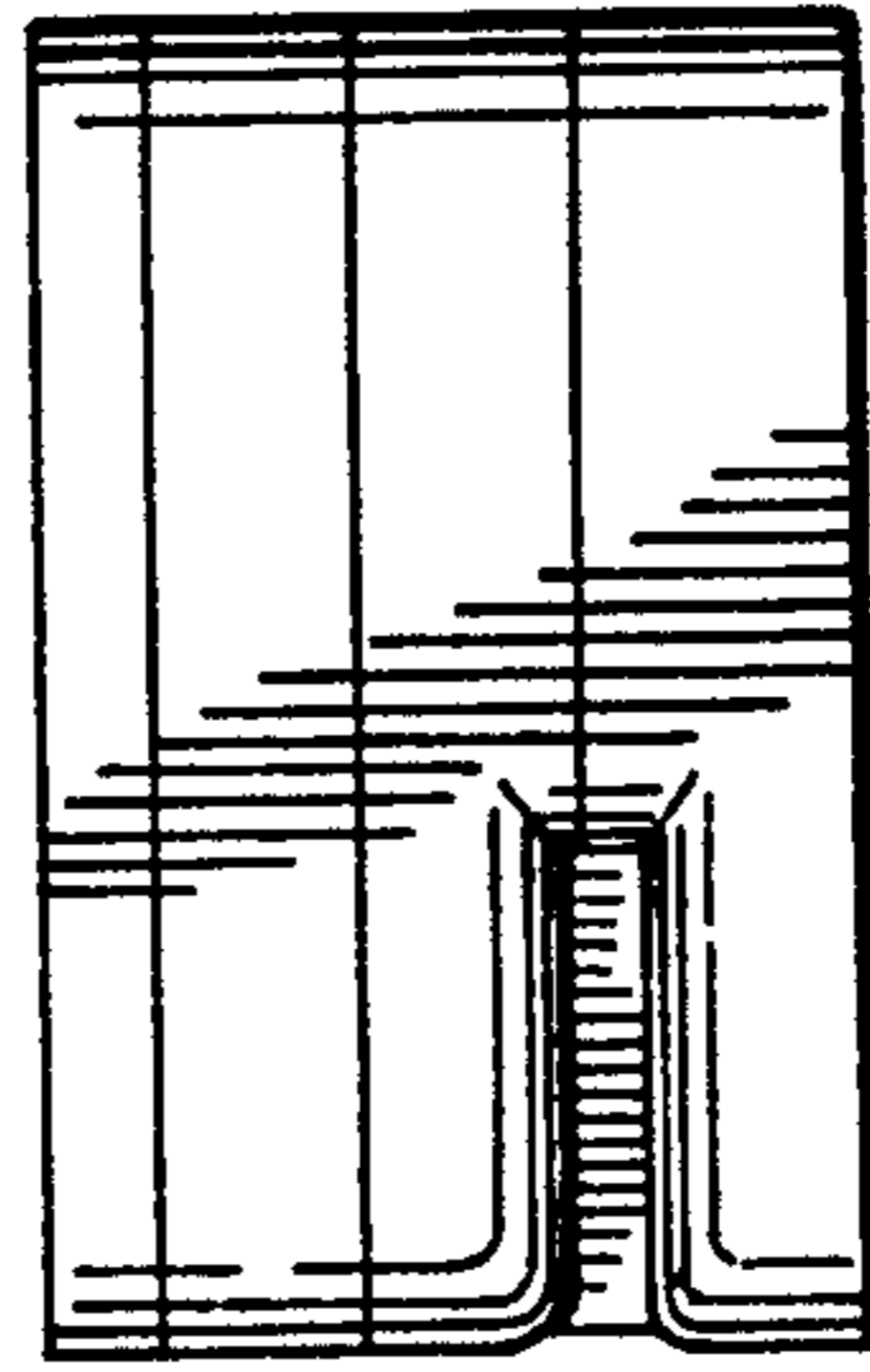
