FIG. 19 is a front elevational view of a ninth embodiment of a tab portion of a shingle showing our new design;

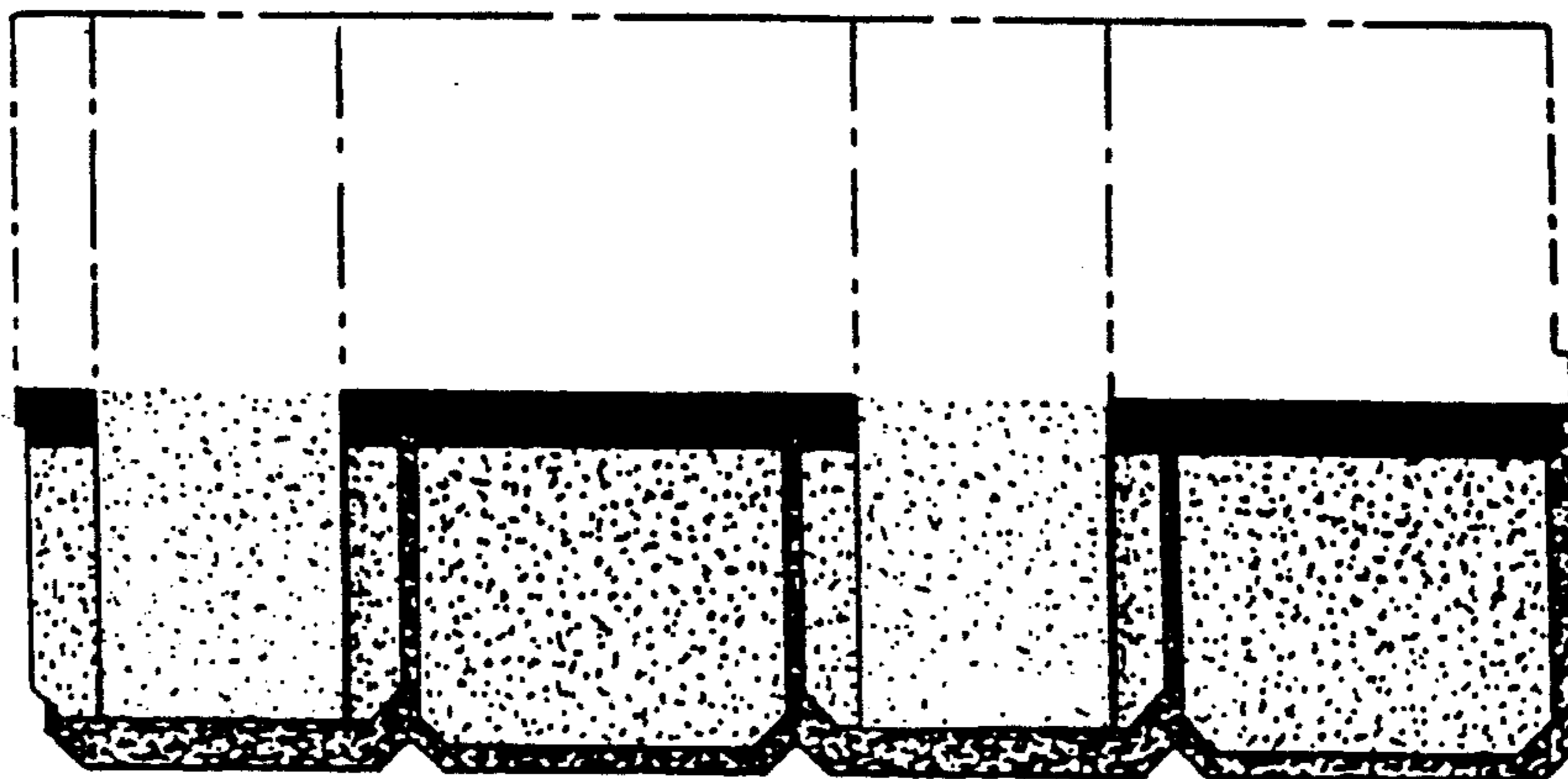


FIG. 20 is a bottom view thereof;

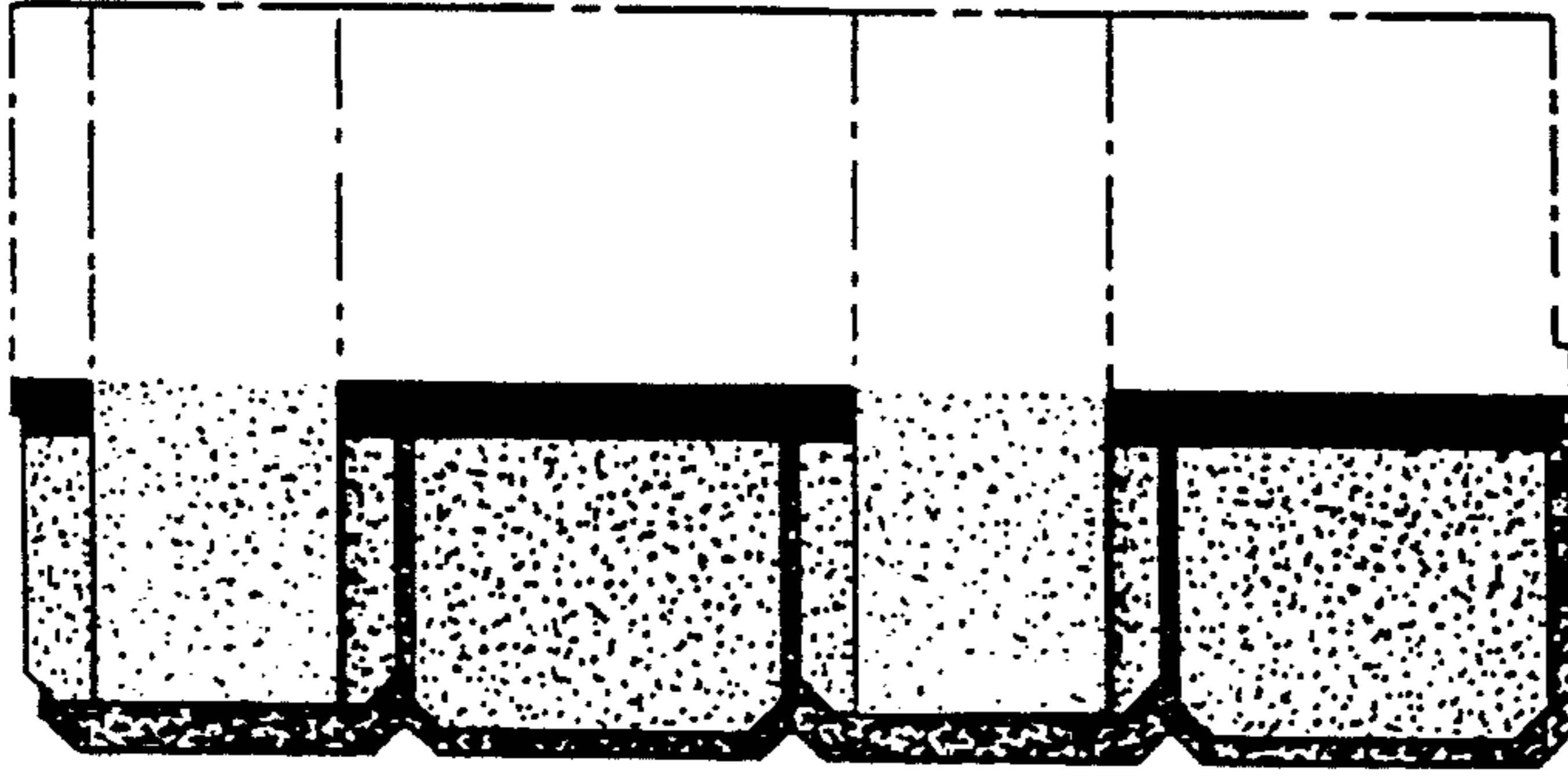

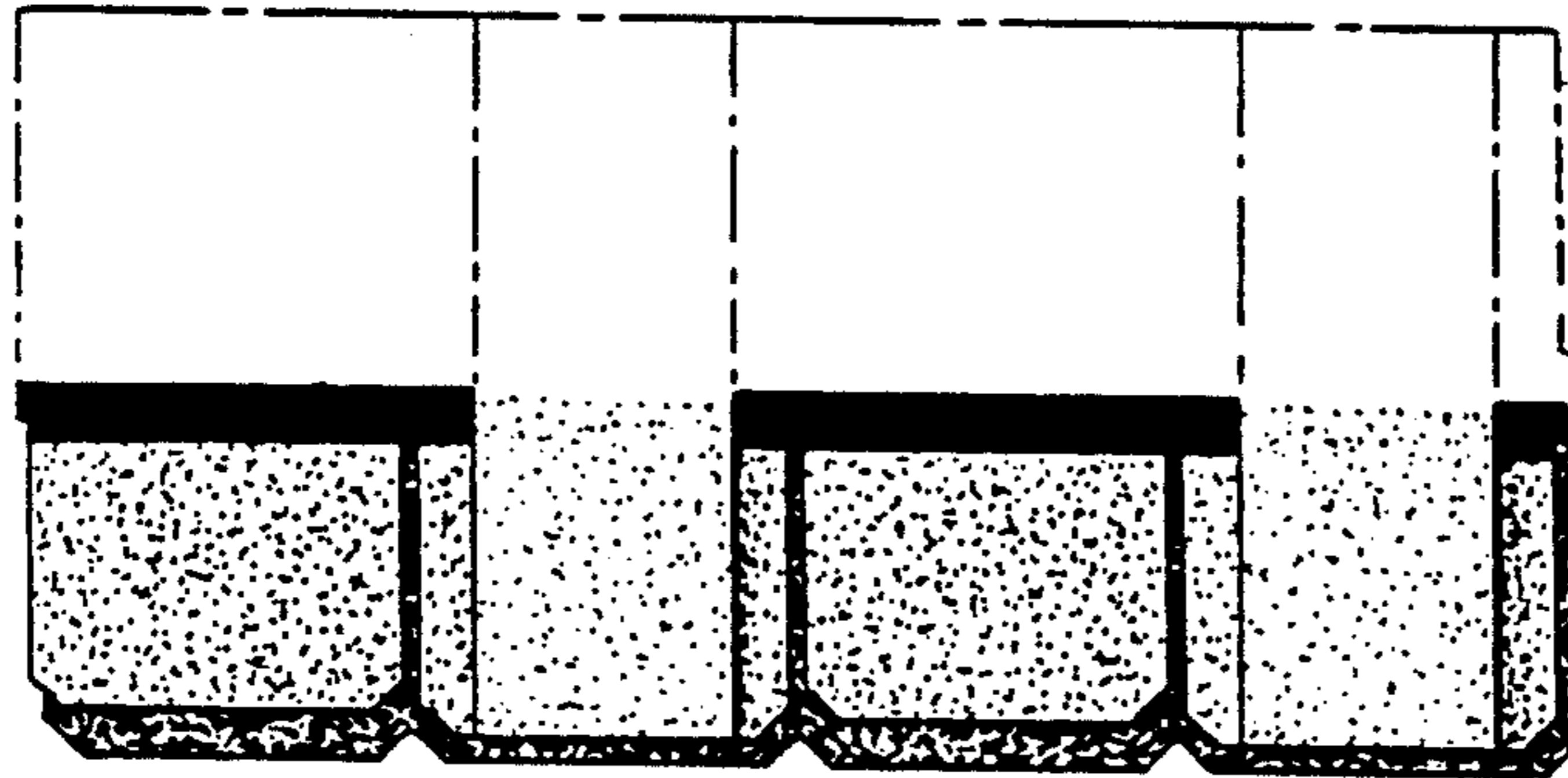

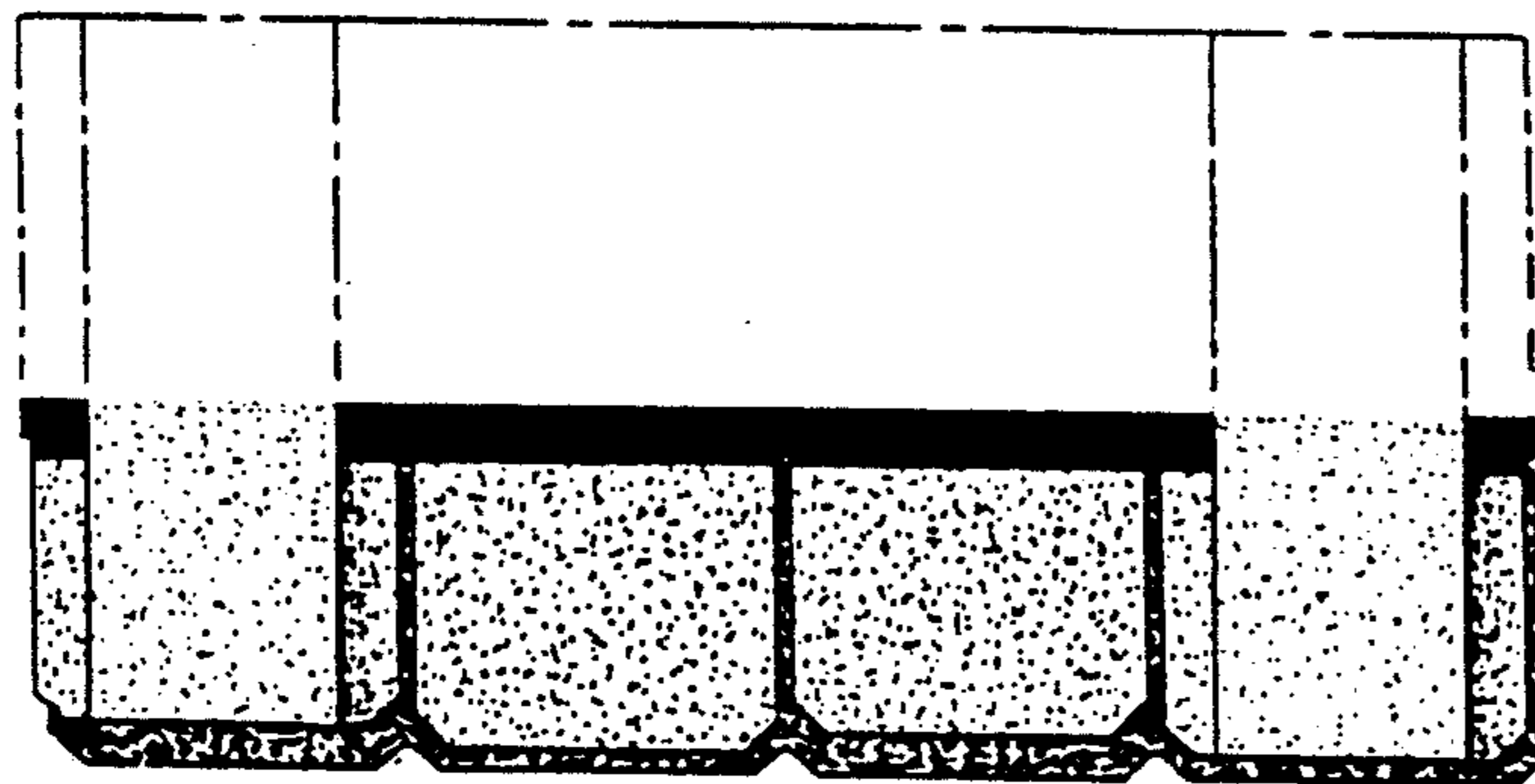

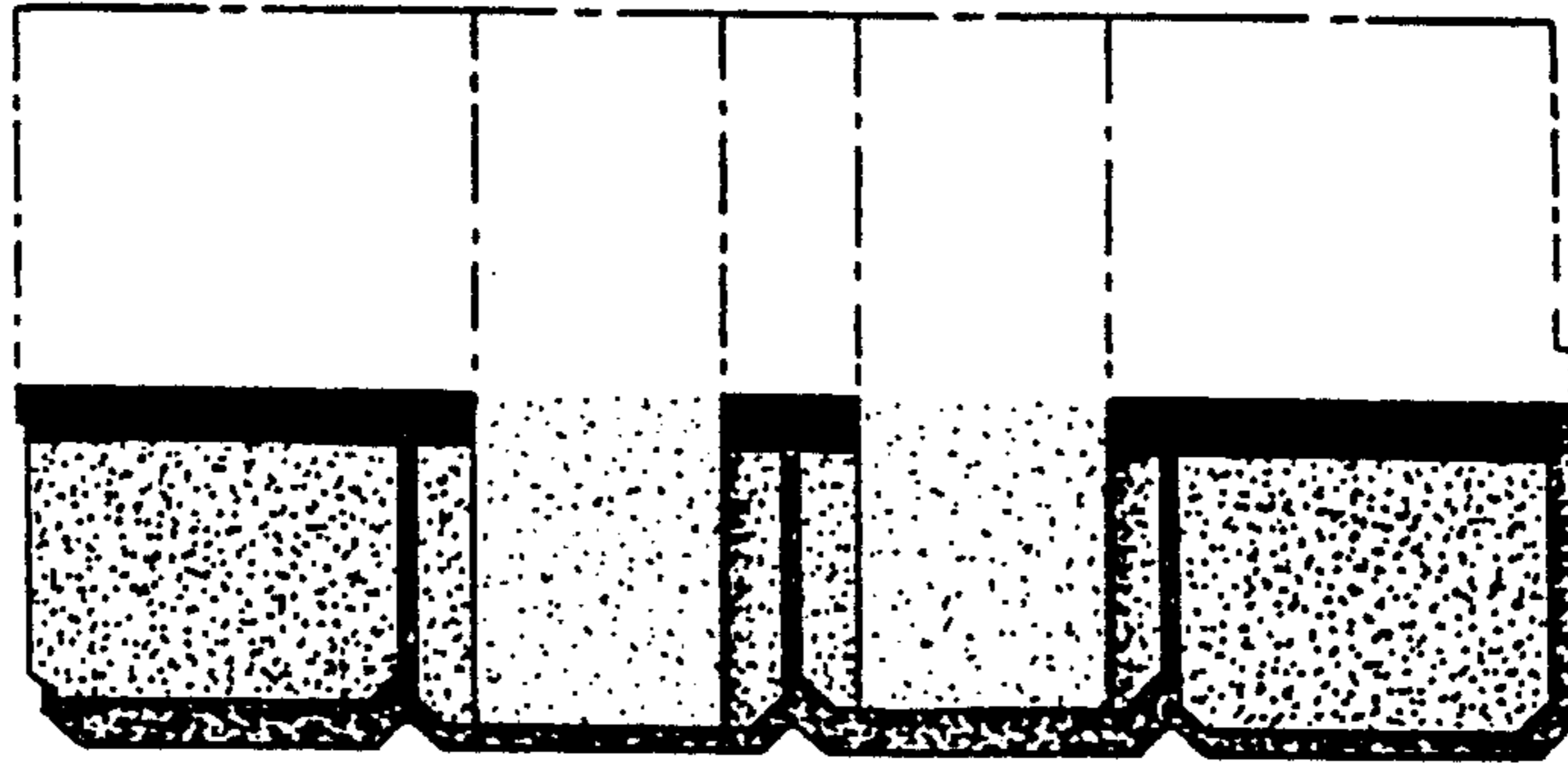

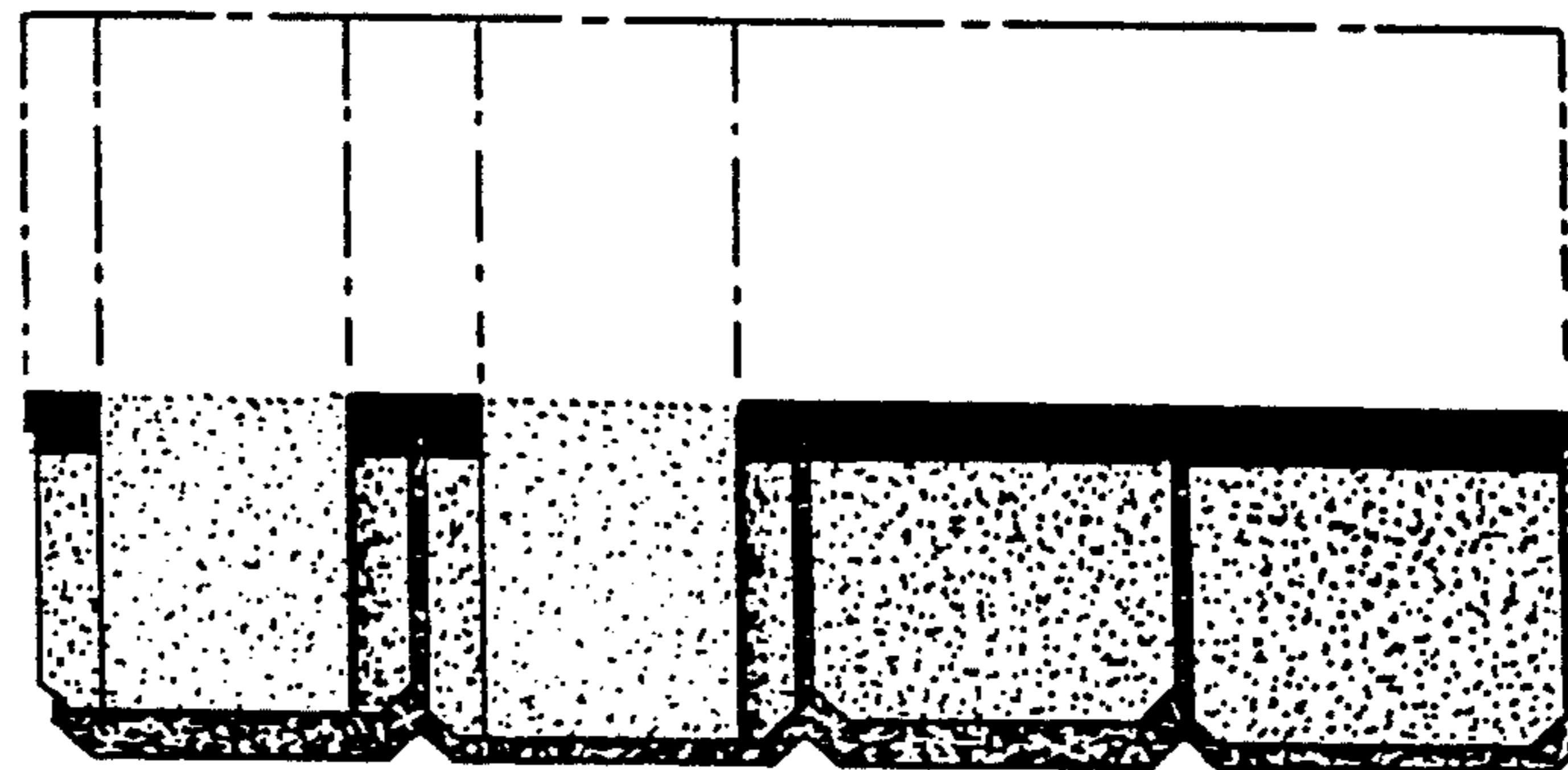

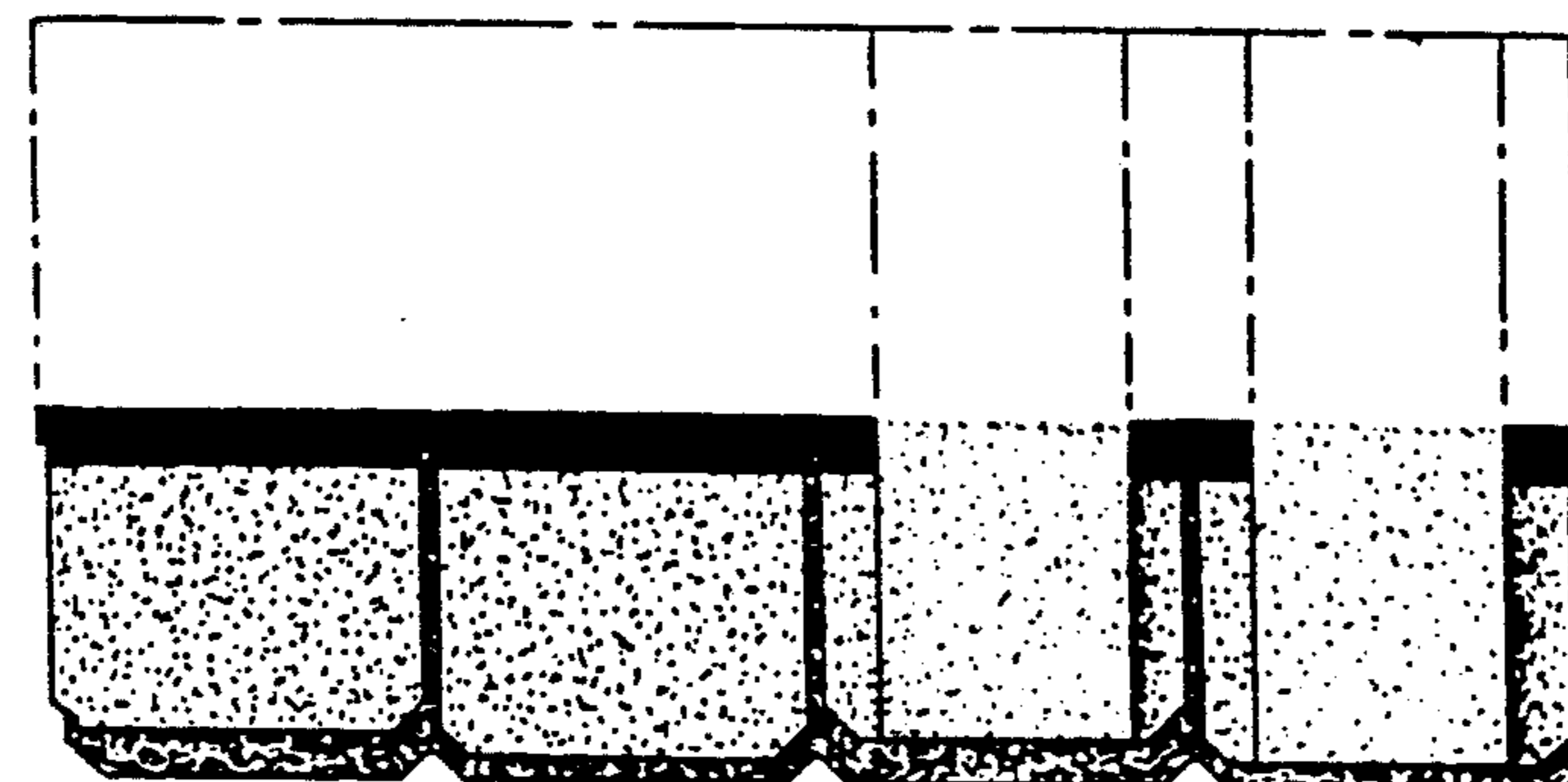

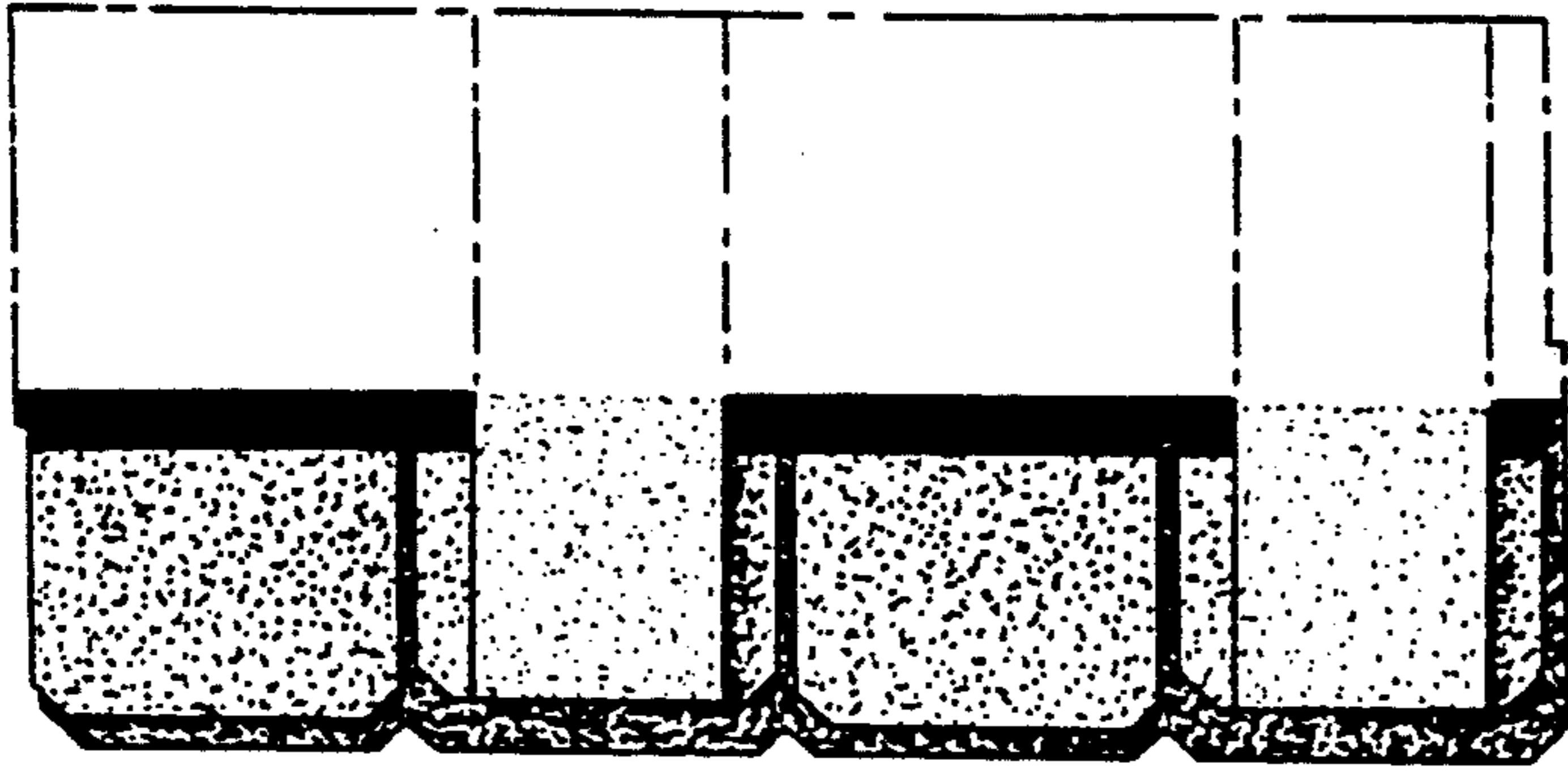

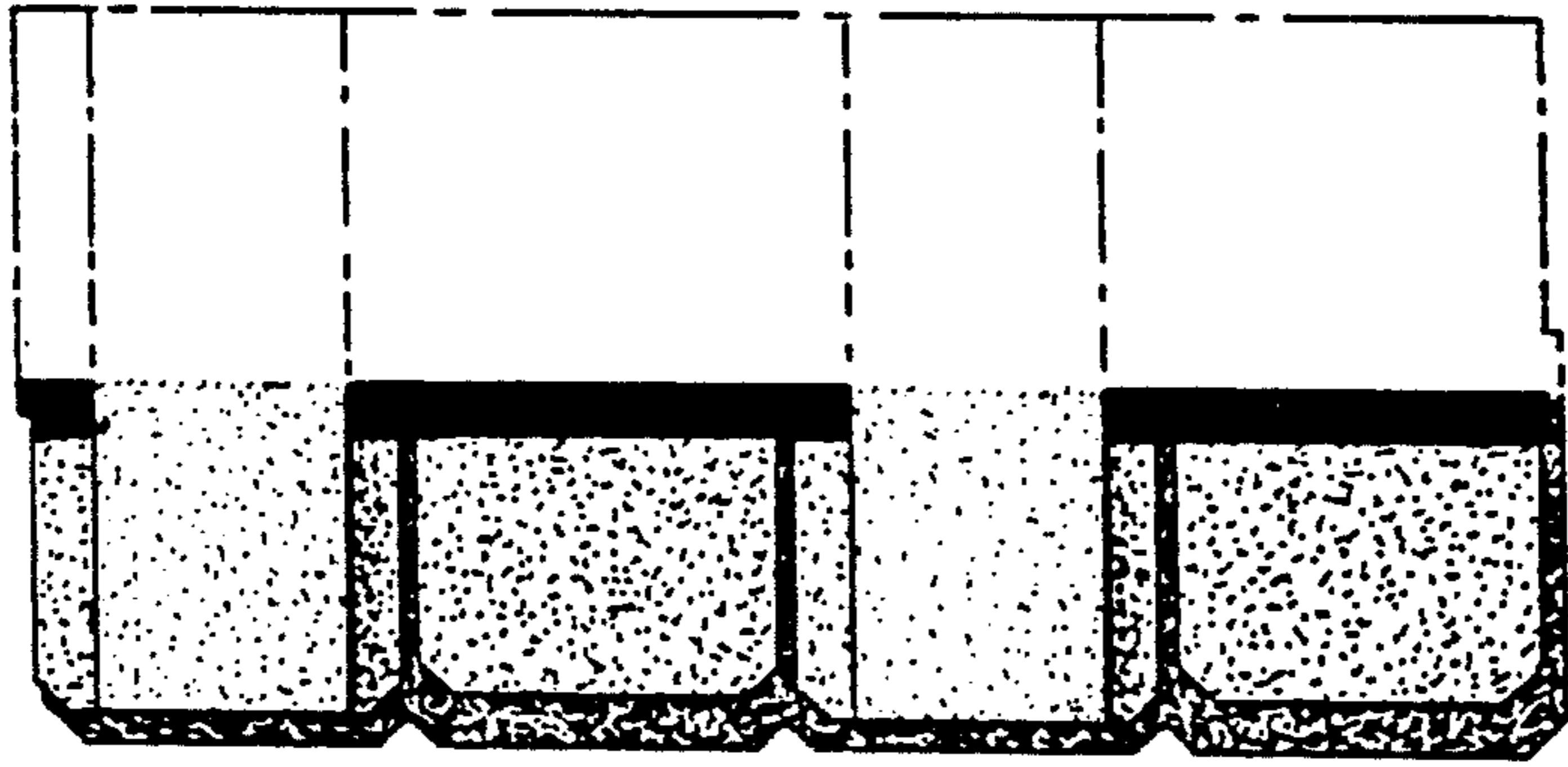

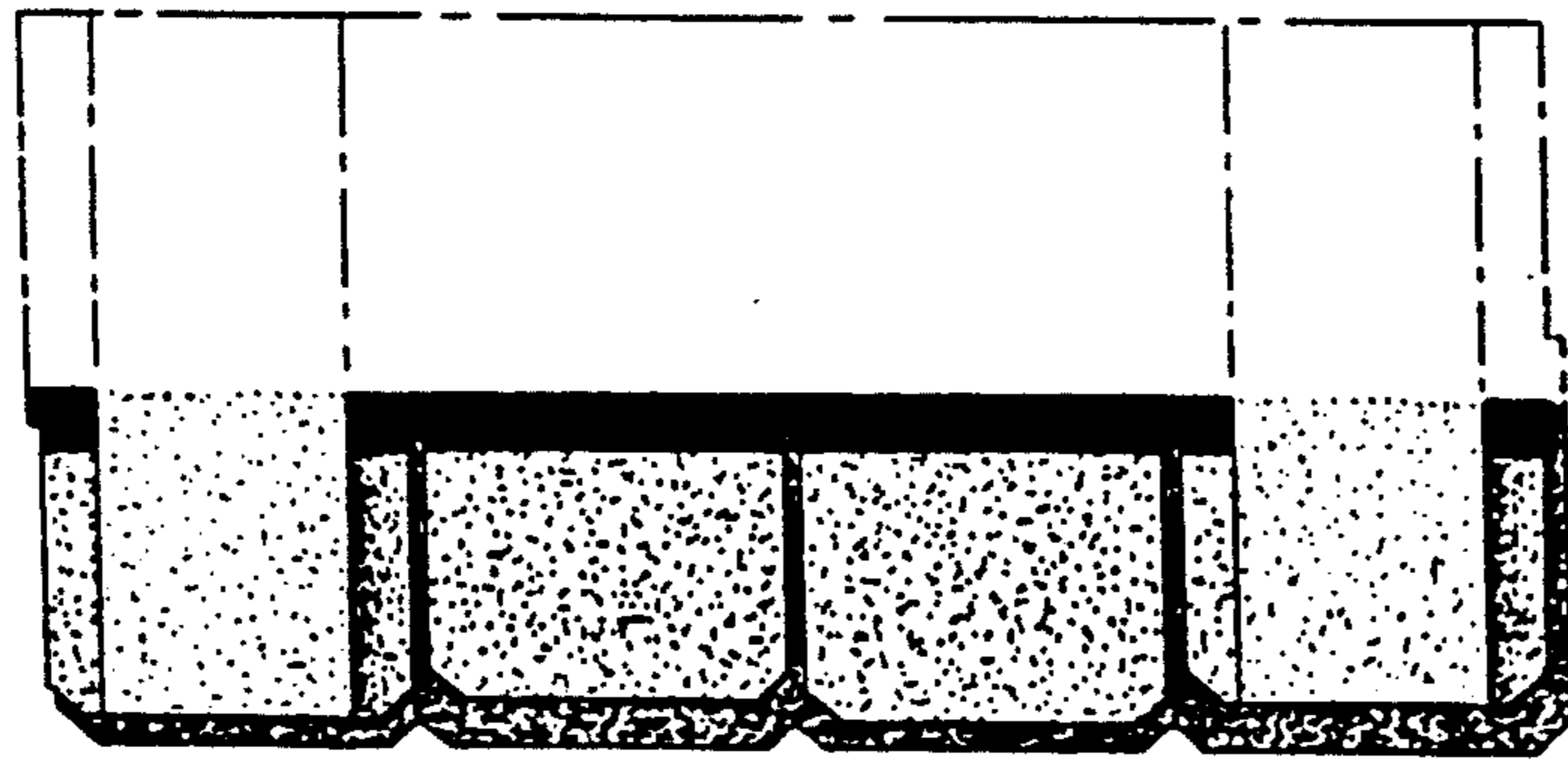

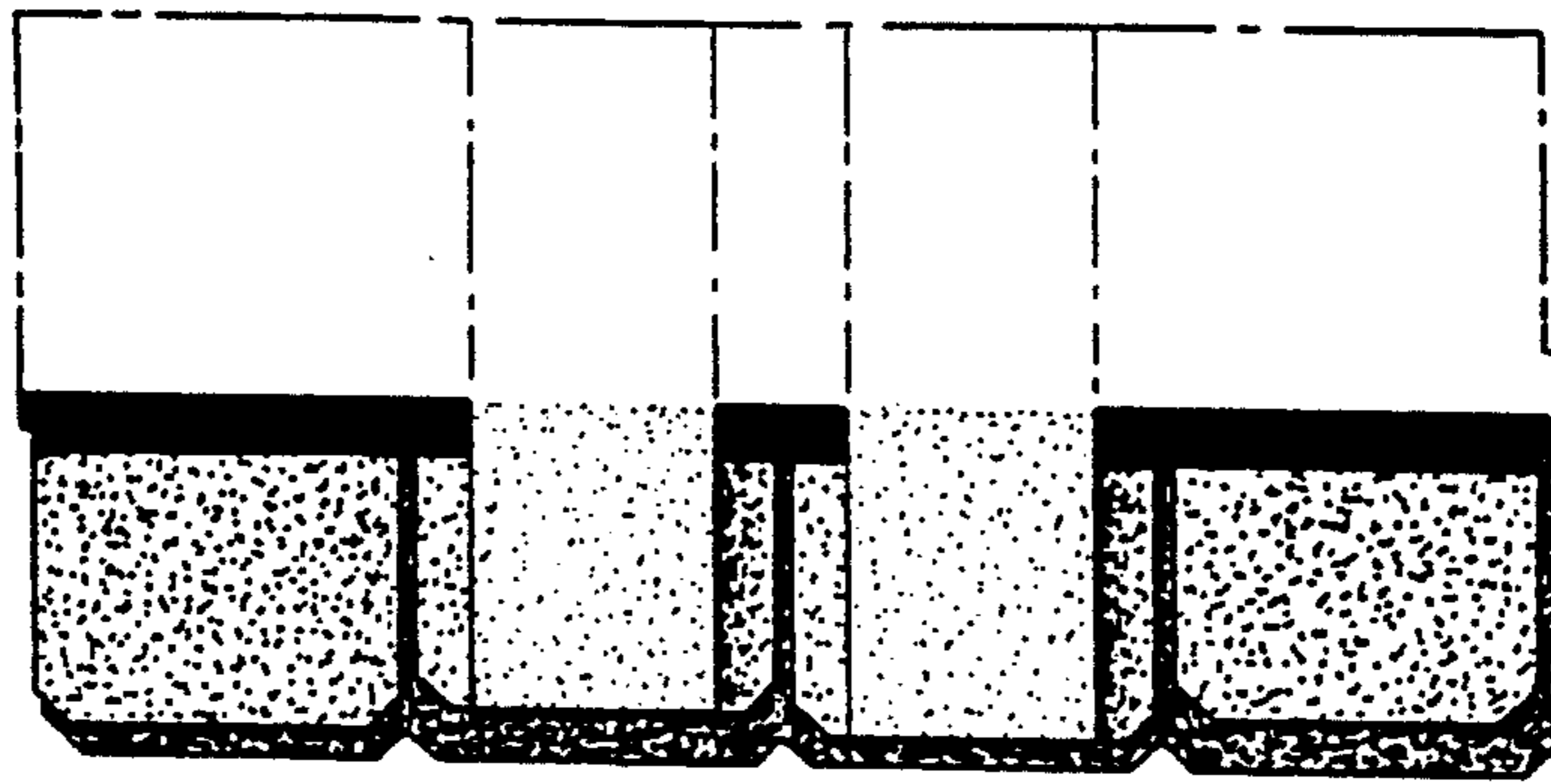

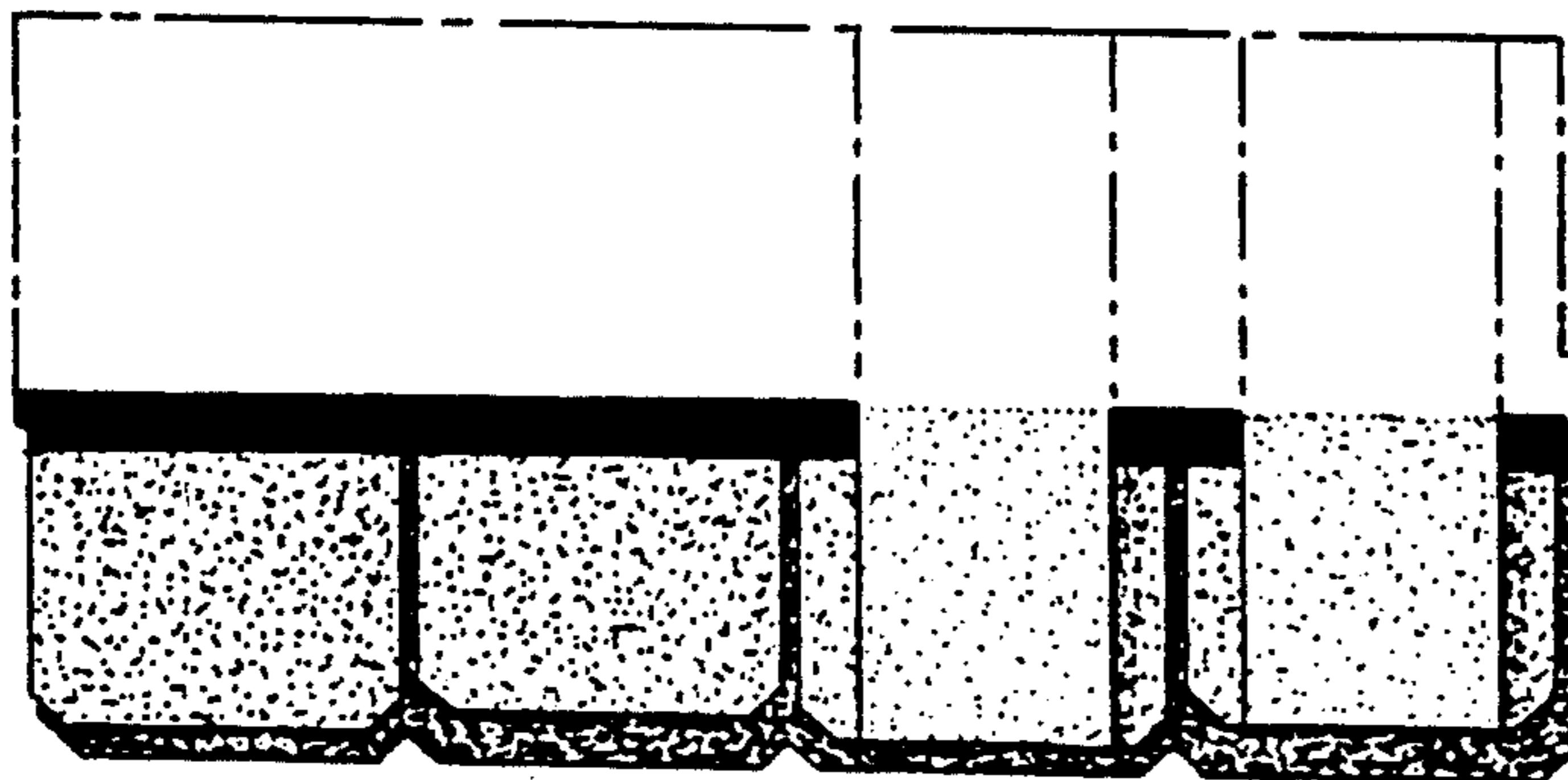

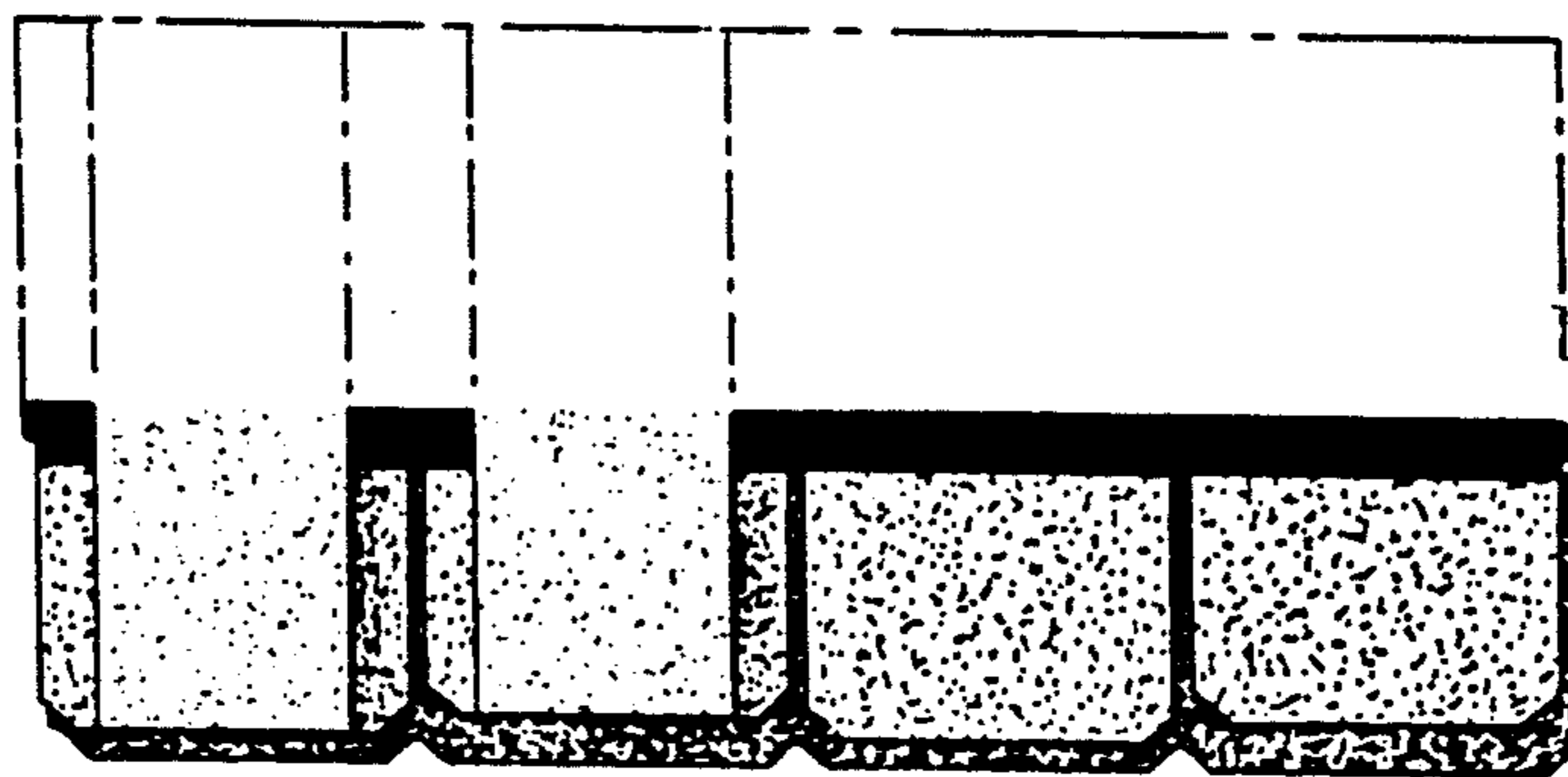
