The ornamental design for a toilet tissue dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a toilet tissue dispenser showing my new design, the broken-line disclosure of a portion of a wall being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is an enlarged front elevational view thereof;

FIG. 10 is an enlarged rear elevational view thereof;

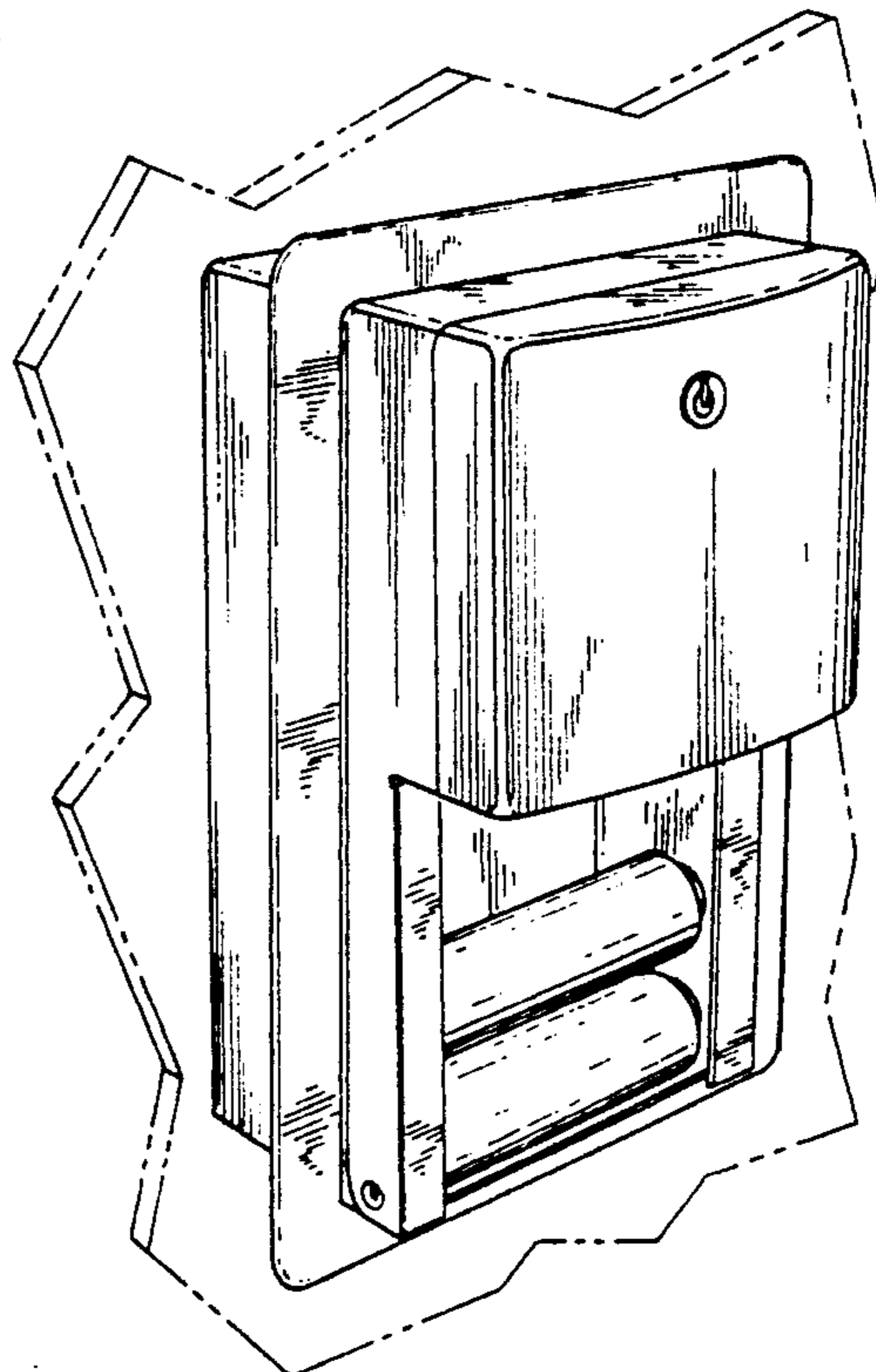
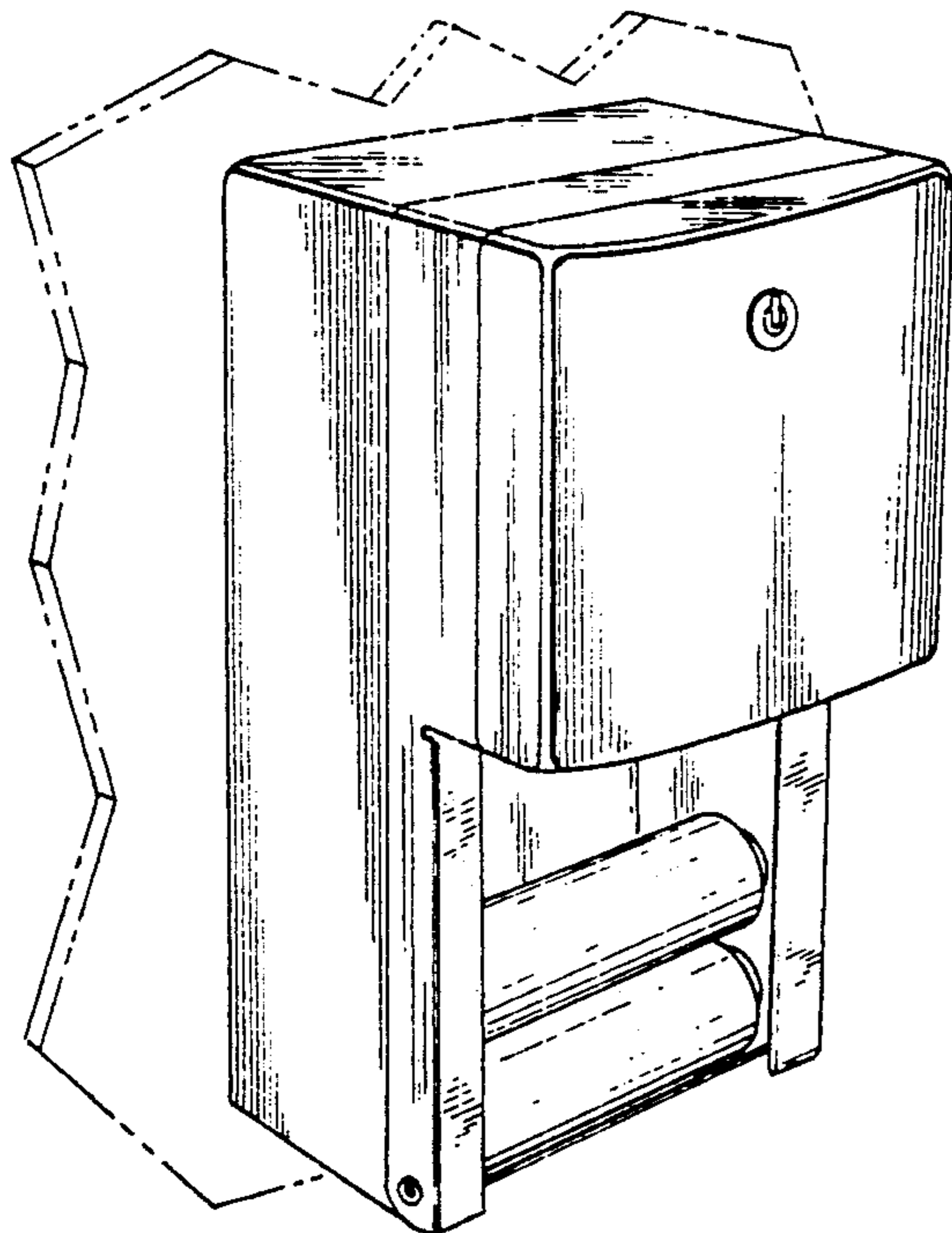

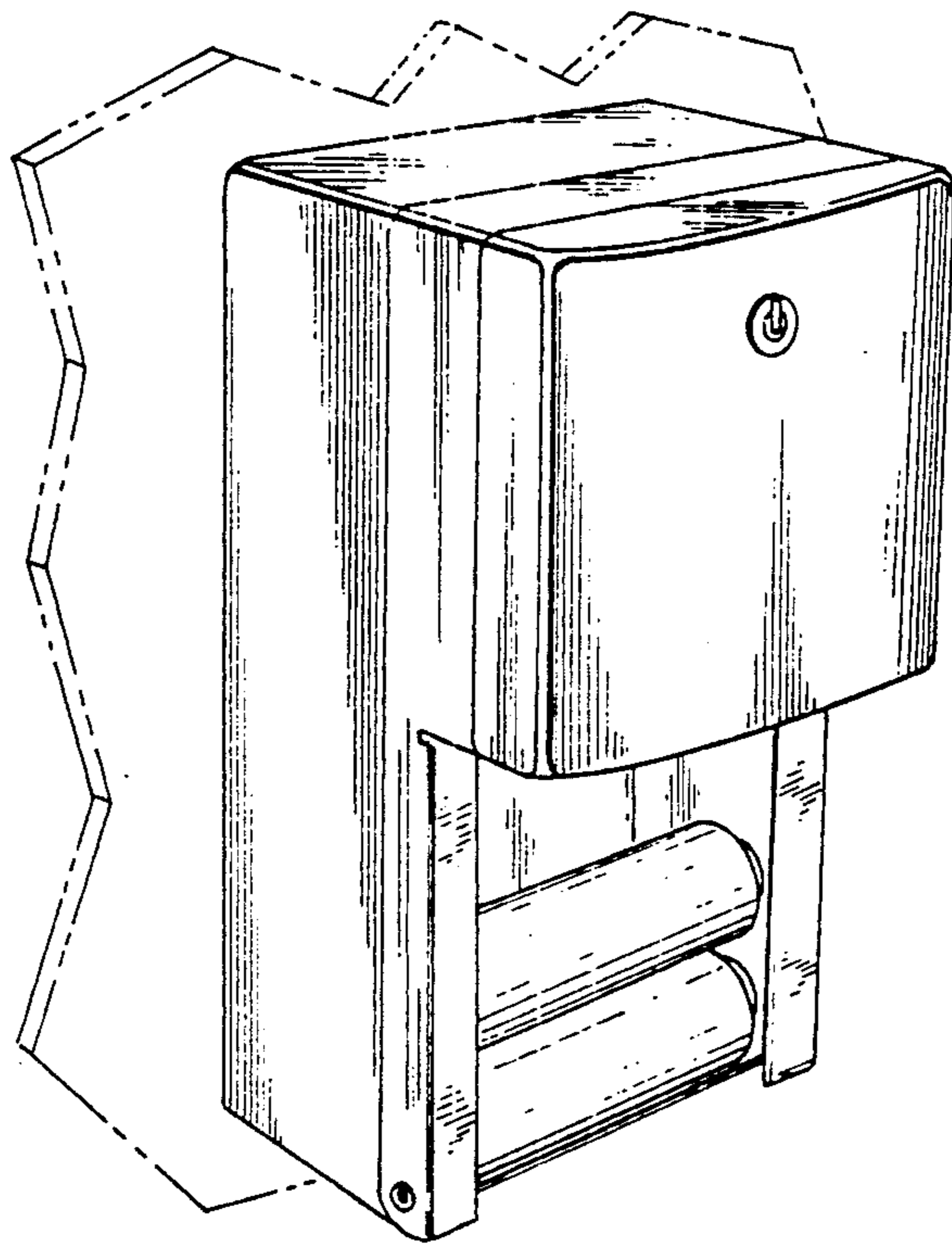

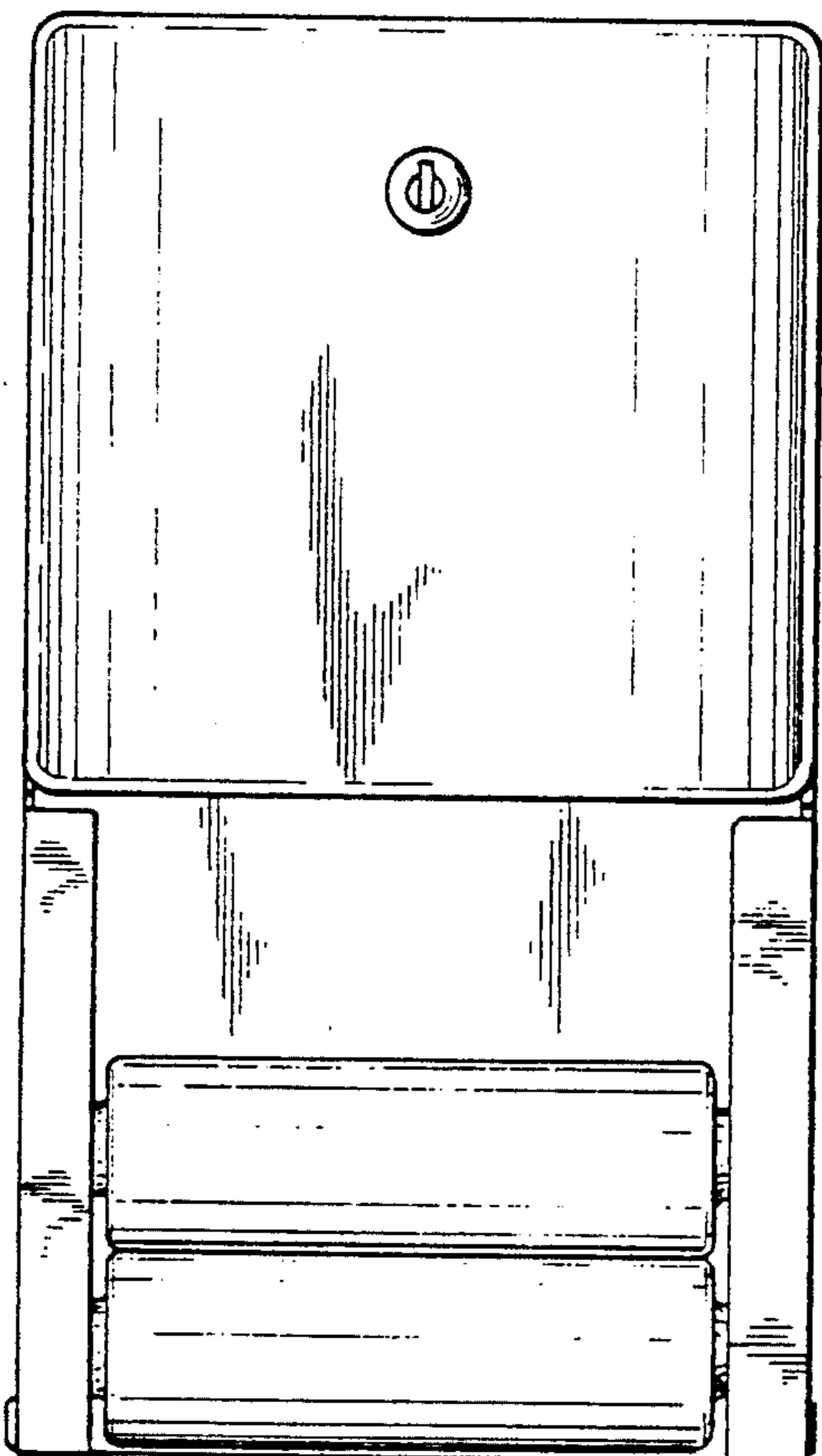

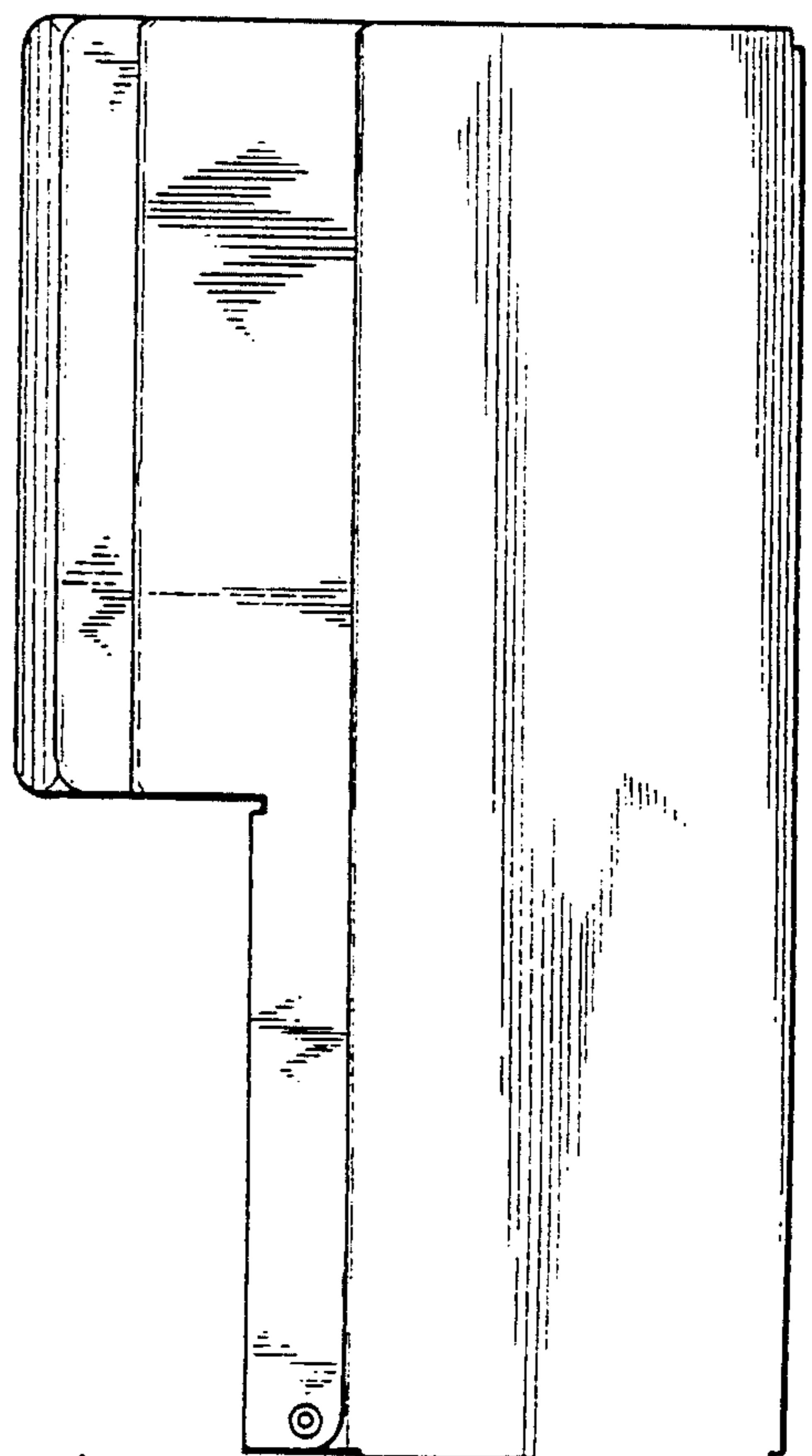

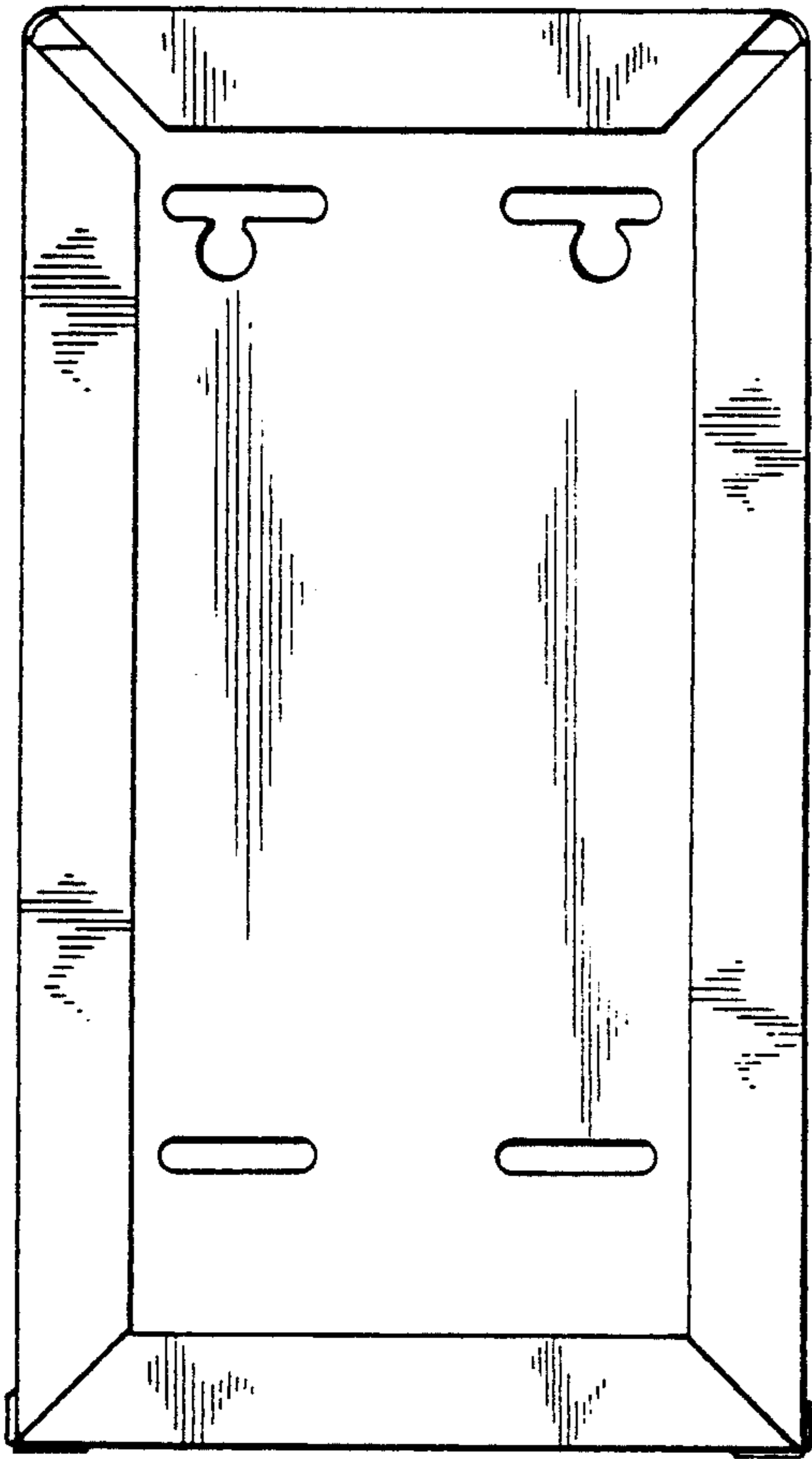
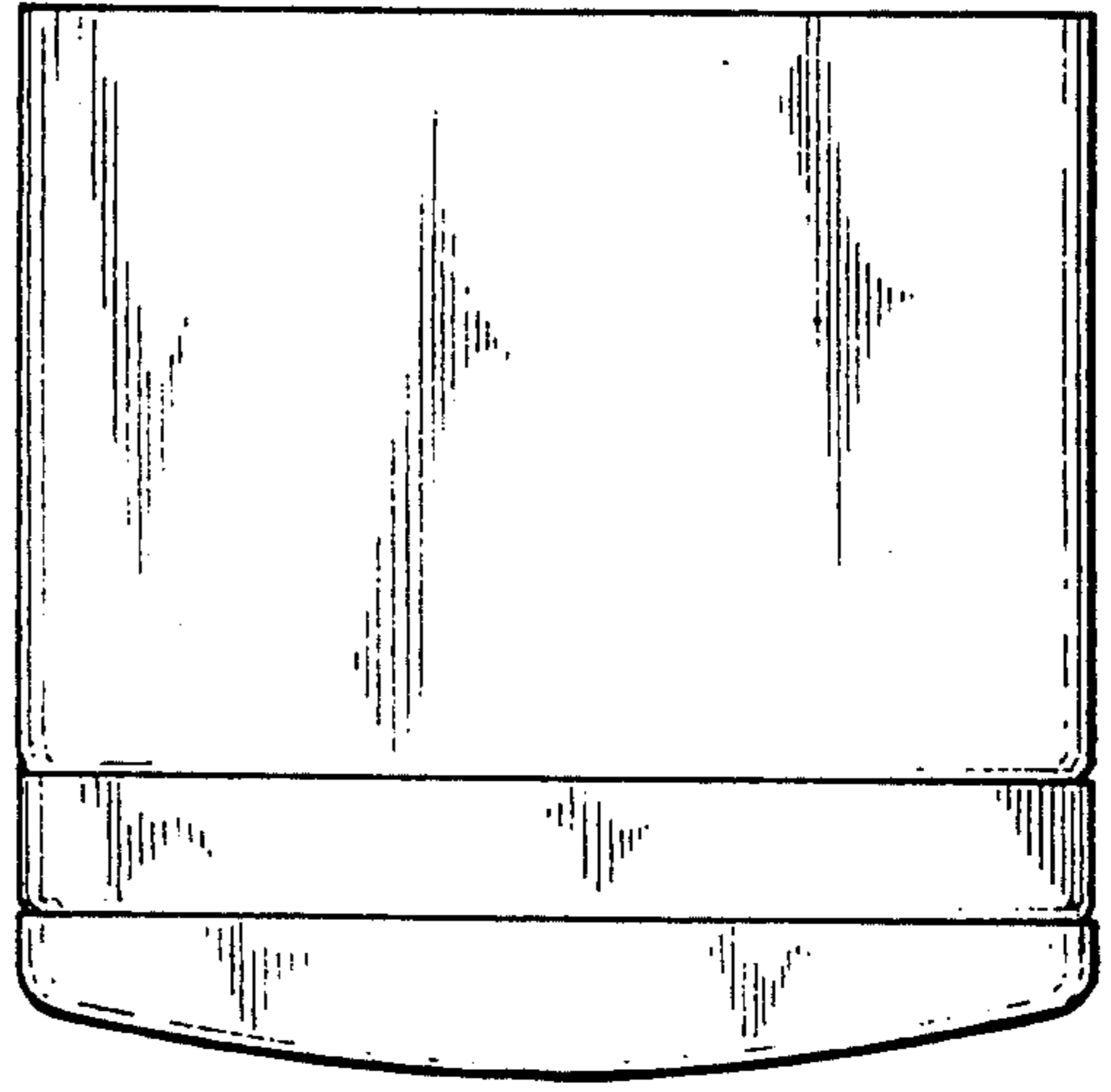

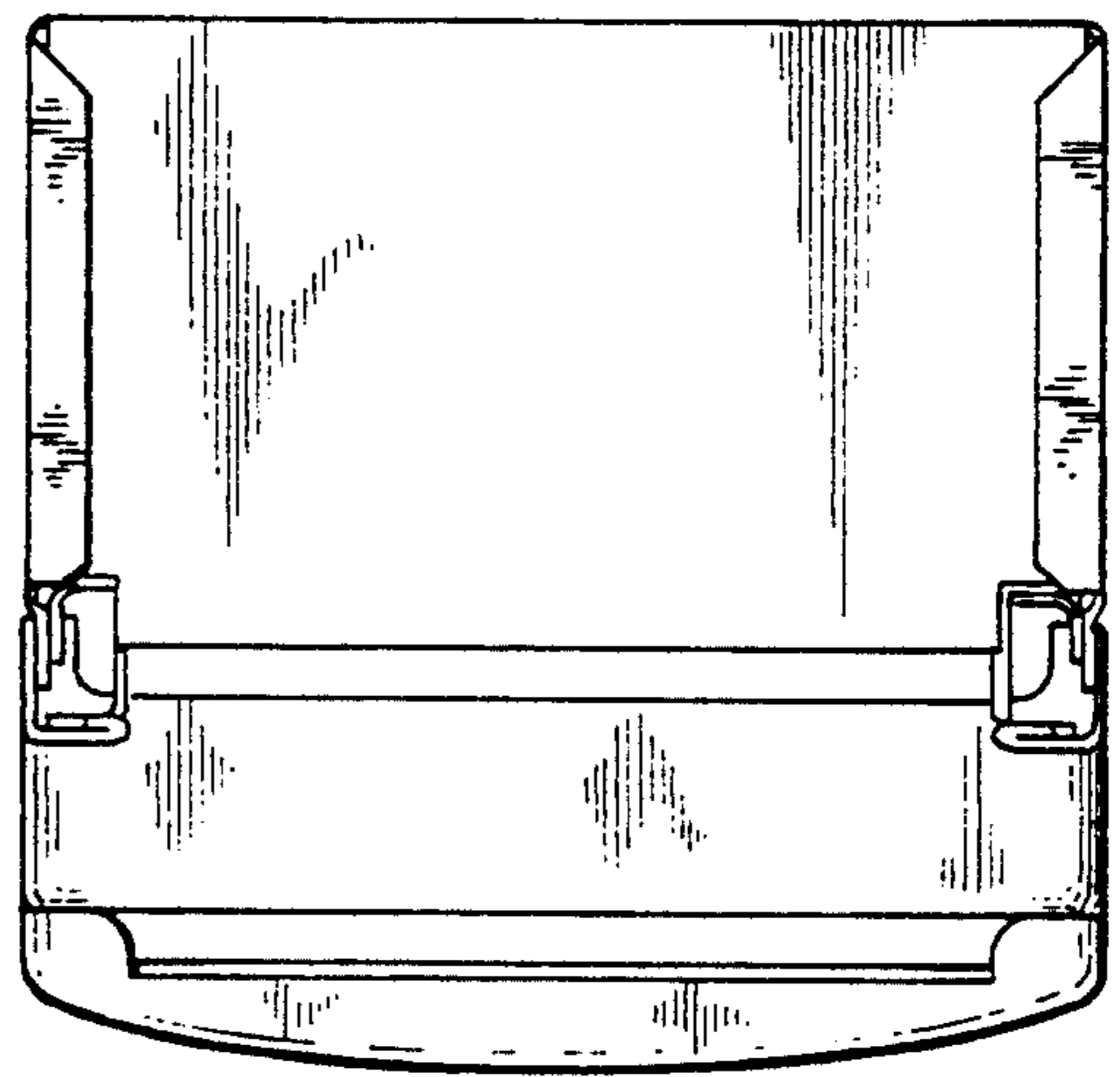

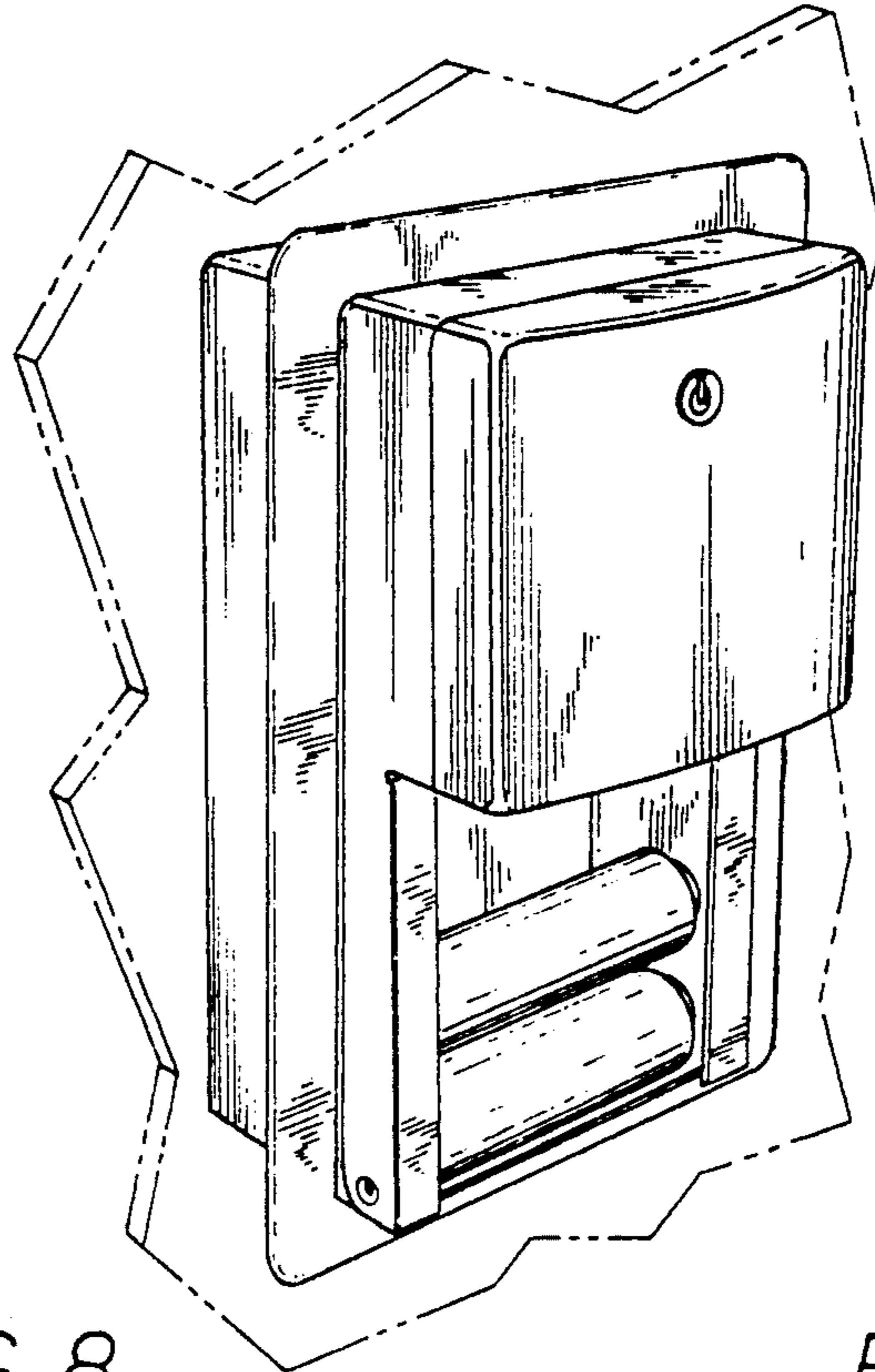

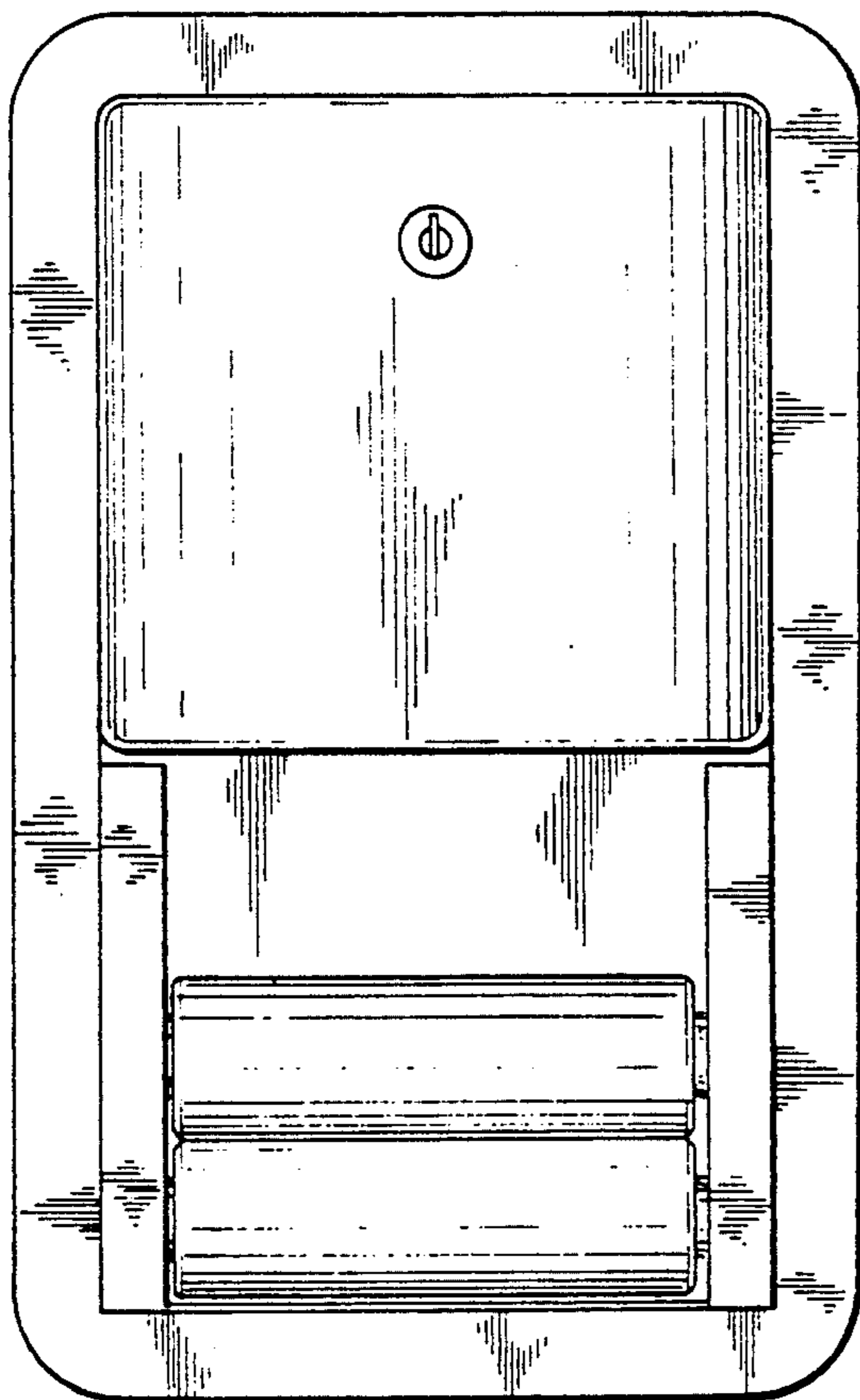
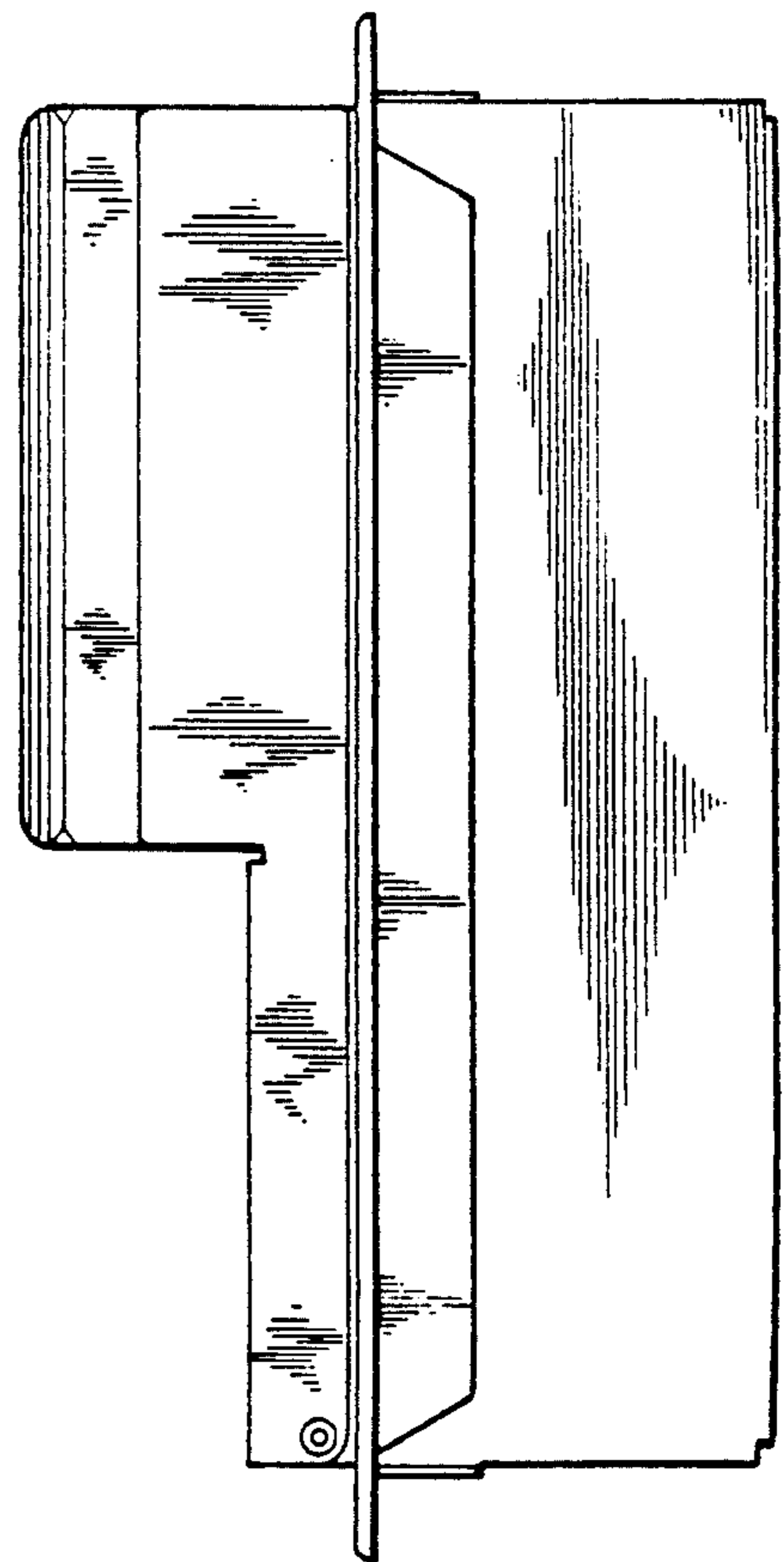

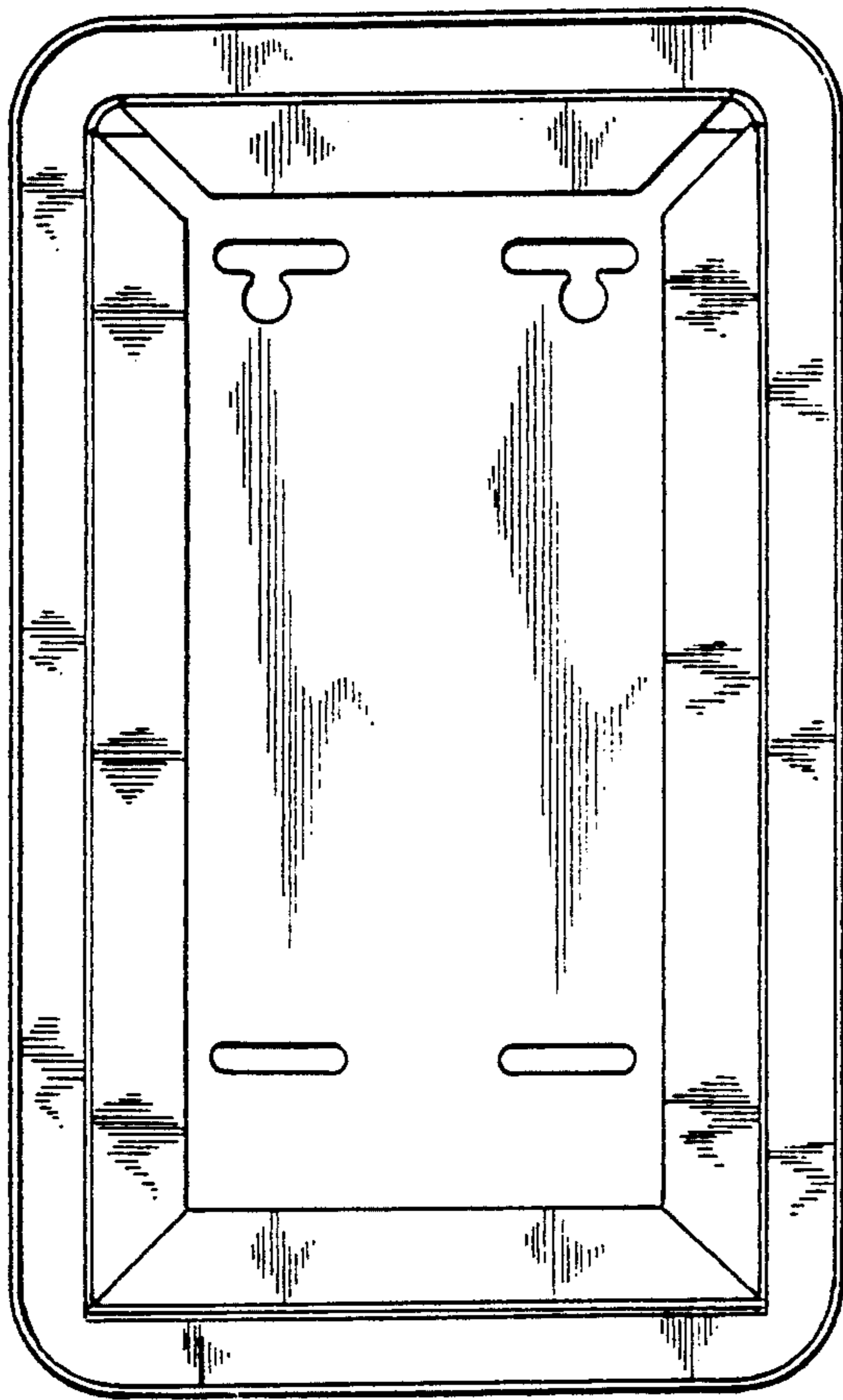

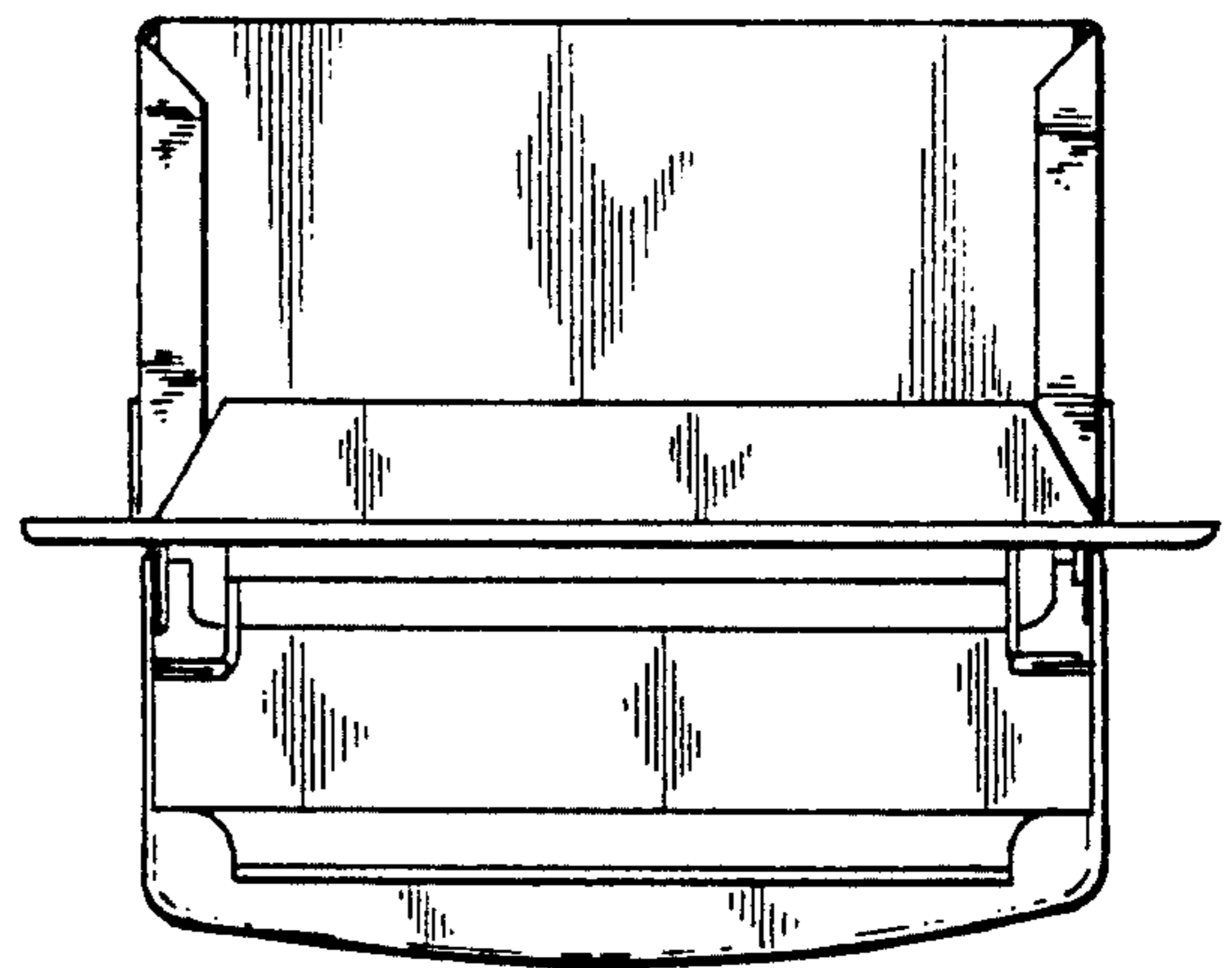
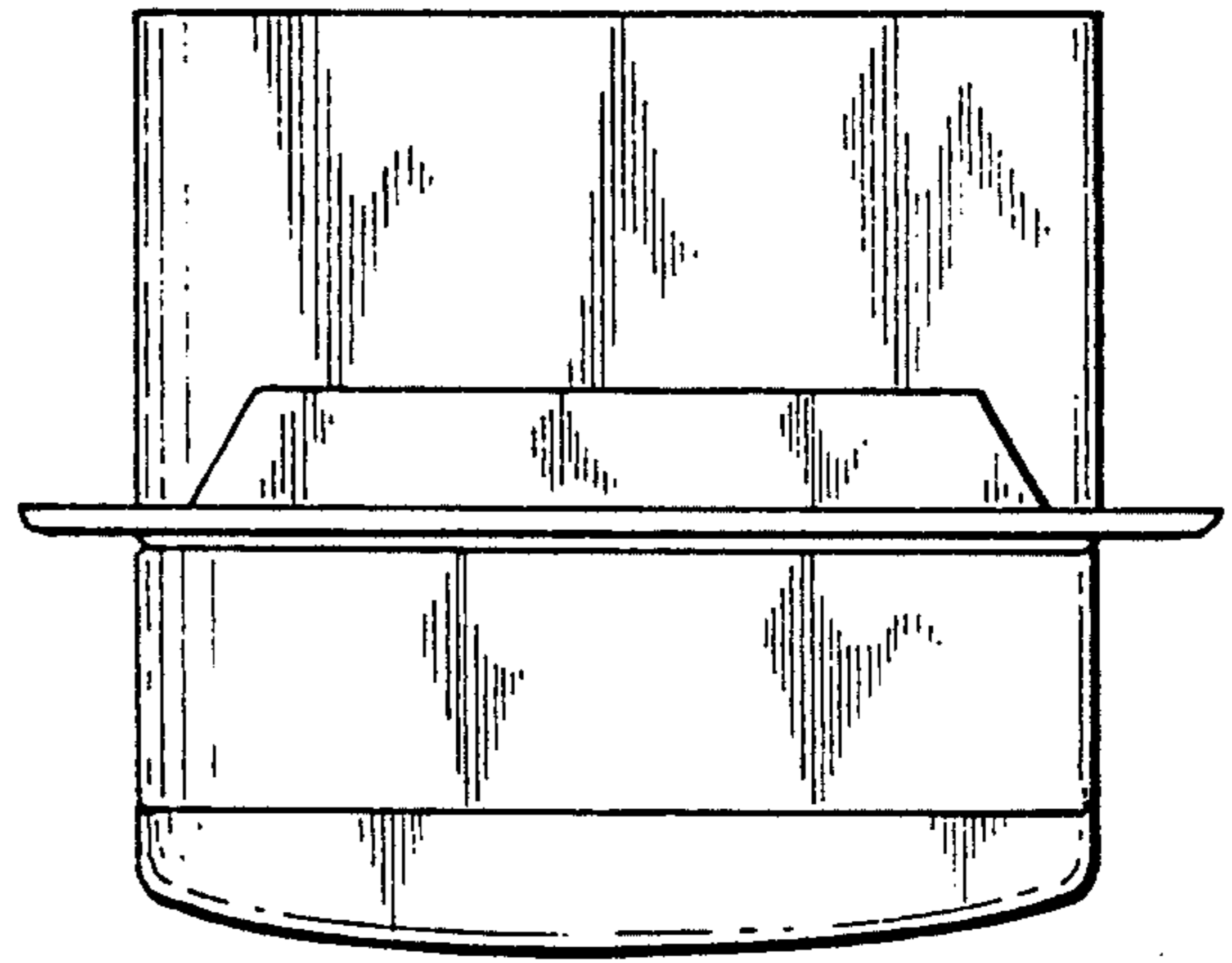
