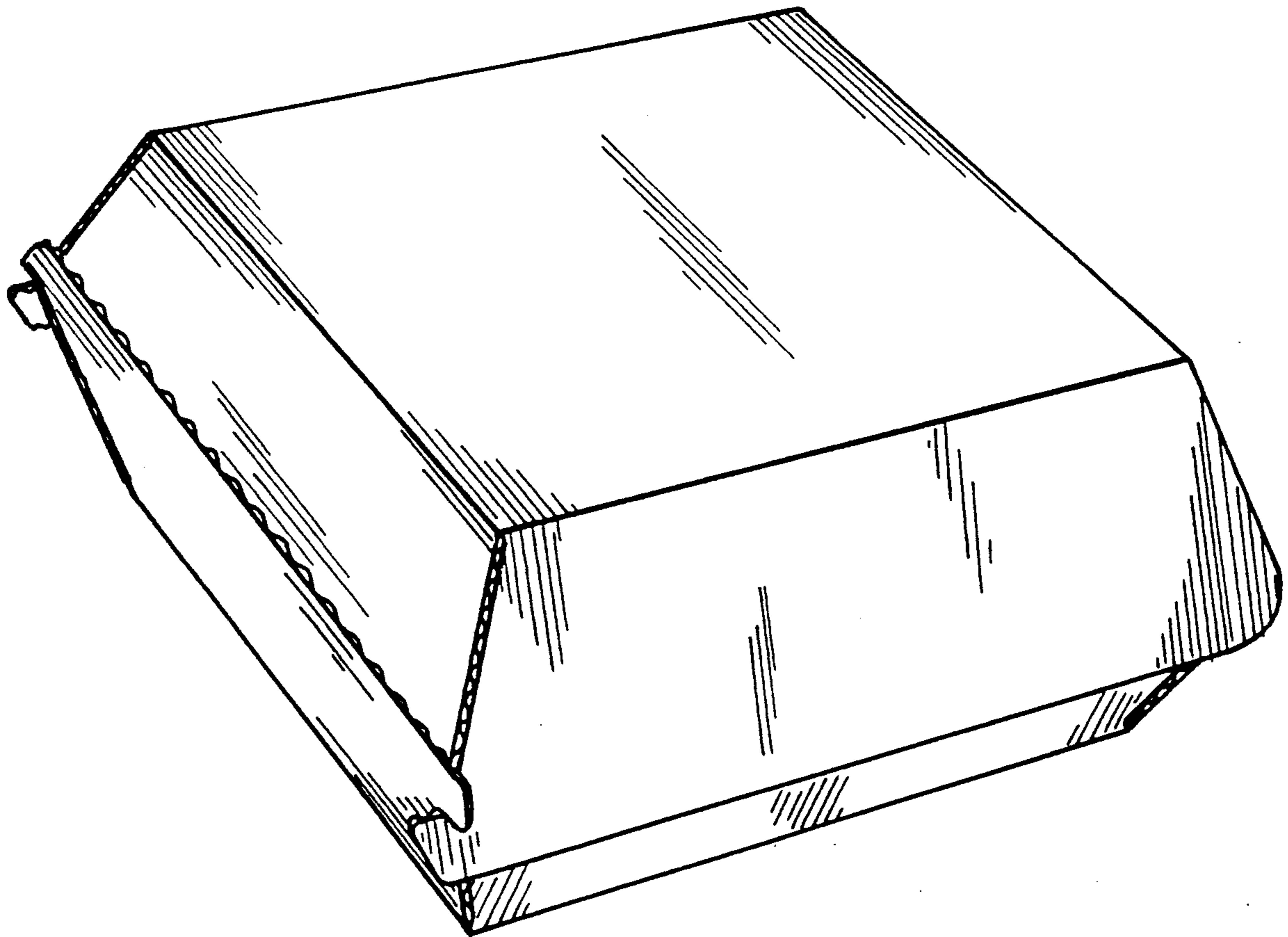

[57] **CLAIM**

The ornamental design for a container for food products, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a blank for a container for food products showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front and top side perspective view of container formed from the blank of FIG. 1 and 2; FIG. 4 is a rear and bottom side perspective view of FIG. 3; FIG. 5 is a front perspective view of FIG. 3 in an open position; FIG. 6 is a top plan view of FIG. 3; FIG. 7 is a left side elevational view of FIG. 3; the right side elevational view being a mirror image thereof; FIG. 8 is a front elevational view of FIG. 3; FIG. 9 is a rear elevational view of FIG. 3; and, FIG. 10 is a bottom plan view of a second embodiment of FIG. 1. The corresponding views disclosed in the second embodiment (FIG. 10) are similar to the first embodiment (FIGS. 2-9 inclusive). The broken lines are intended to represent fold lines.



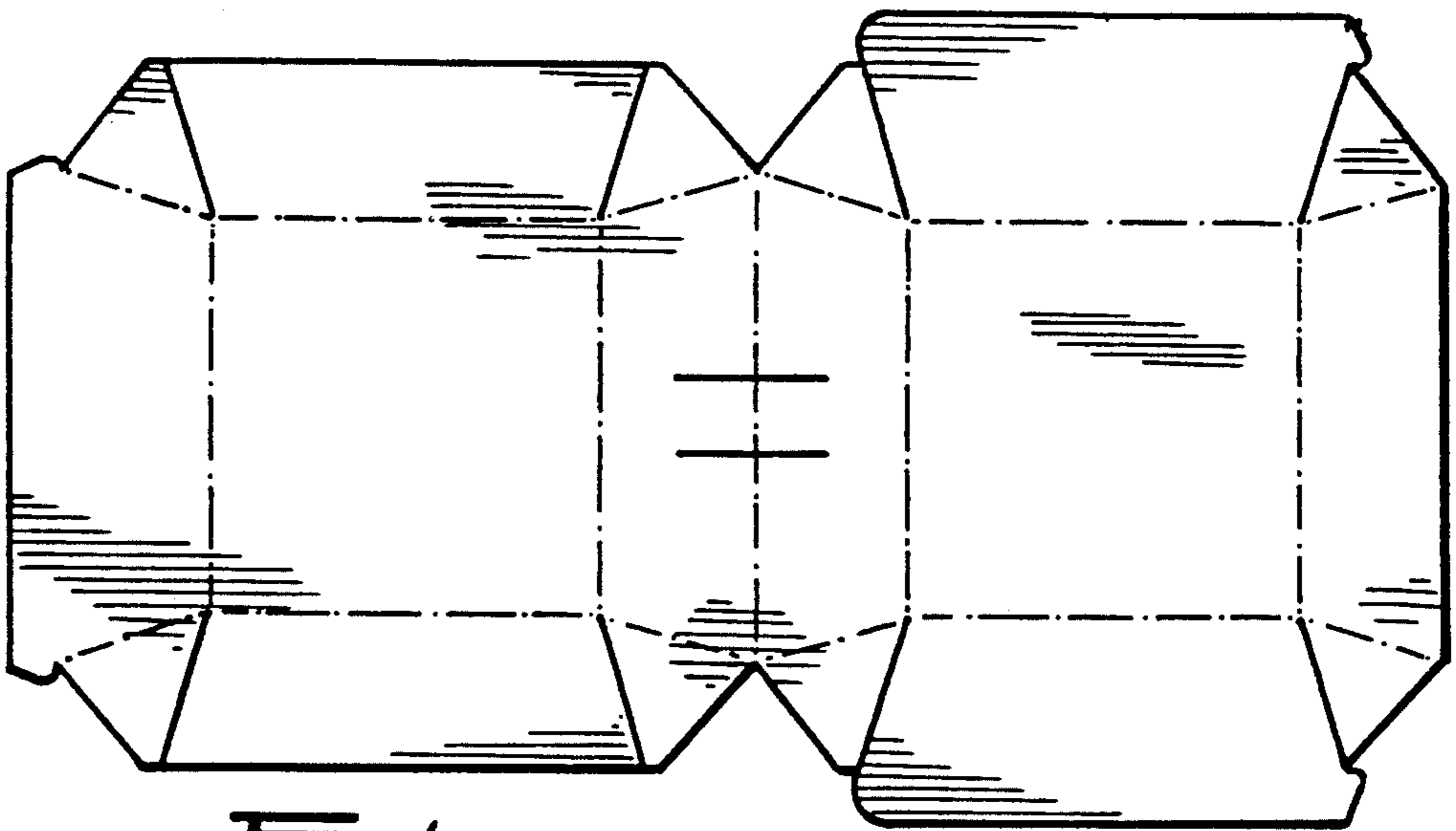

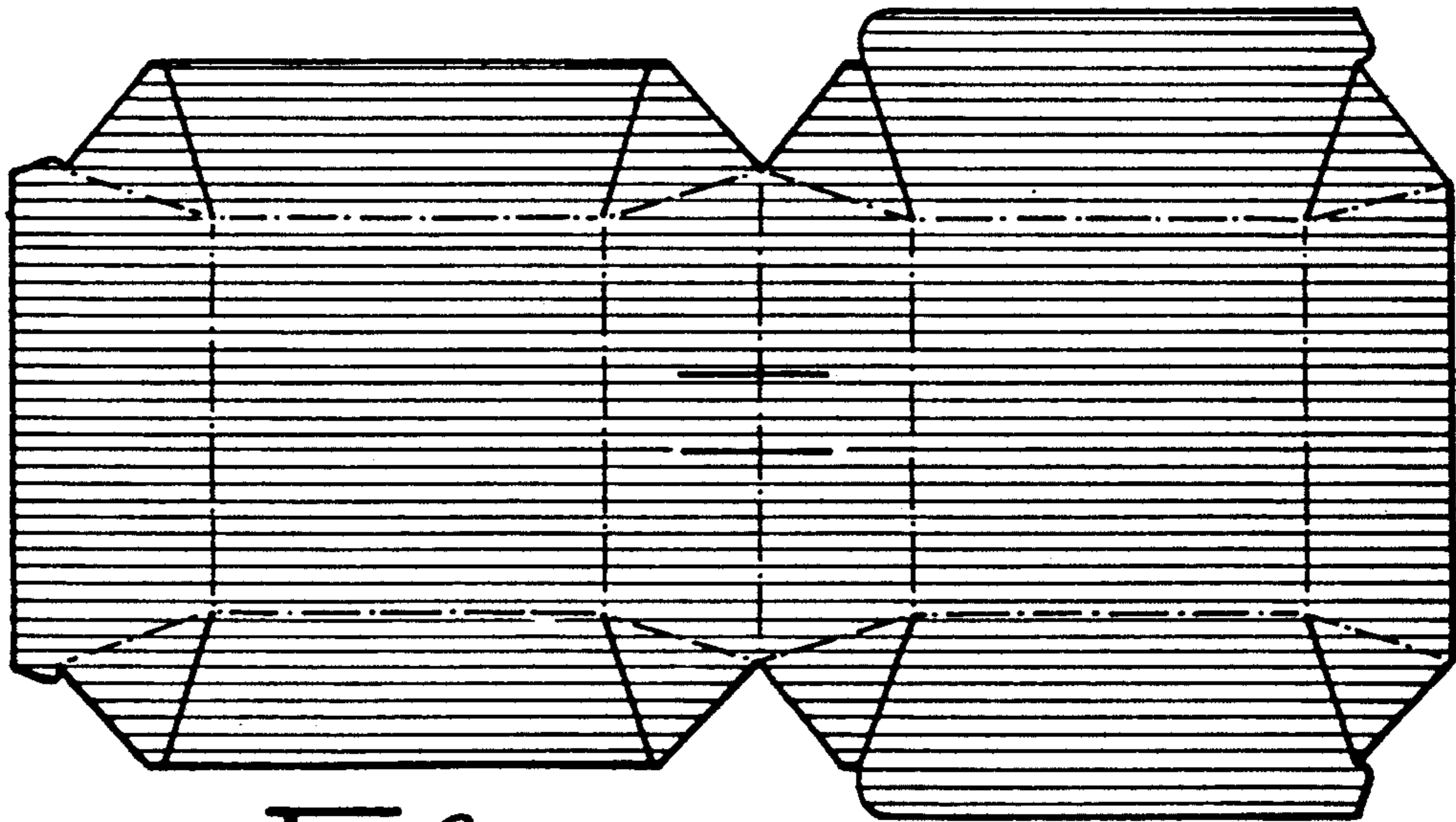

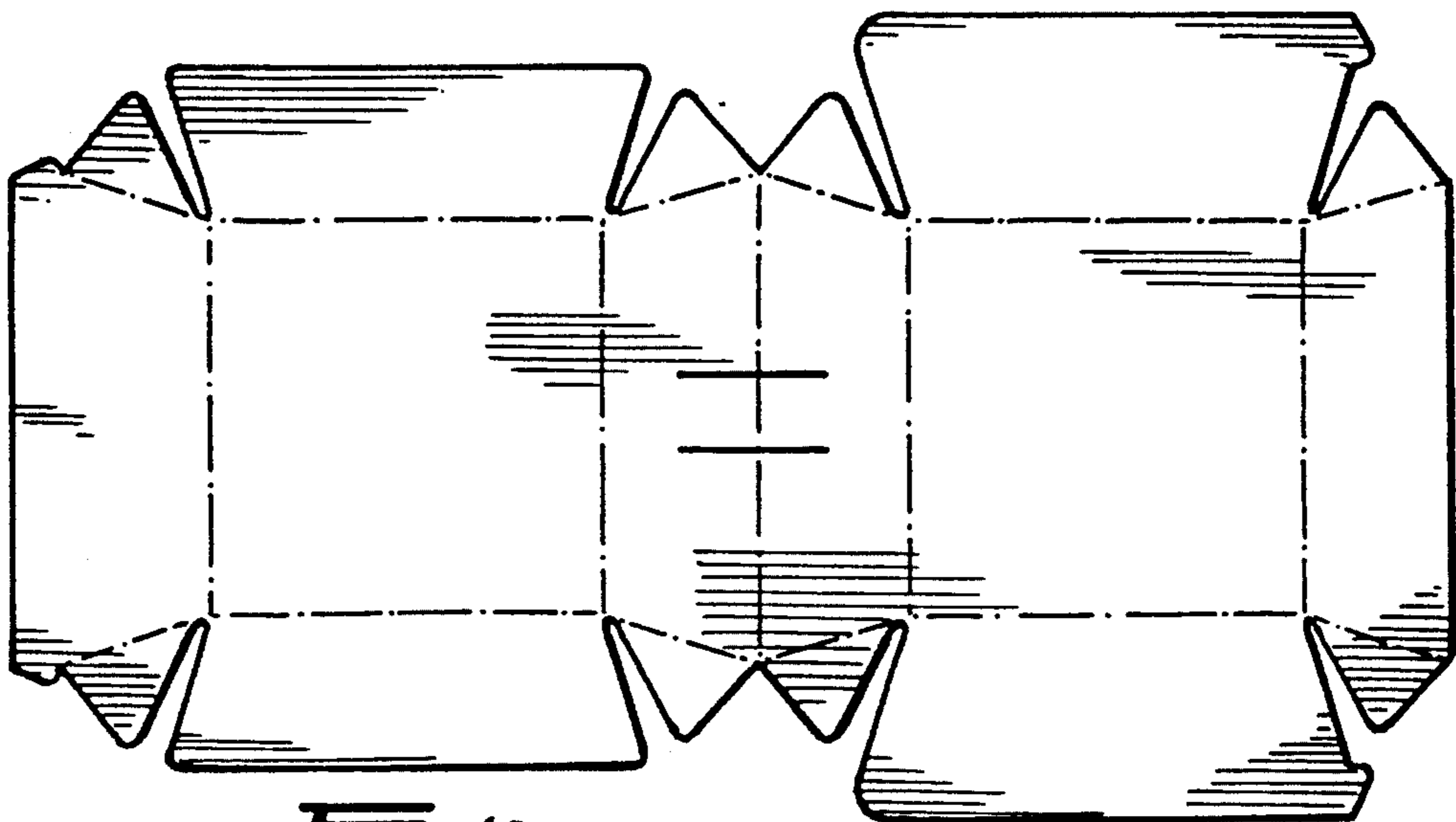

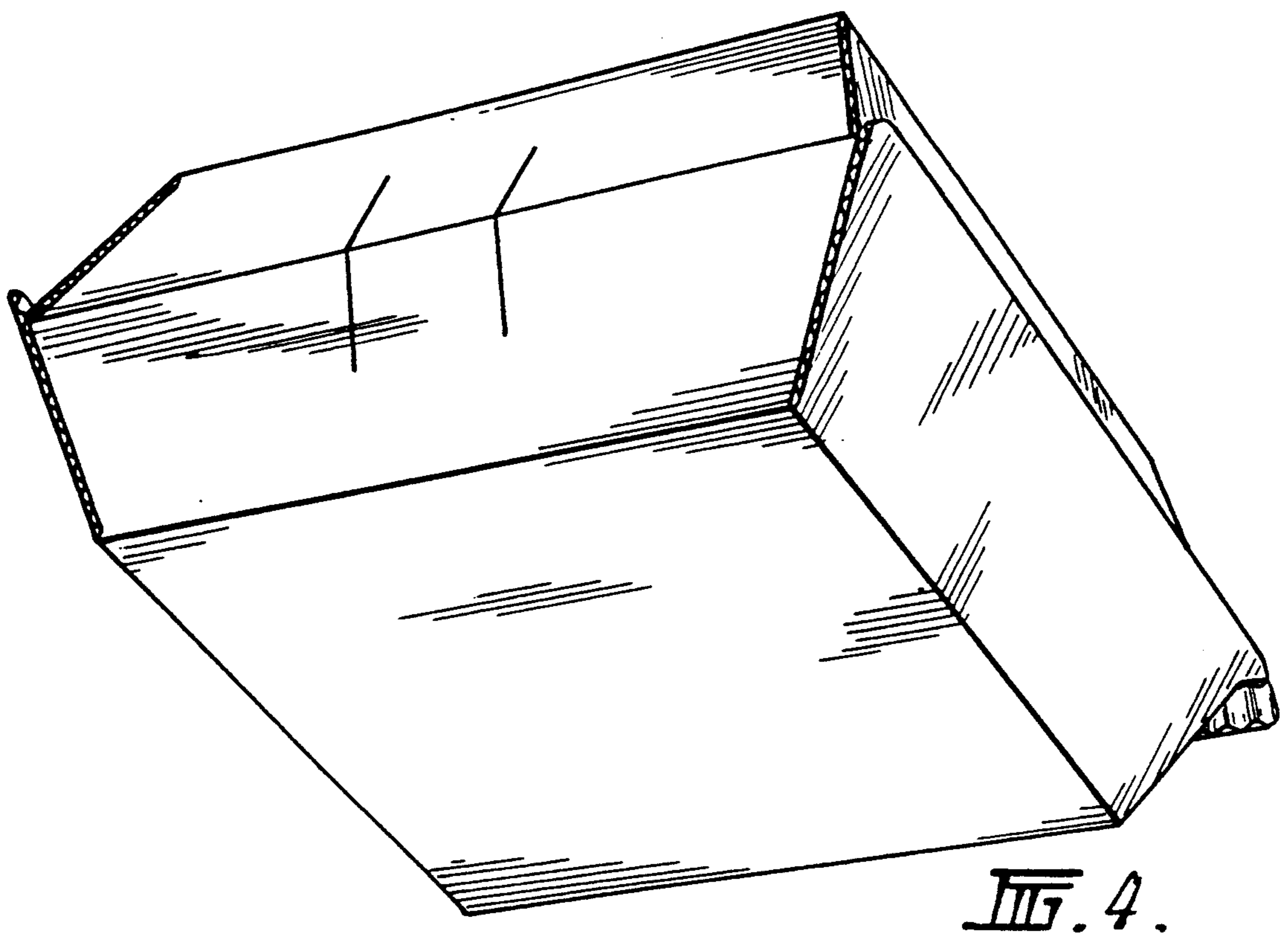
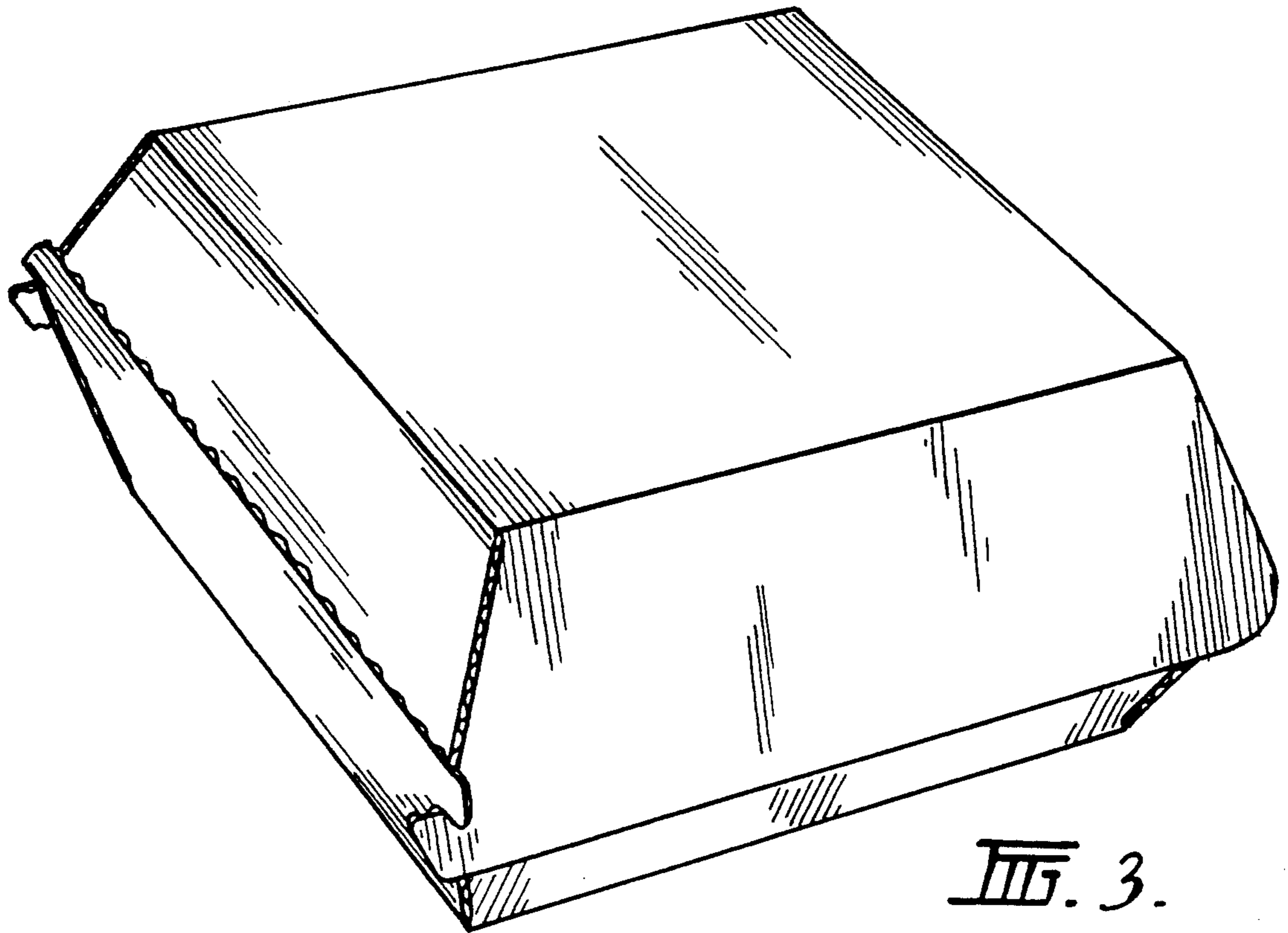
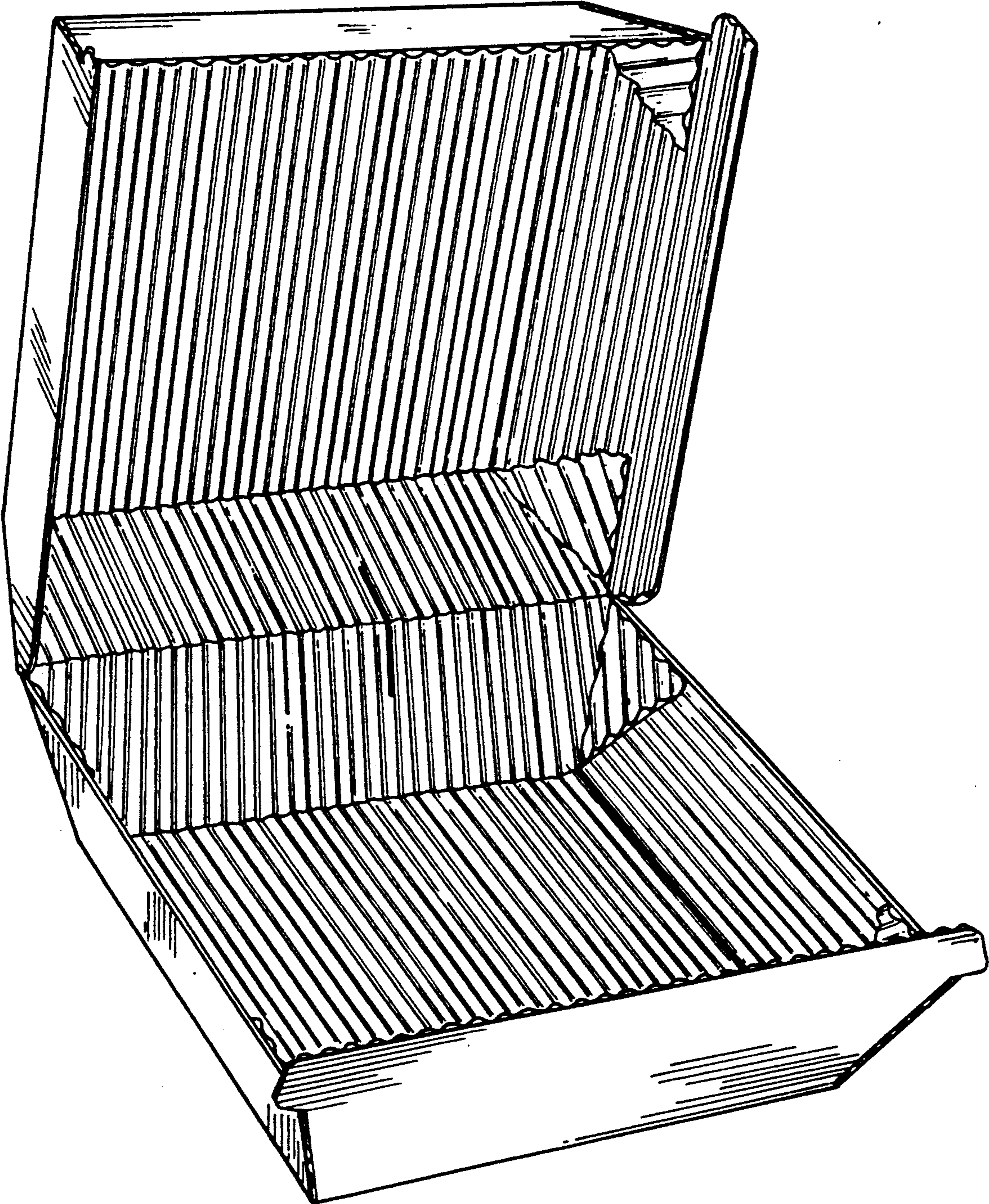

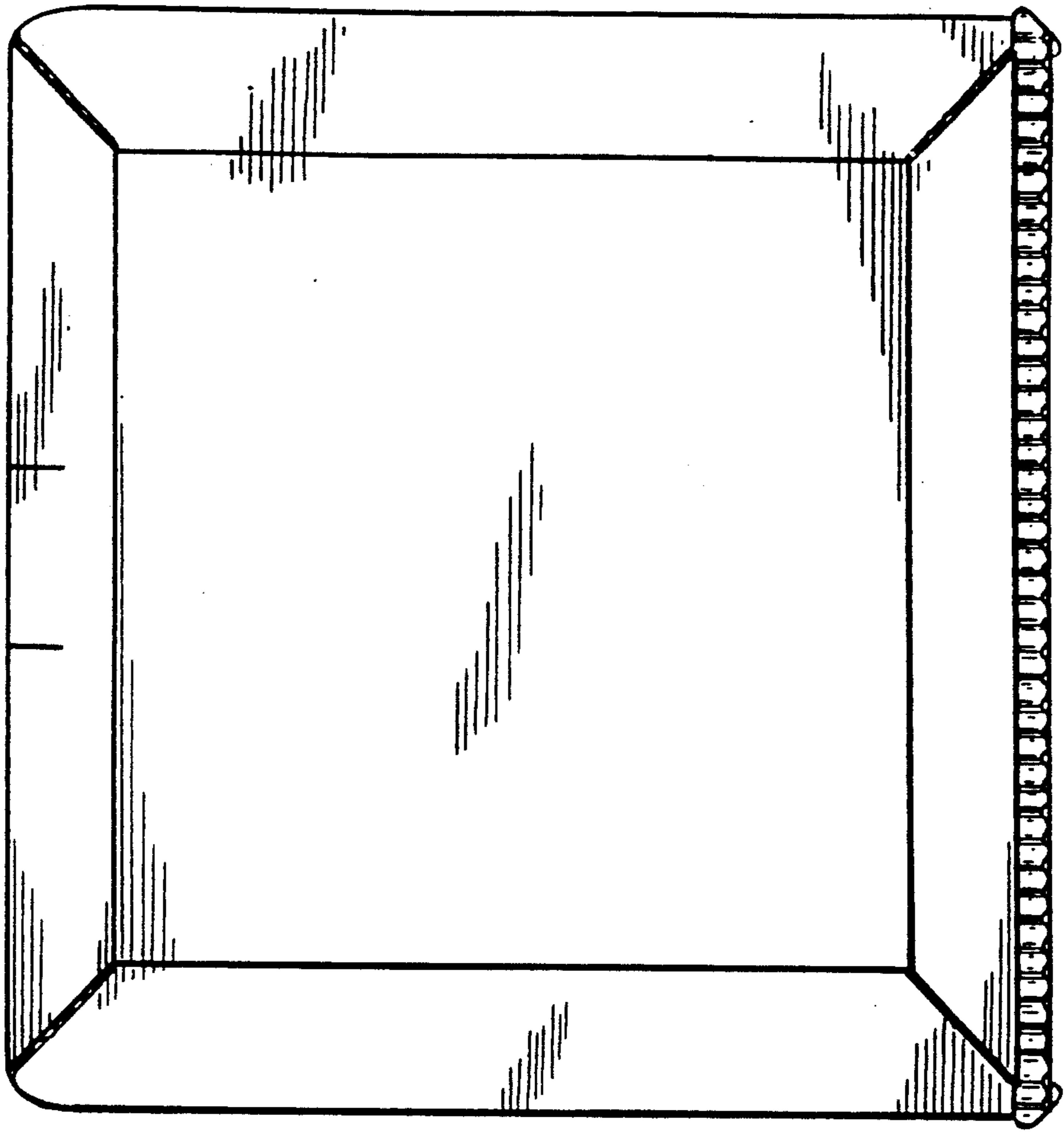

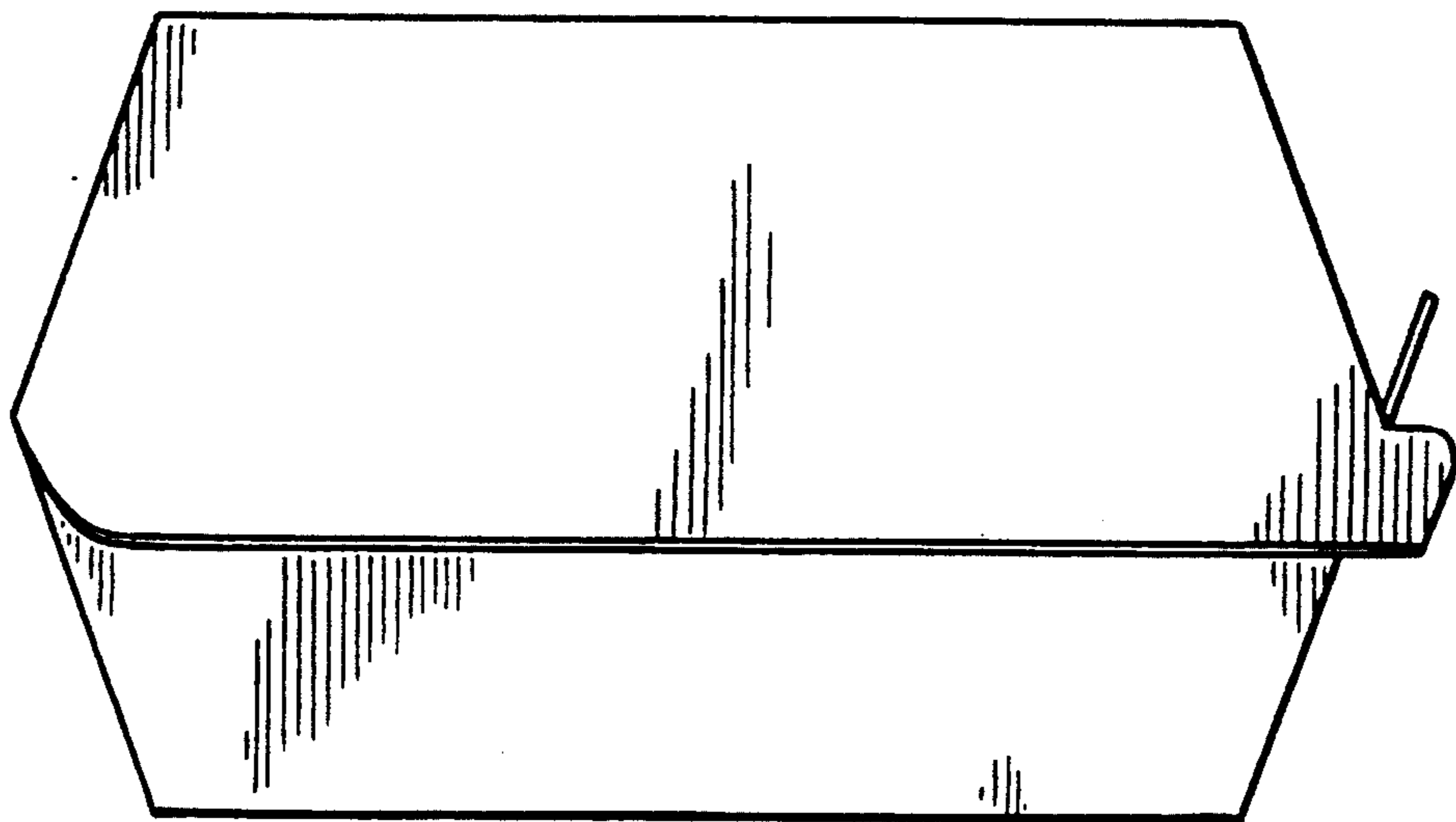

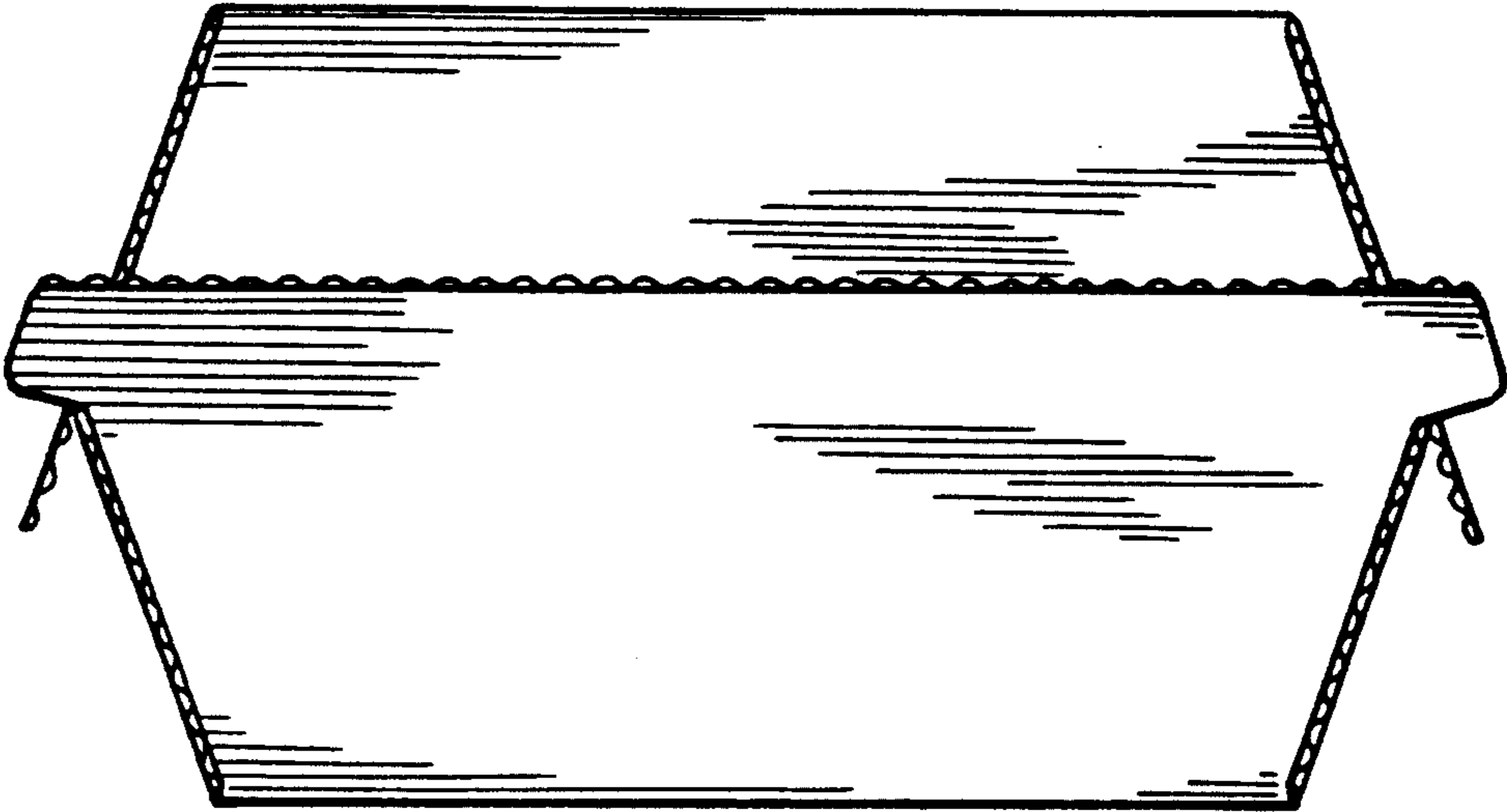

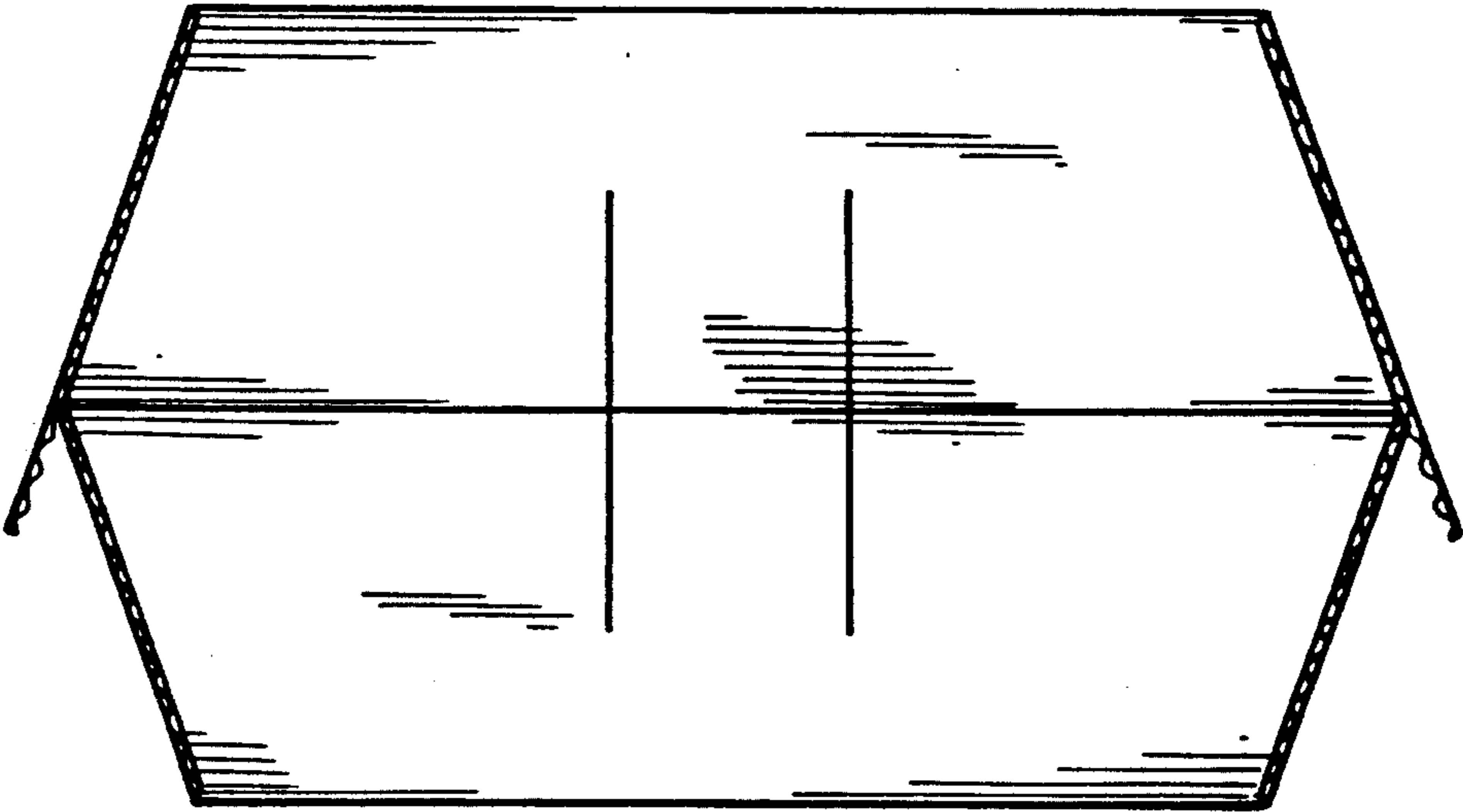
