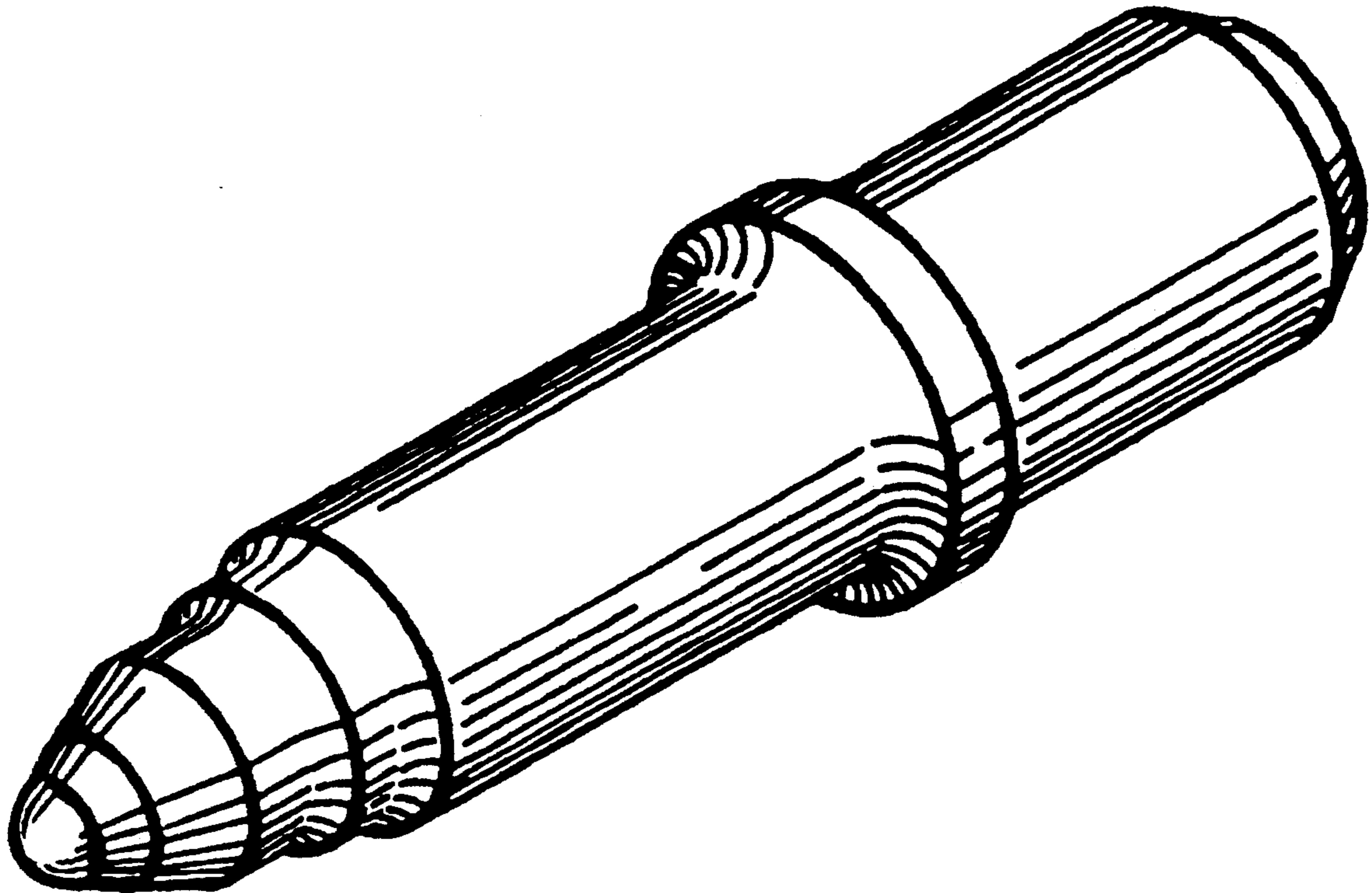

[57] **CLAIM**

The ornamental design for a ball-point pen tip, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a ball-point pen tip showing my new design, all other sides being identical thereto;
 FIG. 2 is an enlarged, fragmentary side elevational view of the head portion;
 FIG. 3 is a top plan view of FIG. 1;
 FIG. 4 is a bottom plan view of FIG. 1;
 FIG. 5 is a longitudinal cross-sectional view of FIG. 1;
 FIG. 6 is a perspective view of FIG. 1;
 FIG. 7 is a side elevational view of a second embodiment of my new design, all other sides being identical thereto;
 FIG. 8 is an enlarged, fragmentary side elevational view of the head portion;
 FIG. 9 is a top plan view of FIG. 7;
 FIG. 10 is a bottom plan view of FIG. 7;
 FIG. 11 is a longitudinal cross-sectional view of FIG. 7;

 FIG. 12 is a perspective view of FIG. 7.



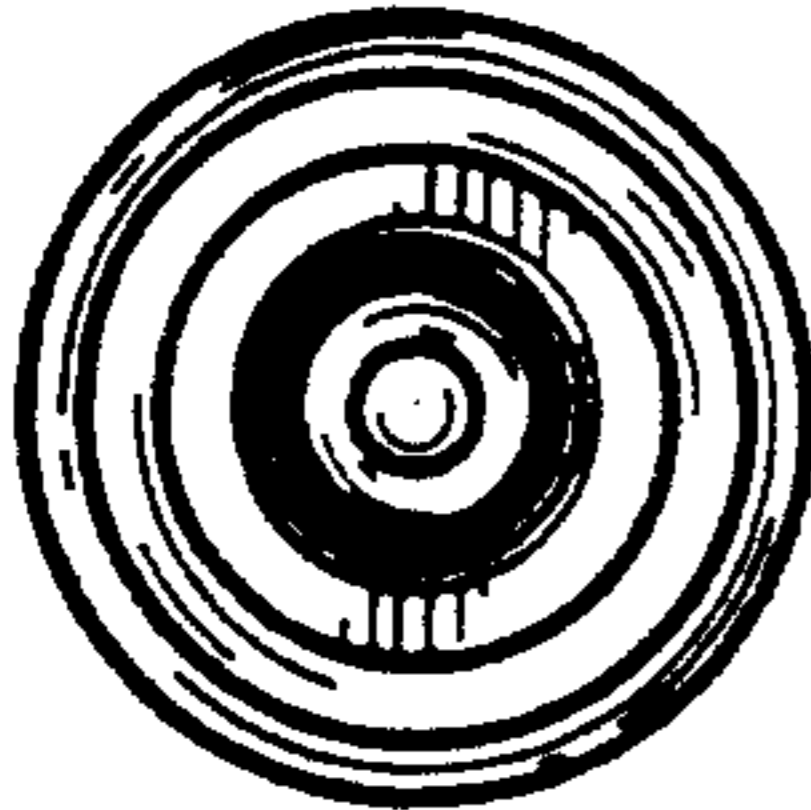

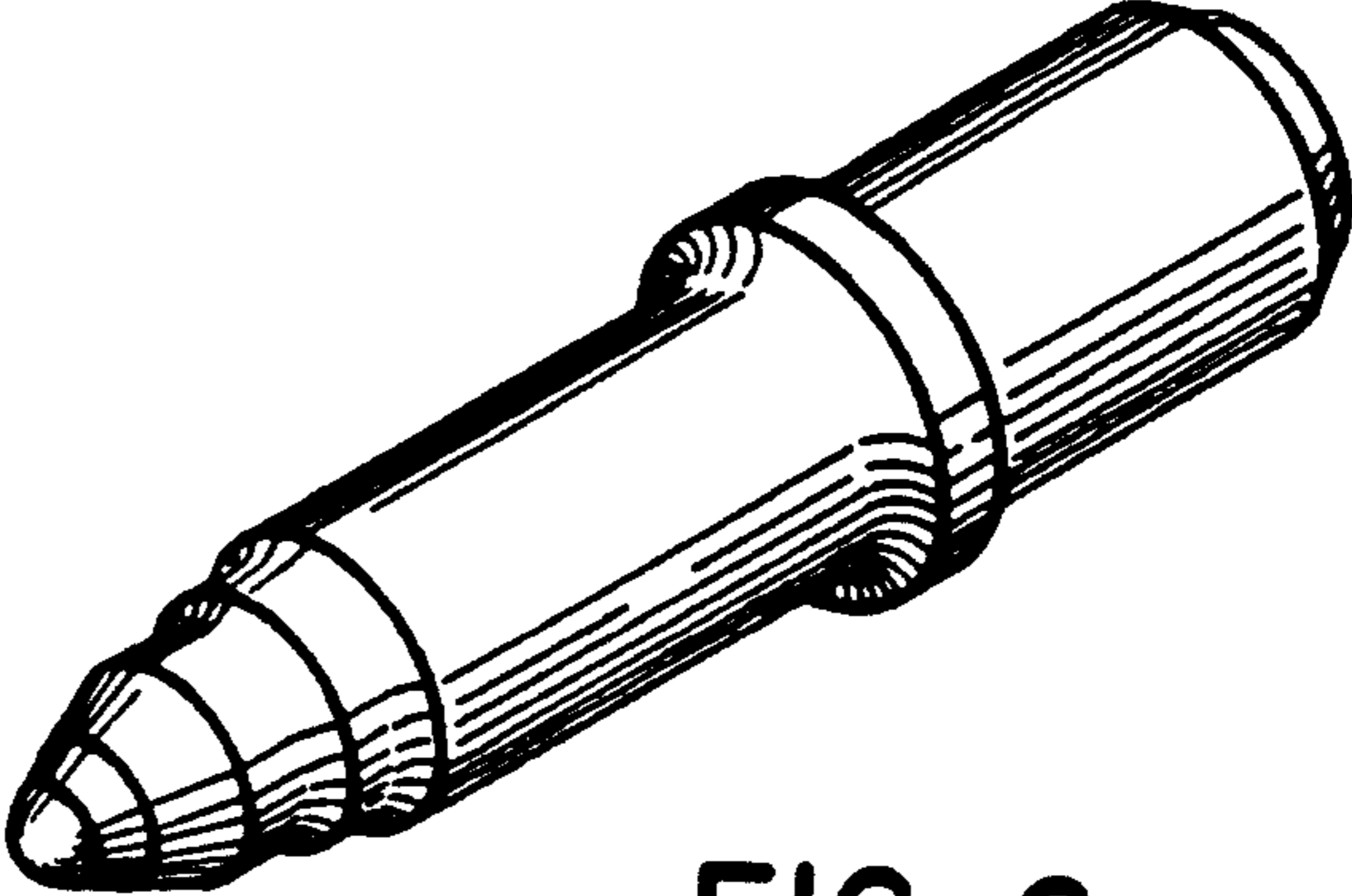

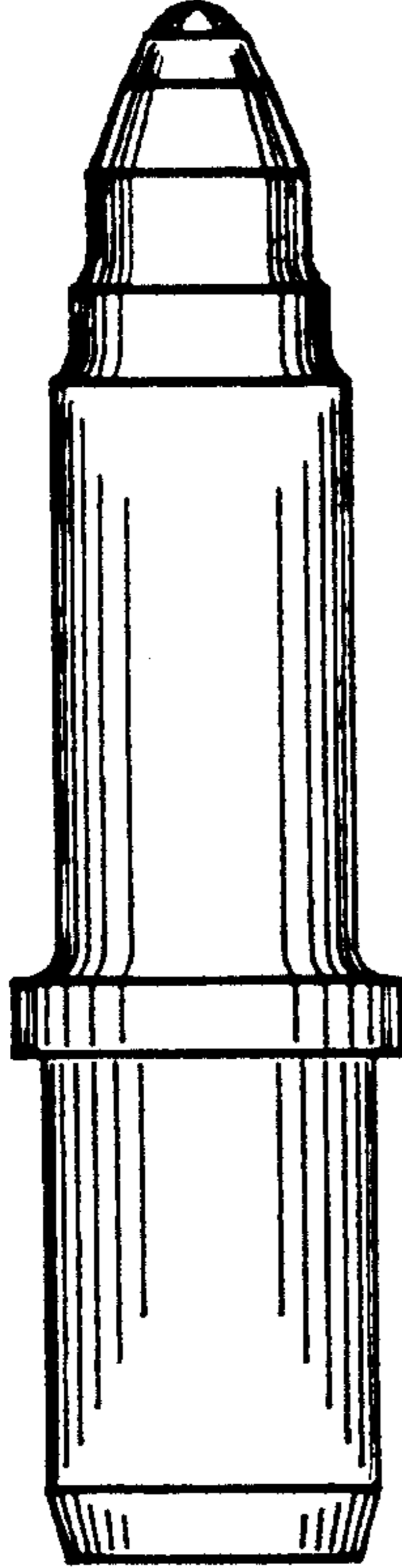

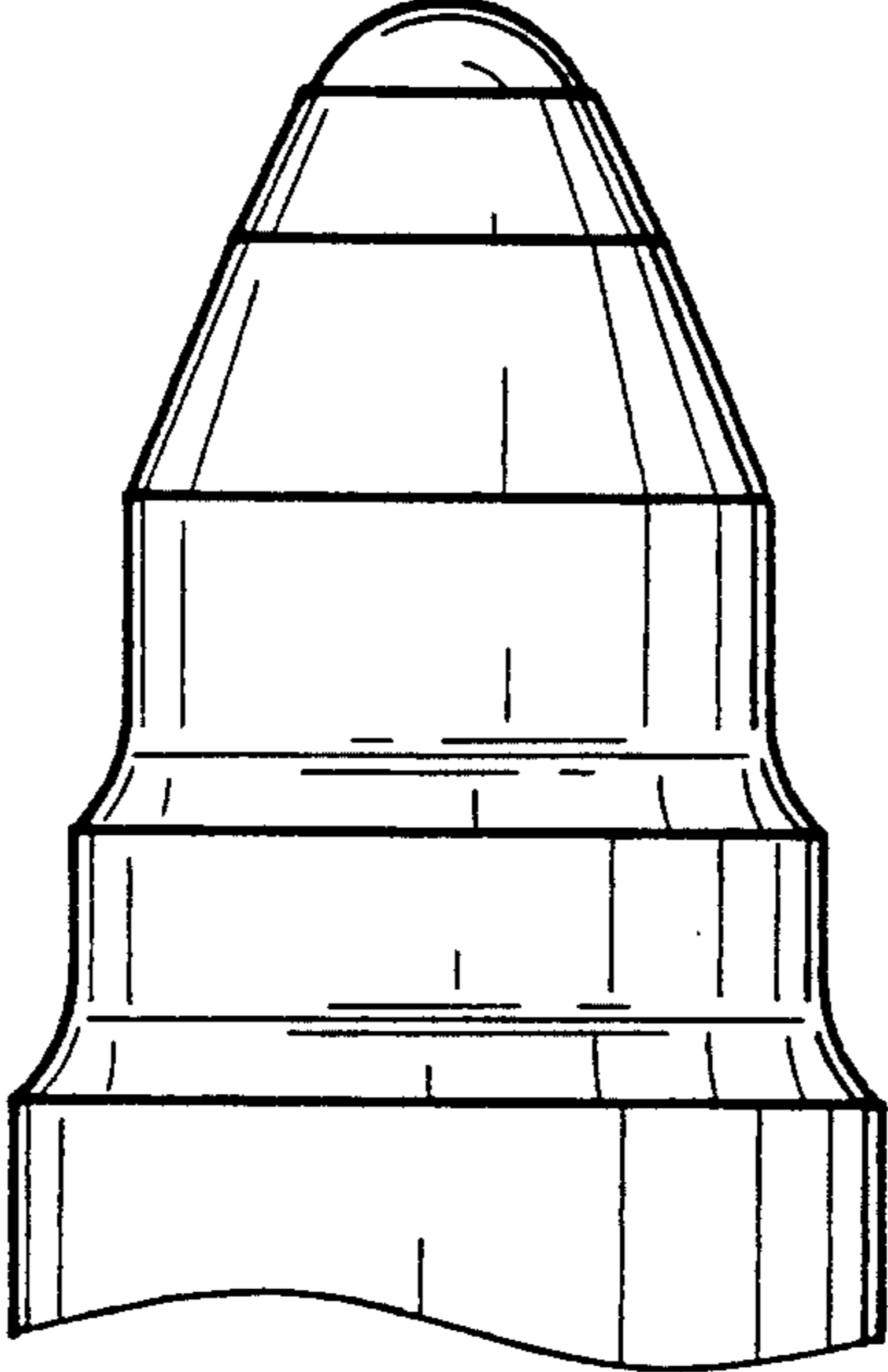

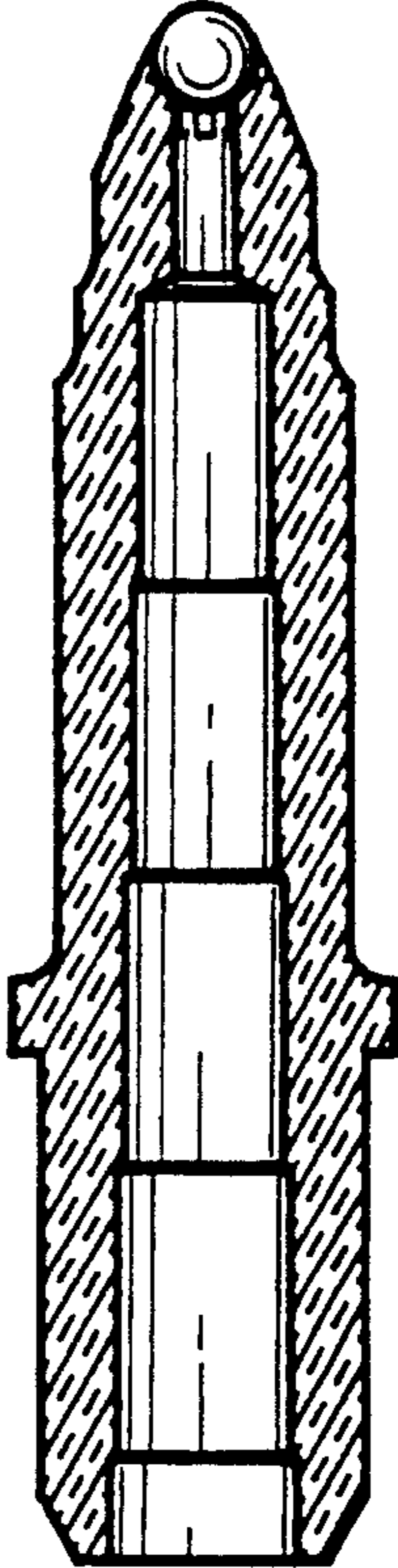

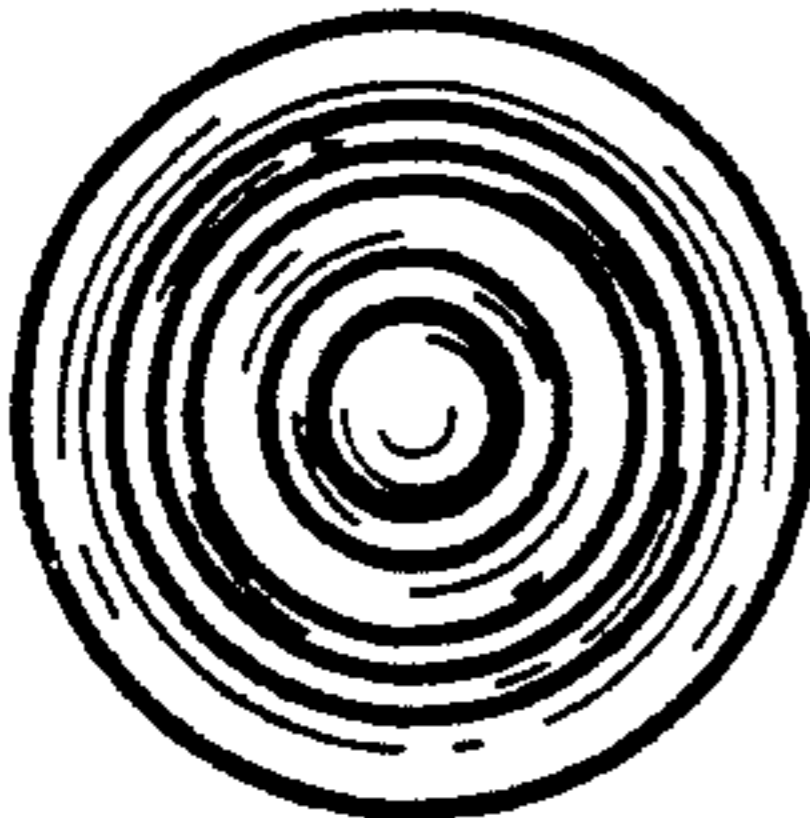

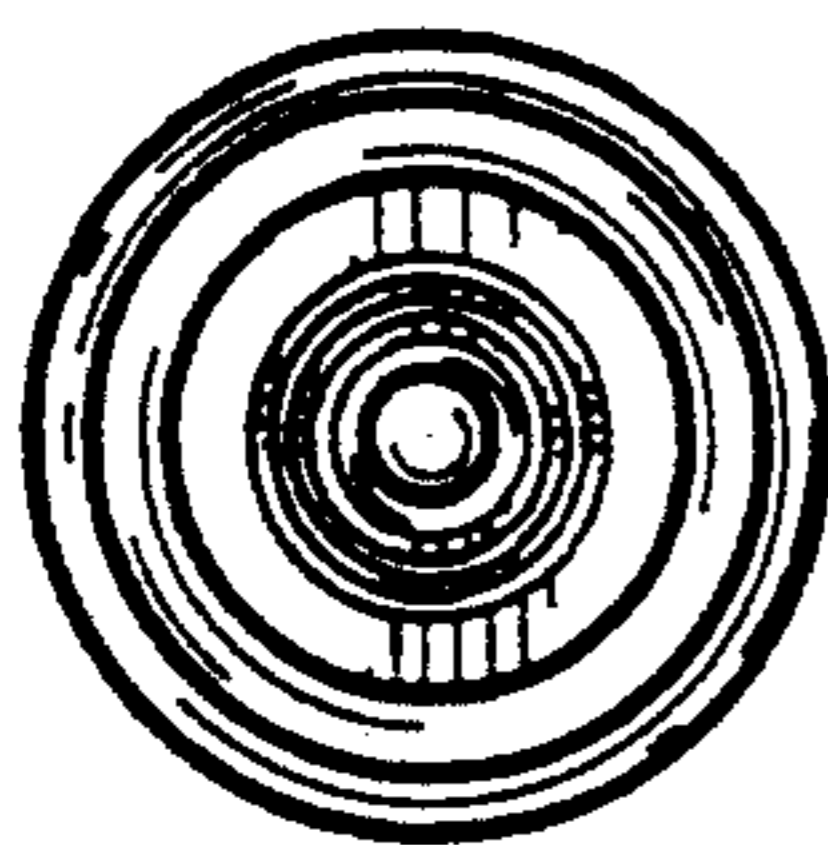

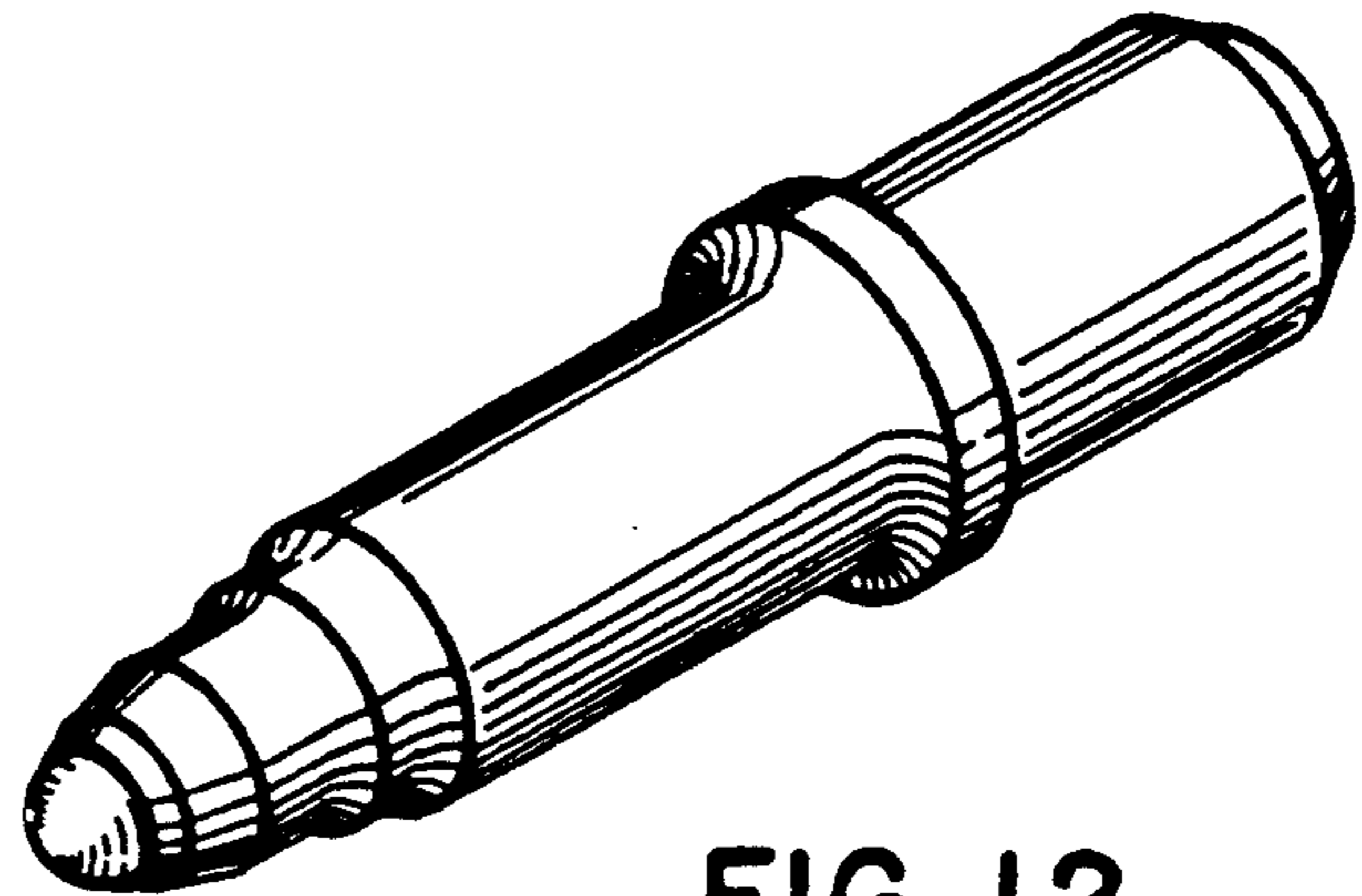

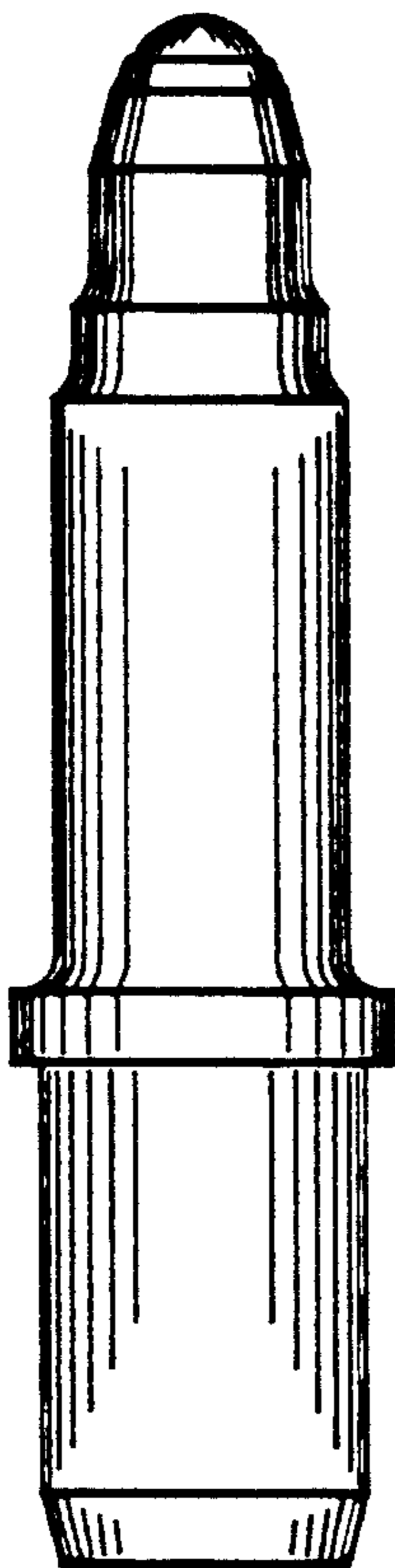

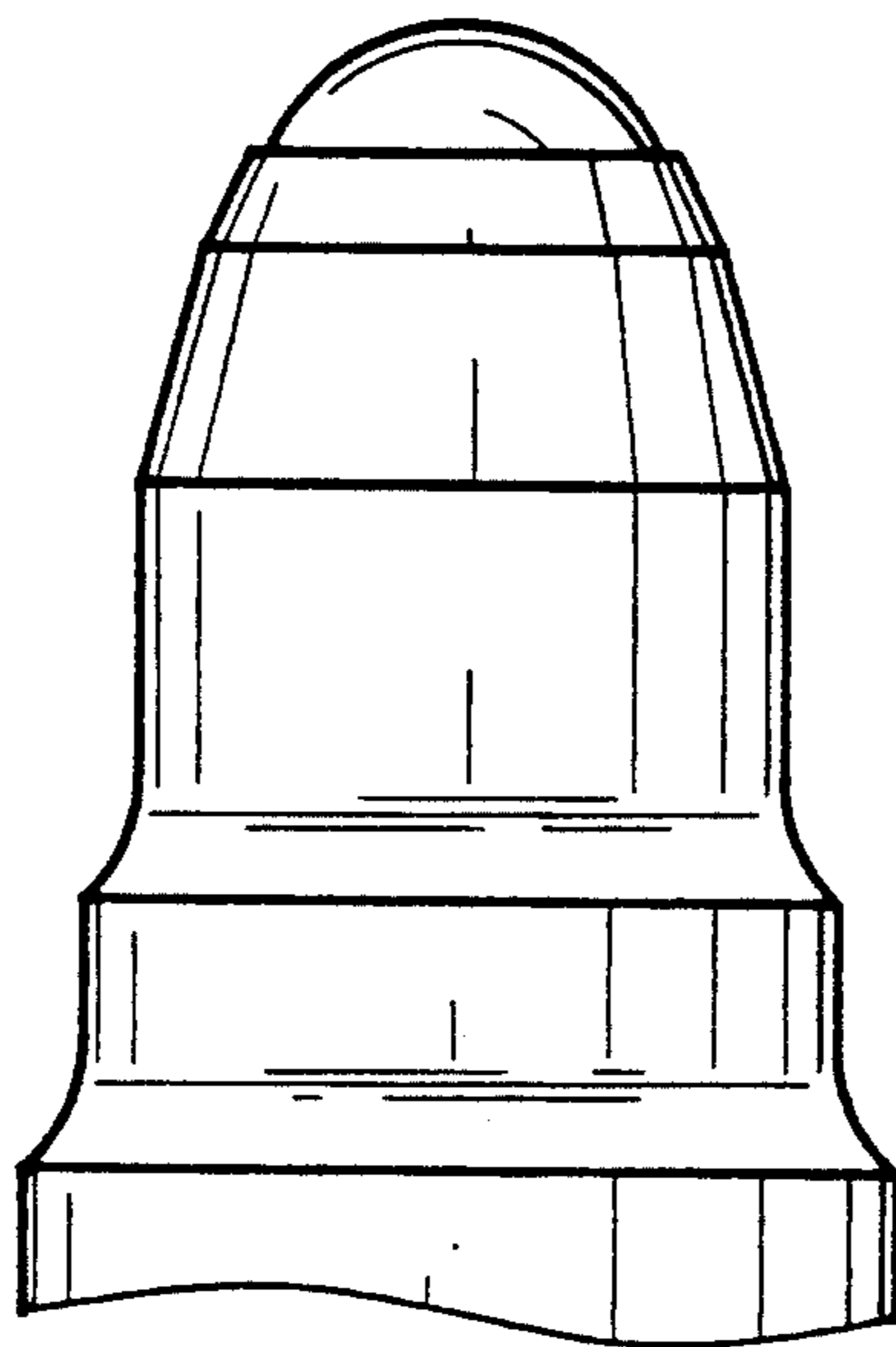

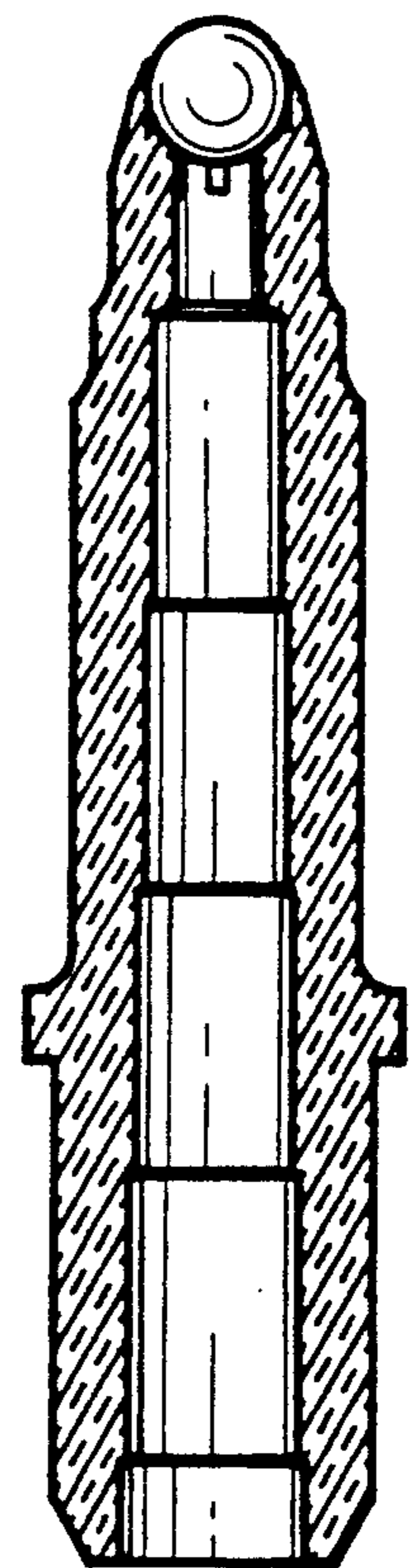

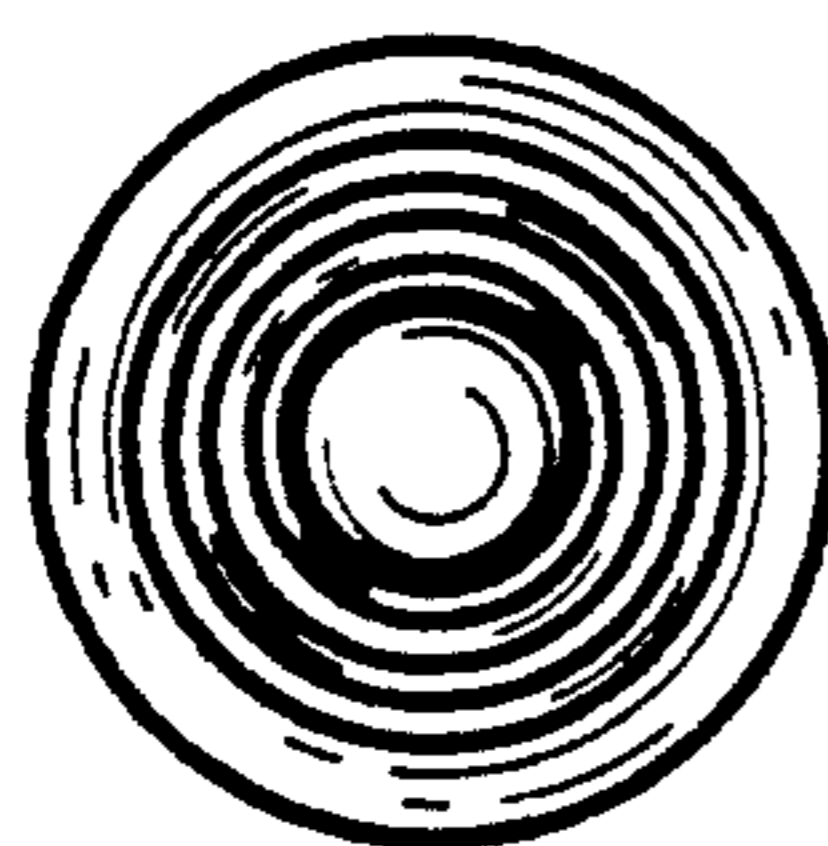
