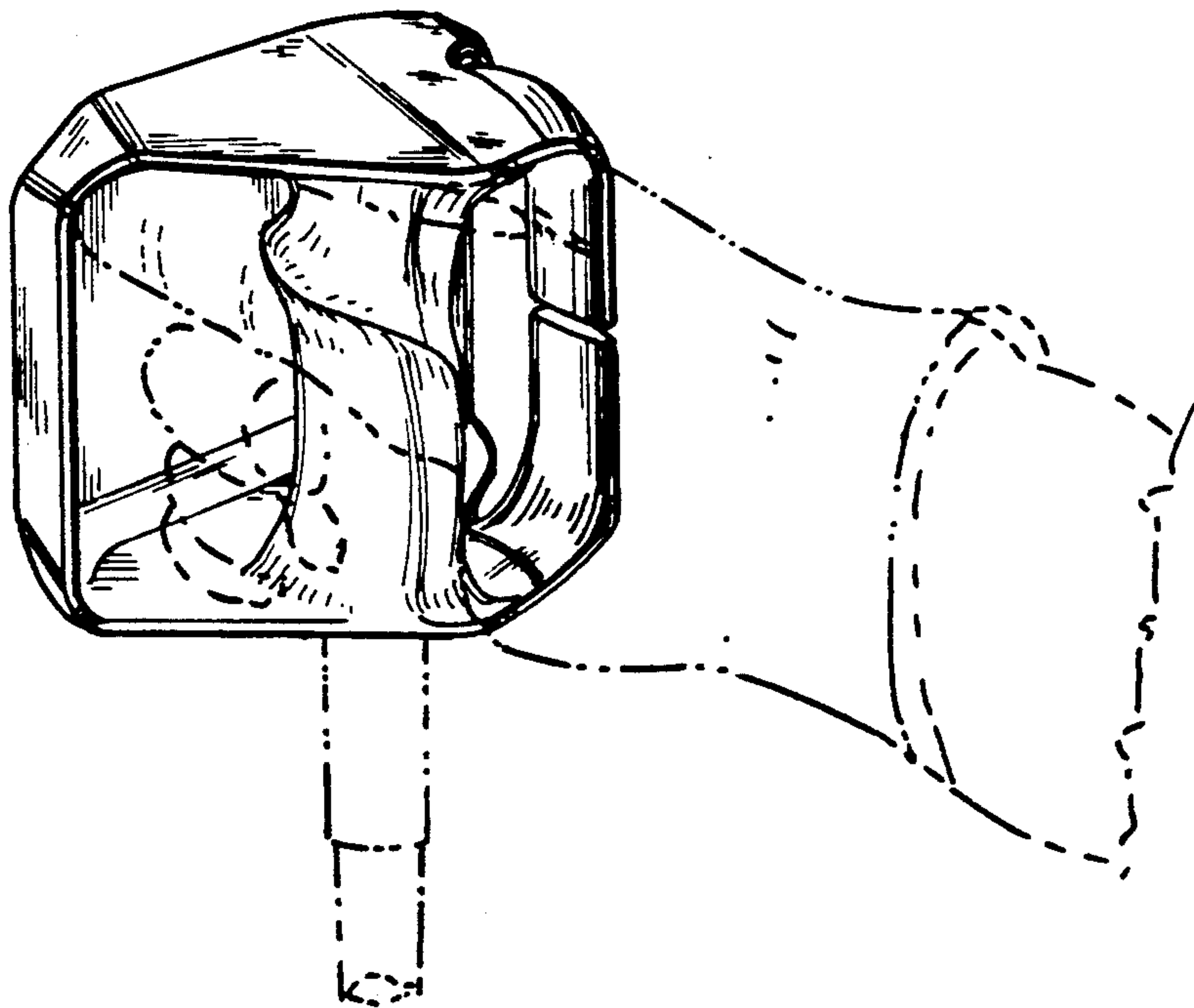

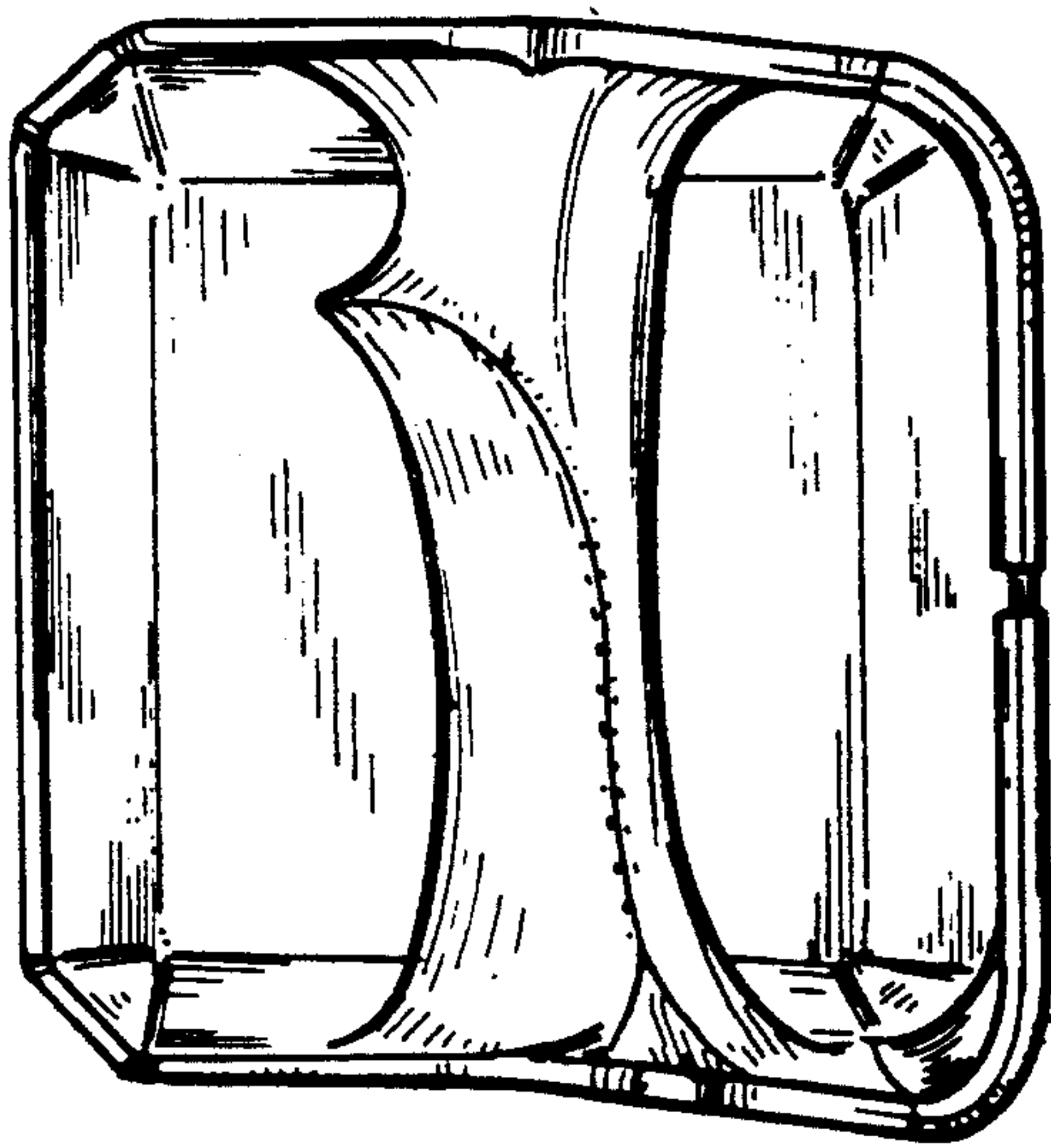
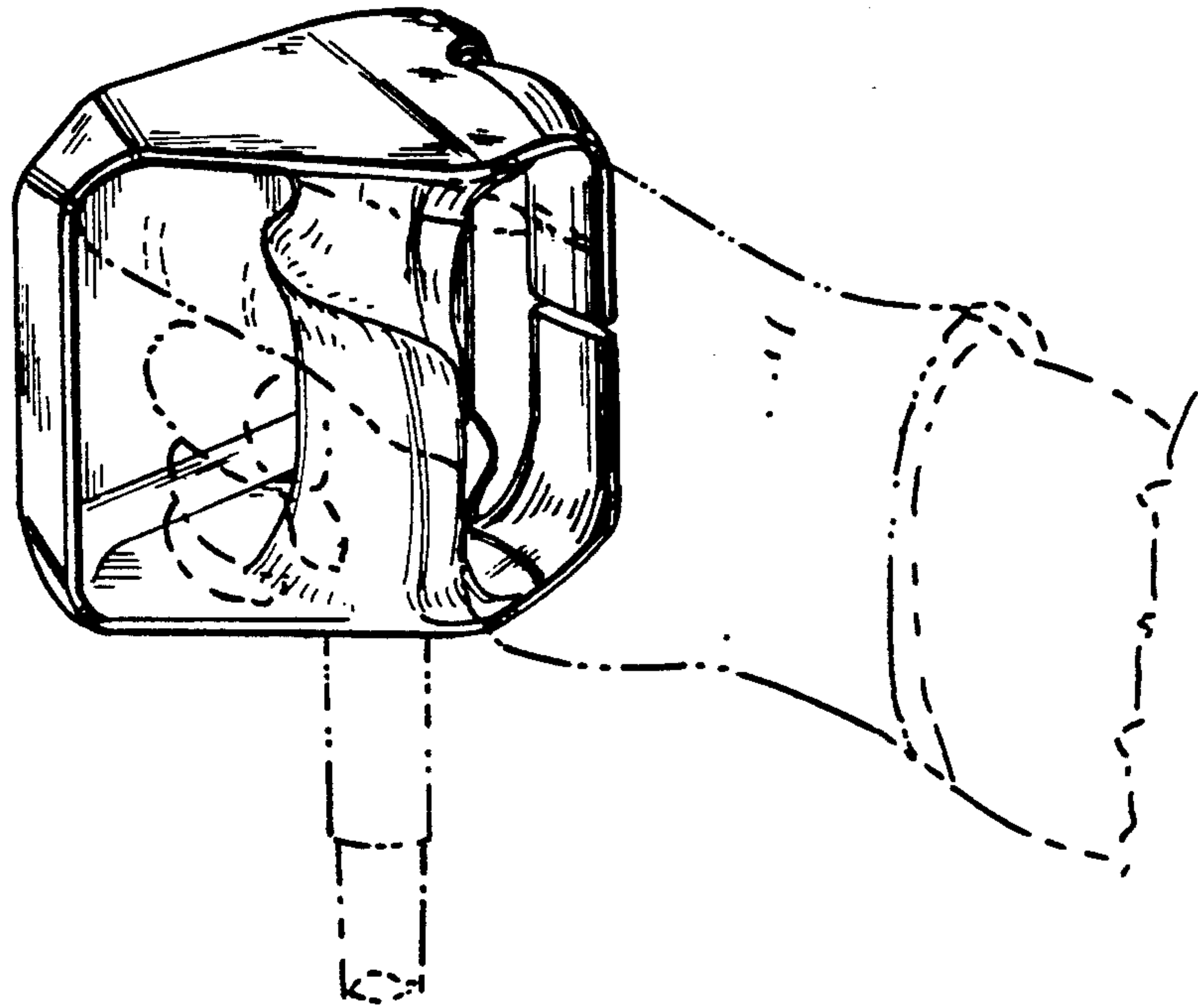

### DESCRIPTION

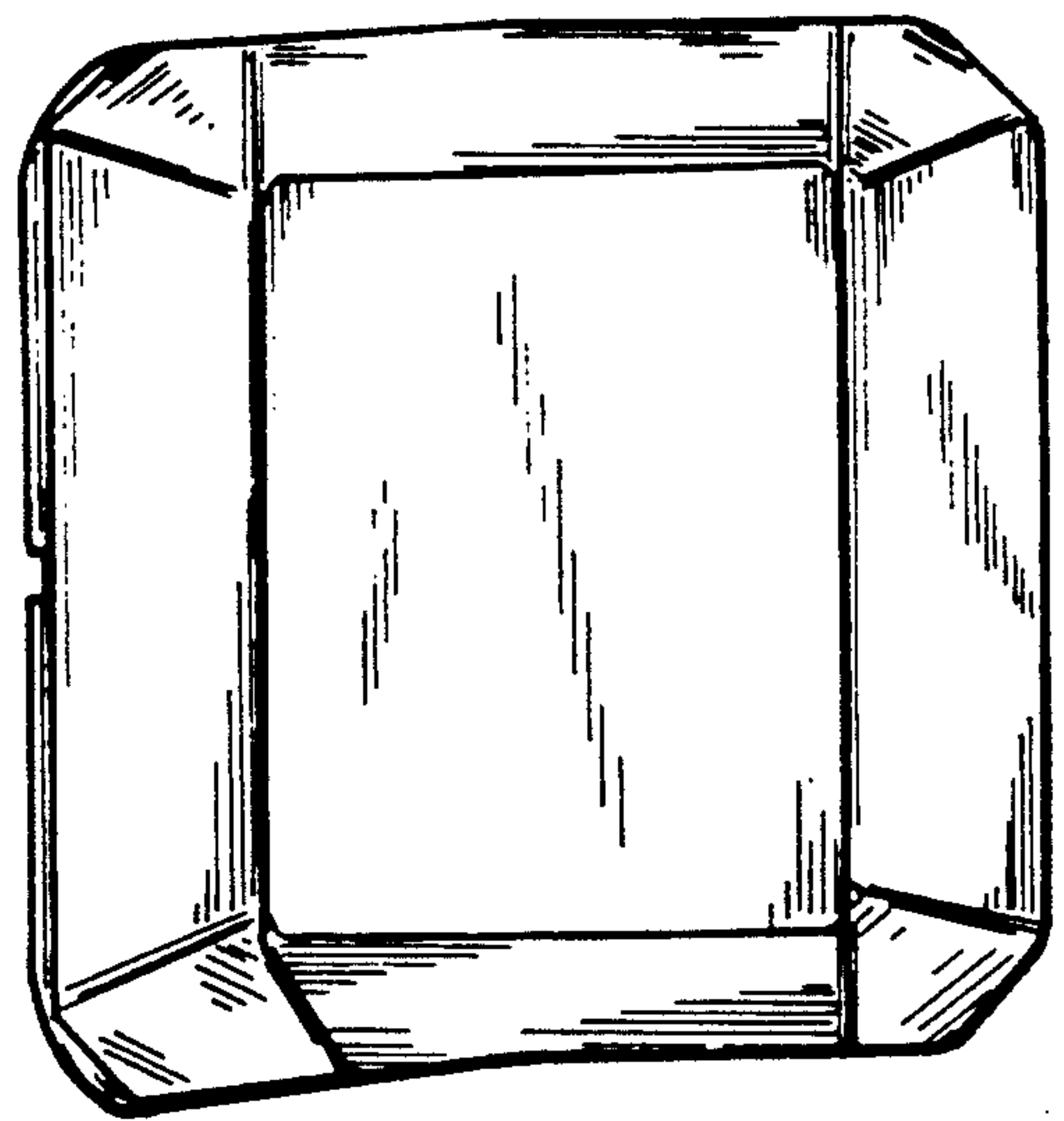
FIG. 1 is a perspective view of a full shield safety handle for ski pole showing my new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a front end elevational view thereof; and  
FIG. 7 is a rear end elevational view thereof.  
The broken lines in FIG. 1 showing the ski pole and the hand of a user are for illustrative purposes only and form no part of the claimed design.



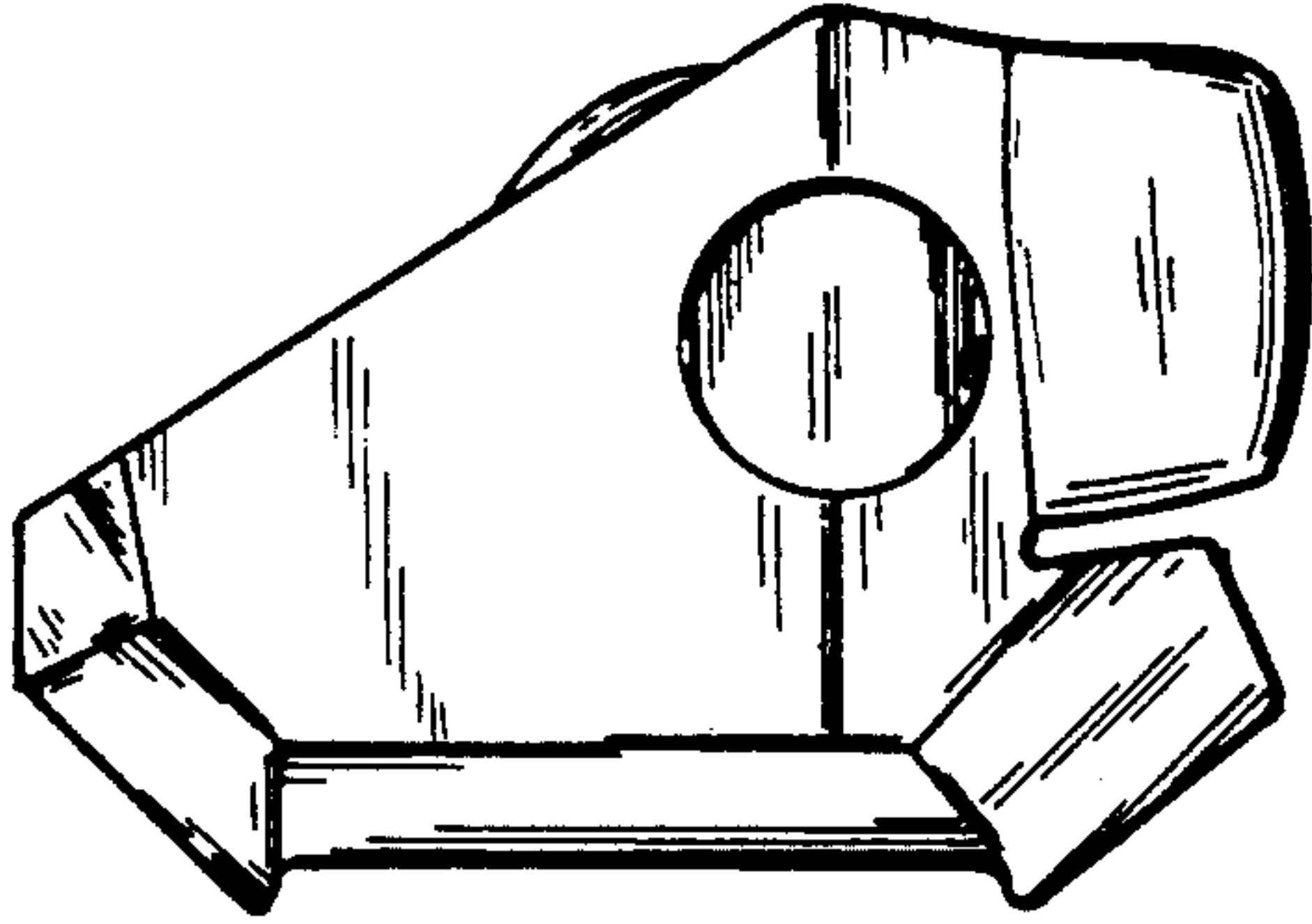

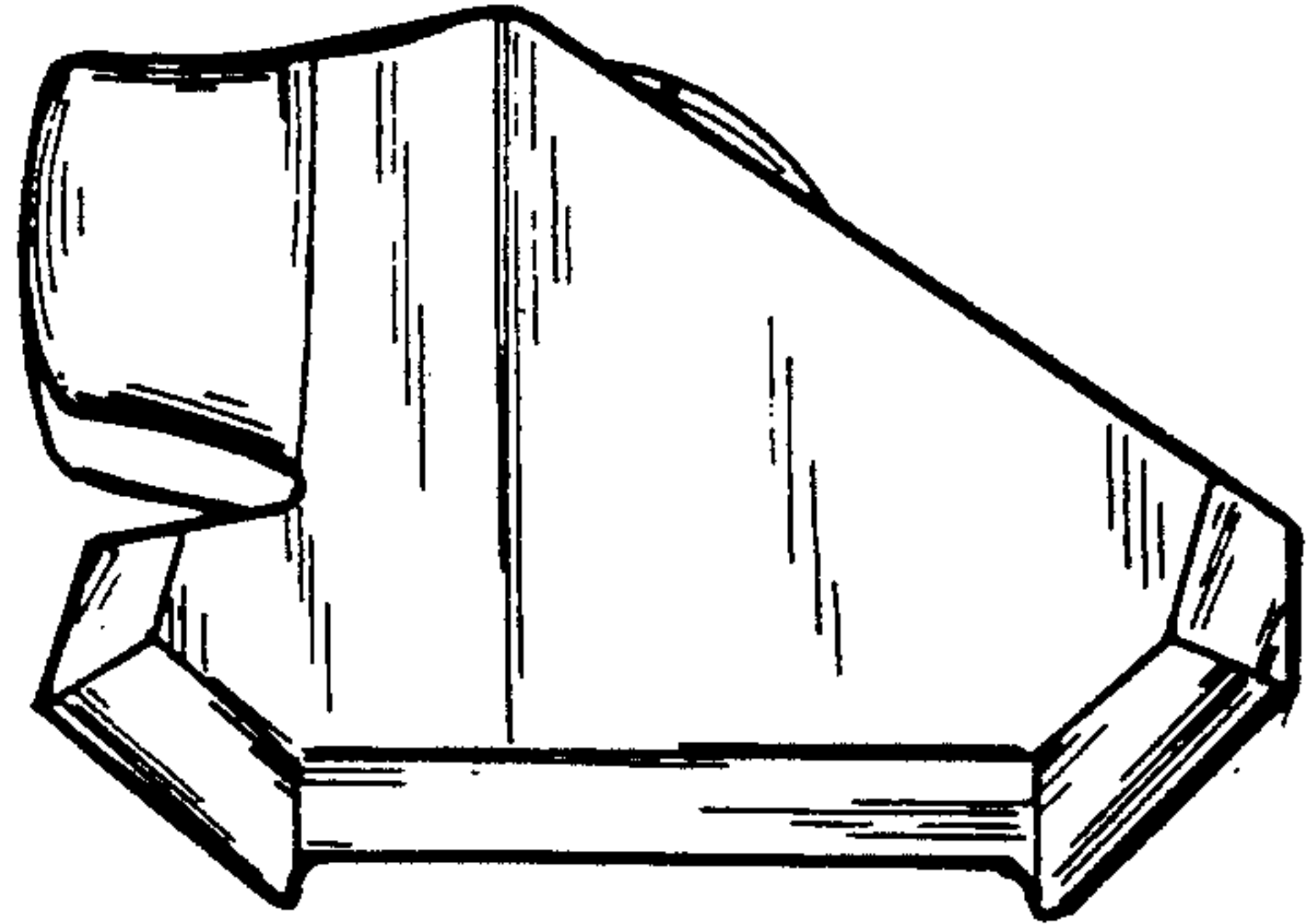

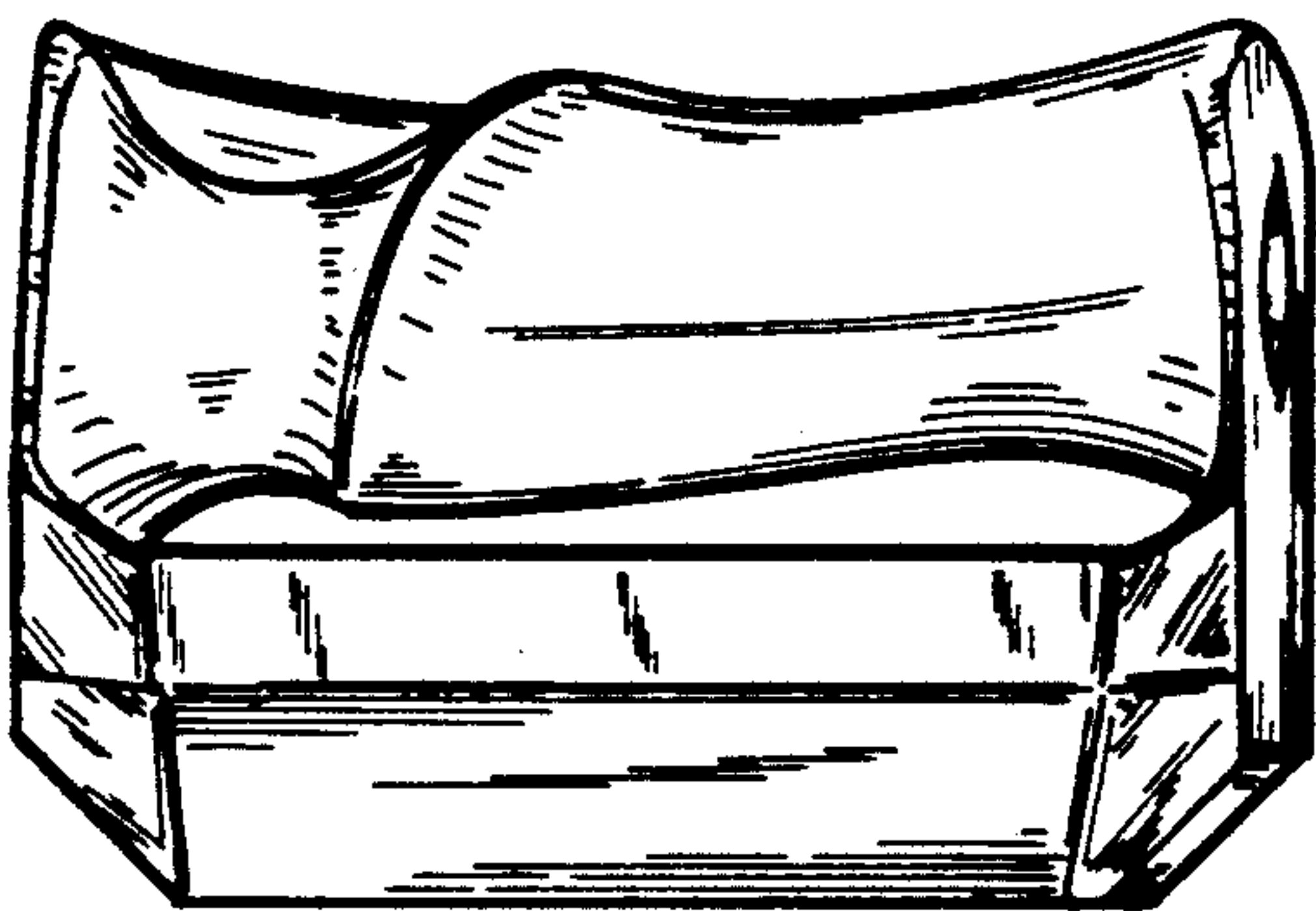

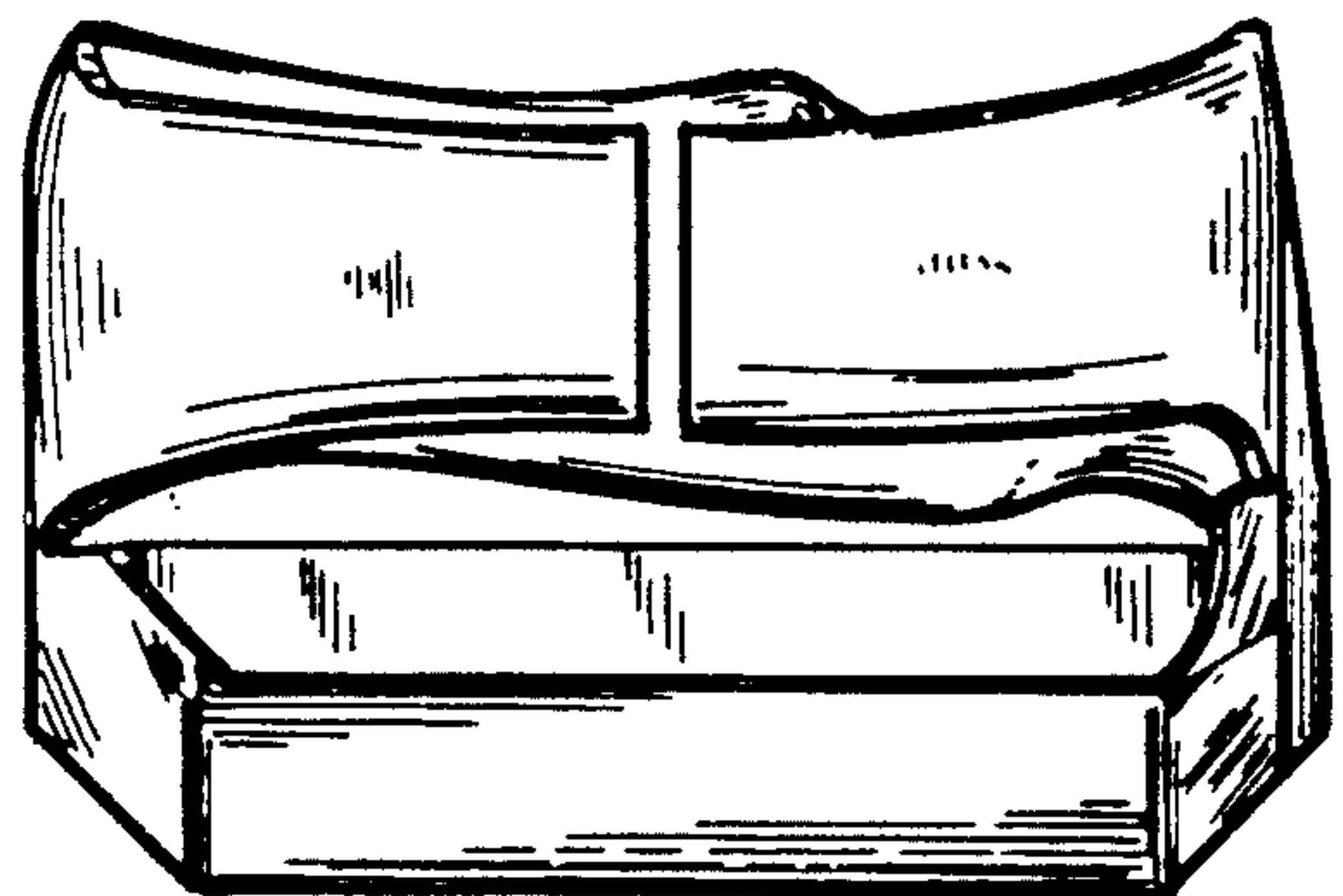
