The ornamental design for a lavatory, as shown and described.

DESCRIPTION

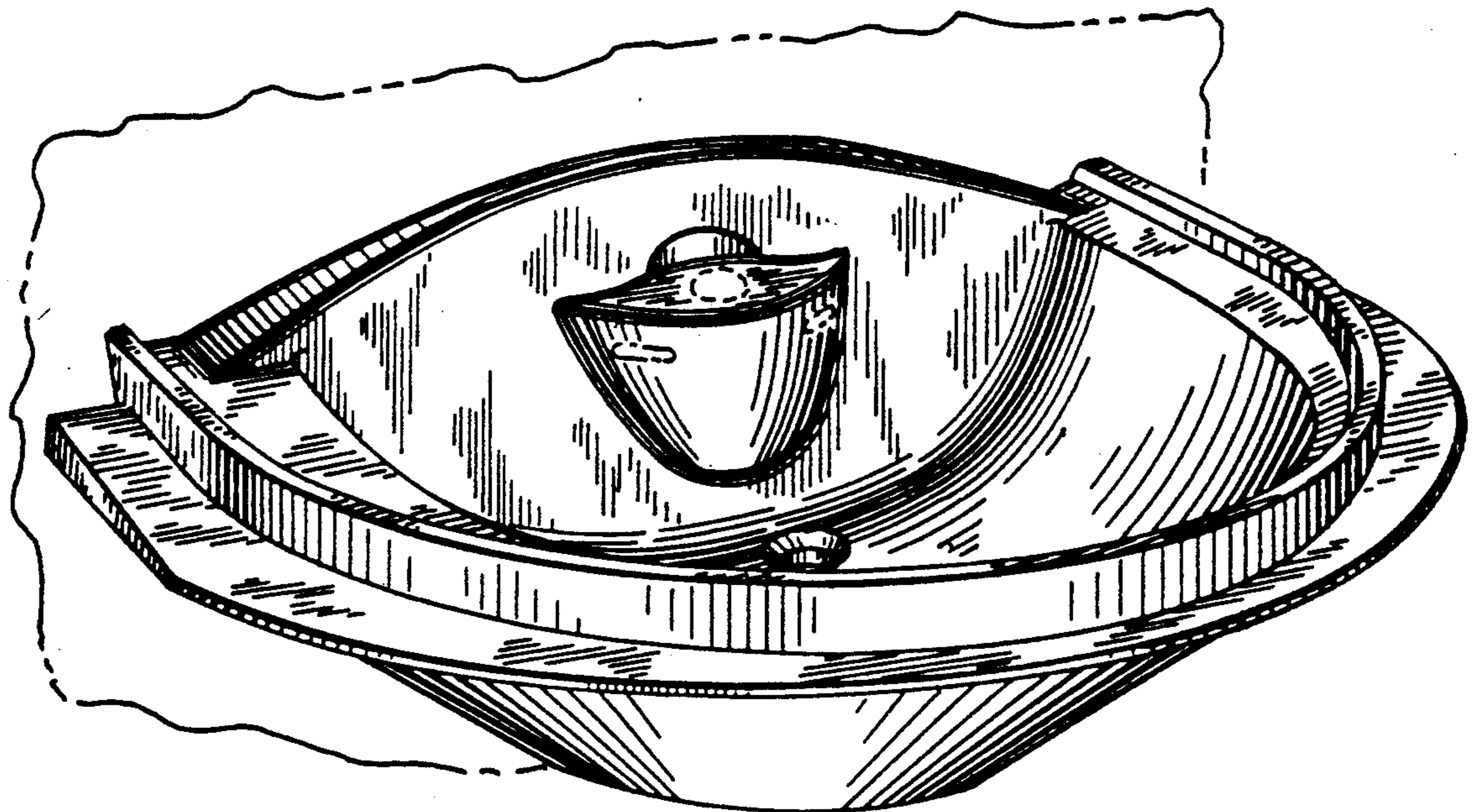
FIG. 1 is a perspective view taken from the top, front and left side of a lavatory showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof, the right side being a mirror image of the left side; FIG. 5 is a cross-sectional view taken on line 5-5 of FIG. 2; and, FIG. 6 is a cross-sectional view taken on line 6-6 of FIG. 2.

The fragmentary broken line representations of a bathroom wall in FIG. 1 and of openings in FIGS. 1, 2 and 6 are for the purpose of illustration only and form no part of the claimed design.

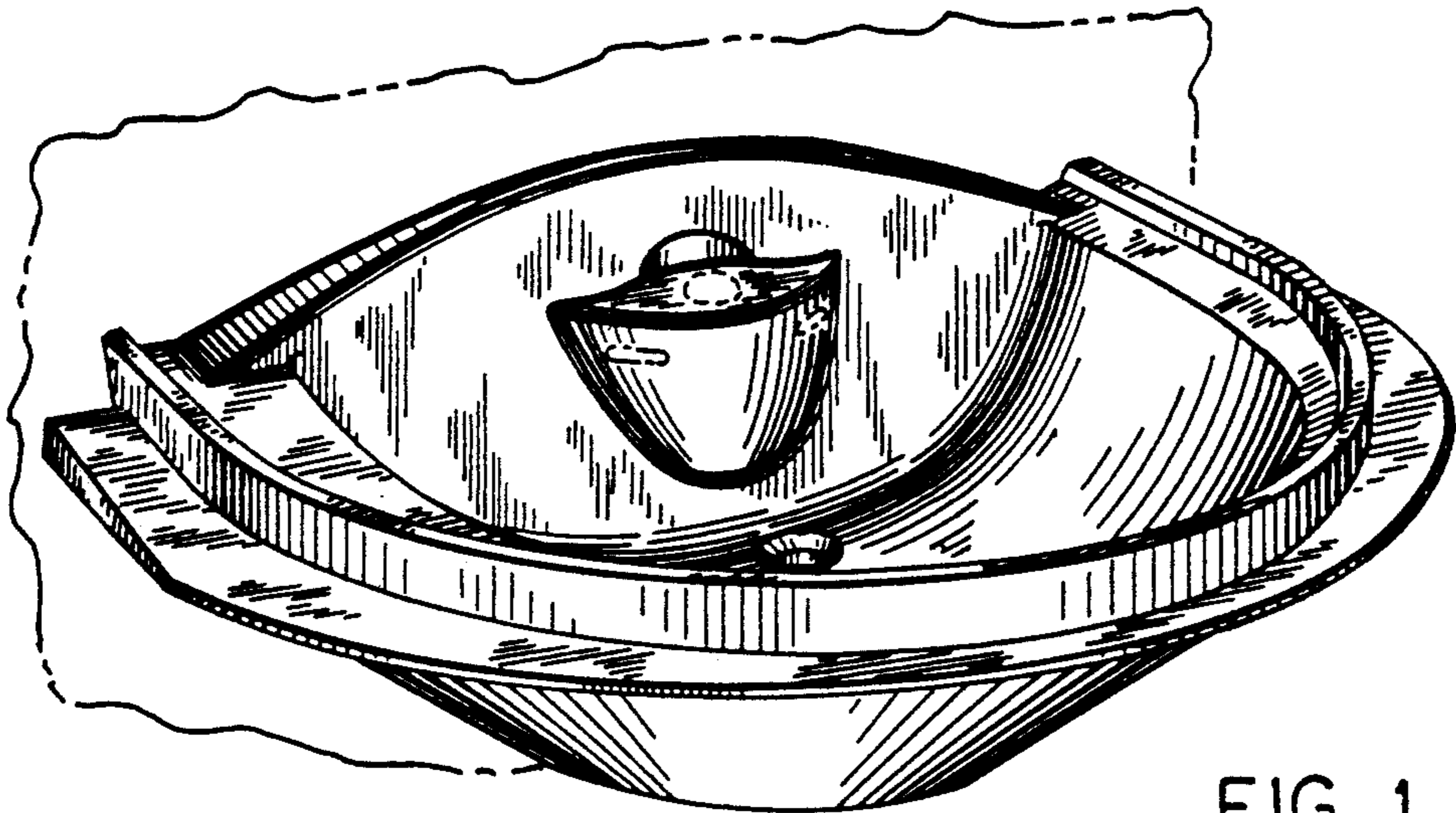

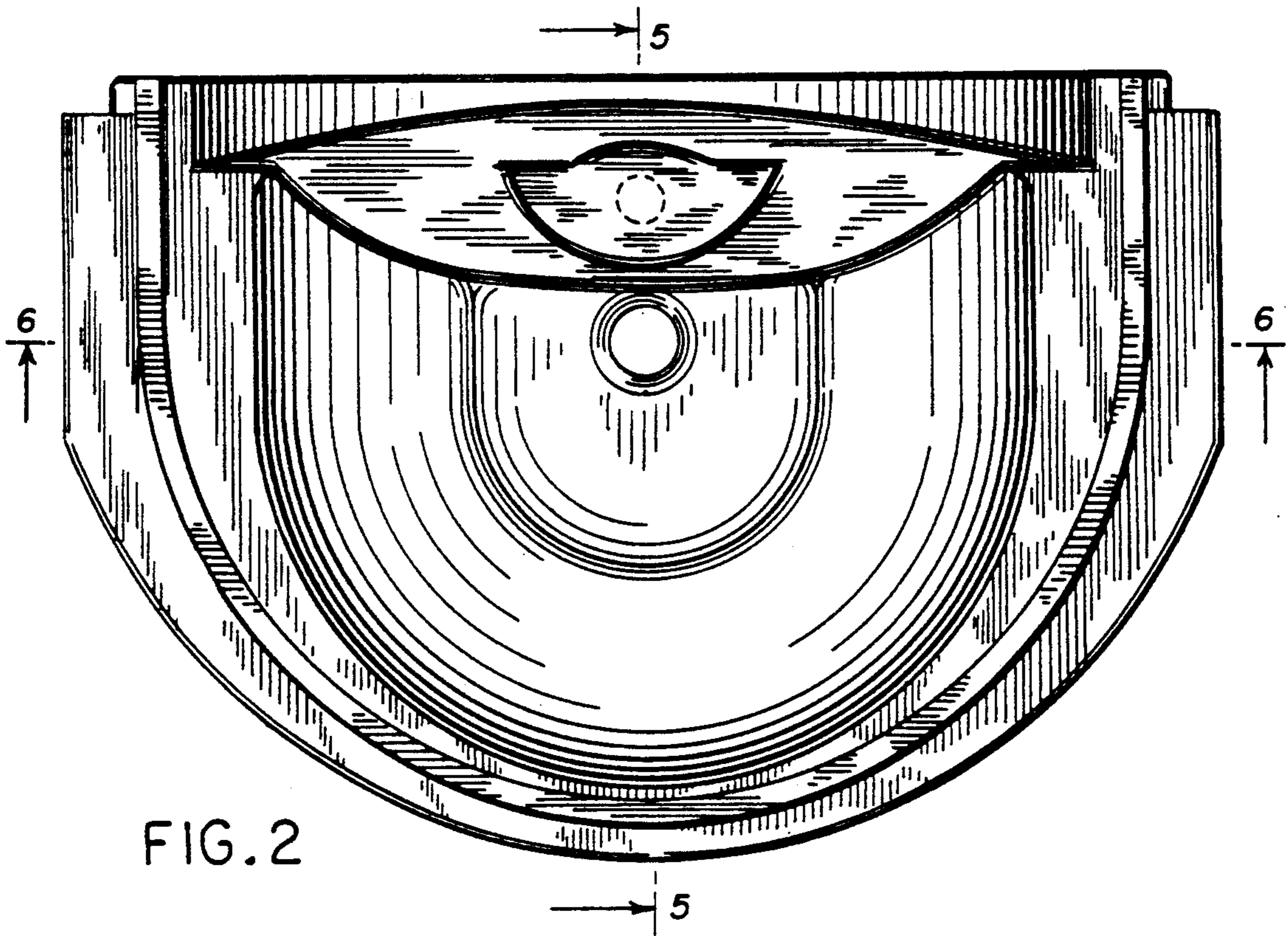

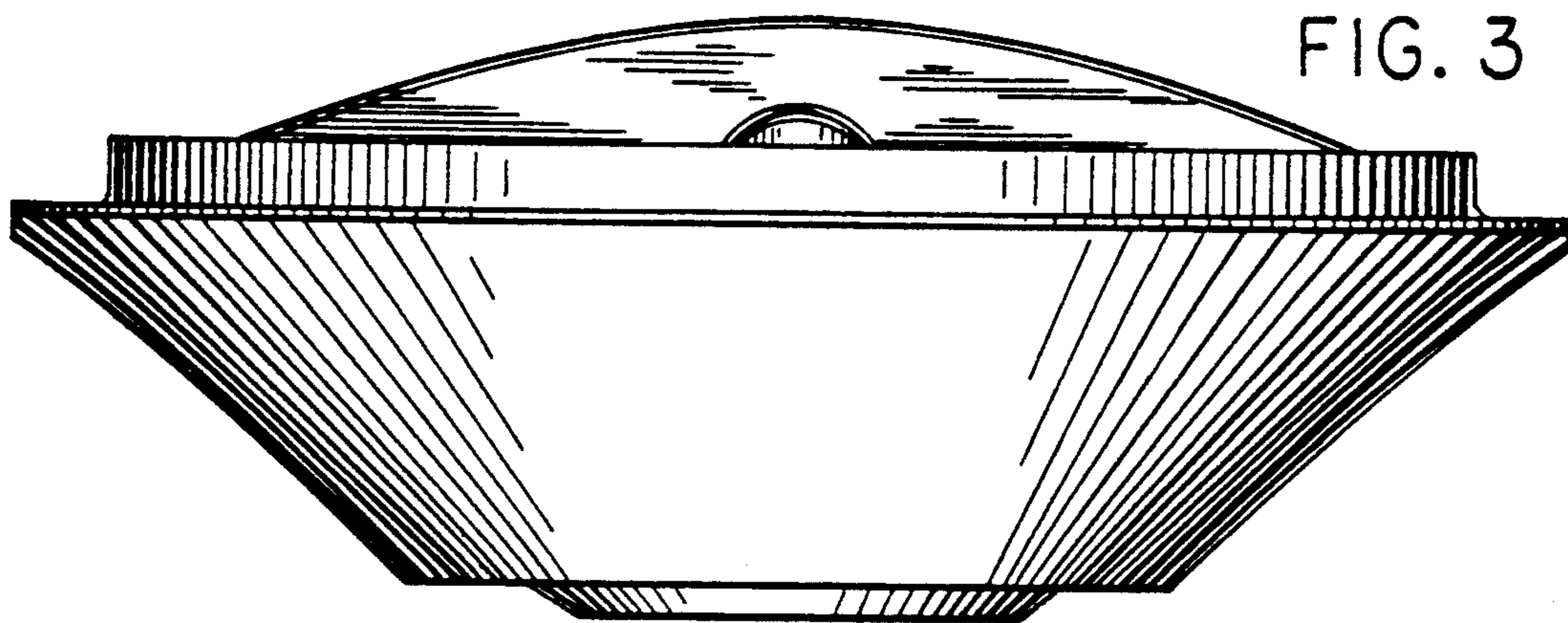

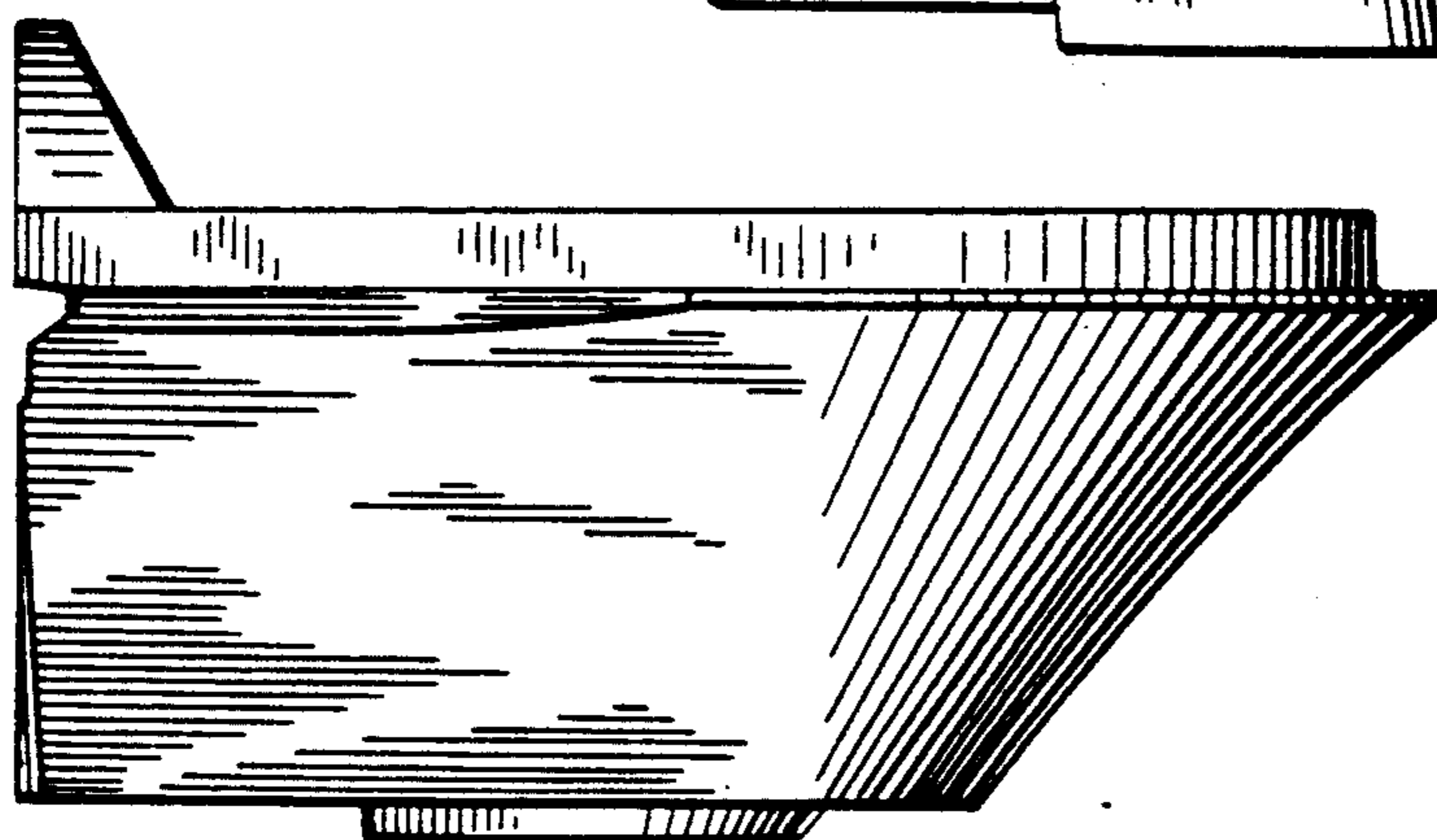
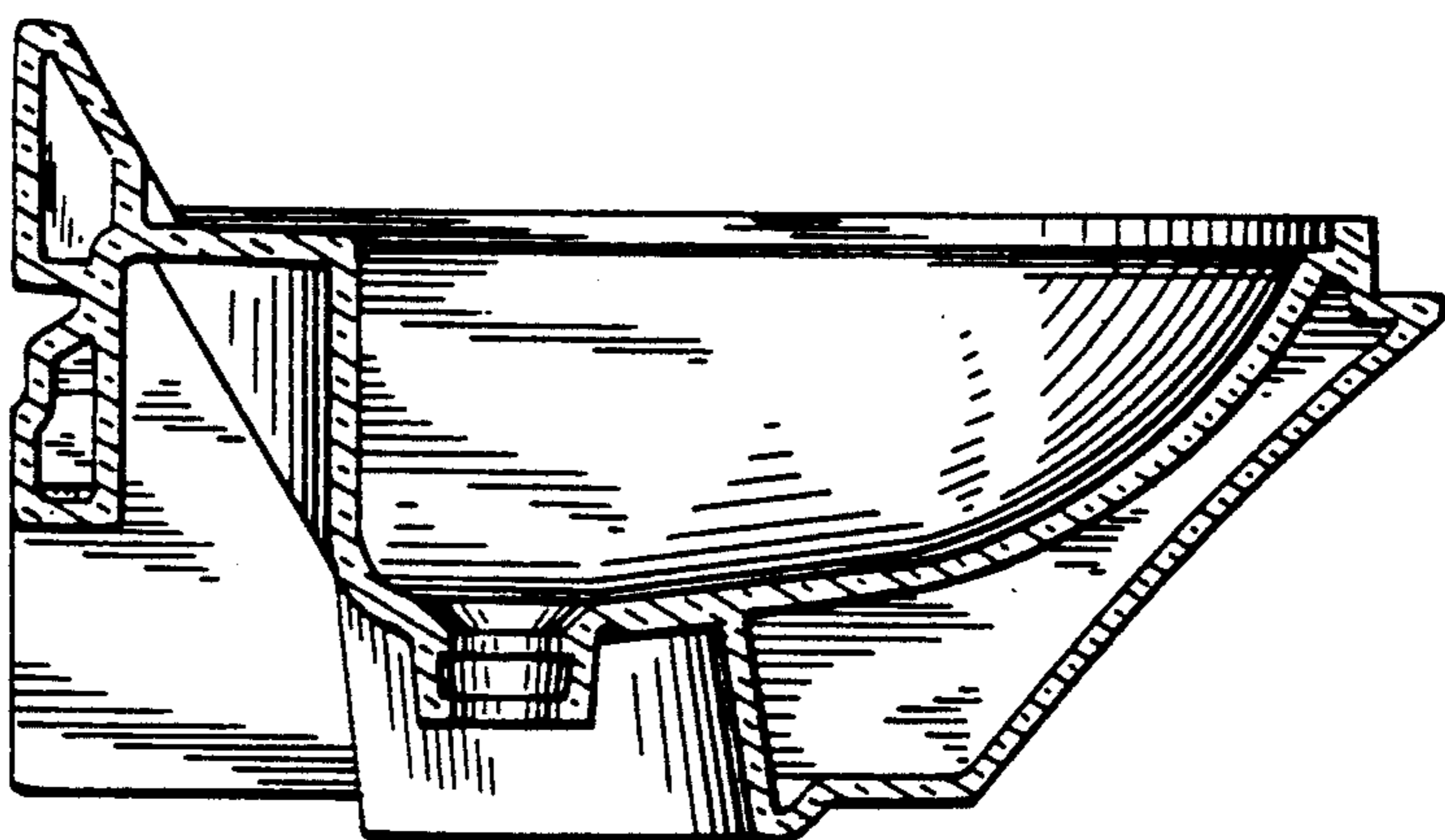

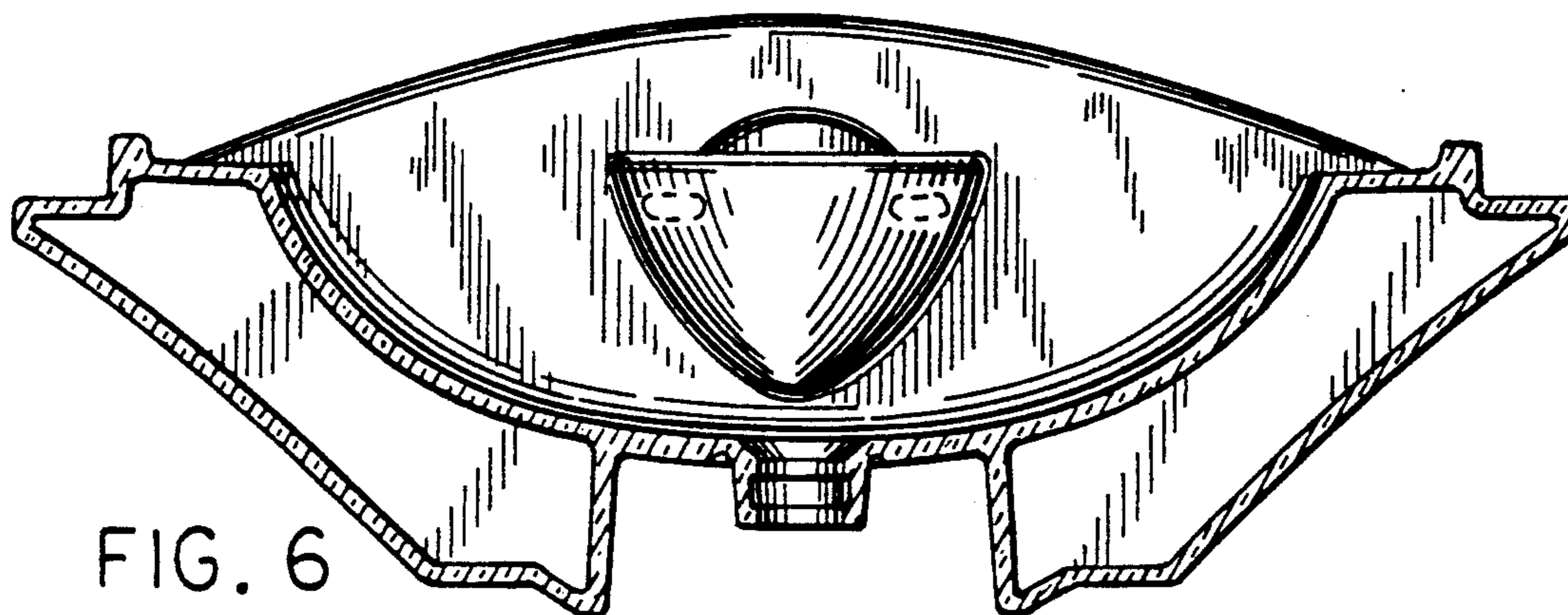
