[57] CLAIM

The ornamental design for a child's training toilet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a child's training toilet and showing our design;
FIG. 2 is a top view thereof;
FIG. 3 is front elevational view, thereof;
FIG. 4 is a right side elevational view thereof, the left side being a mirror image of the right side;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front perspective view thereof showing the legs in a folded position;
FIG. 8 is a top view of FIG. 7;
FIG. 9 is a front elevational view of FIG. 7;
FIG. 10 is a right side elevational view of FIG. 7, the left side being a mirror image of the right side;
FIG. 11 is a rear elevational view of FIG. 7; and,
FIG. 12 is a bottom view of FIG. 7.

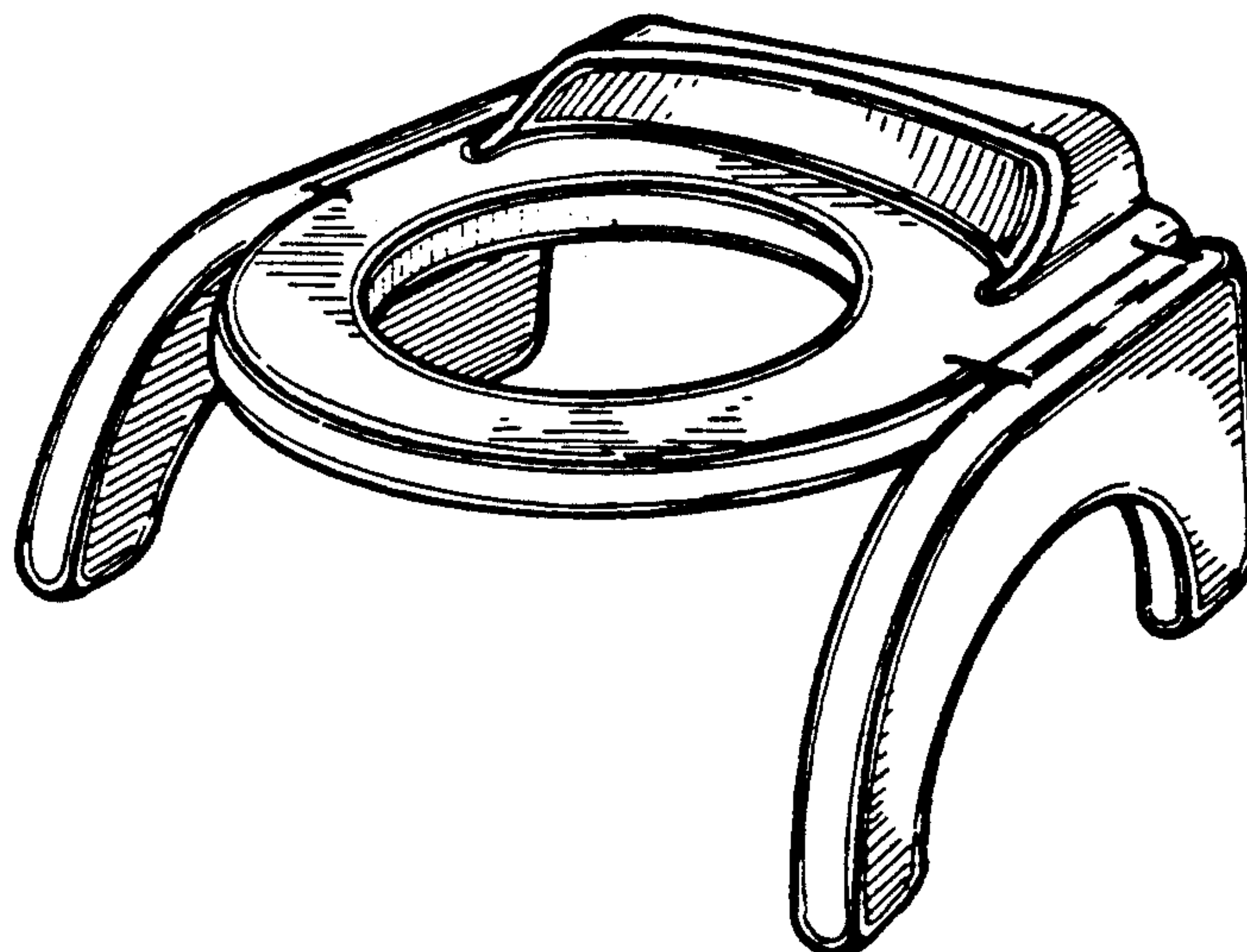

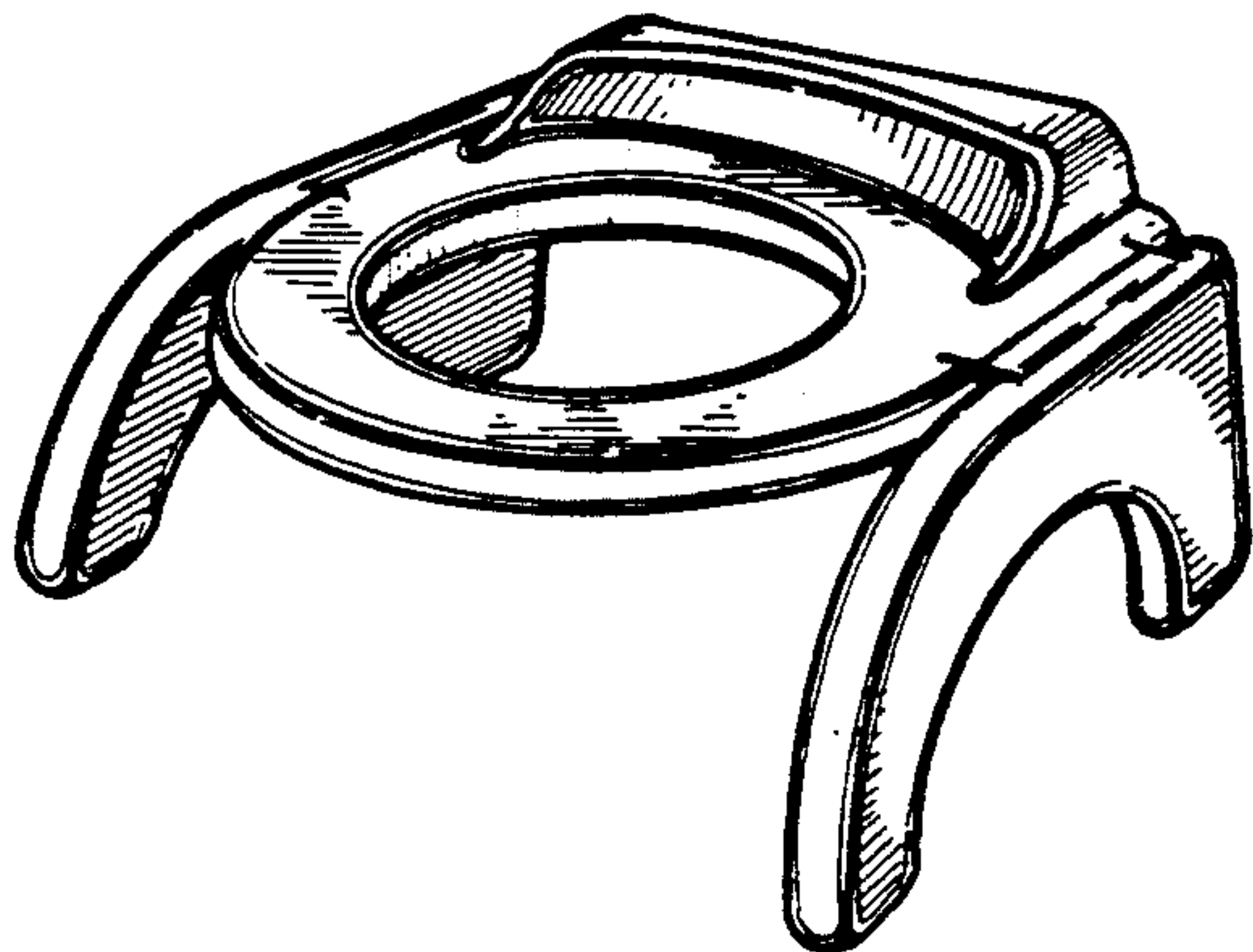

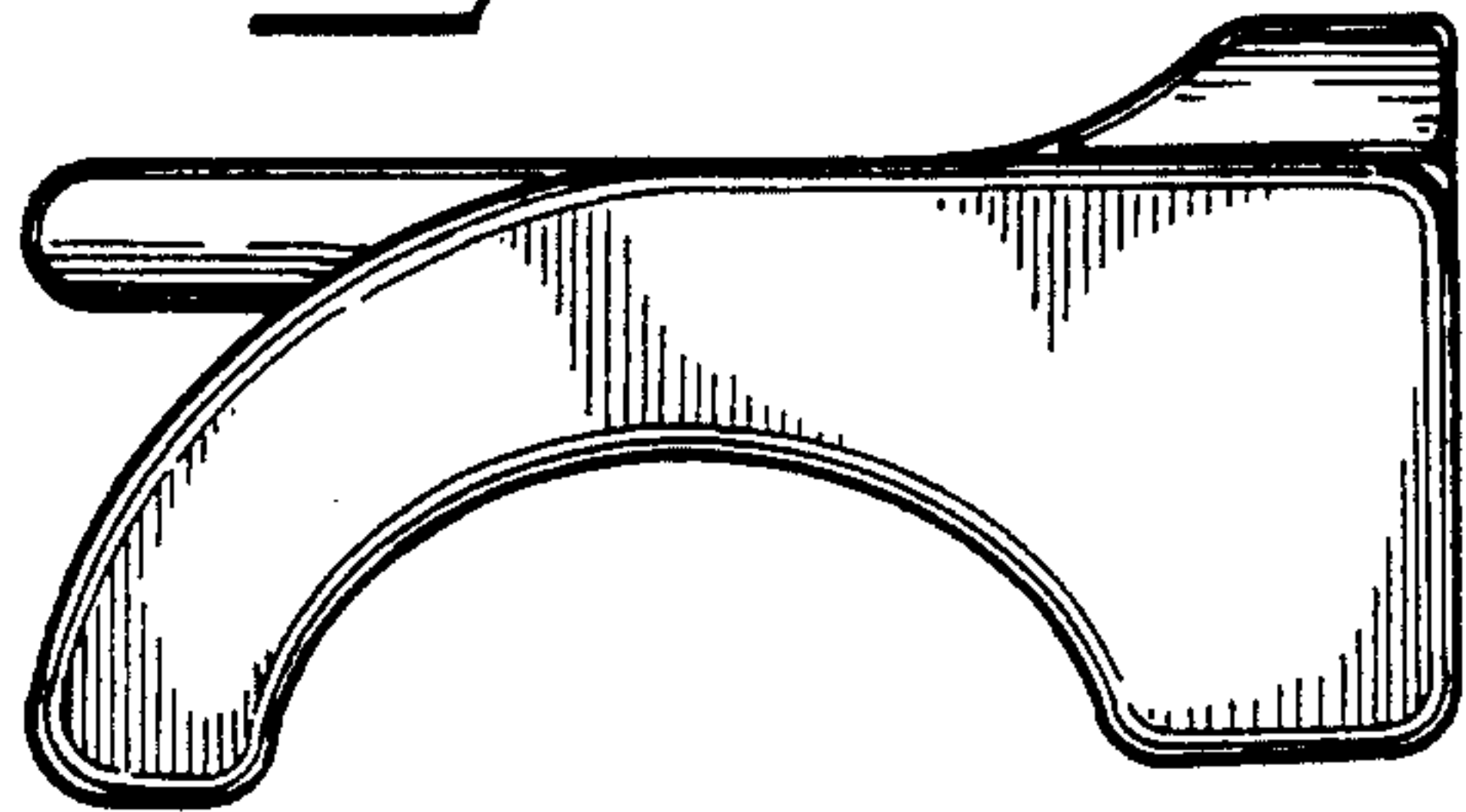

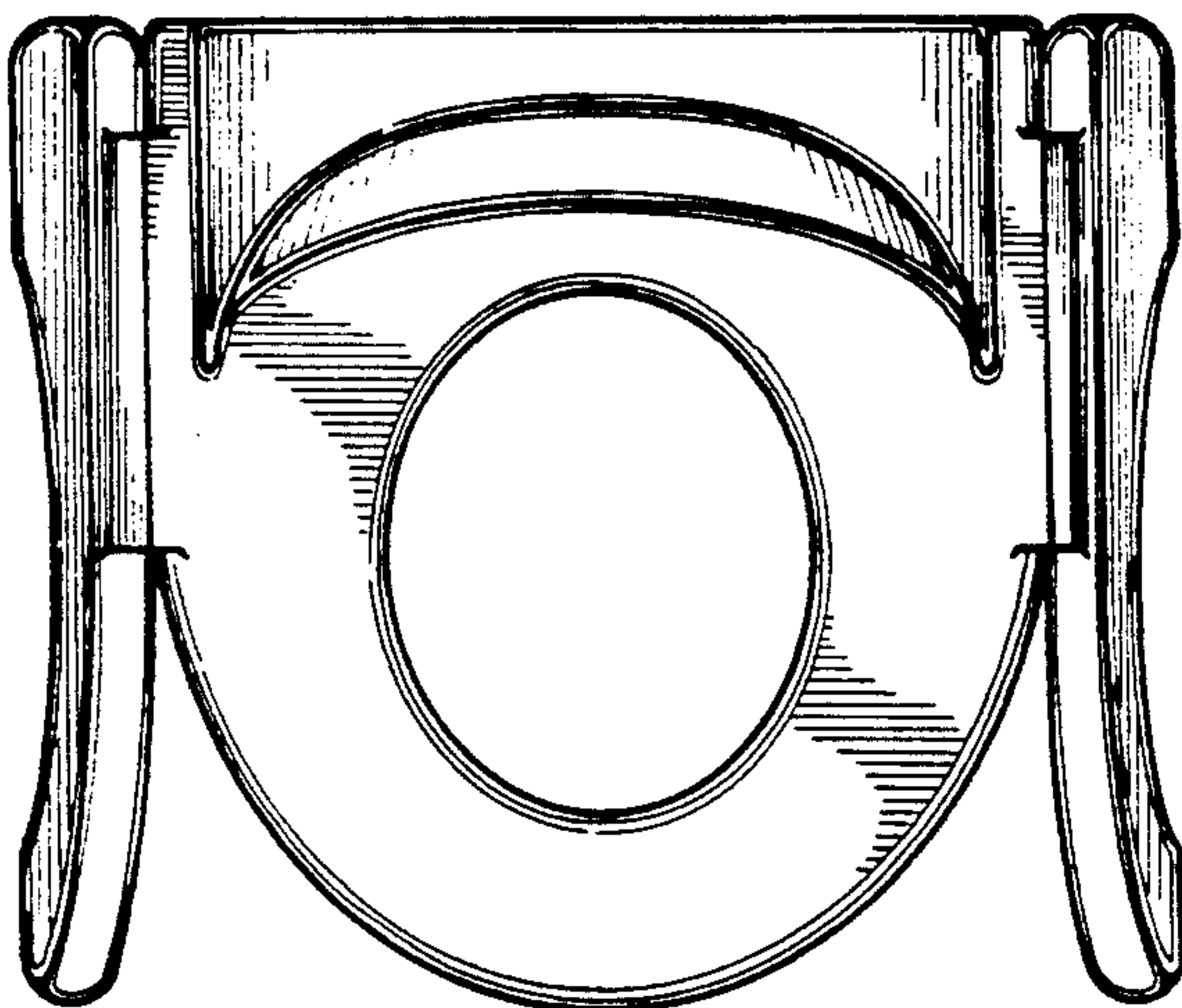

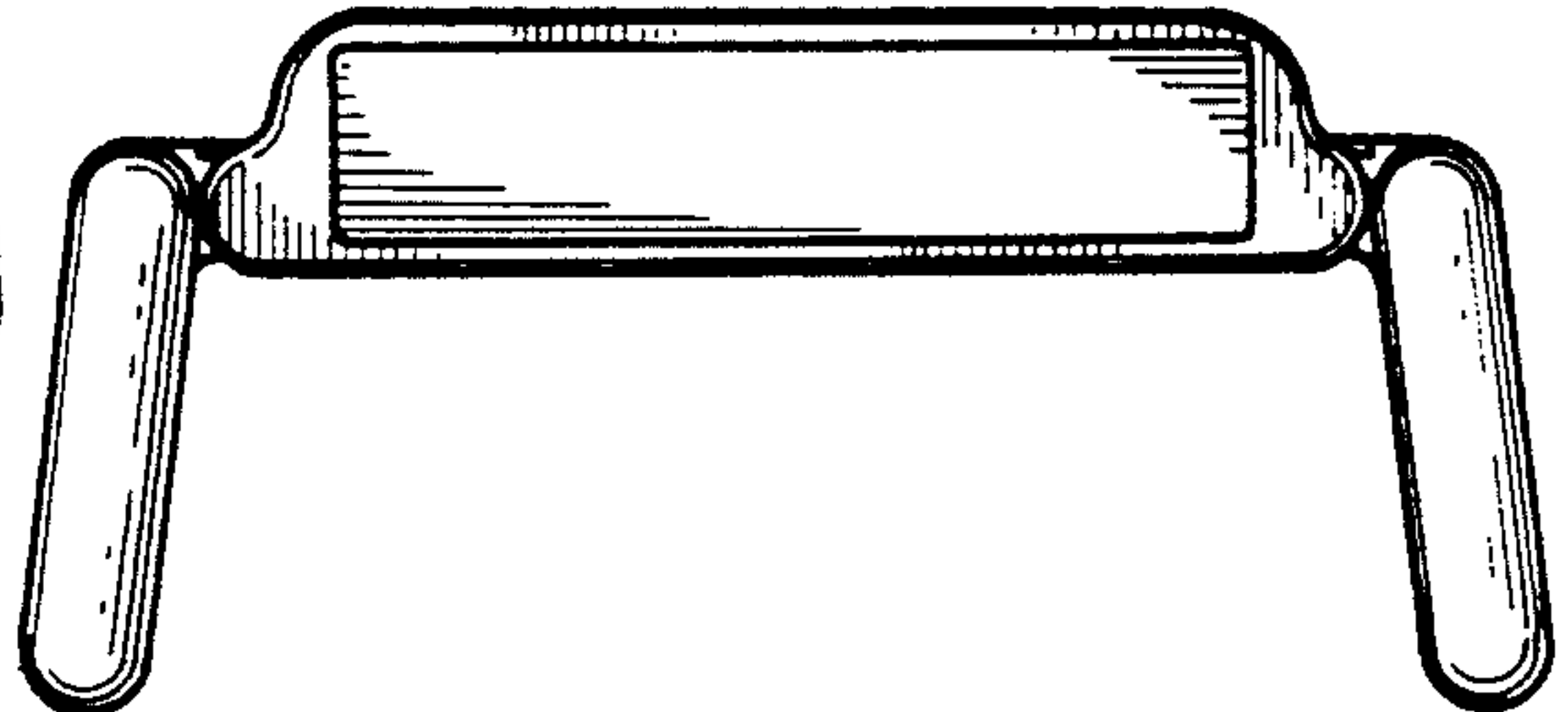

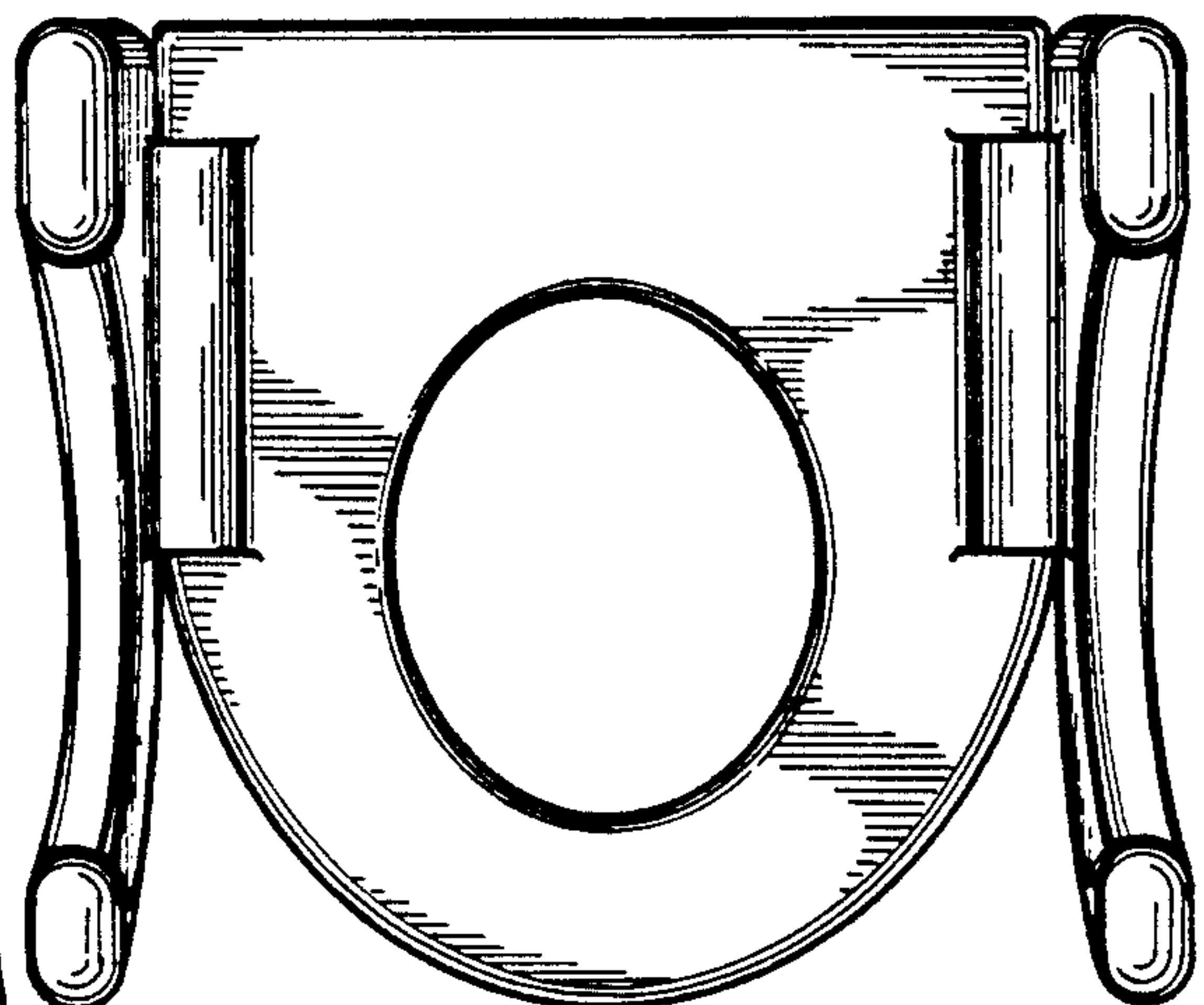

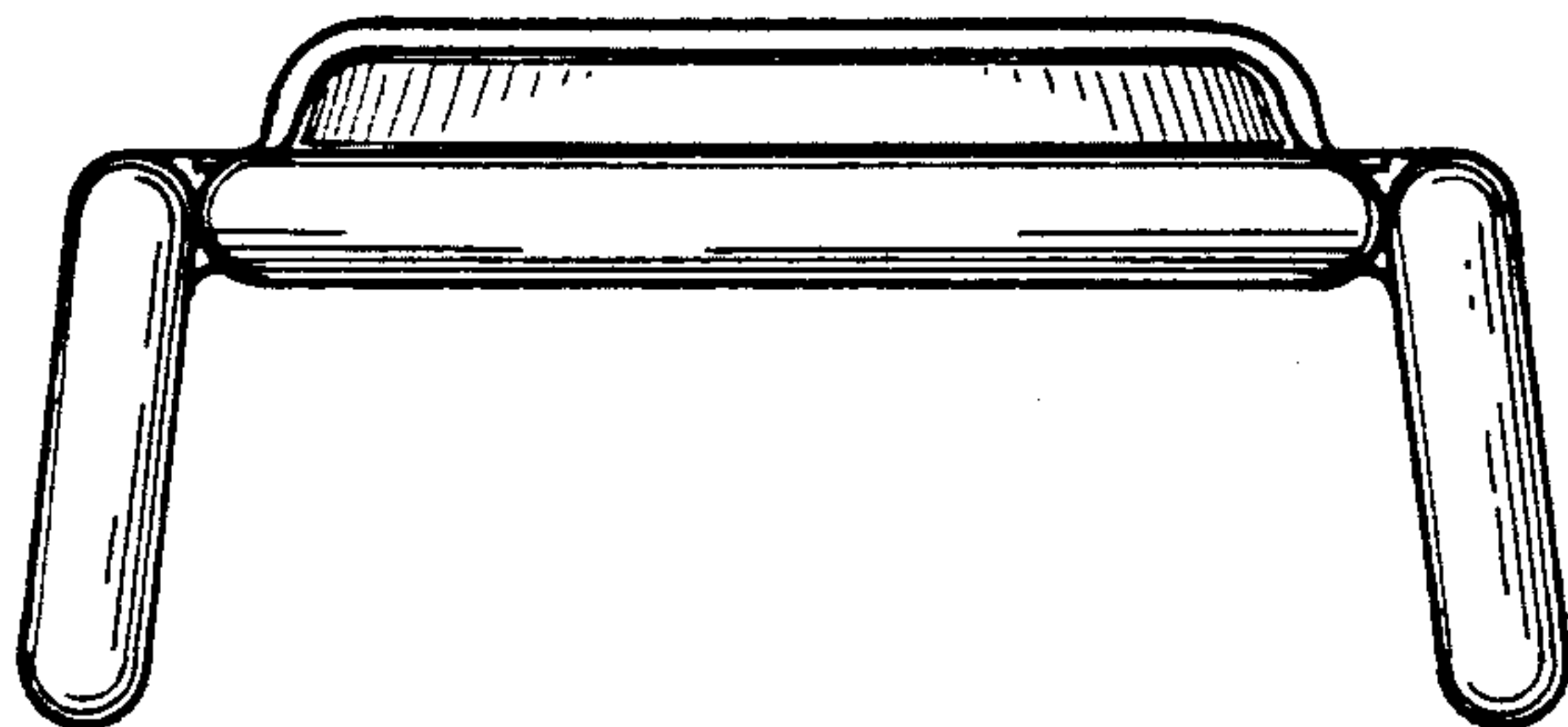

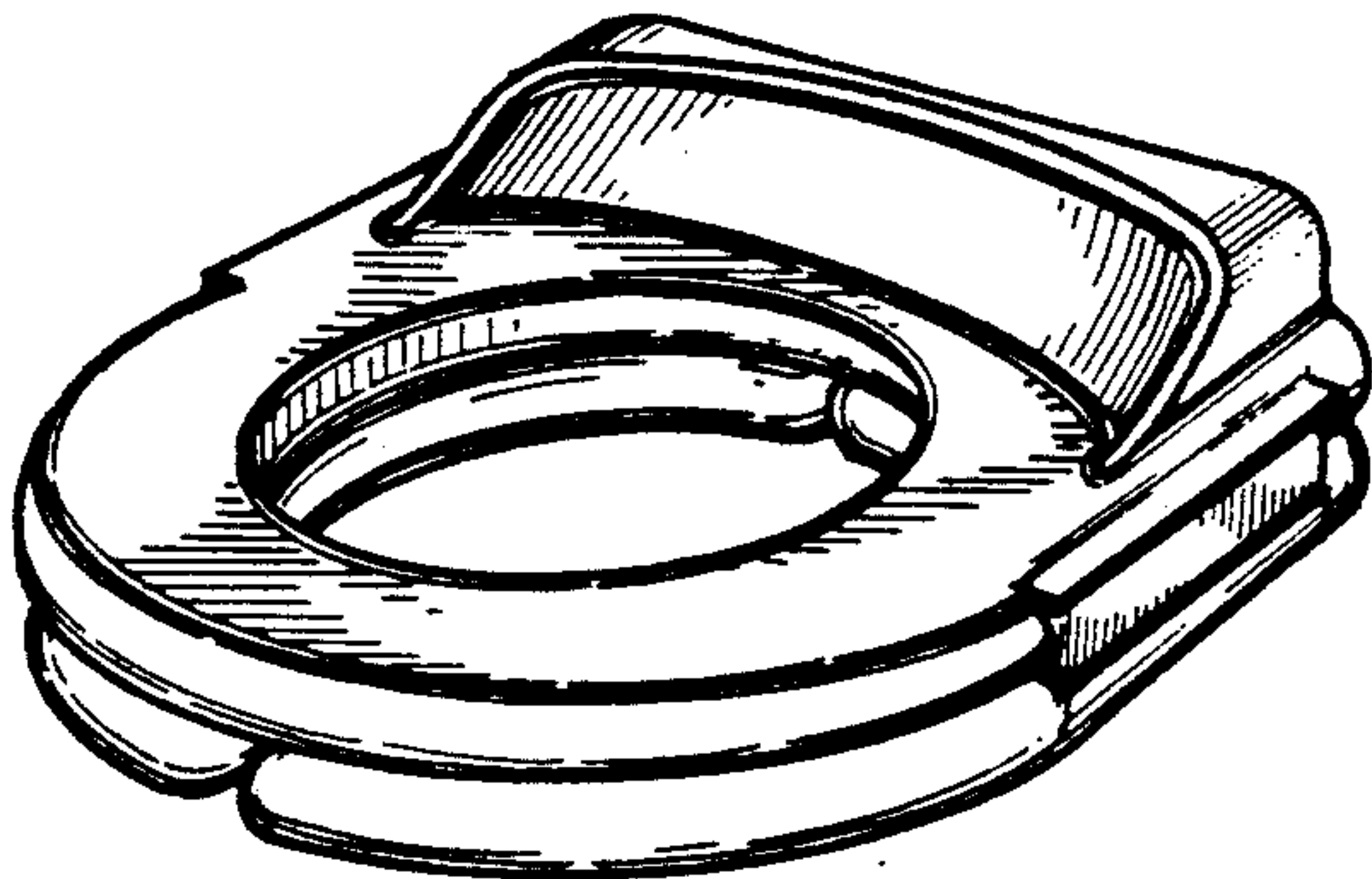

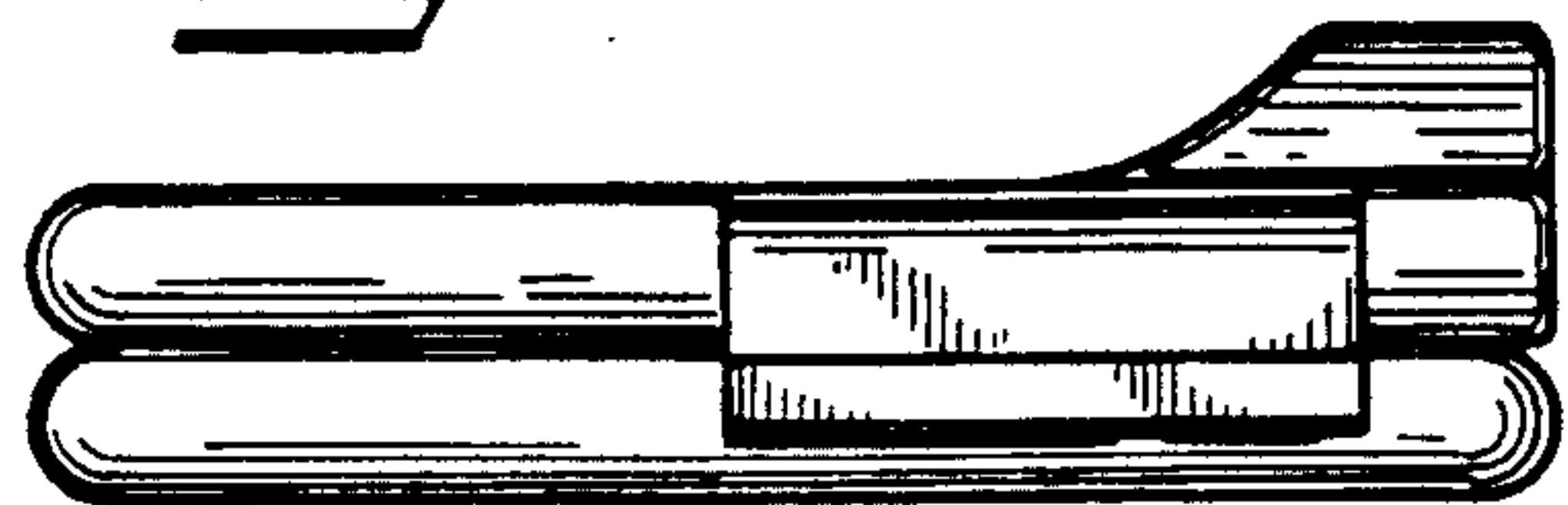

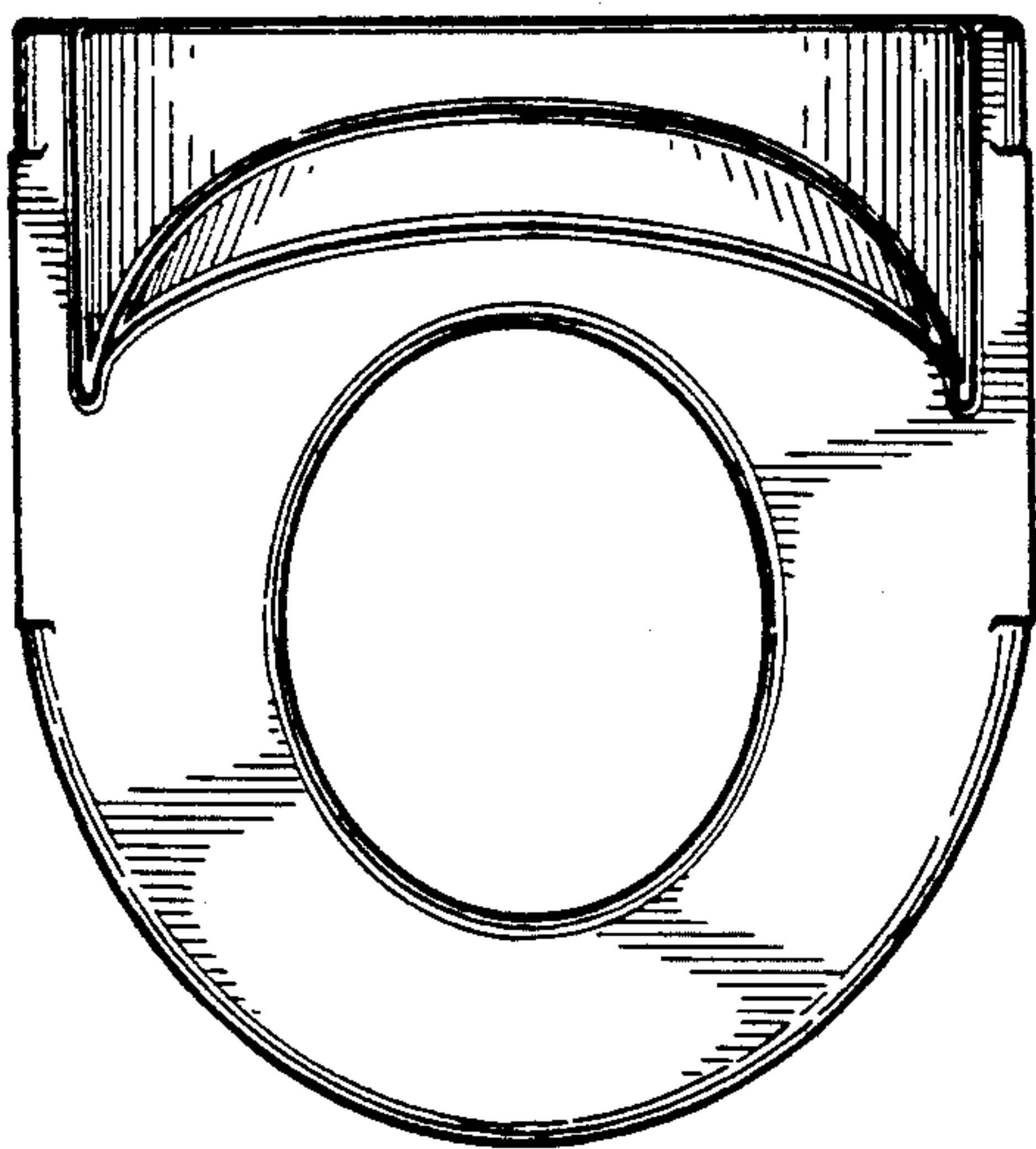

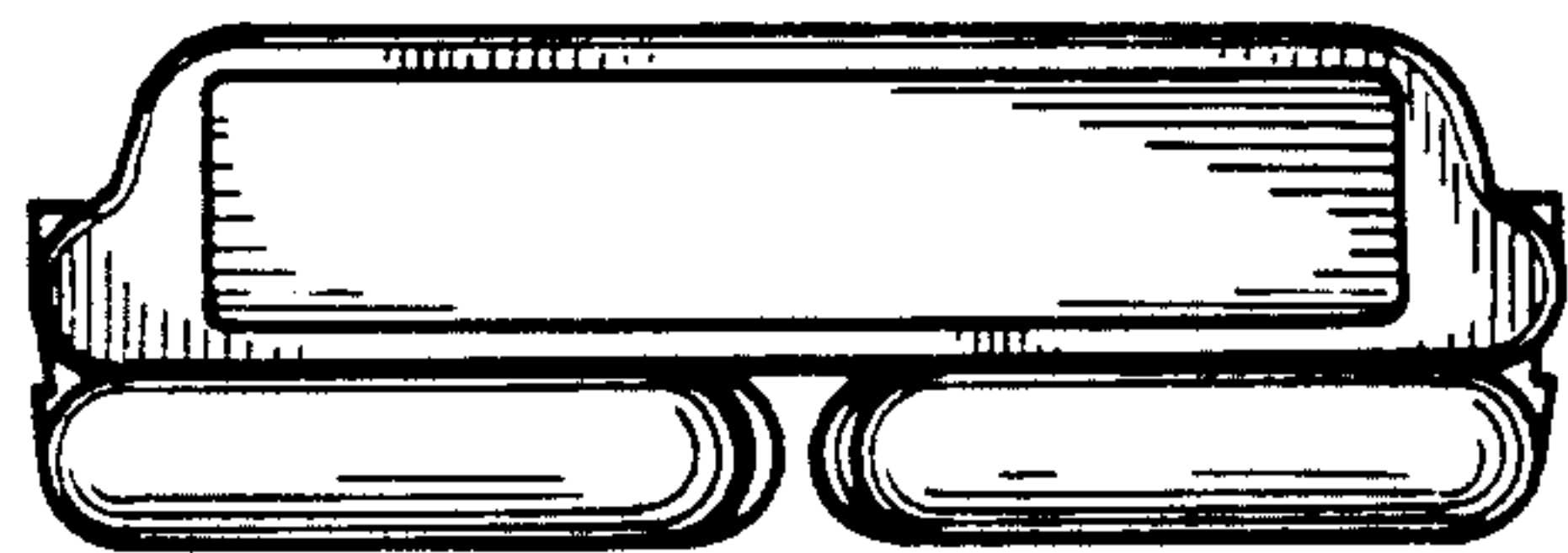

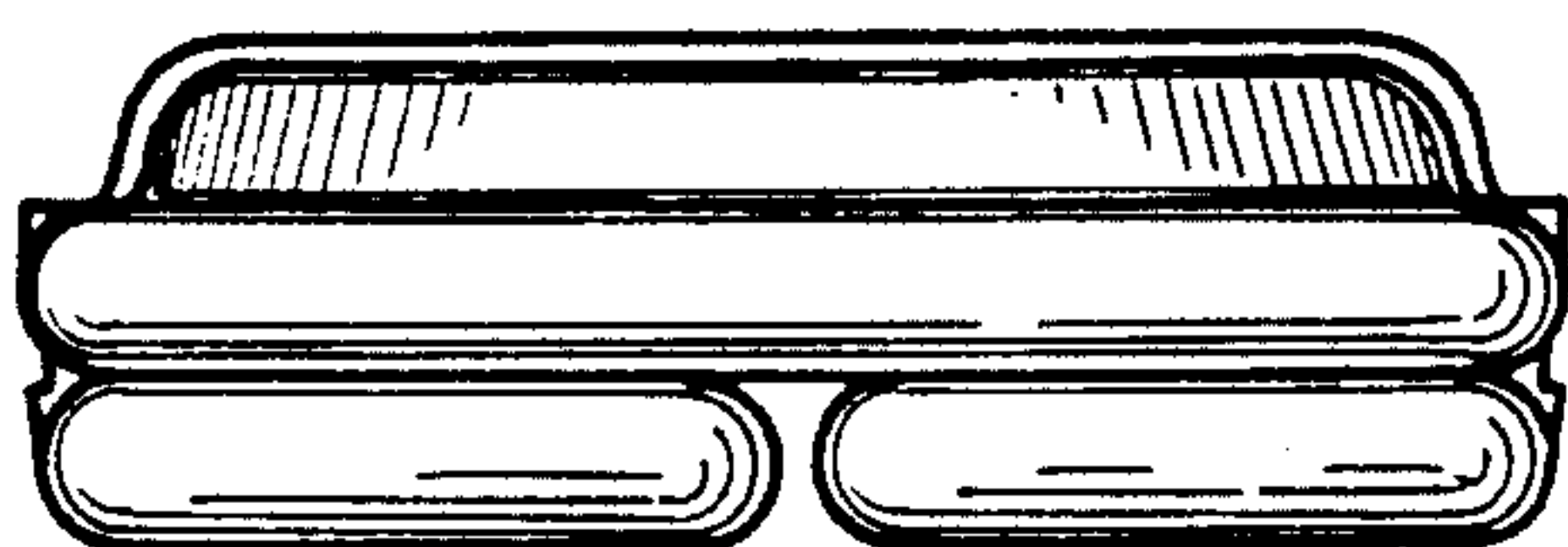
