FIG. 5 is a perspective view of the ladder top shown in FIG. 3.

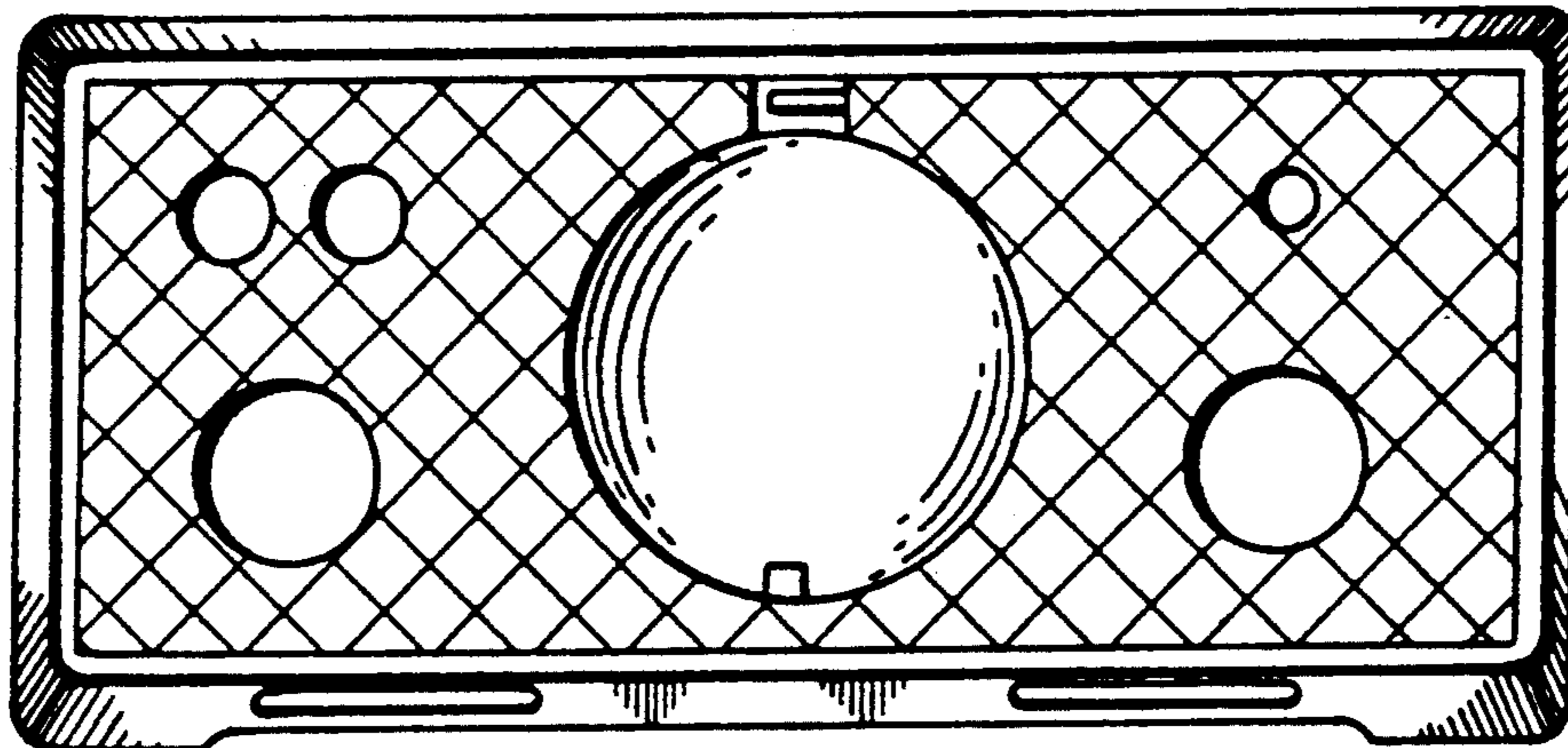

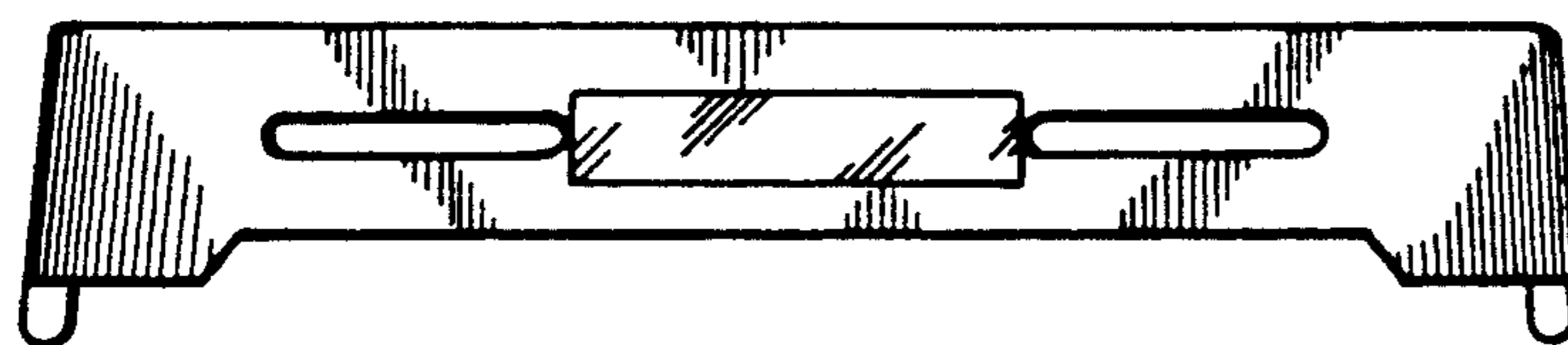
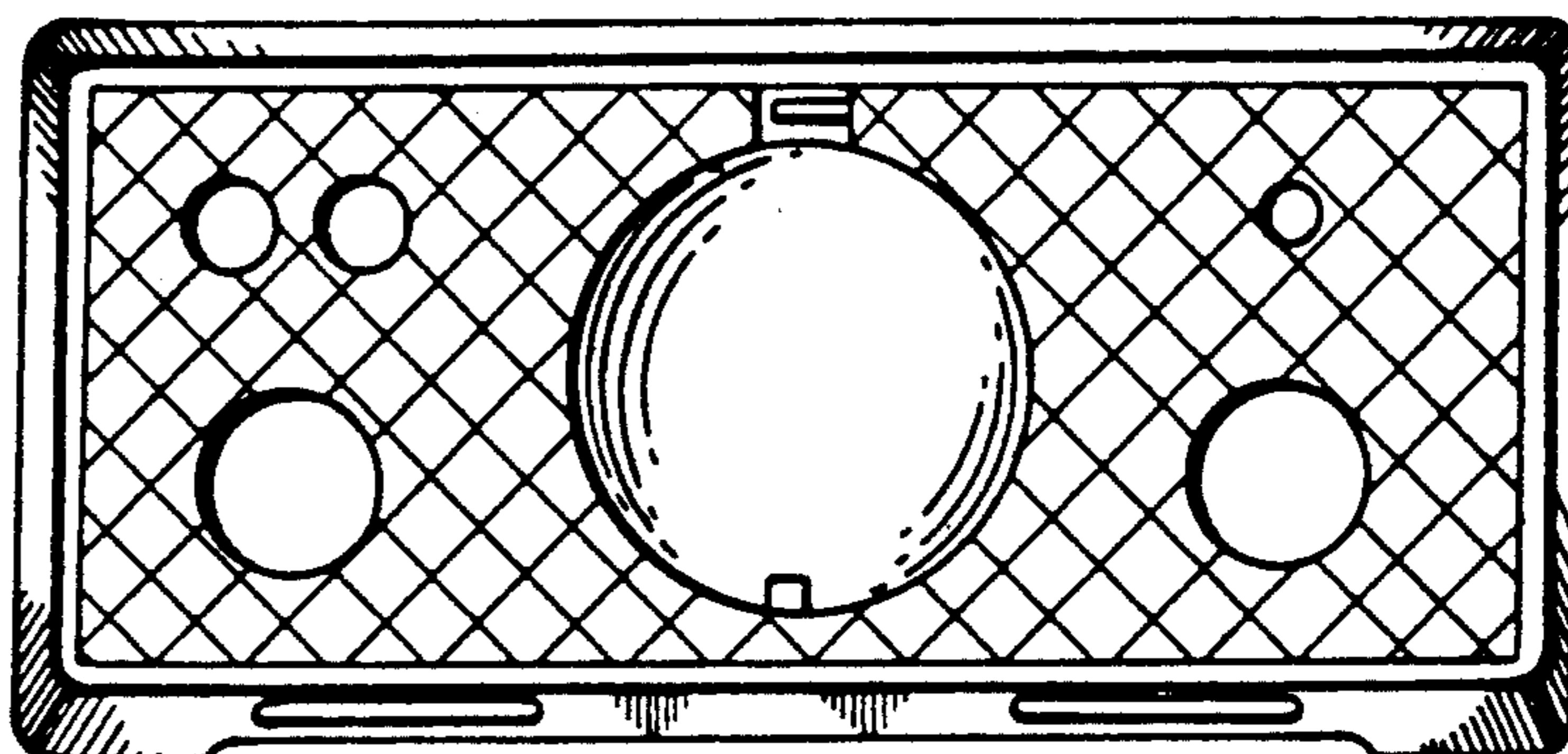

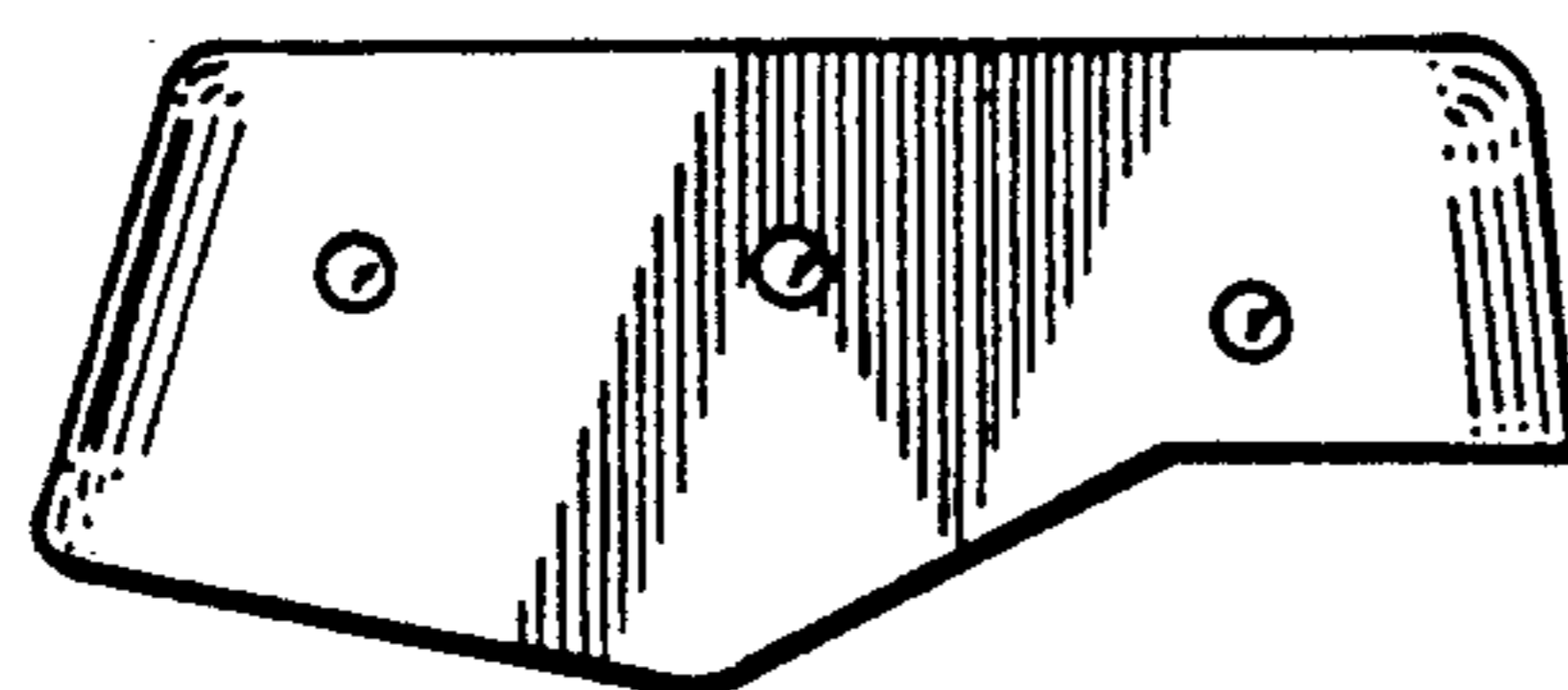
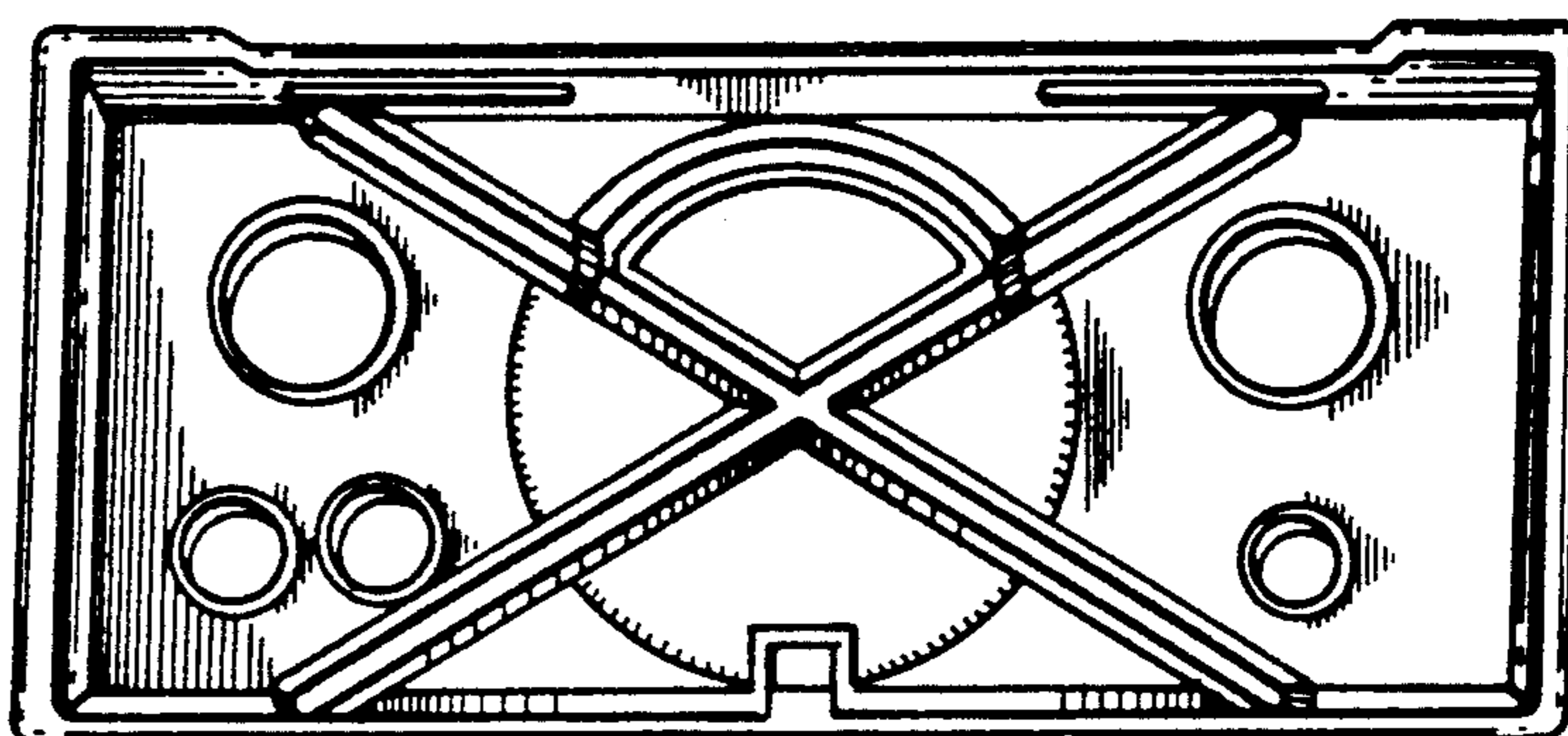

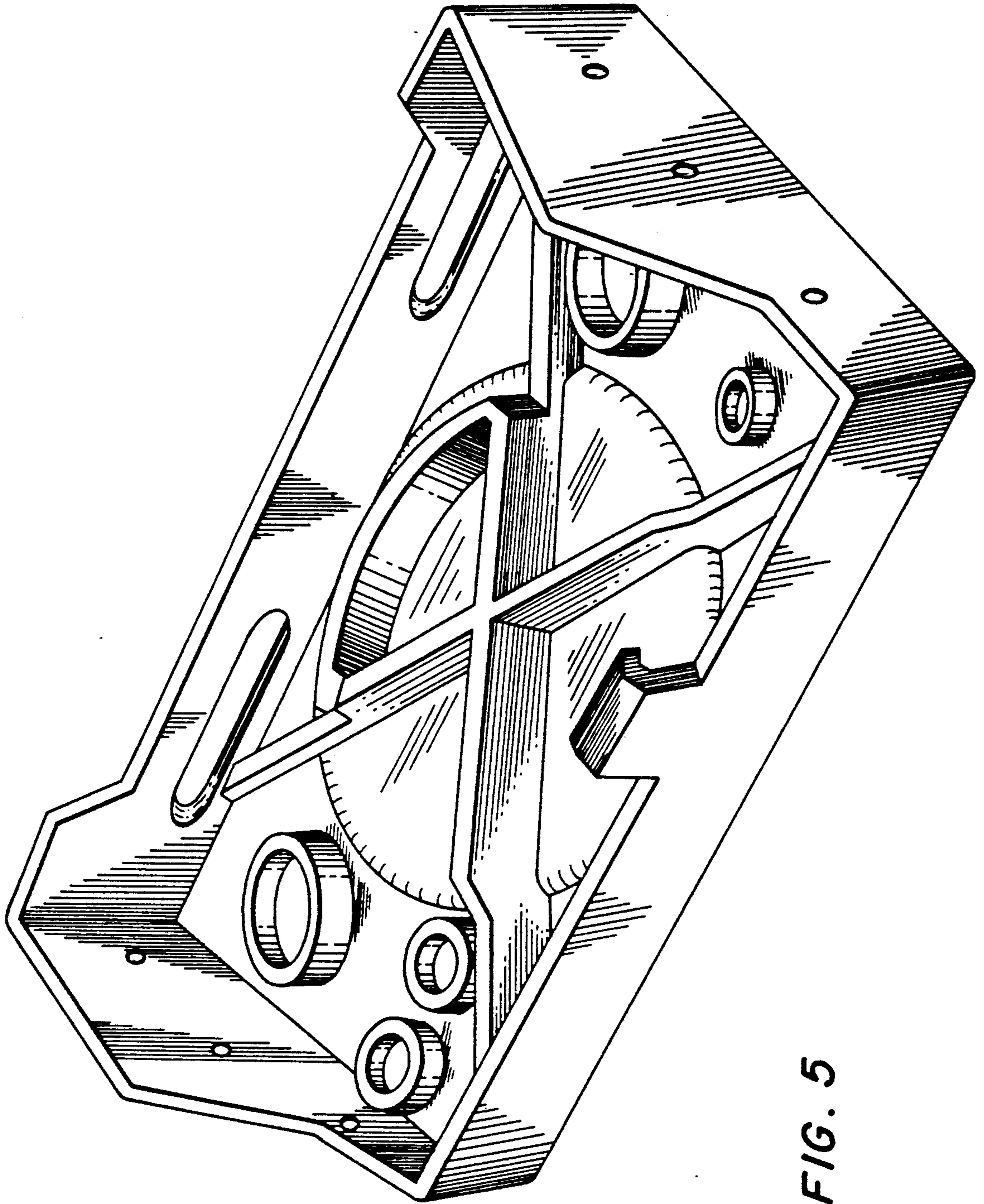
