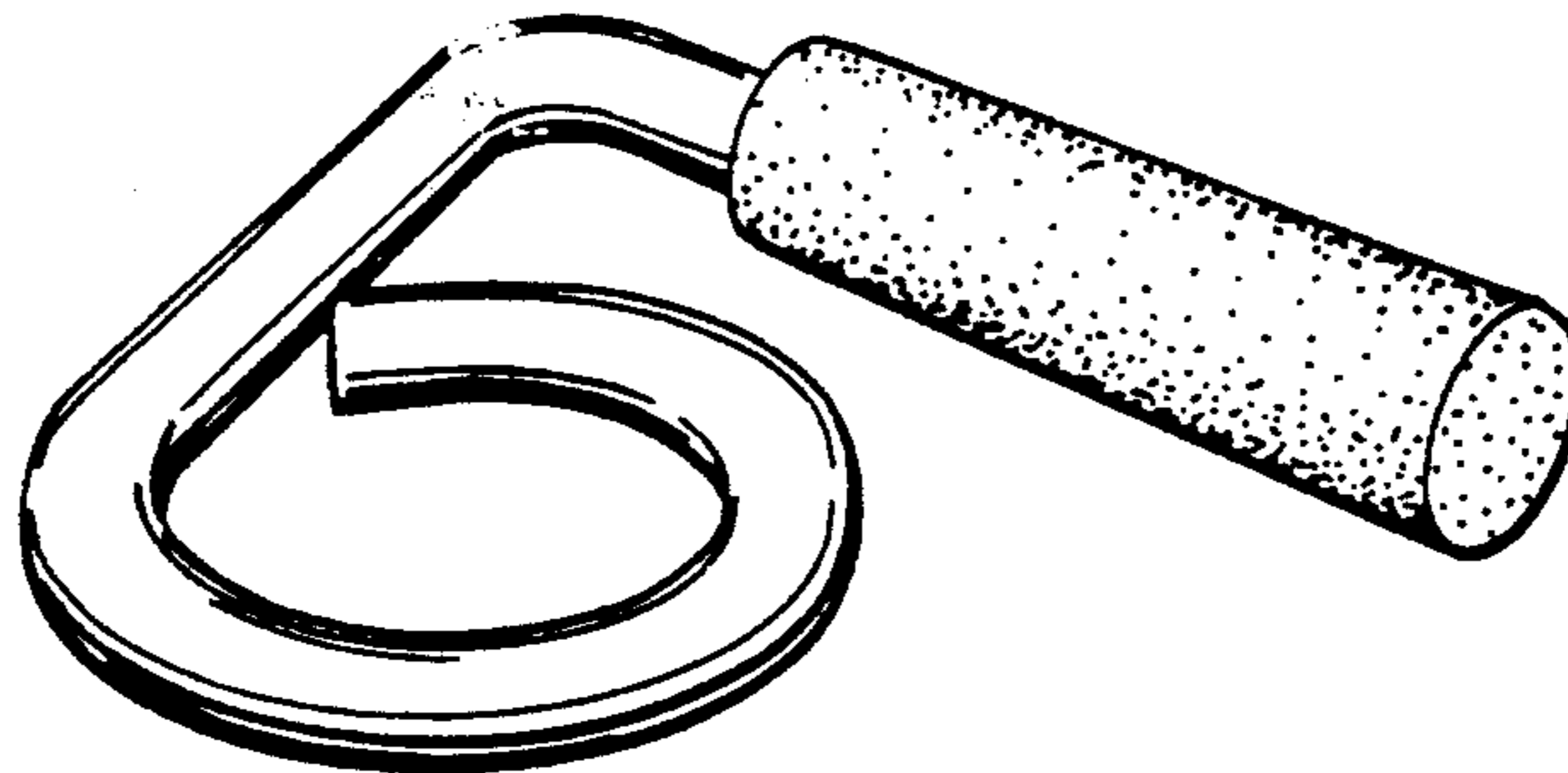

[57] **CLAIM**

The ornamental design for a bottle lifter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle lifter showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a perspective view of an alternative embodiment of the bottle lifter of FIG. 1;  
 FIG. 8 is a top plan view thereof;  
 FIG. 9 is a front elevational view thereof, the rear elevational view being a mirror image;  
 FIG. 10 is a right side elevational view thereof;  
 FIG. 11 is a left side elevational view thereof; and,  
 FIG. 12 is a bottom plan view thereof.



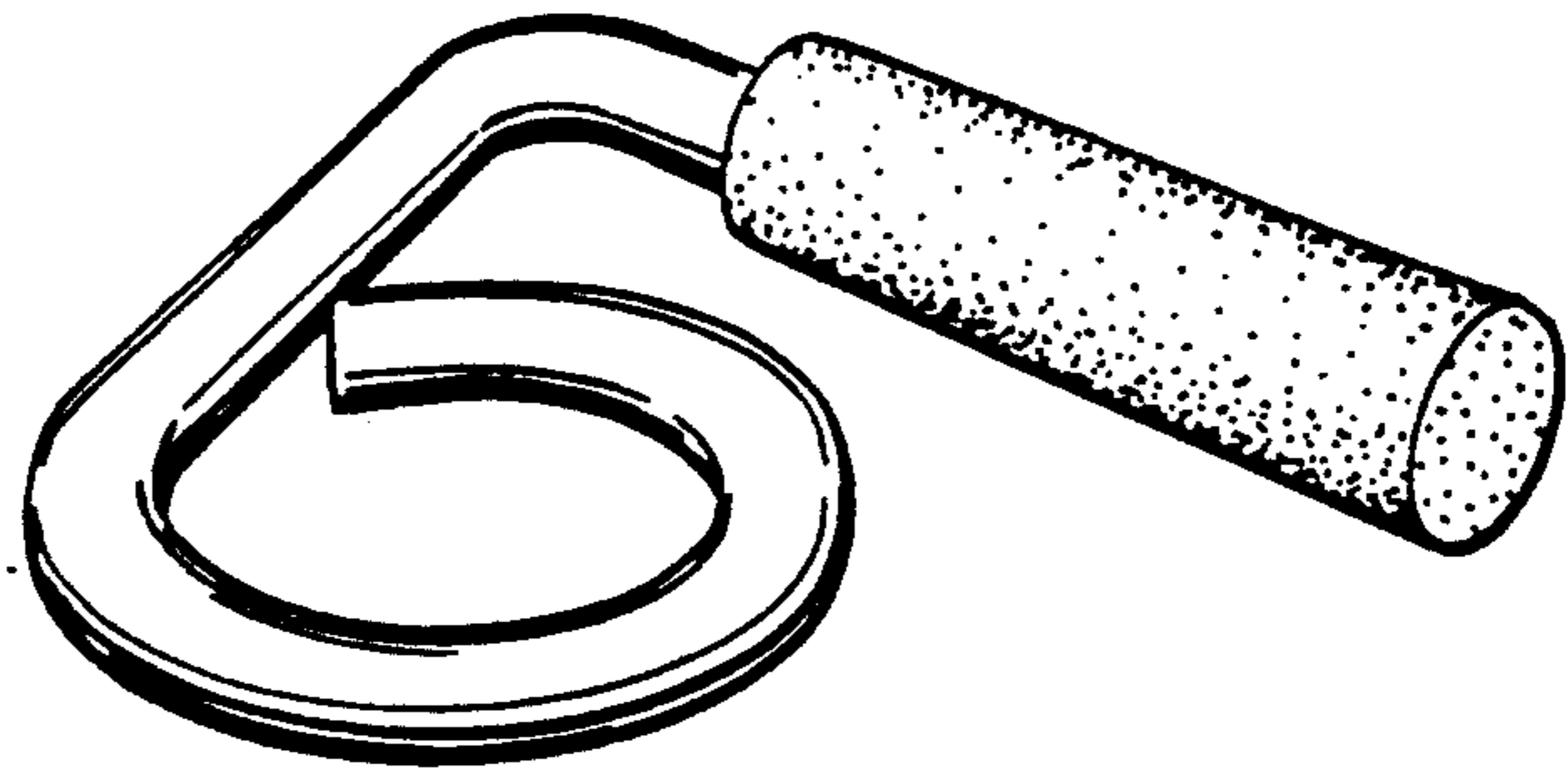

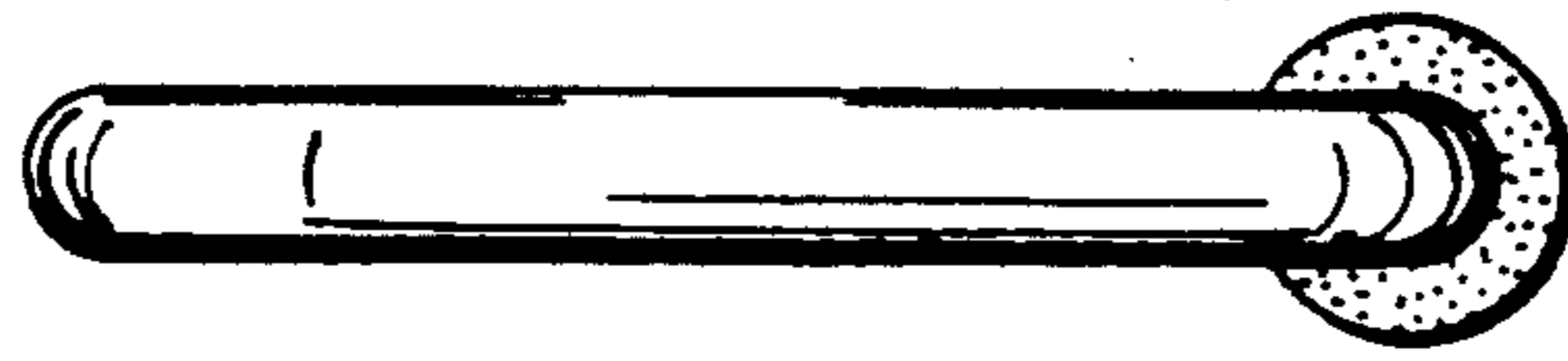

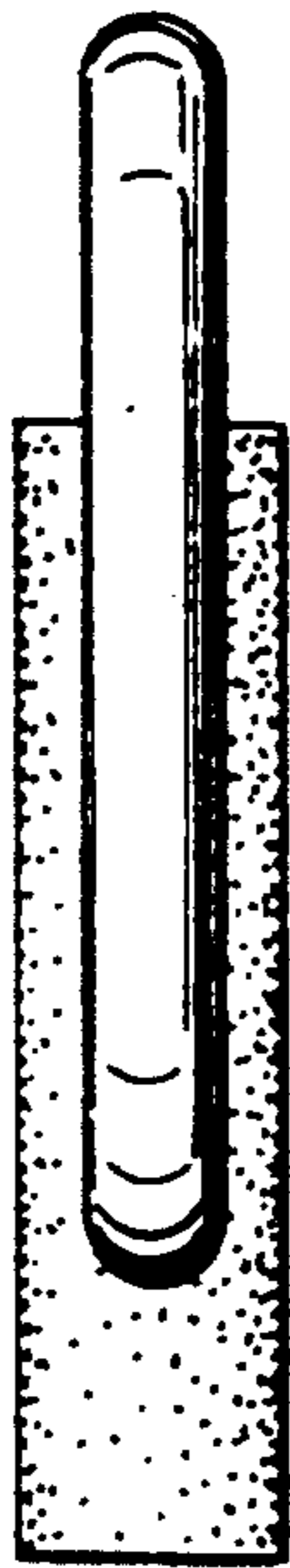

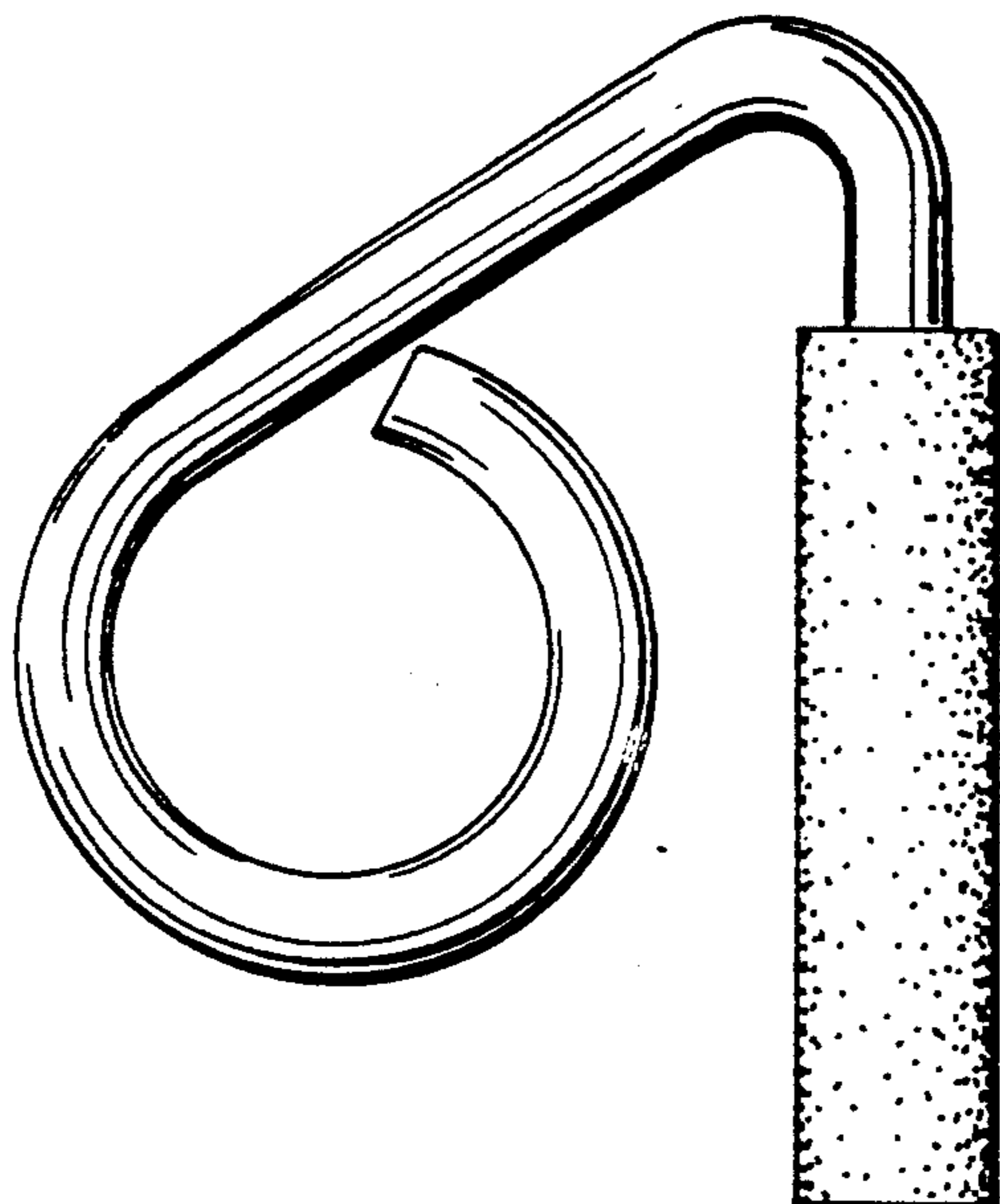

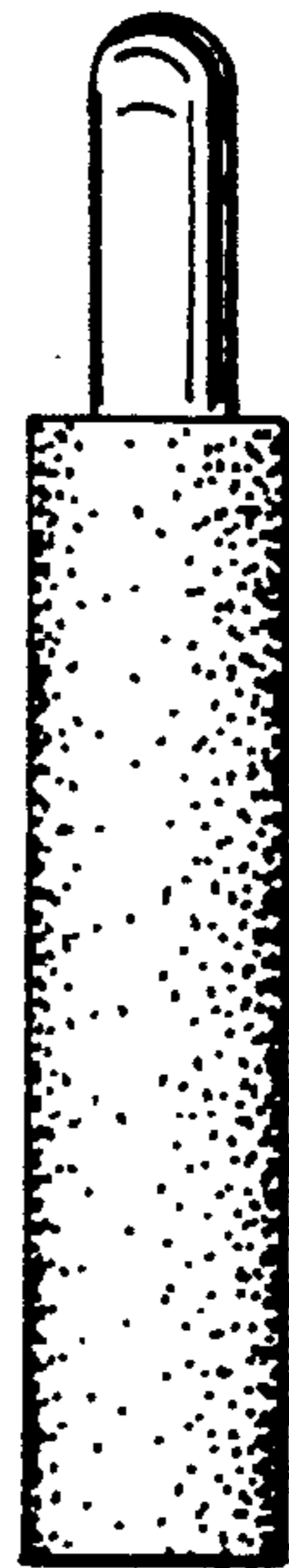

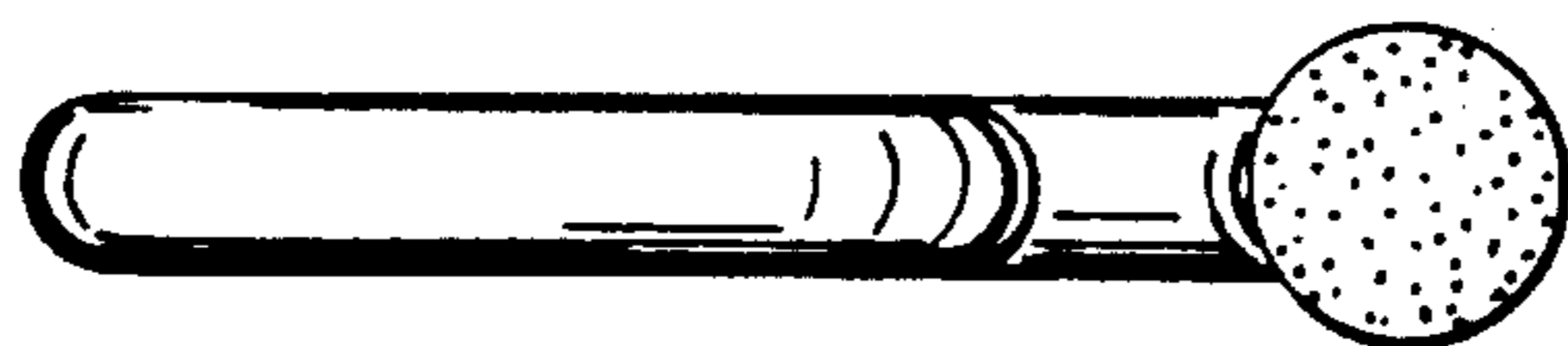

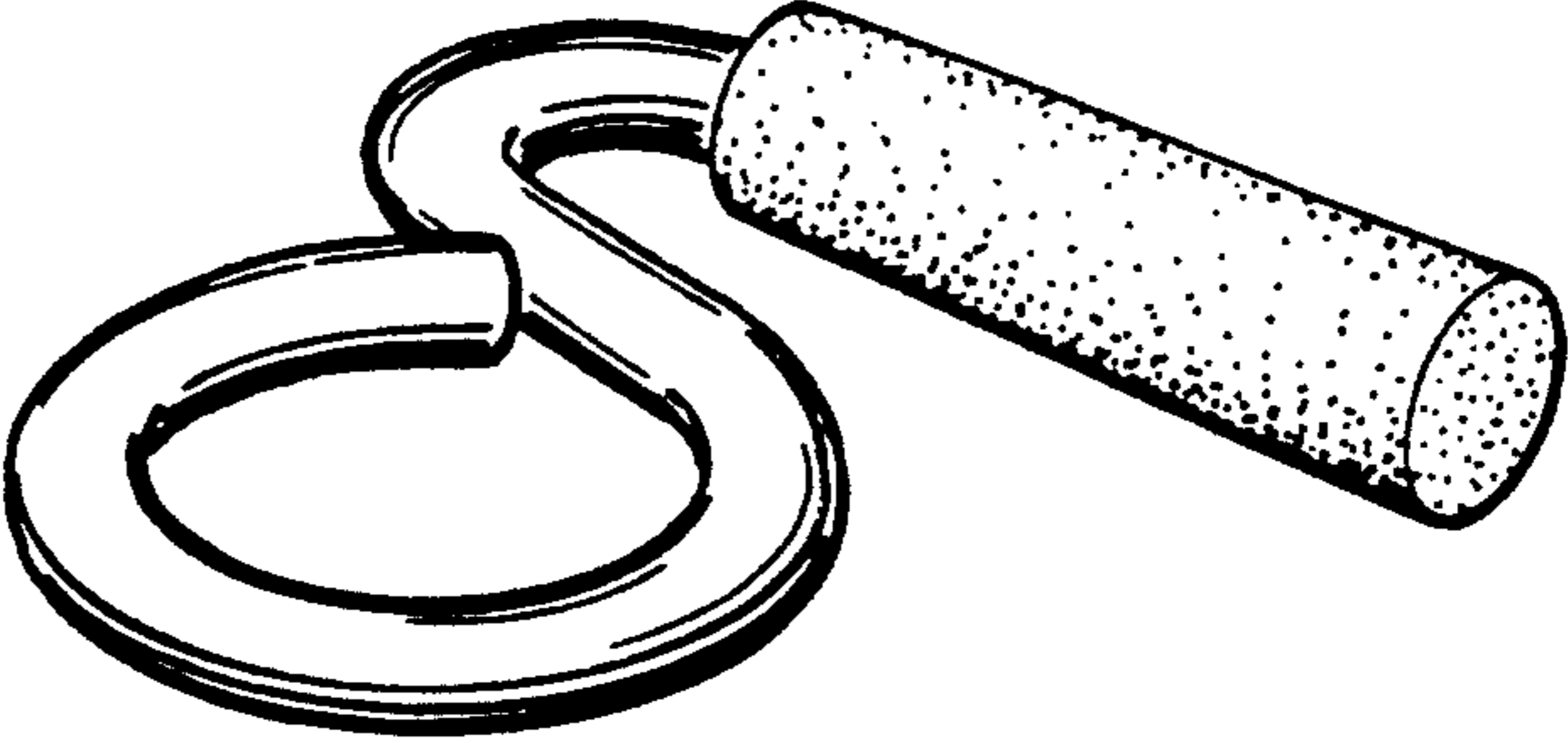

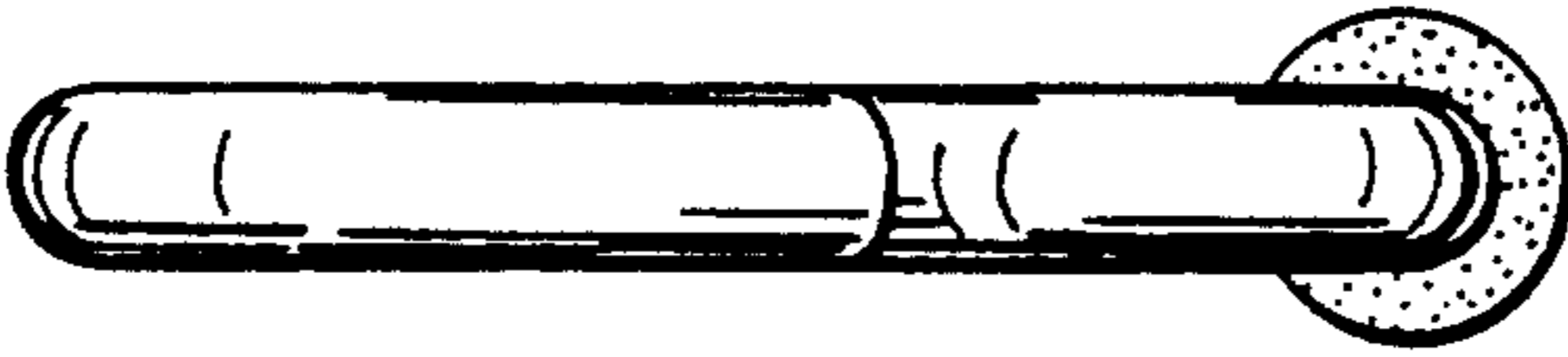

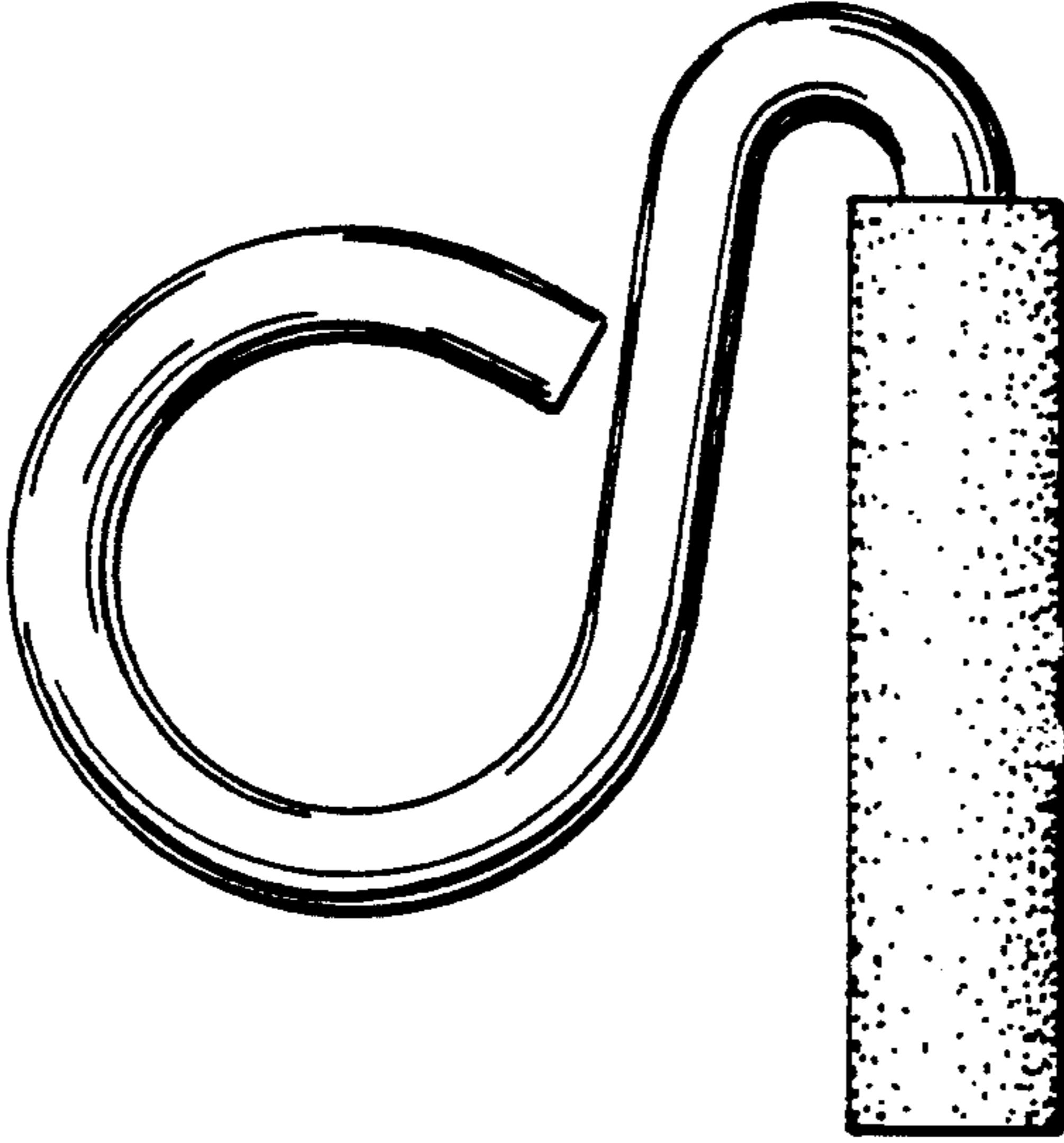

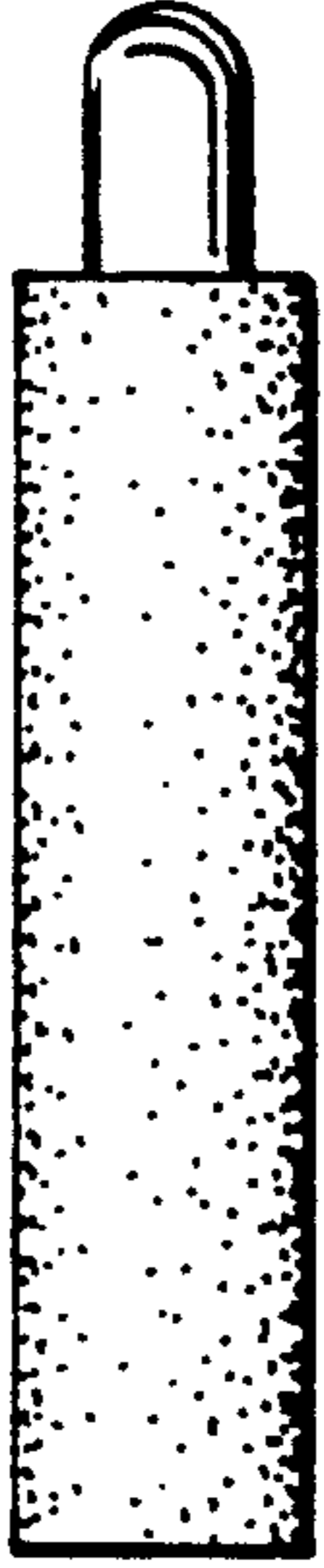

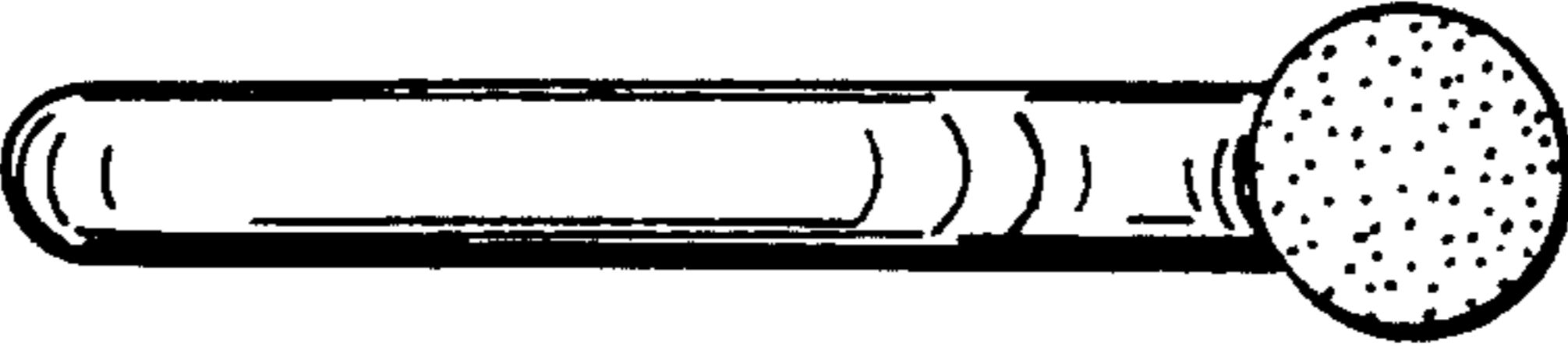
