The ornamental design for an arm chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view, looking slightly from above, of an arm chair in accordance with one embodiment showing my new design;

 FIG. 9 is a top plan view;

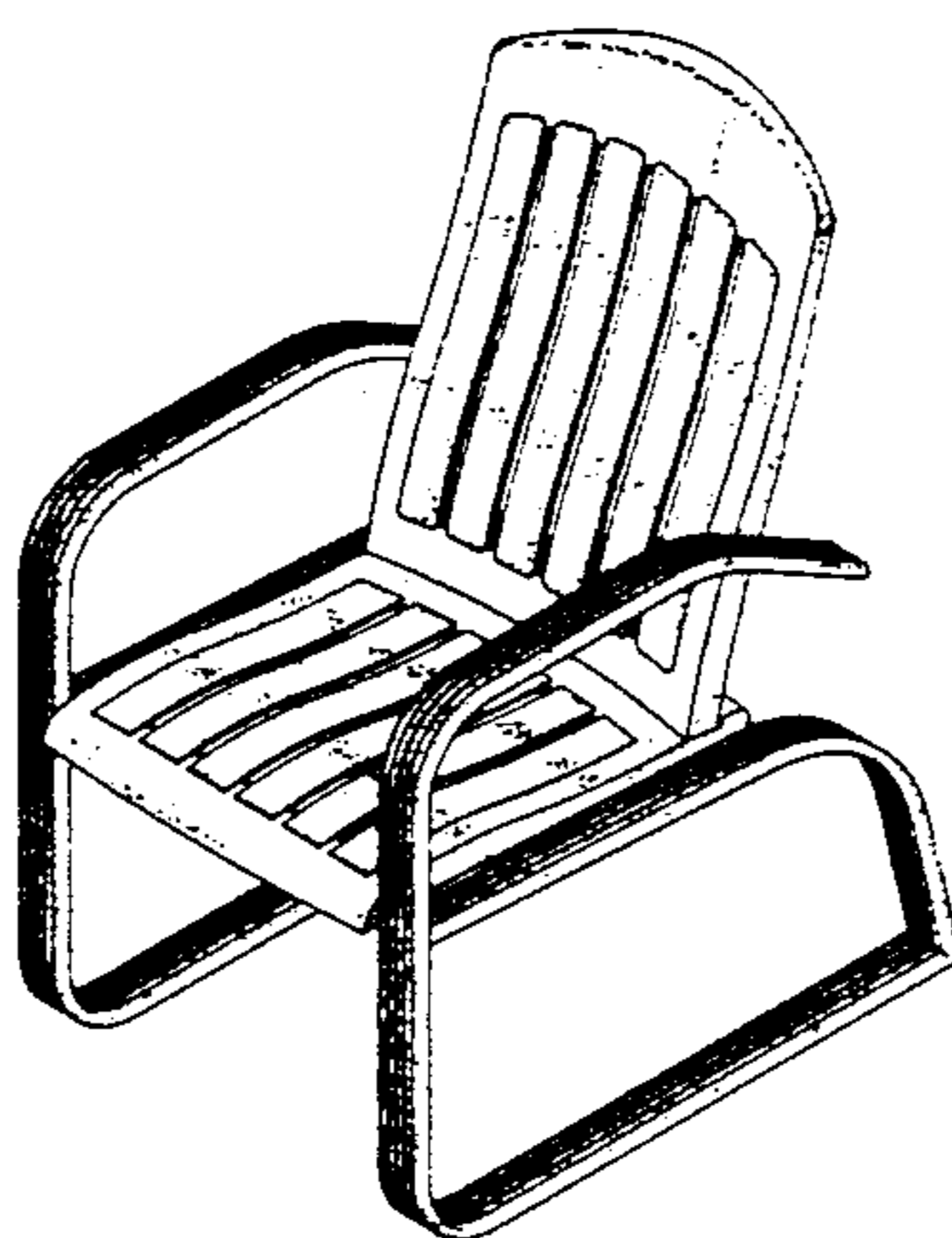


FIG. 10 is a right side elevational view, the left side being a mirror image thereof;

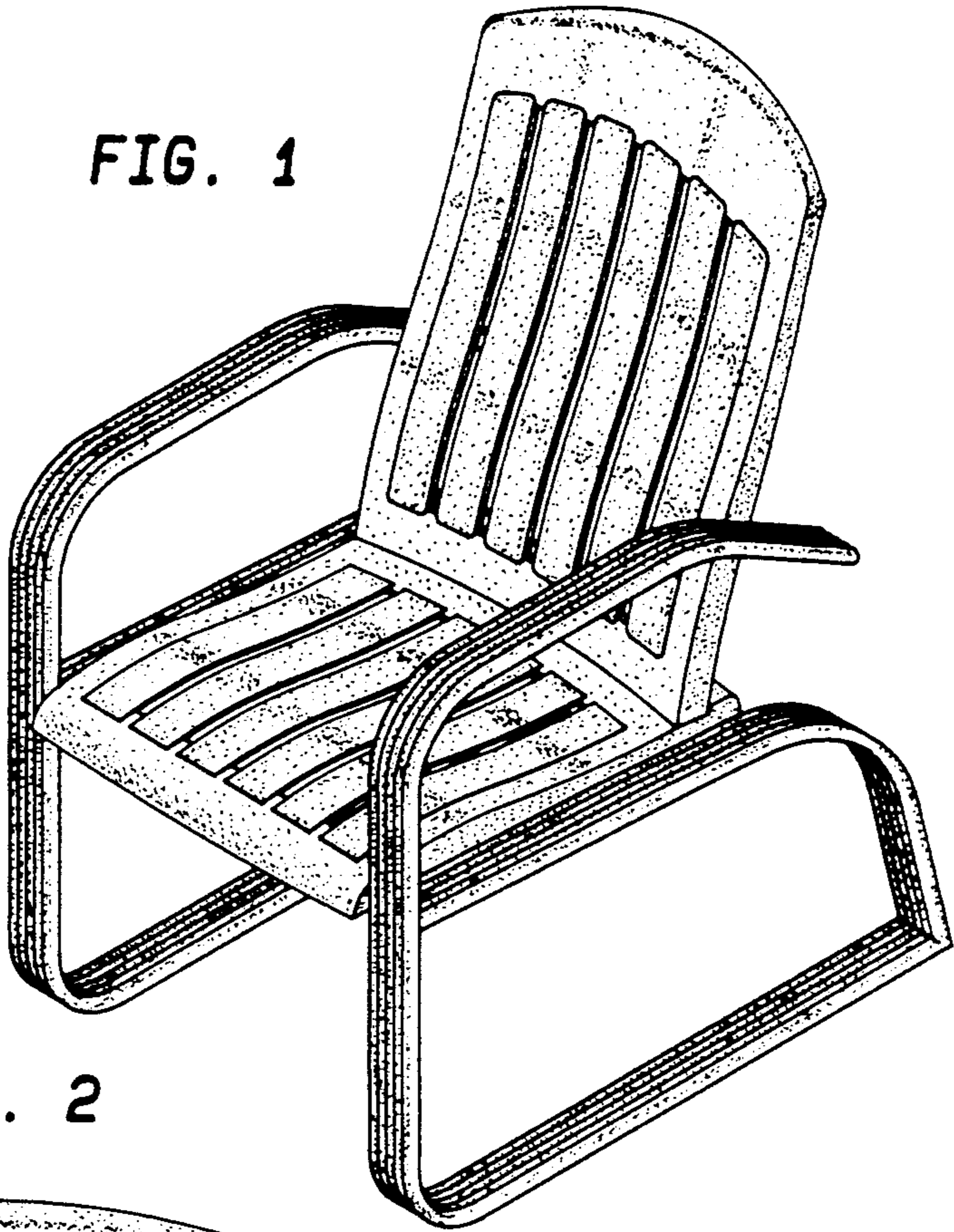

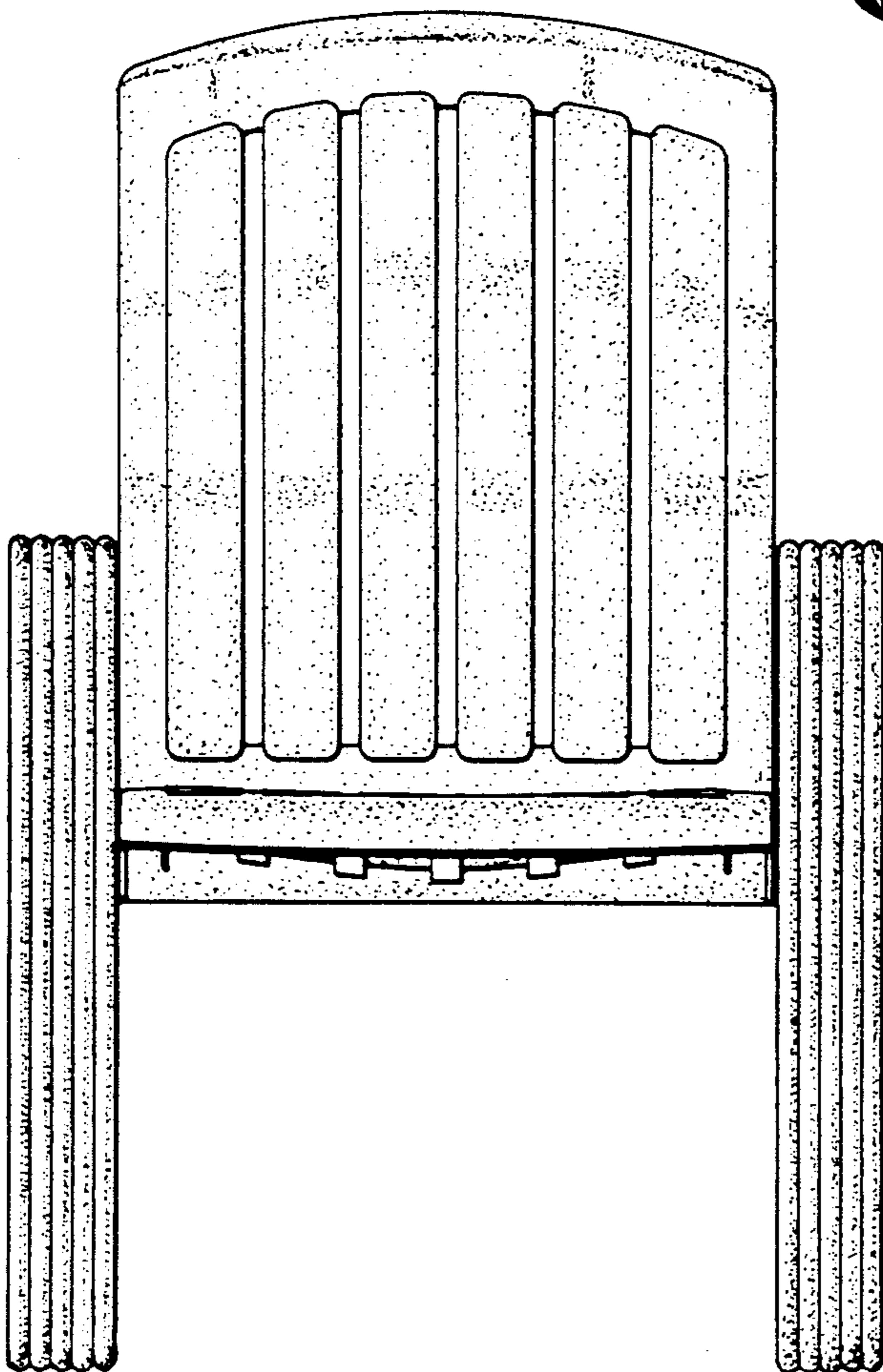

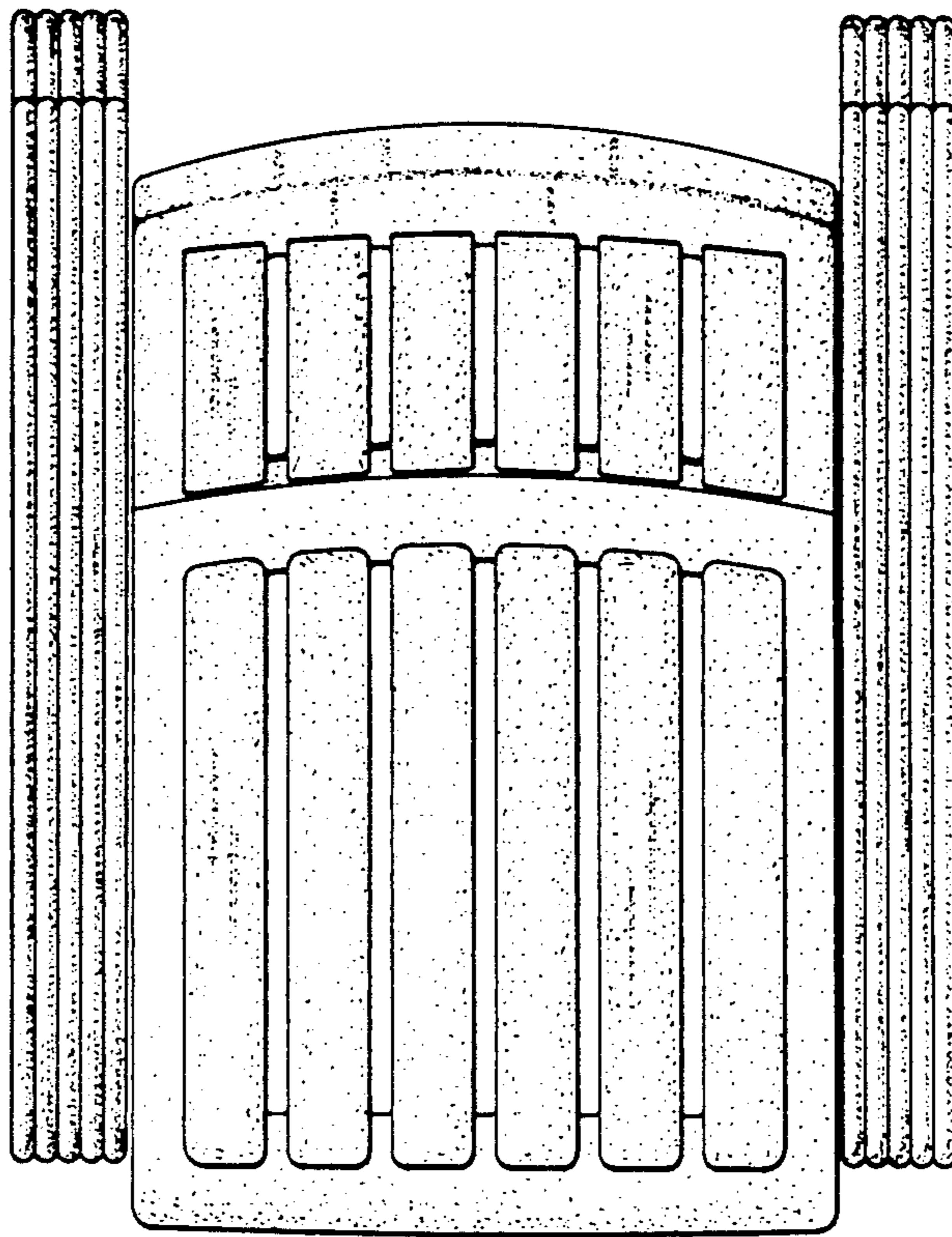

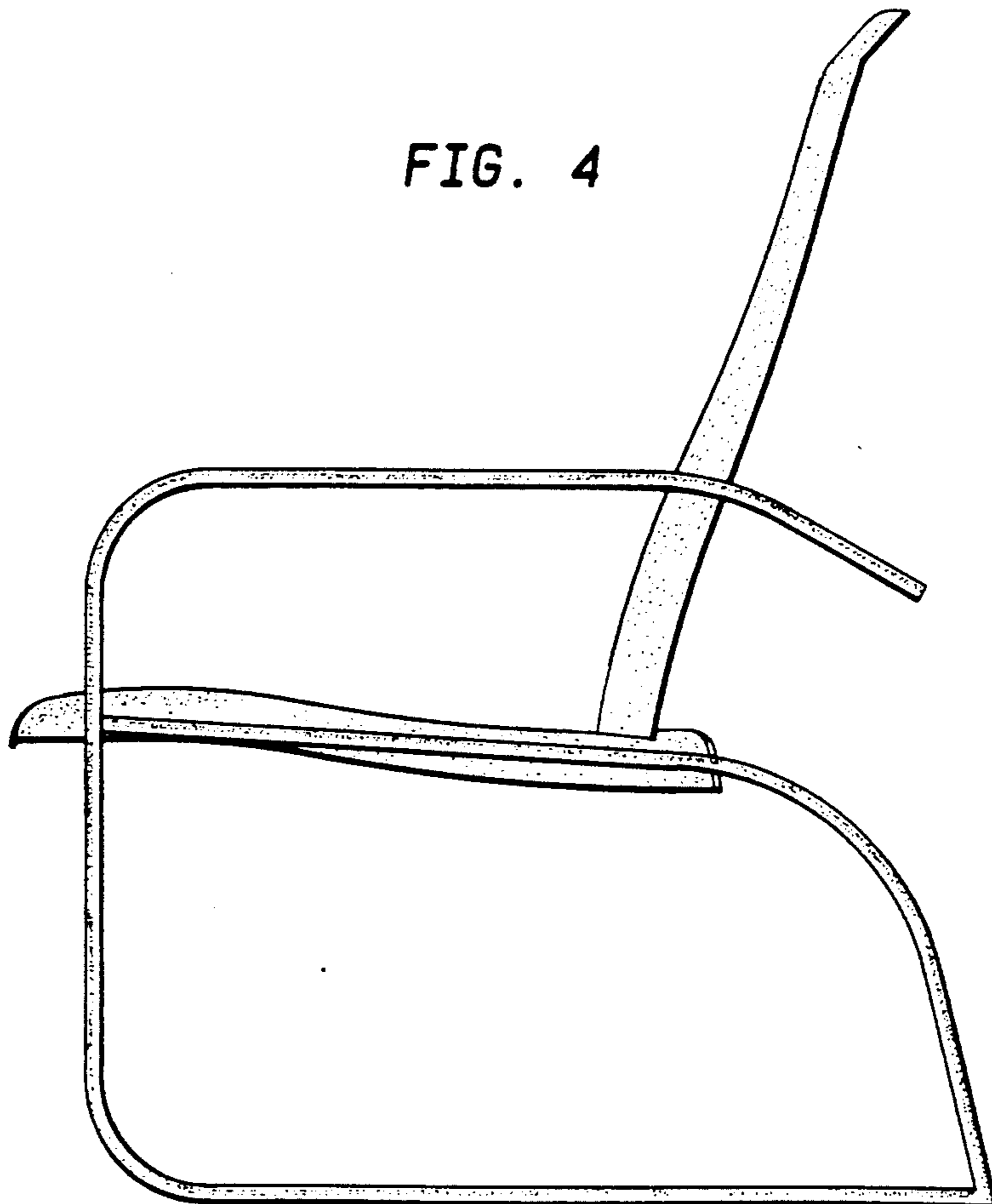

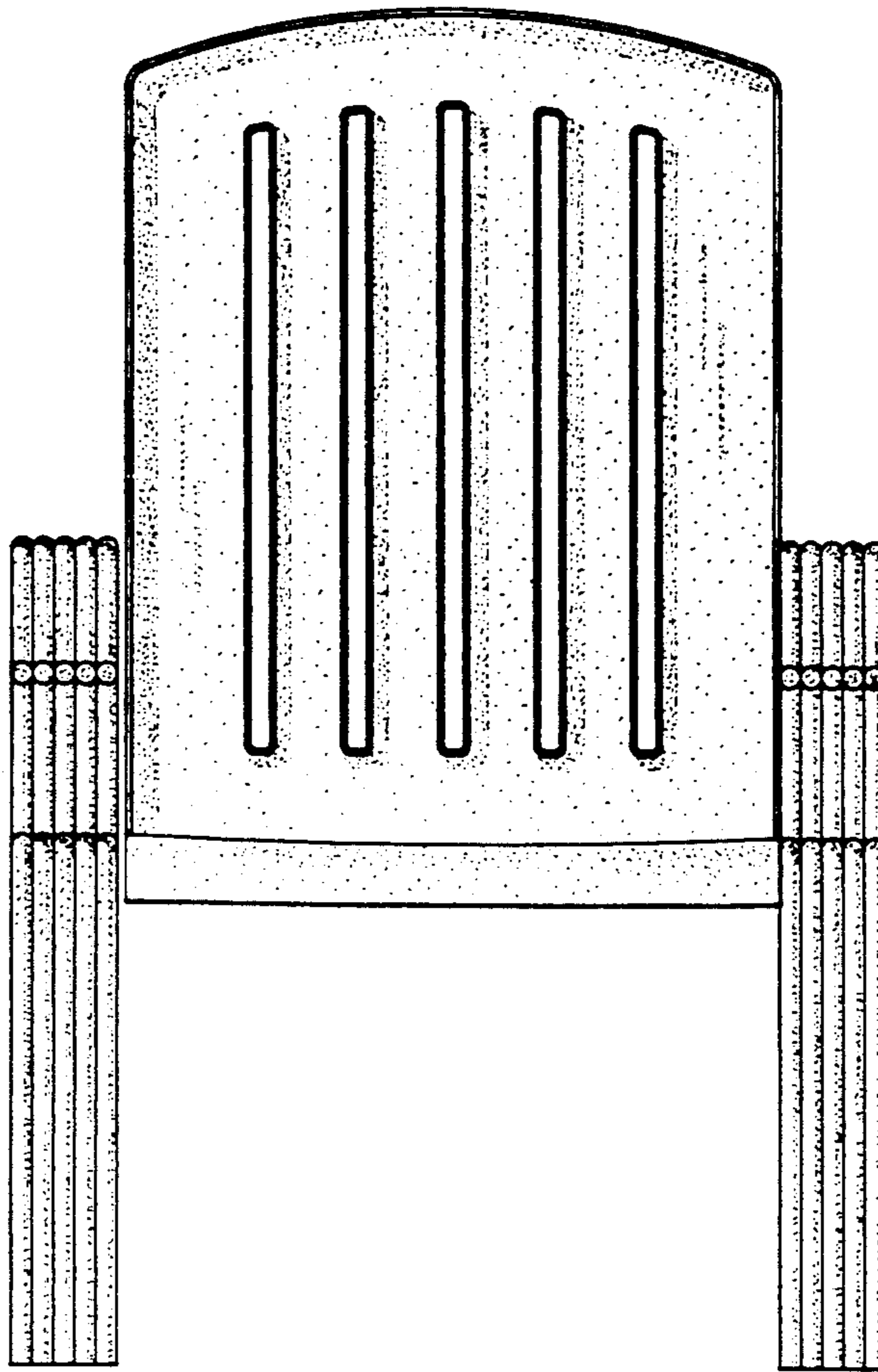

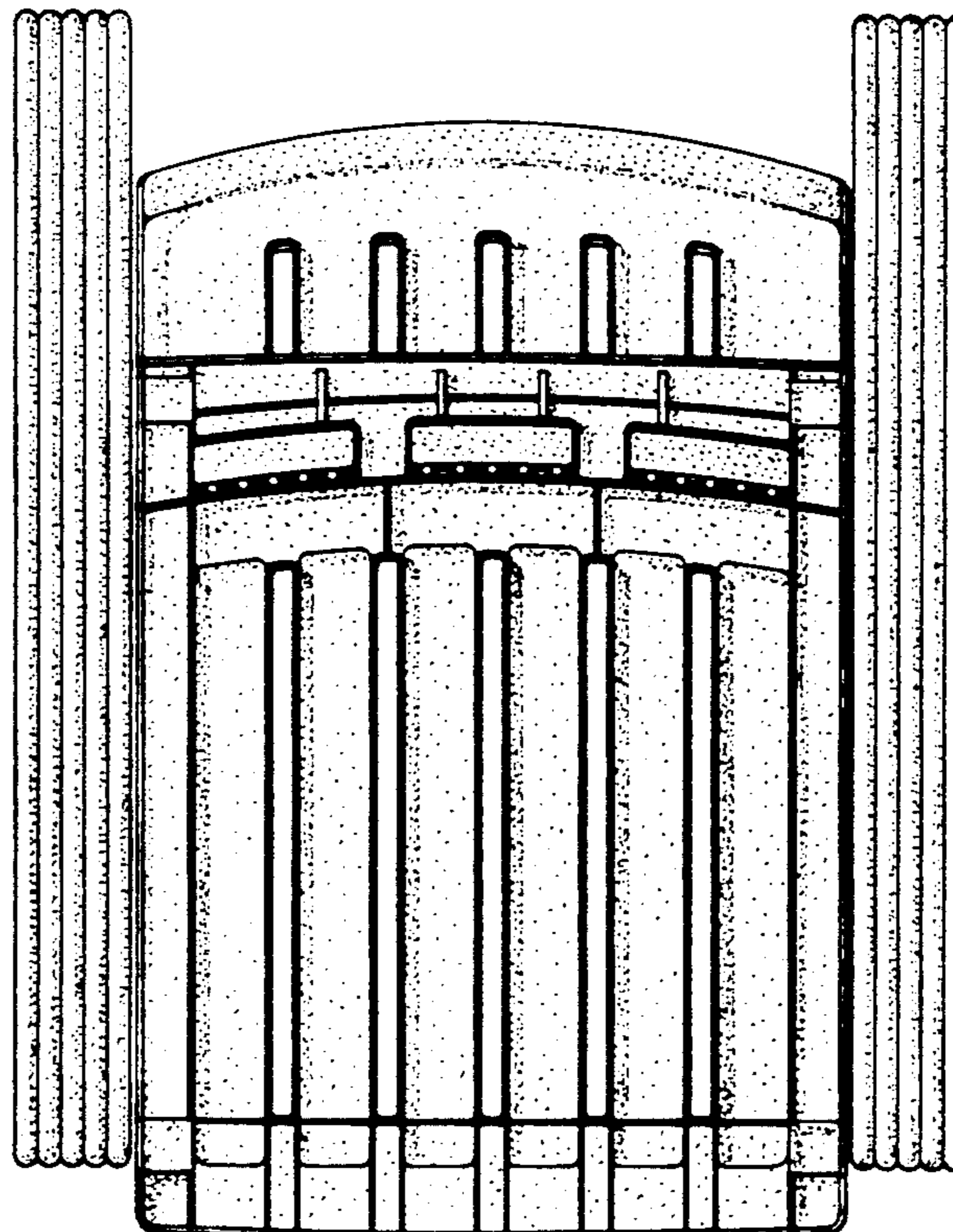

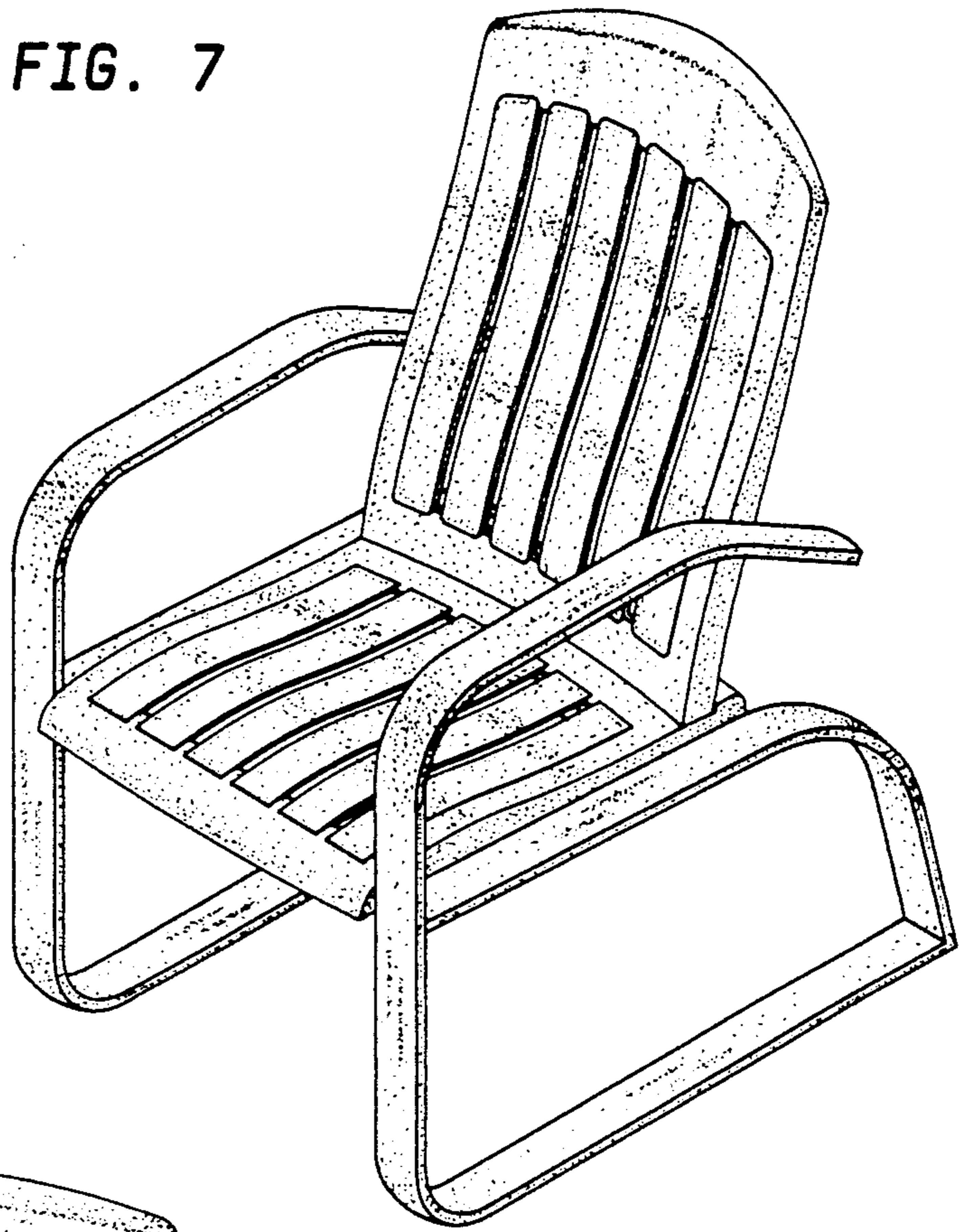

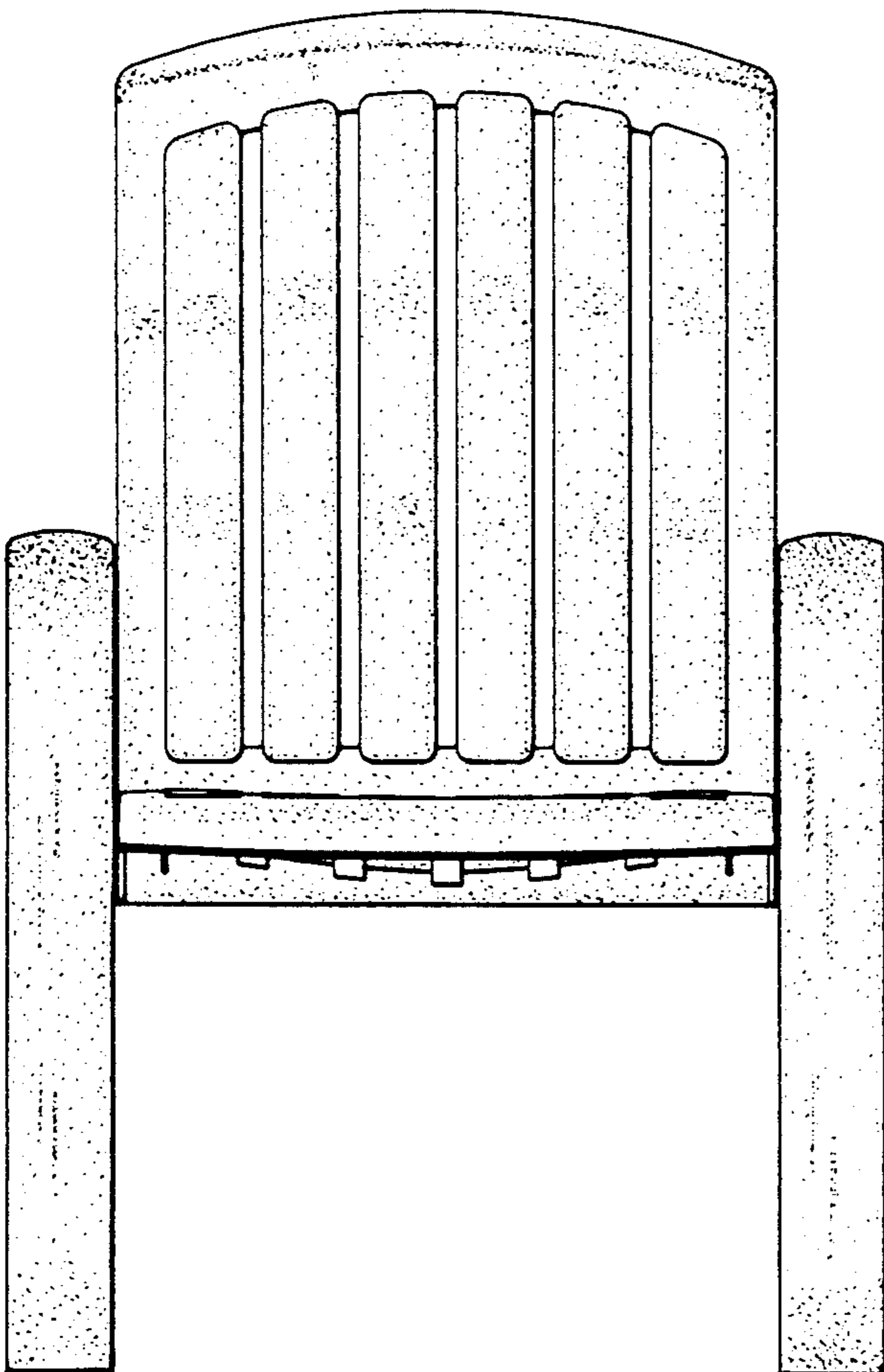

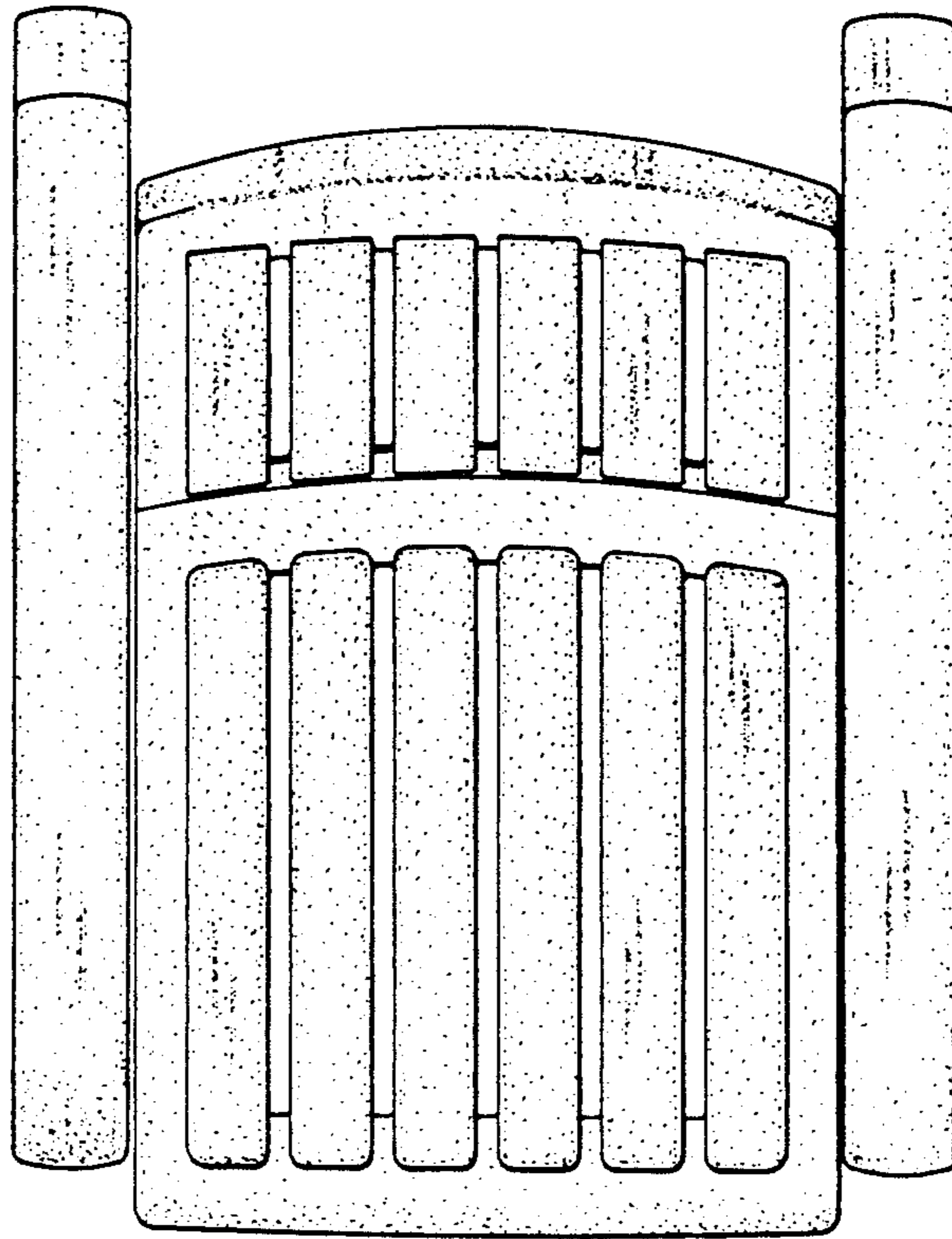

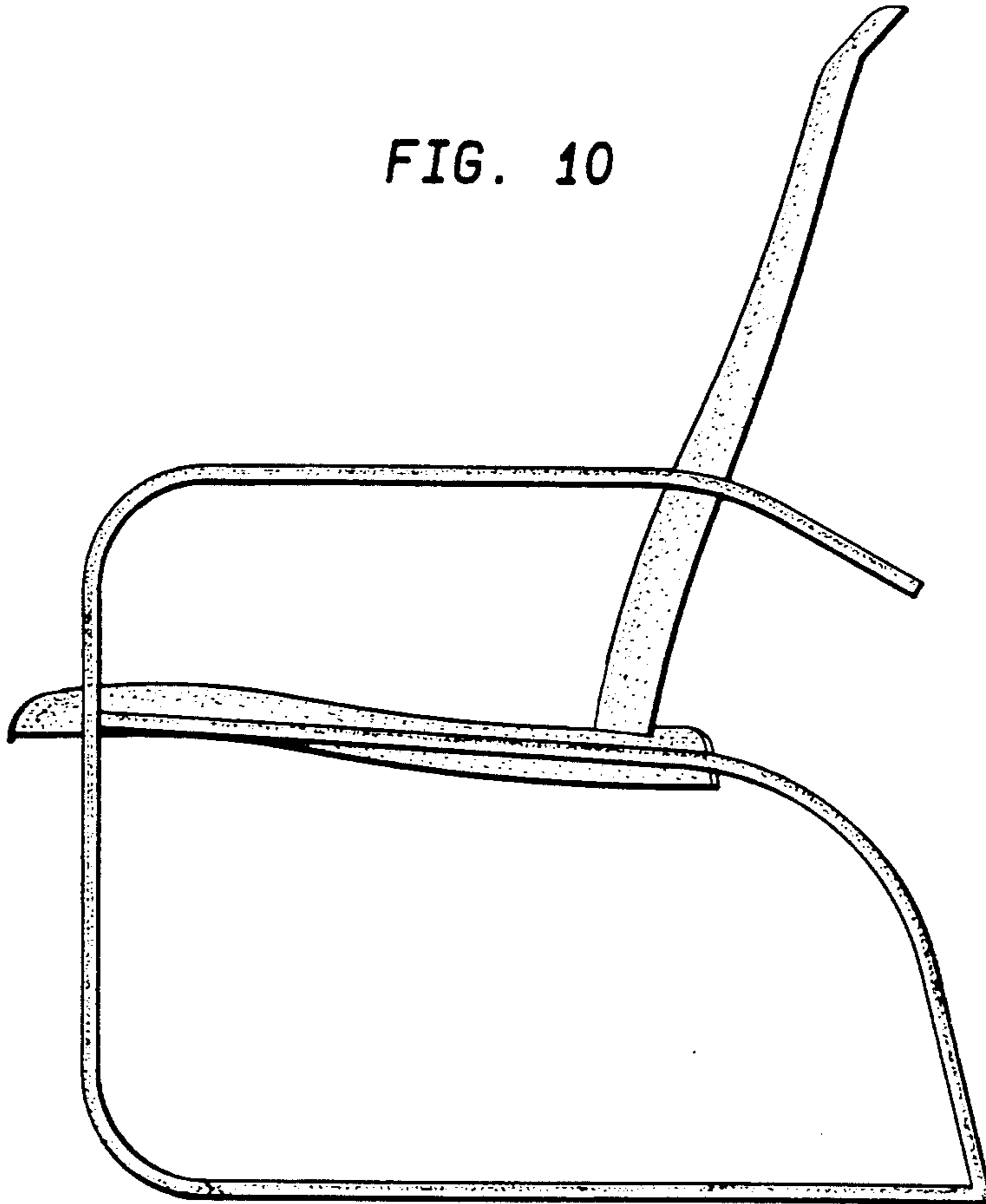

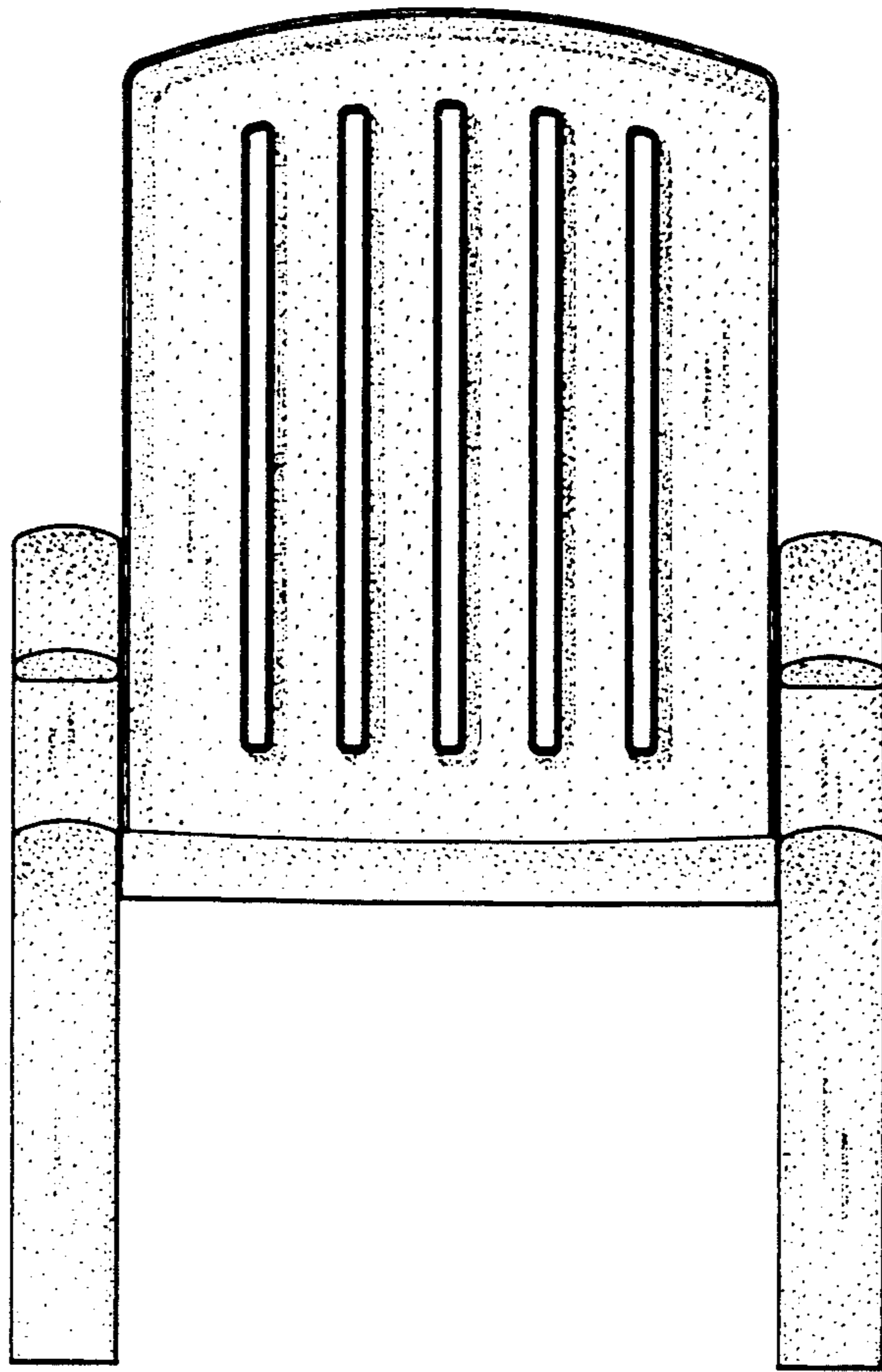

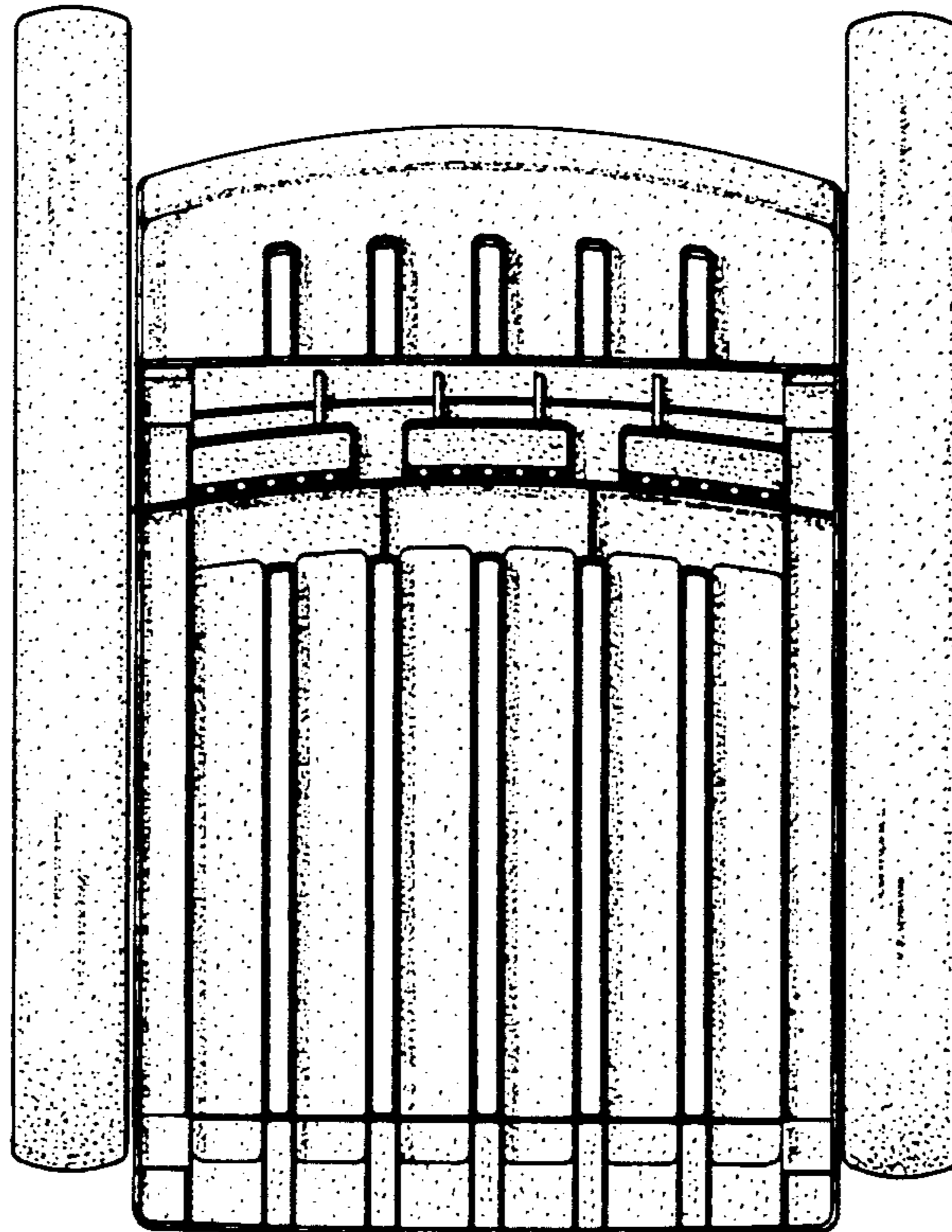

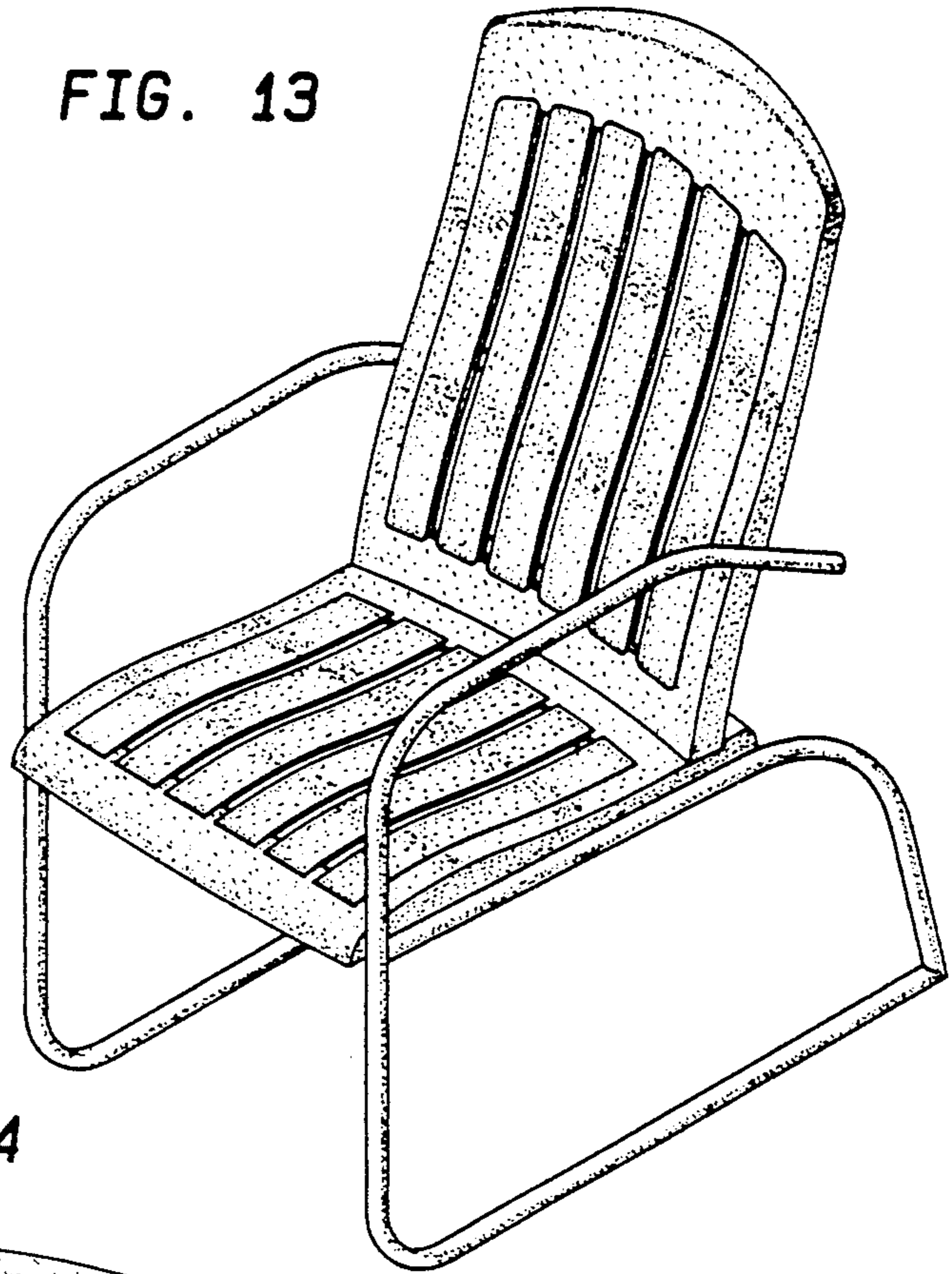

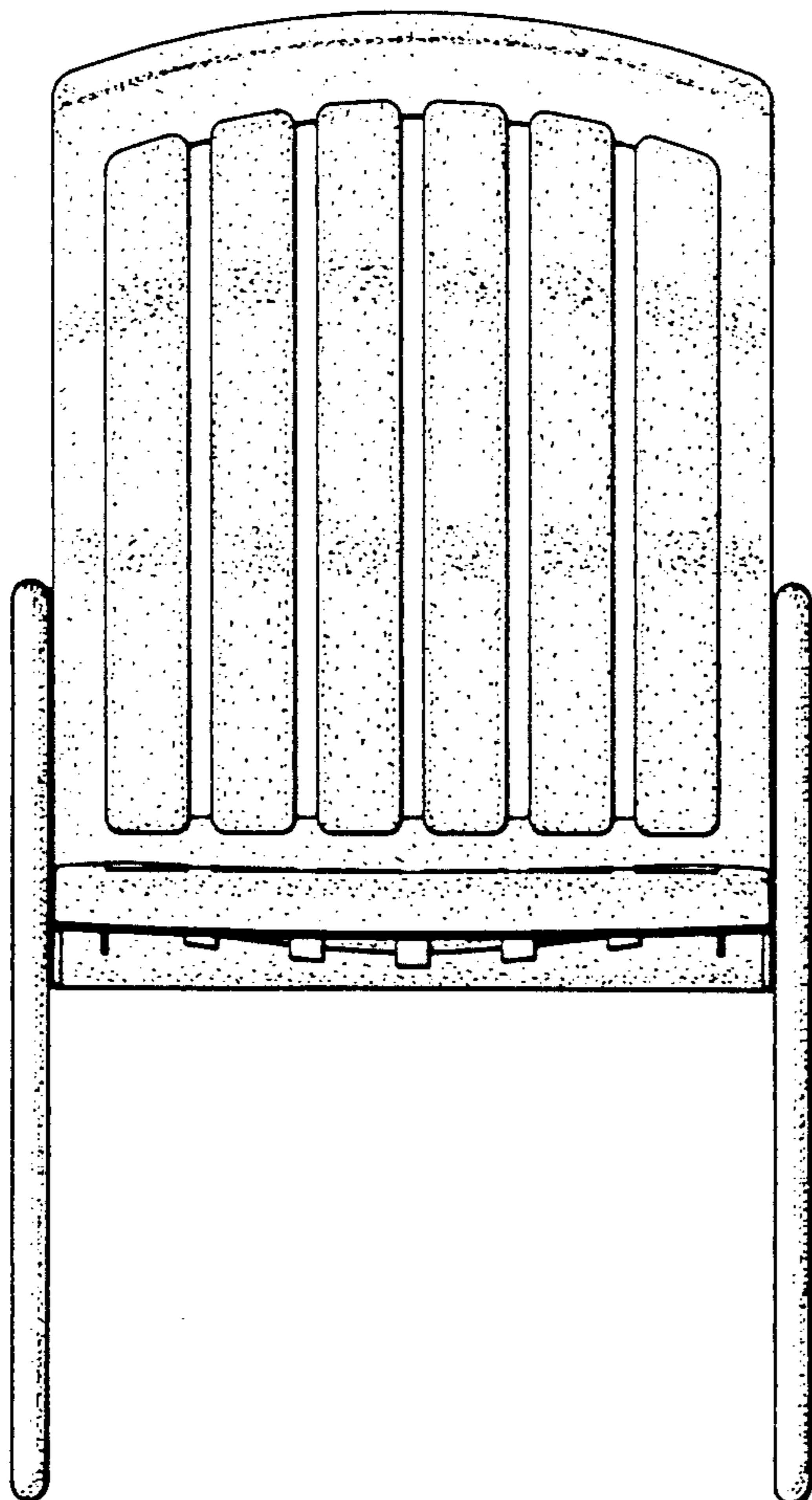

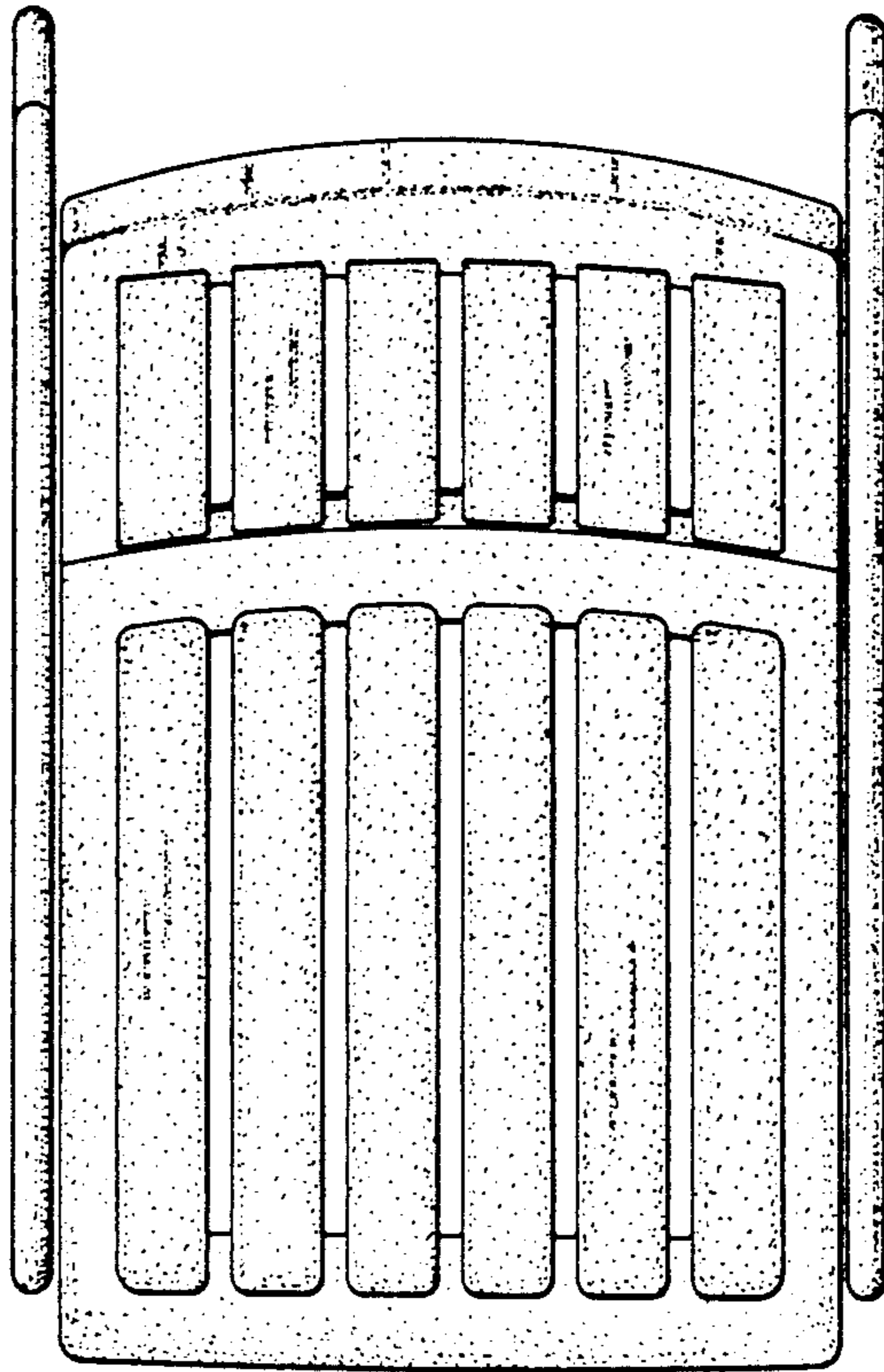

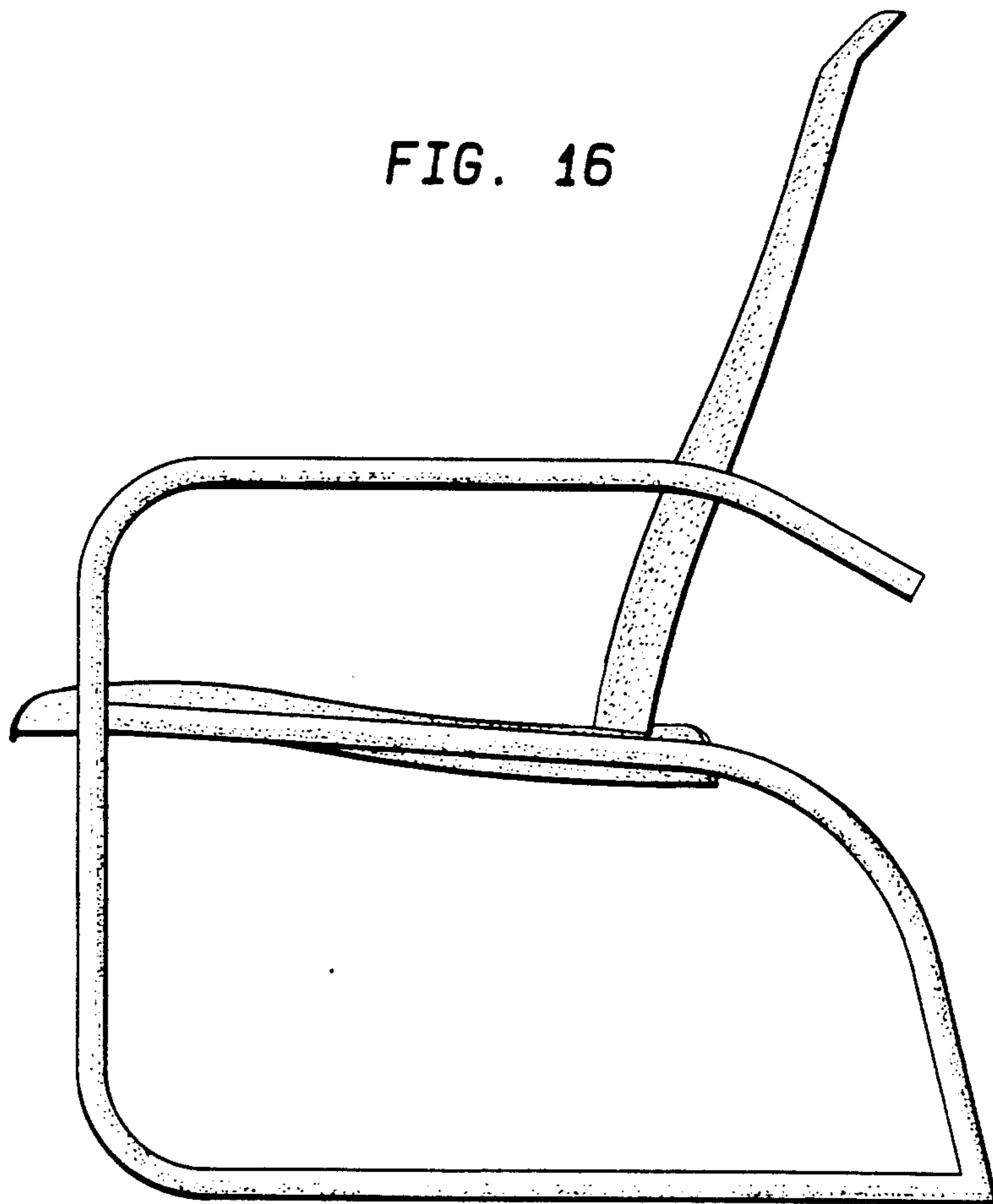

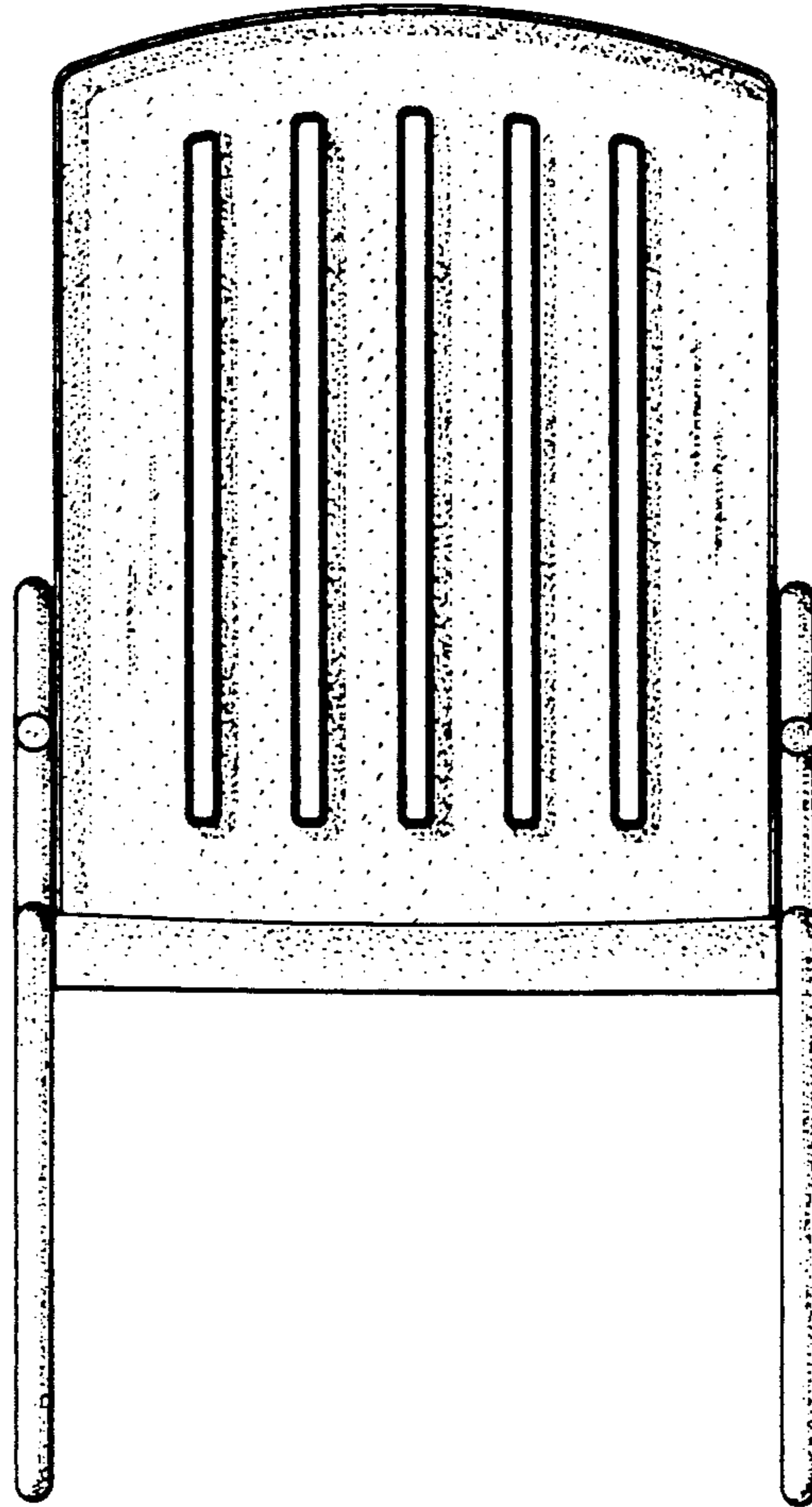
