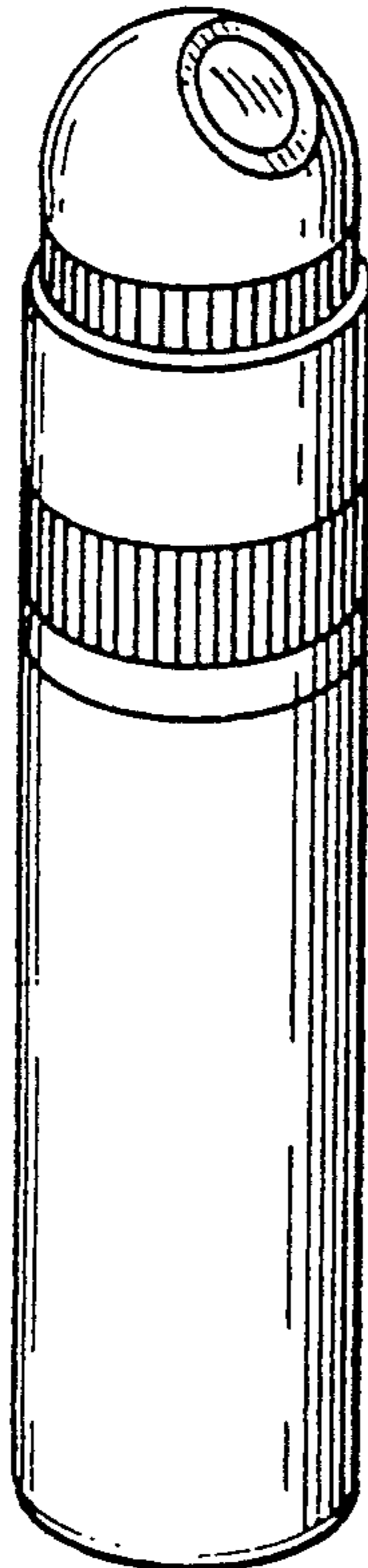

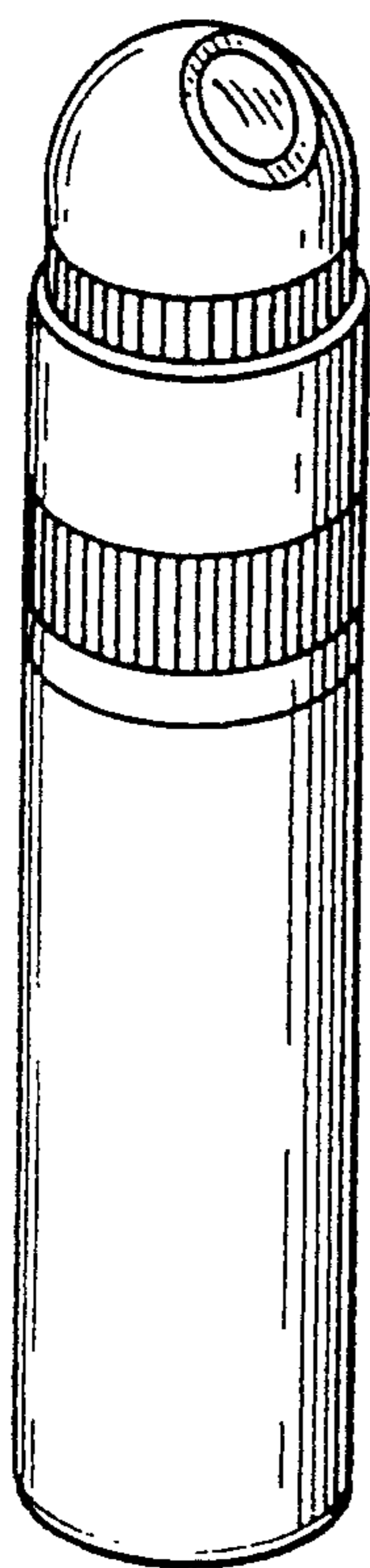
### [57] CLAIM

The ornamental design for a dispensing container for cosmetic product, as shown and described.

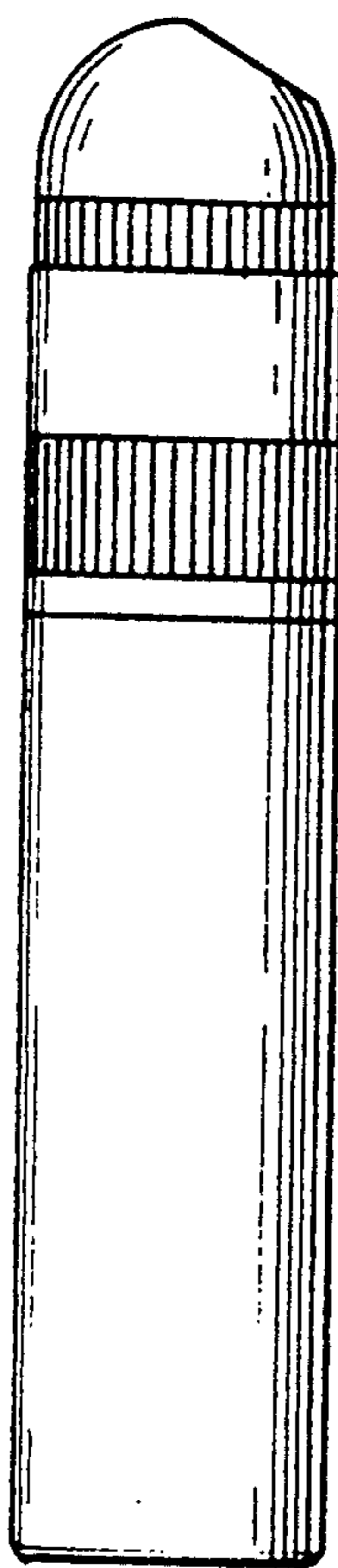
### DESCRIPTION

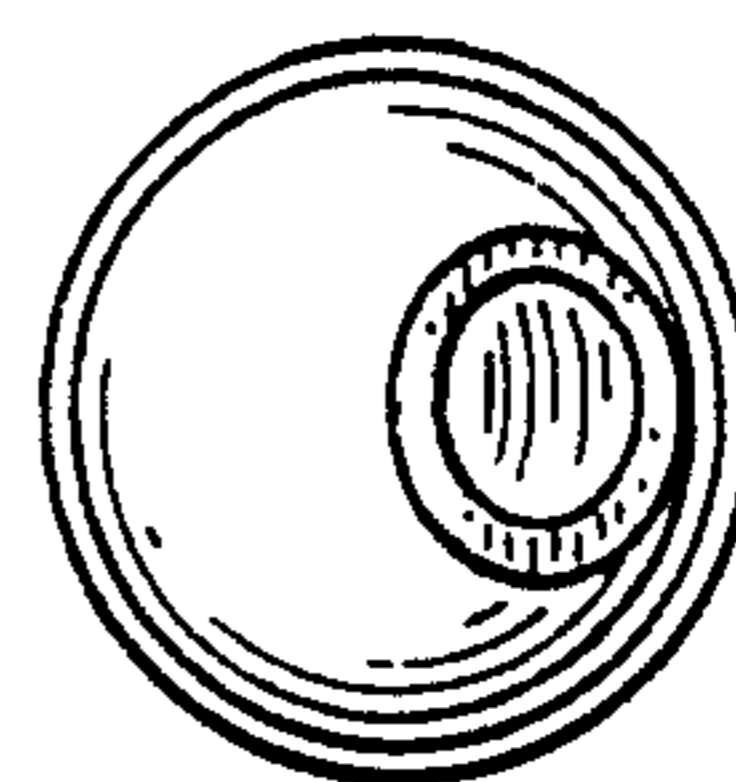




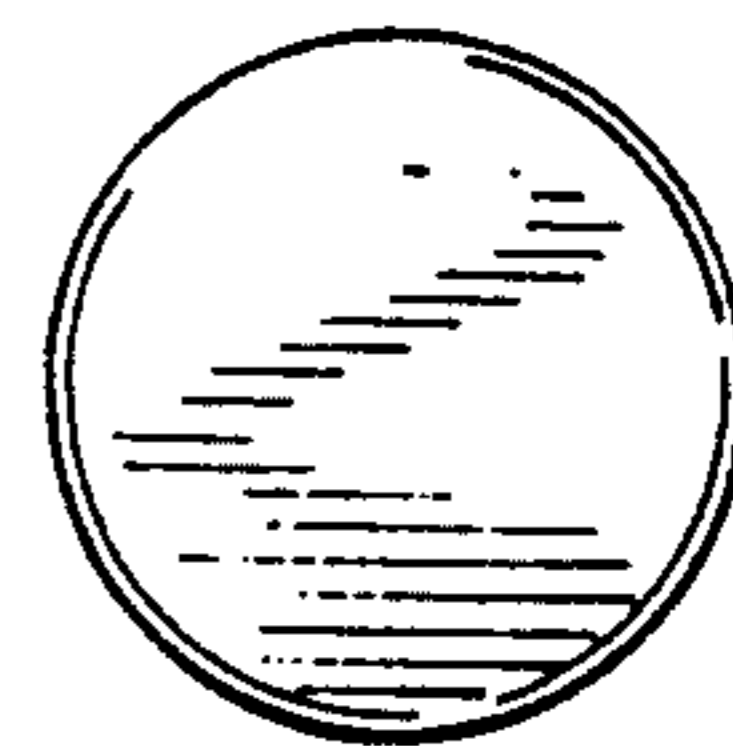
