The ornamental design for a lunch box, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of a lunch box showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

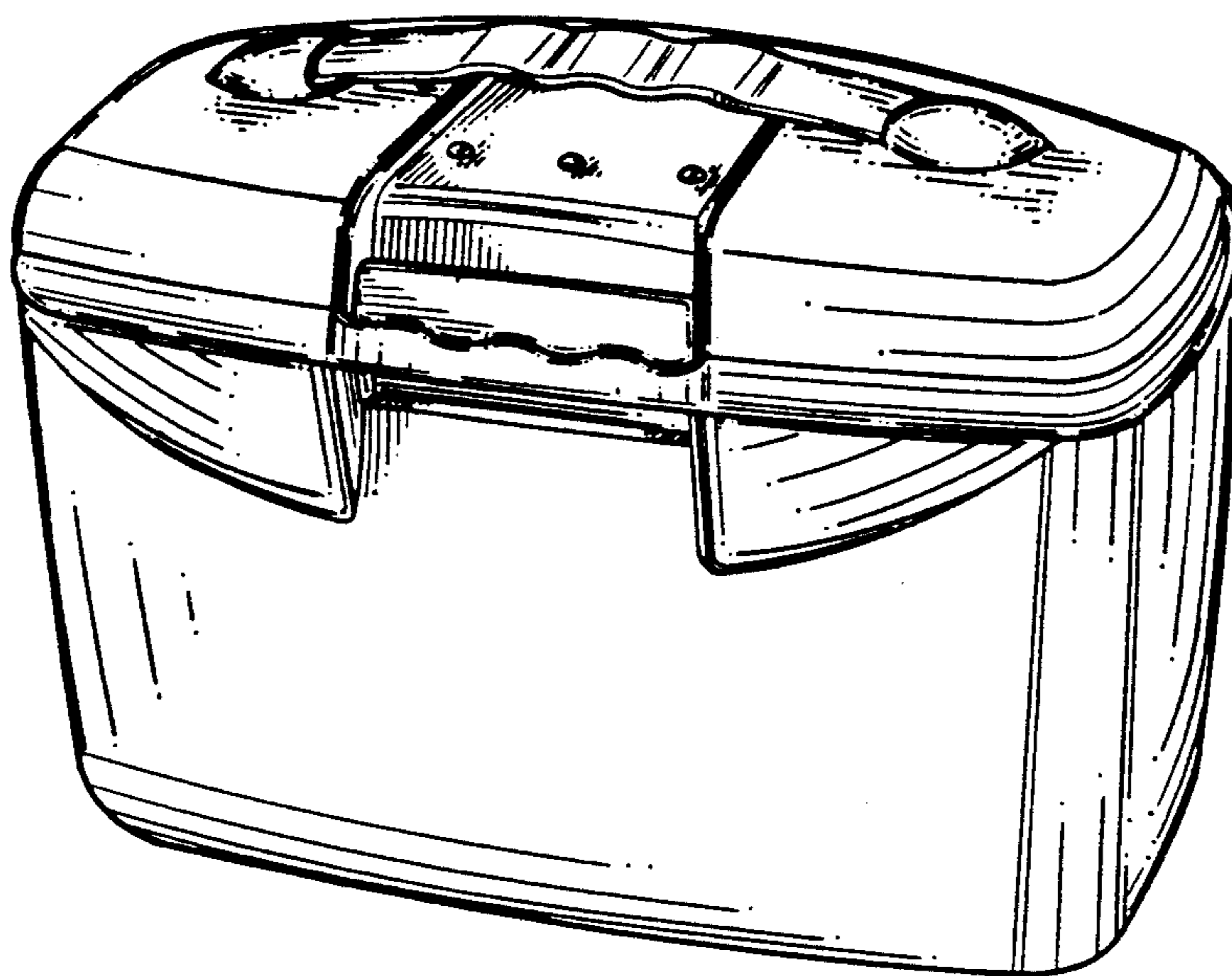
FIG. 4 is a bottom plan view thereof;

The rear elevational, bottom plan and side elevational views thereof would be as depicted in the preferred embodiment views, FIGS. 3, 4 and 6.



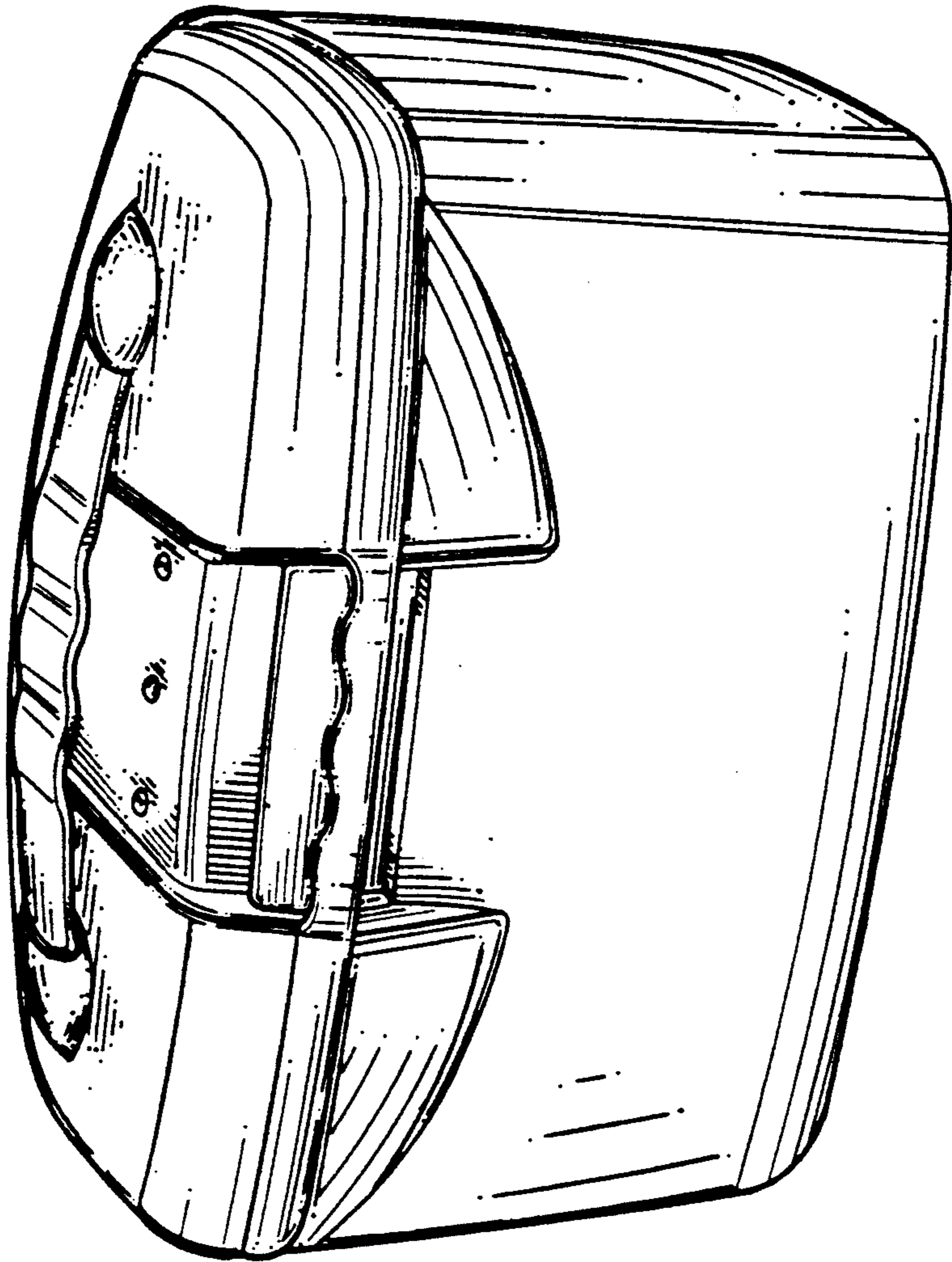

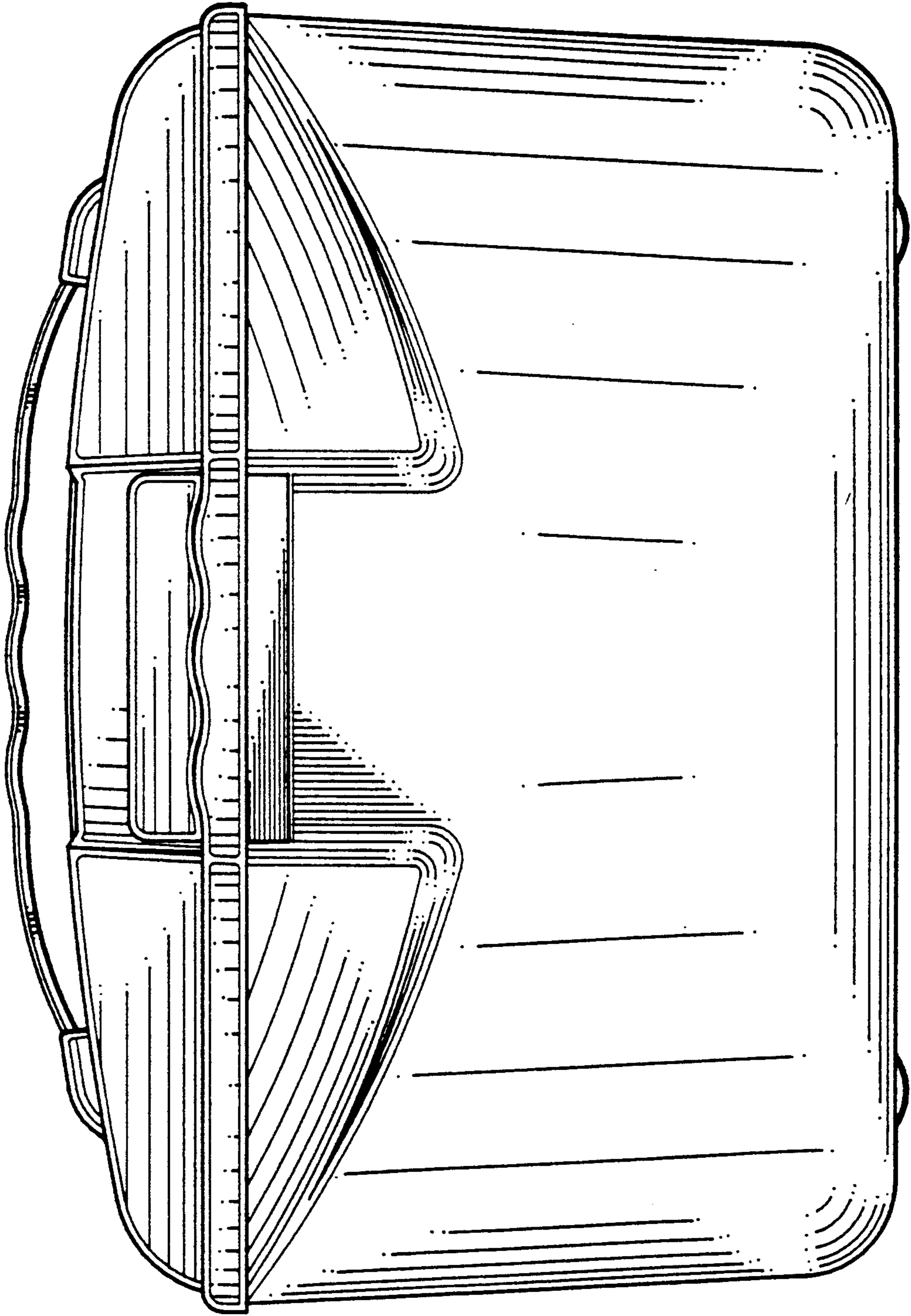

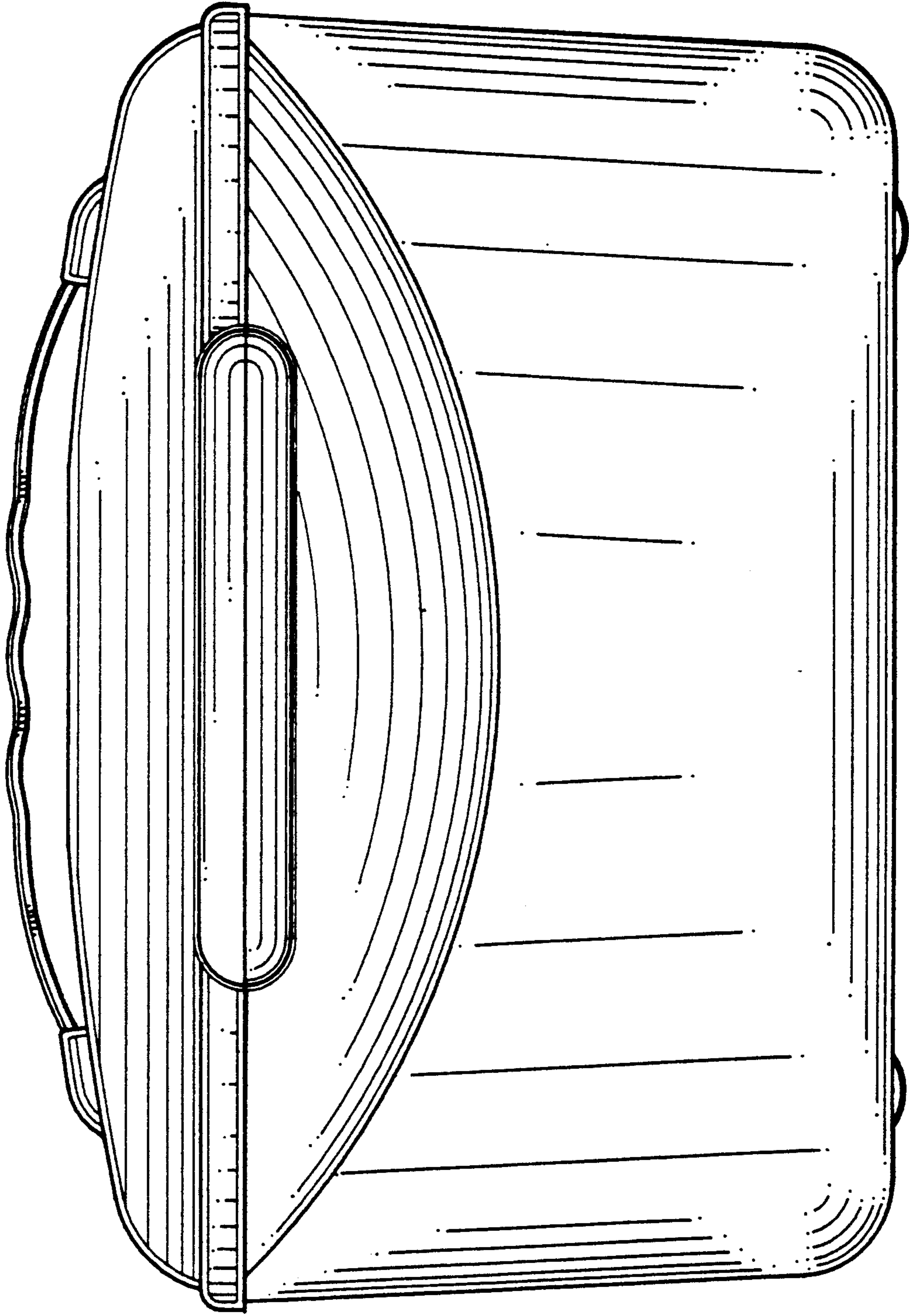

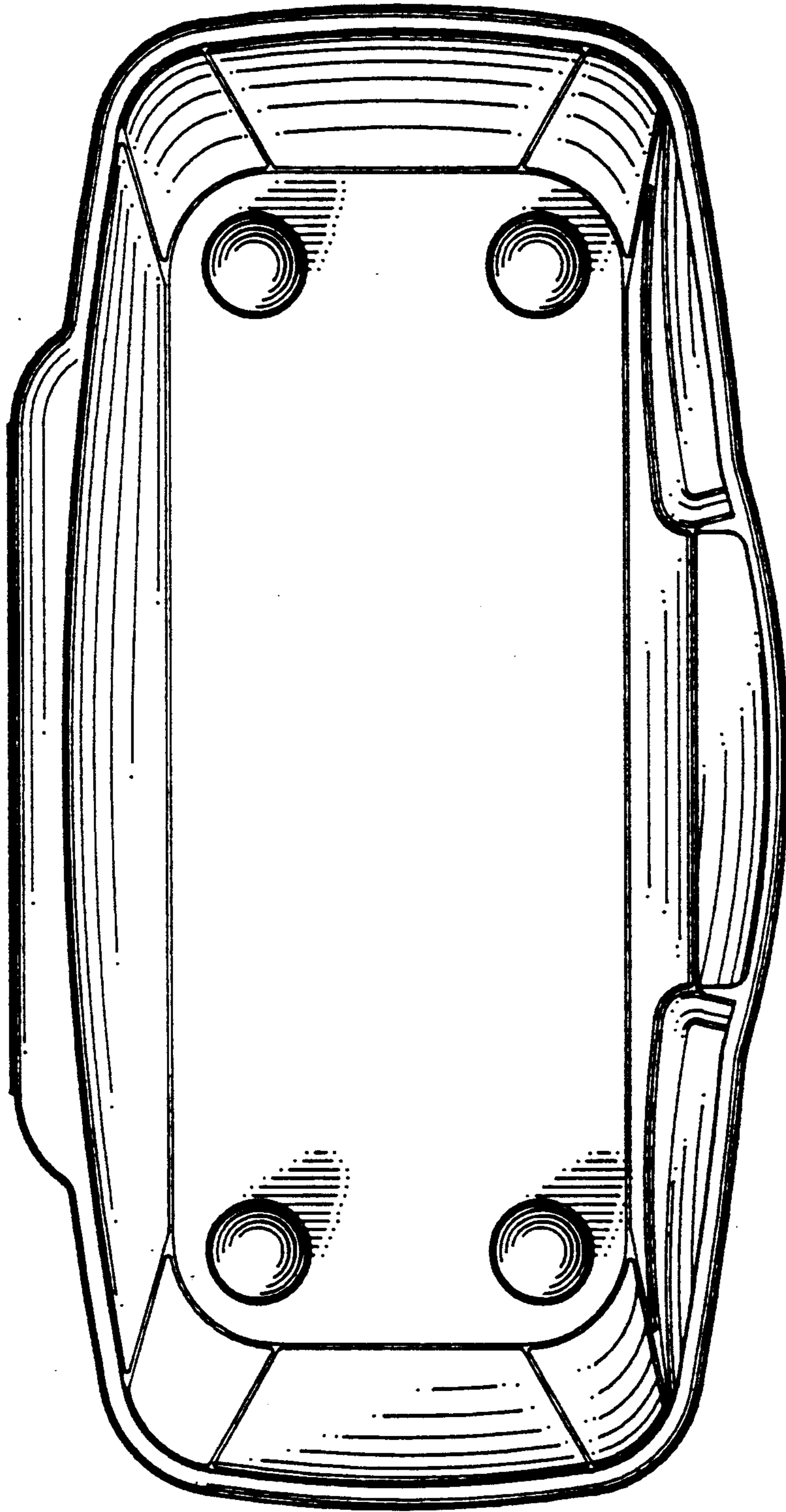

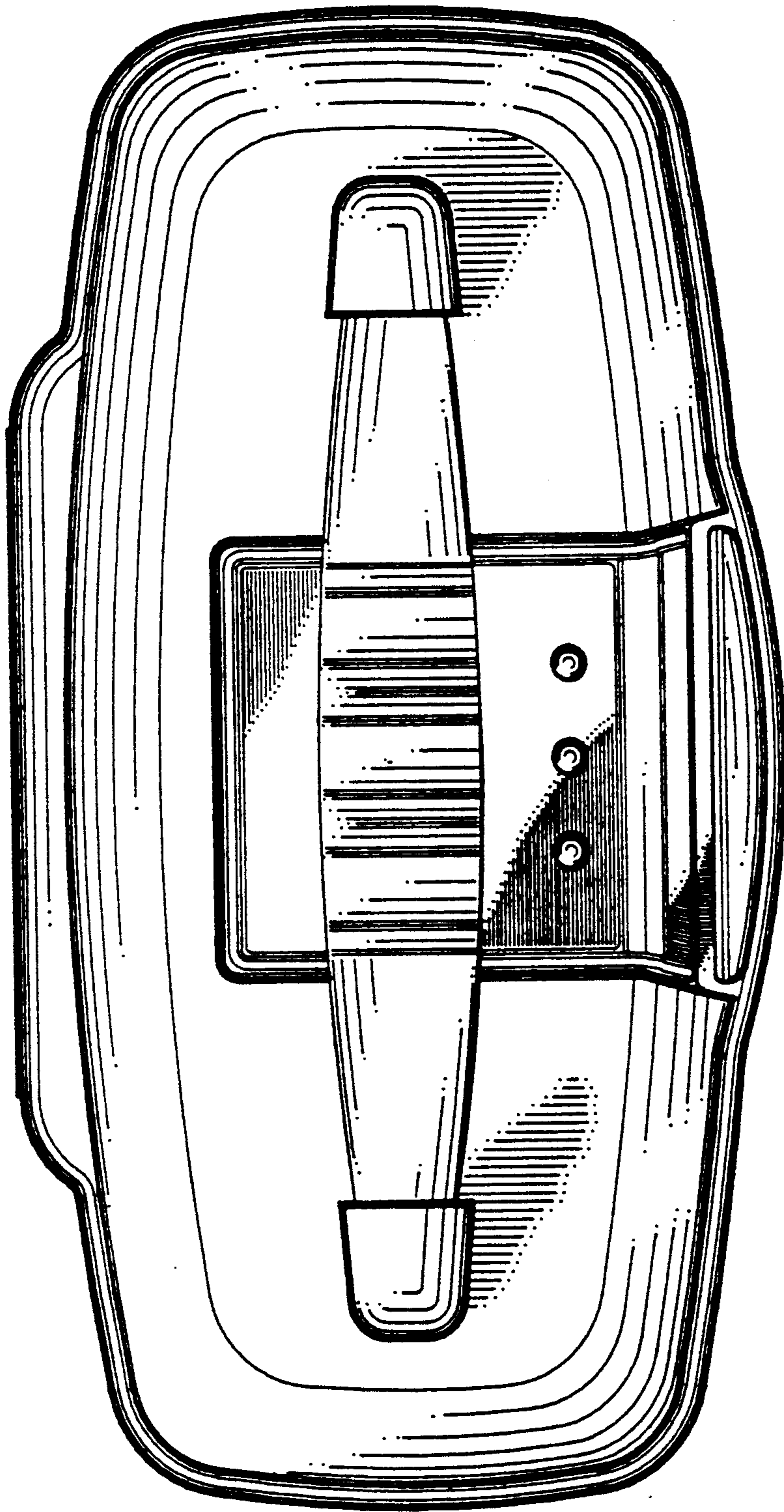

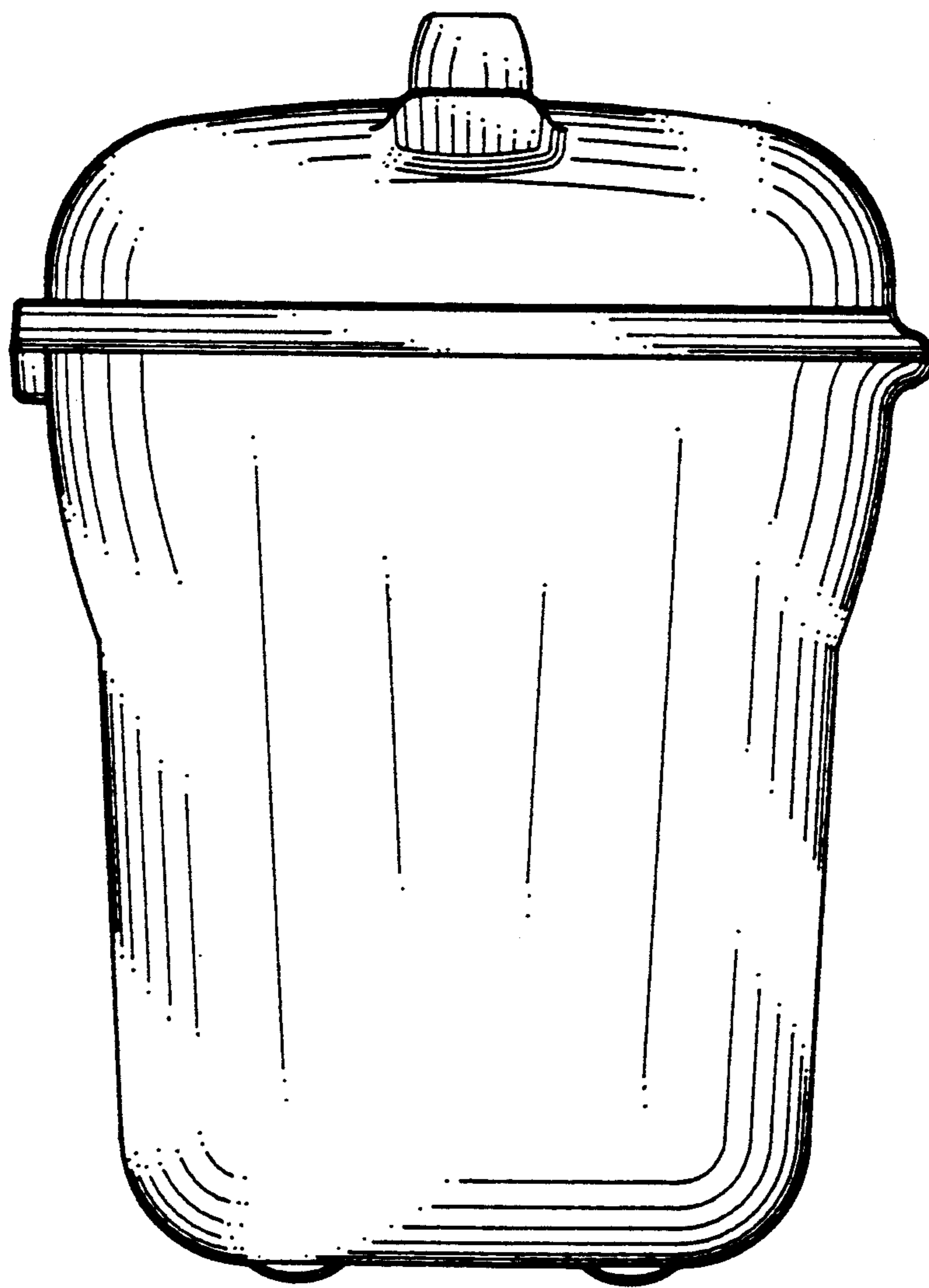

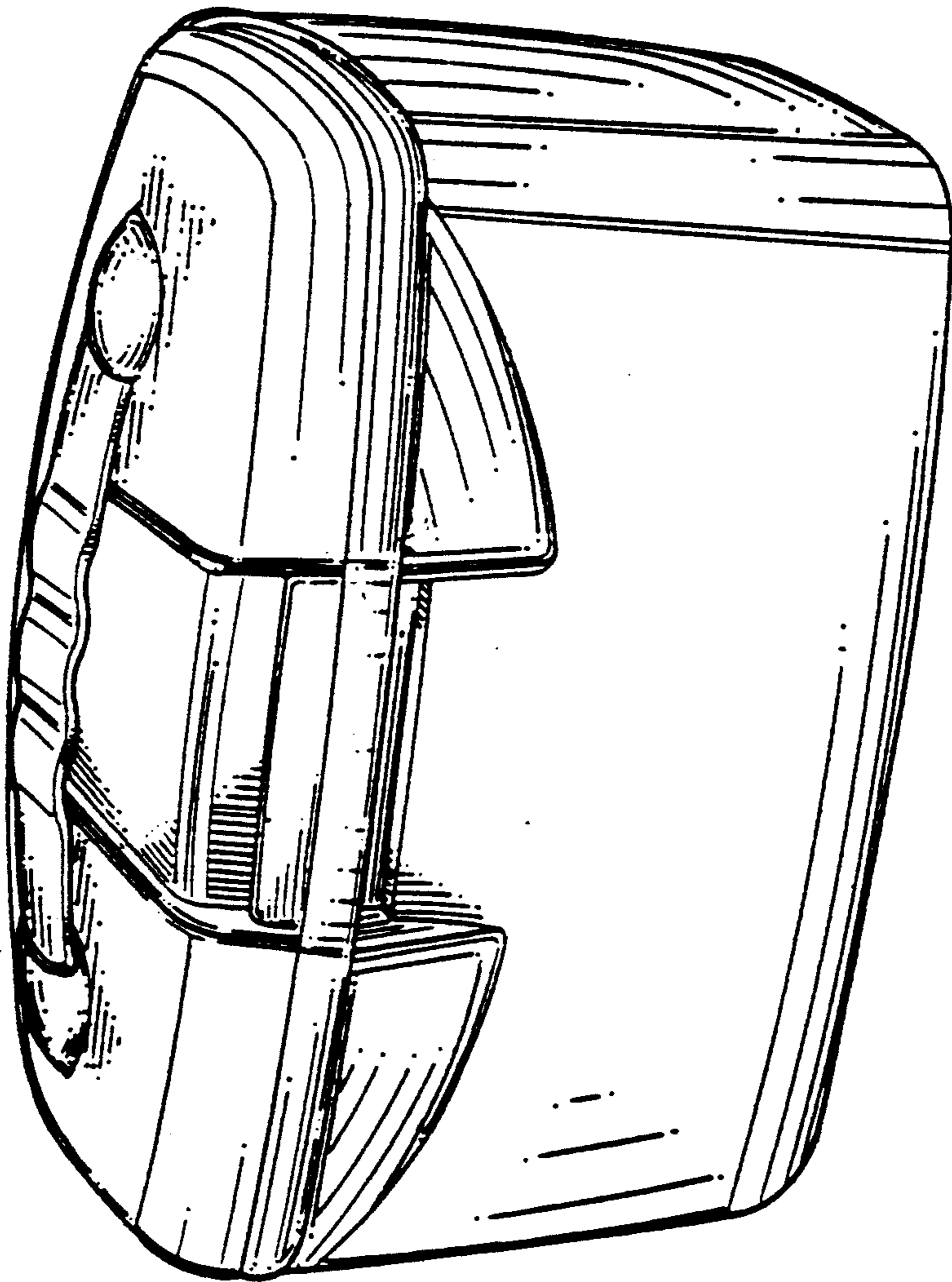
