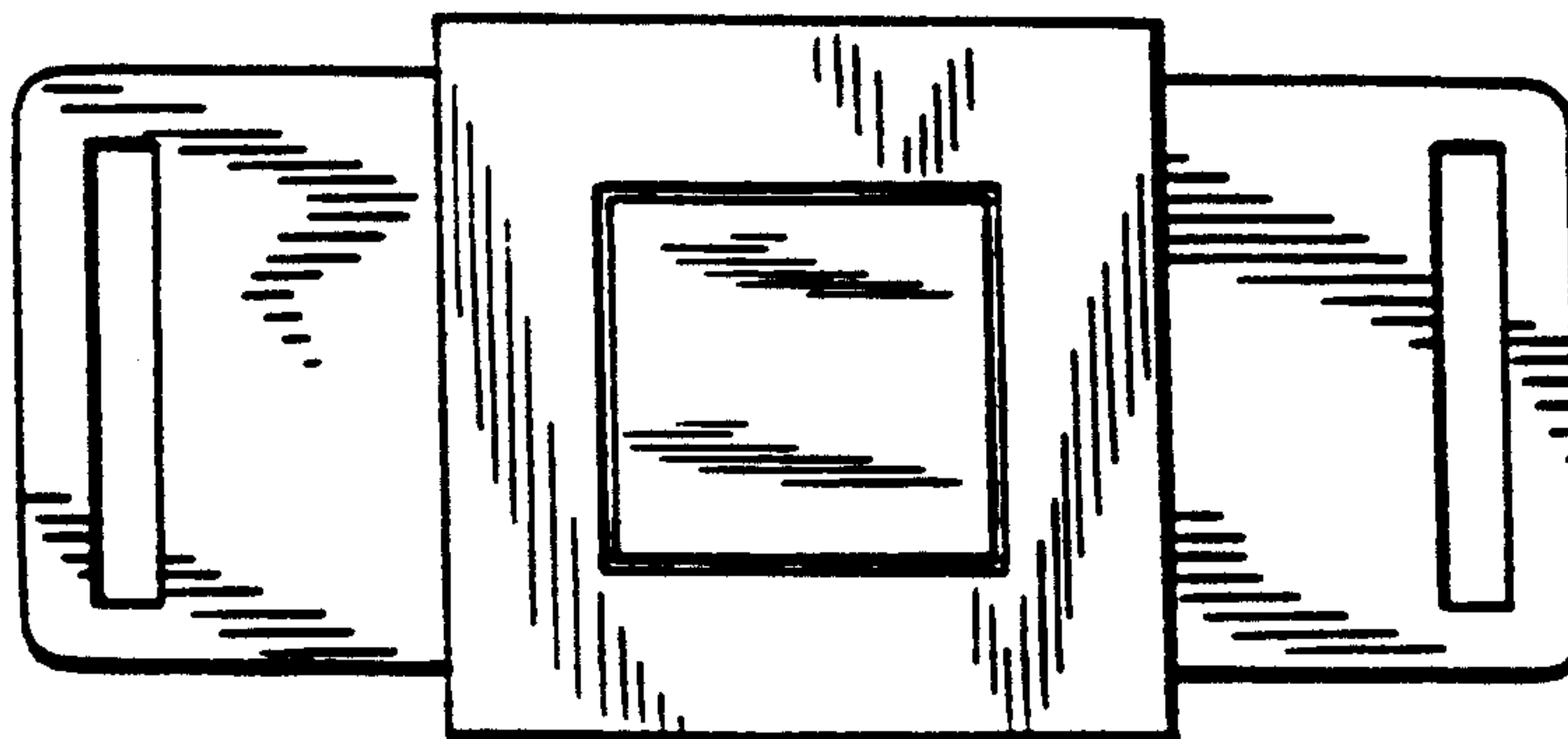

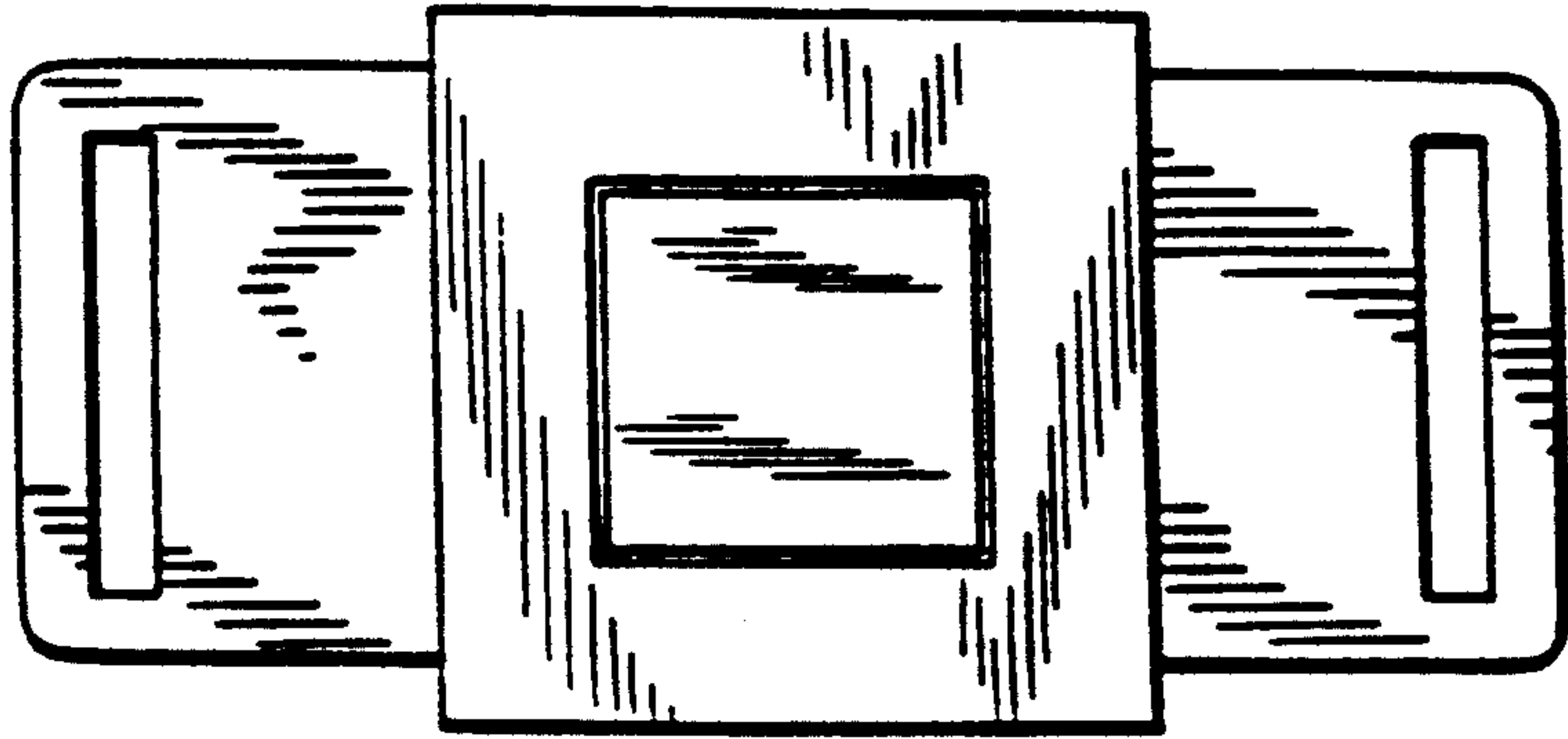
The ornamental design for a buckle, as shown and described.

## DESCRIPTION

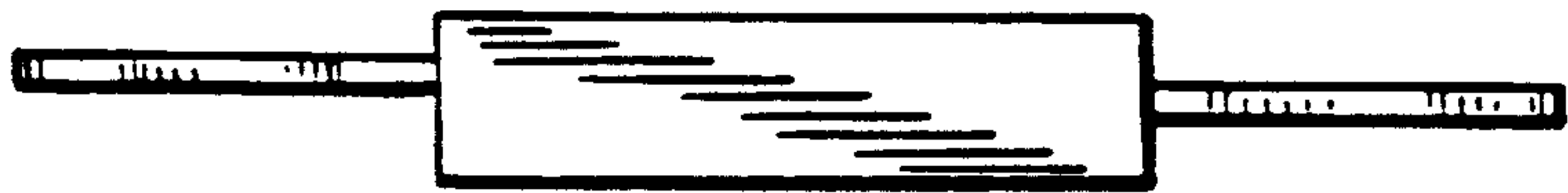
FIG. 1 is a top plan view of a buckle showing my new design;

 FIG. 20 is a bottom plan view thereof.



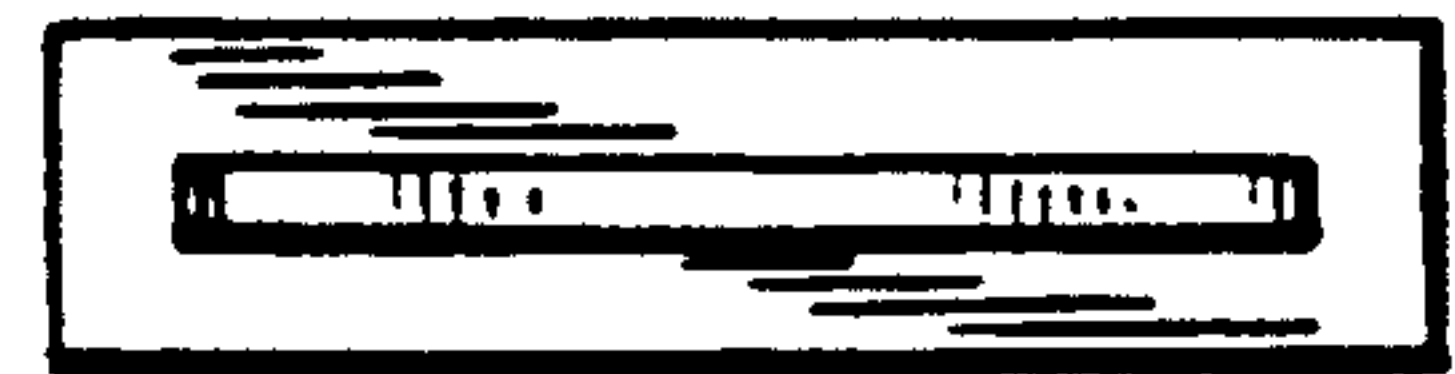
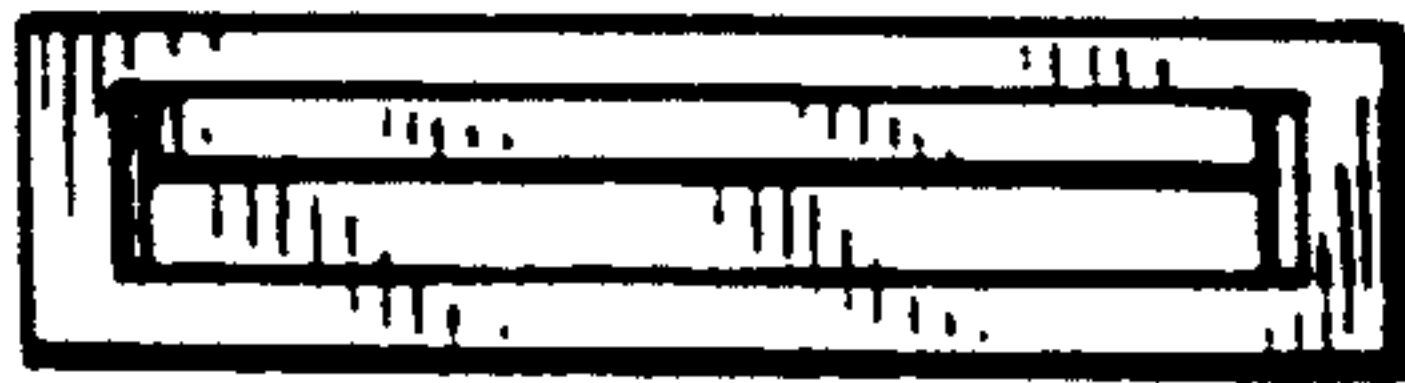

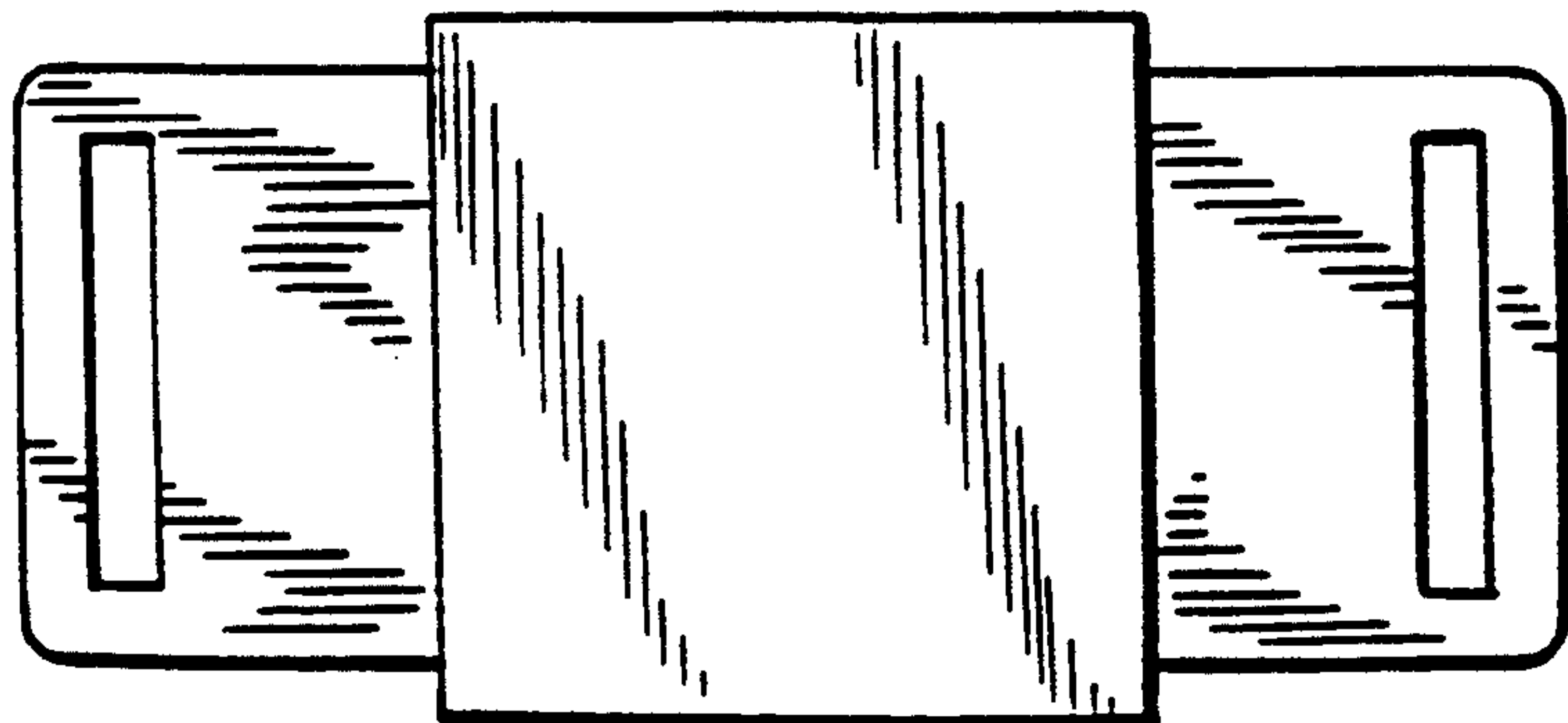

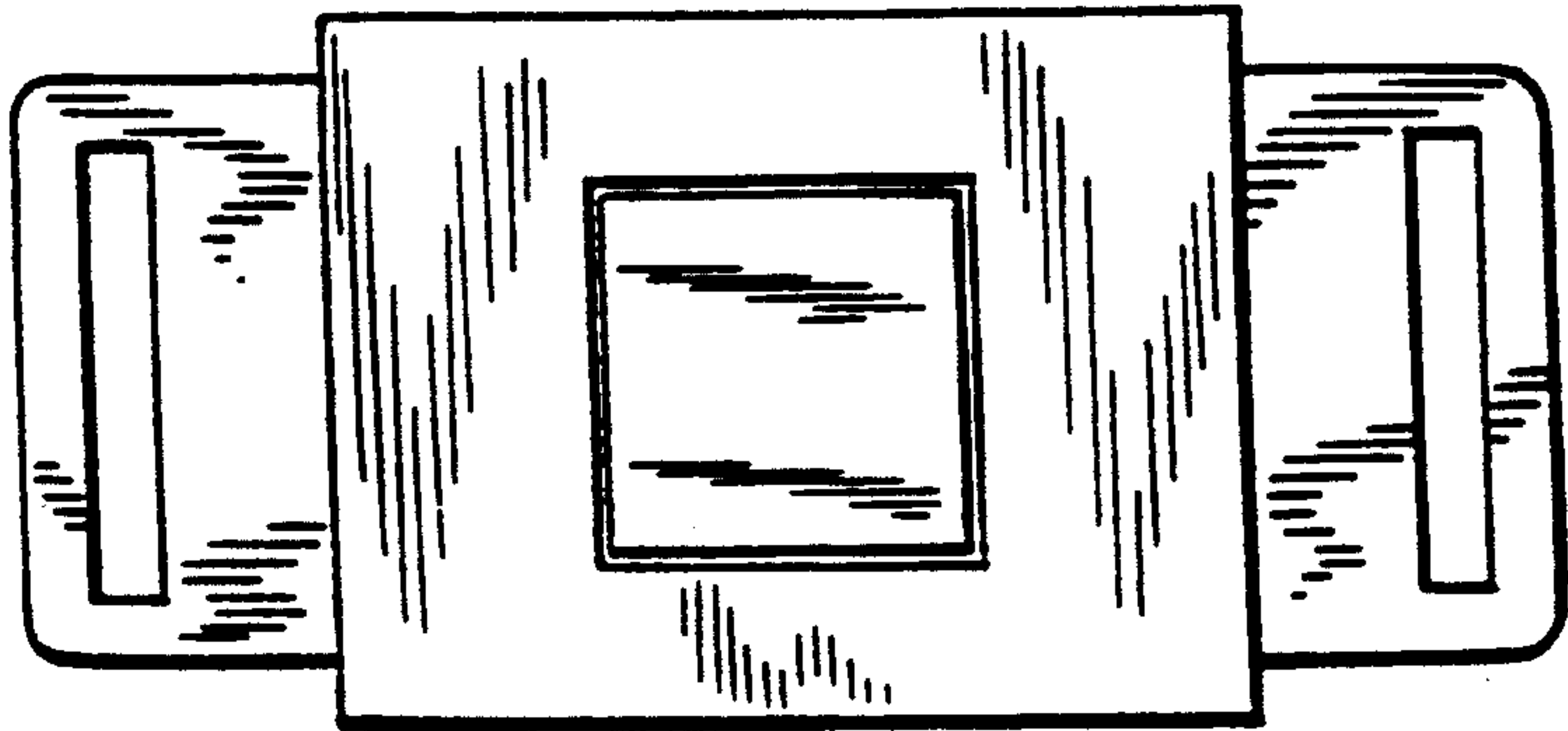

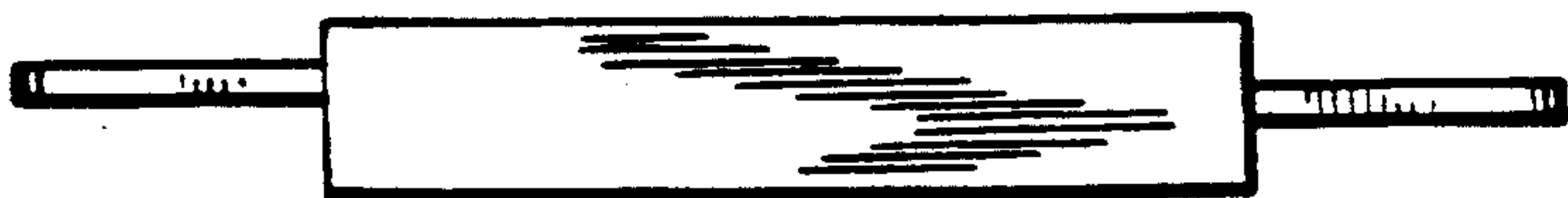

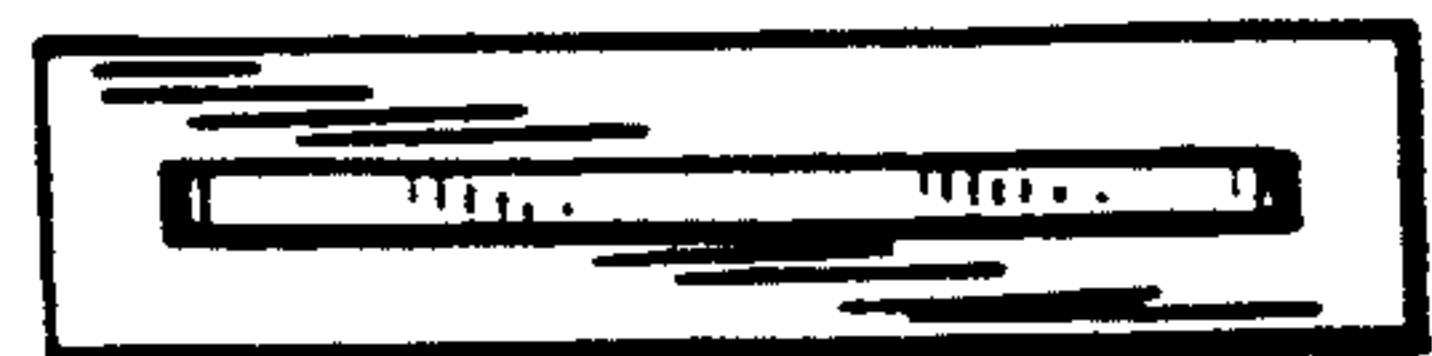
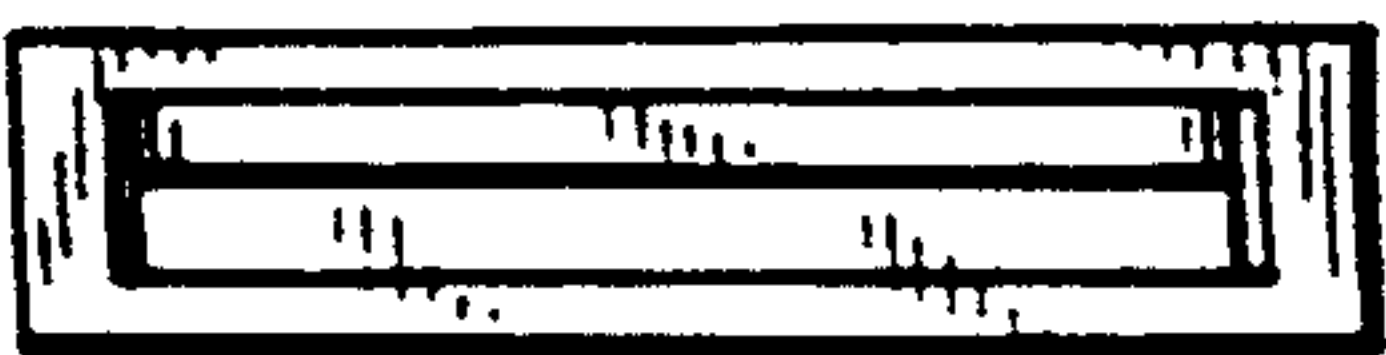

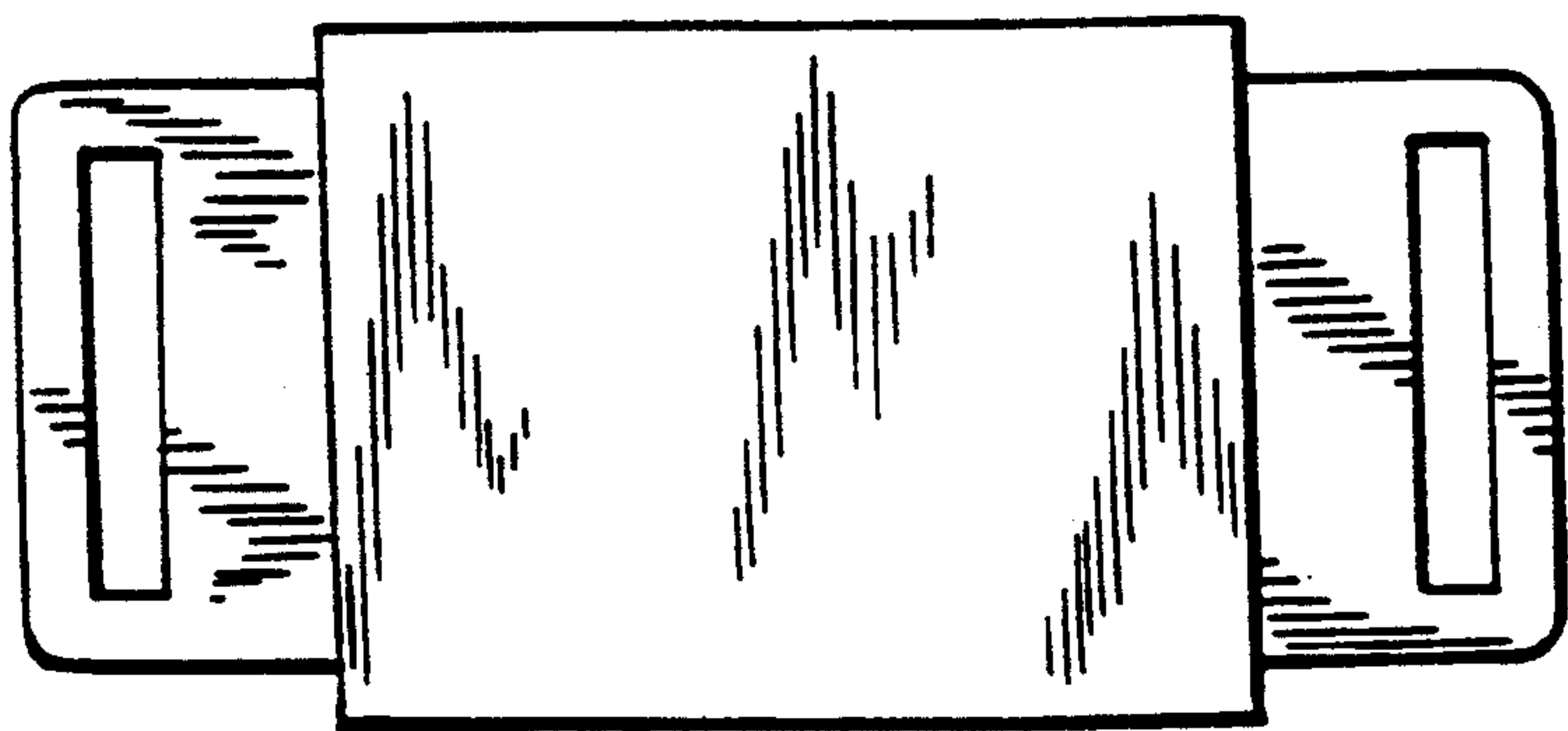

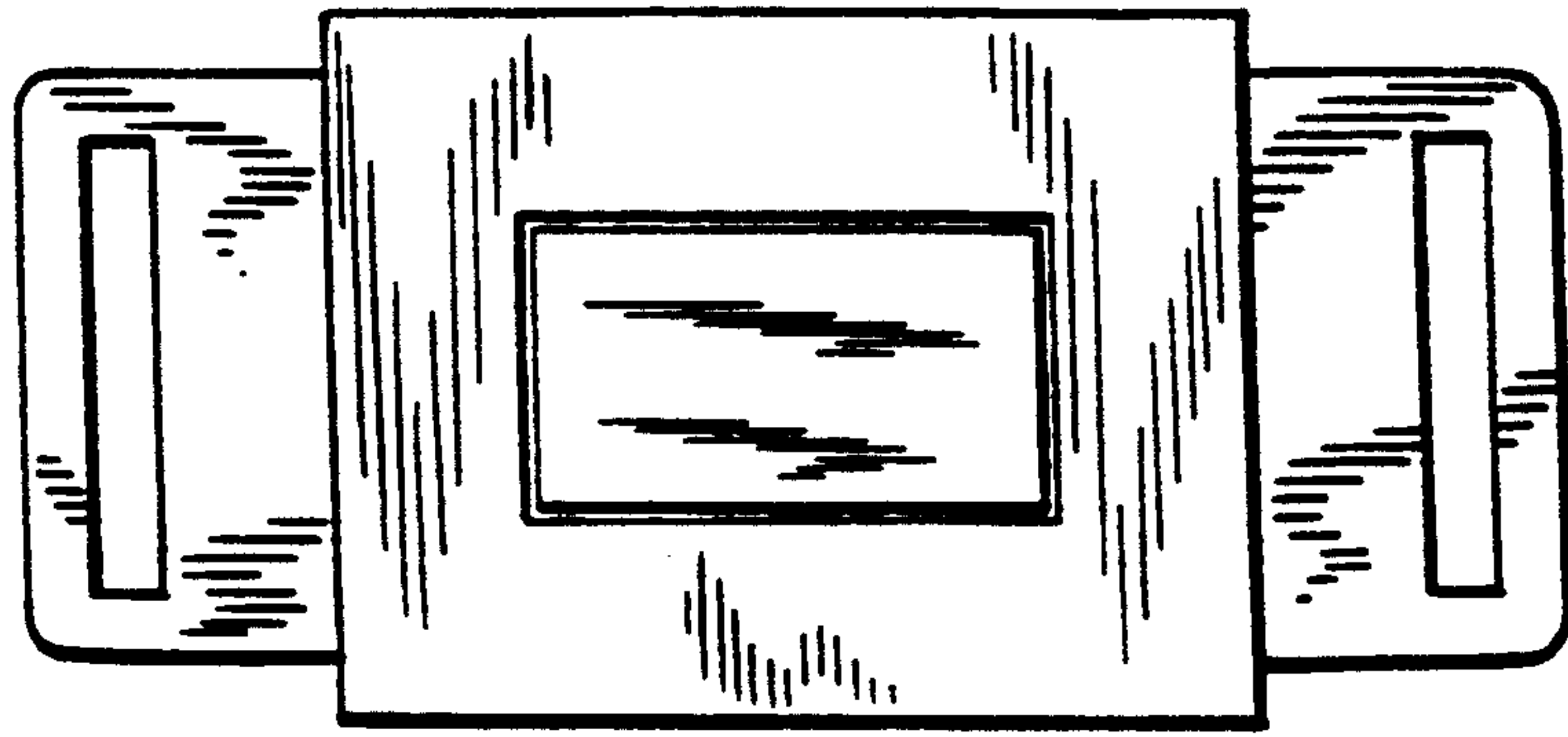

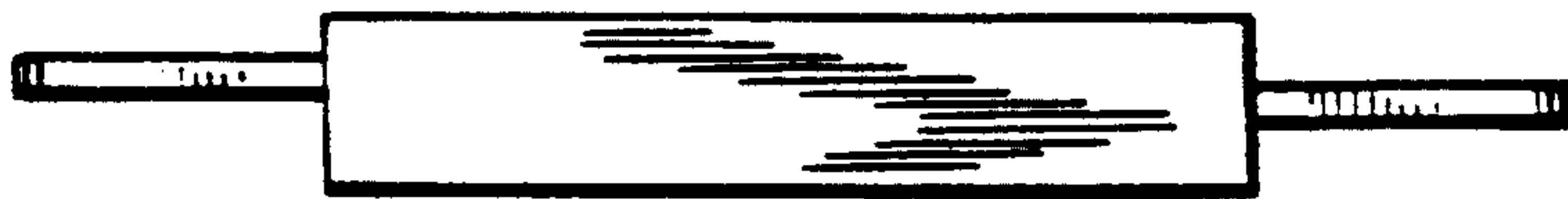

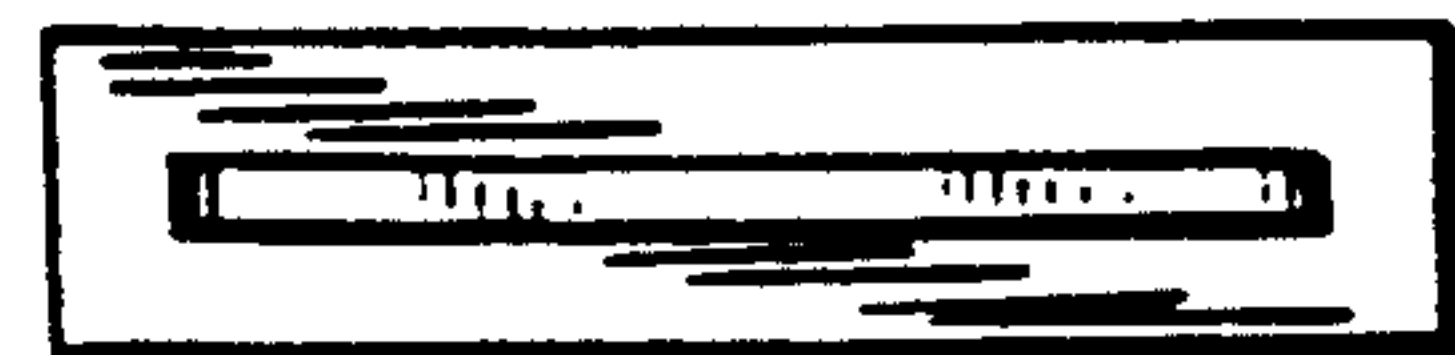
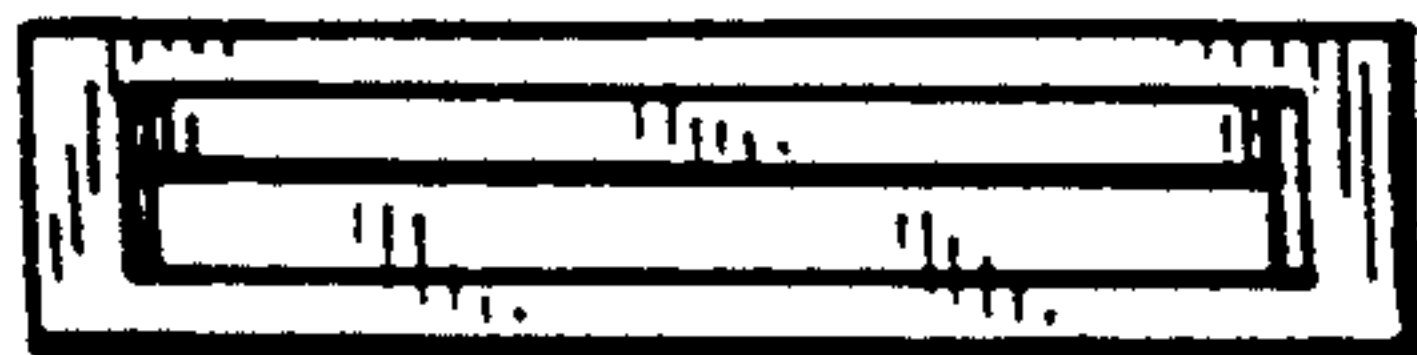

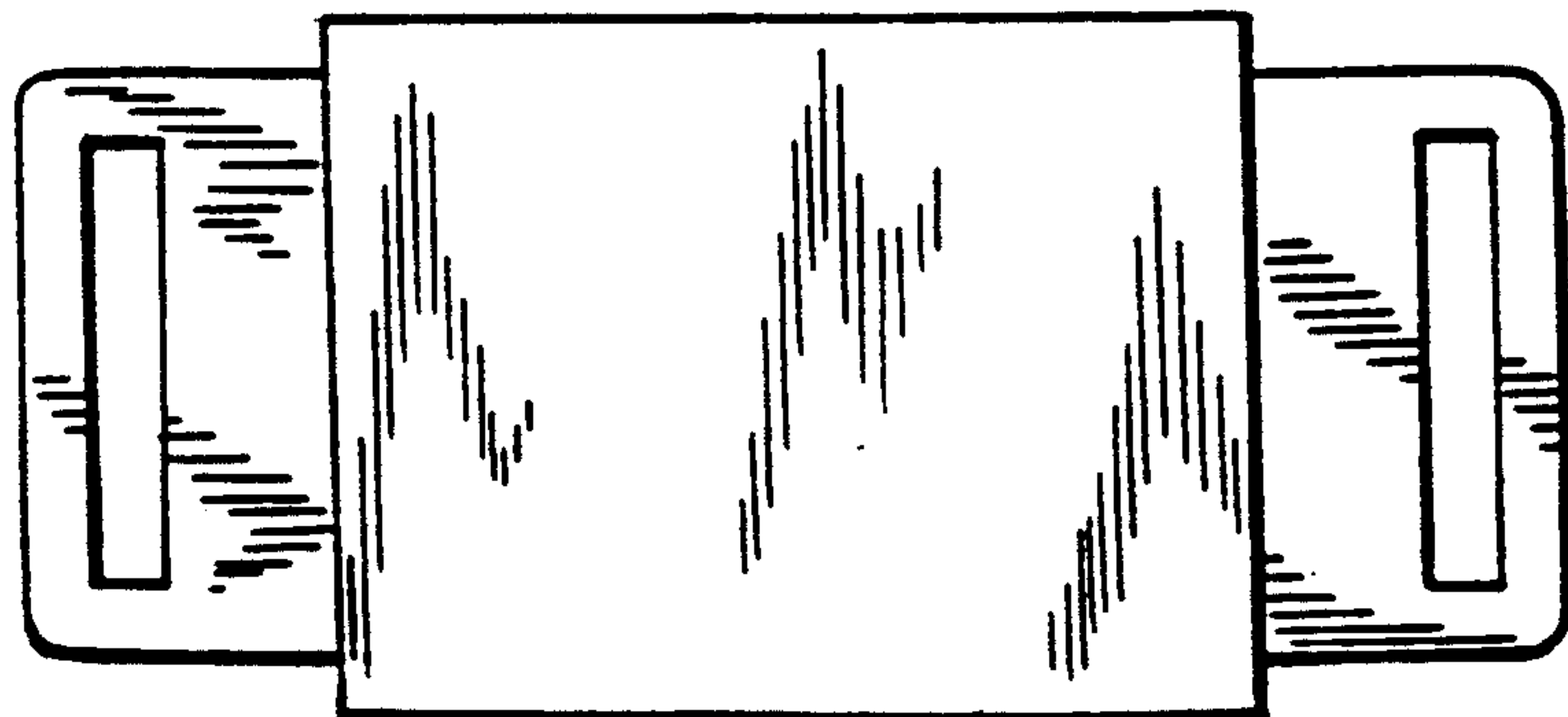

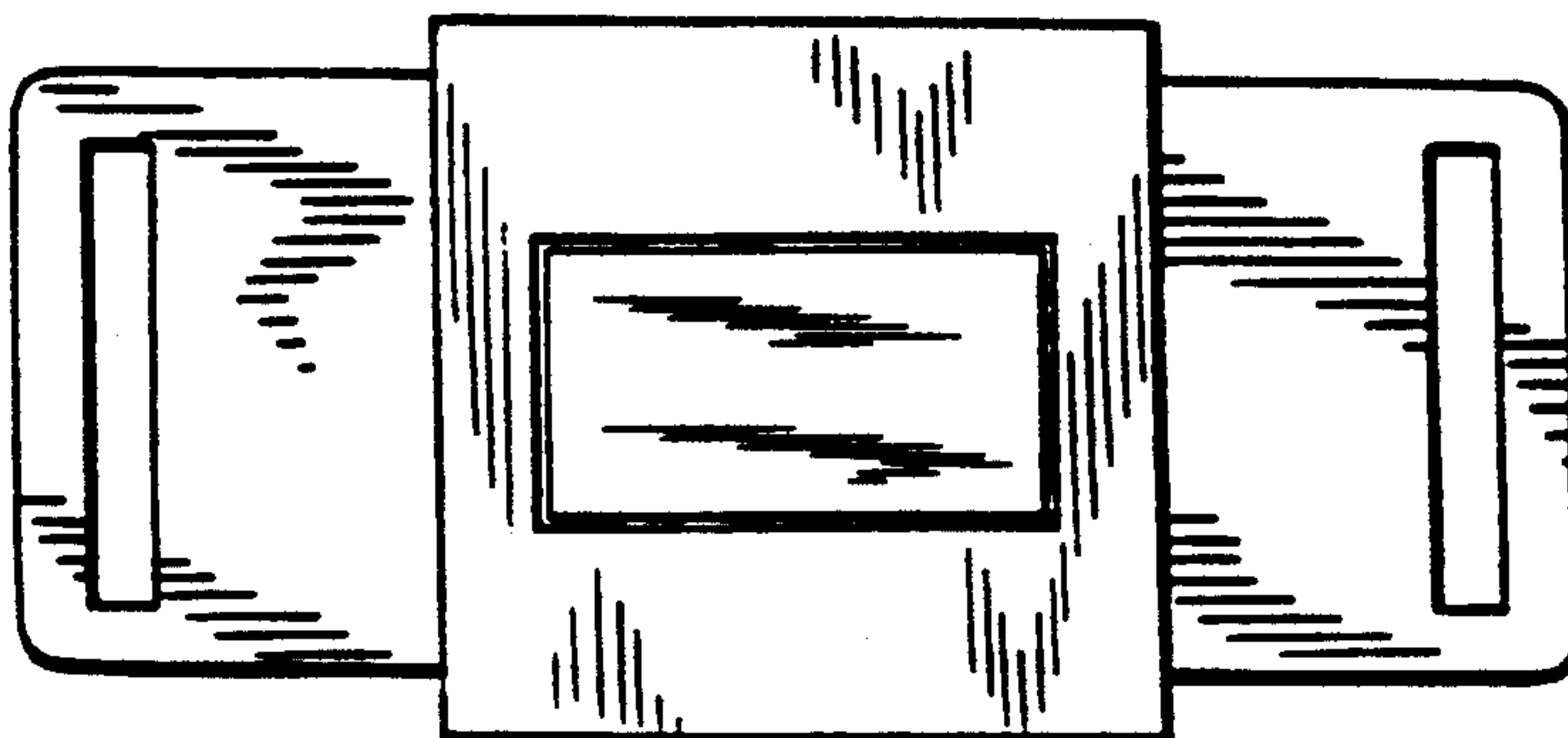

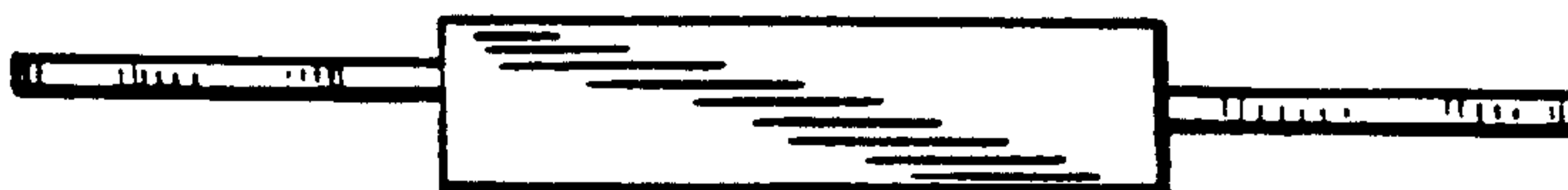

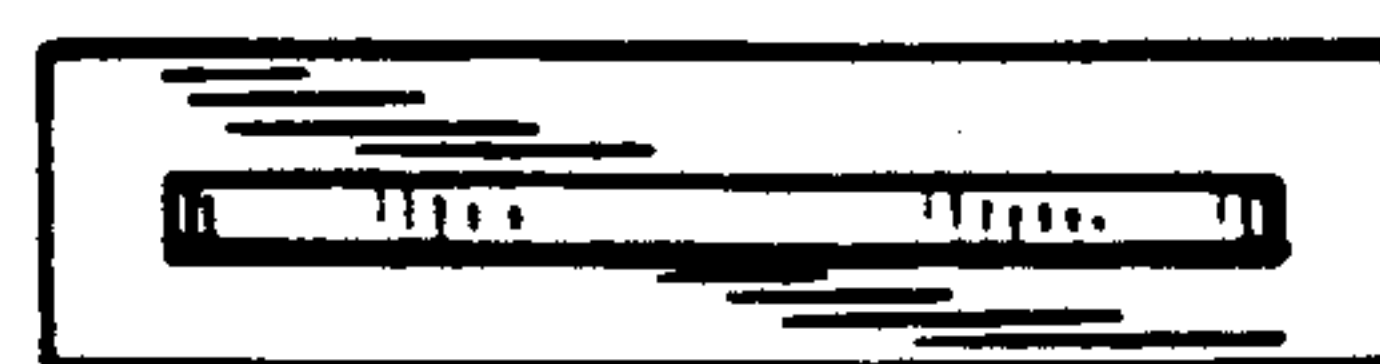
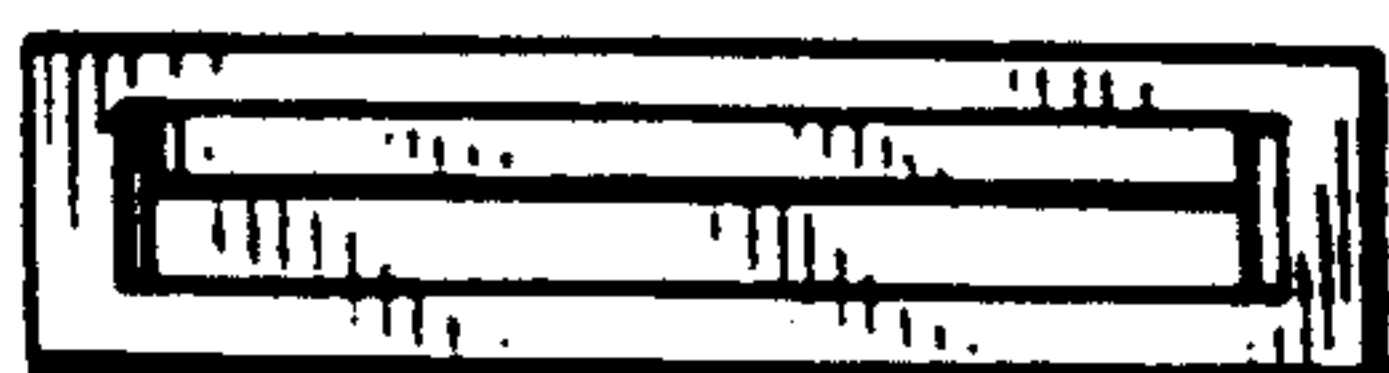
