The ornamental design for a dry shaver, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right side perspective view showing our new design with the roller-shutter portion retracted;

FIG. 3 is a rear elevational view thereof;

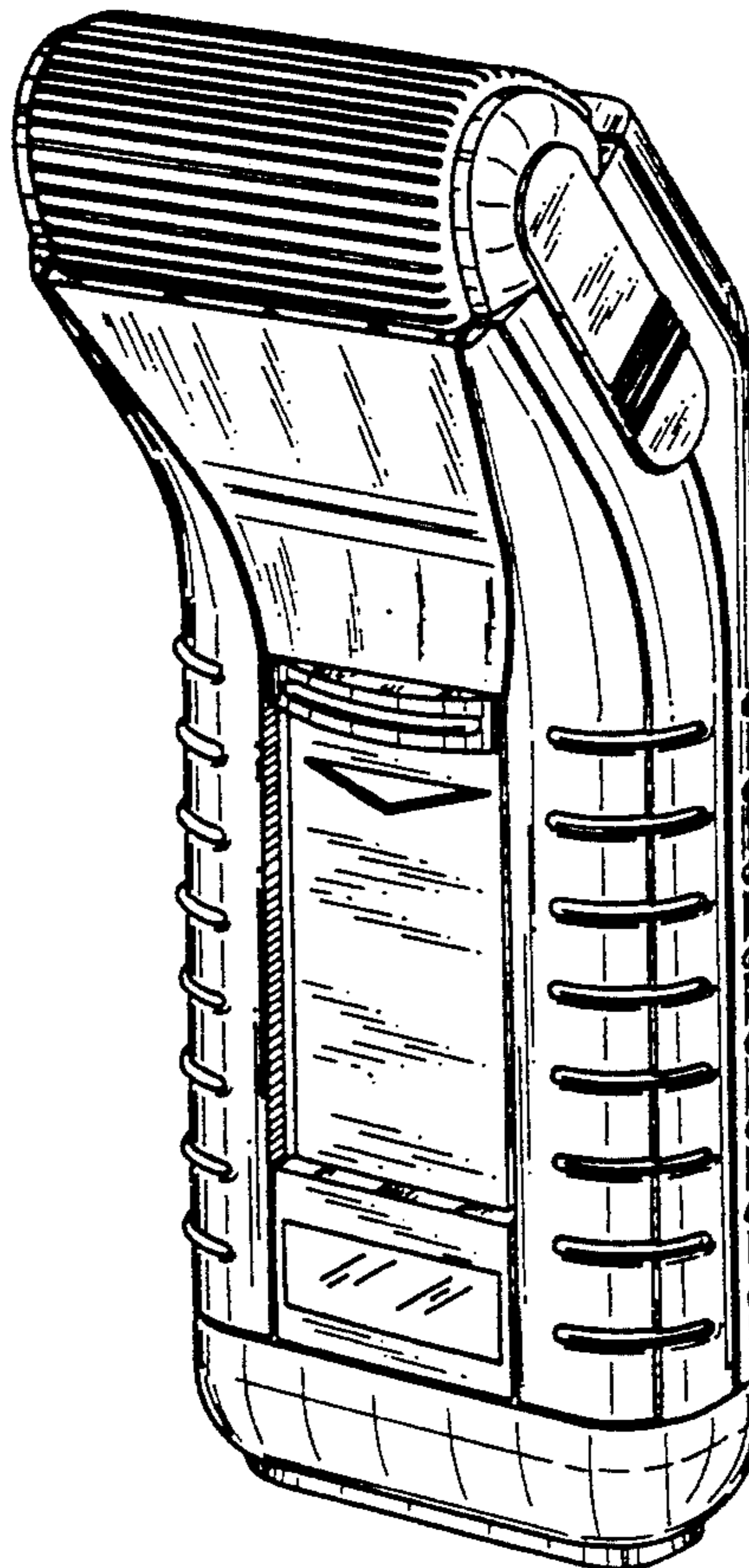
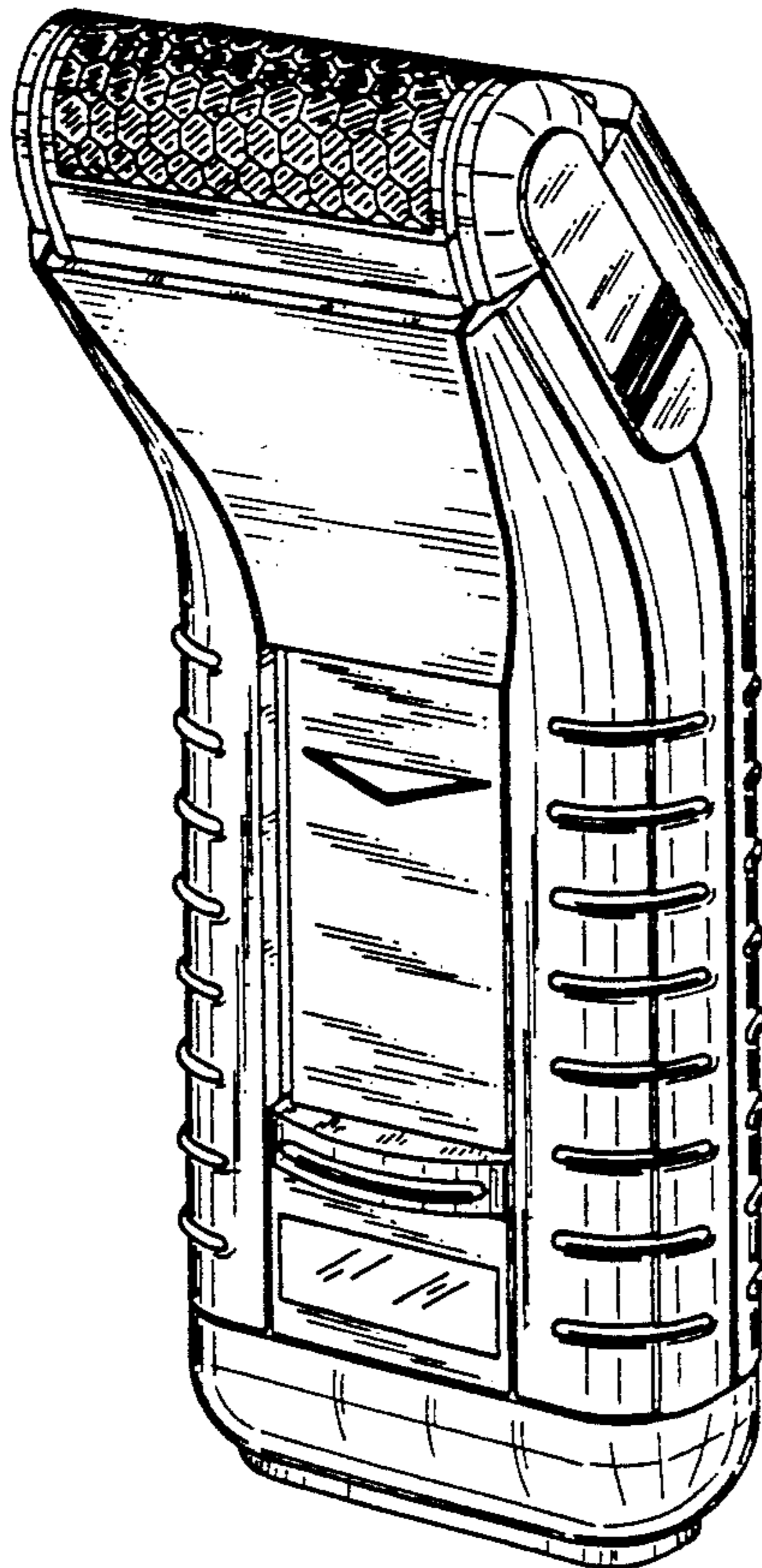
FIG. 4 is a right side elevational view thereof;

FIG. 8 is a front, top, right side perspective view showing our new design with the roller-shutter extended to cover the shaving head portion.



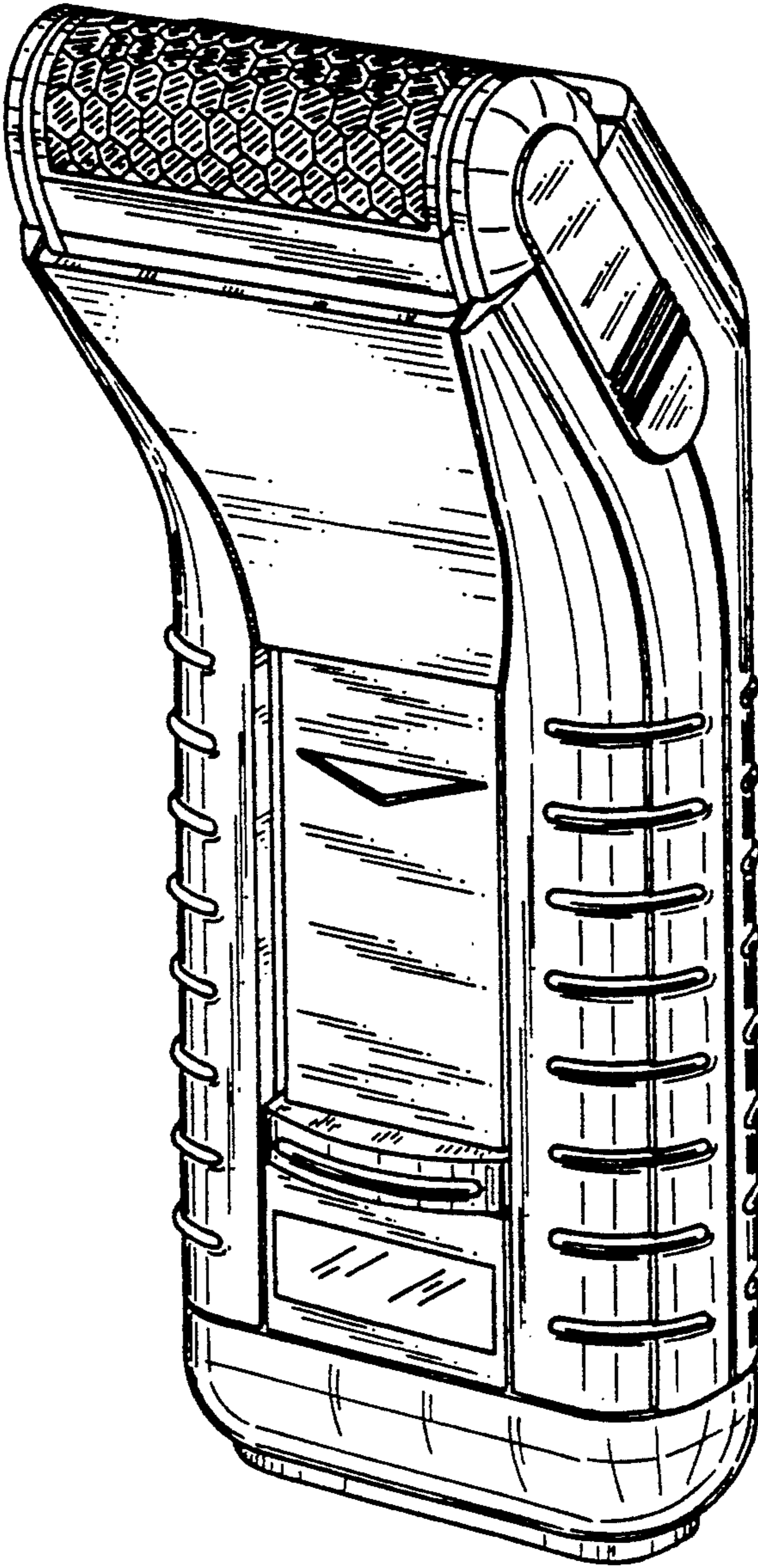

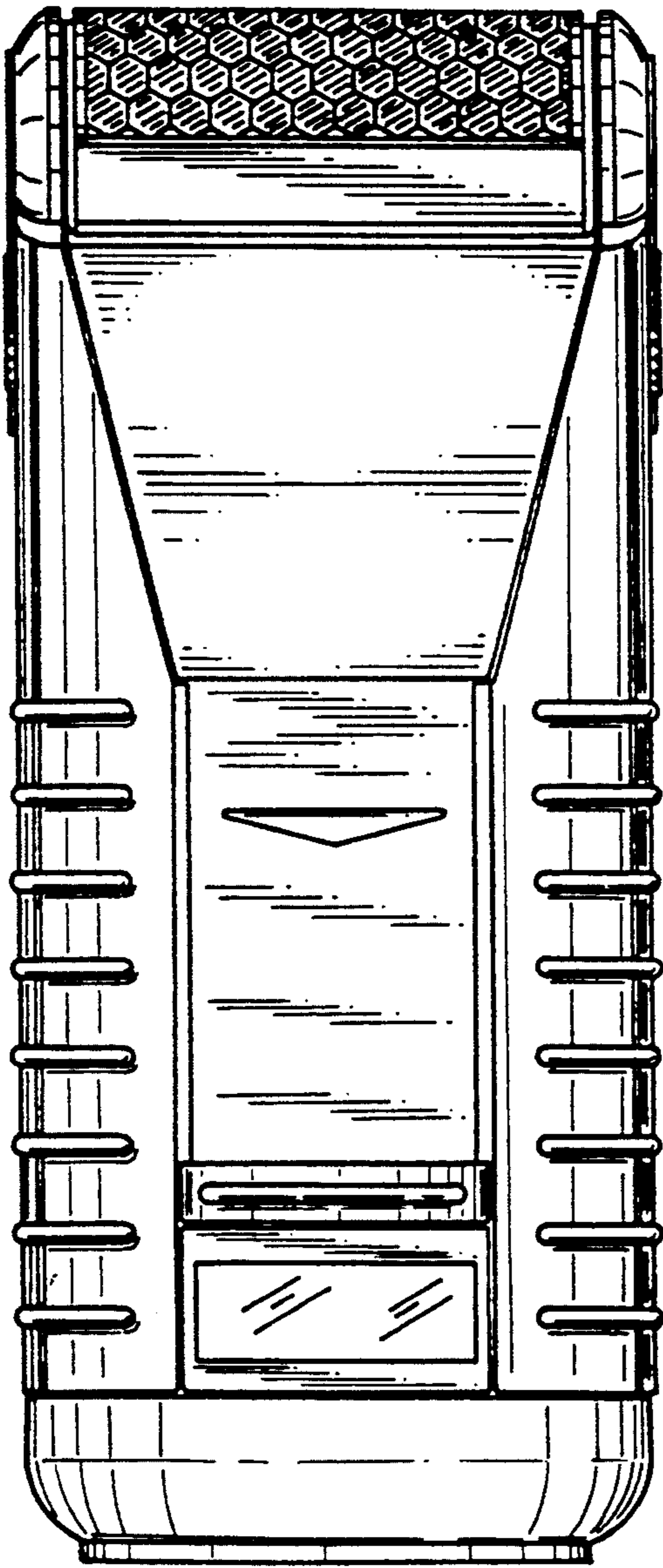

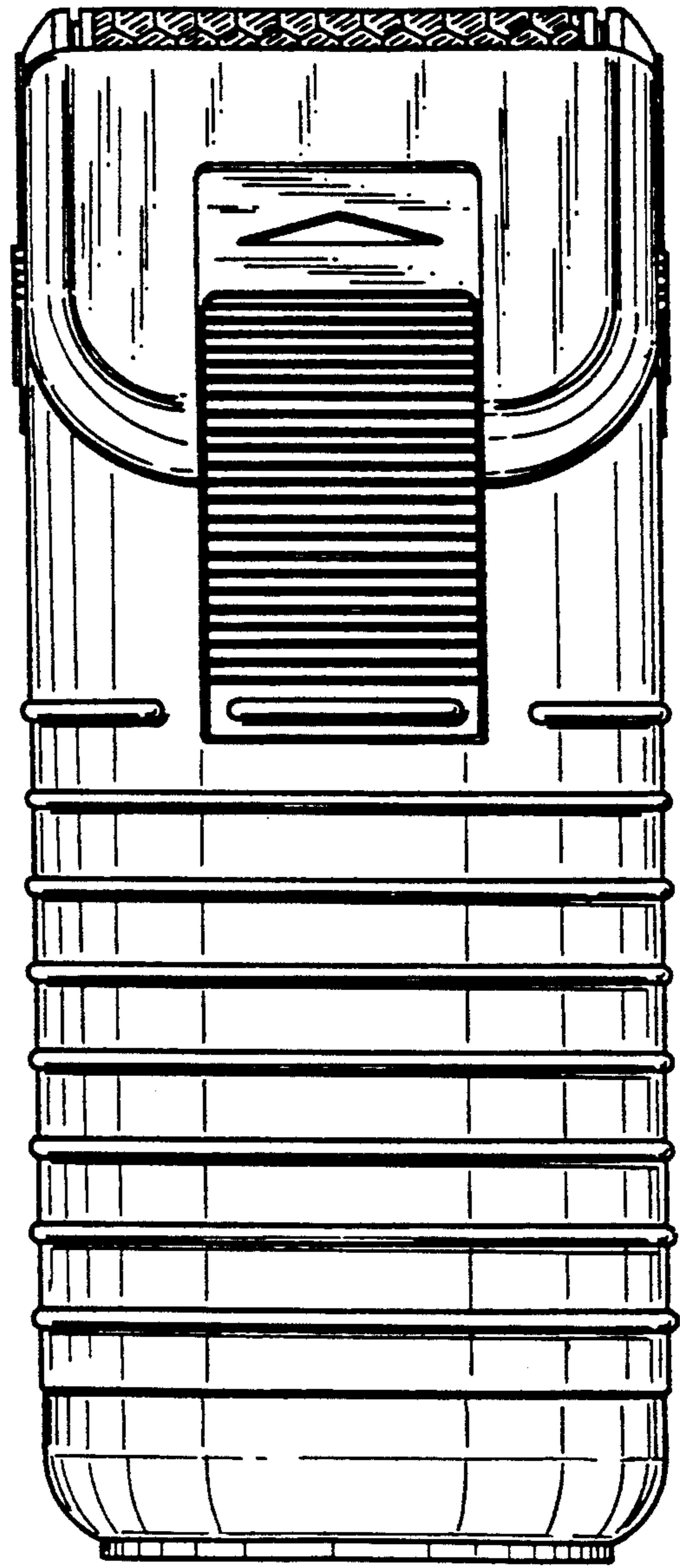

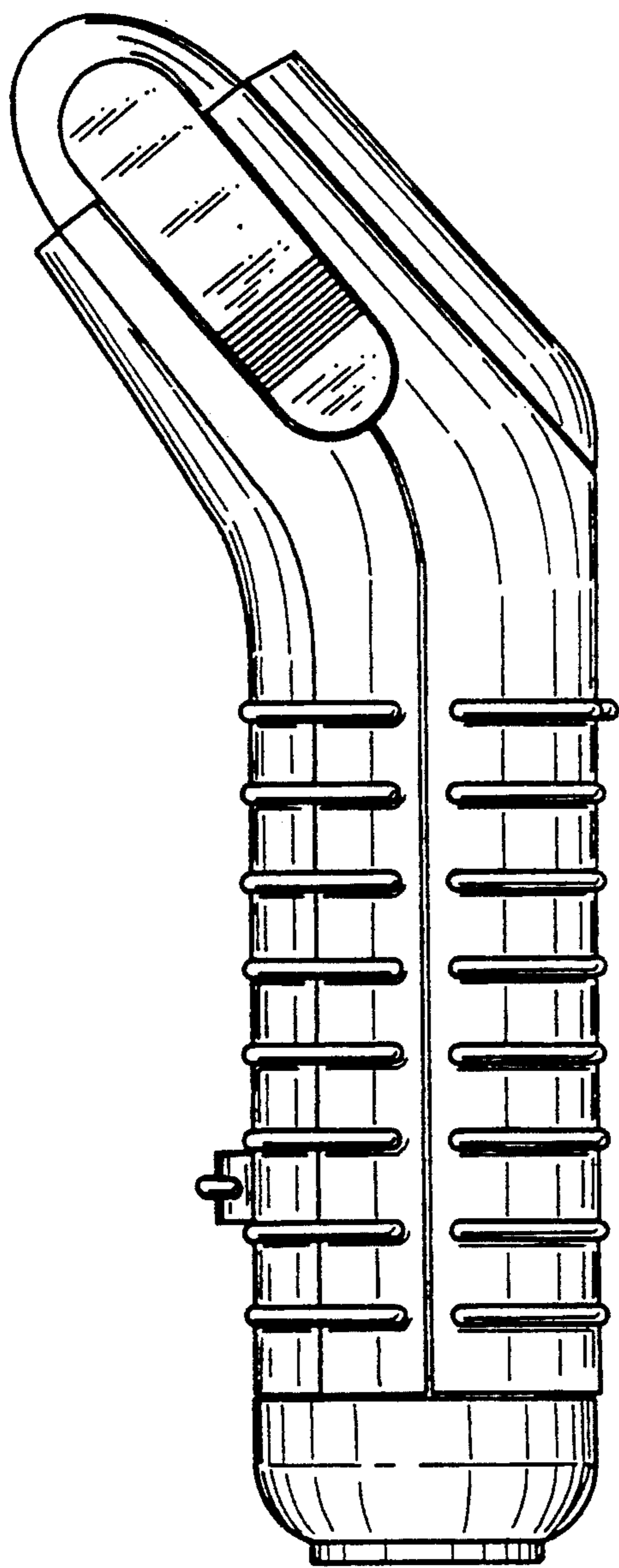

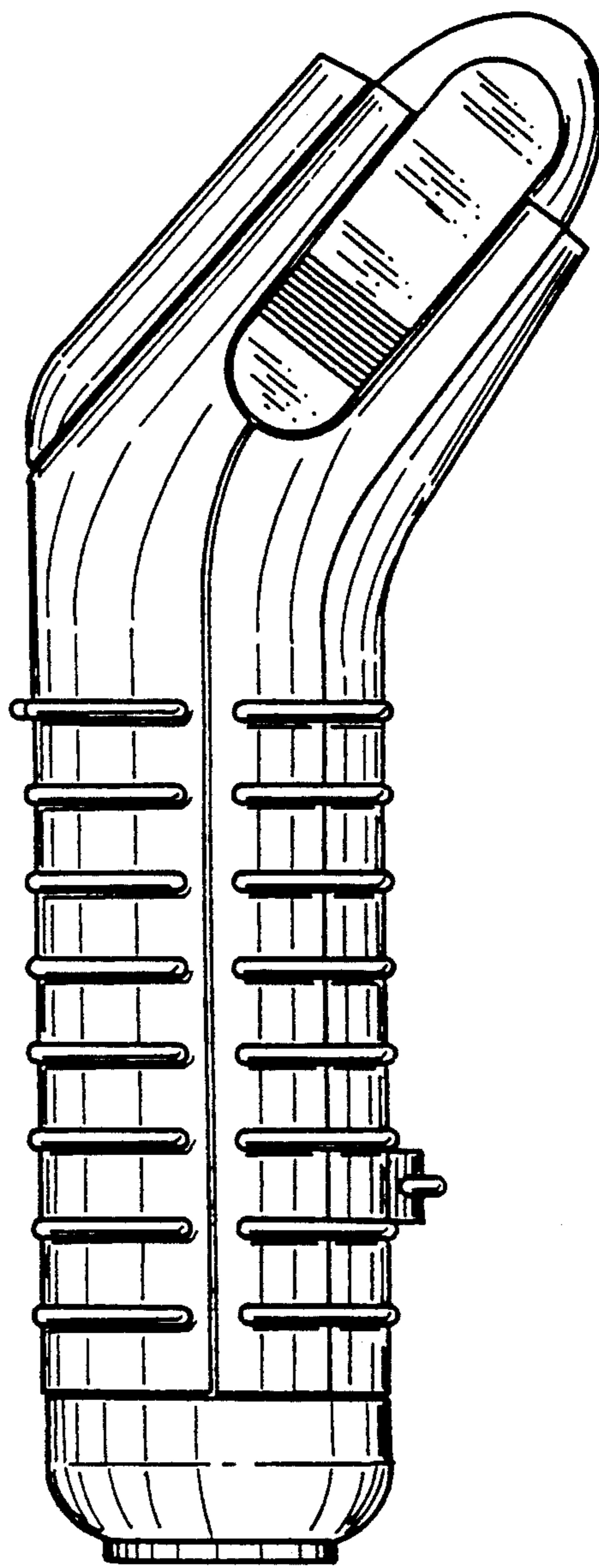

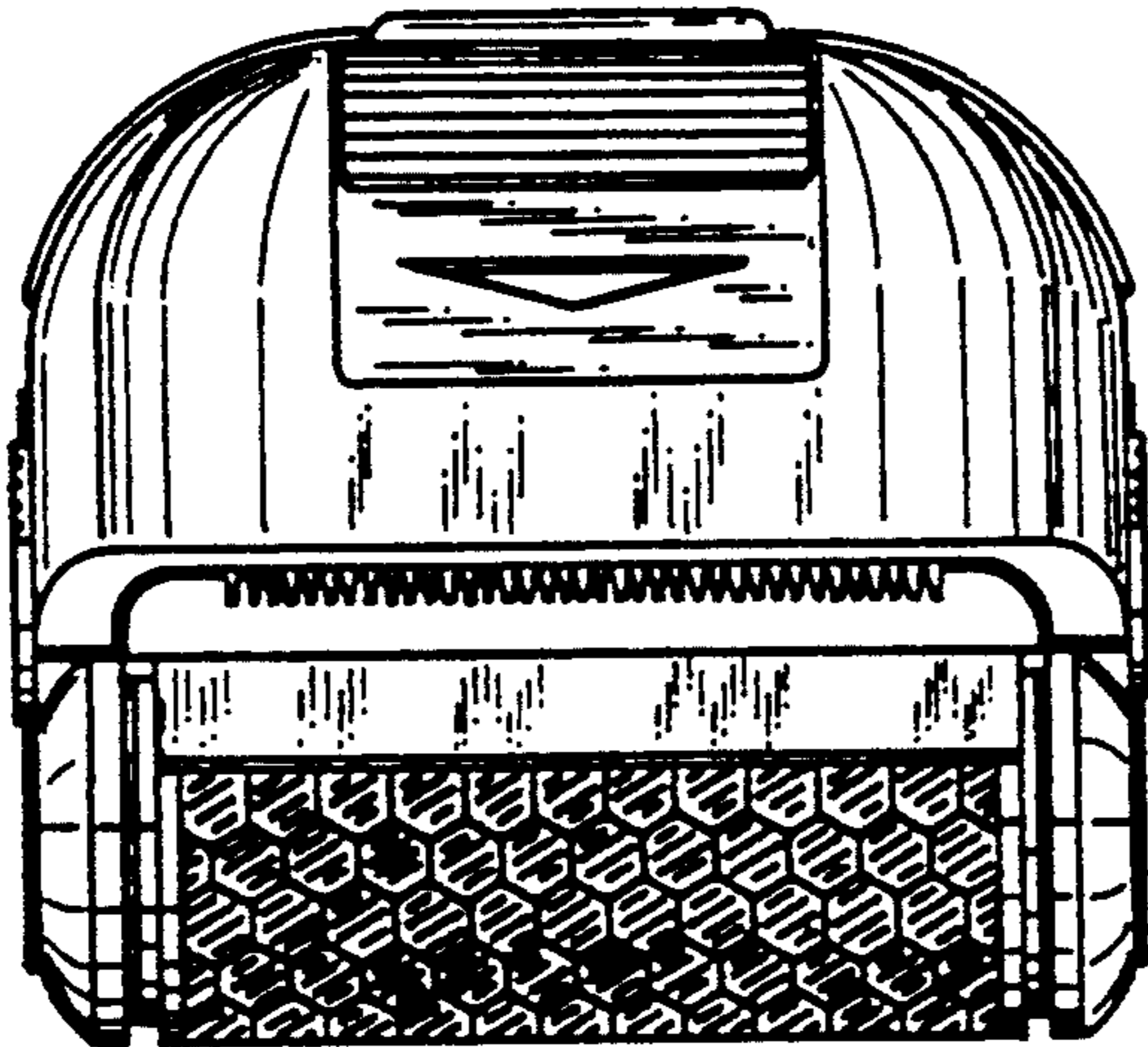

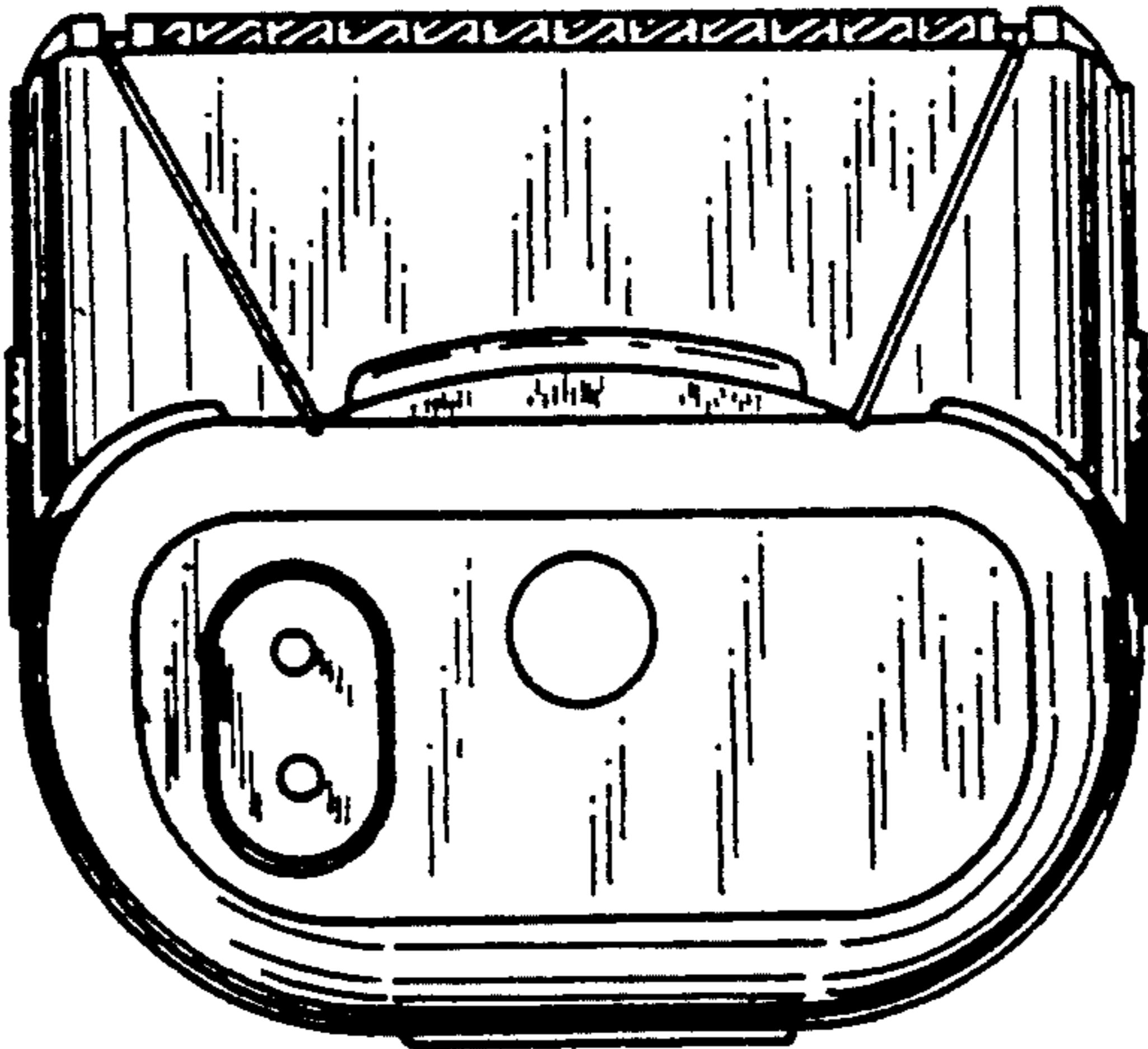

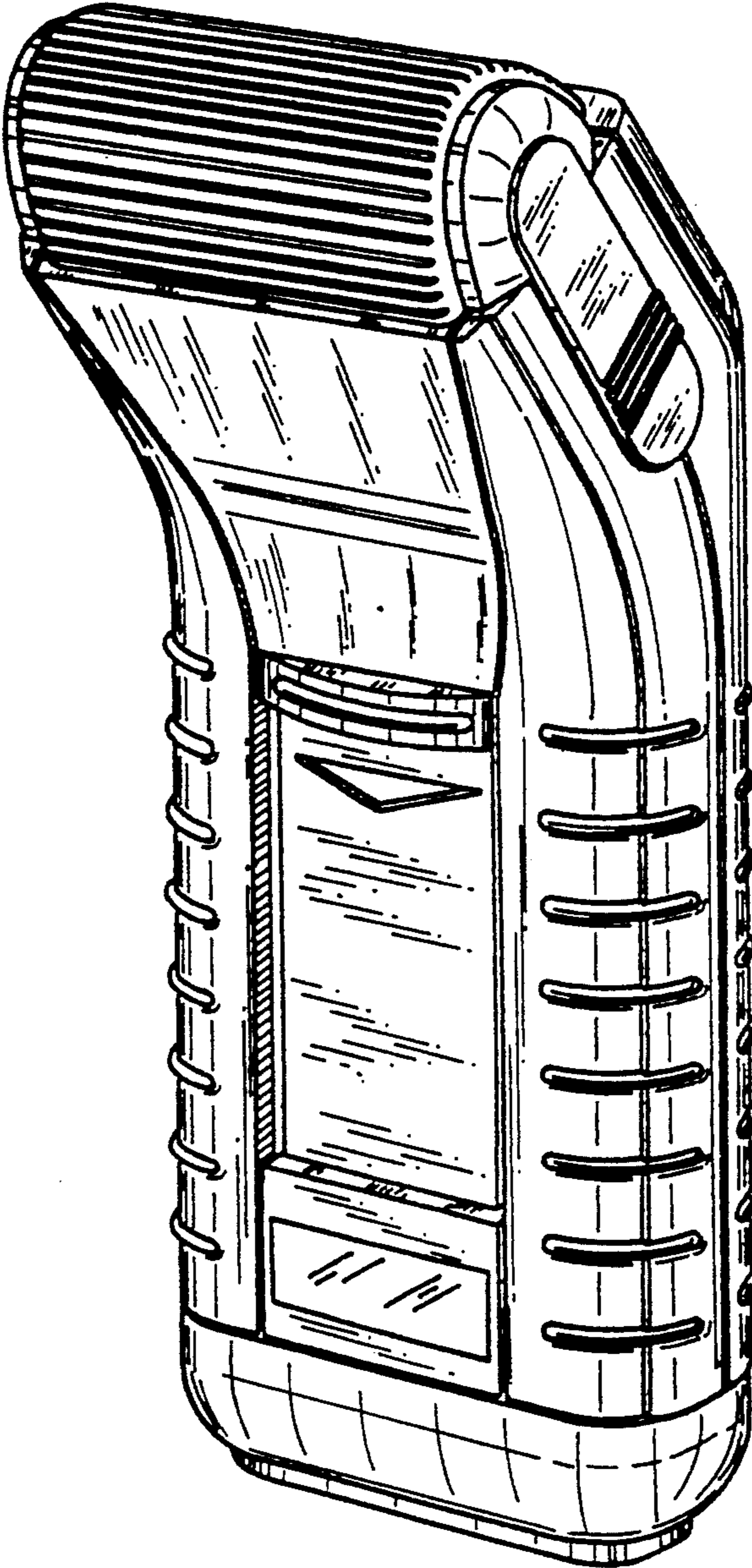
