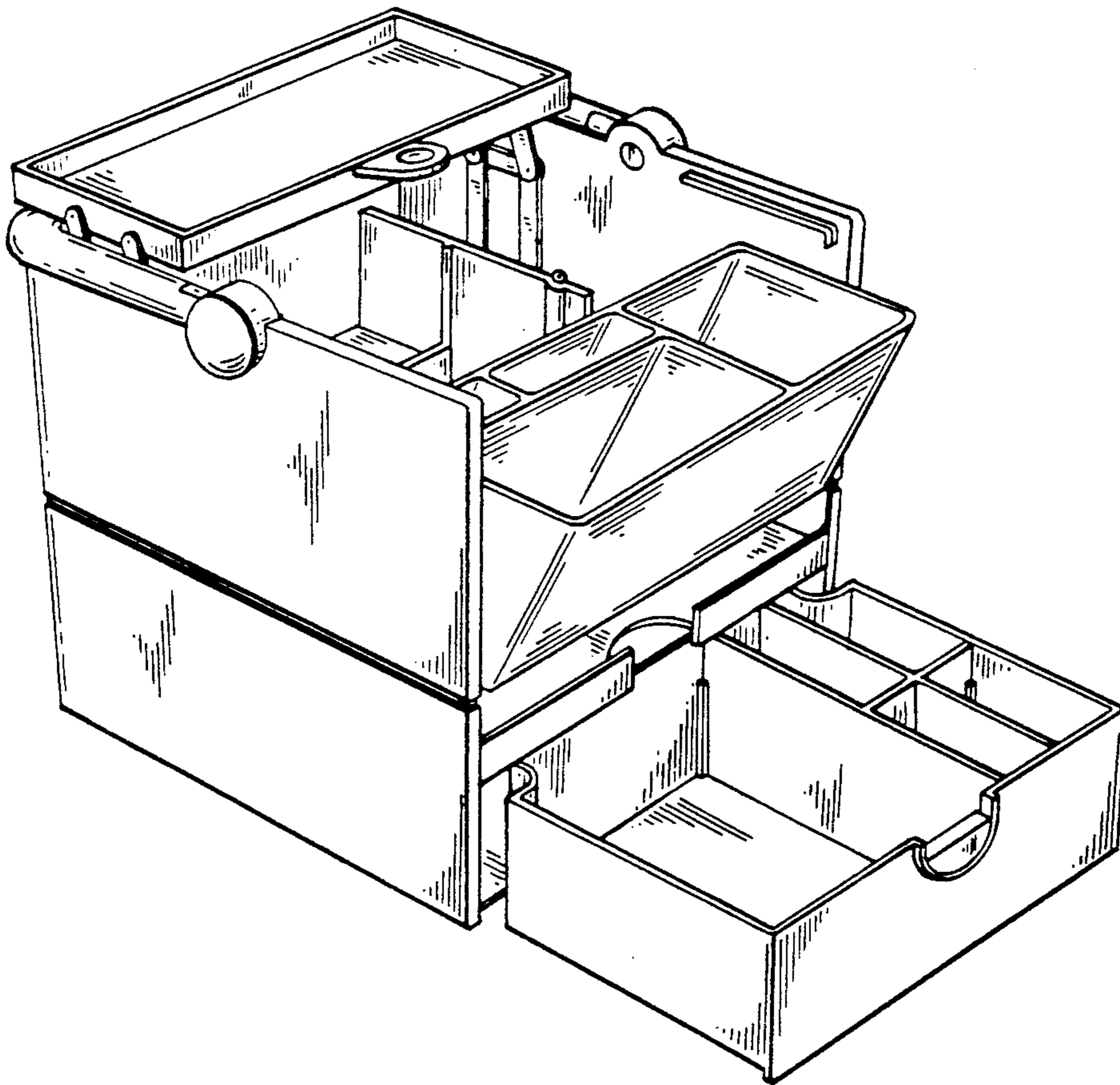

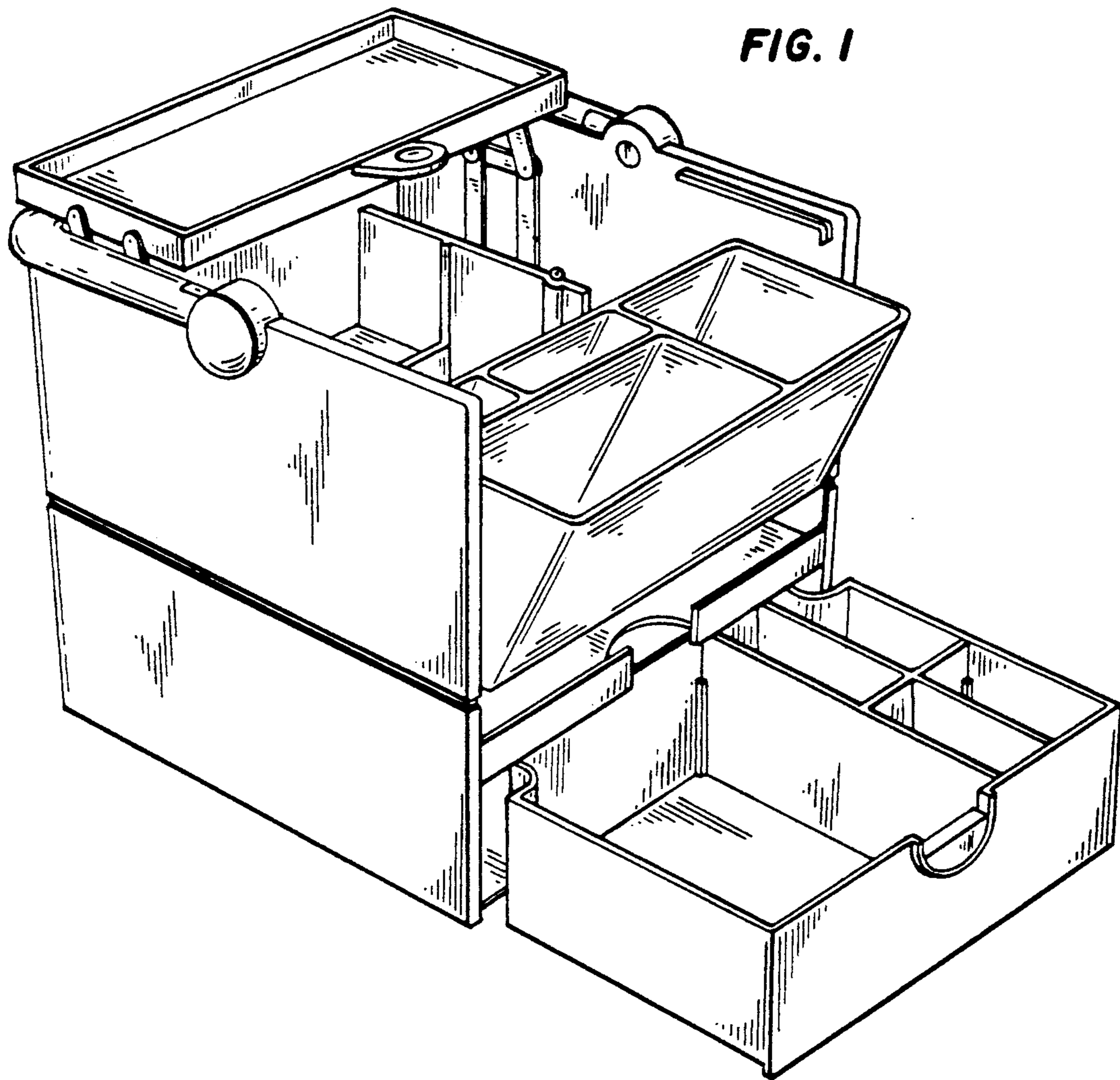
[57] **CLAIM**

The ornamental design for an organizer for sewing supplies, as shown.

DESCRIPTION

FIG. 1 is a perspective view of an organizer for sewing supplies in accordance with the present invention; FIG. 2 is an elevational view of the front, referenced to the view depicted in FIG. 1, of an organizer for sewing supplies in accordance with the present invention; FIG. 3 is an elevational view of the rear, referenced to the view depicted in FIG. 1, of an organizer for sewing supplies in accordance with the present invention; FIG. 4 is an elevational view of the top, referenced to the view depicted in FIG. 1, of an organizer for sewing supplies in accordance with the present invention; FIG. 5 is an elevational view of the bottom, referenced to the view depicted in FIG. 1, of an organizer for sewing supplies in accordance with the present invention; and, FIG. 6 is an elevational view of the right side, referenced to the view depicted in FIG. 1, of an organizer for sewing supplies in accordance with the present invention, an elevational view of the left side being a mirror image.





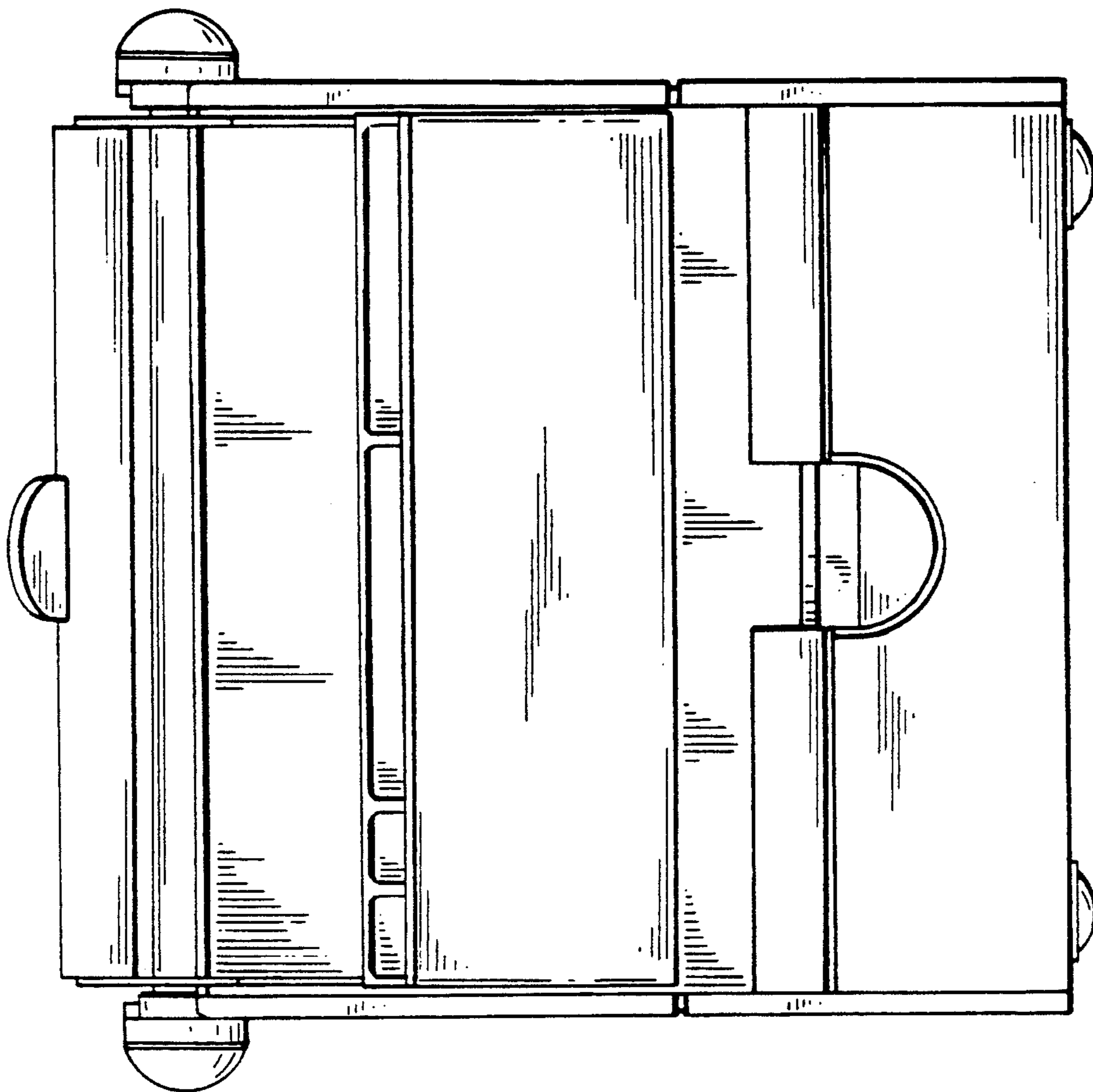

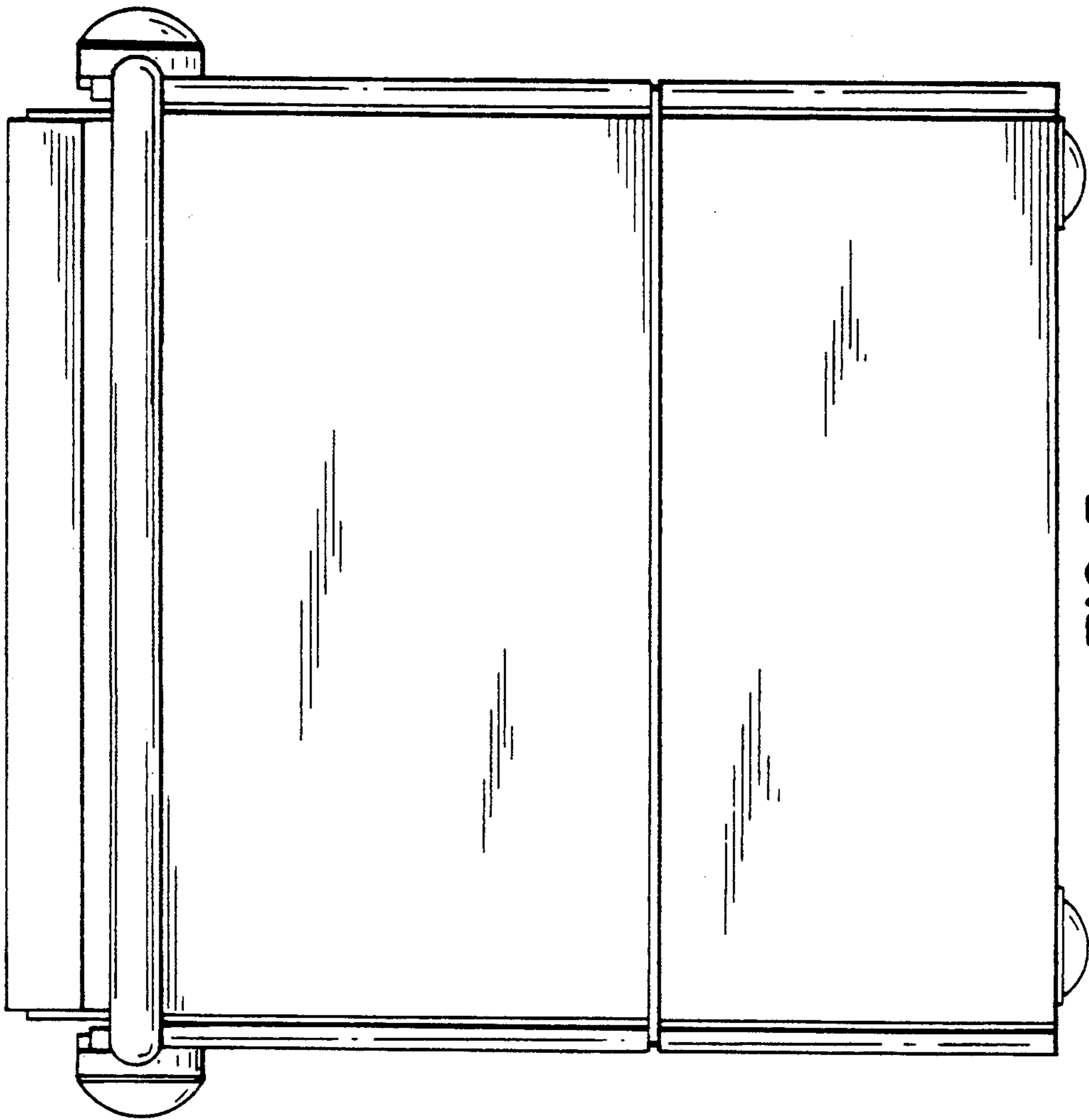

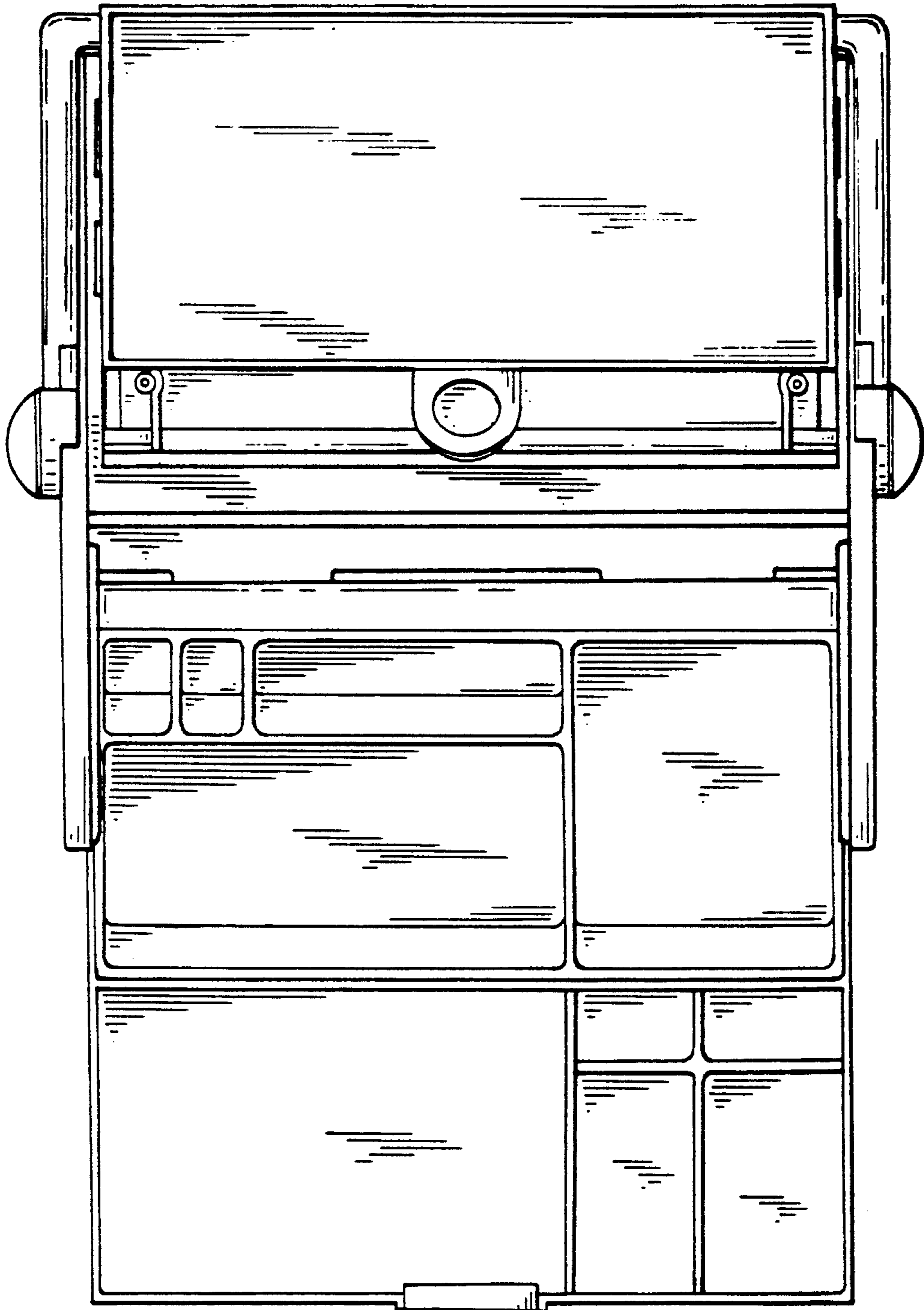

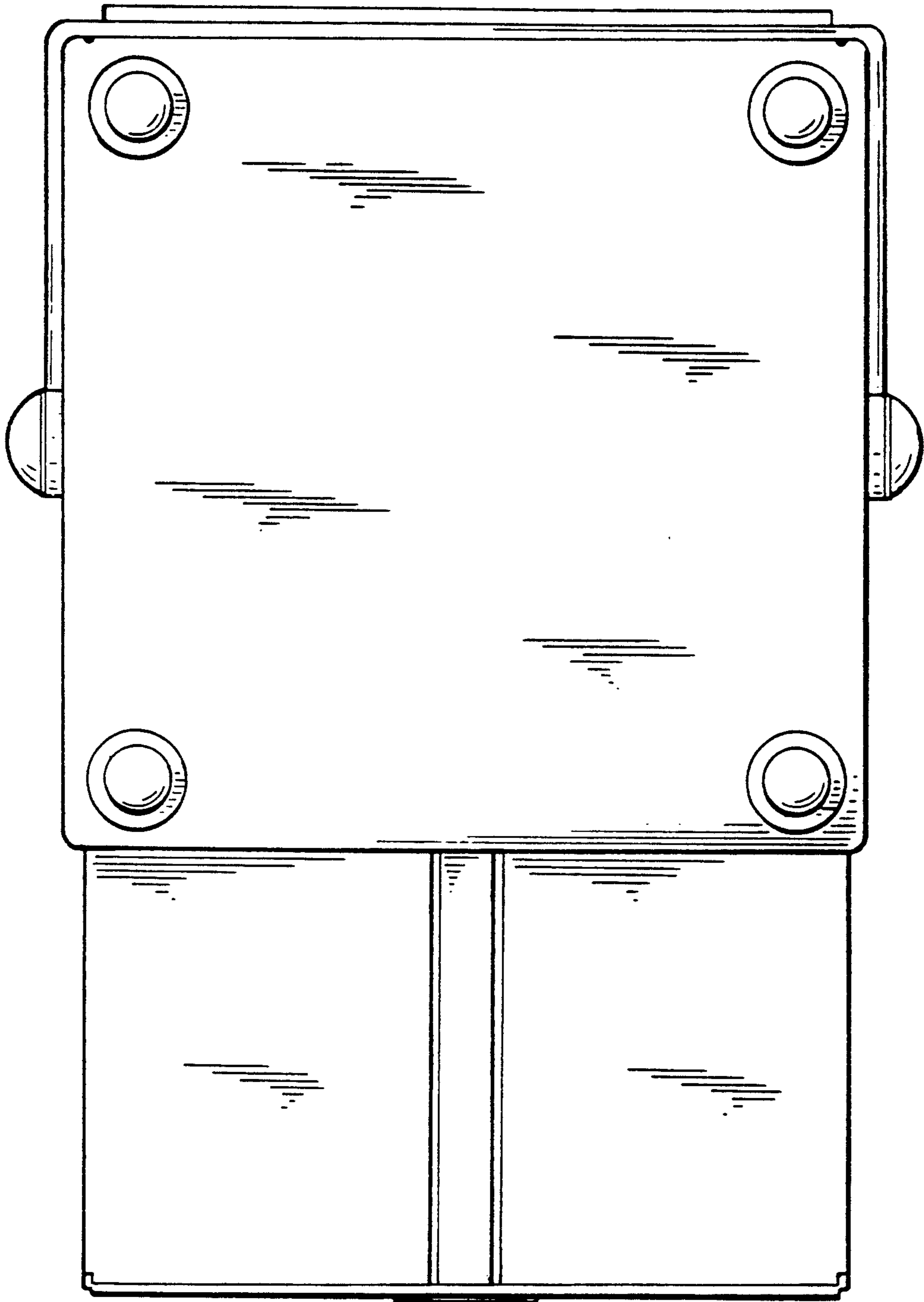

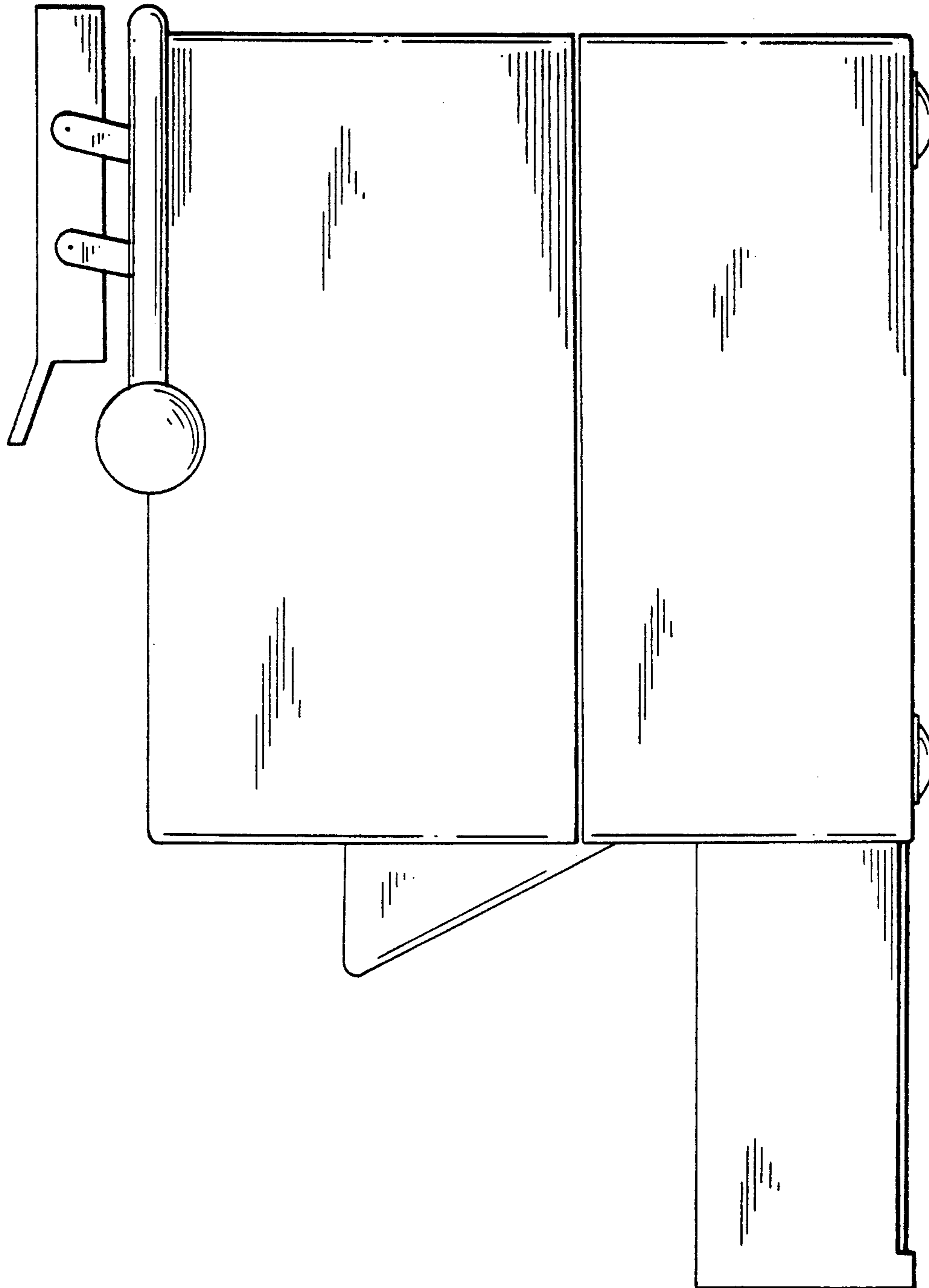
