[57] **CLAIM**

The ornamental design for a hairbrush for spiking hair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the hairbrush for spiking hair of this invention;  
FIG. 2 is a left side elevational view of FIG. 1;  
FIG. 3 is a front elevational view of FIG. 1;  
FIG. 4 is a right side elevational view of FIG. 1;  
FIG. 5 is a rear elevational view of FIG. 1;  
FIG. 6 is a top plan view of FIG. 1; and,  
FIG. 7 is a bottom plan view of FIG. 1;  
FIG. 8 is a perspective view of a second embodiment of the hairbrush for spiking hair of this invention;  
FIG. 9 is a right side elevational view of FIG. 8;  
FIG. 10 is a front elevational view of FIG. 8;  
FIG. 11 is a left side elevational view of FIG. 8;  
FIG. 12 is a rear elevational view of FIG. 8;  
FIG. 13 is a top plan view of FIG. 8; and,  
FIG. 14 is a bottom plan view of FIG. 8.

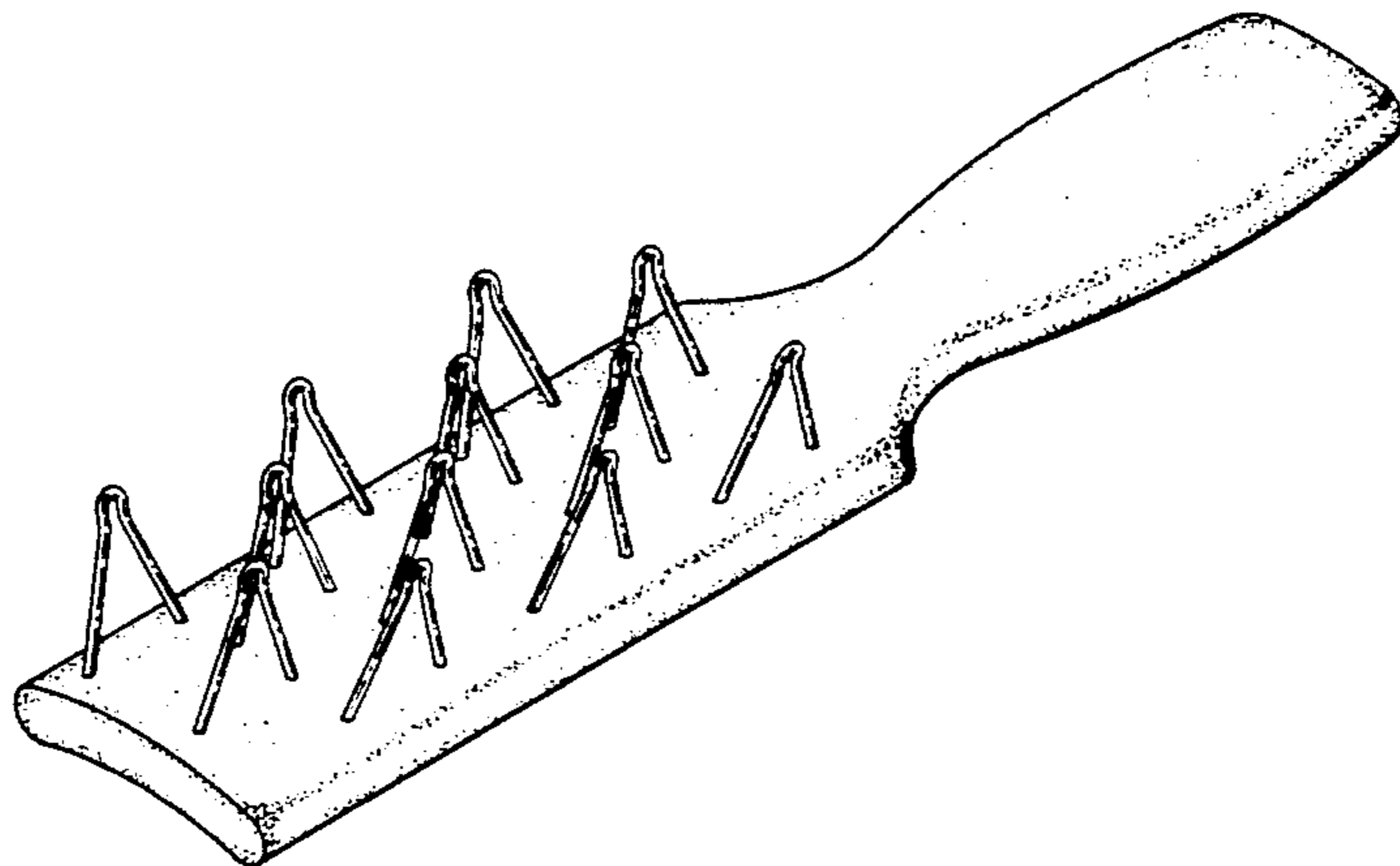
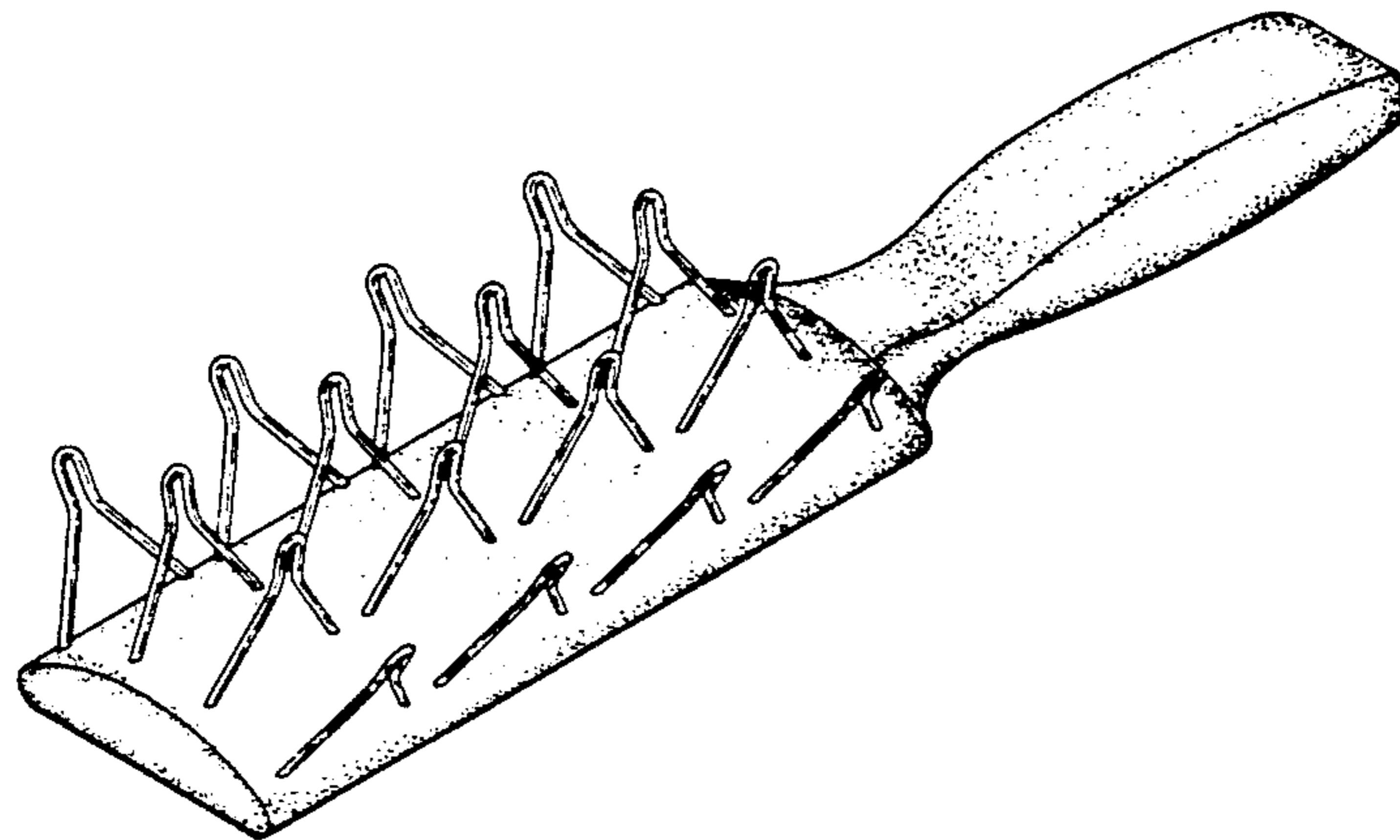

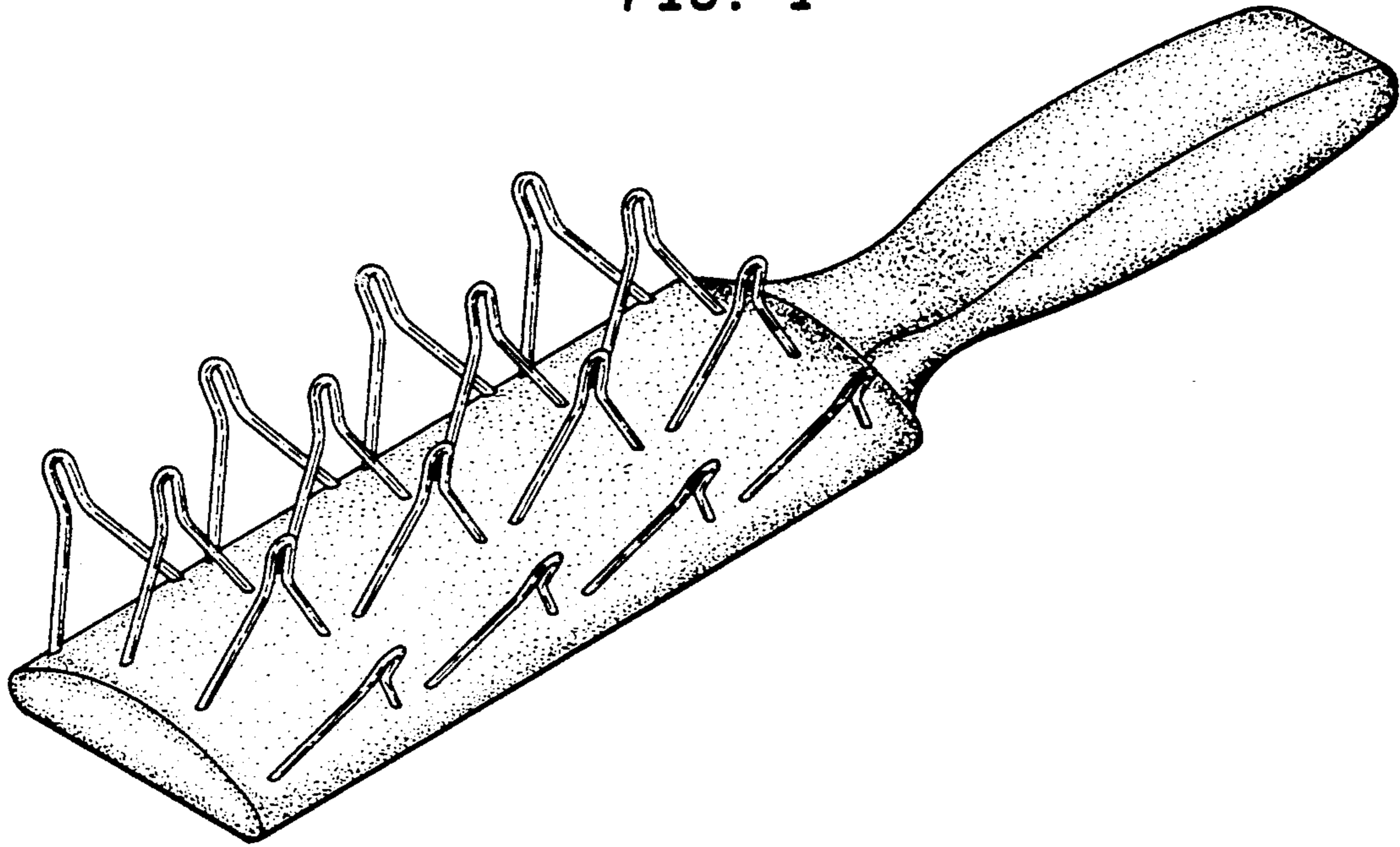

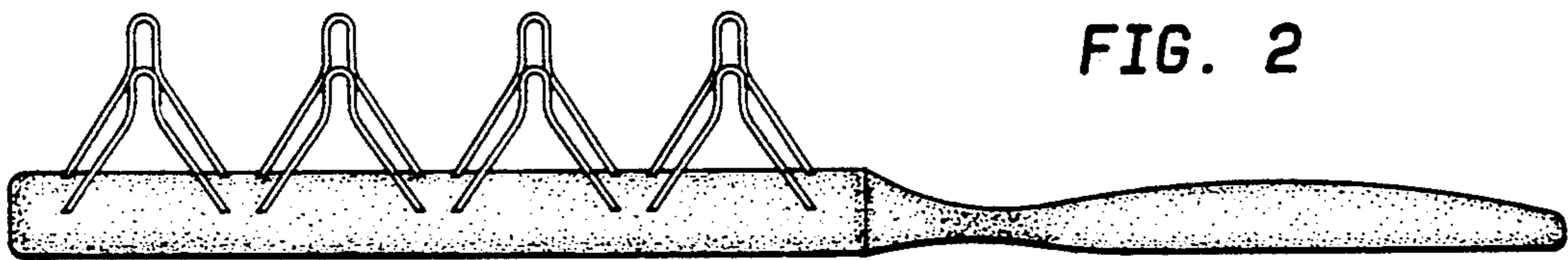

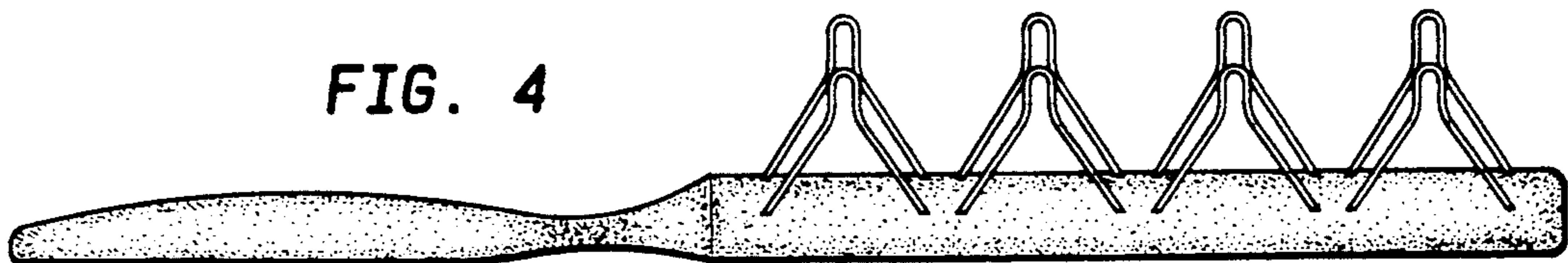

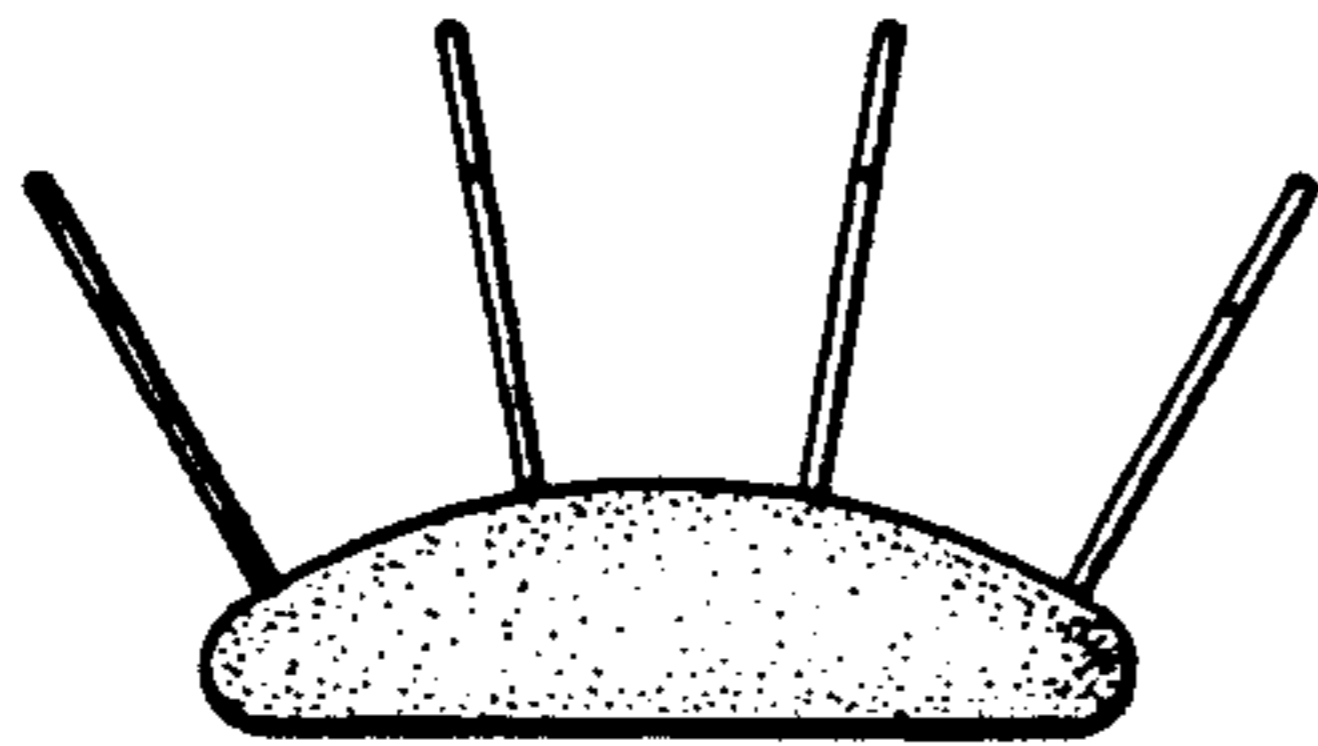

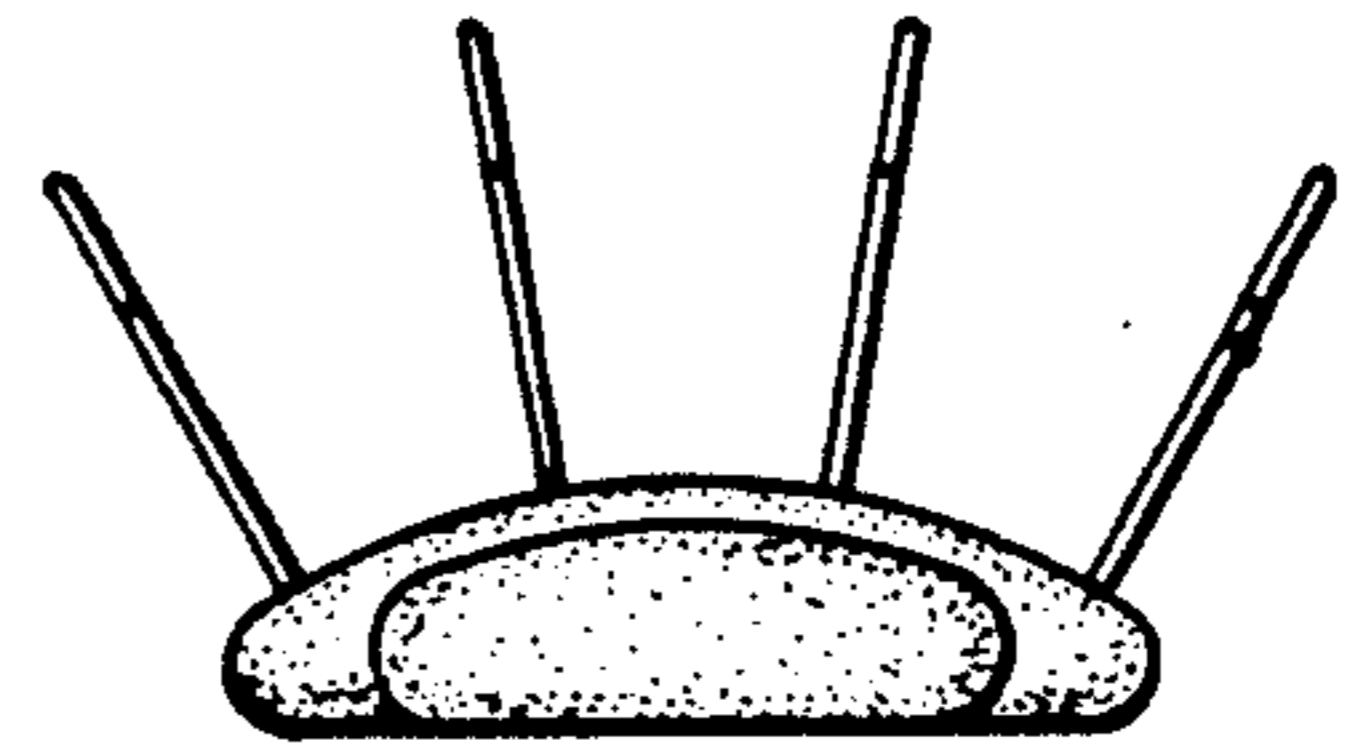

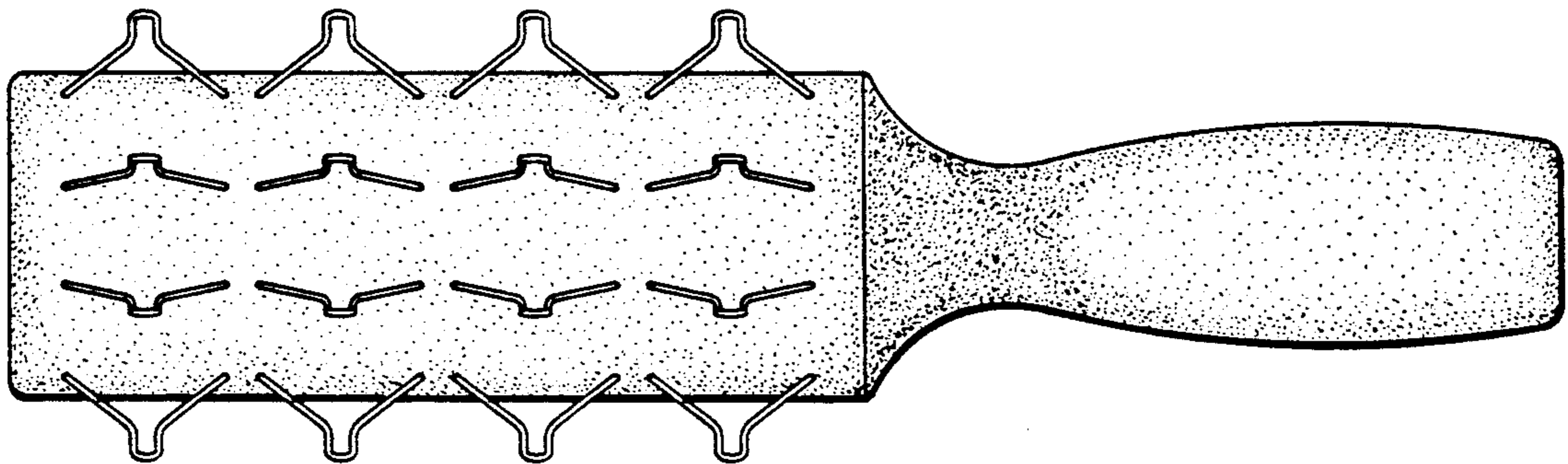

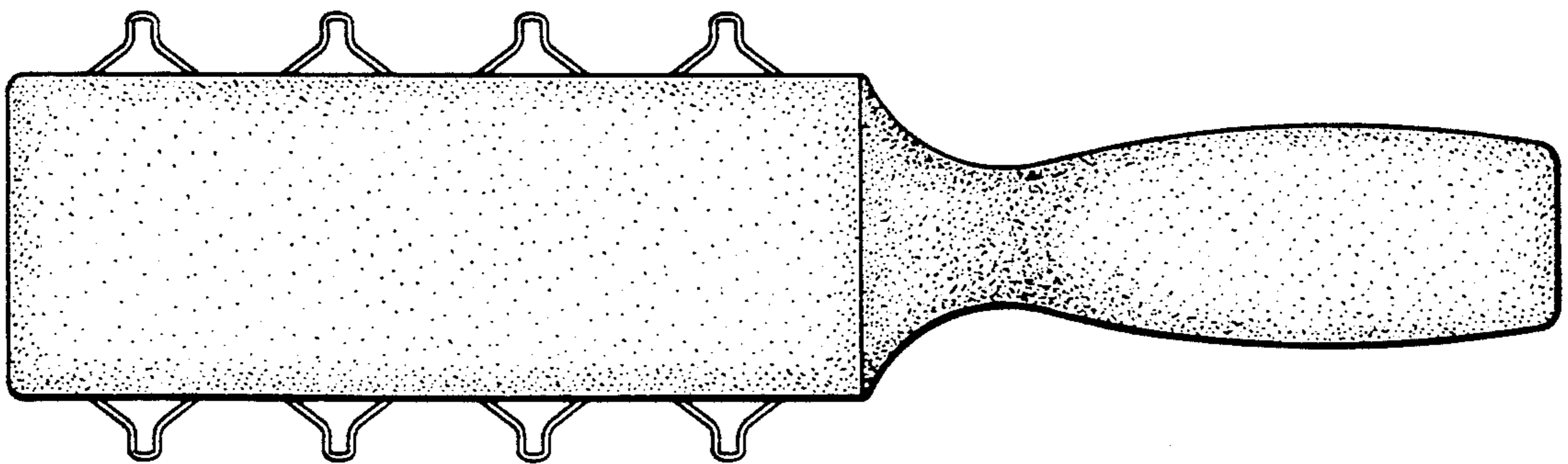

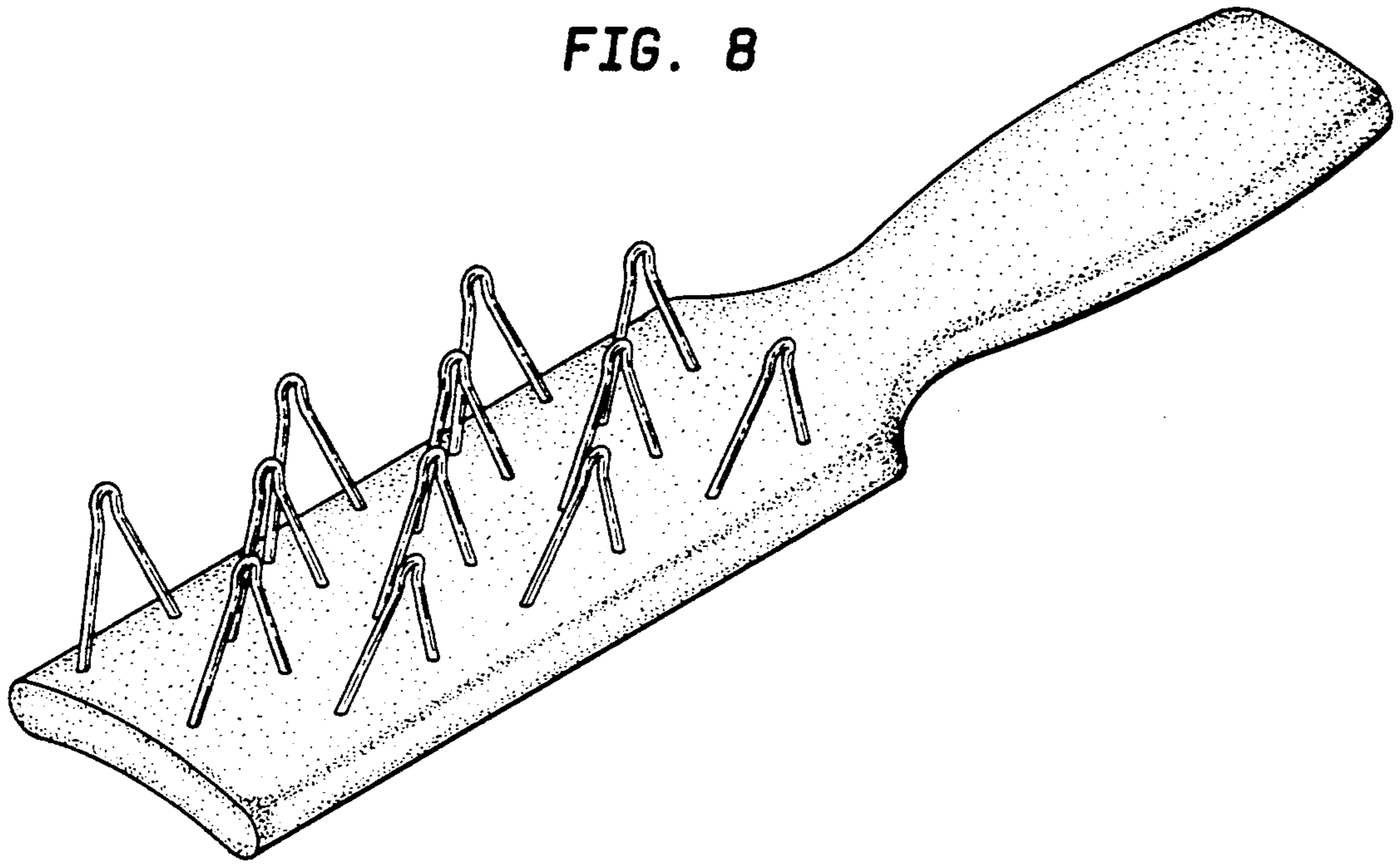

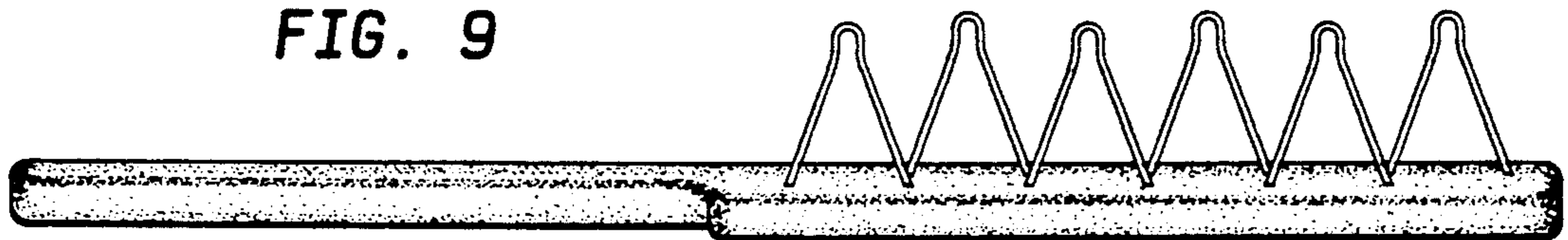

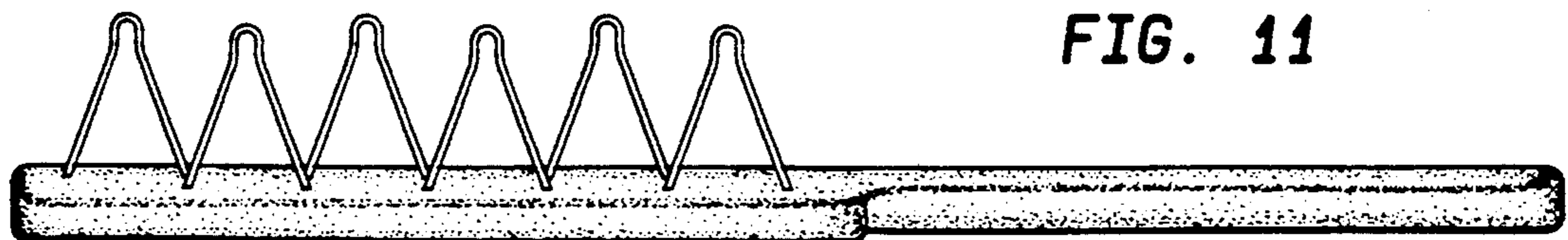

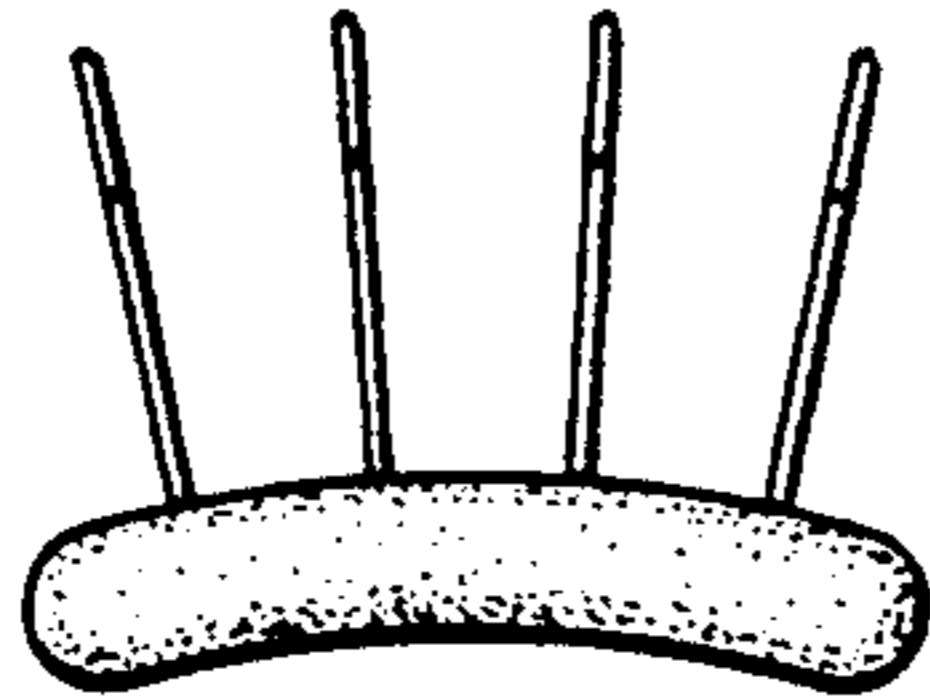

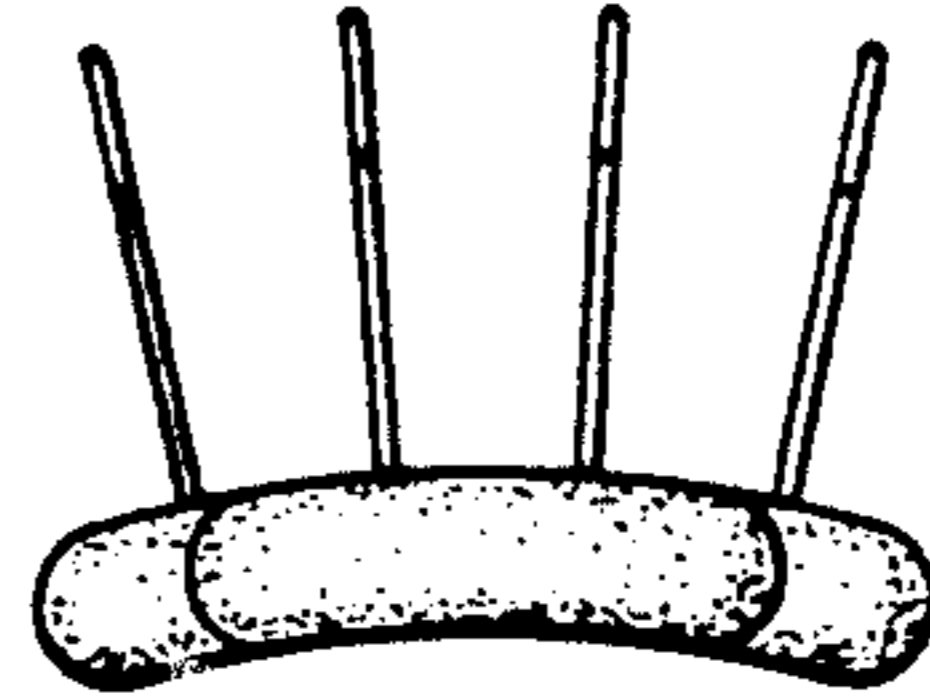

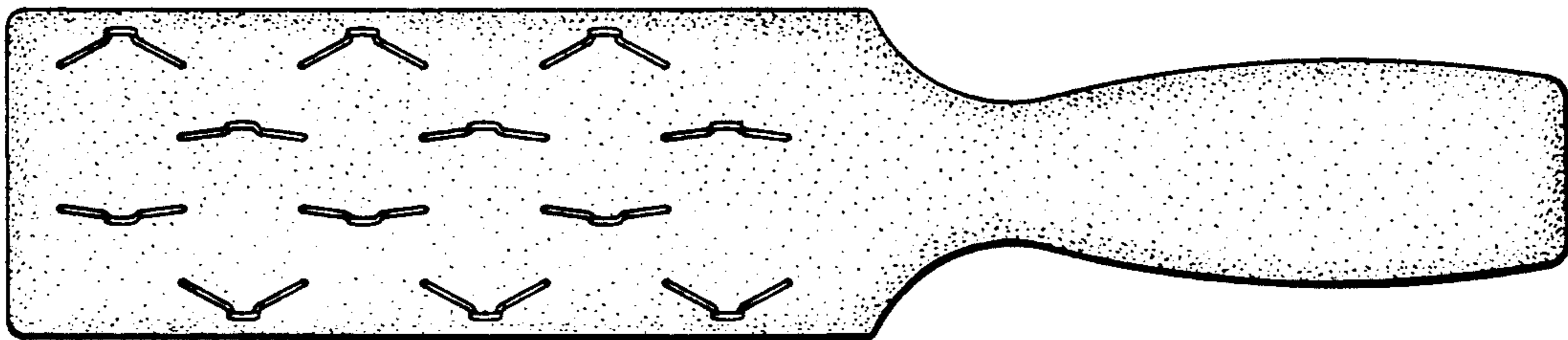
