[57] **CLAIM**

The ornamental design for a dispensing container with a slidable closure, as shown and described.

DESCRIPTION

FIG. 1 is front elevational view of a dispensing container with a slidable closure showing our new design; the rear elevational view being the same in appearance; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; and, FIG. 4 is a right side elevational view thereof, the left side elevational view being the same in appearance.

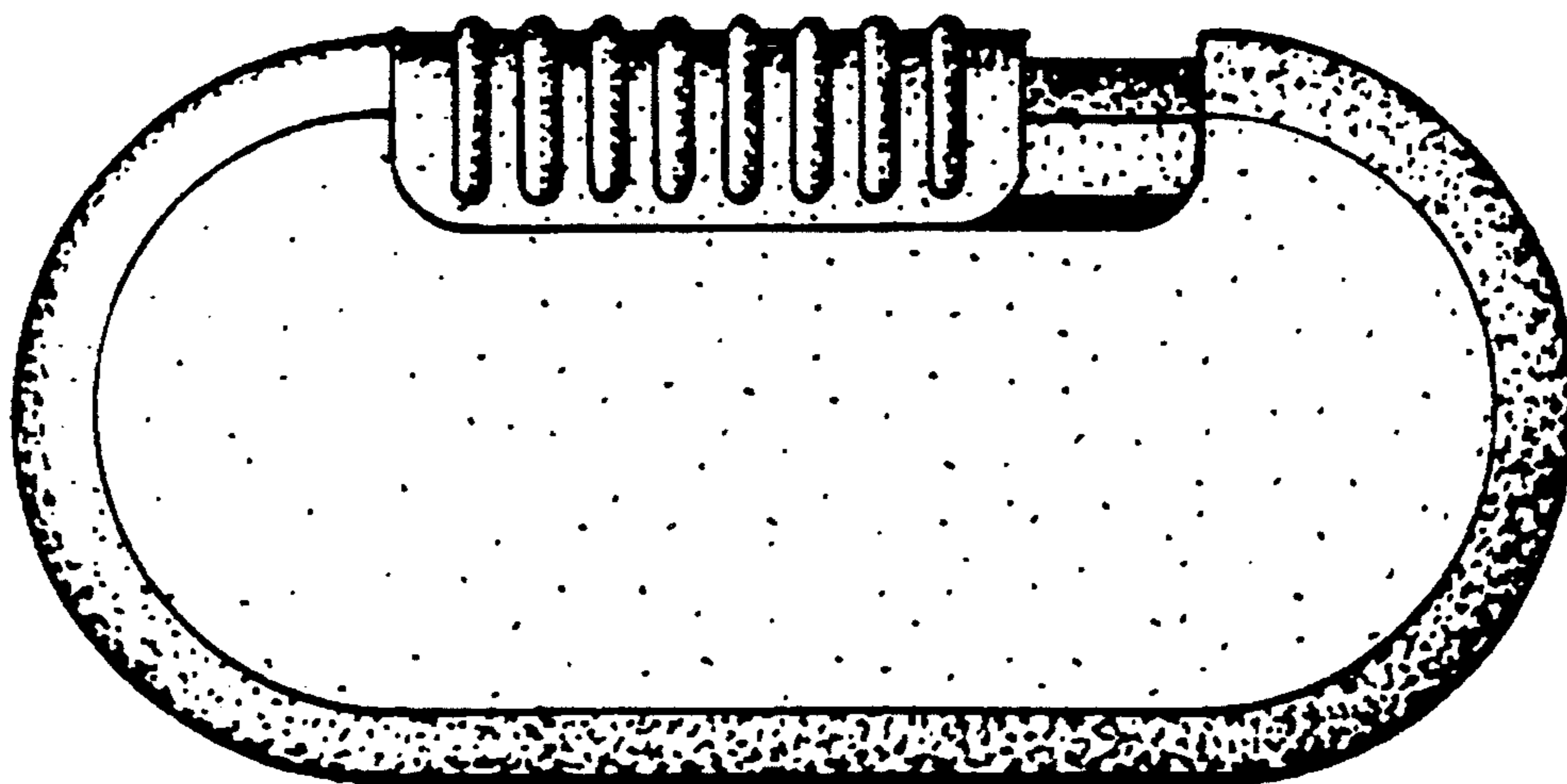

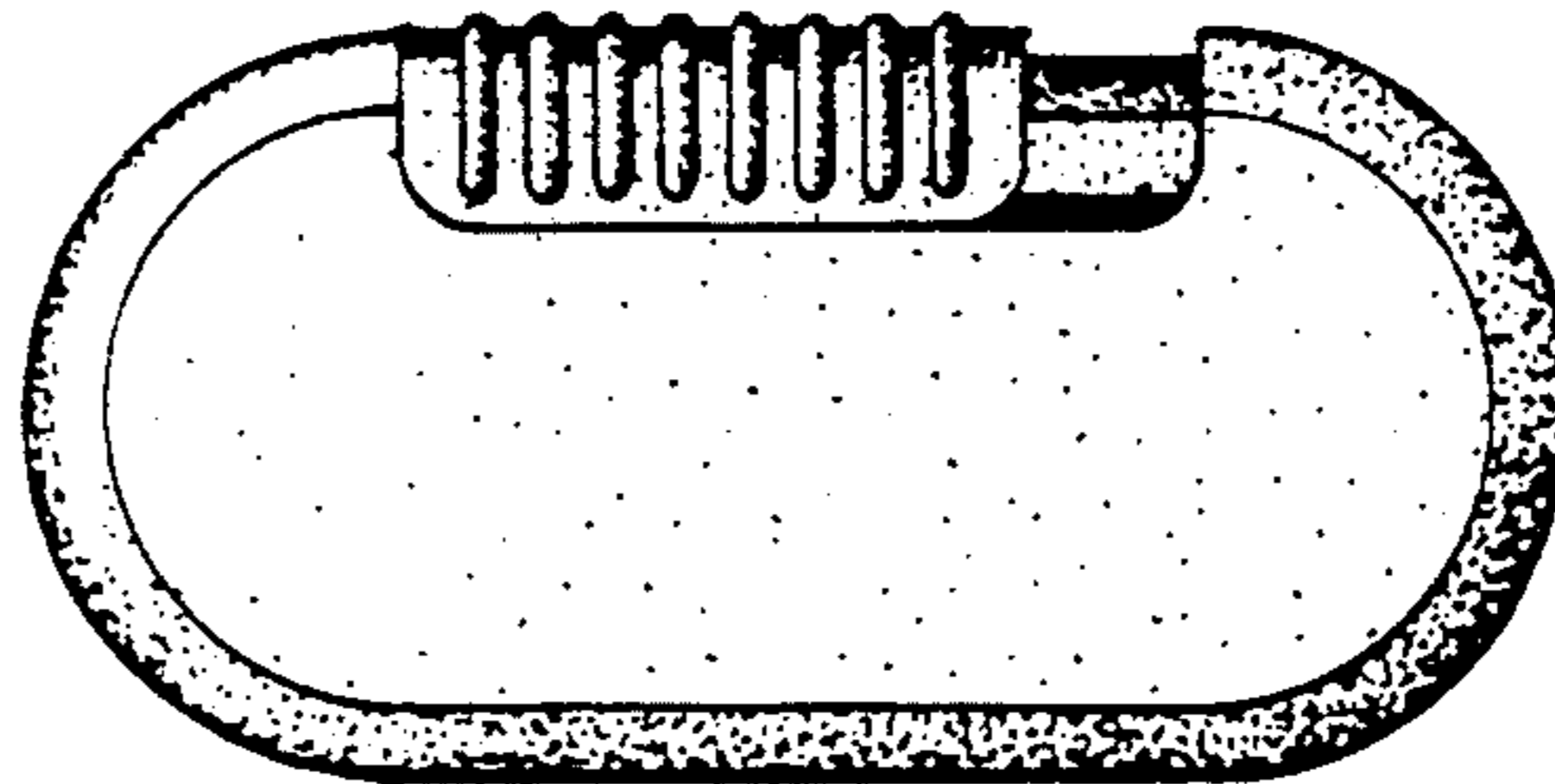

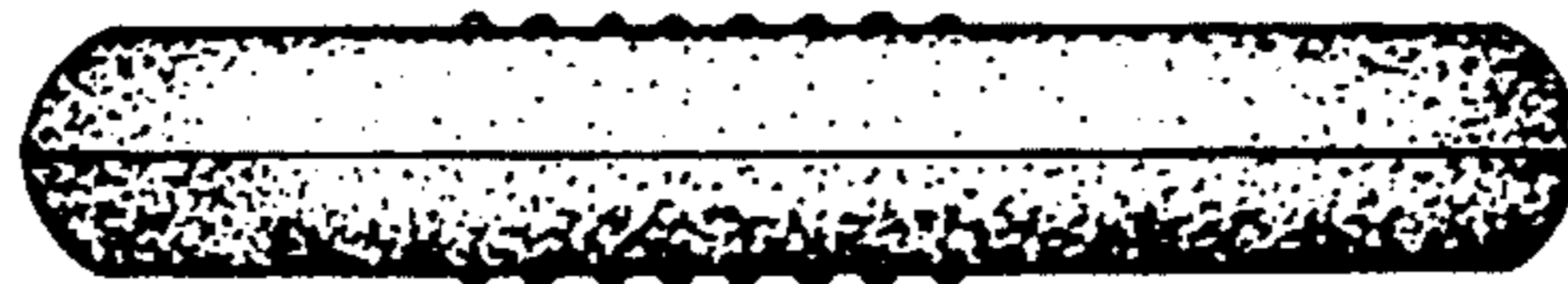
