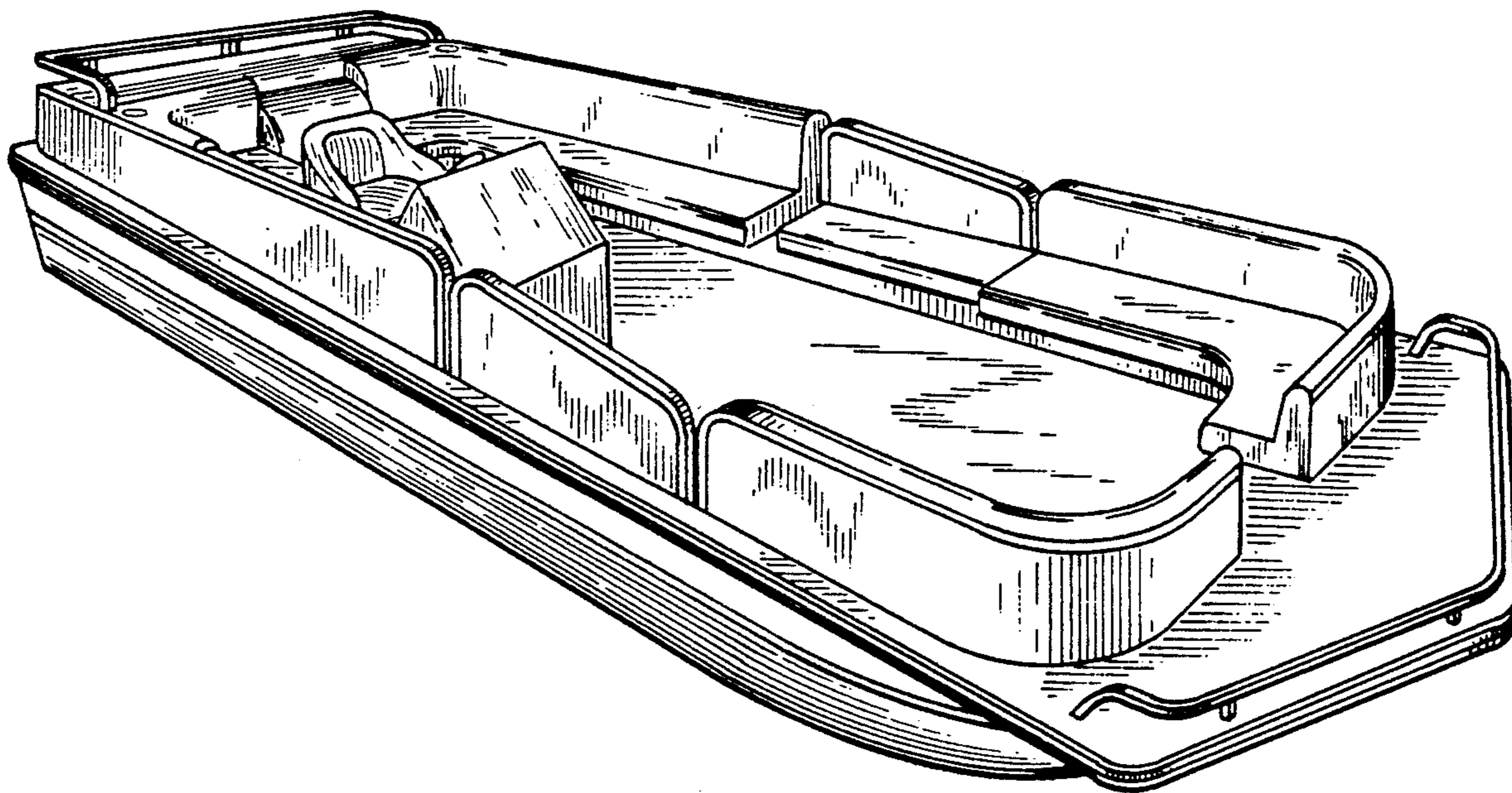

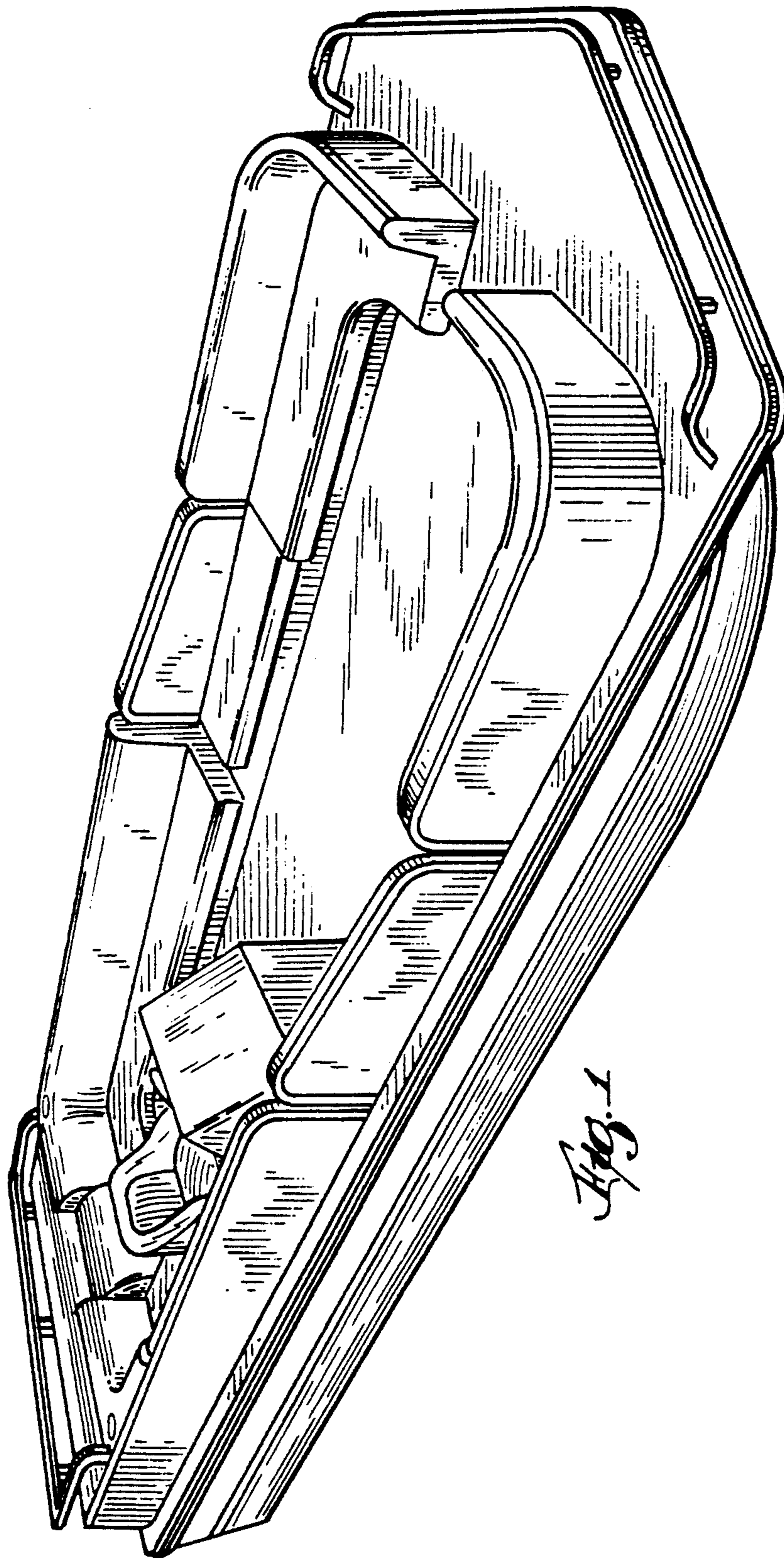

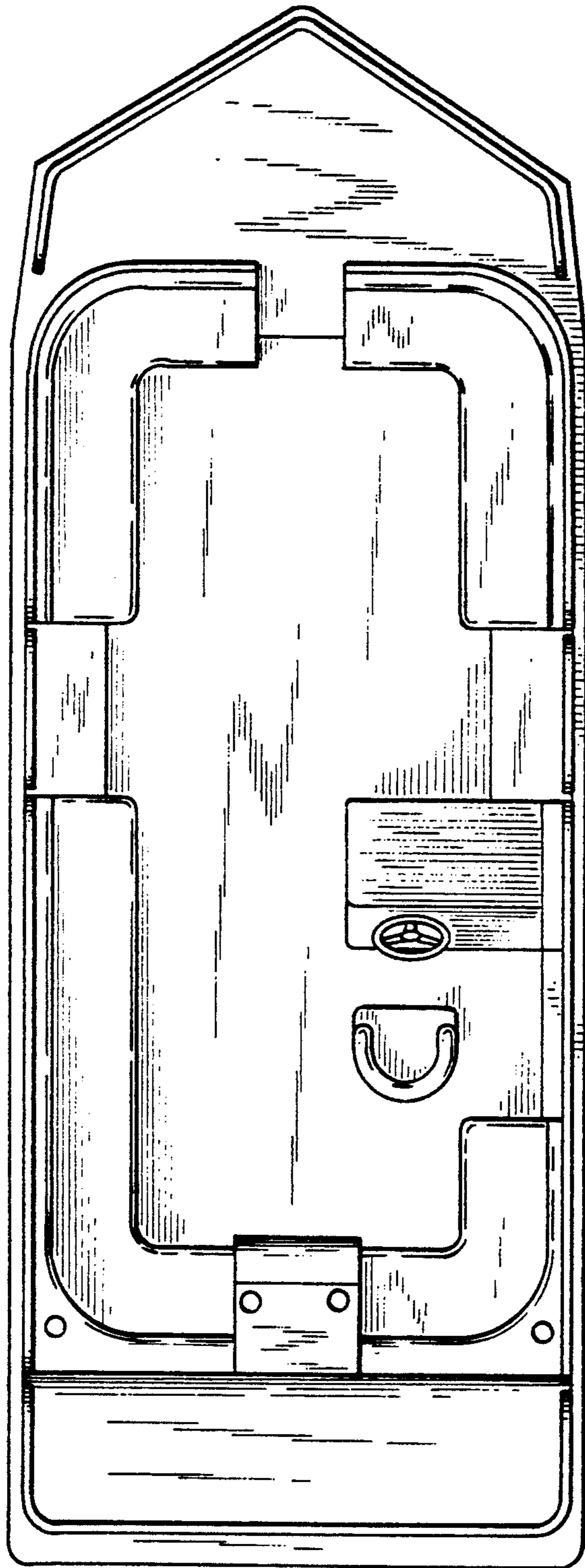

 FIG. 13 is a rear elevational view of FIG. 9.

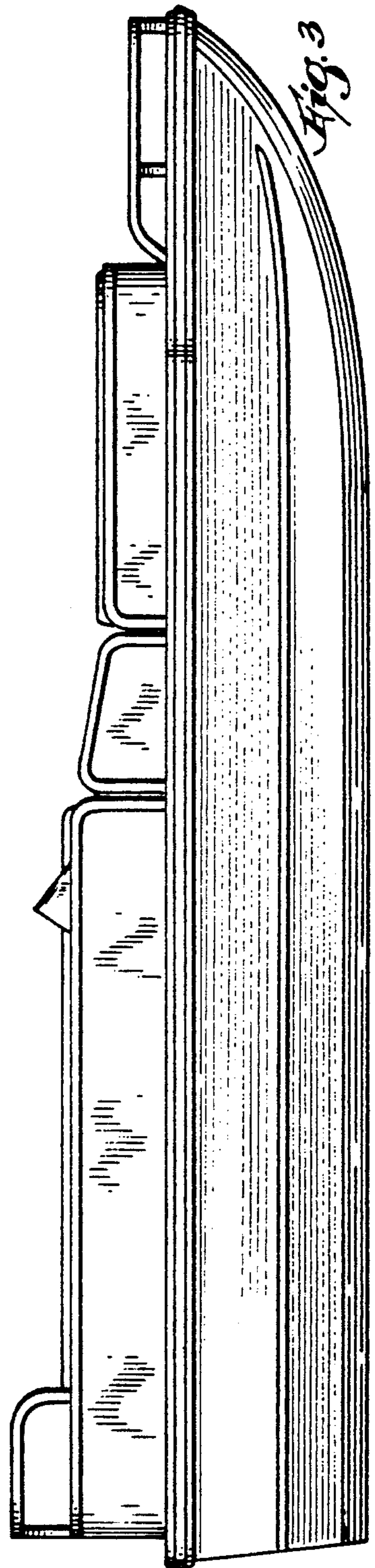




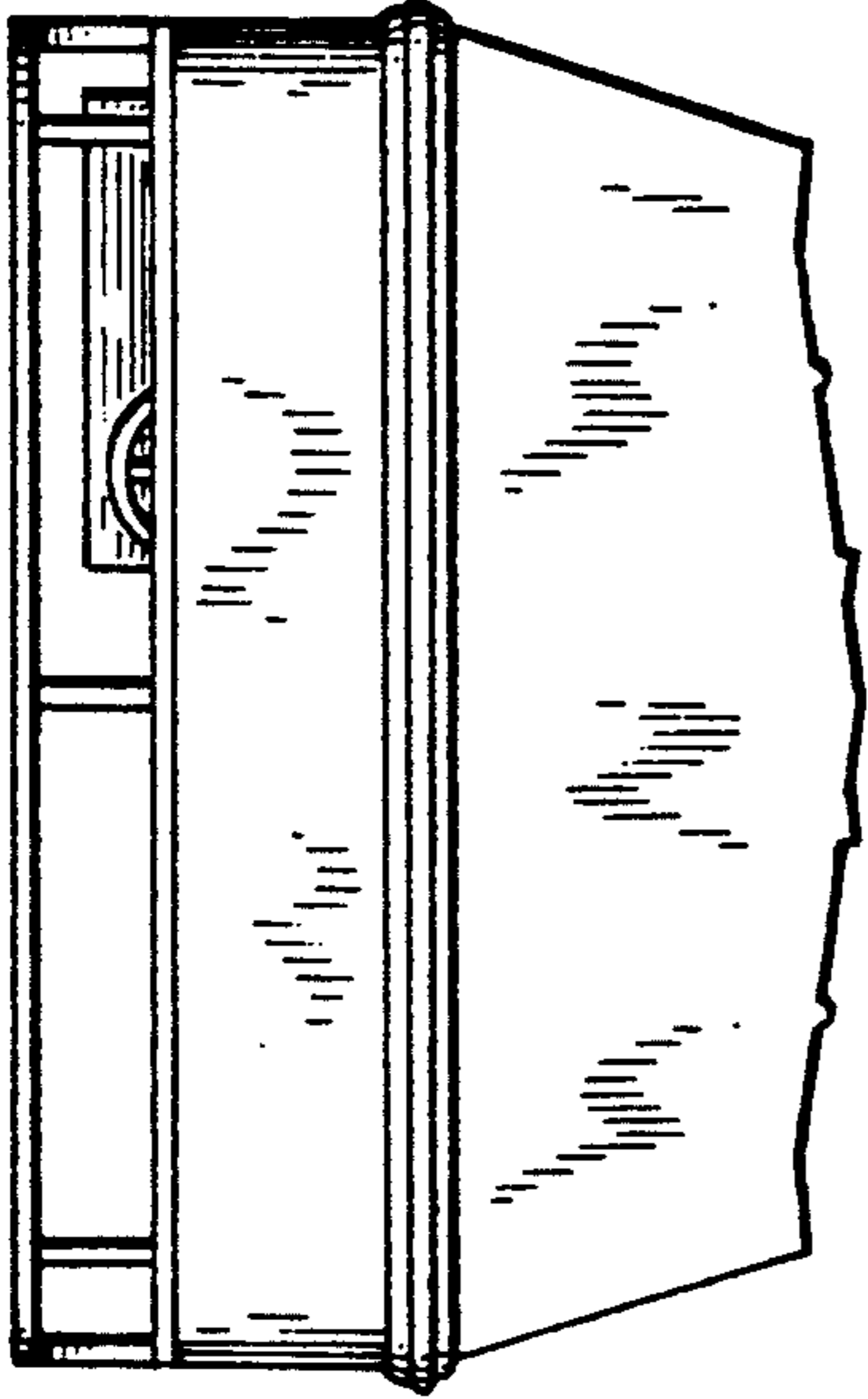

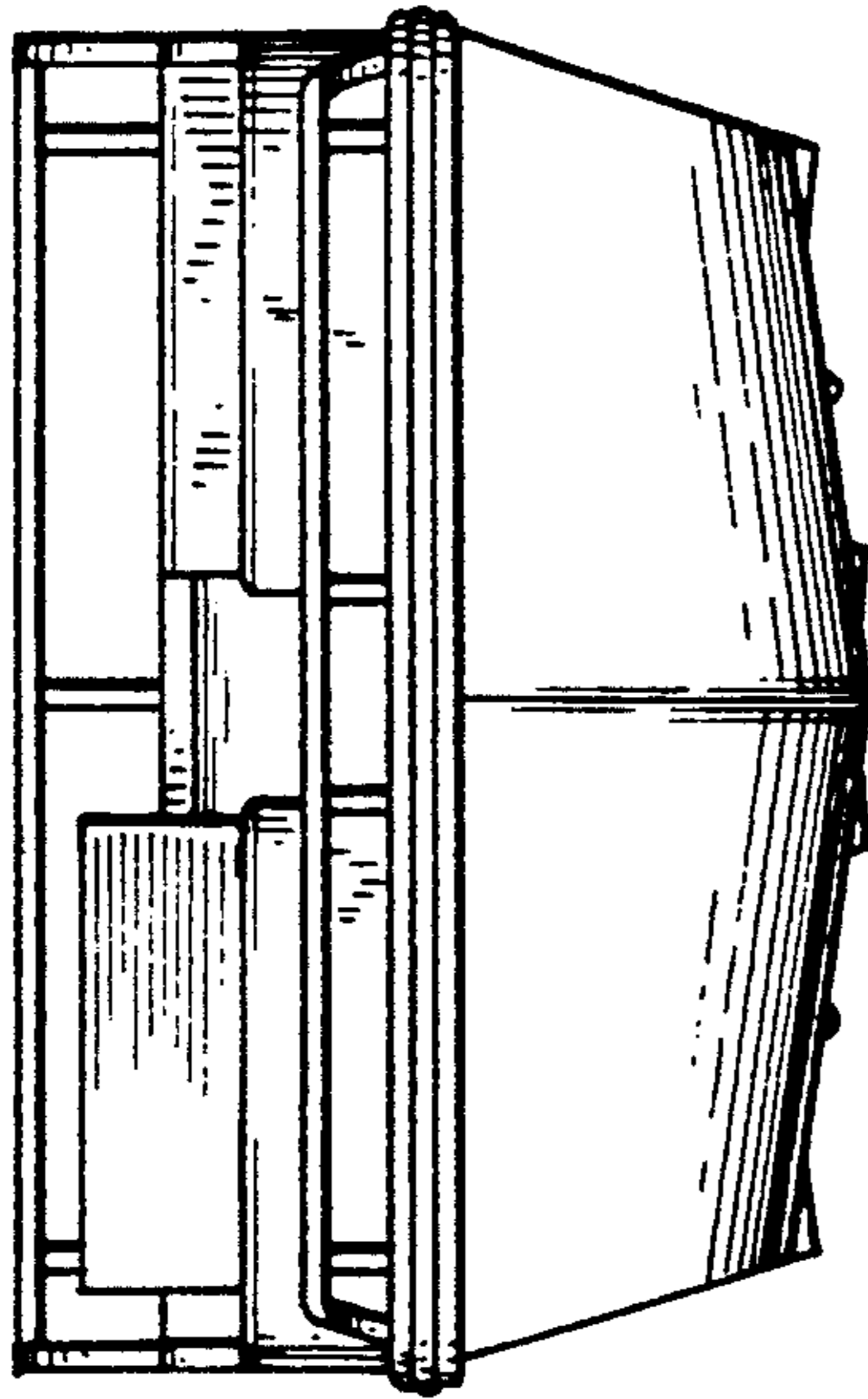

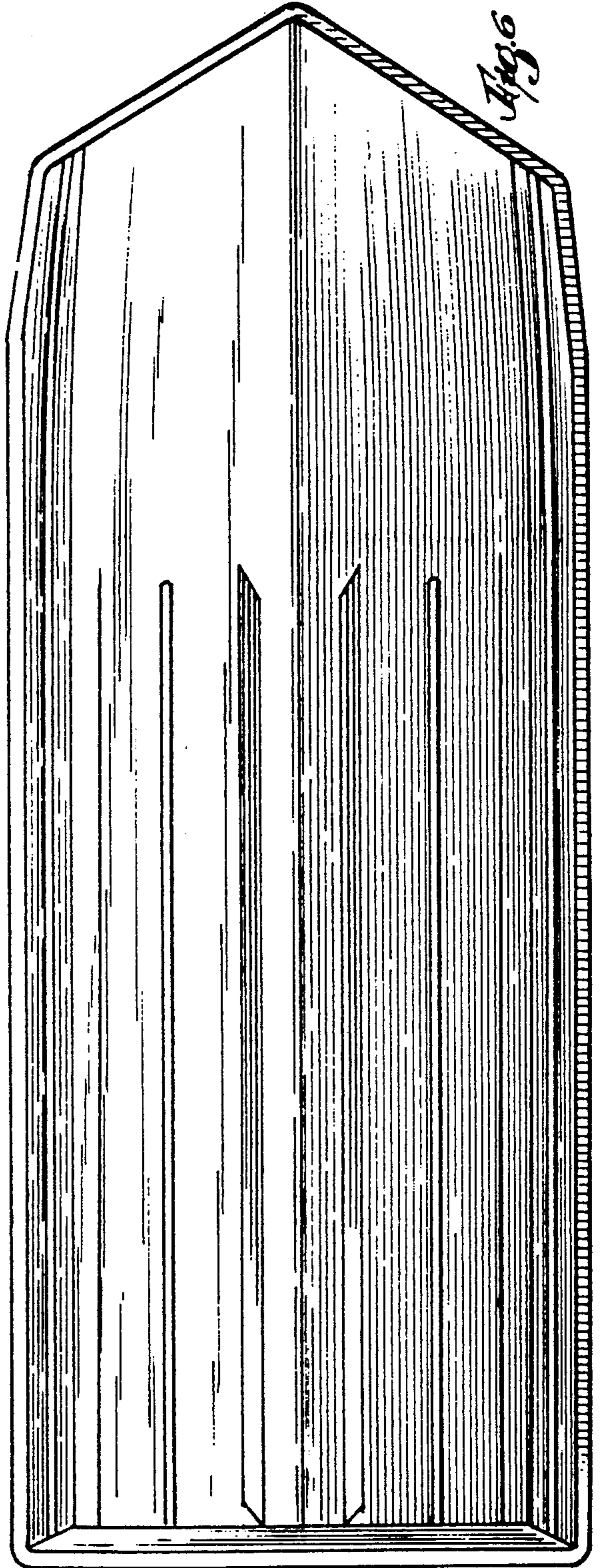

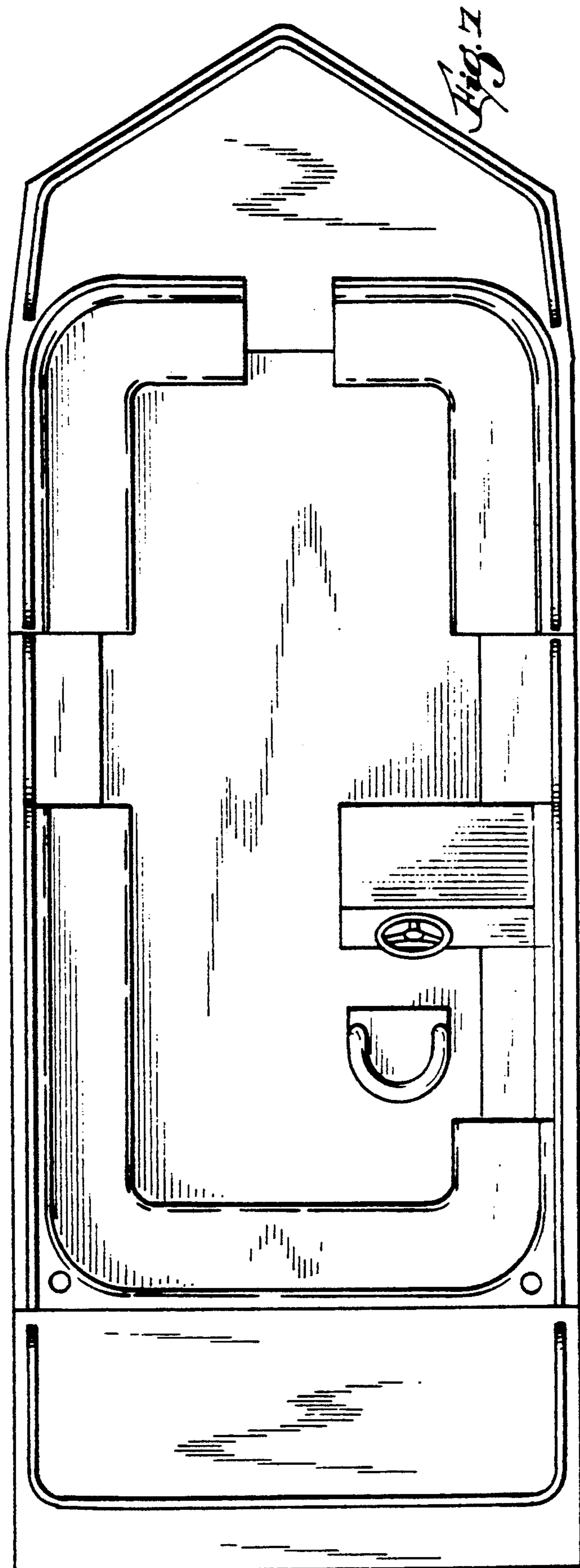

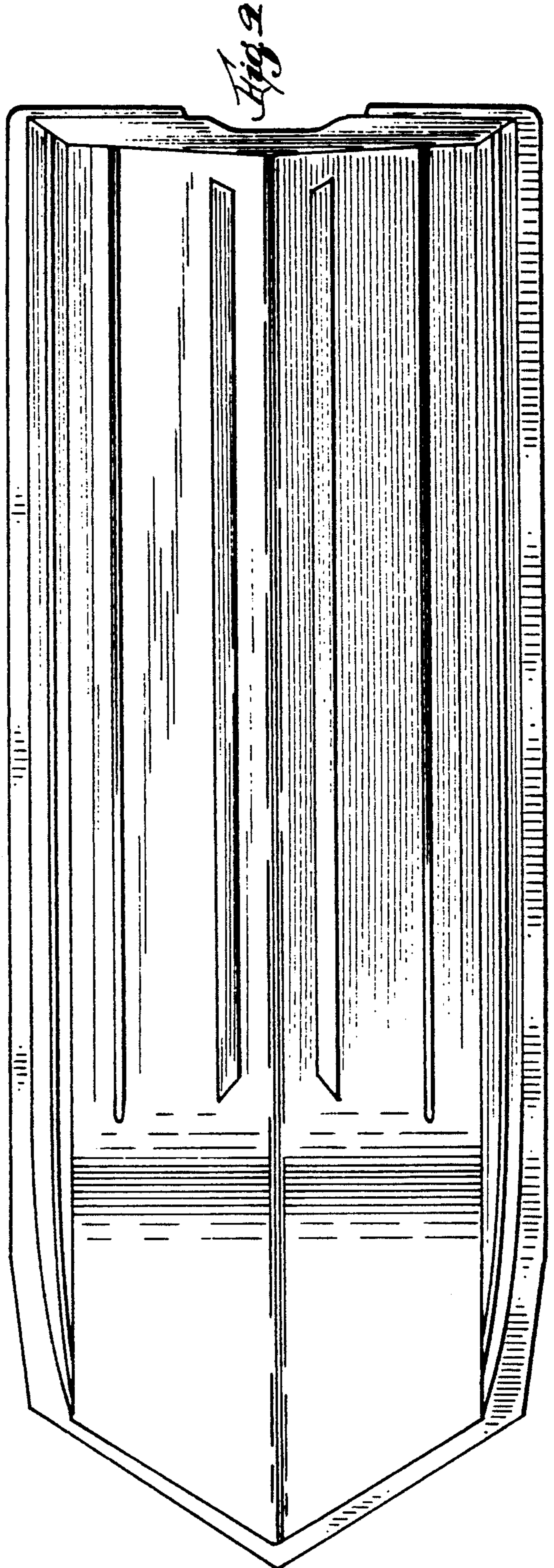
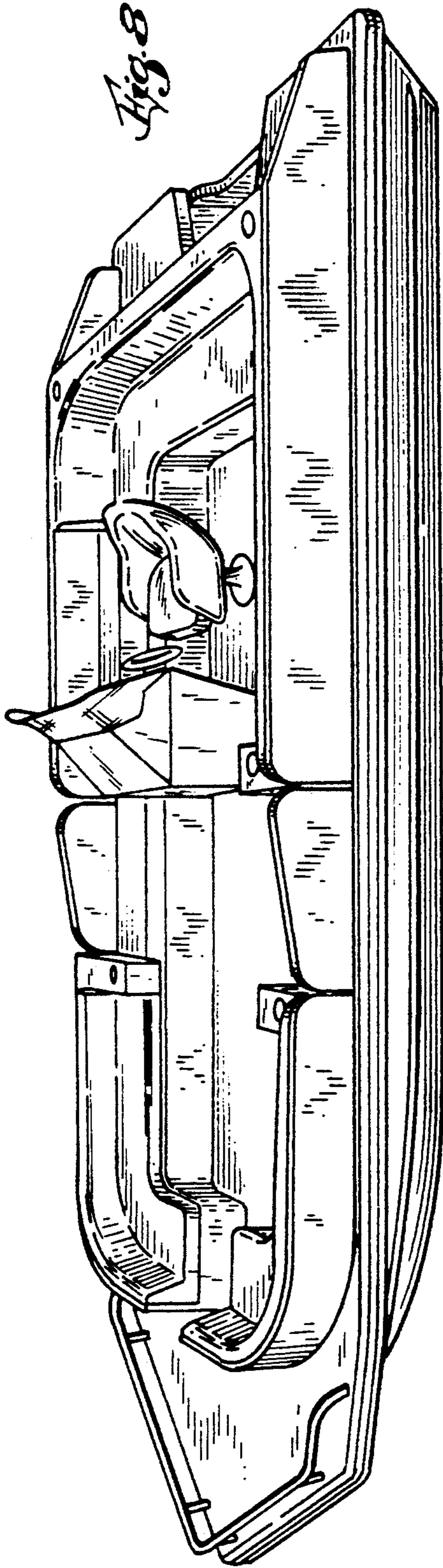


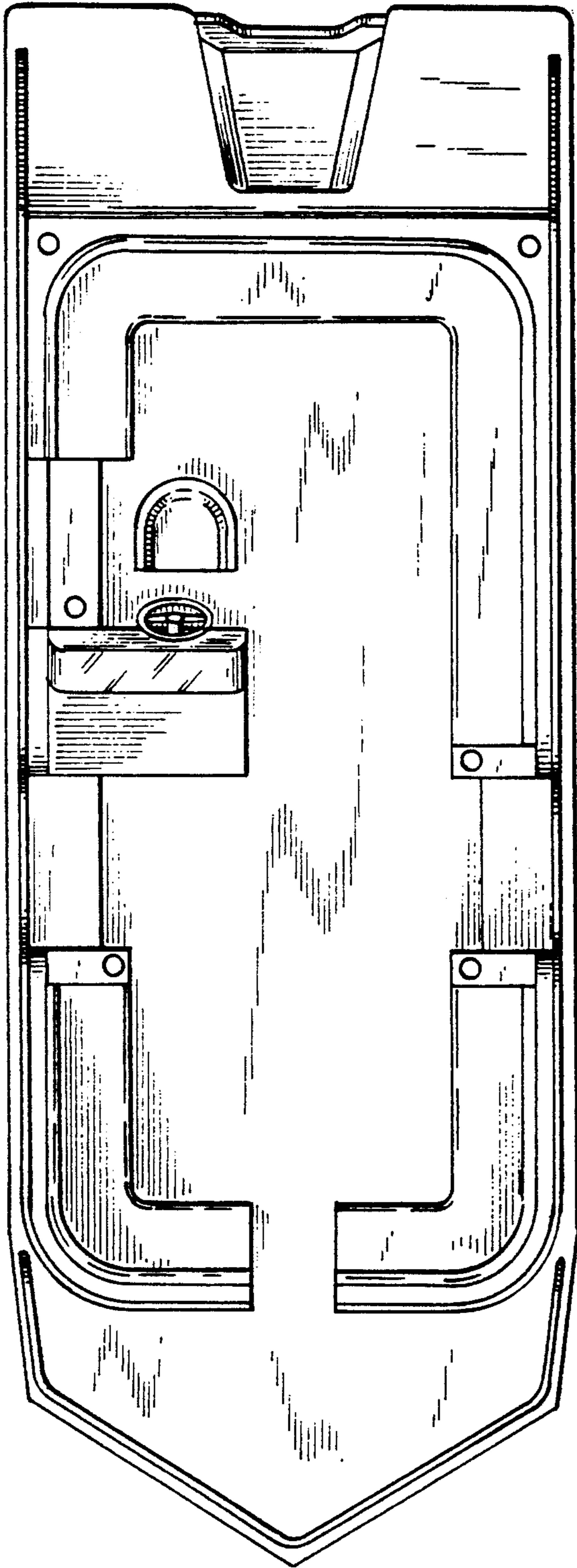

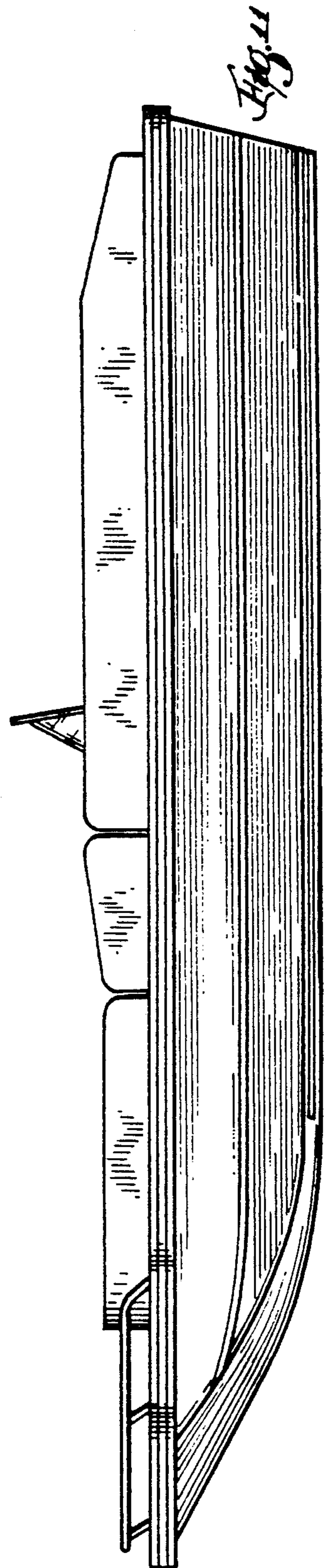

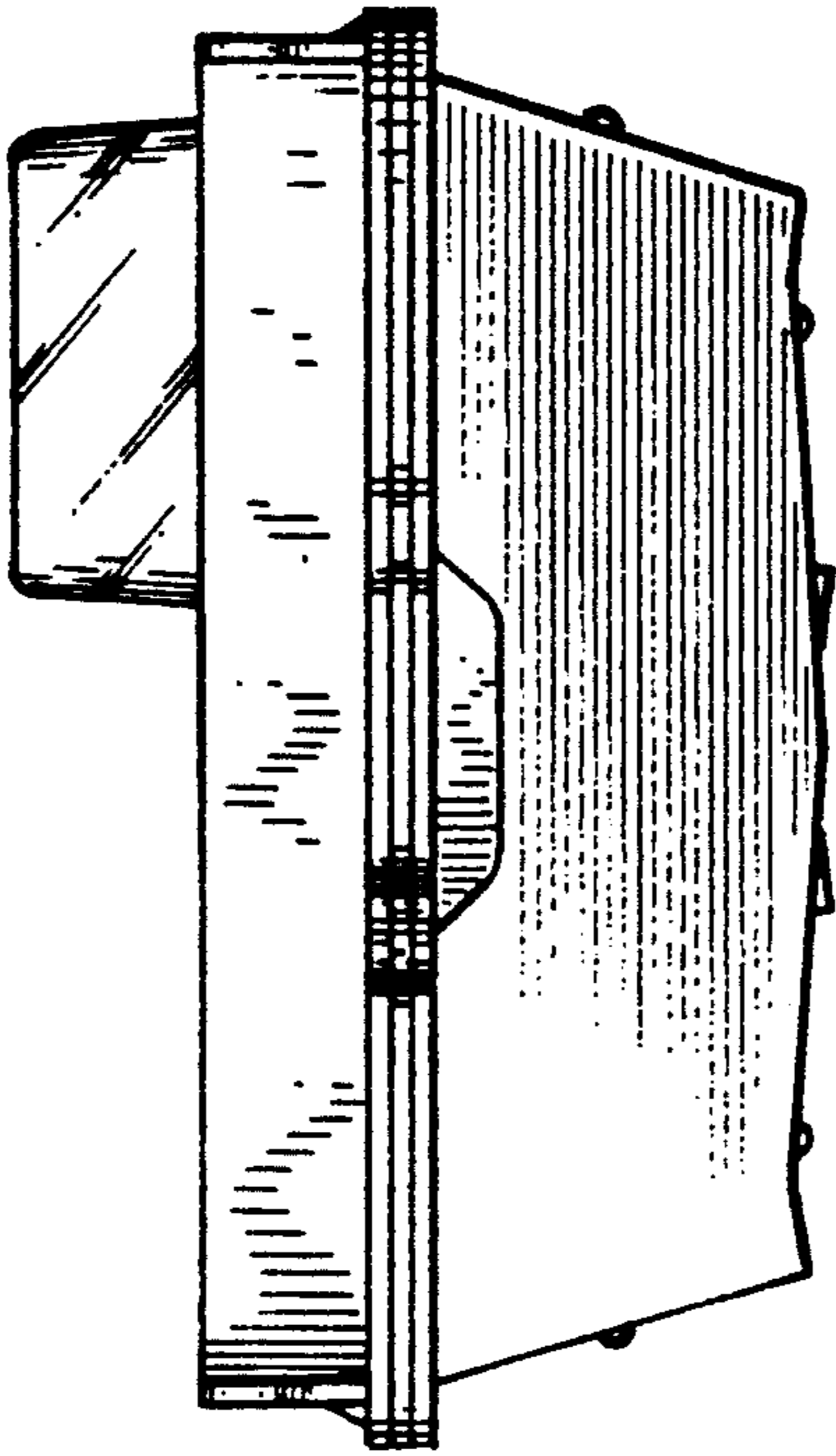




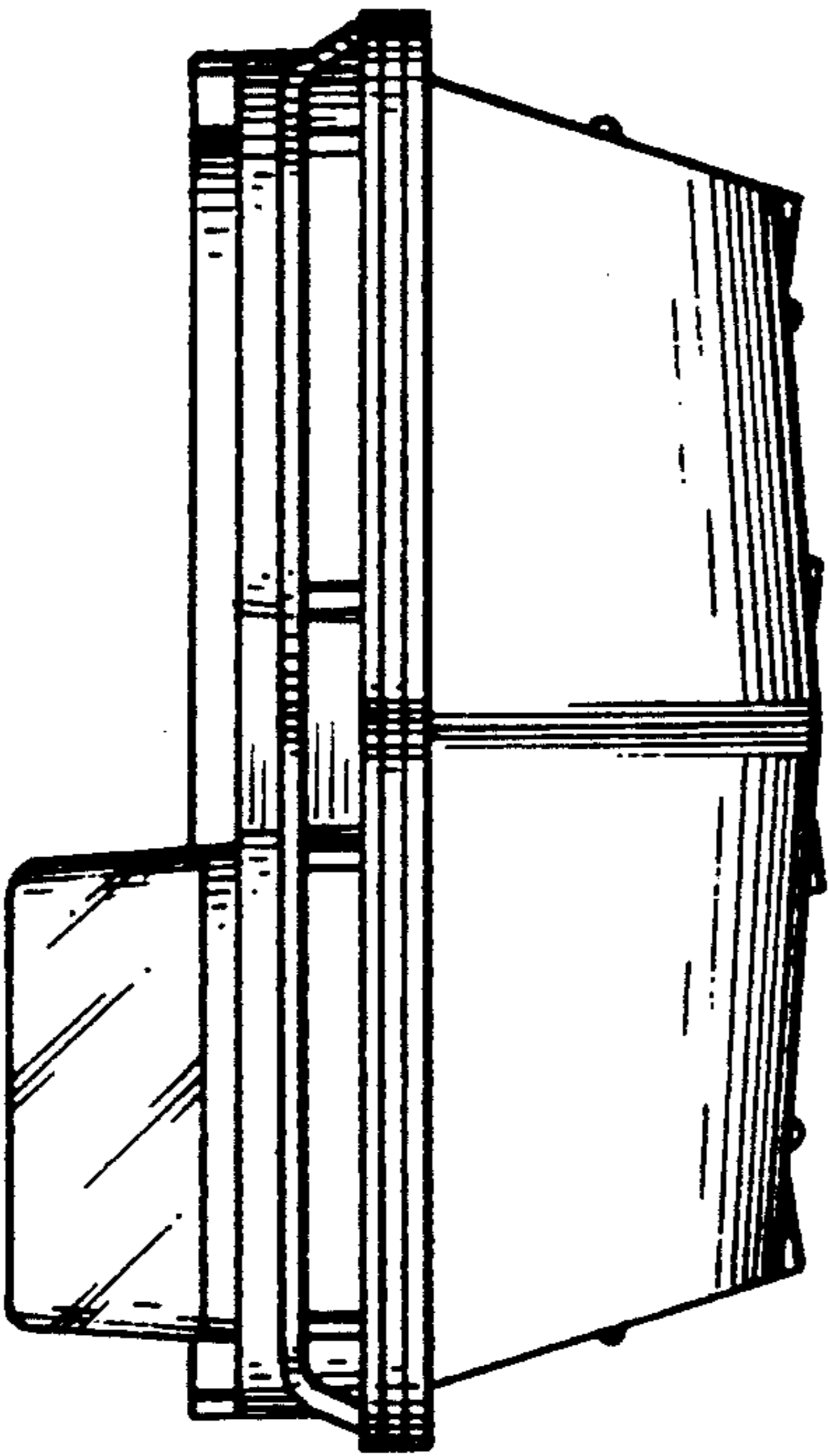
