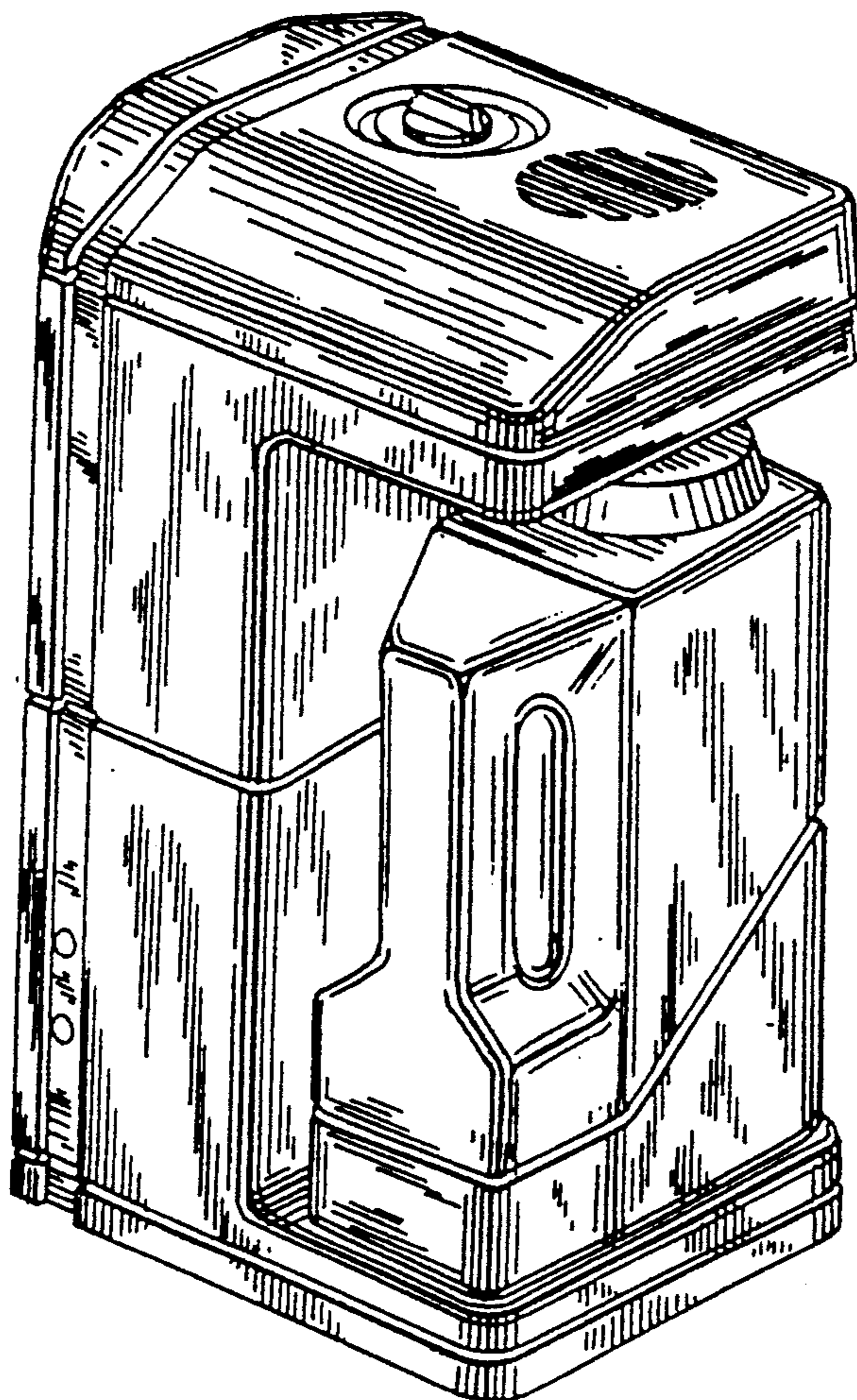

The ornamental design for a combined water filter base and container, as shown.

DESCRIPTION

FIG. 1 is a top perspective view of a combined water filter base and container showing my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right side elevational view thereof; and, FIG. 6 is a left side elevational view.



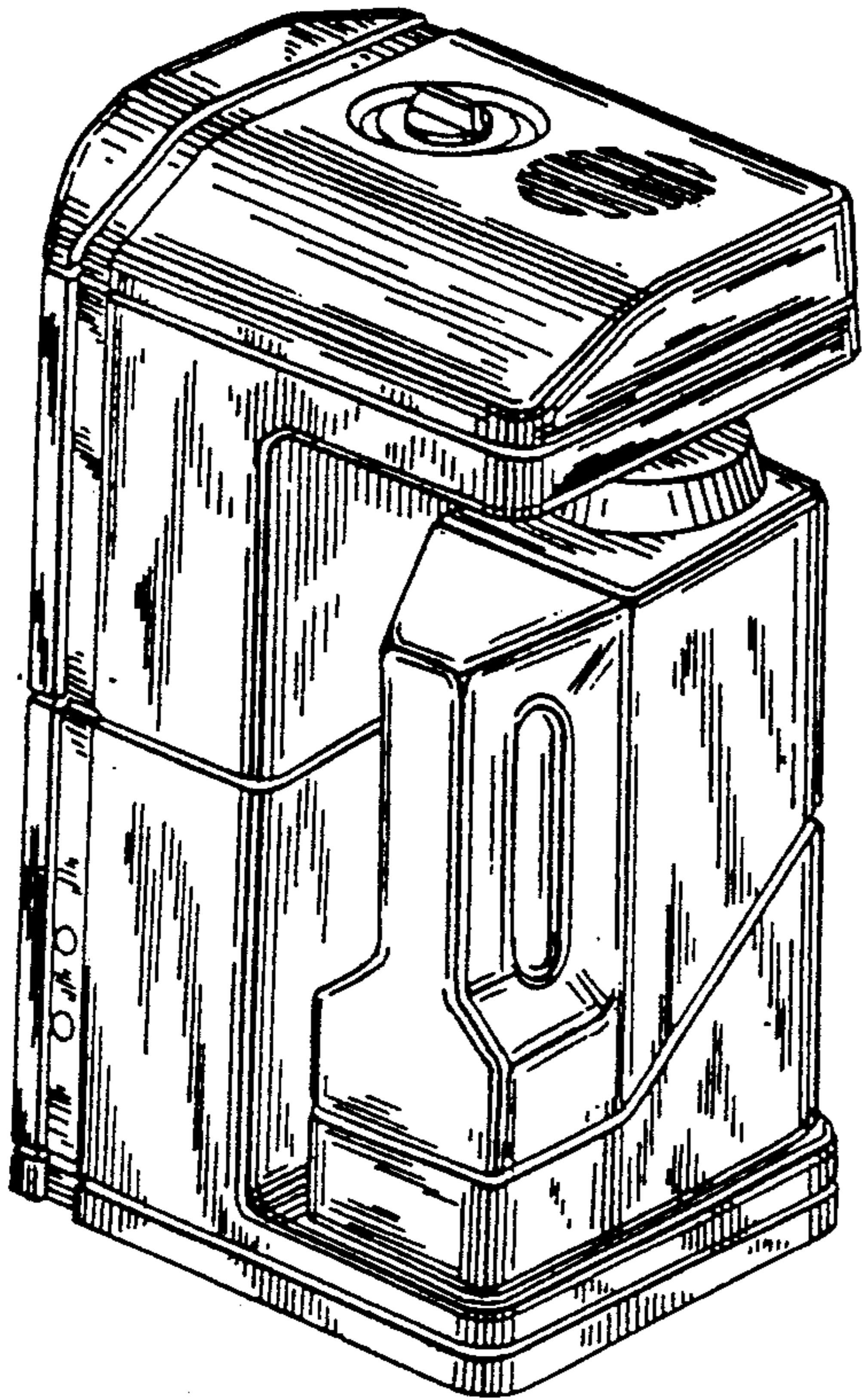

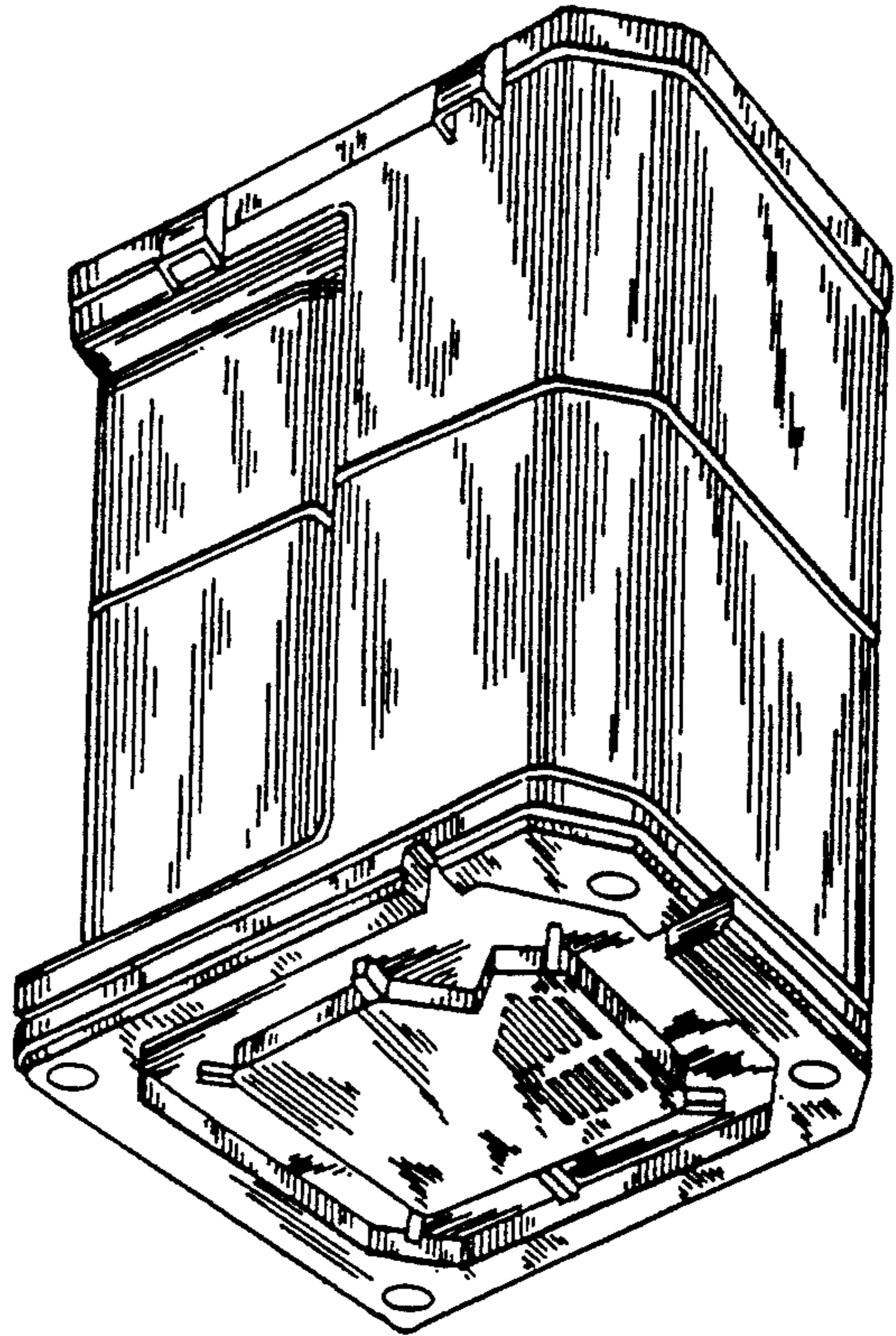

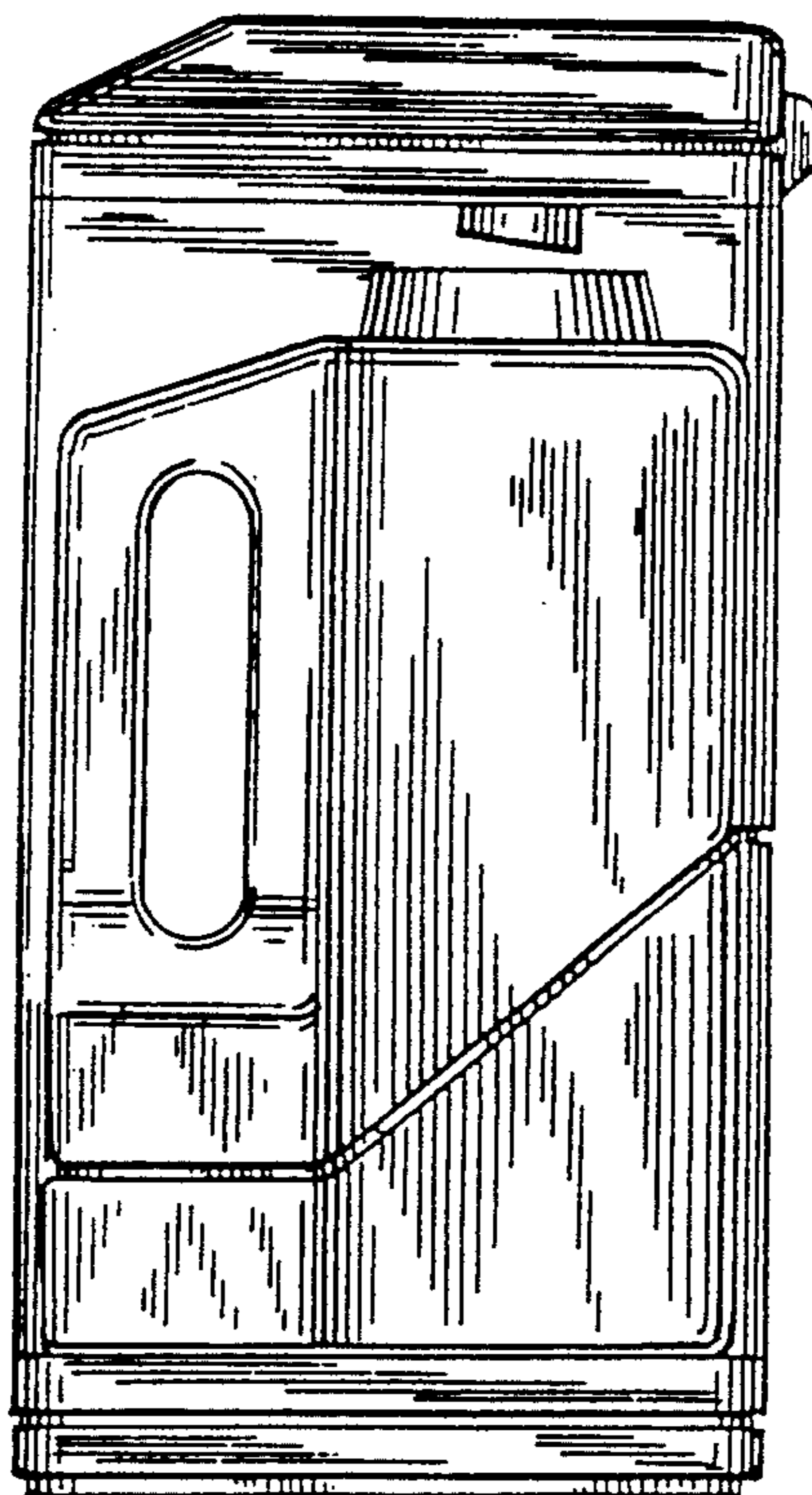

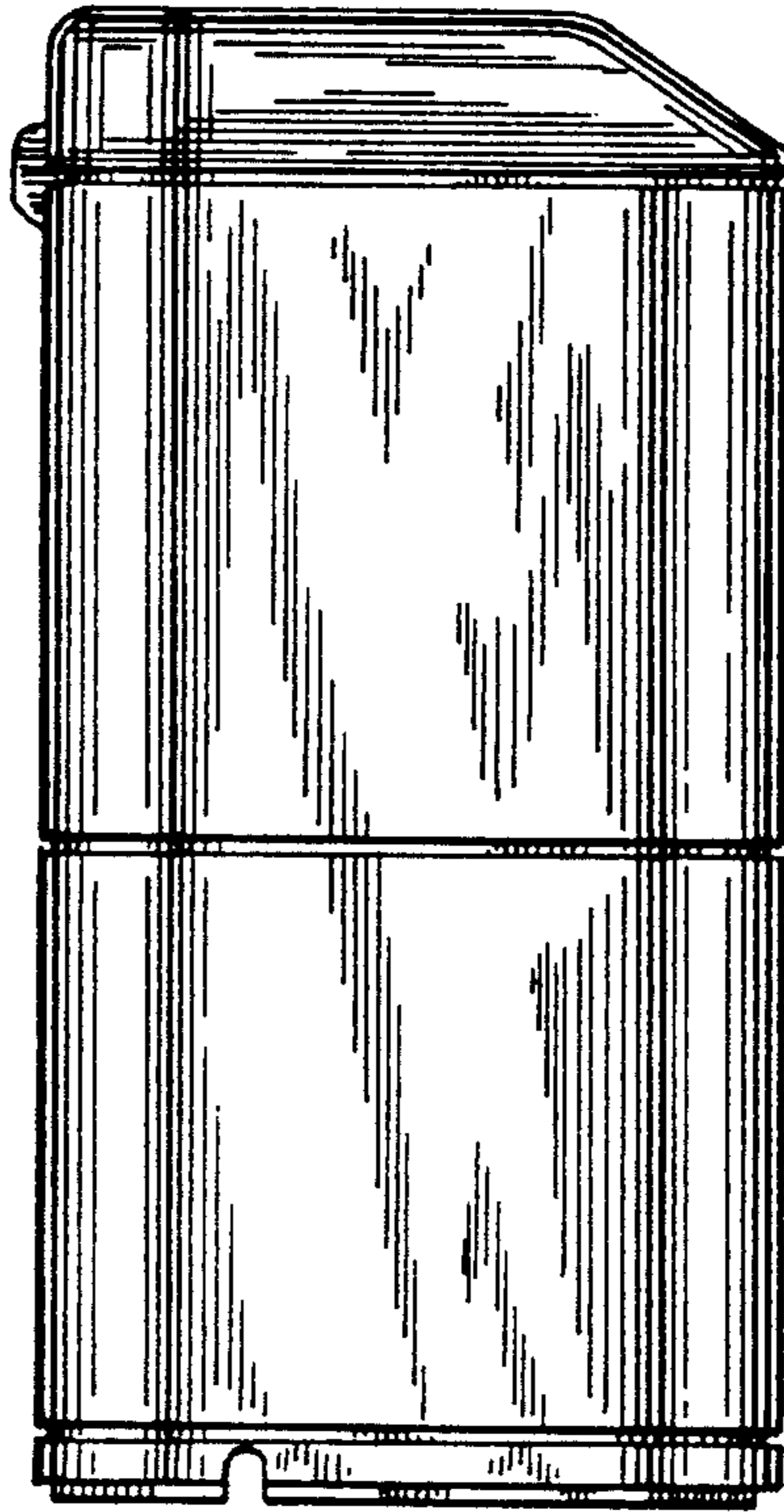

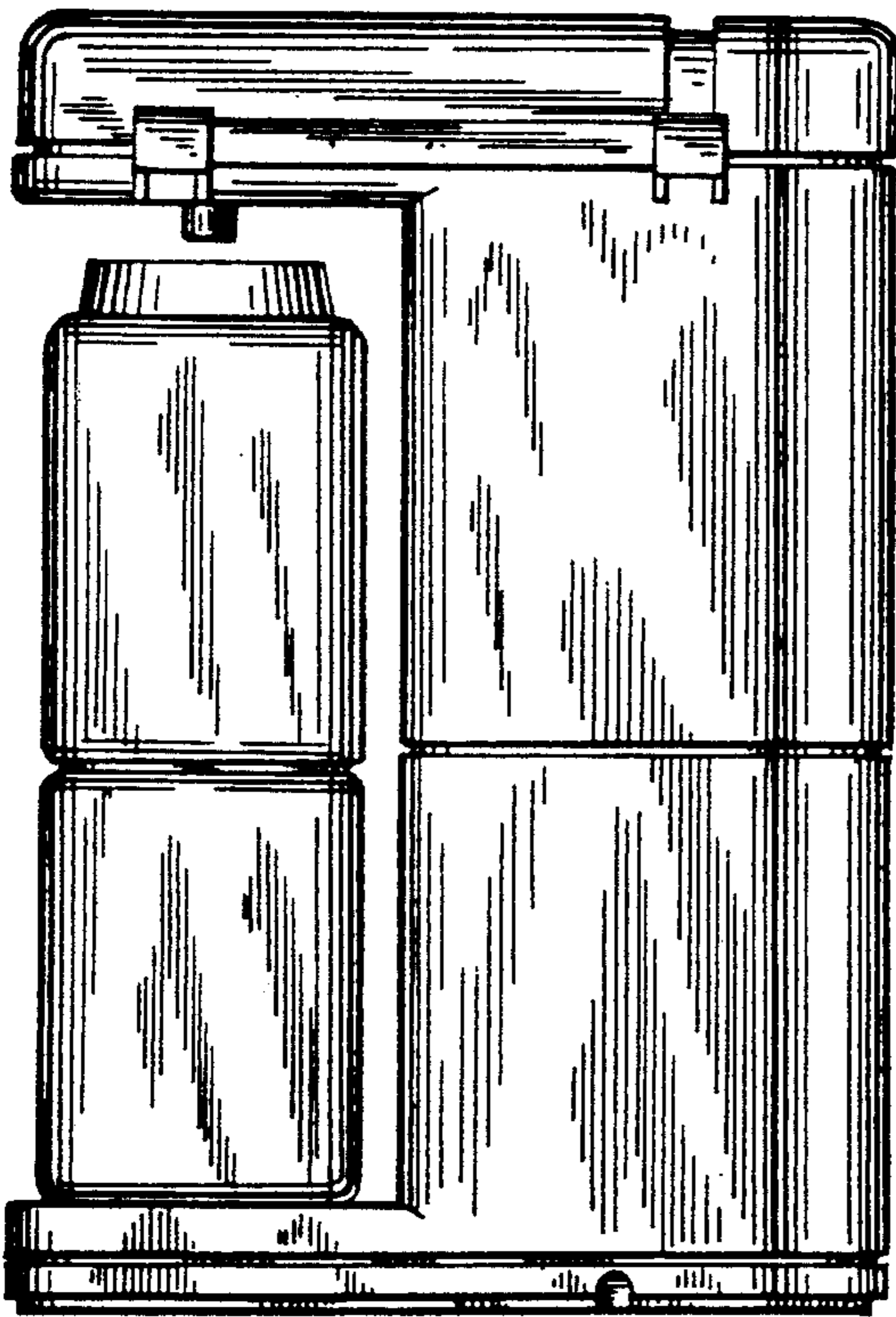

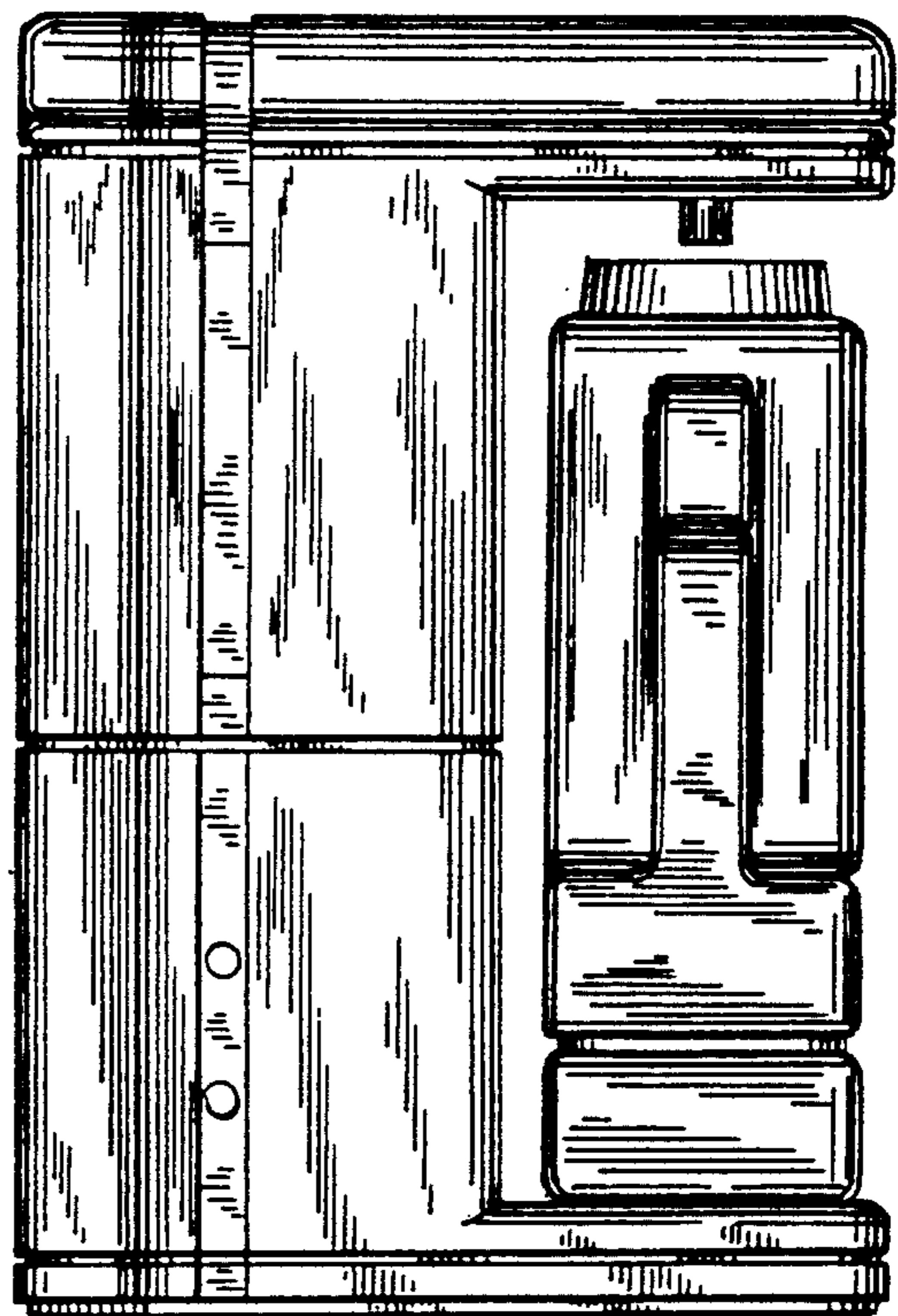
