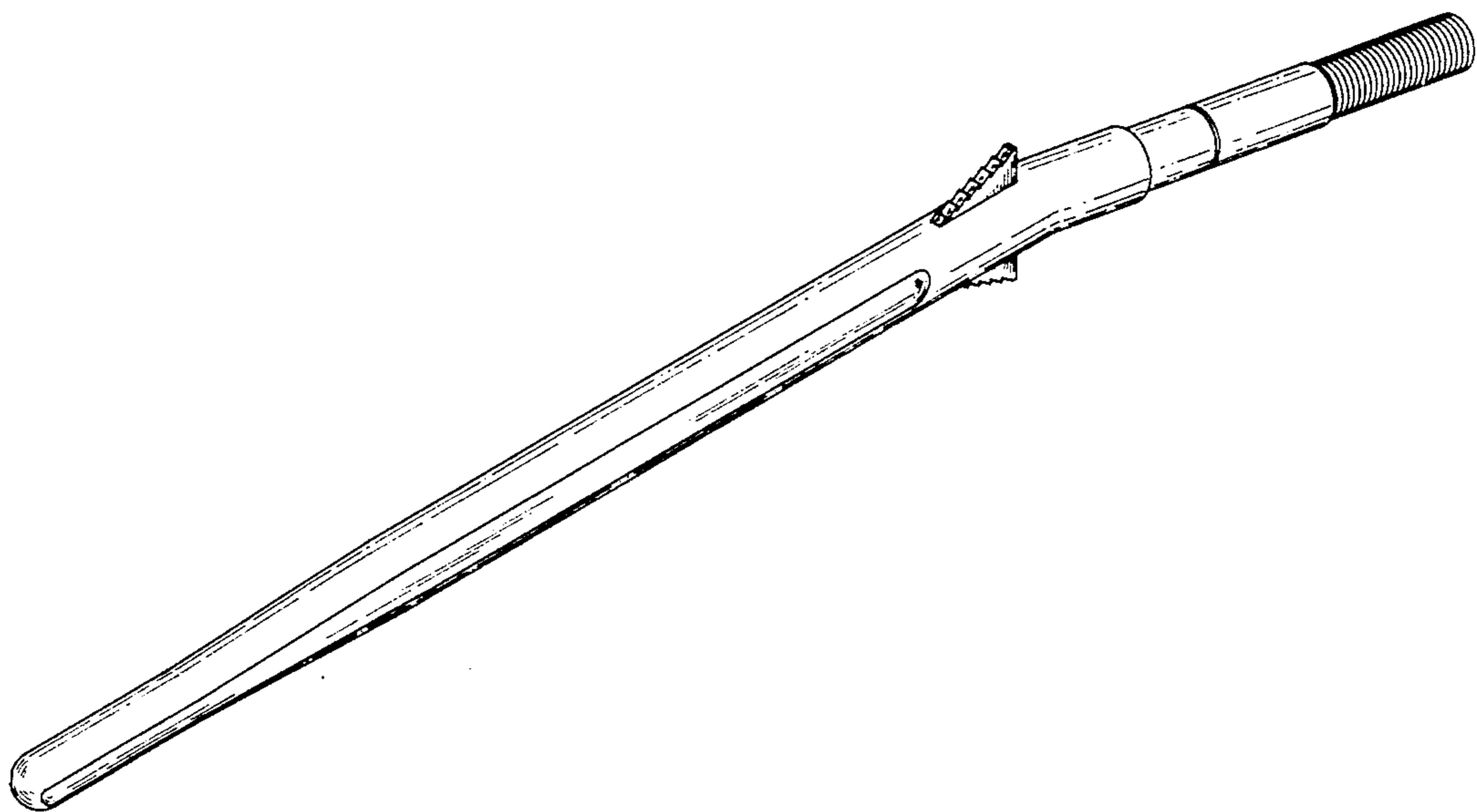

### DESCRIPTION

FIG. 1 is a perspective view of an alignment rod showing our new design;  
 FIG. 2 is a left side view (the right side view is the mirror image thereof);

 FIG. 6 is a top view.



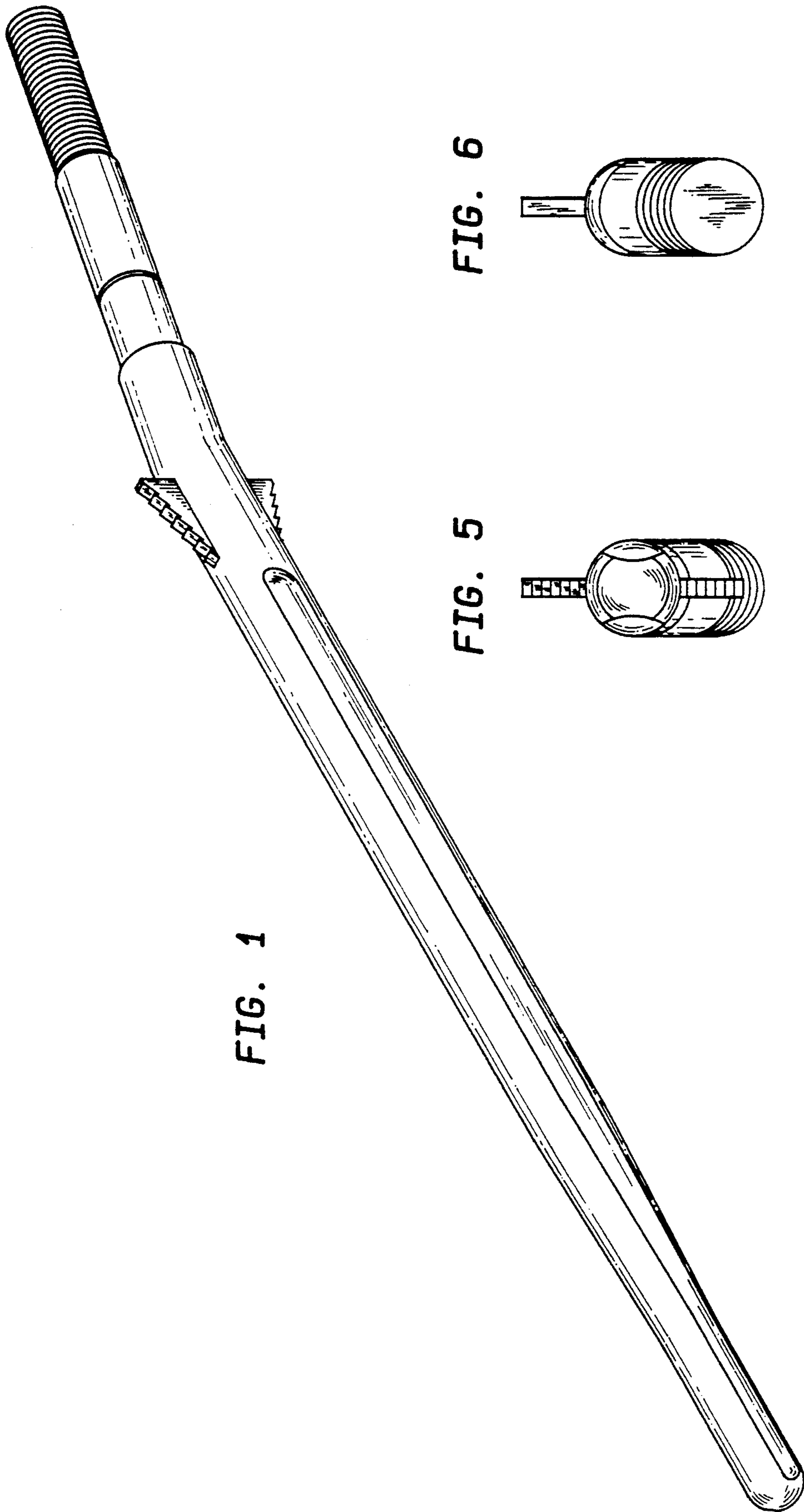

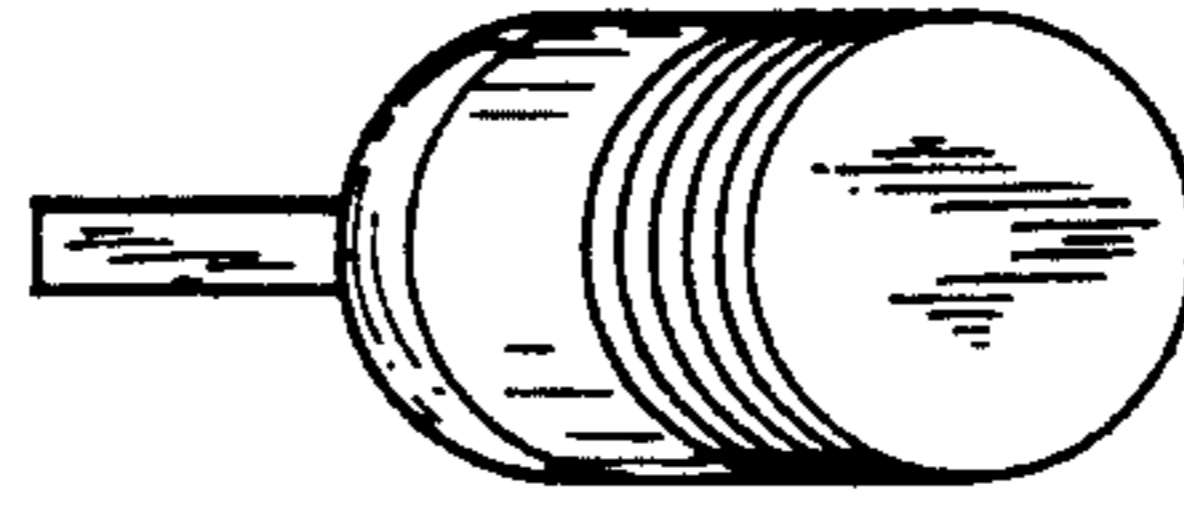

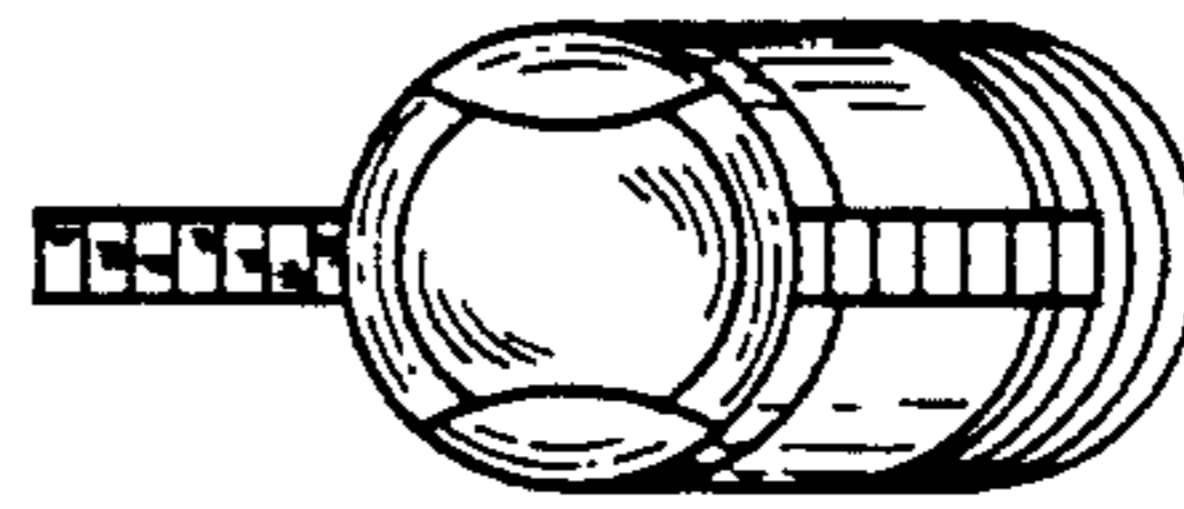

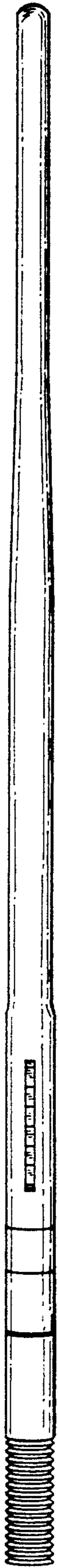

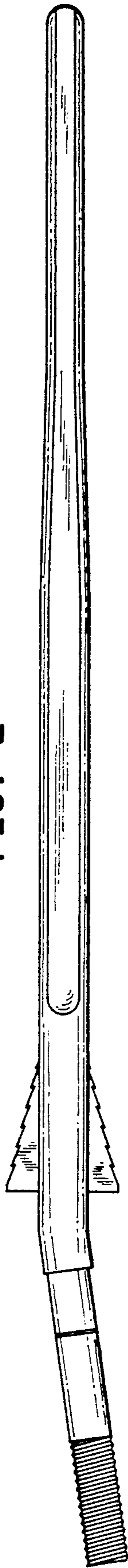
