The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a shoe upper showing our new design;

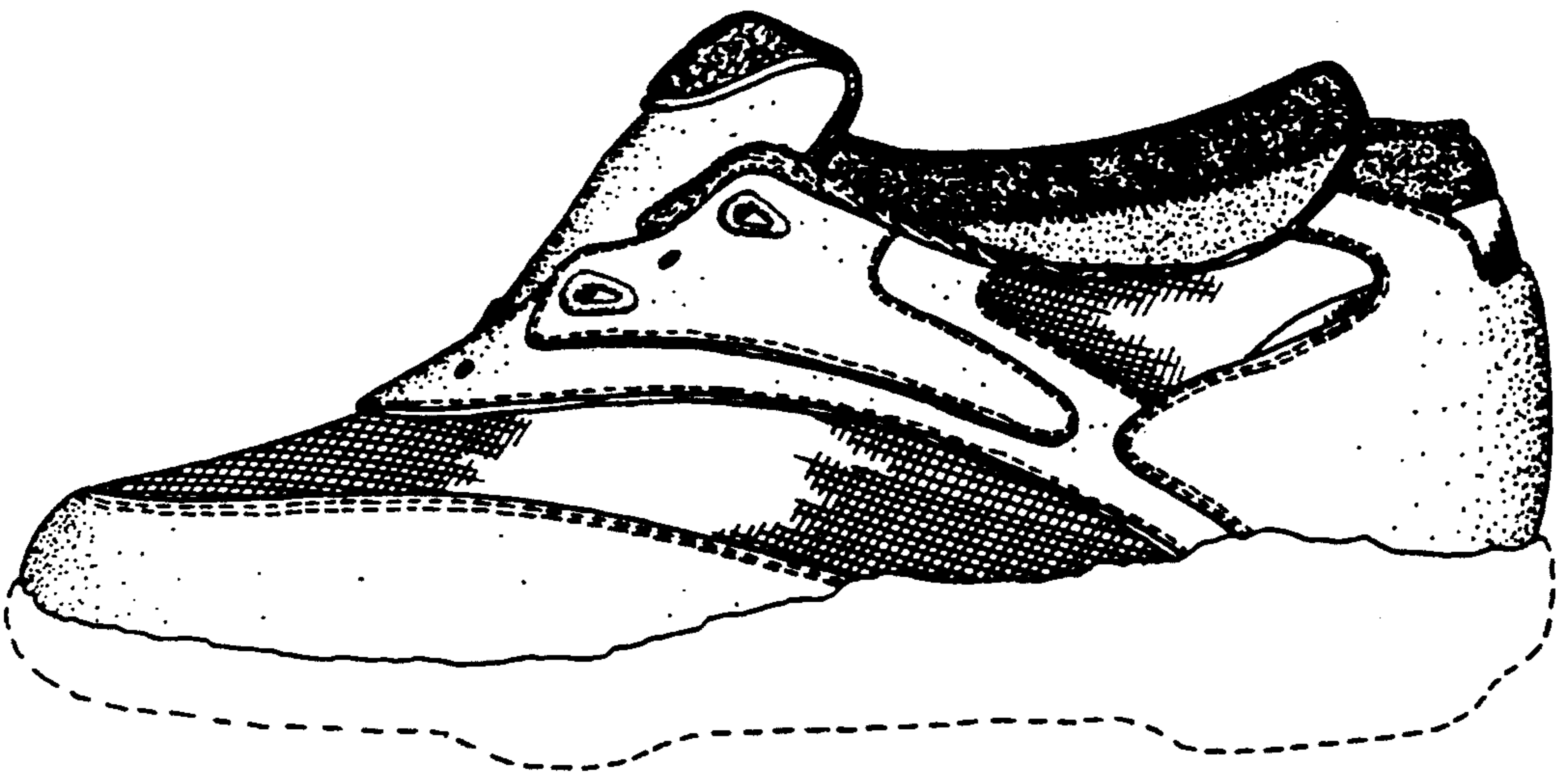

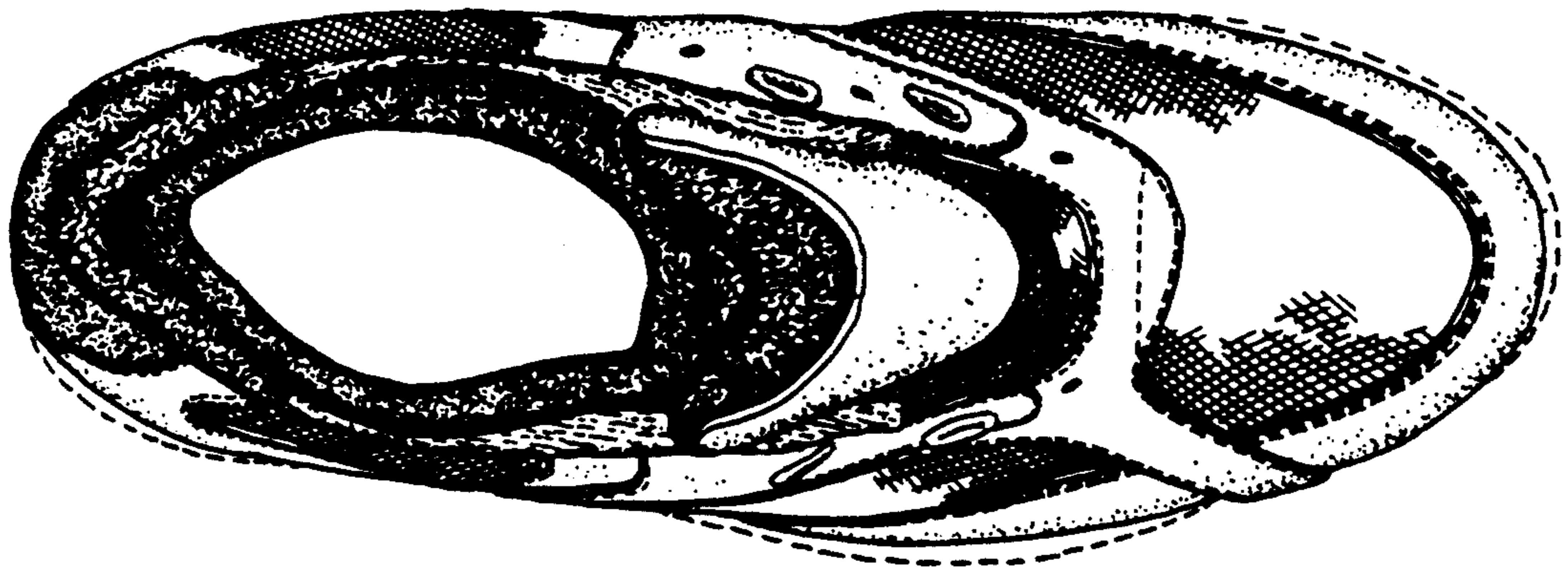

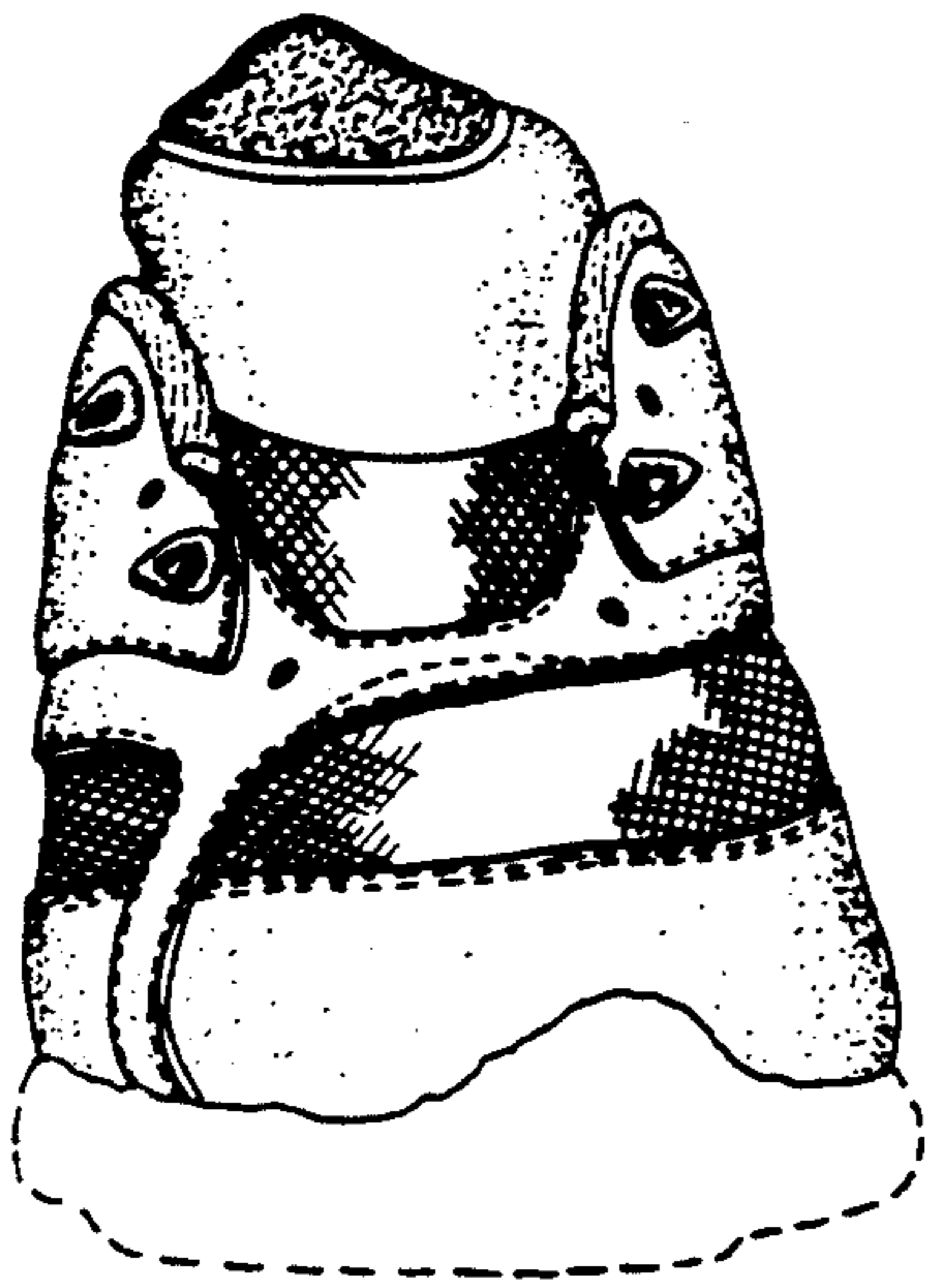

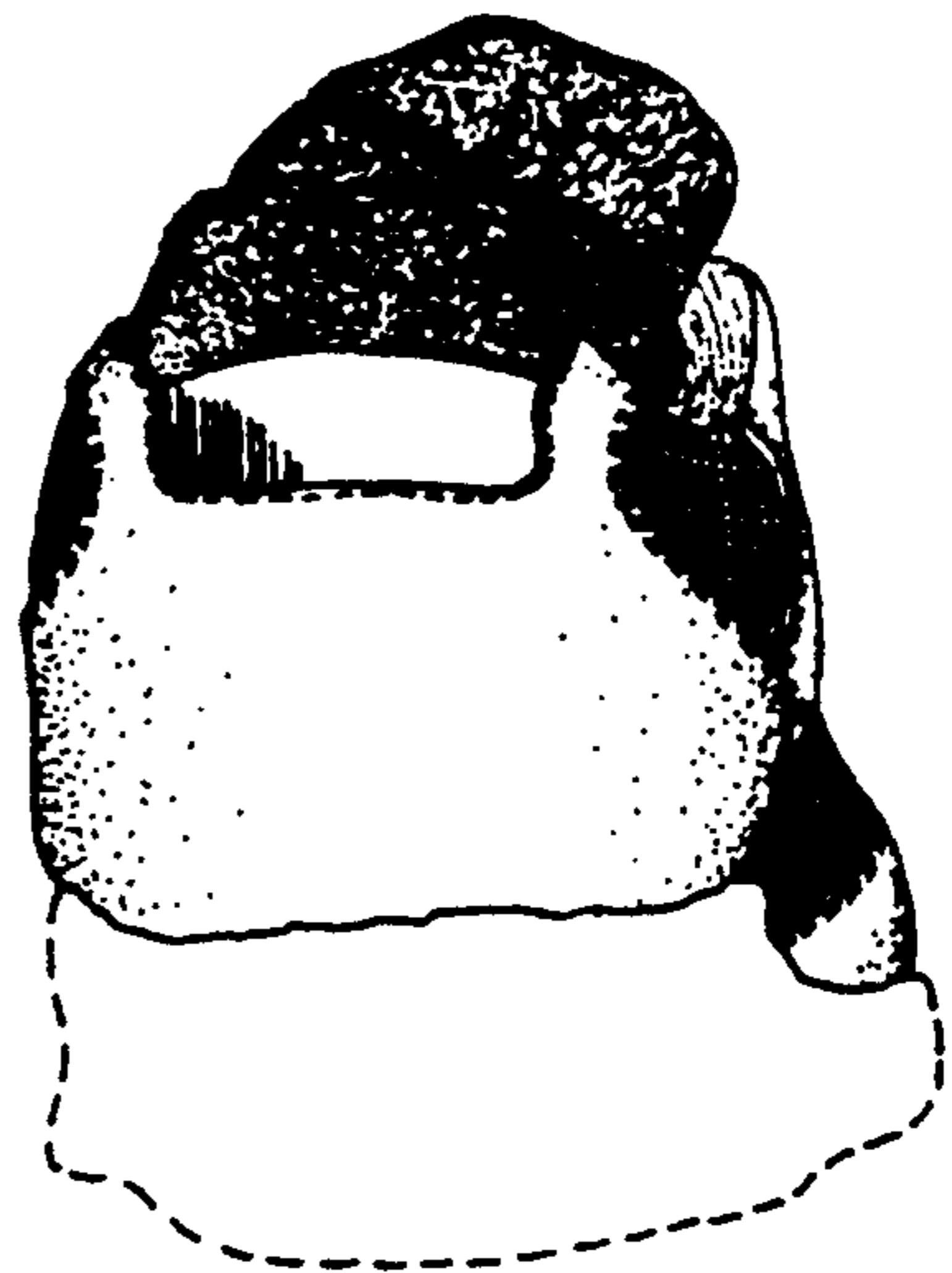

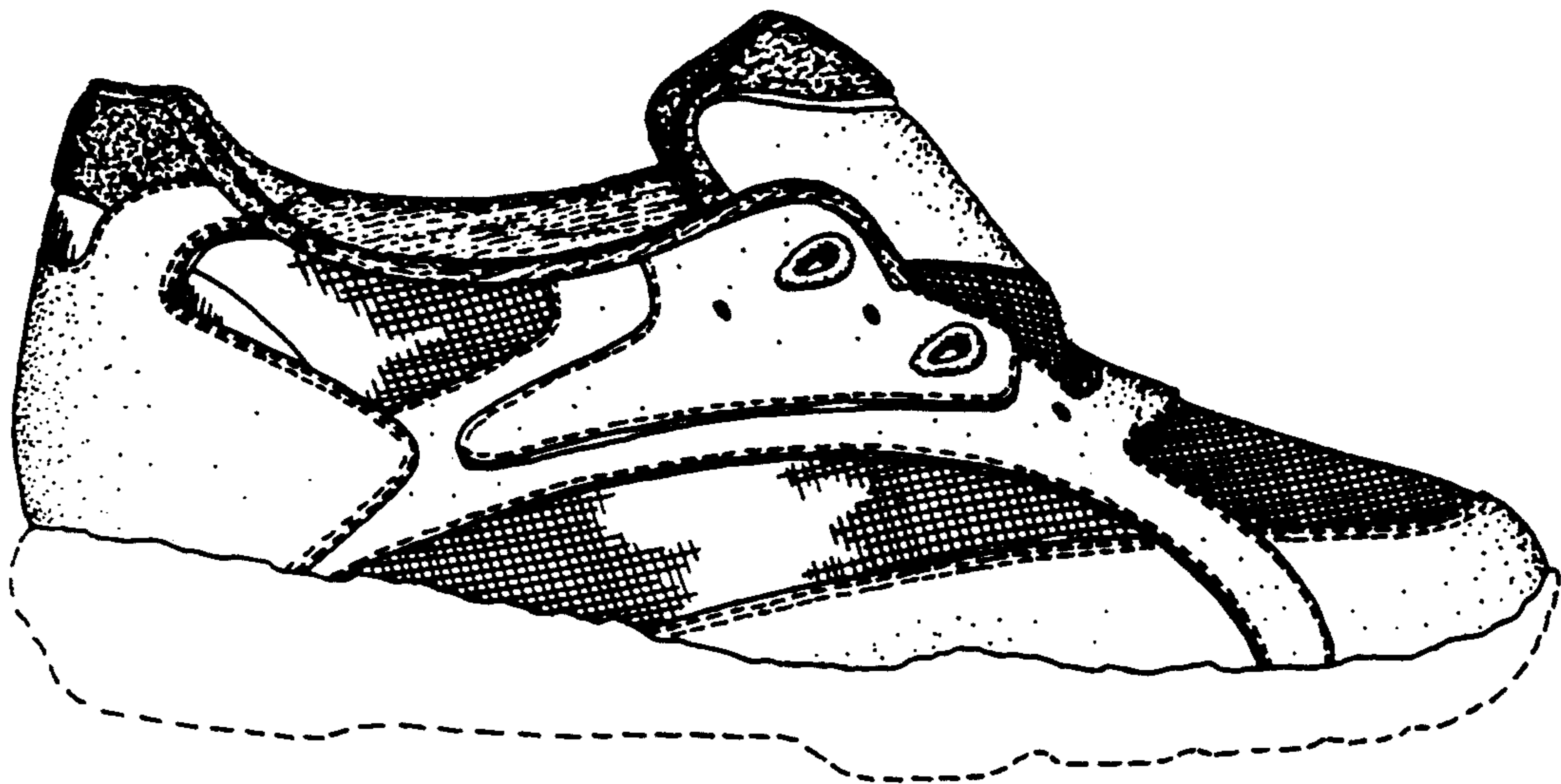

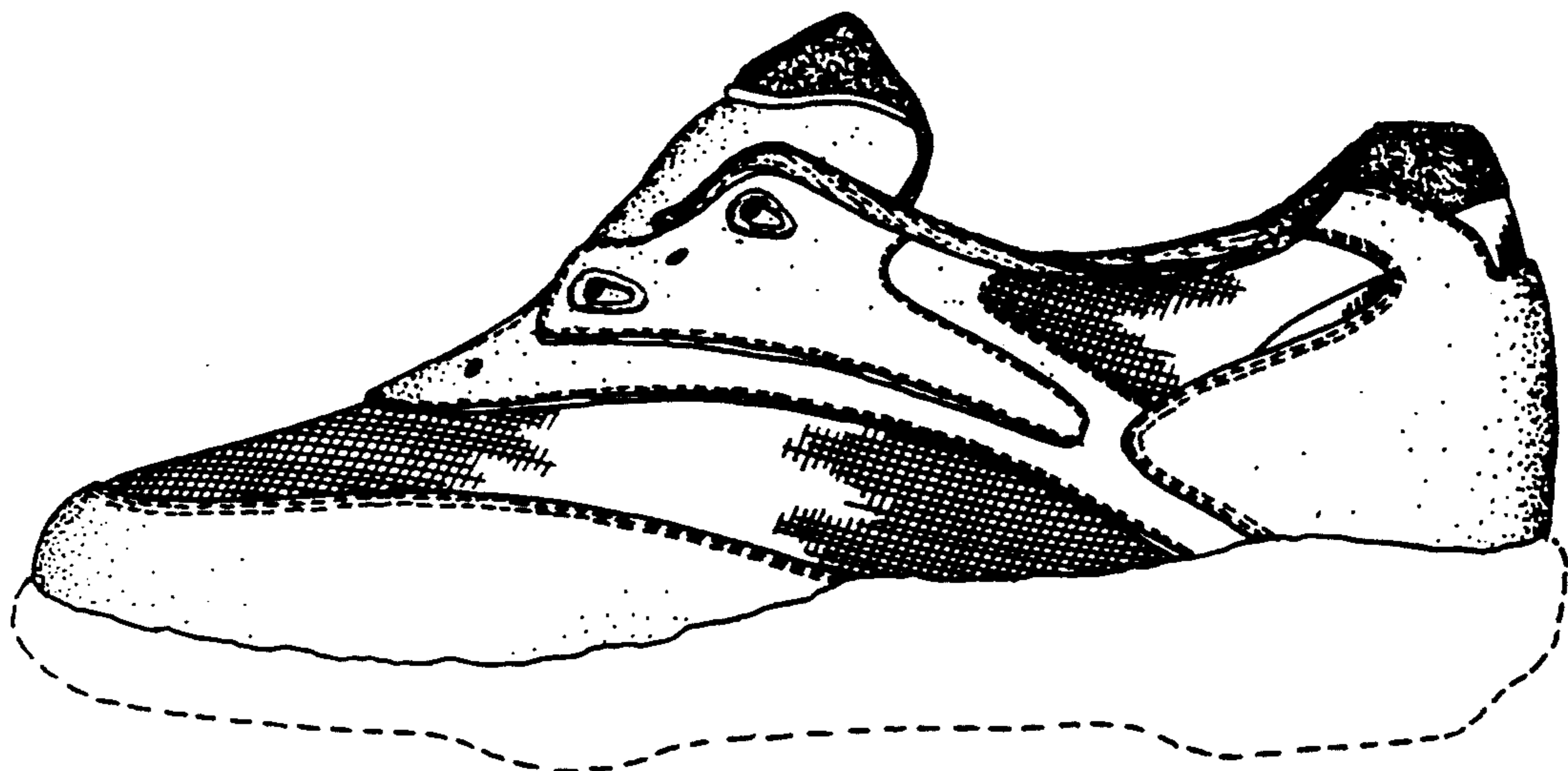

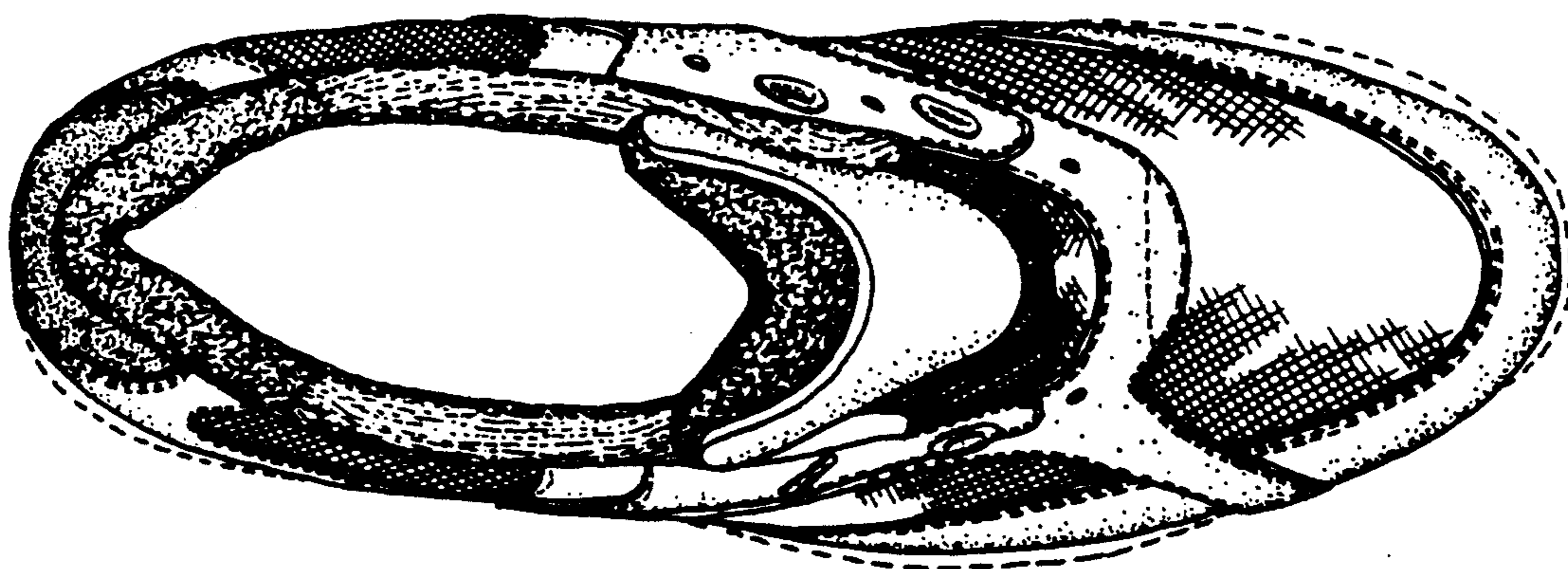

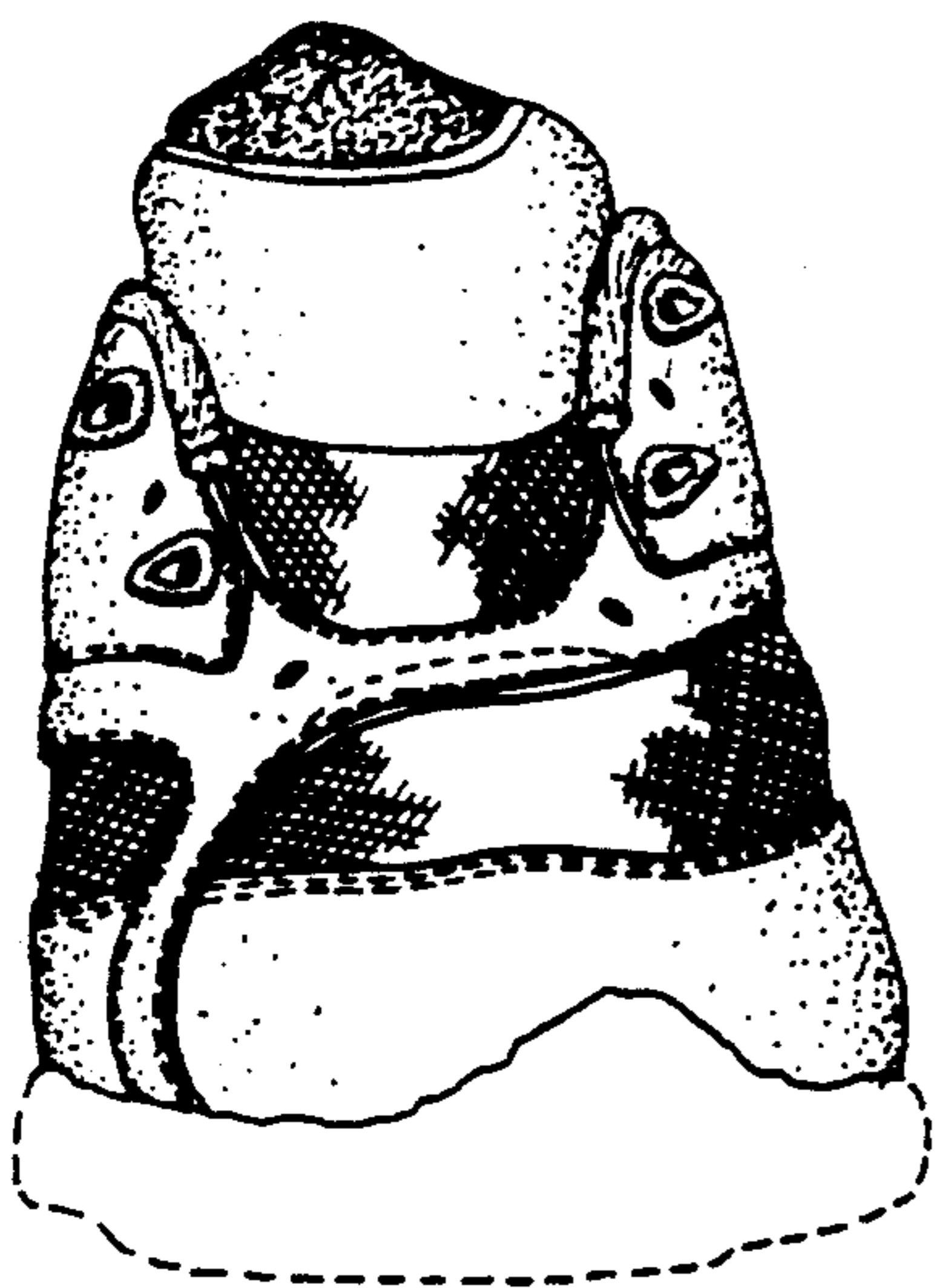

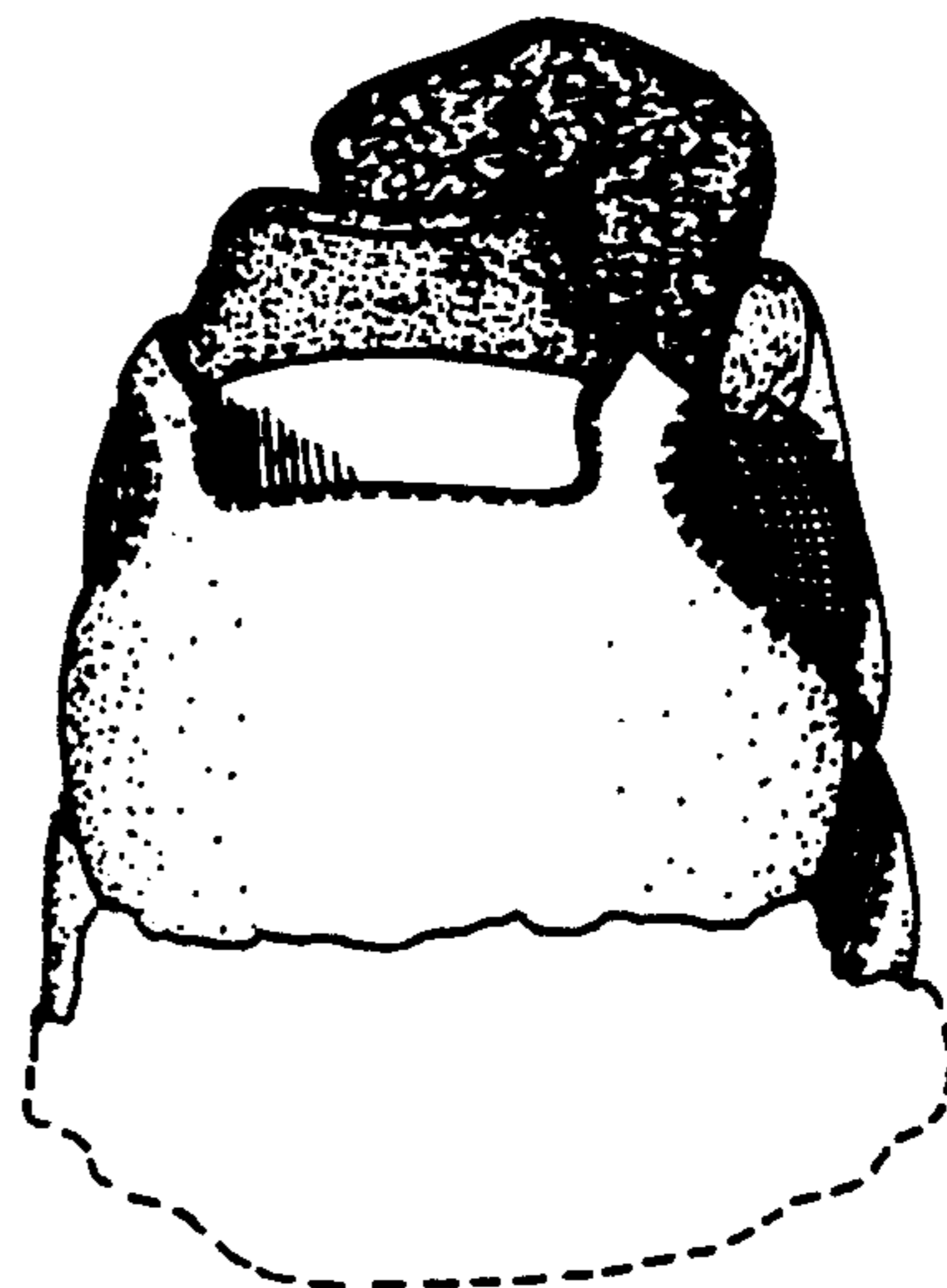

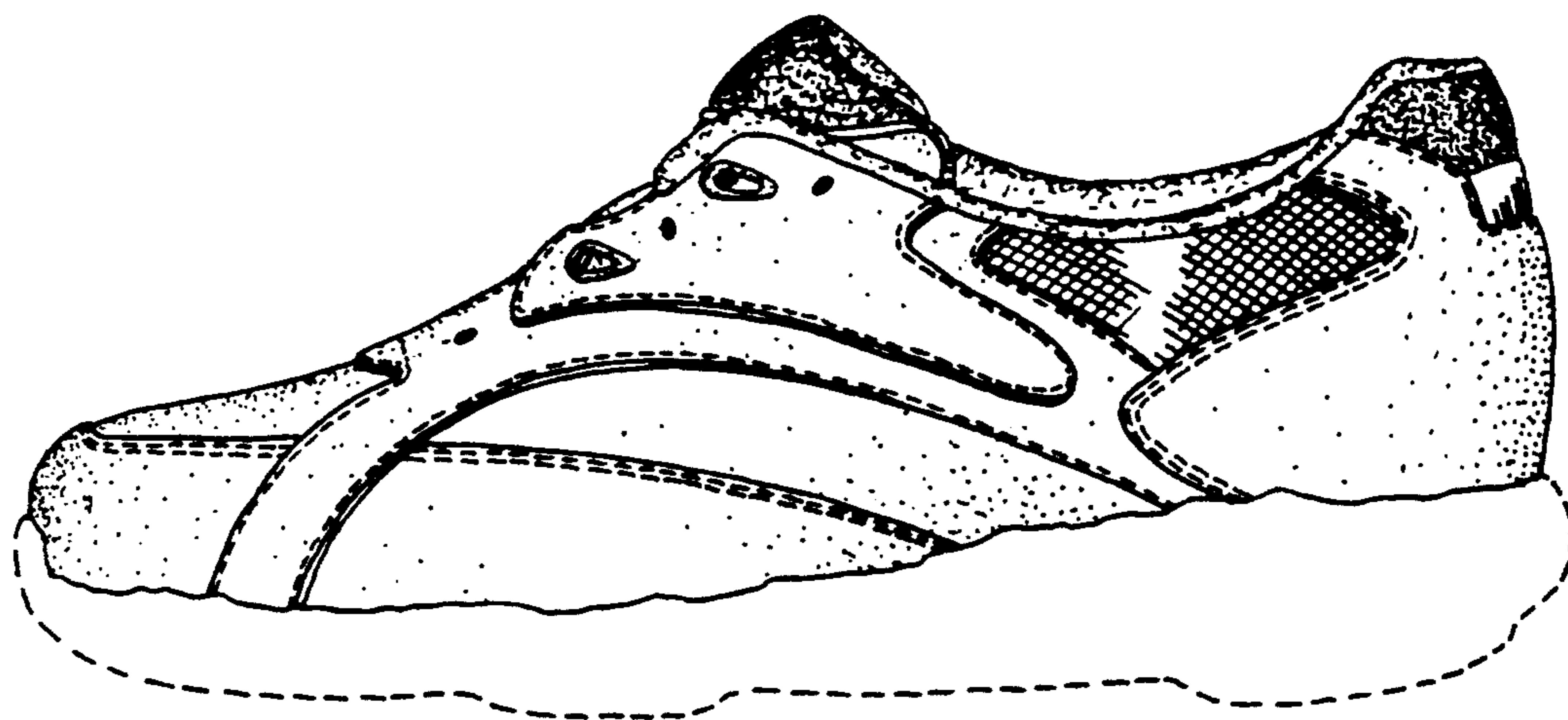

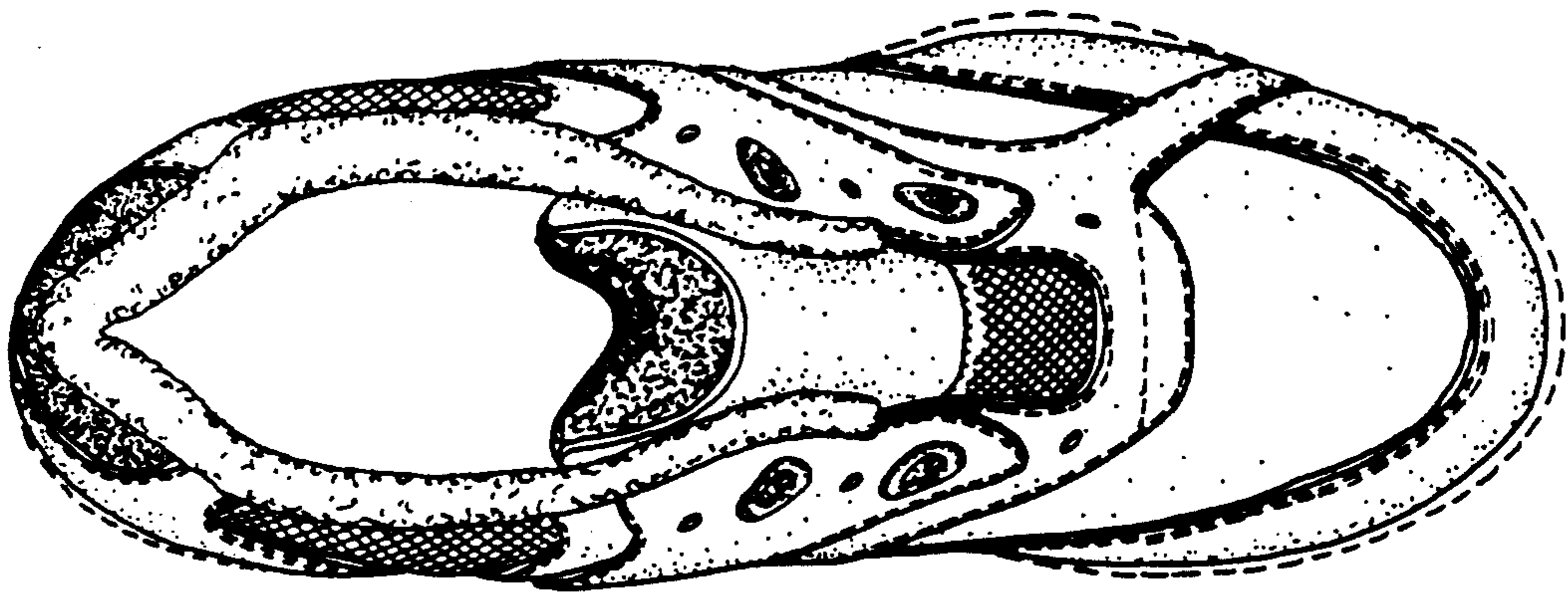

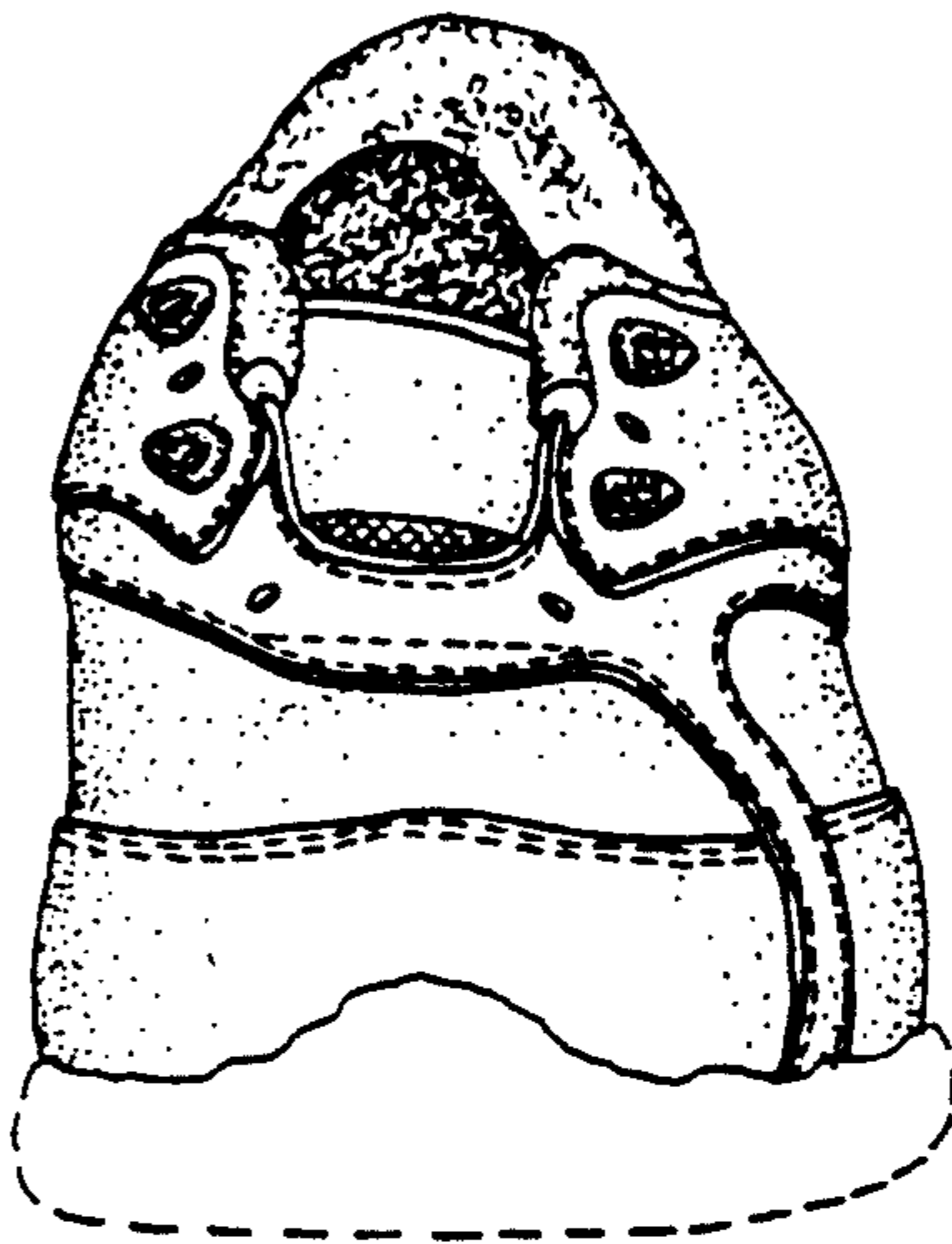

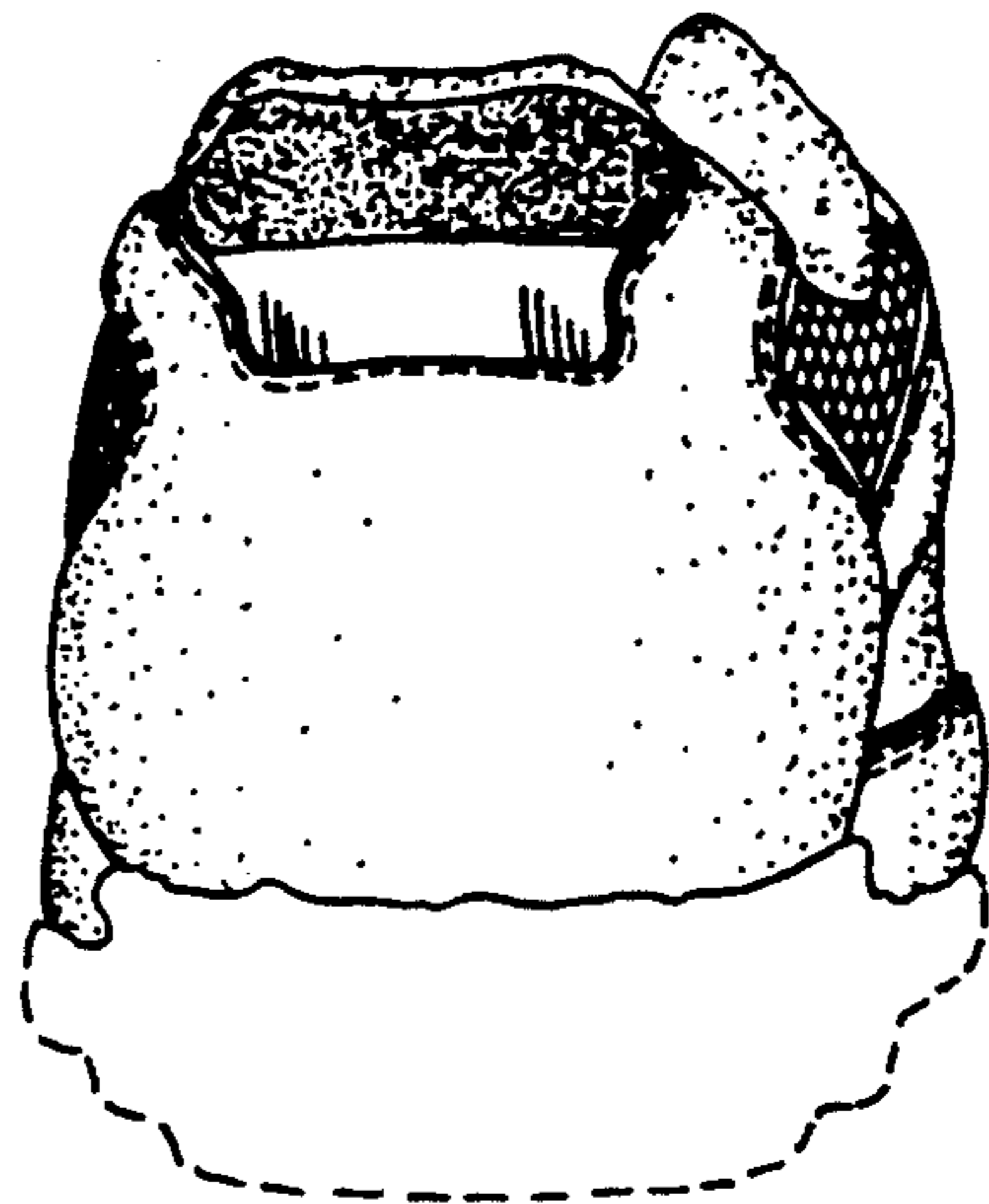
