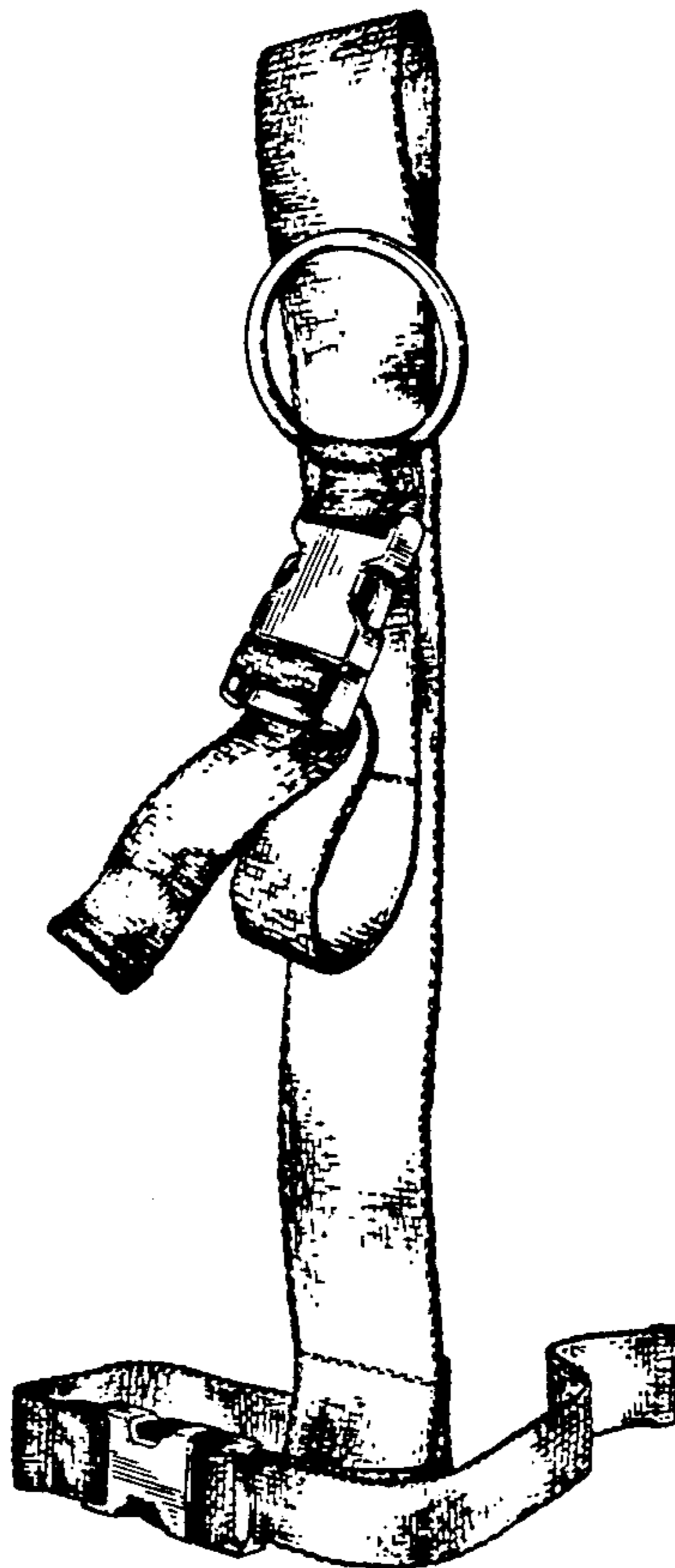

The ornamental design for a cord holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the cord holder showing my new design;
FIG. 2 is a front perspective view thereof with the fasteners attached;
FIG. 3 is a rear, side perspective view thereof; and,
FIG. 4 is a front perspective view thereof showing the article in use.
The broken lines showing a cord are for illustrative purposes only and form no part of the claimed design.



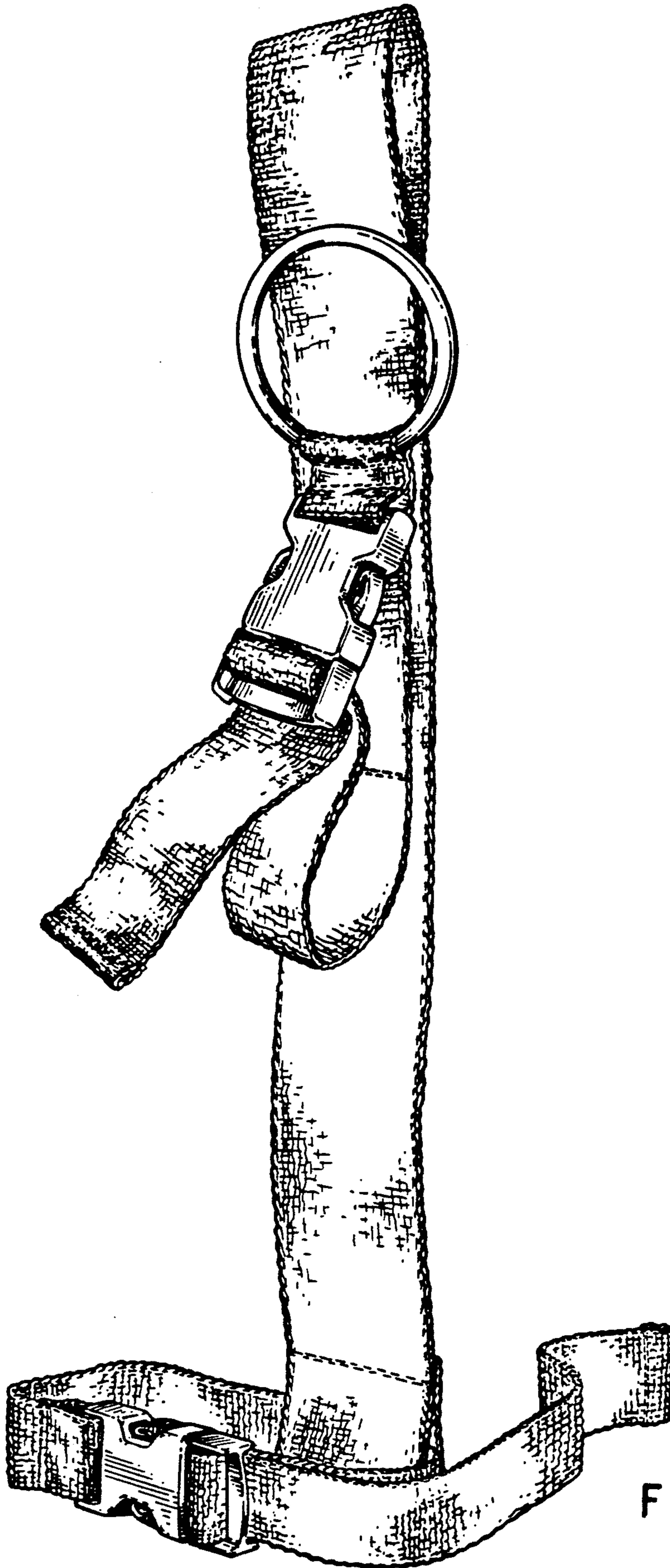

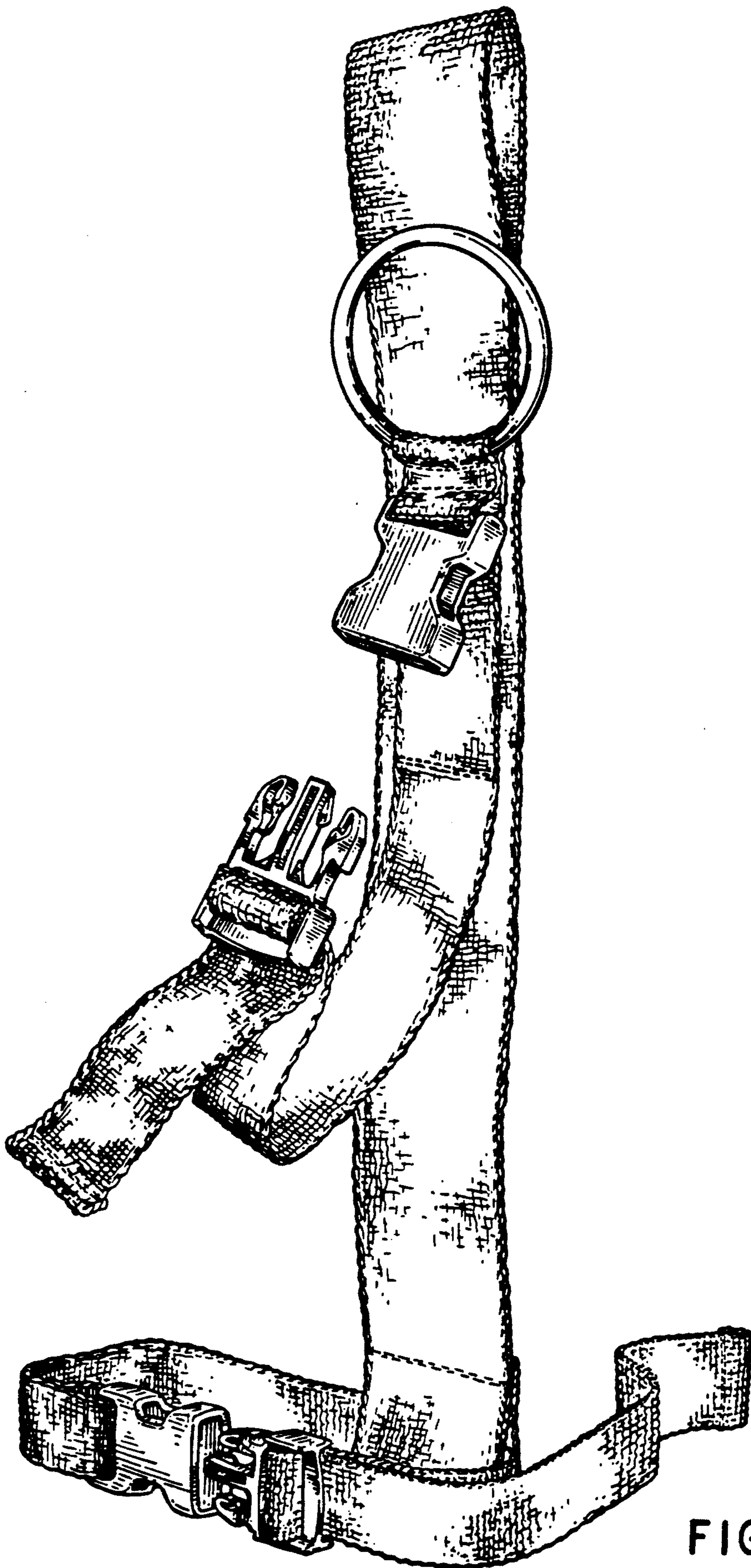

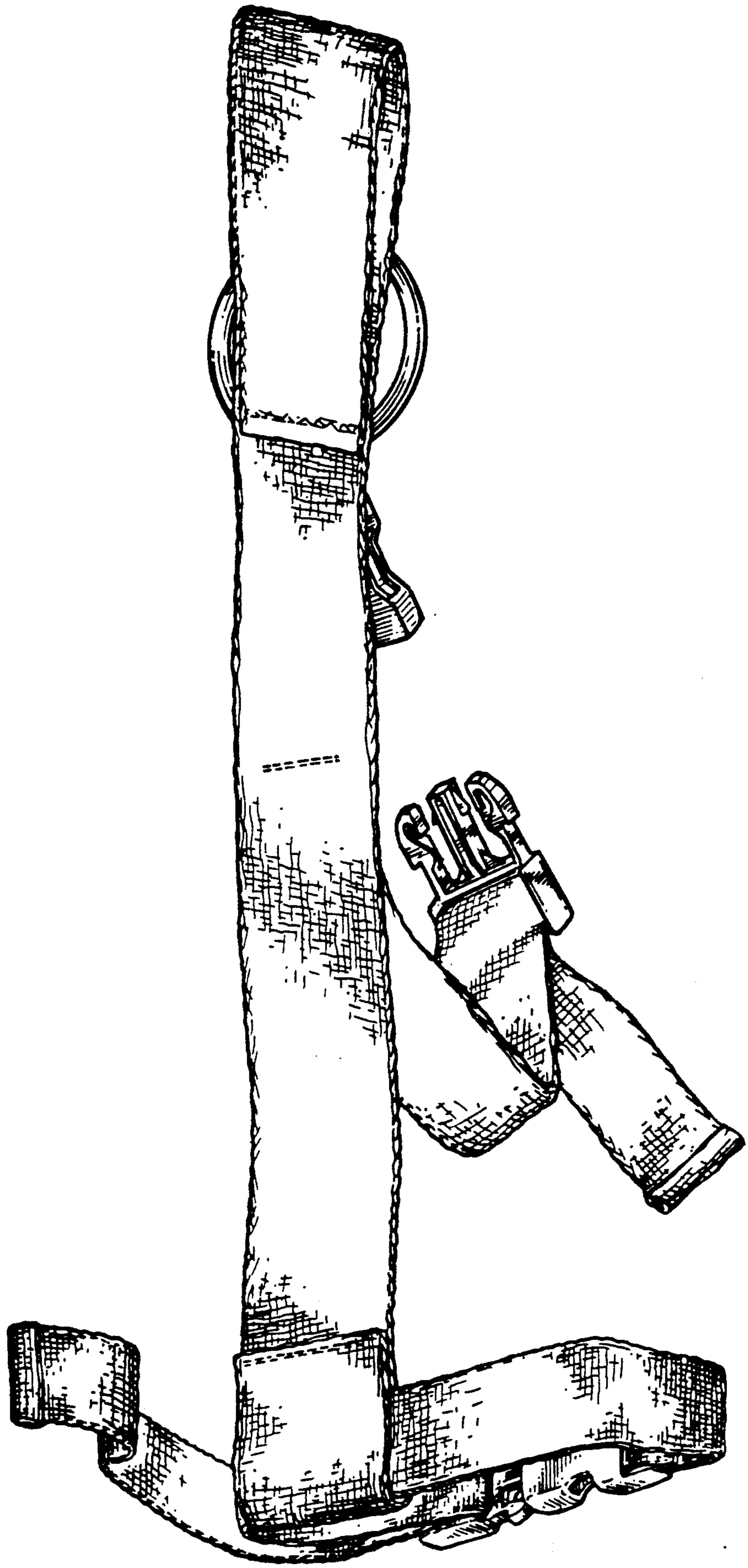

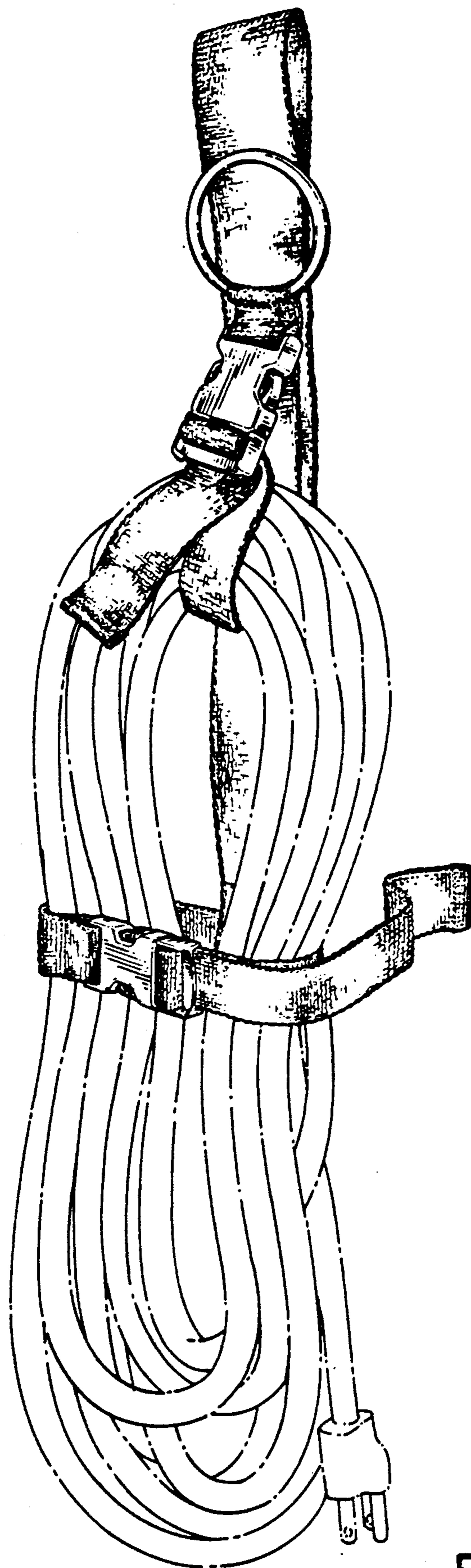
