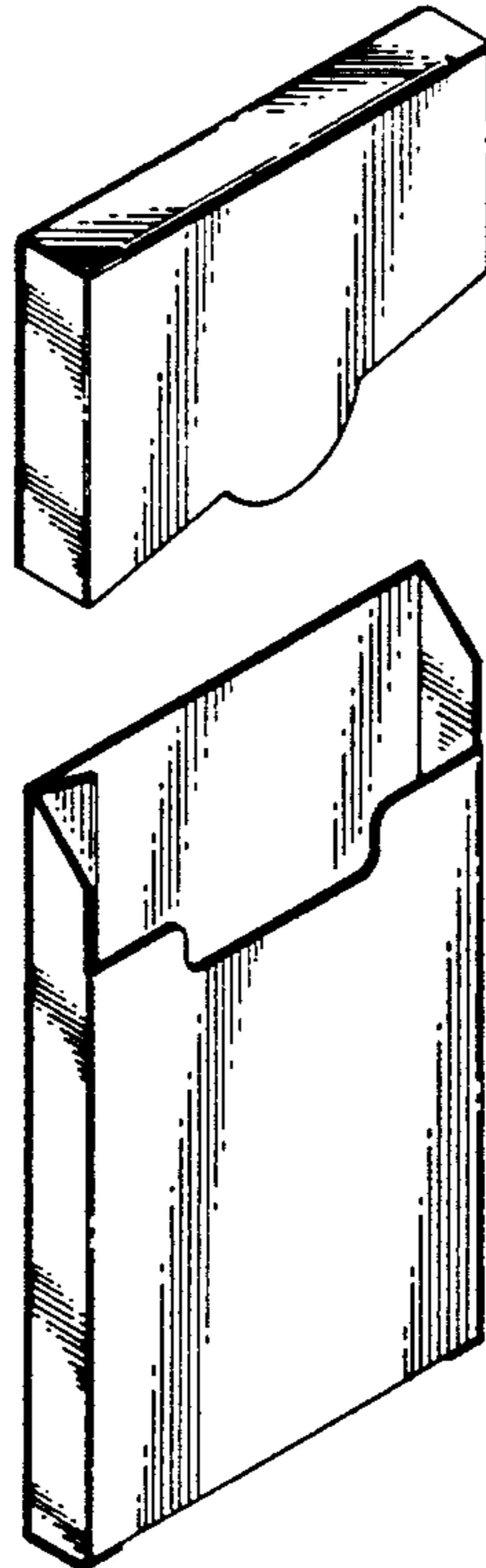

## [57] CLAIM

The ornamental design for a photographic print package, as shown and described.

## DESCRIPTION

FIG. 1 is a front elevational view of a photographic print package showing my new design;  
 FIG. 2 is an exploded front perspective view thereof;  
 FIG. 3 is a front perspective view thereof, in closed position;  
 FIG. 4 is a rear perspective view thereof, in closed position;

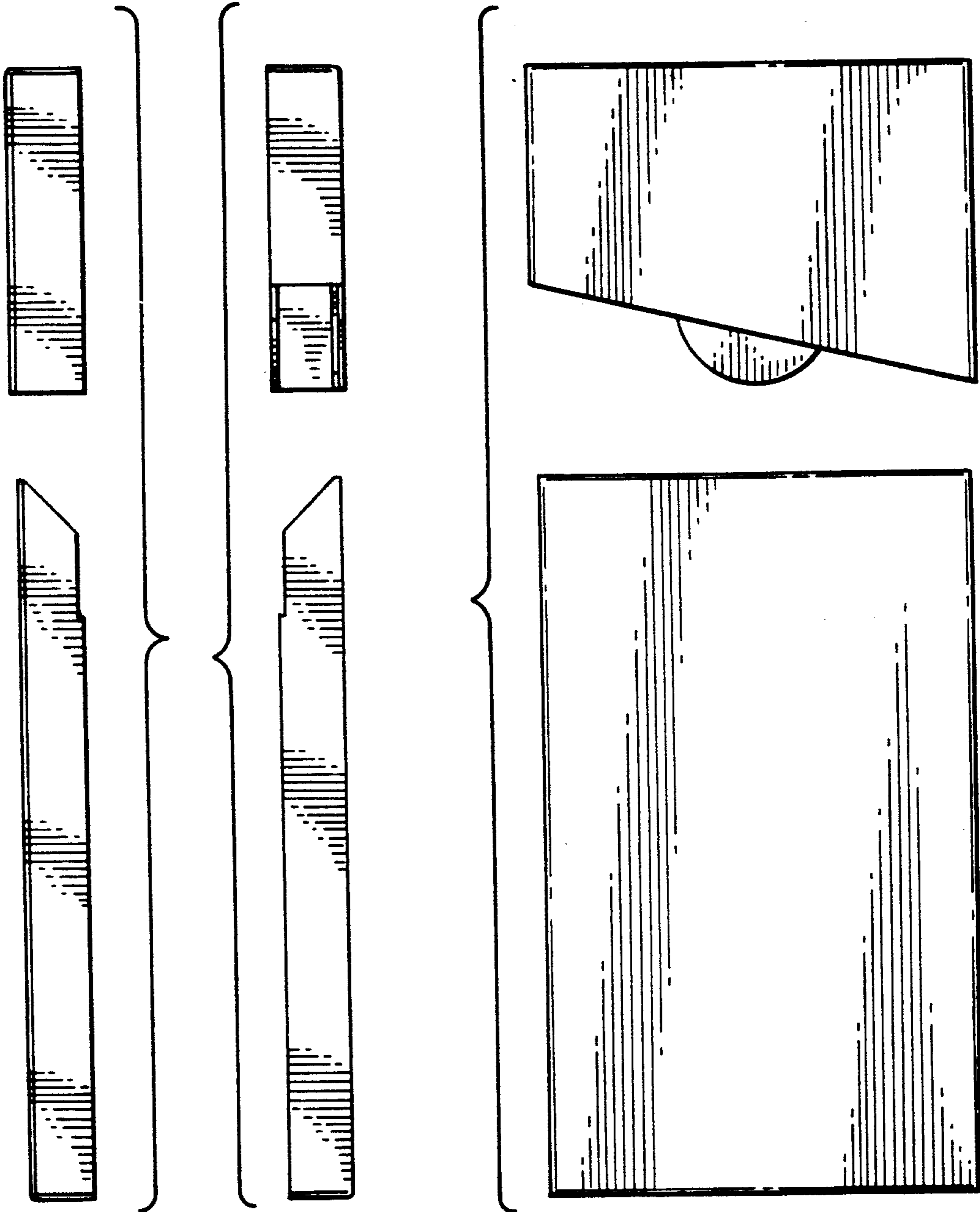


FIG. 5 FIG. 6

 FIG. 5 is an exploded left side elevational view thereof;  
 FIG. 6 is an exploded right side elevational view thereof;  
 FIG. 7 is an exploded rear elevational view thereof;  
 FIG. 8 is a top plan view of a cover, shown separately for clarity of illustration;  
 FIG. 9 is a bottom plan view of a package, shown separately for clarity of illustration;  
 FIG. 10 is a bottom plan view of FIG. 8;  
 FIG. 11 is a top plan view of a package with cover removed for clarity of illustration;  
 FIG. 12 is a front perspective view of an alternate embodiment of the cover;  
 FIG. 13 is a left side elevational view of FIG. 12;  
 FIG. 14 is a top plan view of FIG. 13; and,  
 FIG. 15 is a bottom plan view of FIG. 12.



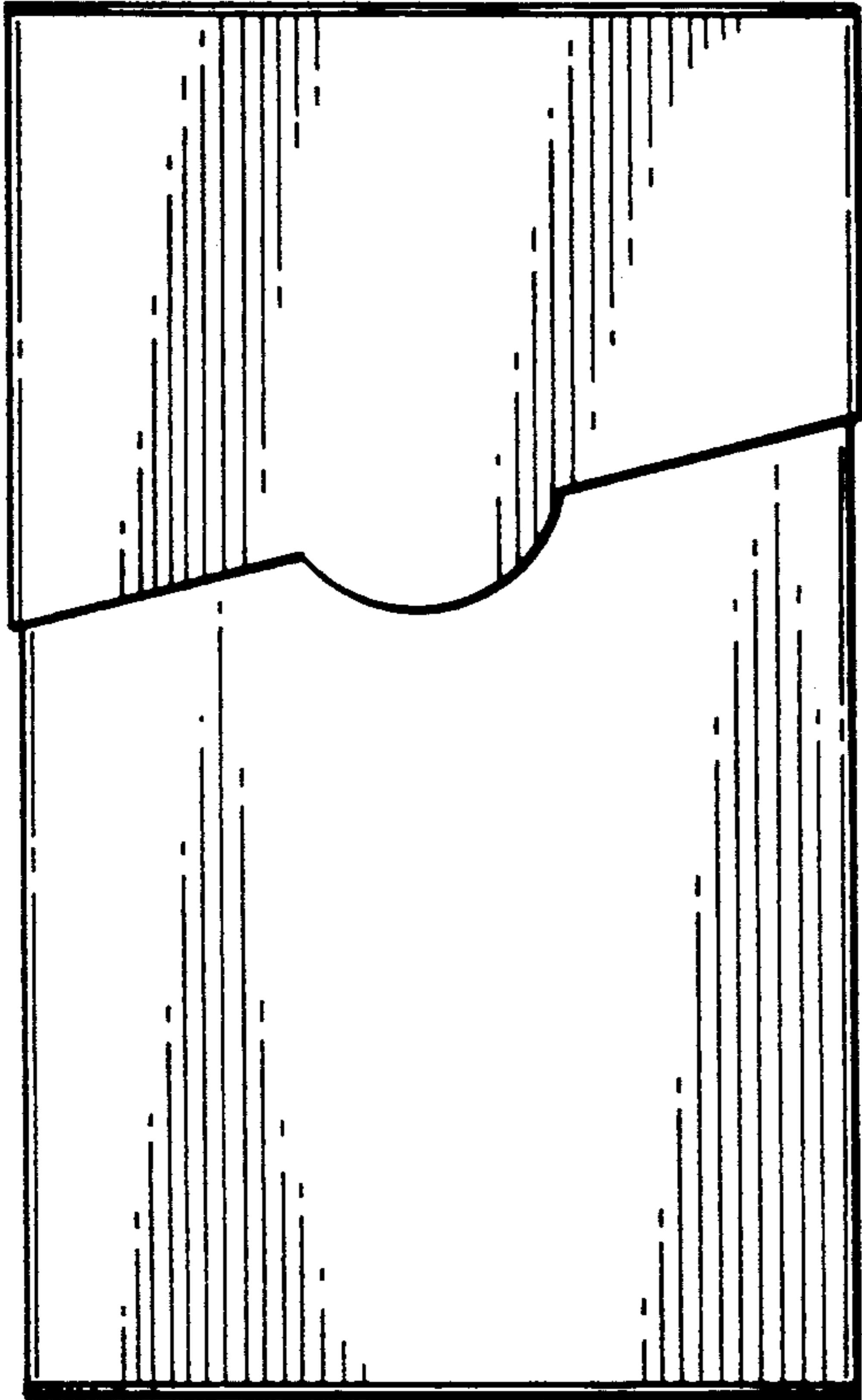

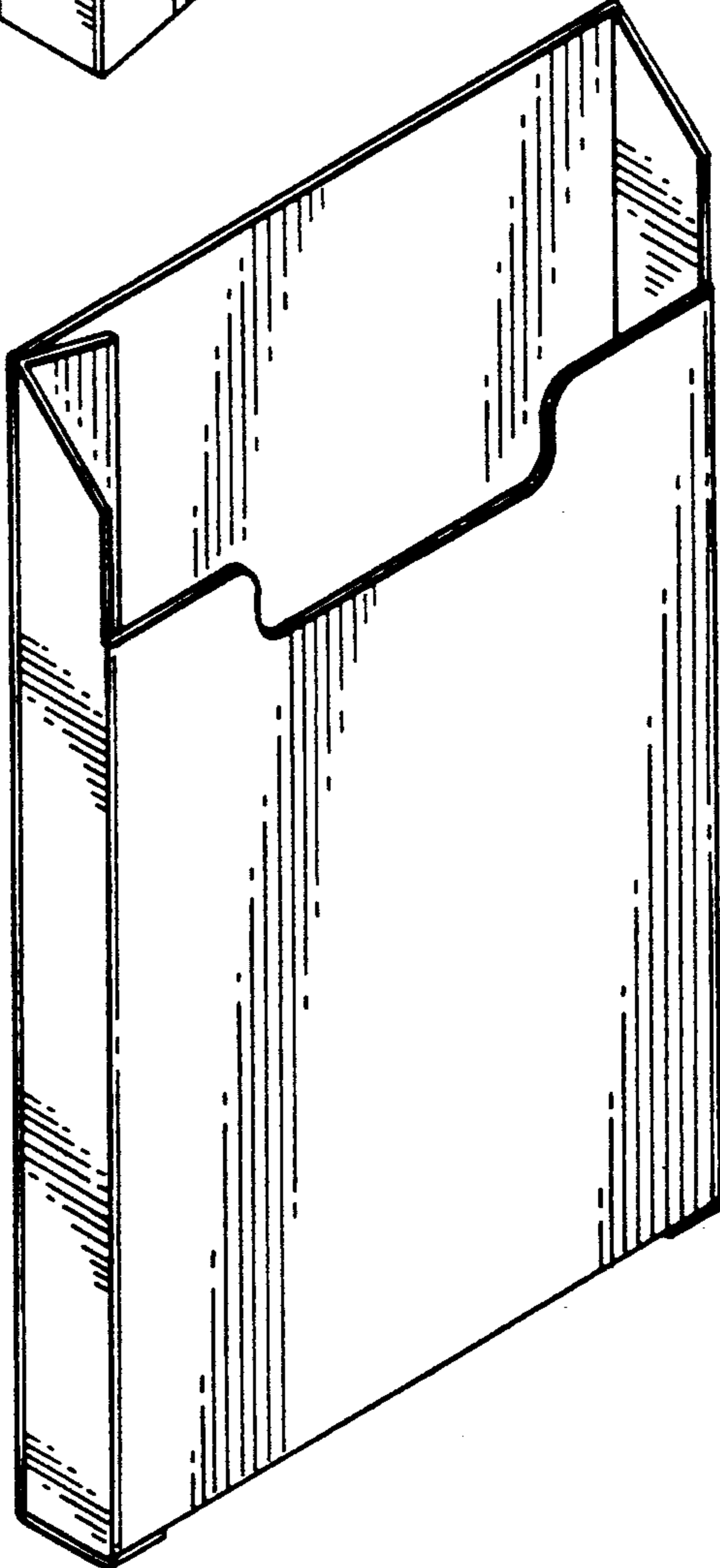
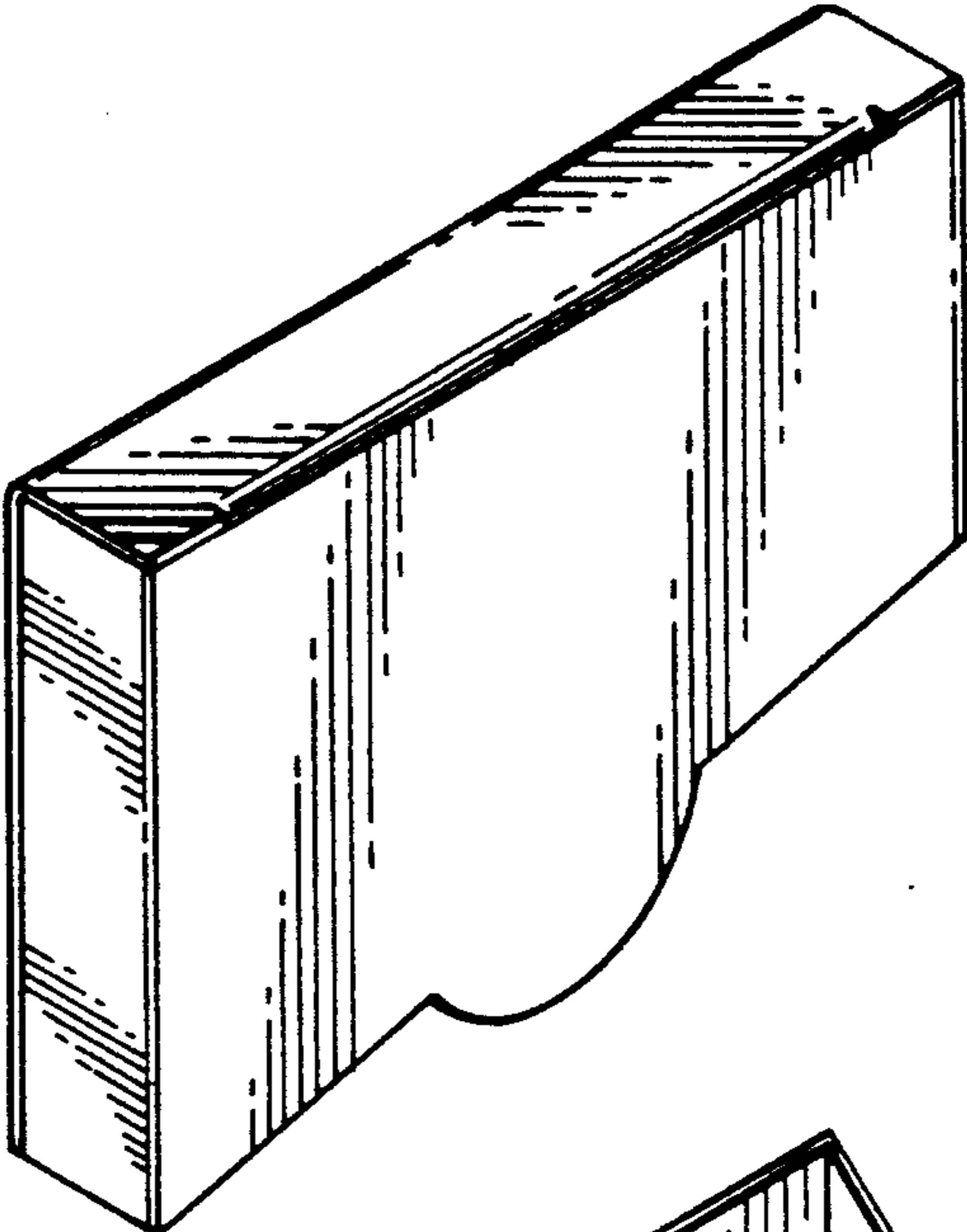

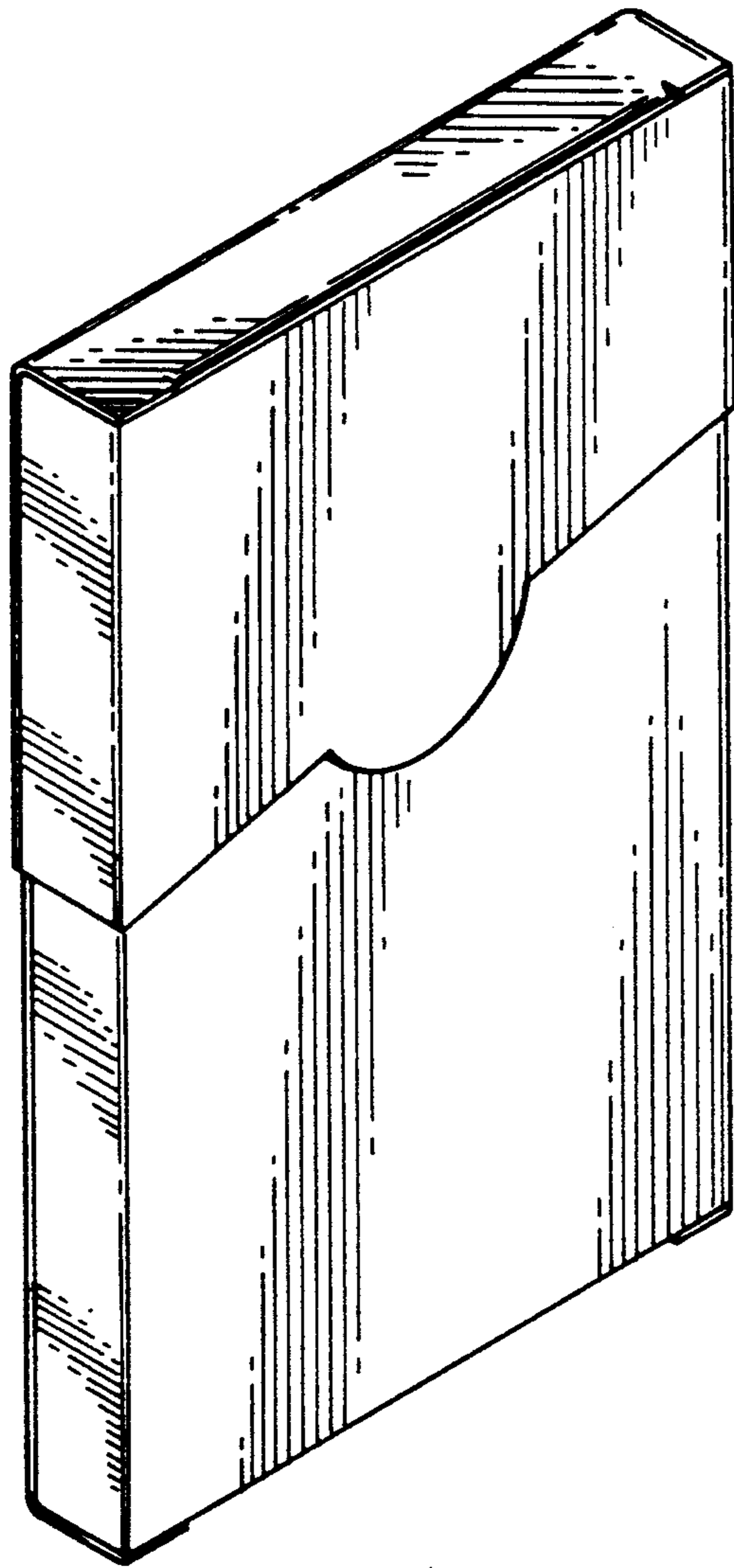
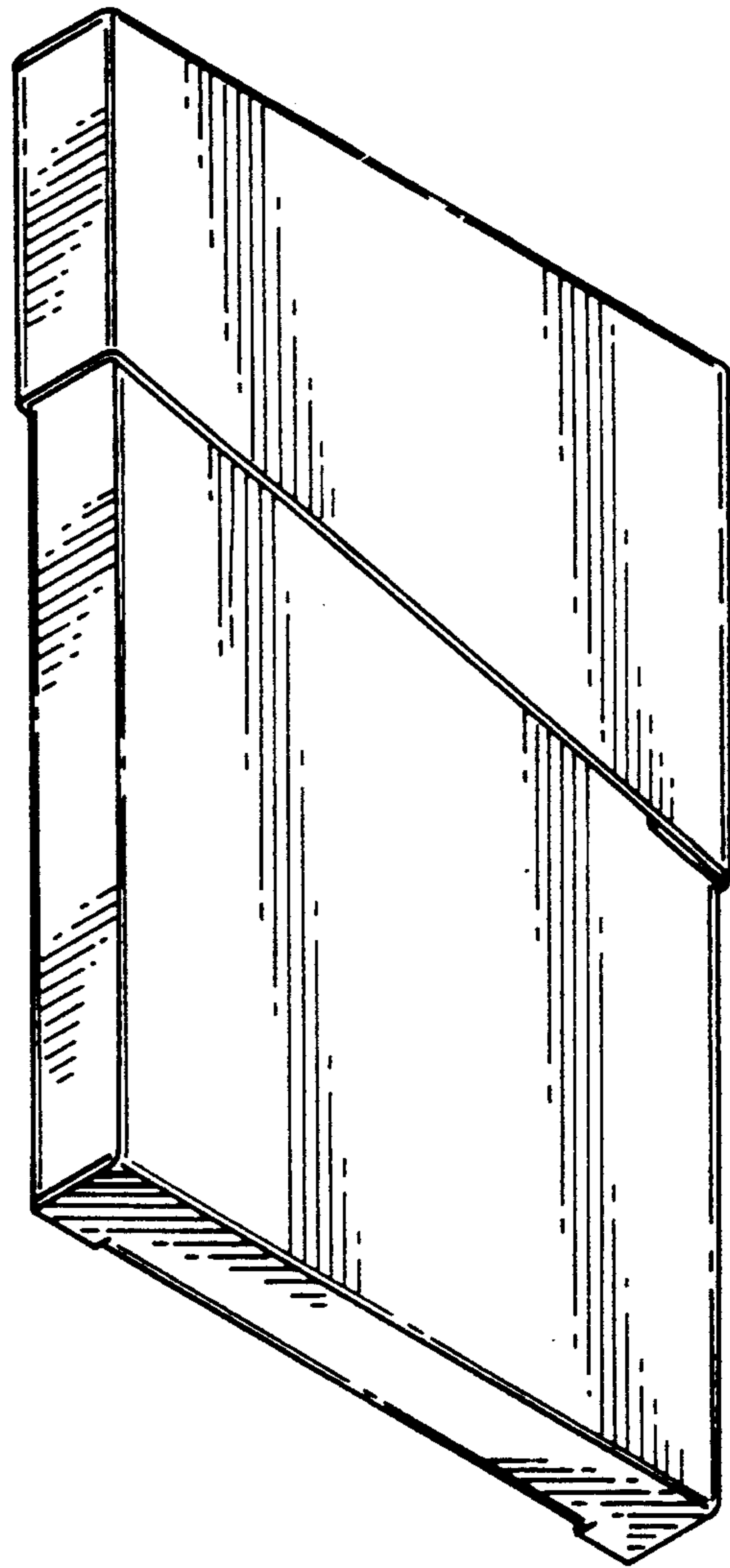

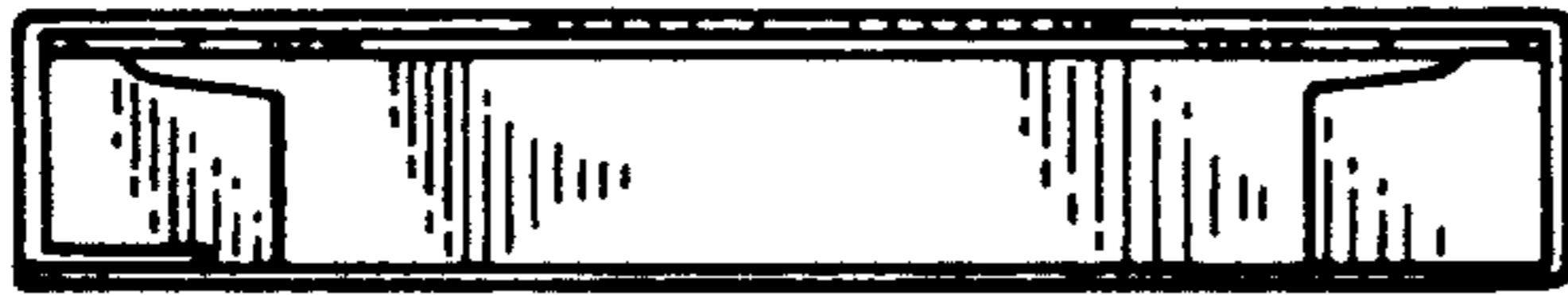

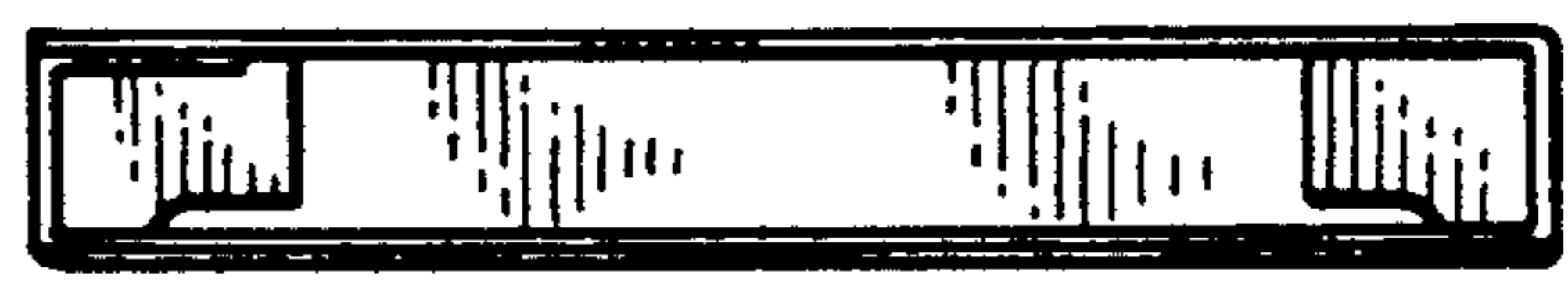

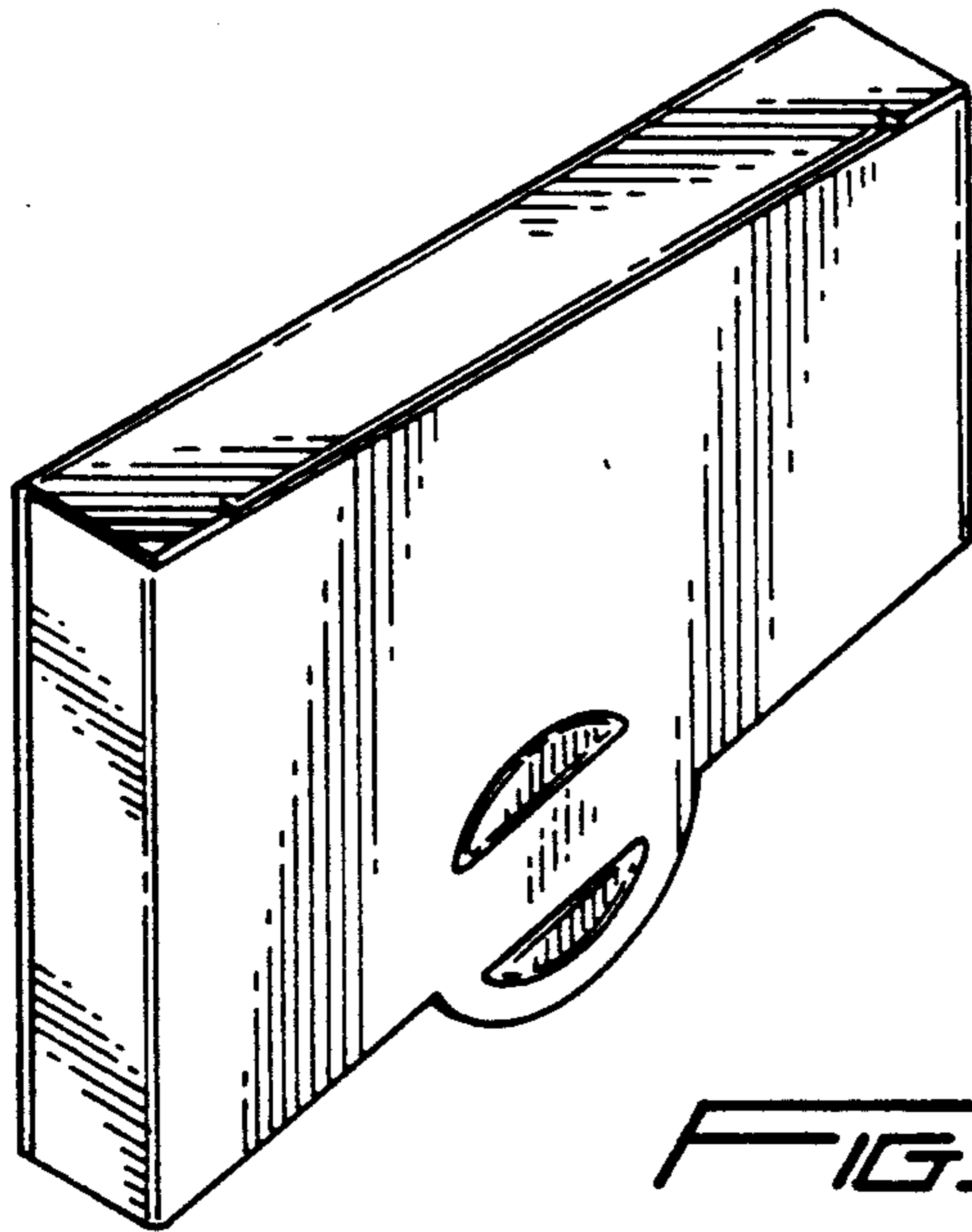

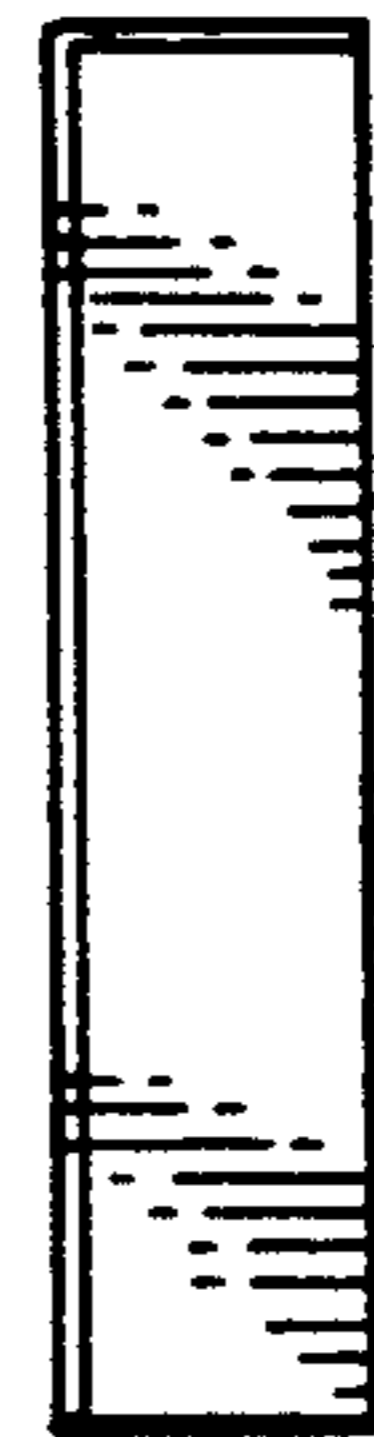

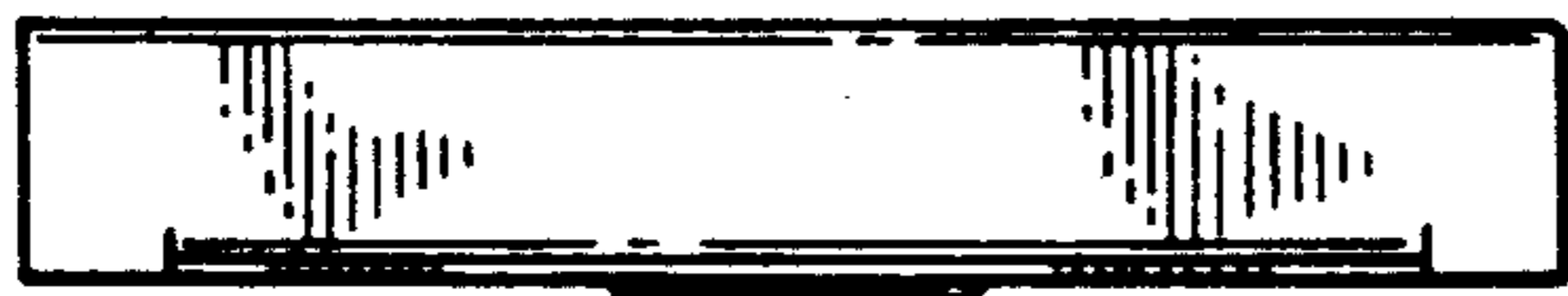
