FIG. 3 is a right shoe elevational view thereof;

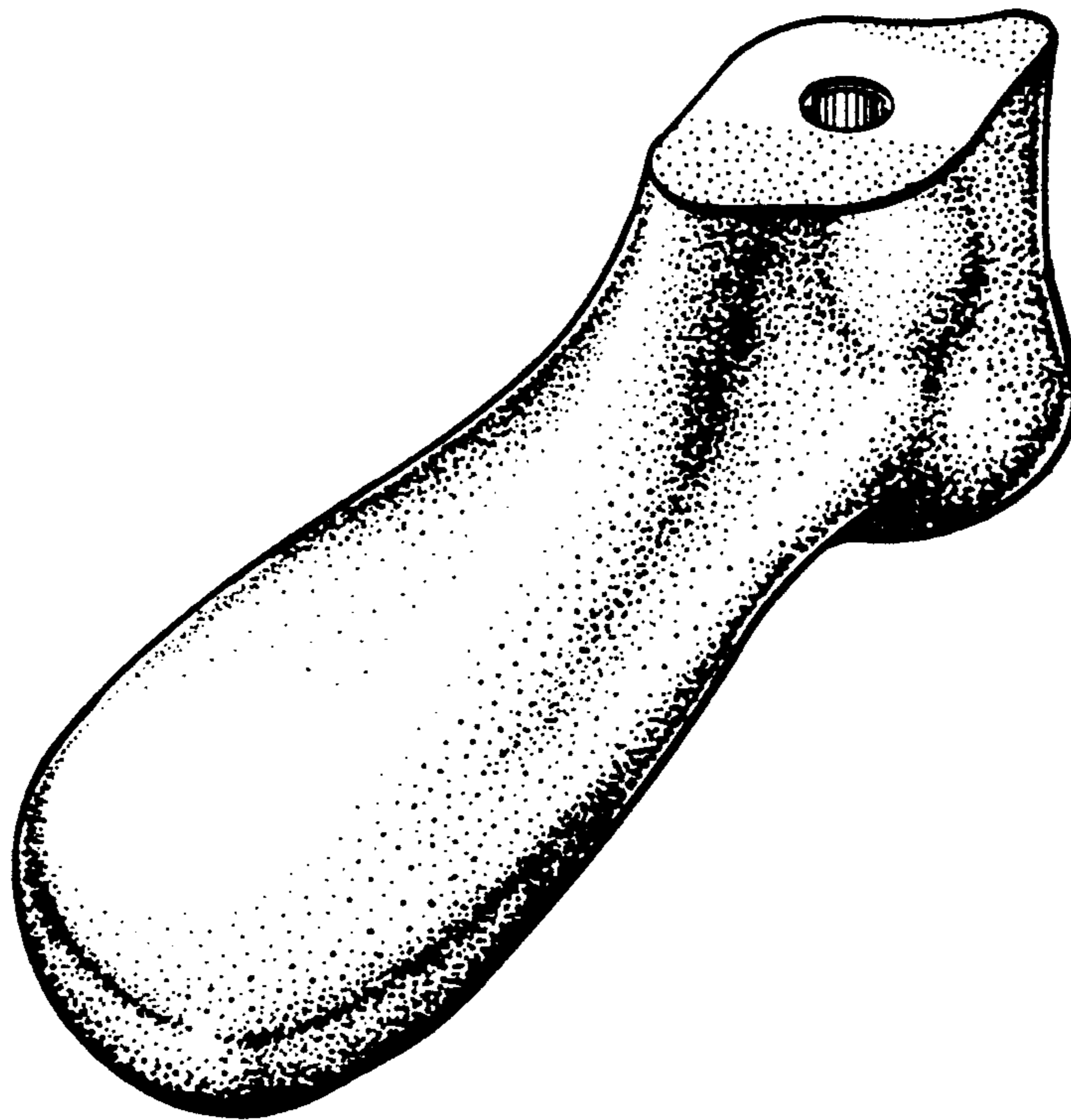
FIG. 4 is a front elevational view thereof;

FIG. 8 is a bottom elevational thereof.



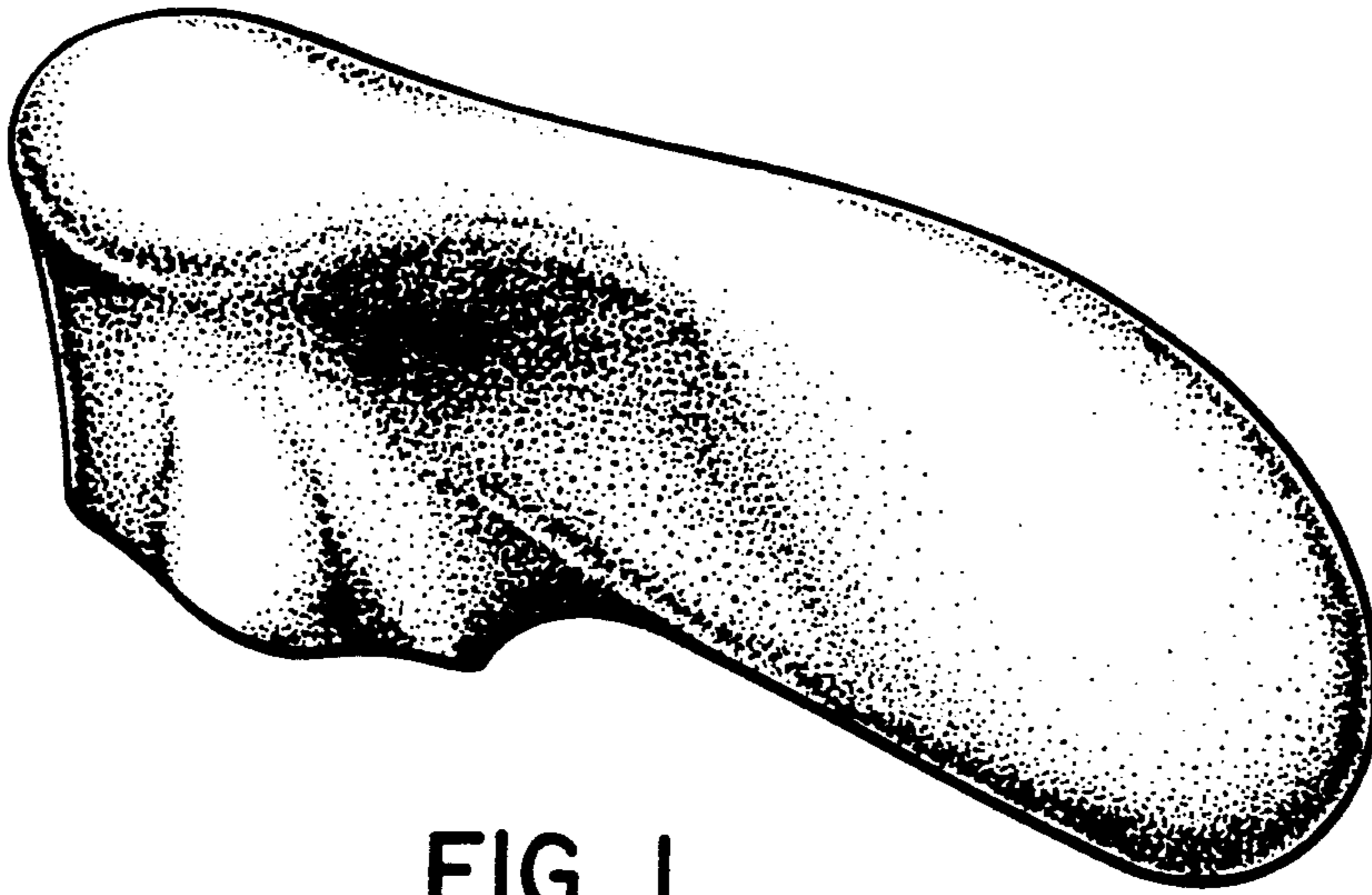

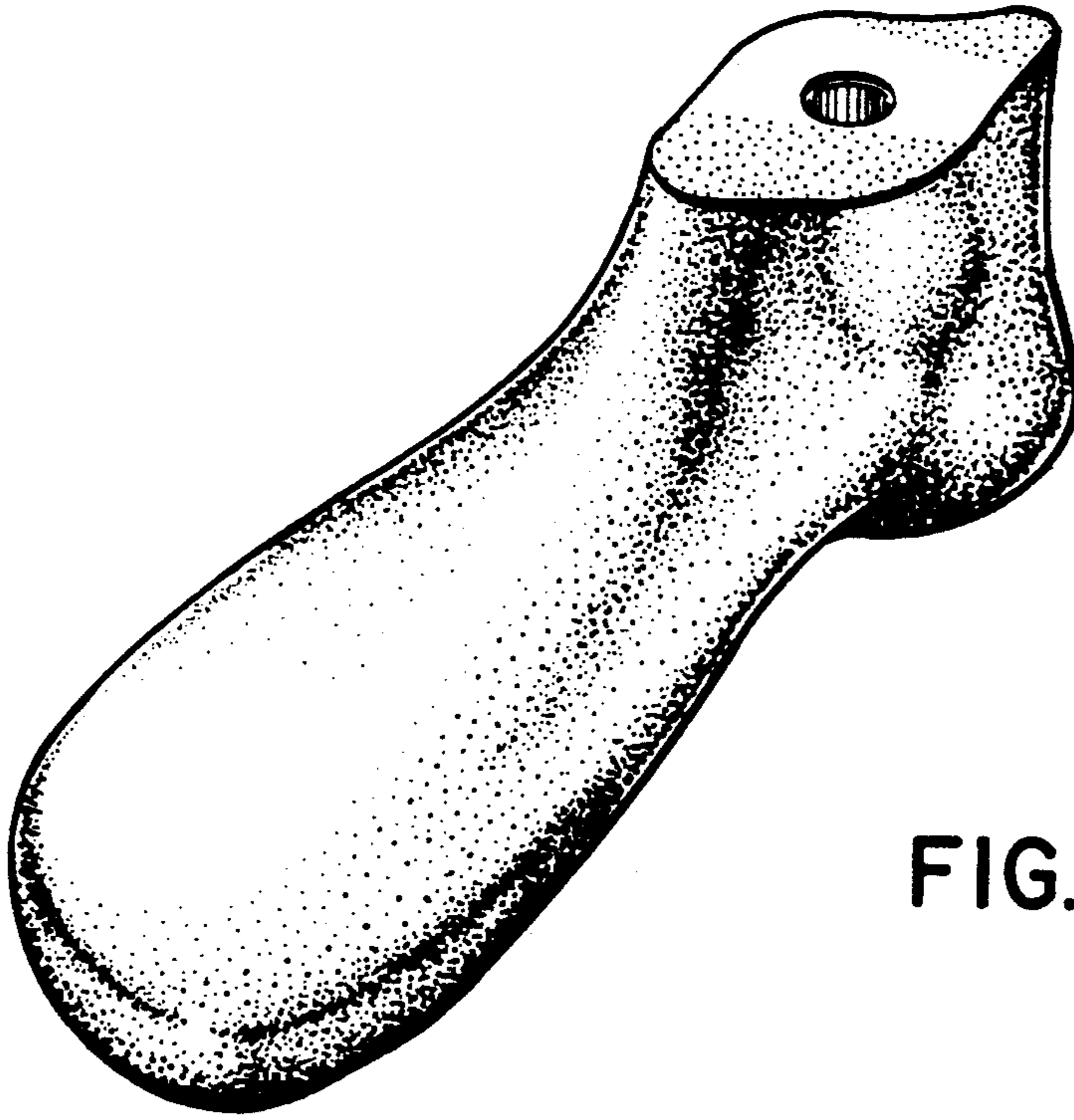

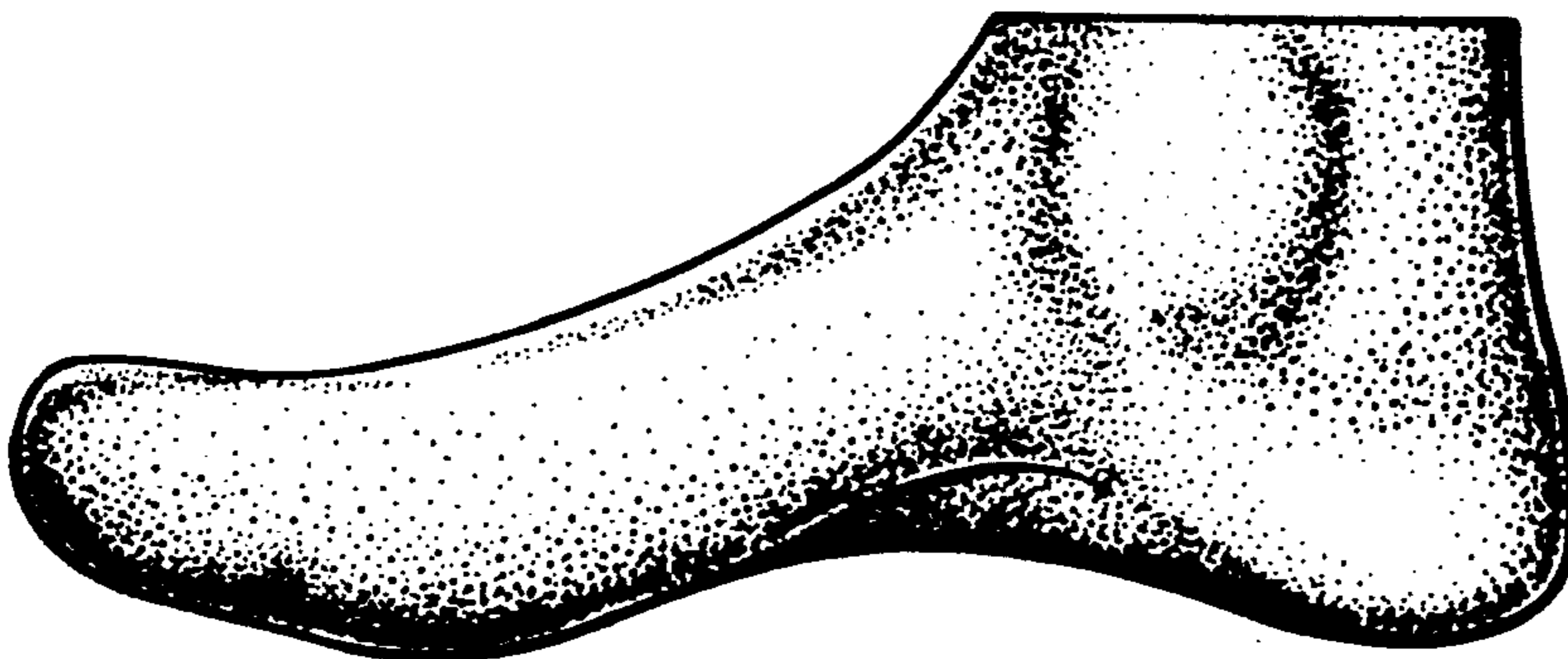

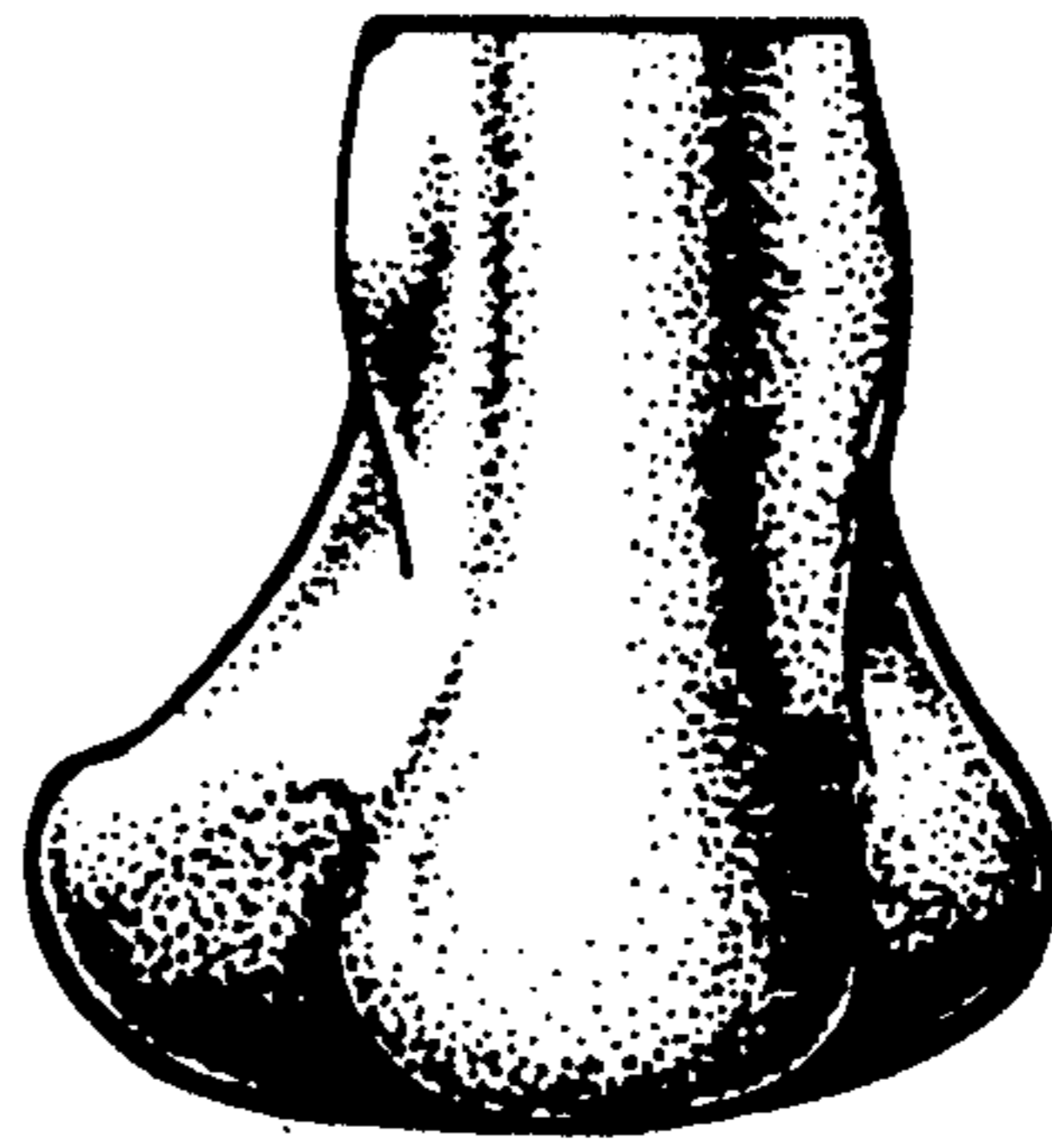

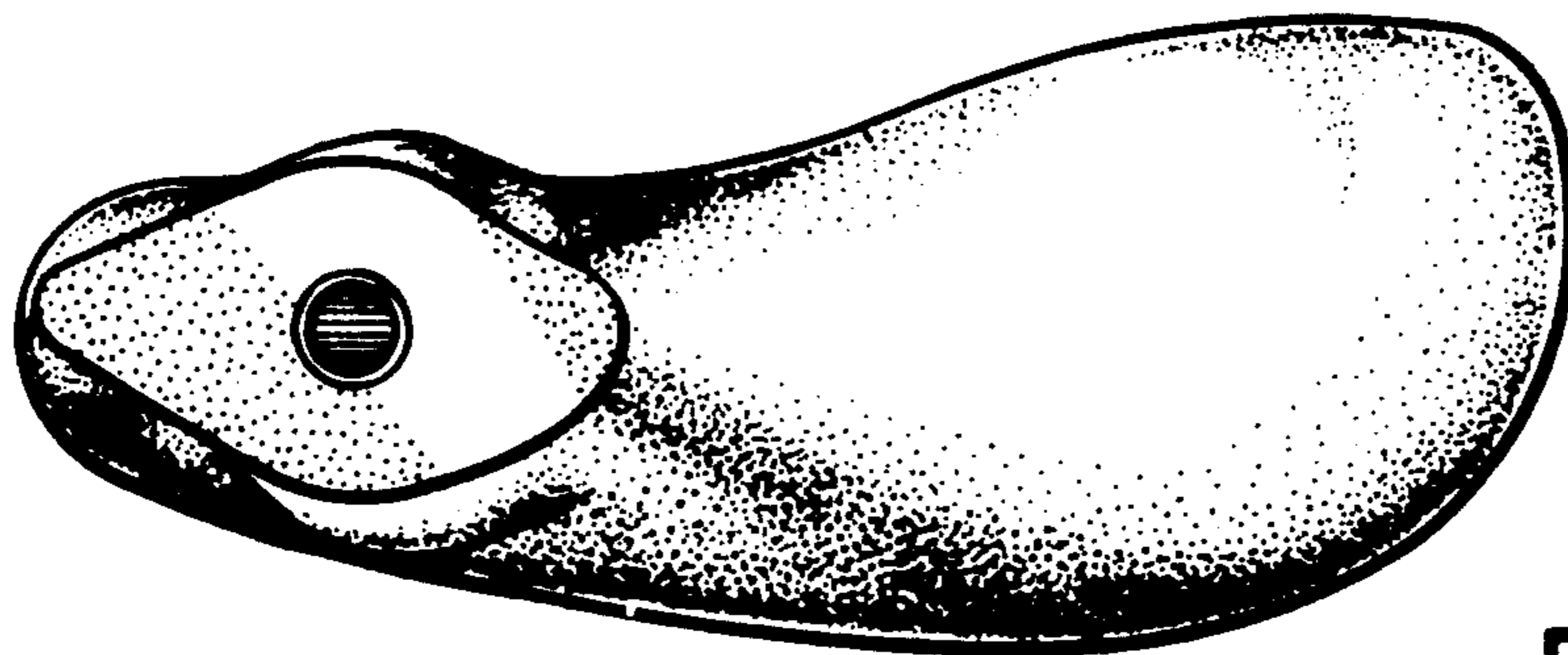

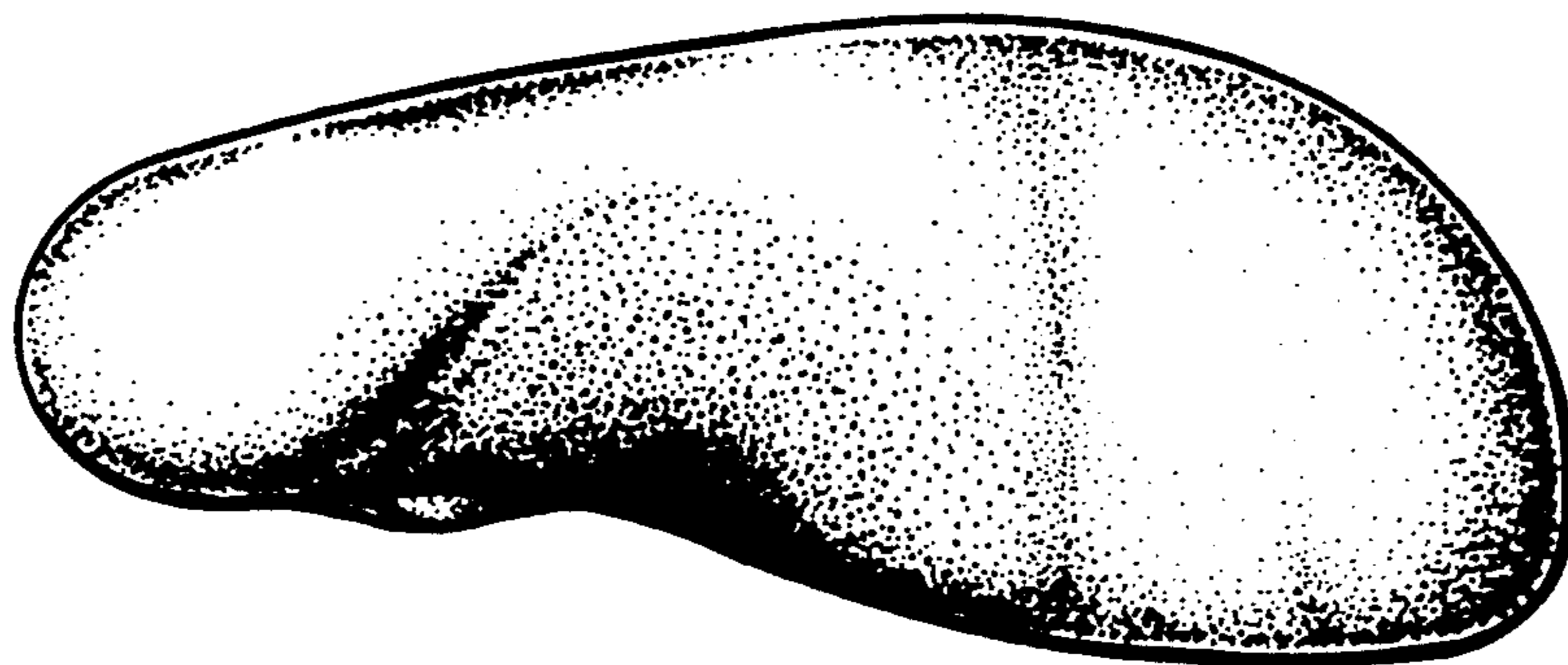
