CLAIM

[57] The ornamental design for a handle for a hex key wrench set, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a handle for a hex wrench set showing my new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

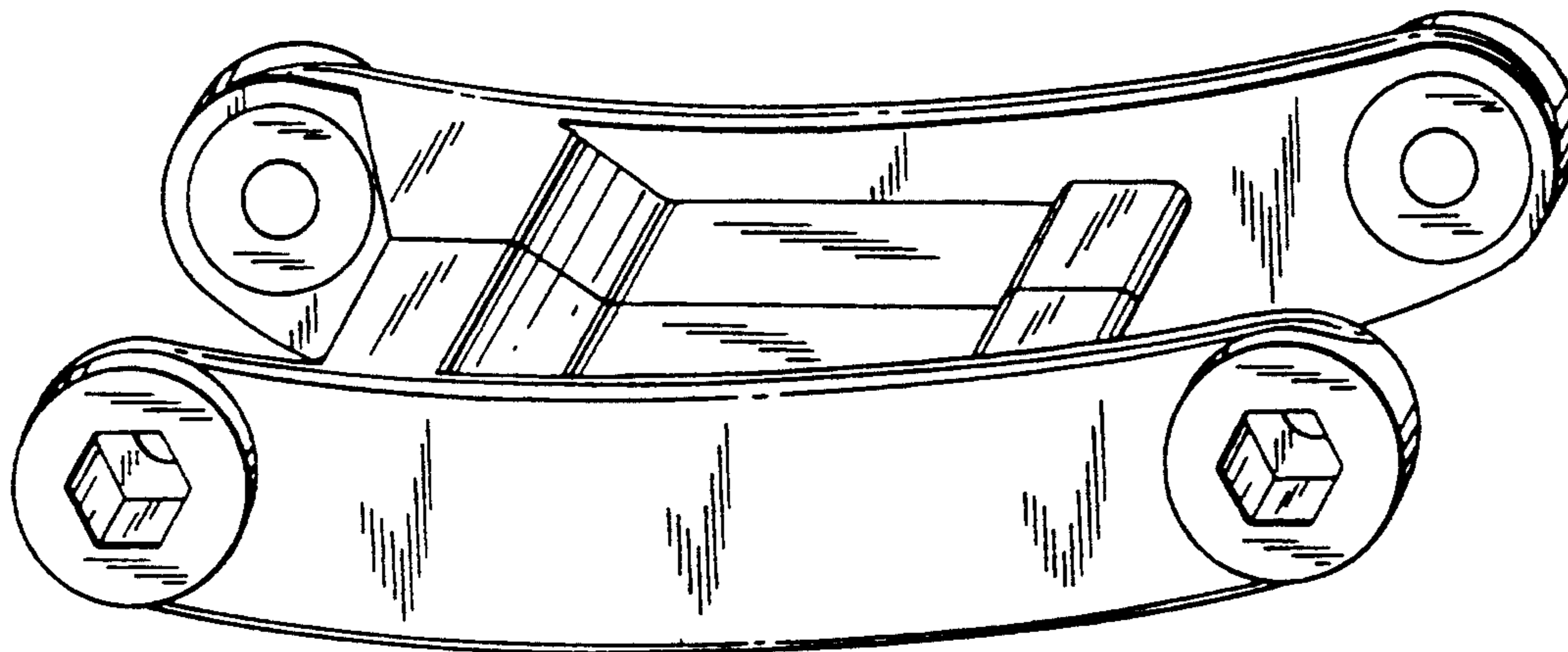

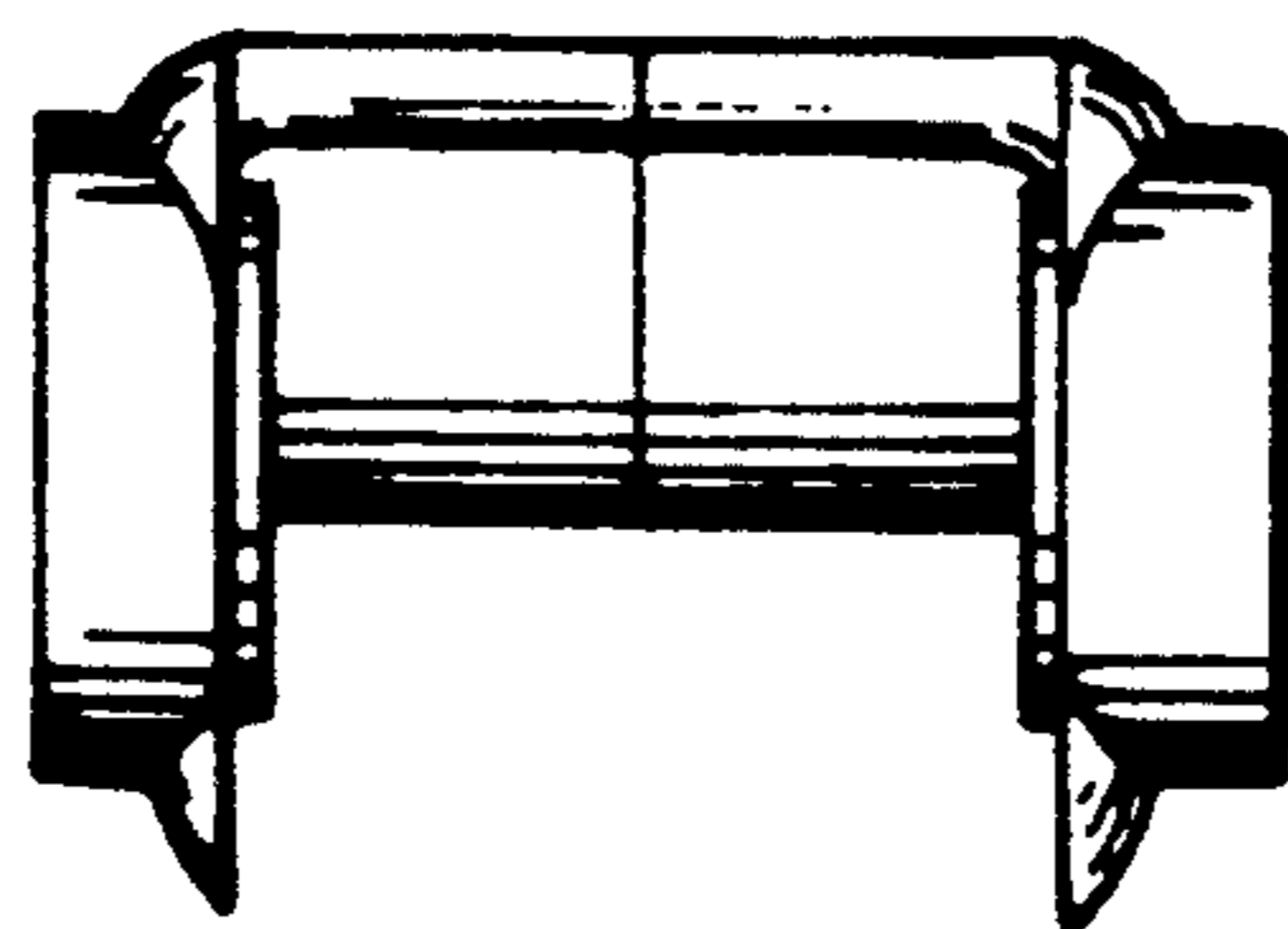
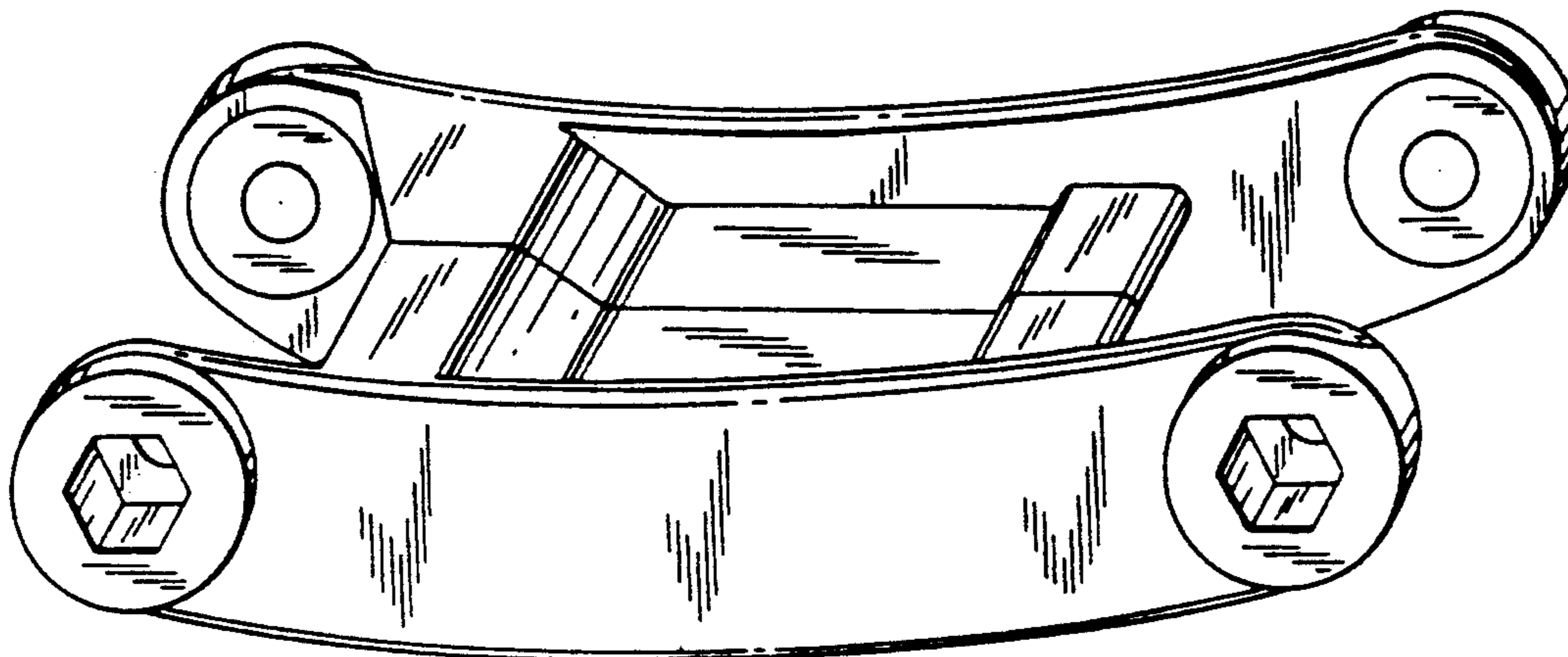

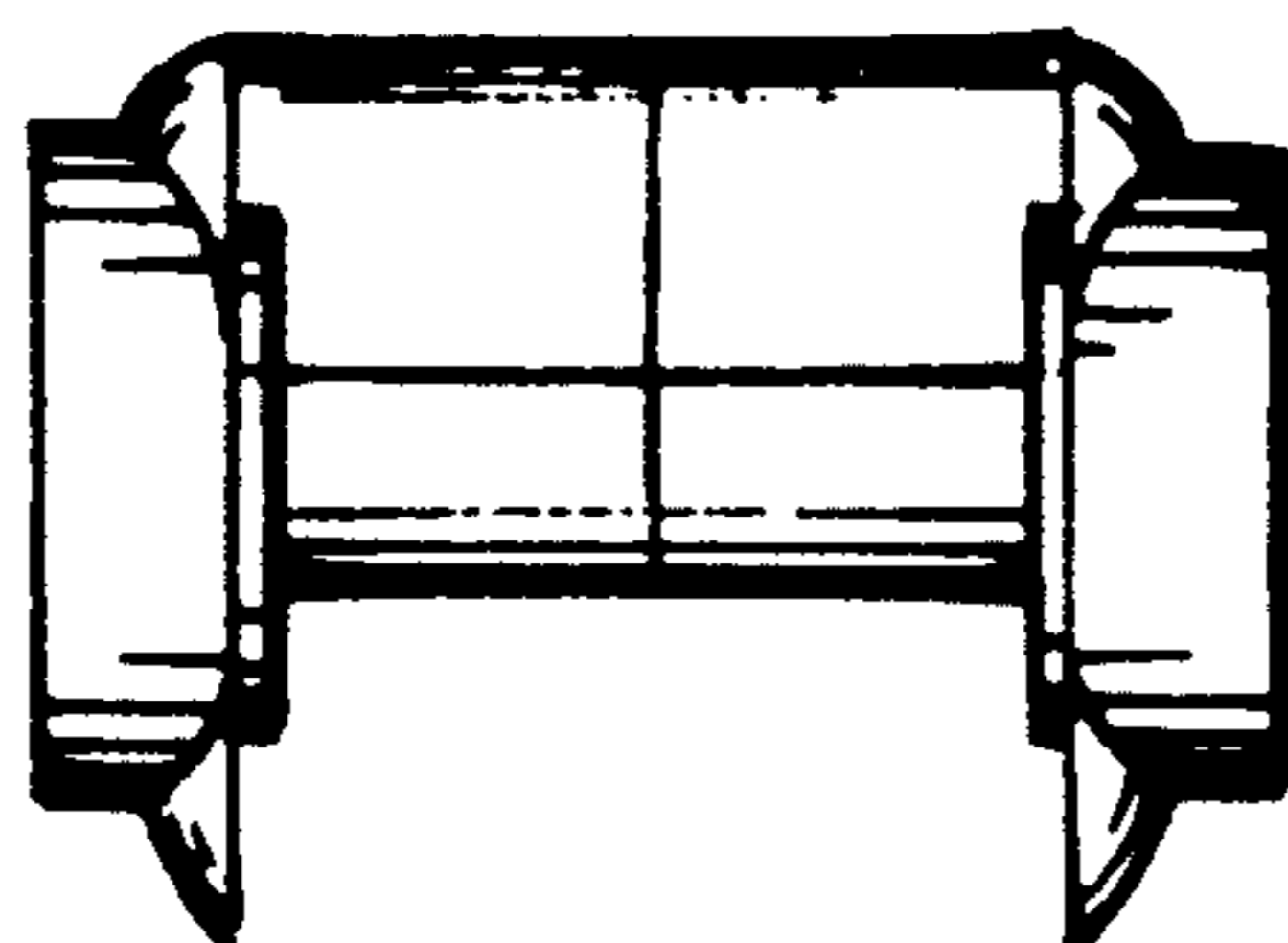

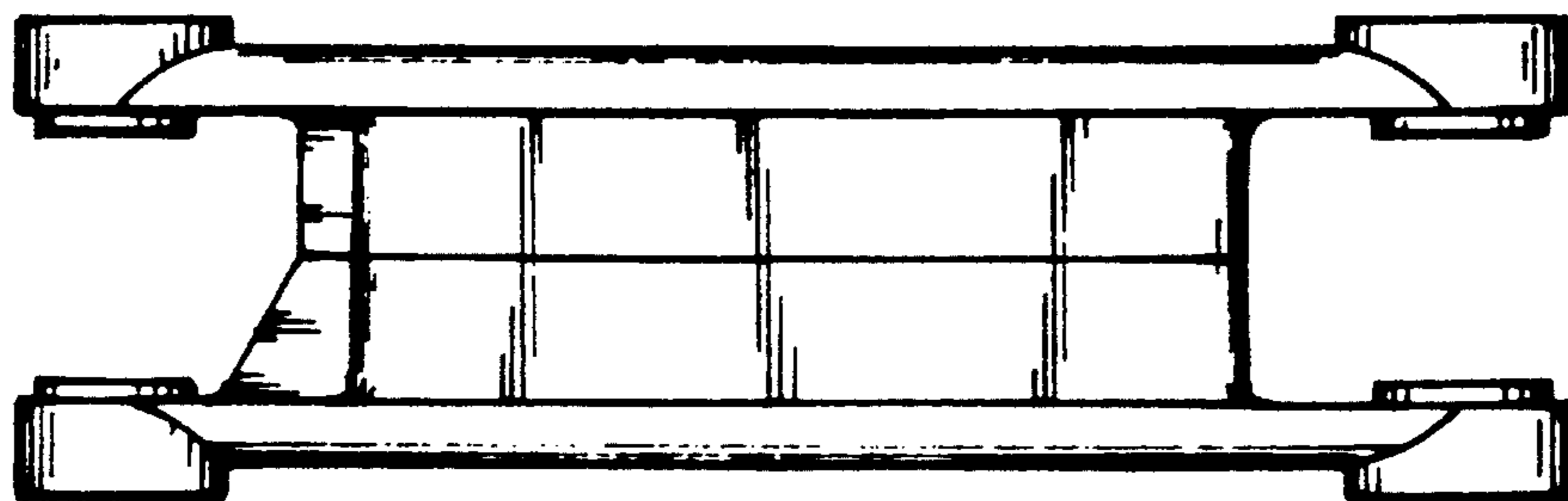

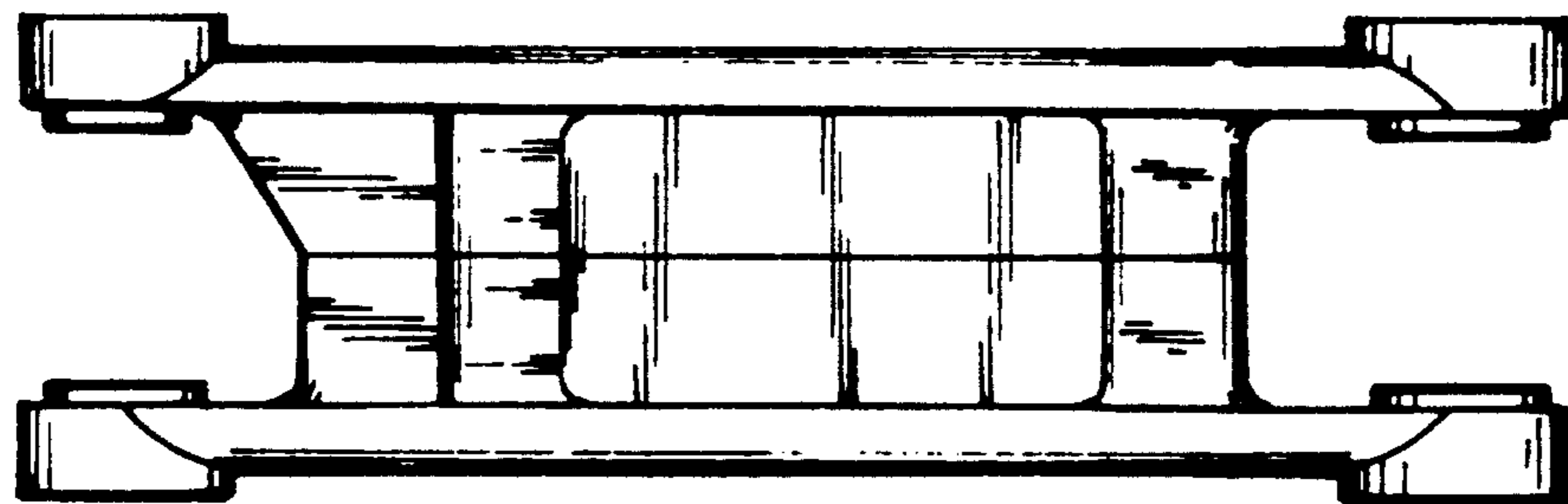

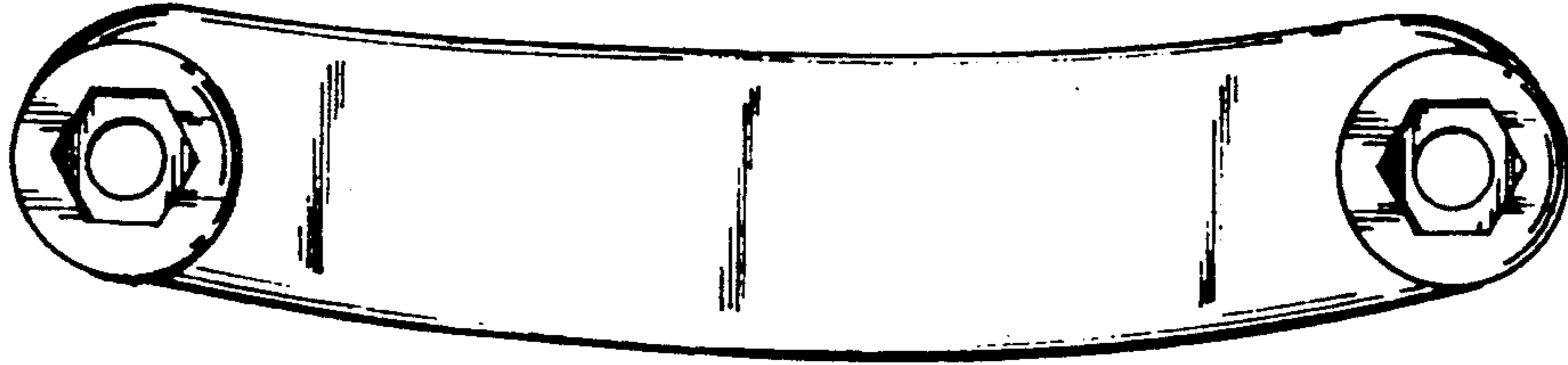

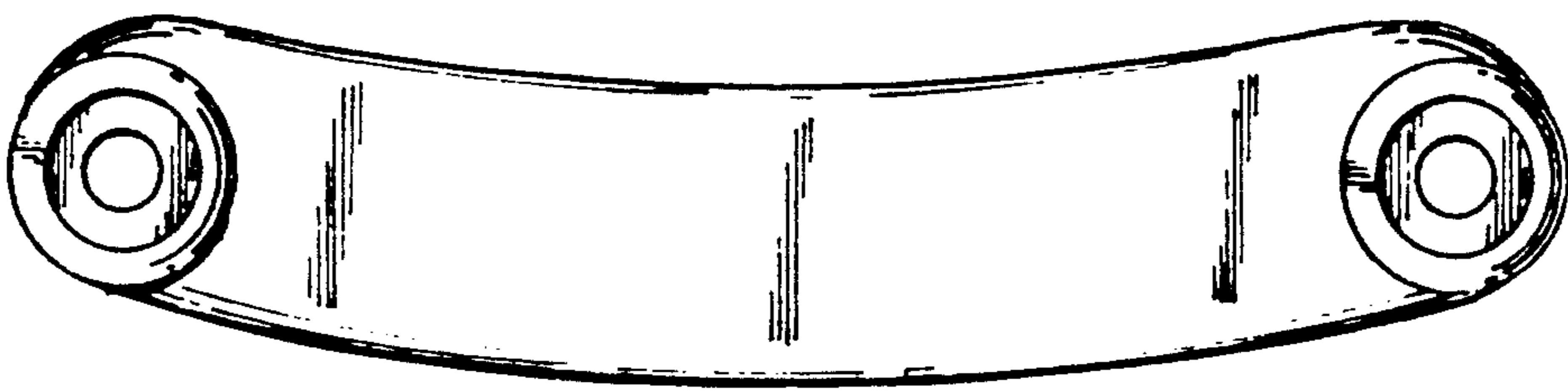
