The ornamental design for a gasket for corrugated pipes, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a gasket for corrugated pipes showing my new design;
 FIG. 2 is a side elevational view thereof, the opposite side being the same as the side shown;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof; and,
 FIG. 6 is a cross sectional view taken on line VI—VI of FIG. 3.

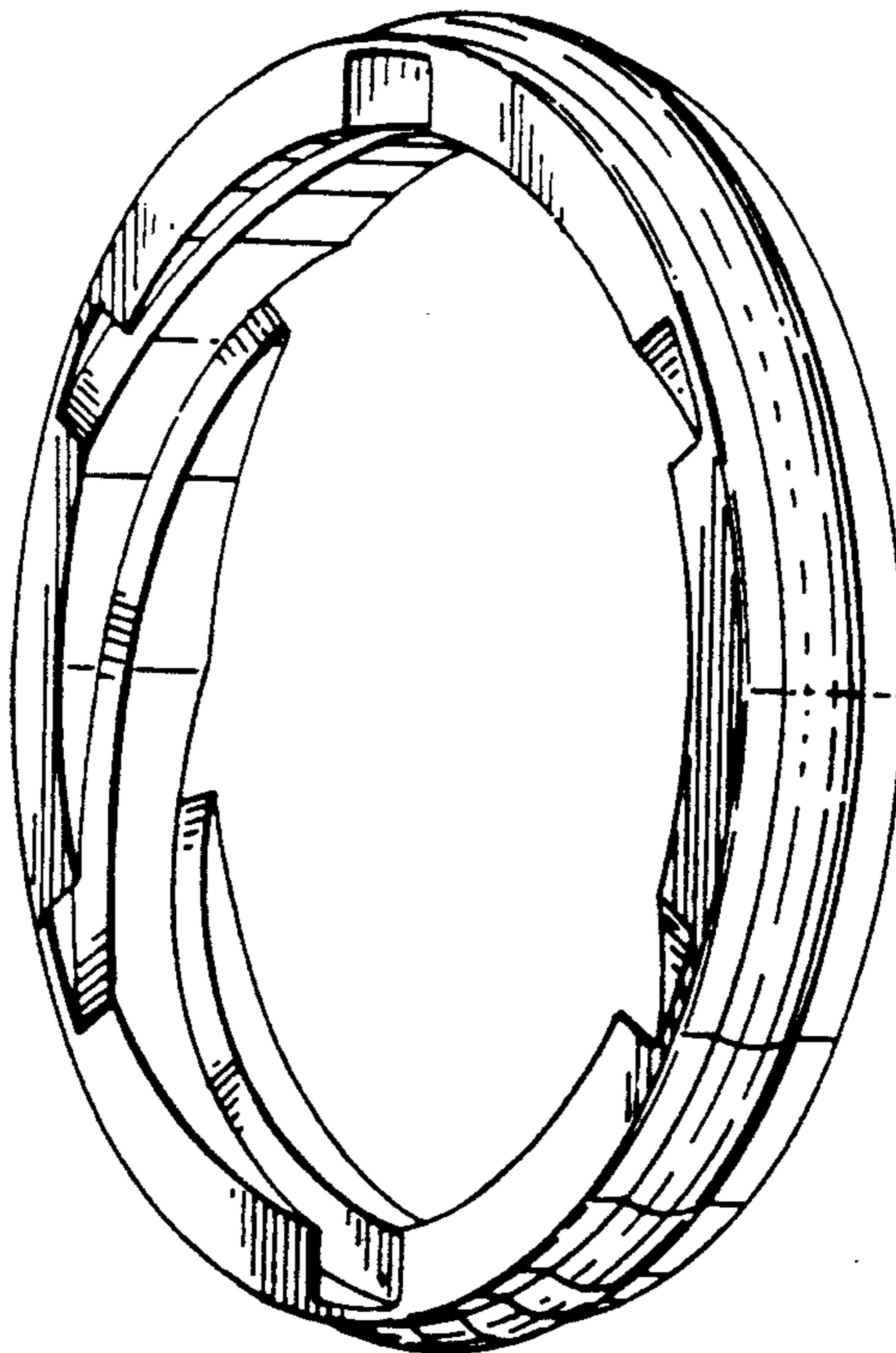

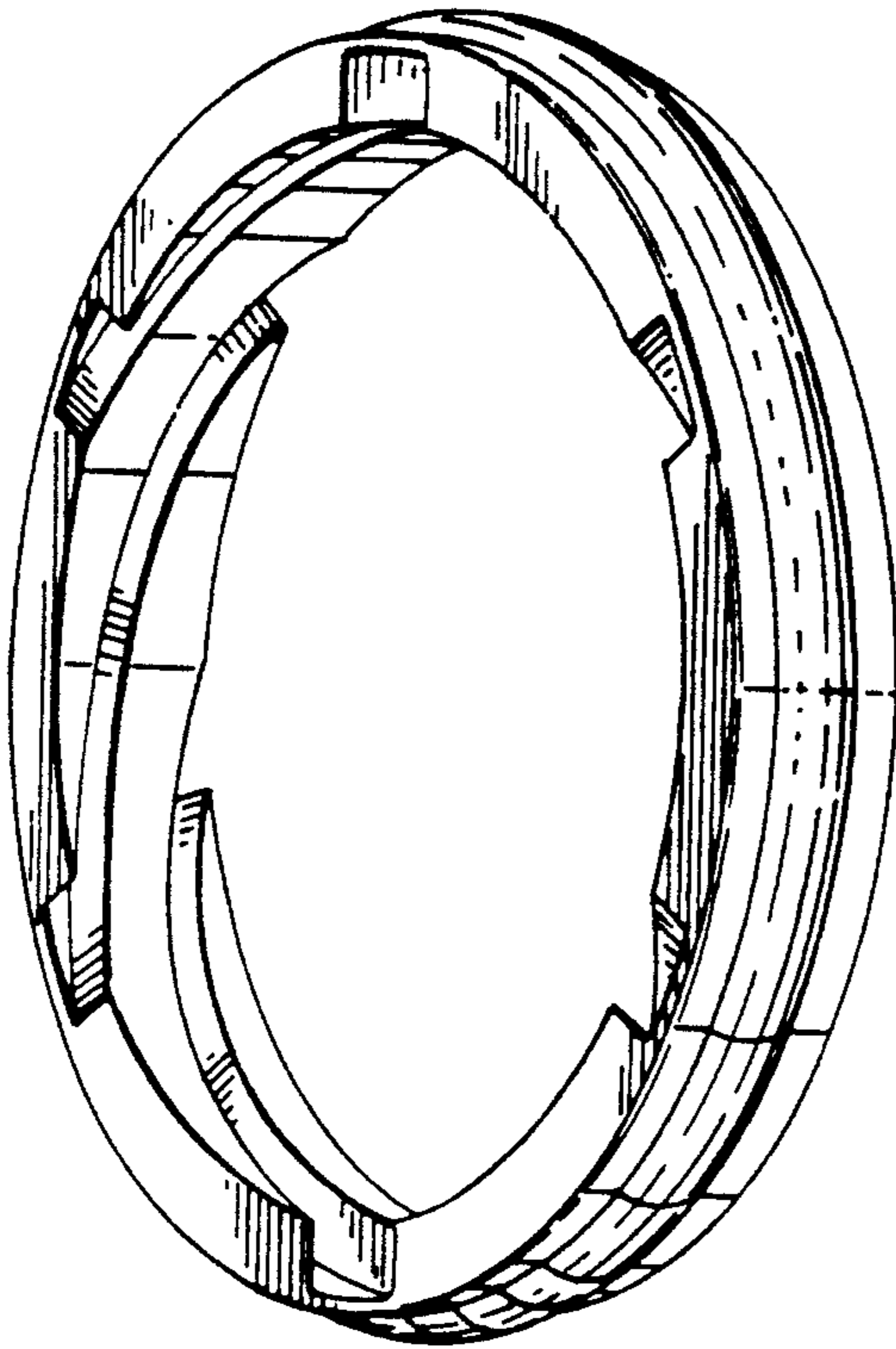

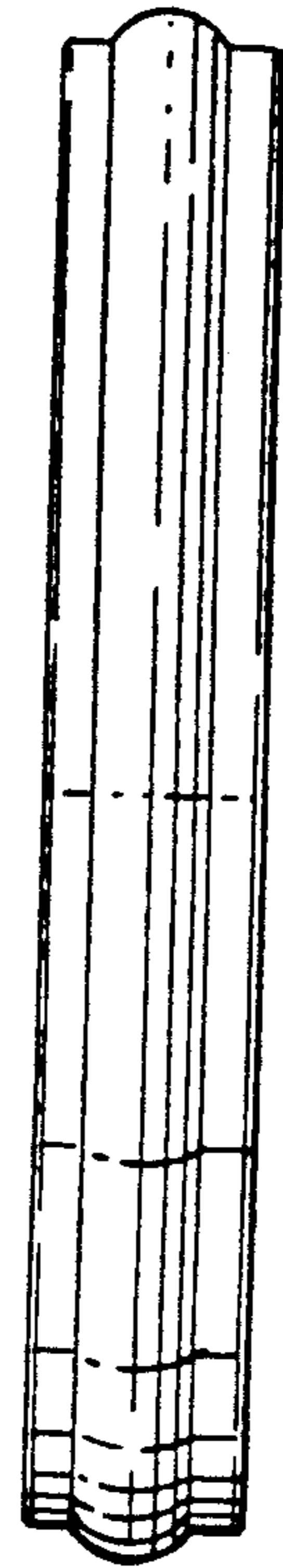

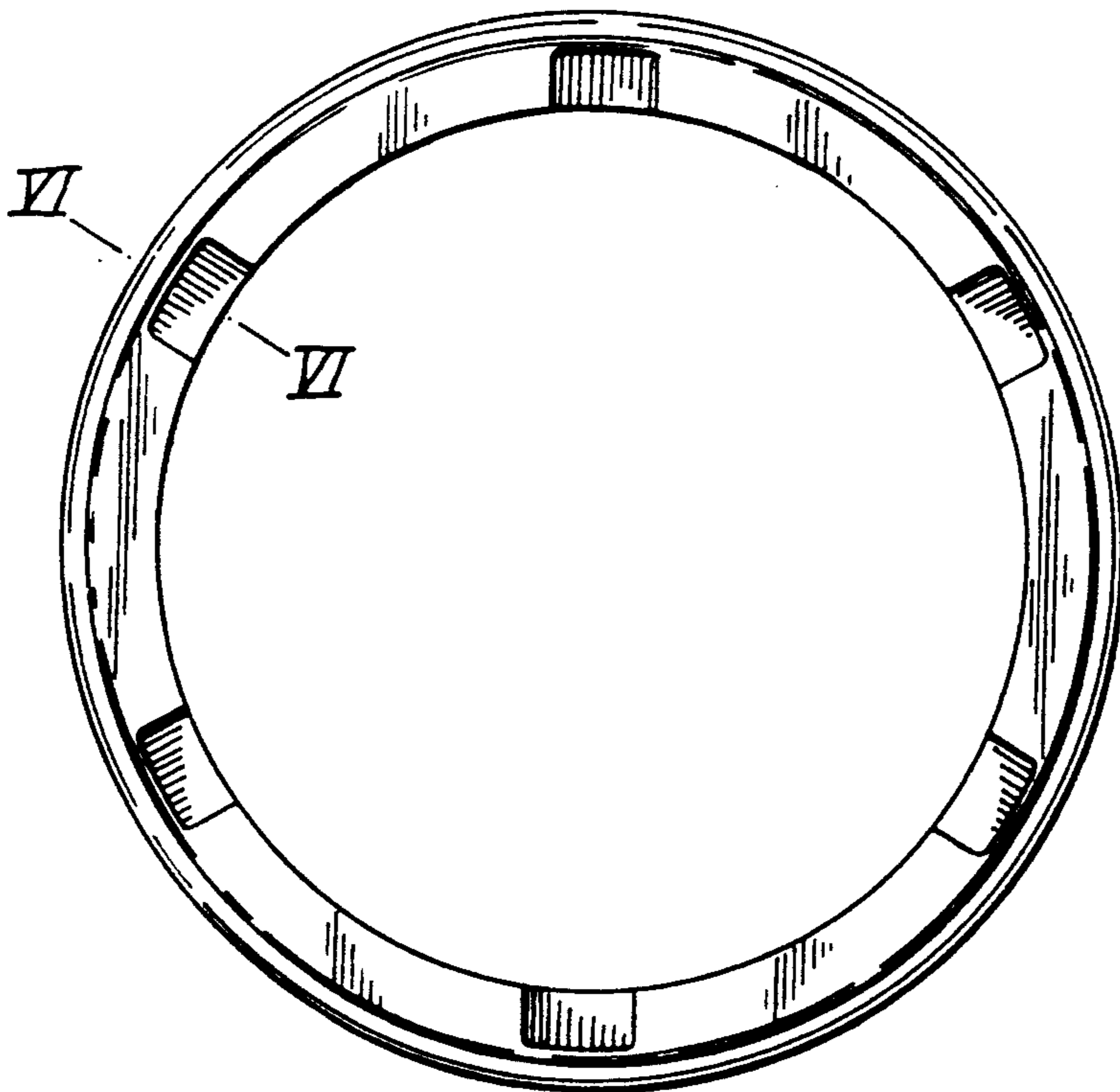

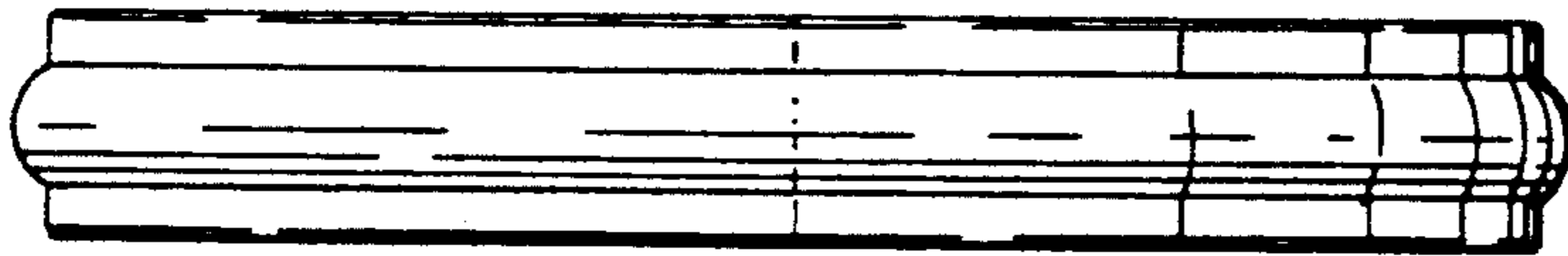

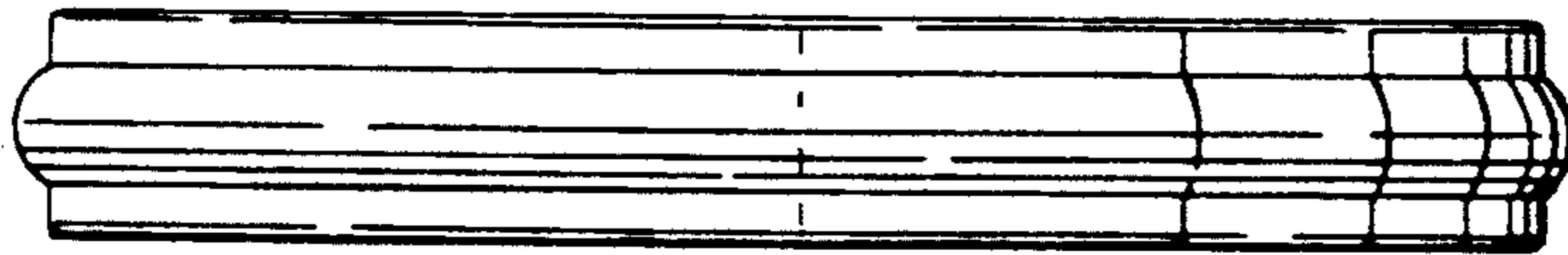
