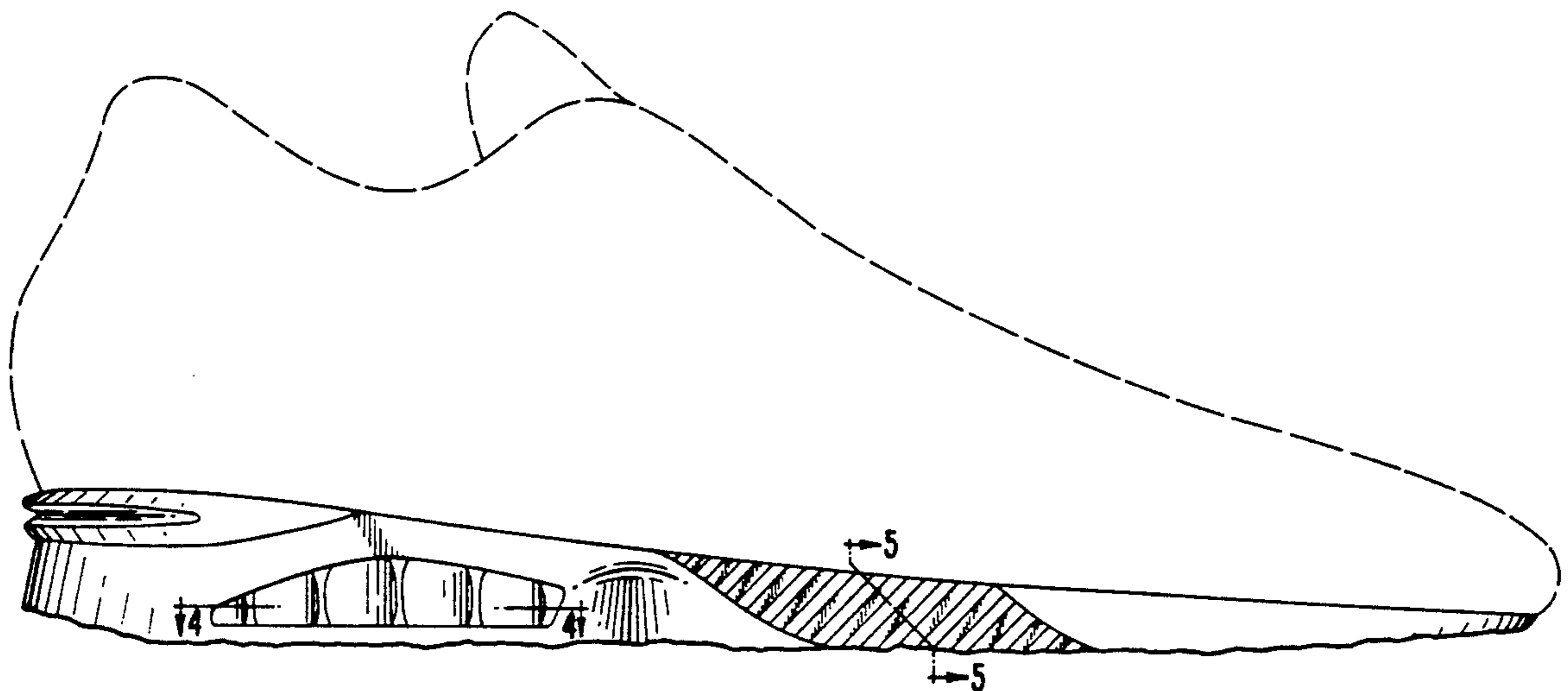

[57] CLAIM

The ornamental design for a midsole of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a midsole of a shoe showing my new design;
 FIG. 2 is a side elevational view of the other side of the midsole of a shoe;
 FIG. 3 is a rear elevational view of the midsole of a shoe;
 FIG. 4 is a cross sectional view taken through line 4—4 of FIG. 1;
 FIG. 5 is a cross sectional view taken along line 5—5 of FIG. 1;
 FIG. 6 is a front elevational view of a midsole of a shoe; and,
 FIG. 7 is a cross sectional view taken along line 7—7 of FIG. 2.
 The broken line showing the sole and upper portion of the shoe in FIGS. 1,2,3 and 6 are for illustrative purposes and form no part of the claimed design.



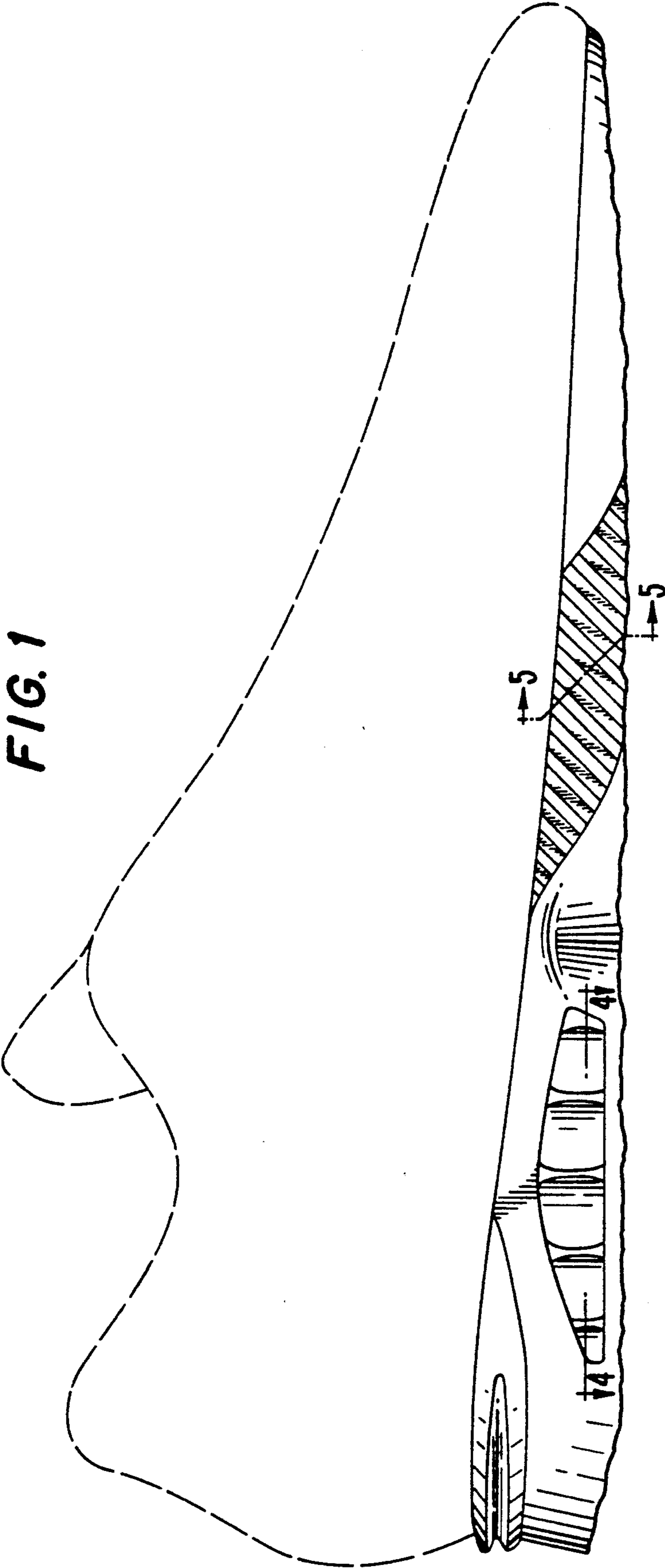

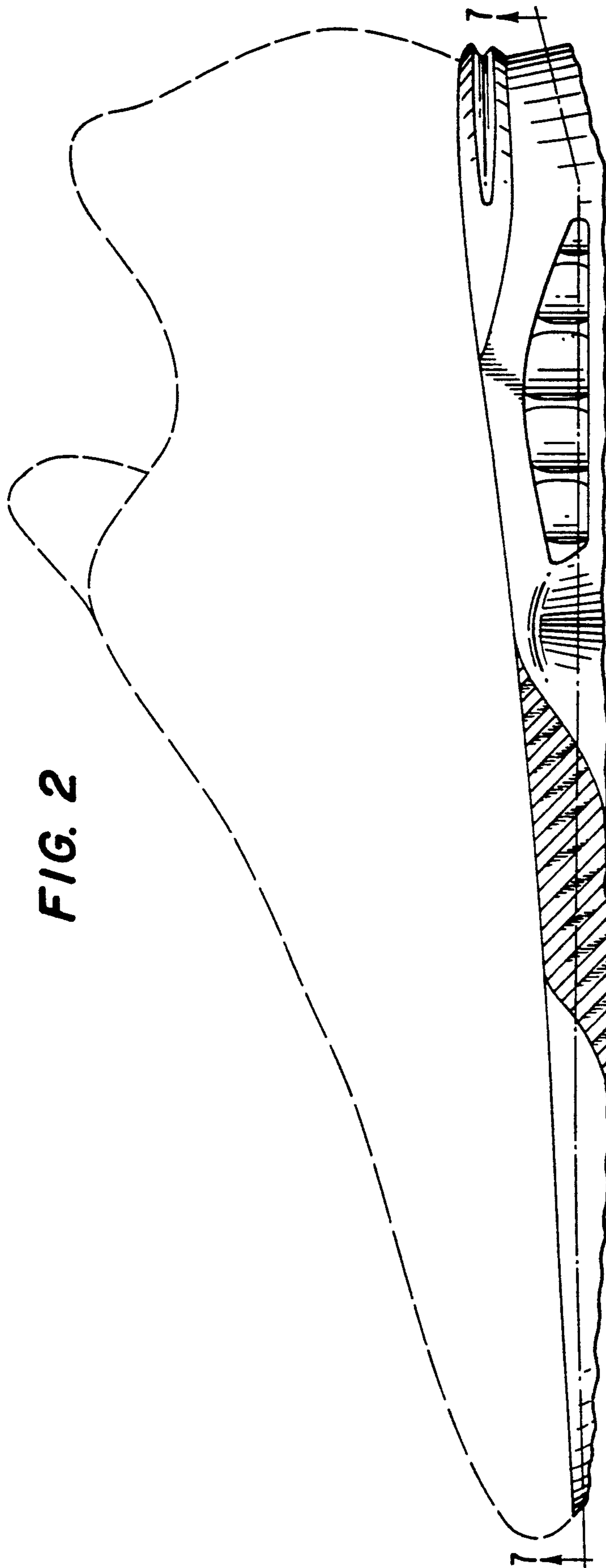

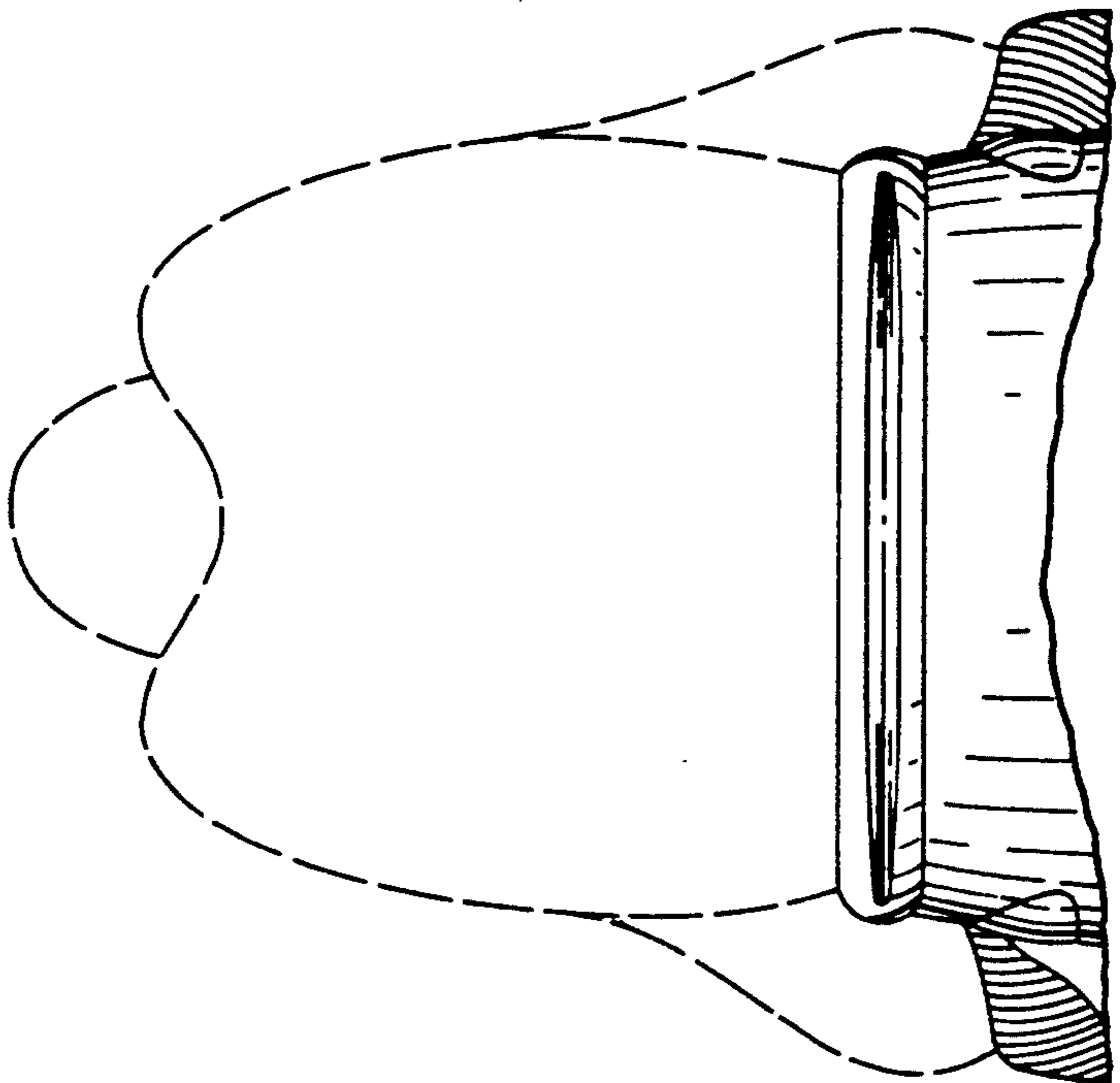

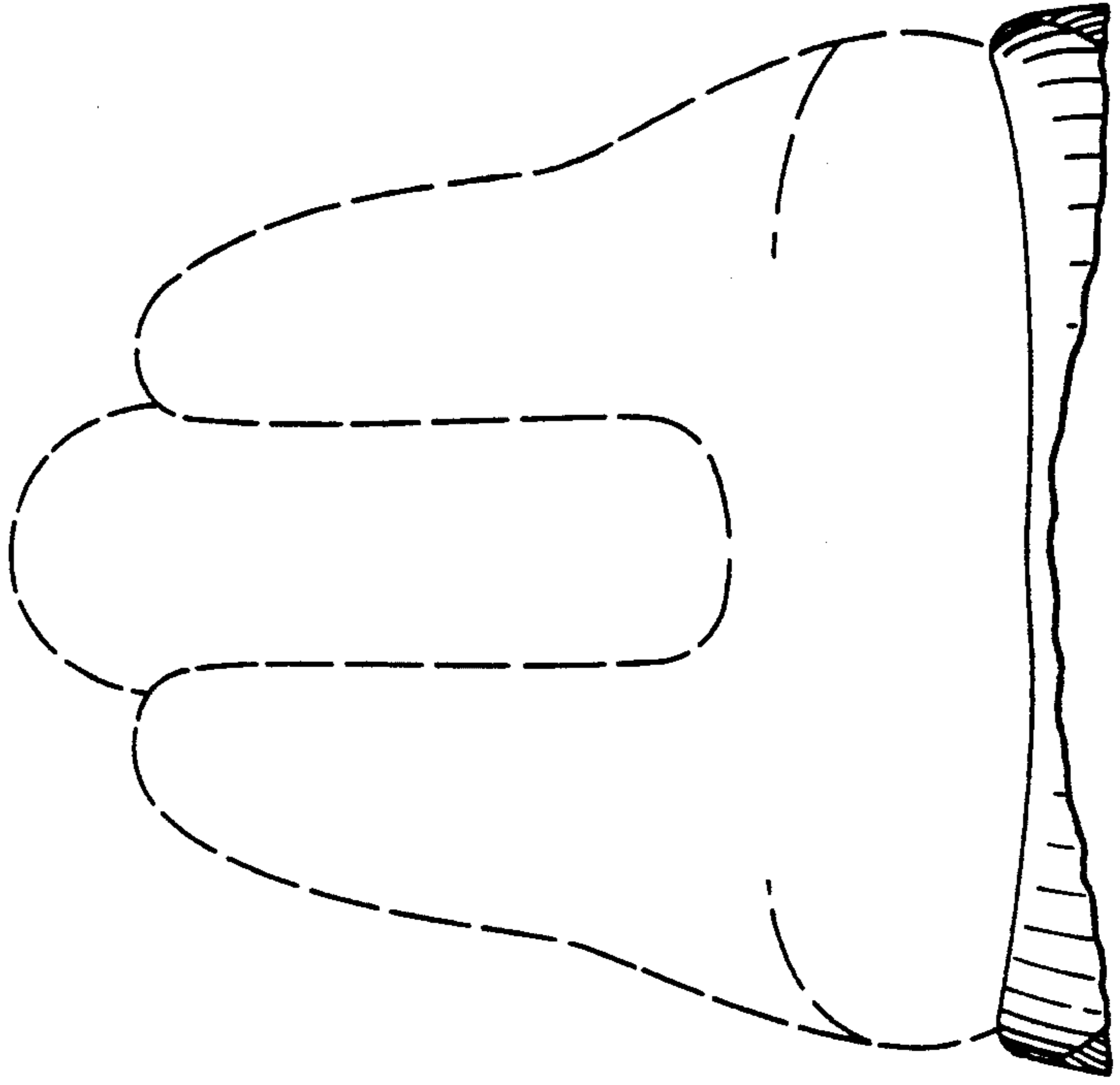
