DESCRIPTION

FIG. 1 is a top right front perspective view of a mixing bowl showing our new design;

FIG. 2 is a cross-sectional view thereof taken through Line 2—2 of FIG. 4;

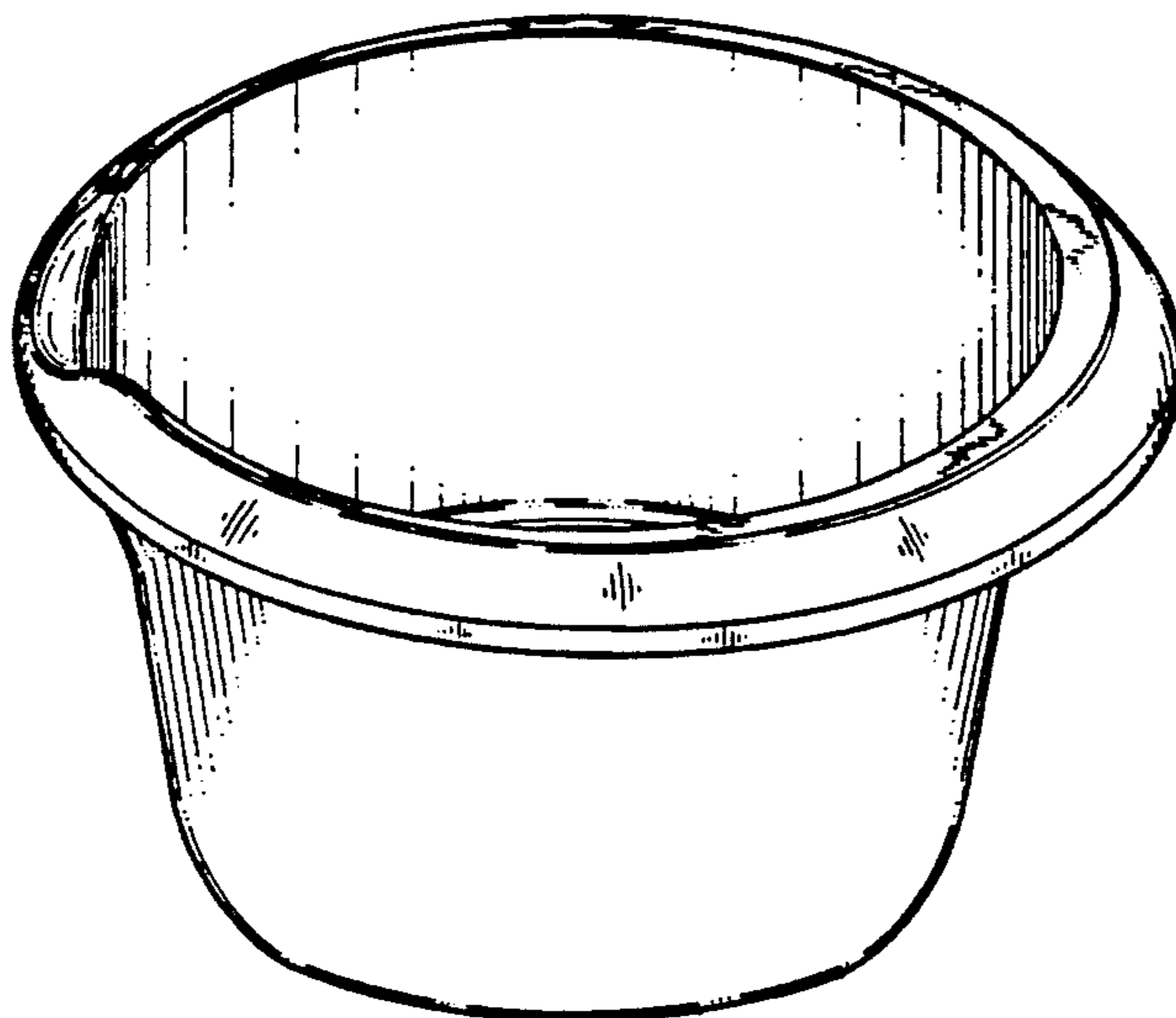
FIG. 3 is a rear elevational view thereof;

FIG. 7 is a side elevational thereof; the opposite side being a mirror image.



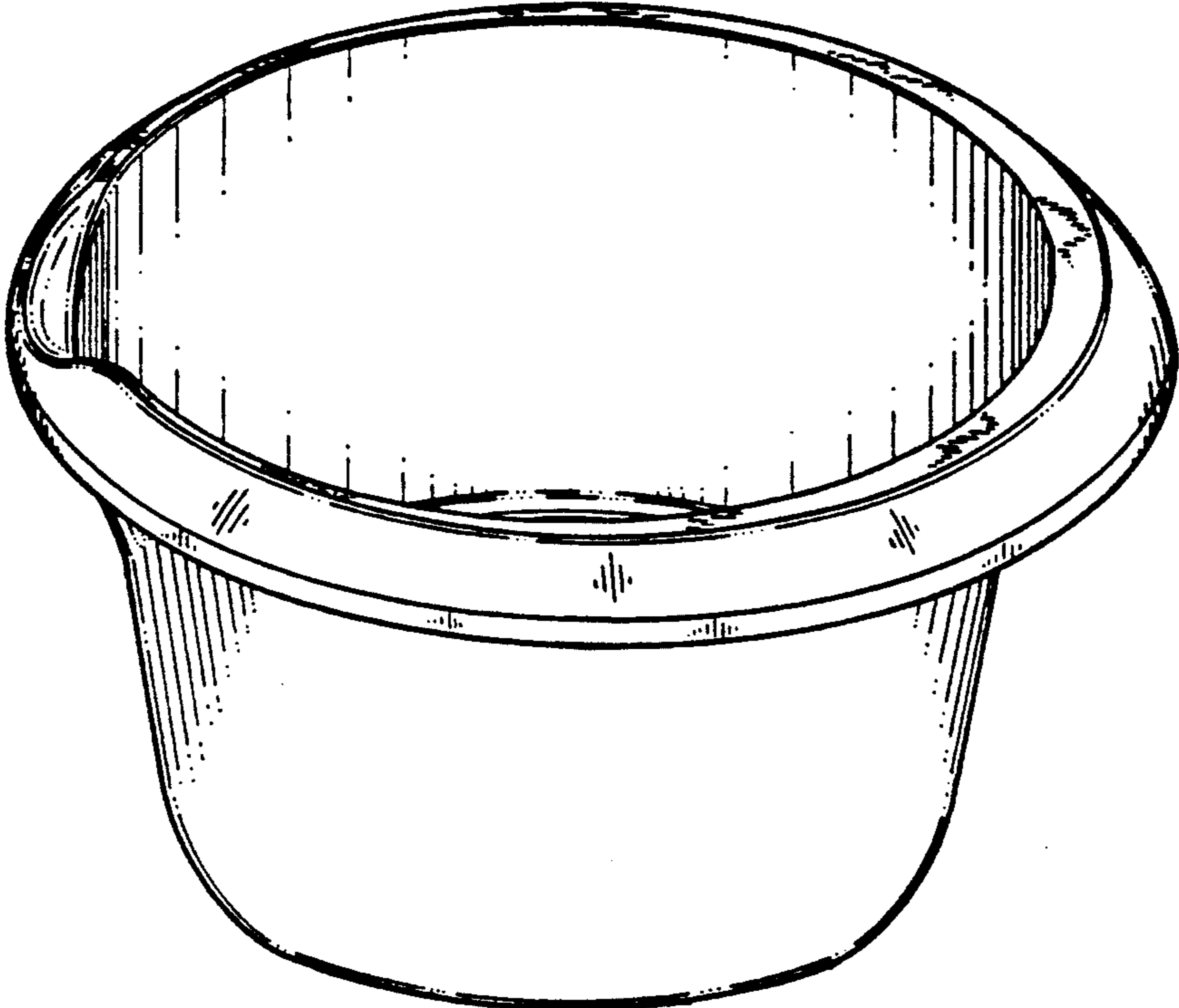

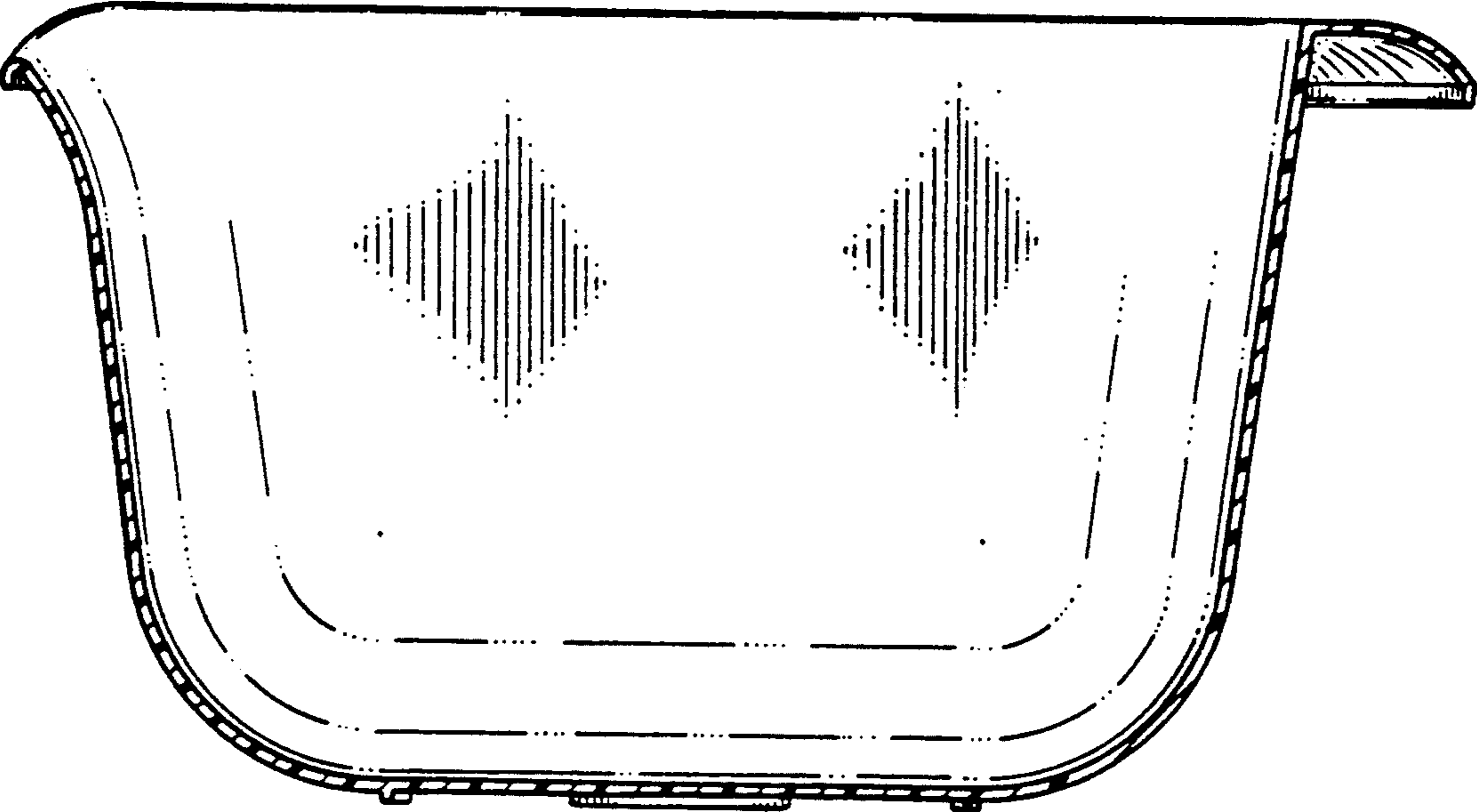

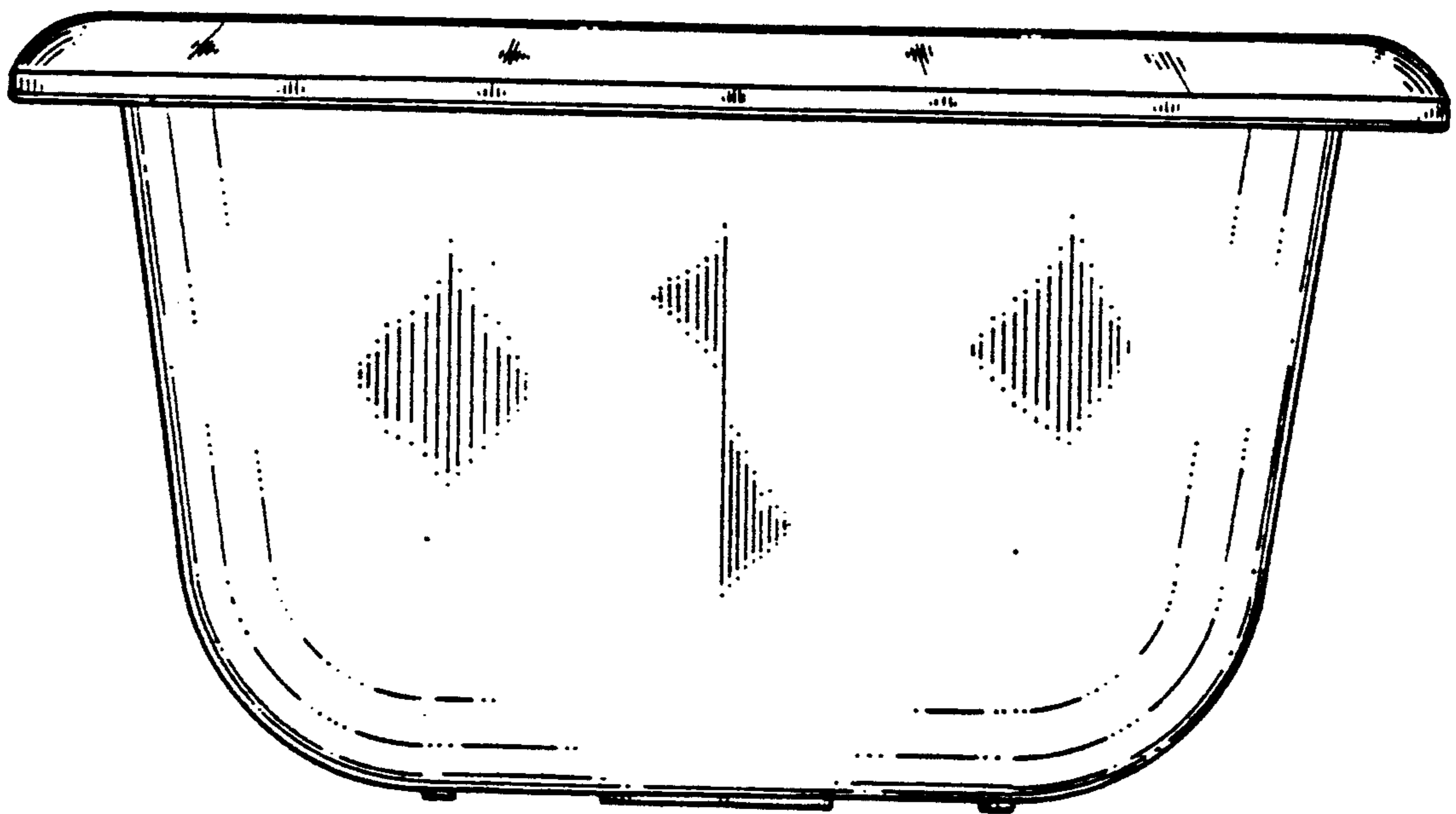

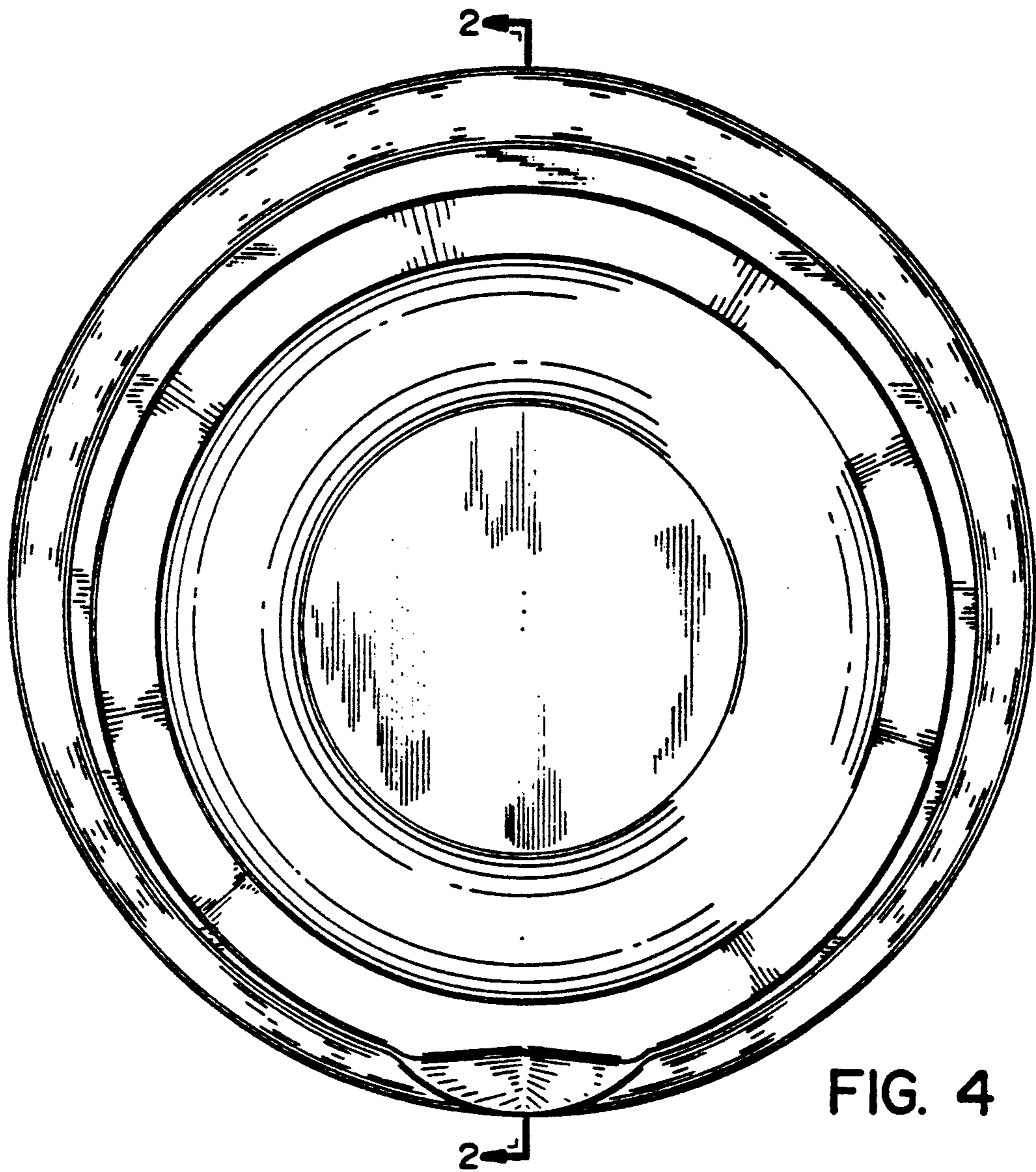

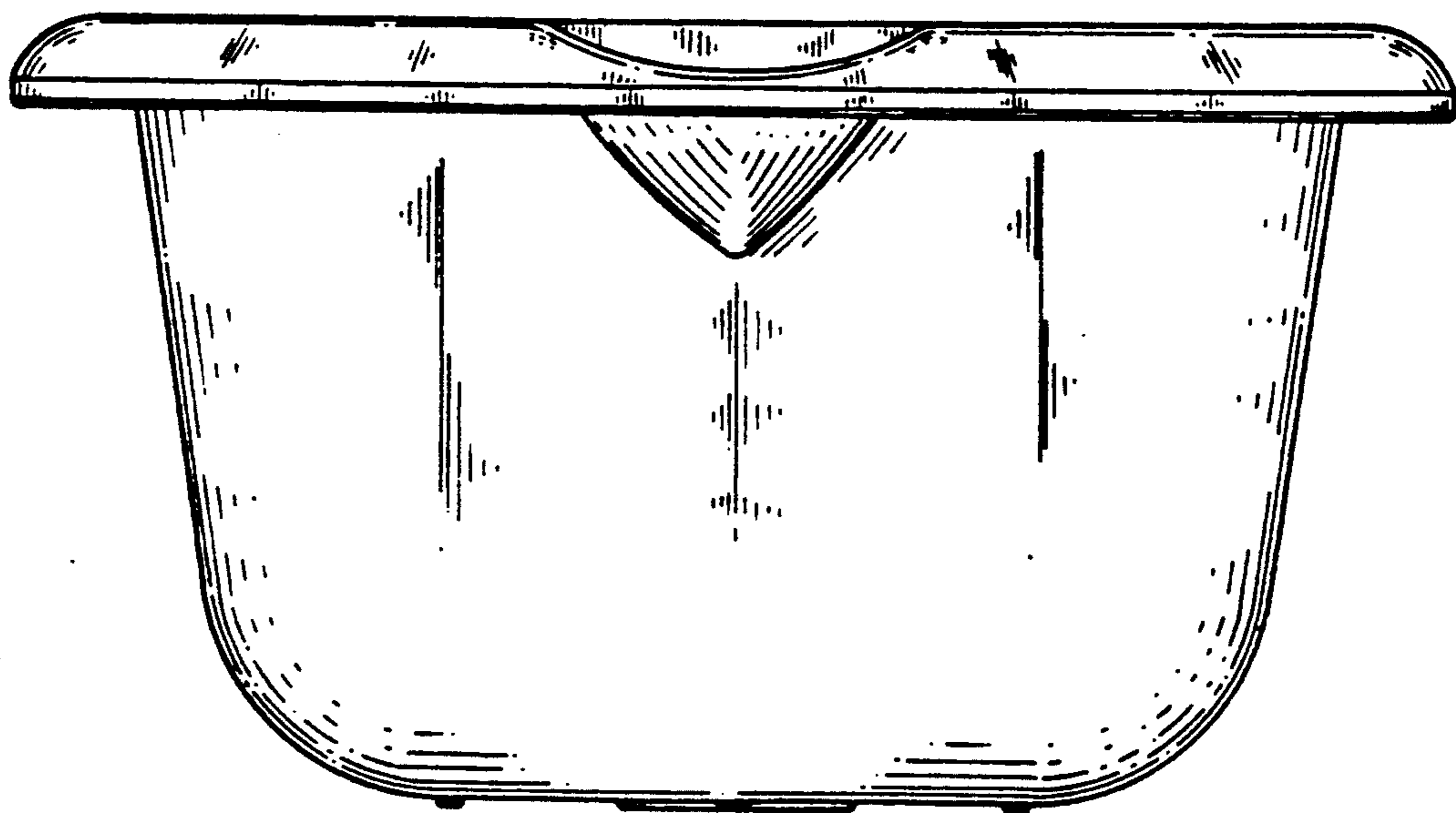

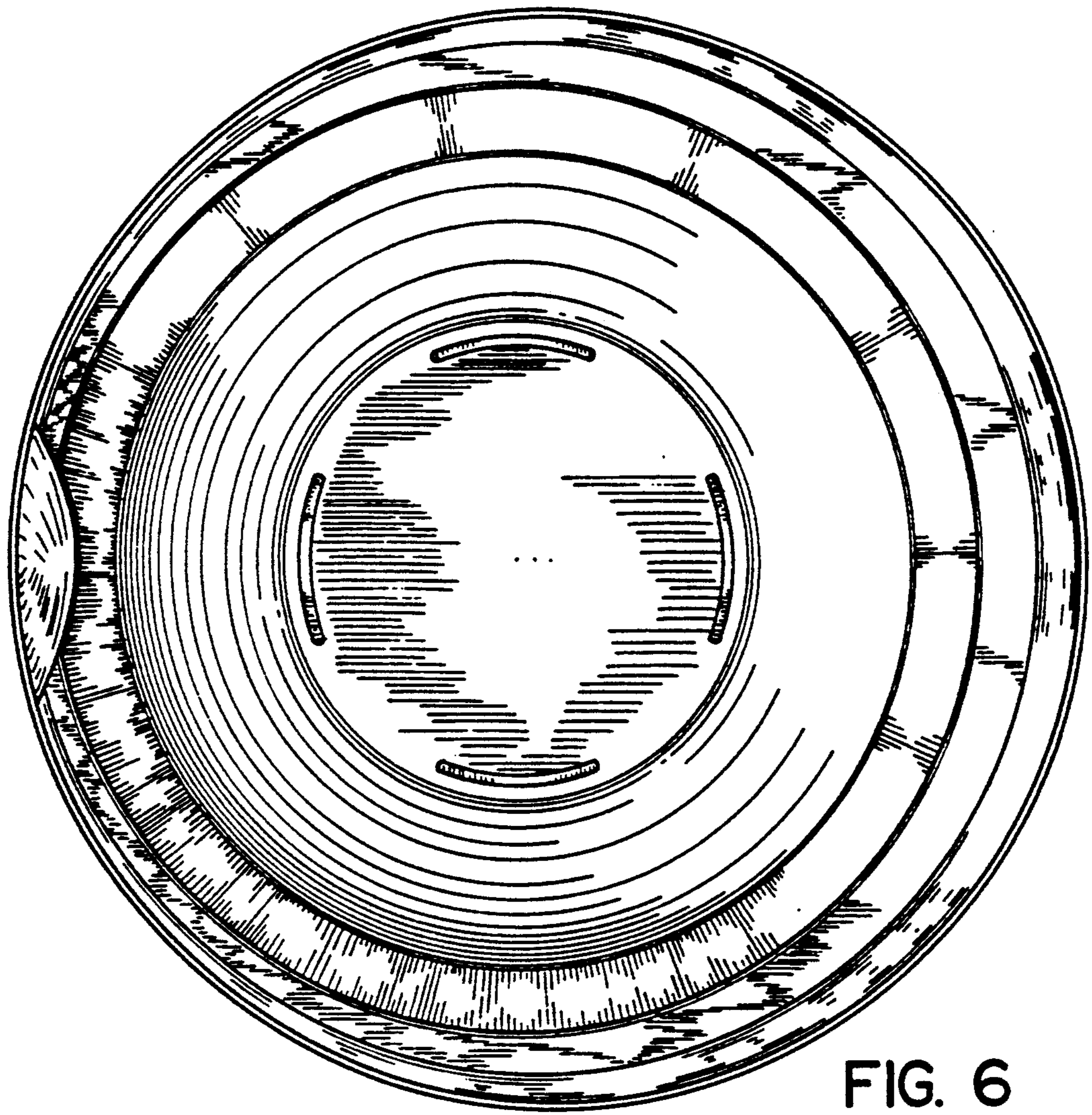

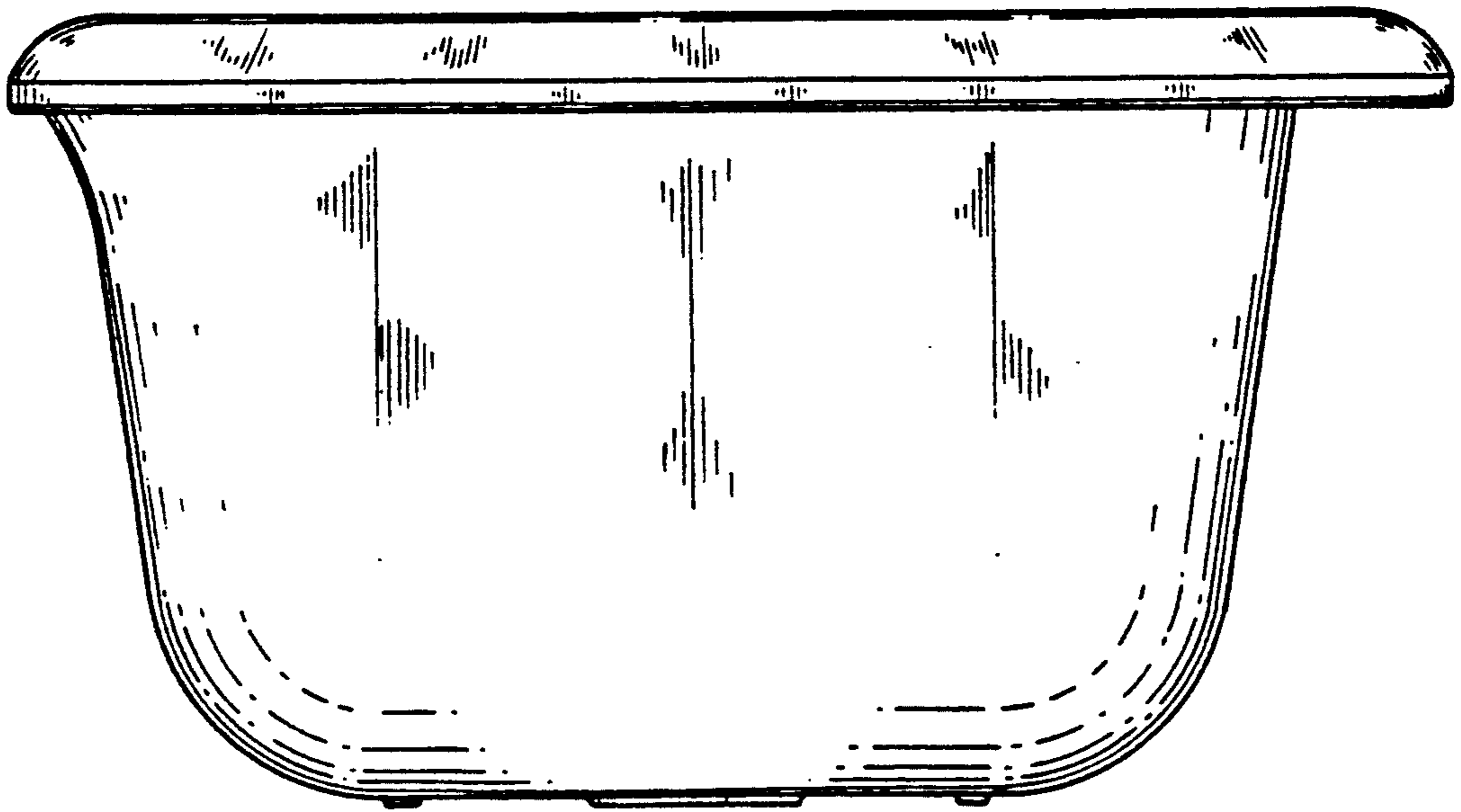
