[57] **CLAIM**

The ornamental design for a printer, as shown and described.

DESCRIPTION

FIG. 1 is a right side, top and front perspective view of a printer showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a sectional view thereof, taken along line 8—8' in FIG. 4 with interior construction omitted; and FIG. 9 is another perspective view thereof showing the paper tray in raised position. The broken lines in FIG. 9 are for purposes of illustration only and form no part of the claimed design.

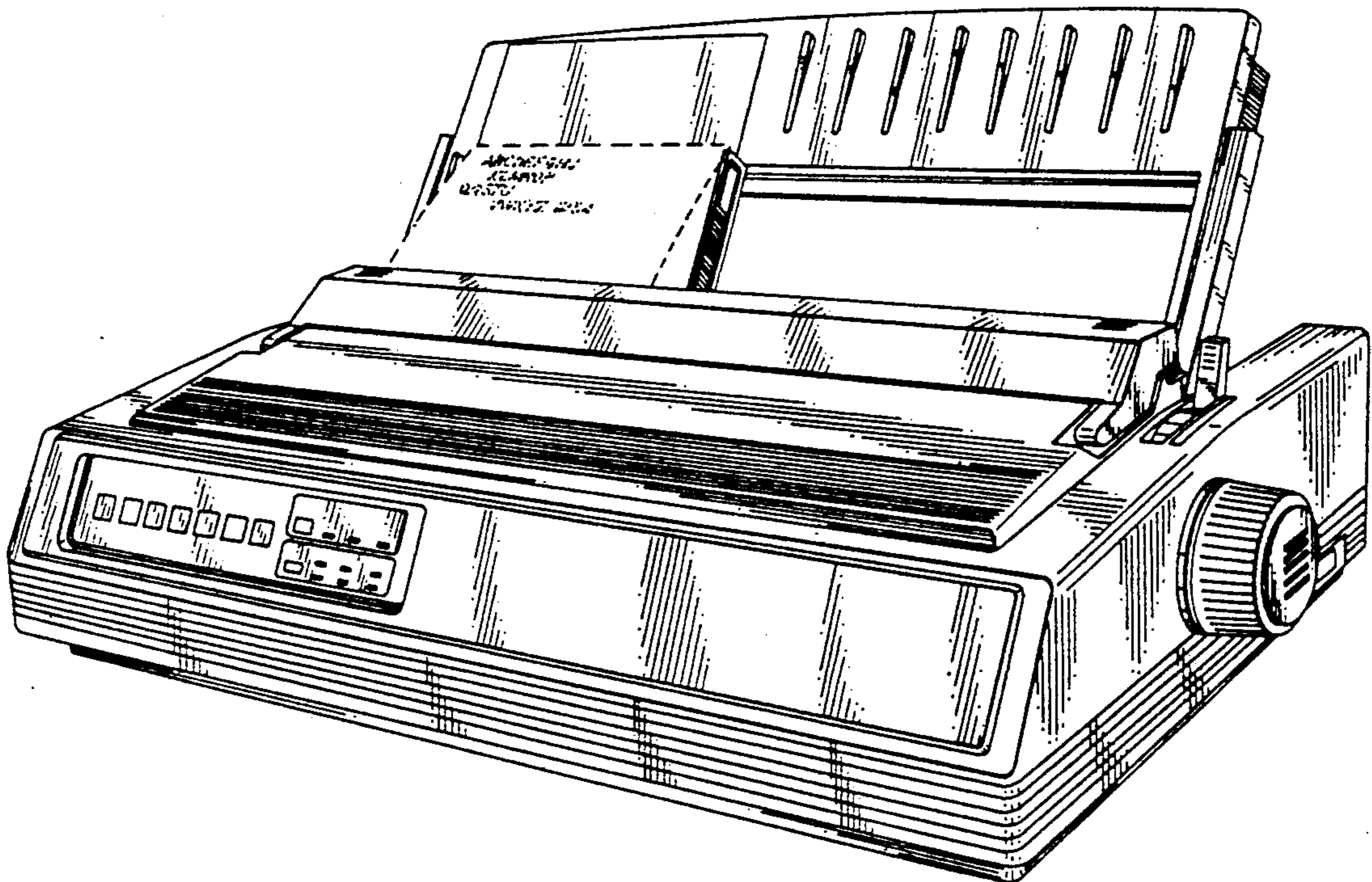

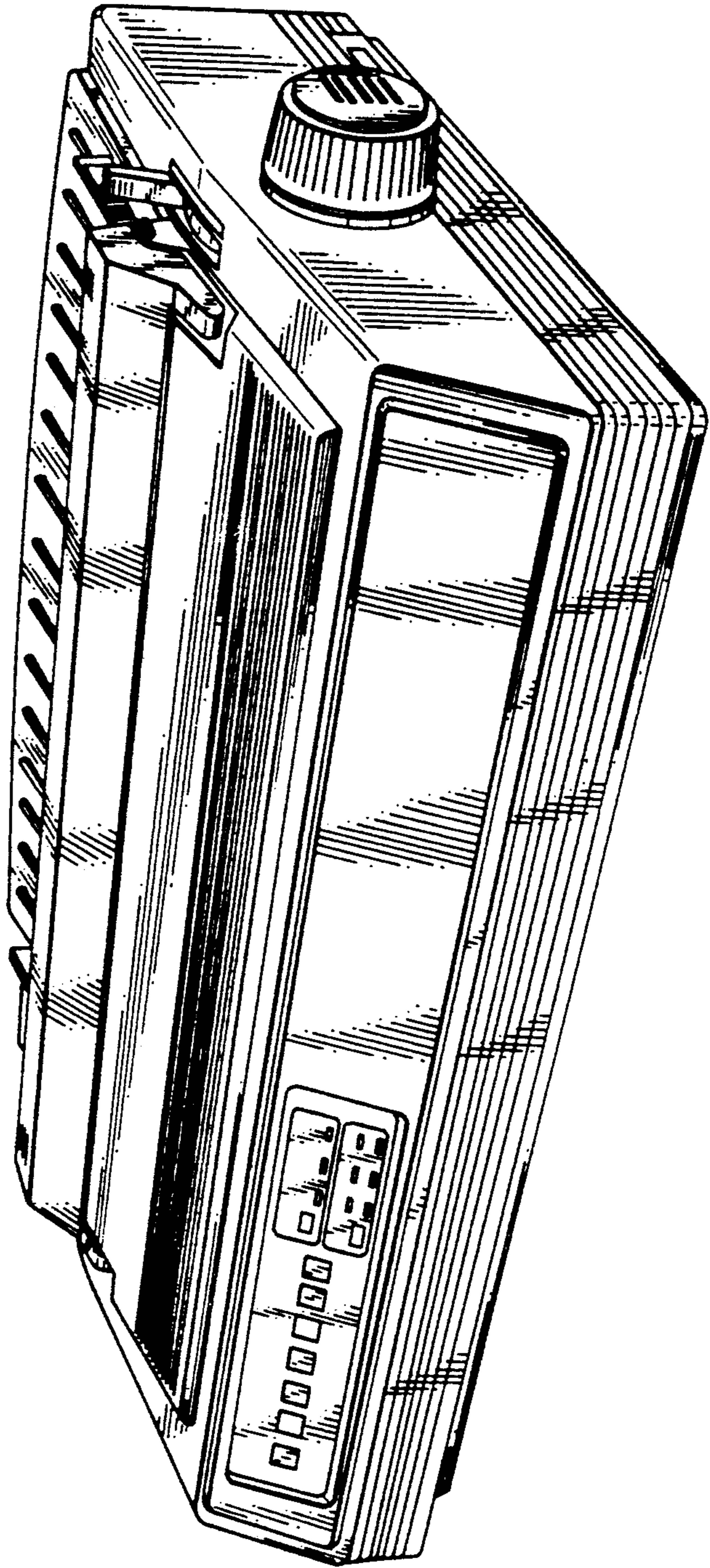

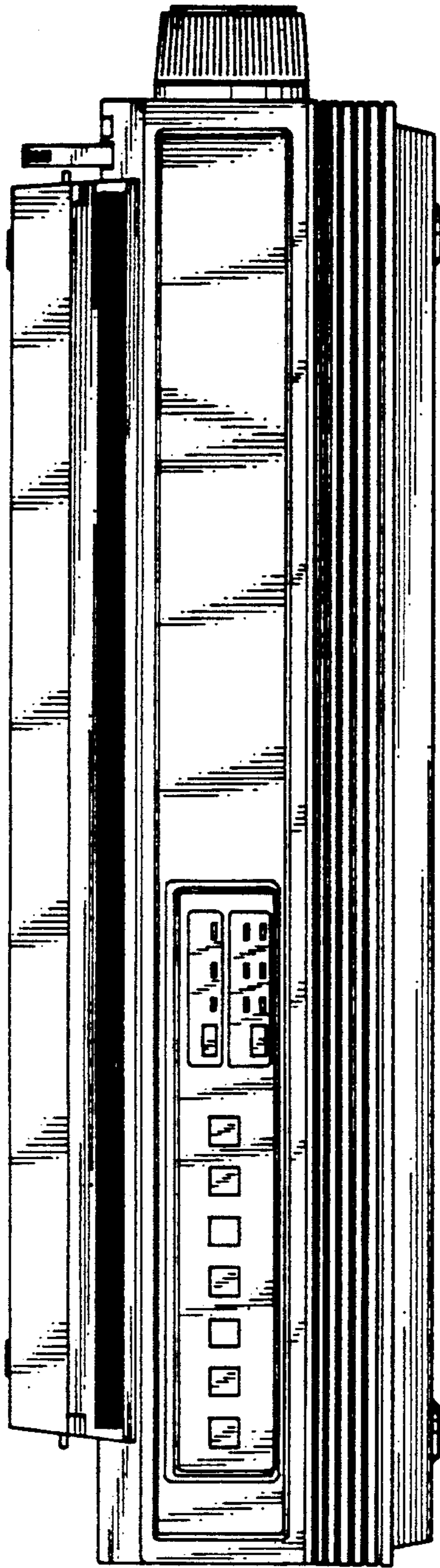
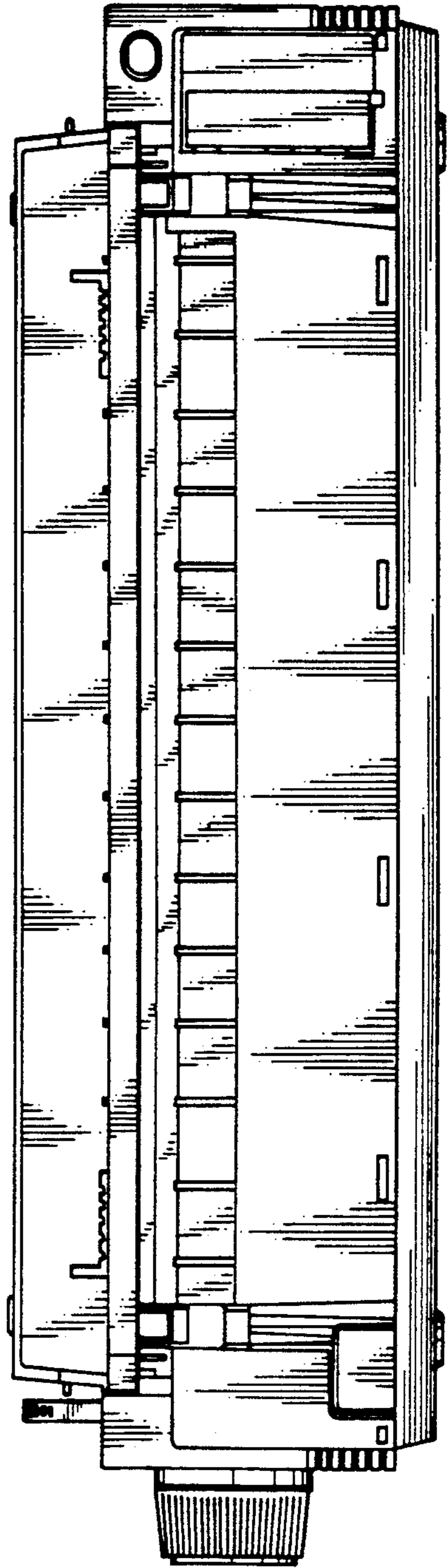

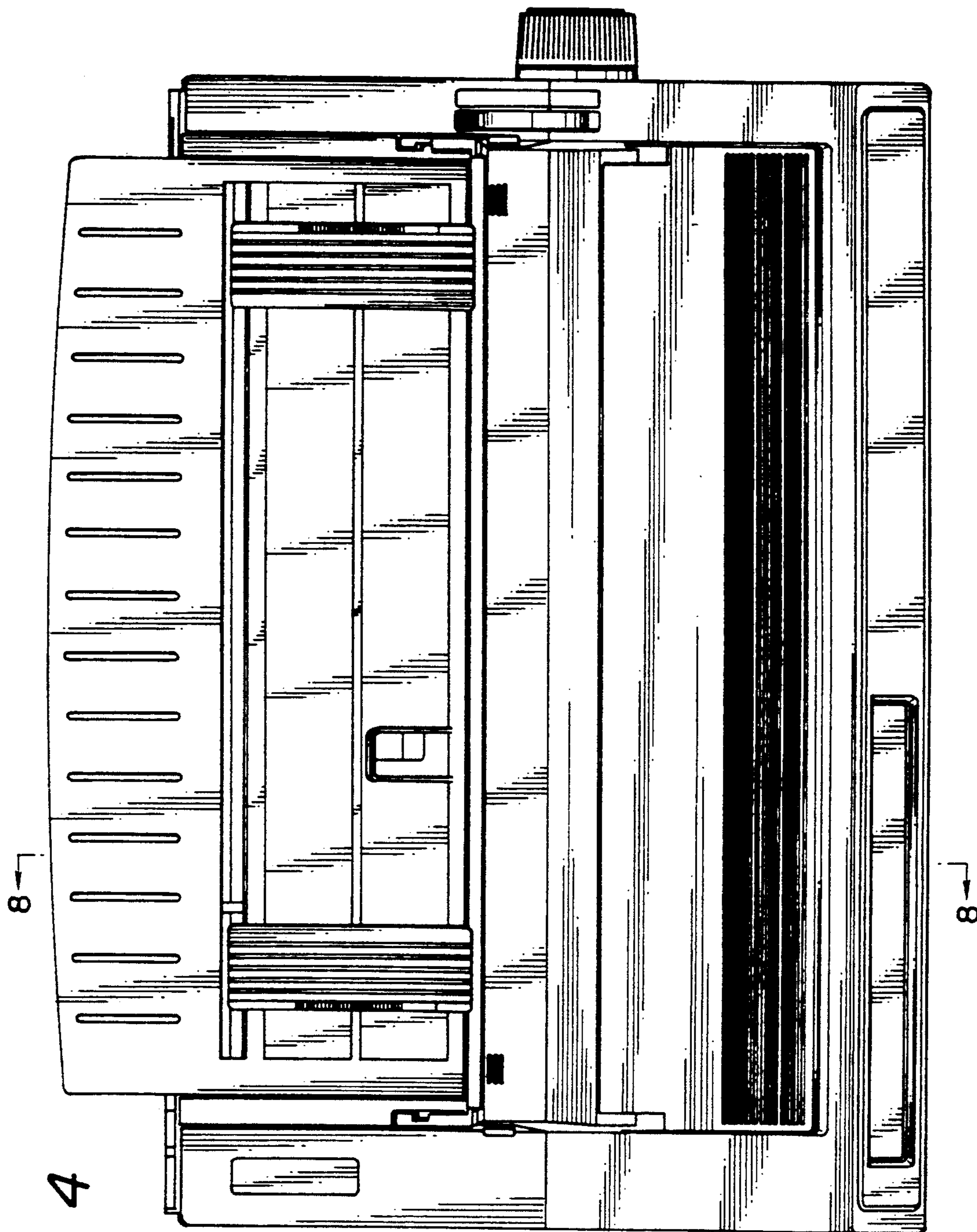

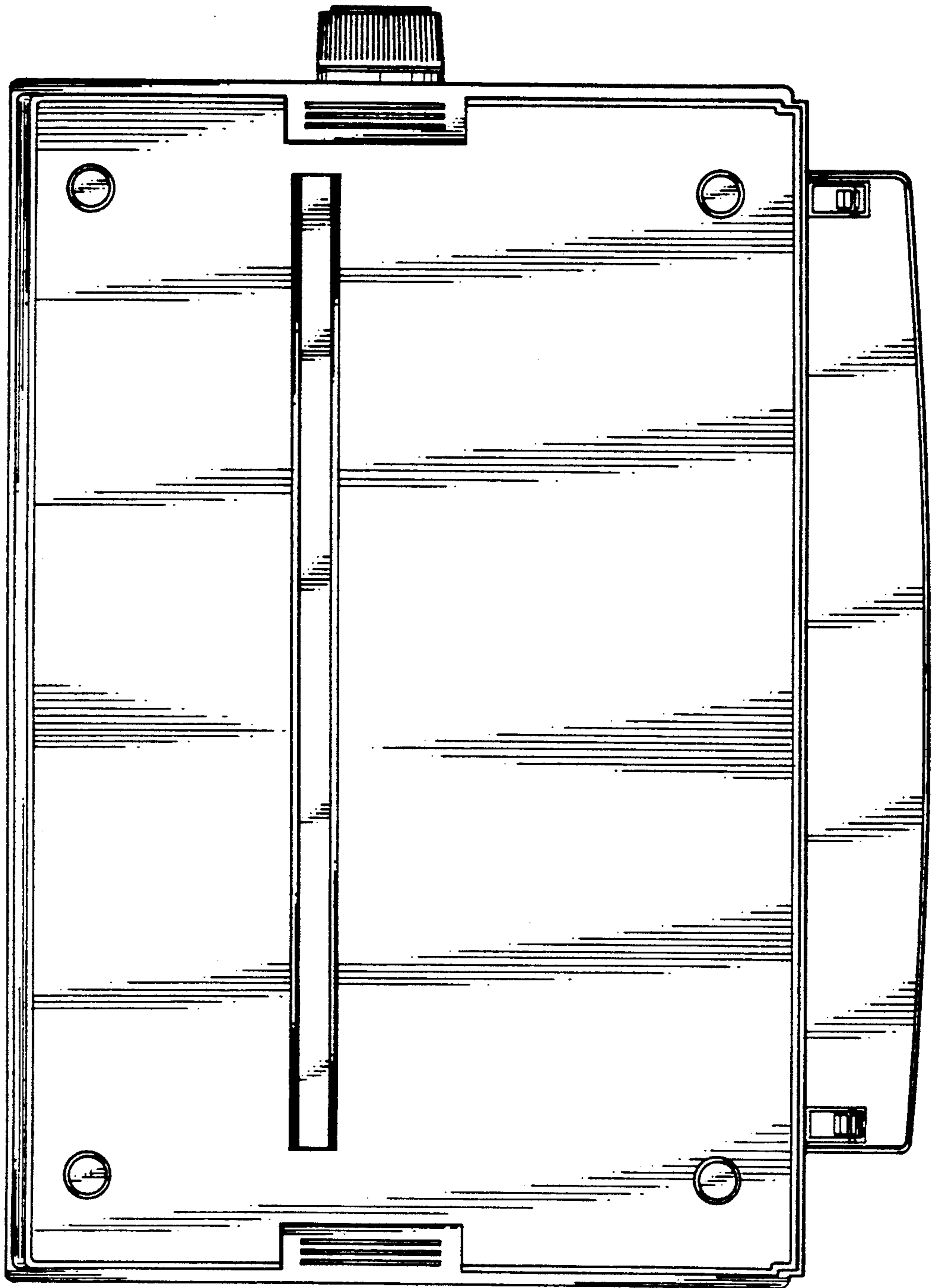

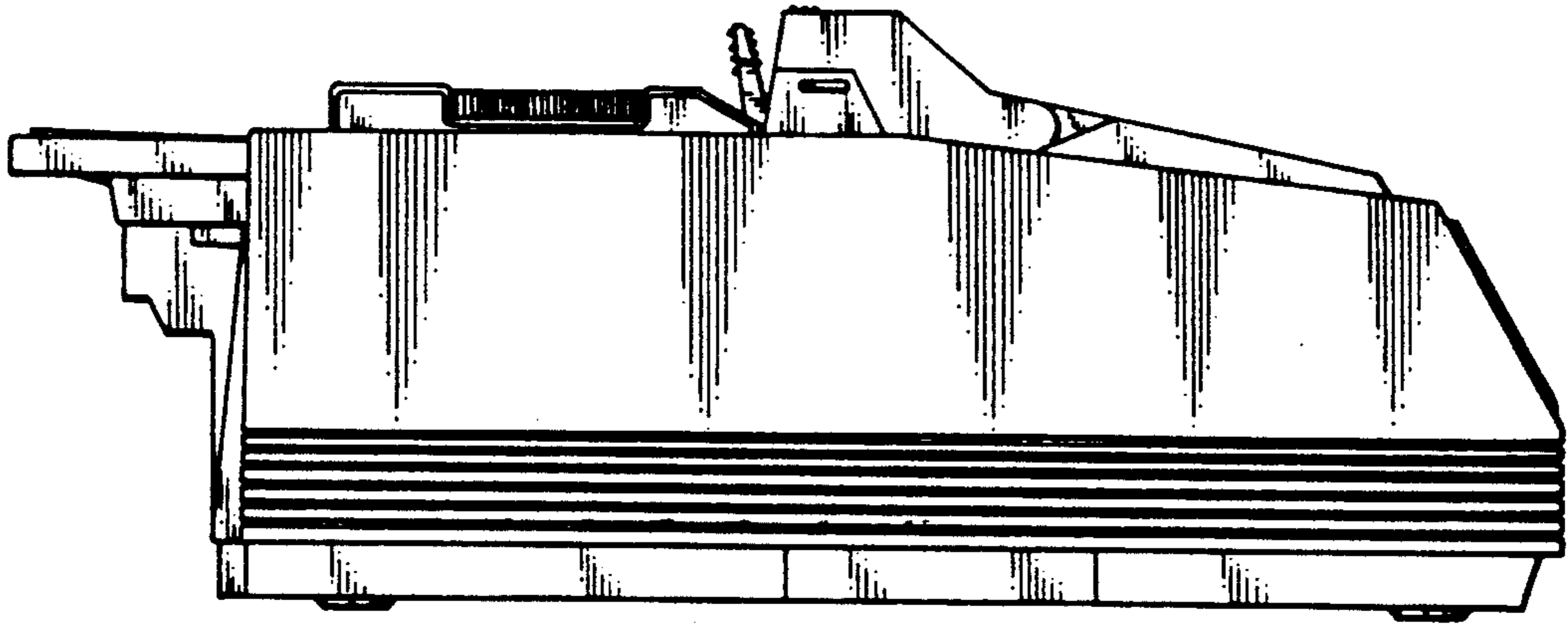

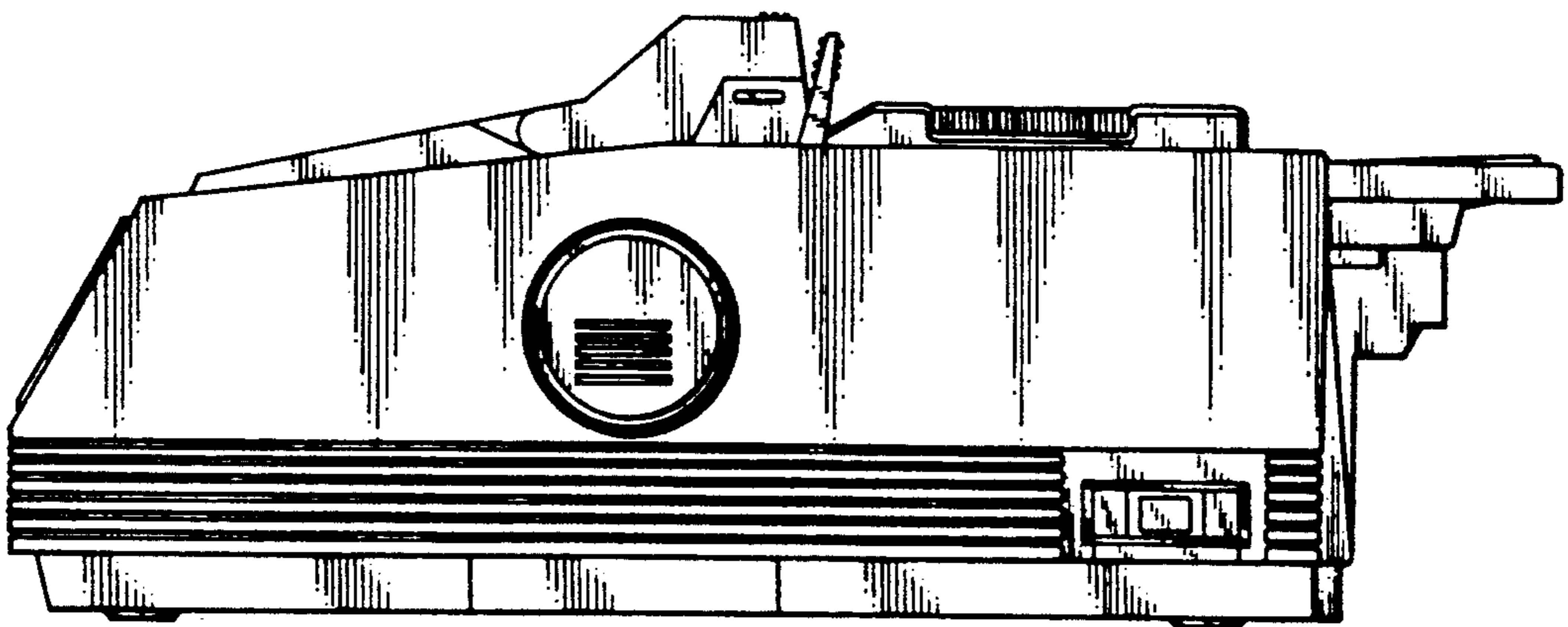
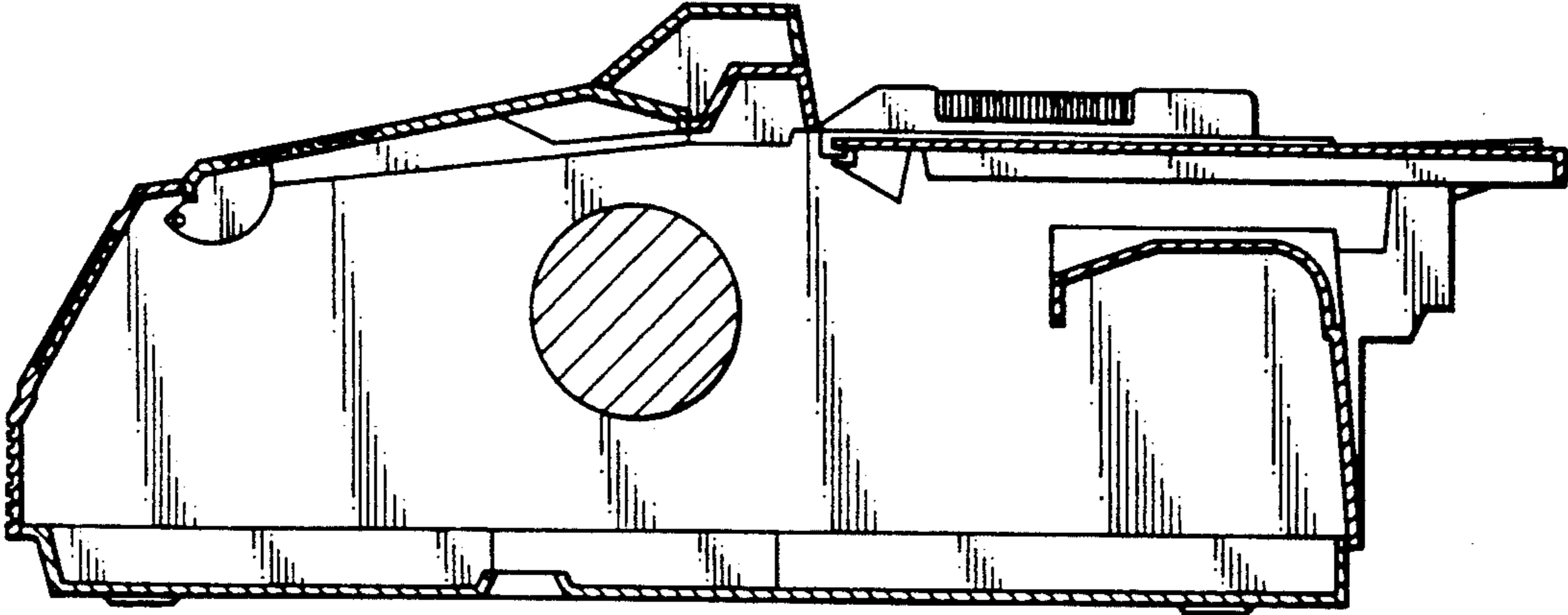

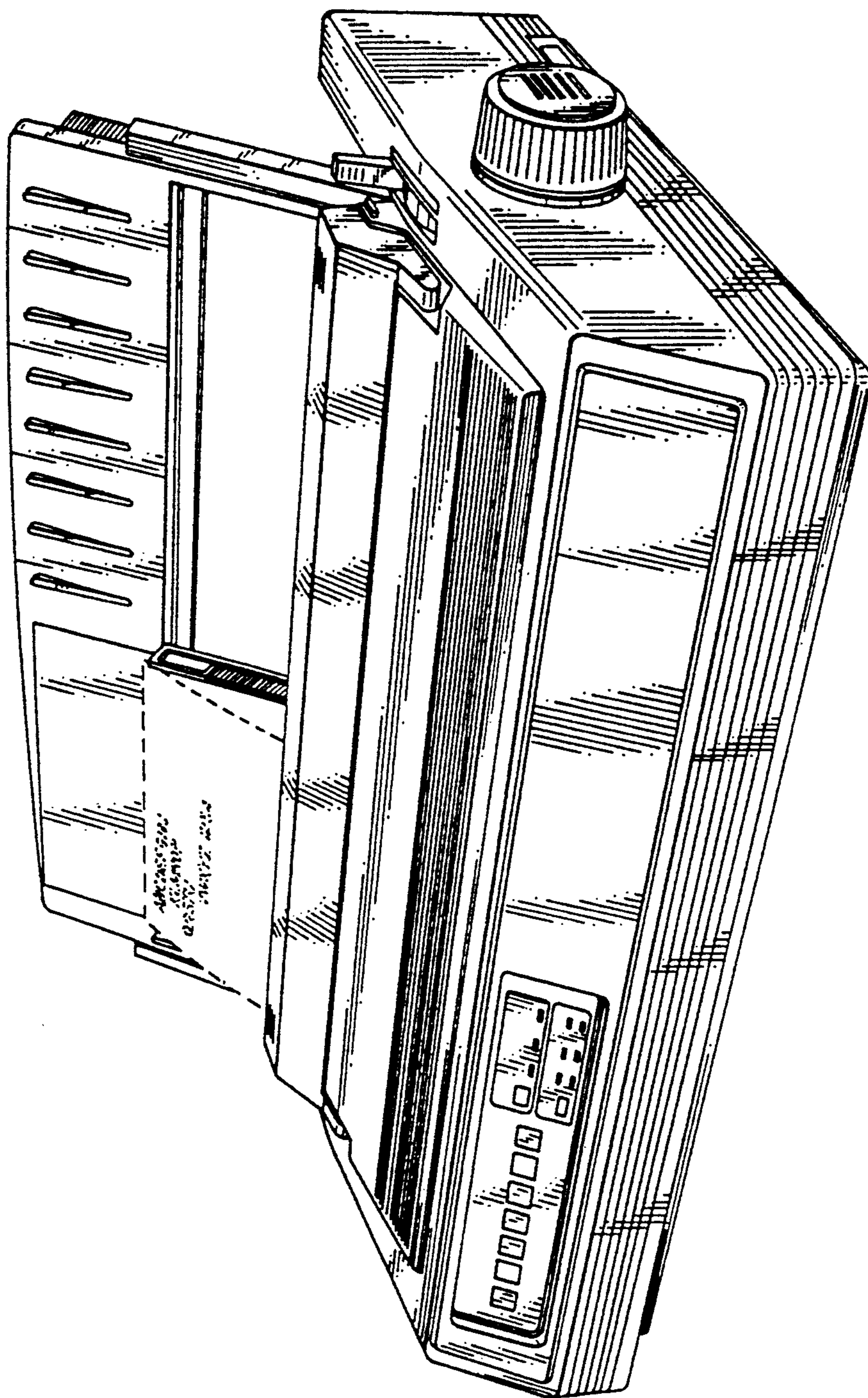
