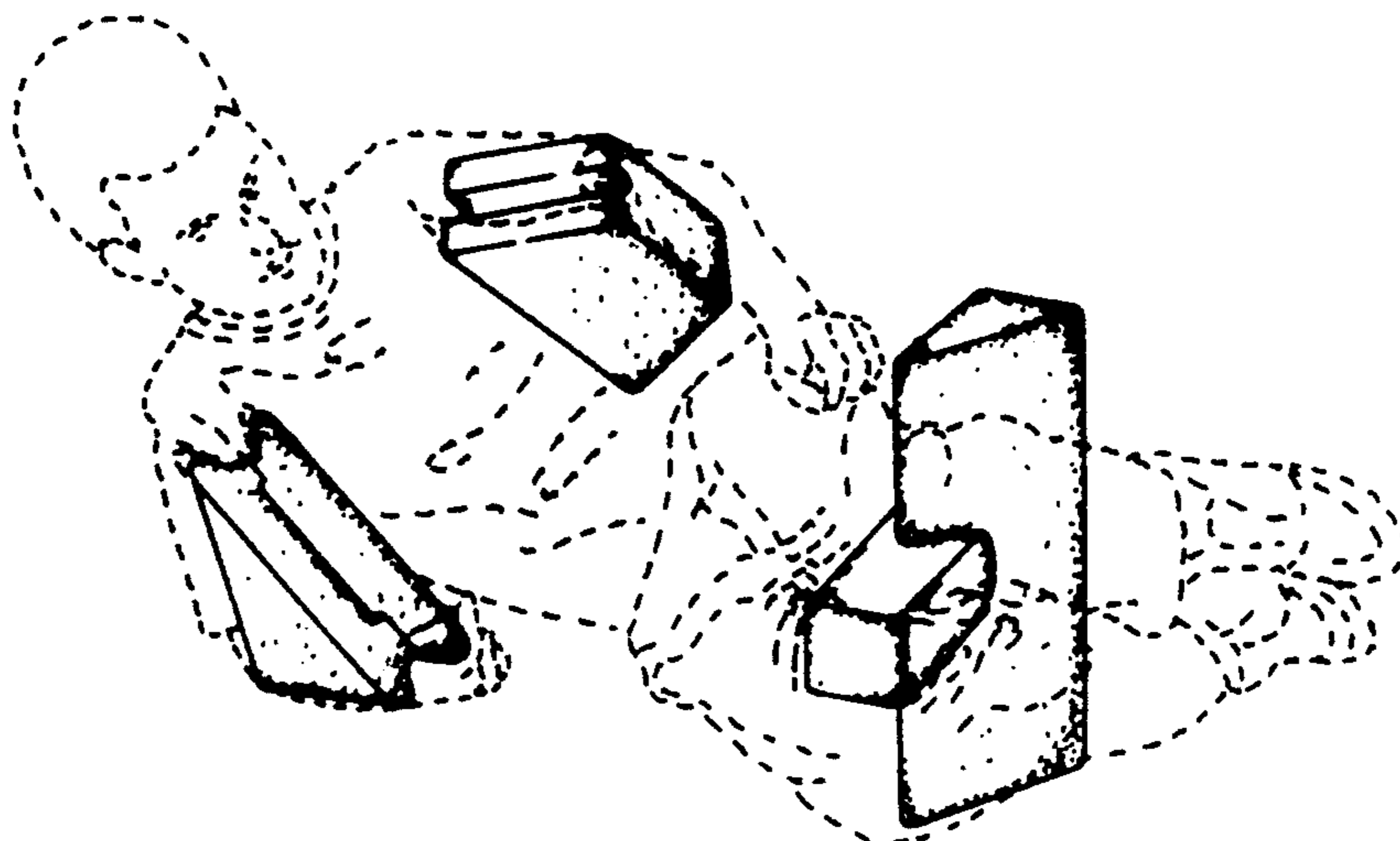

[57] **CLAIM**

The ornamental design for a combined abduction and position cushion set, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combined abduction and position cushion set showing my new design in use; FIG. 2 is an enlarged top plan view of the knee extension and hip abductor cushion, shown separately for clarity of illustration; FIG. 3 is a bottom plan view of FIG. 2; FIG. 4 is a front elevational view of FIG. 2; FIG. 5 is a rear elevational view of FIG. 2; FIG. 6 is a right side elevational view of FIG. 2, the left side being a mirror image of that shown; FIG. 7 is an enlarged top plan view of the shoulder abduction positioner cushion, shown separately for clarity of illustration; FIG. 8 is a bottom plan view of FIG. 7; FIG. 9 is a front elevational view of FIG. 7; FIG. 10 is a rear elevational view of FIG. 7; FIG. 11 is a right side elevational view of FIG. 7, the left side being a mirror image of that shown; FIG. 12 is an enlarged top plan view of the elbow extension positioner pillow, shown separately for clarity of illustration; FIG. 13 is a bottom plan view of FIG. 12; FIG. 14 is an end elevational view of FIG. 12, the opposite end being a mirror image of that shown; and, FIG. 15 is a side elevational view of FIG. 12, the opposite side being a mirror image of that shown. The broken line showing of an incogitant patient in FIG. 1, is for illustrative purposes only, and forms no part of the claimed design.



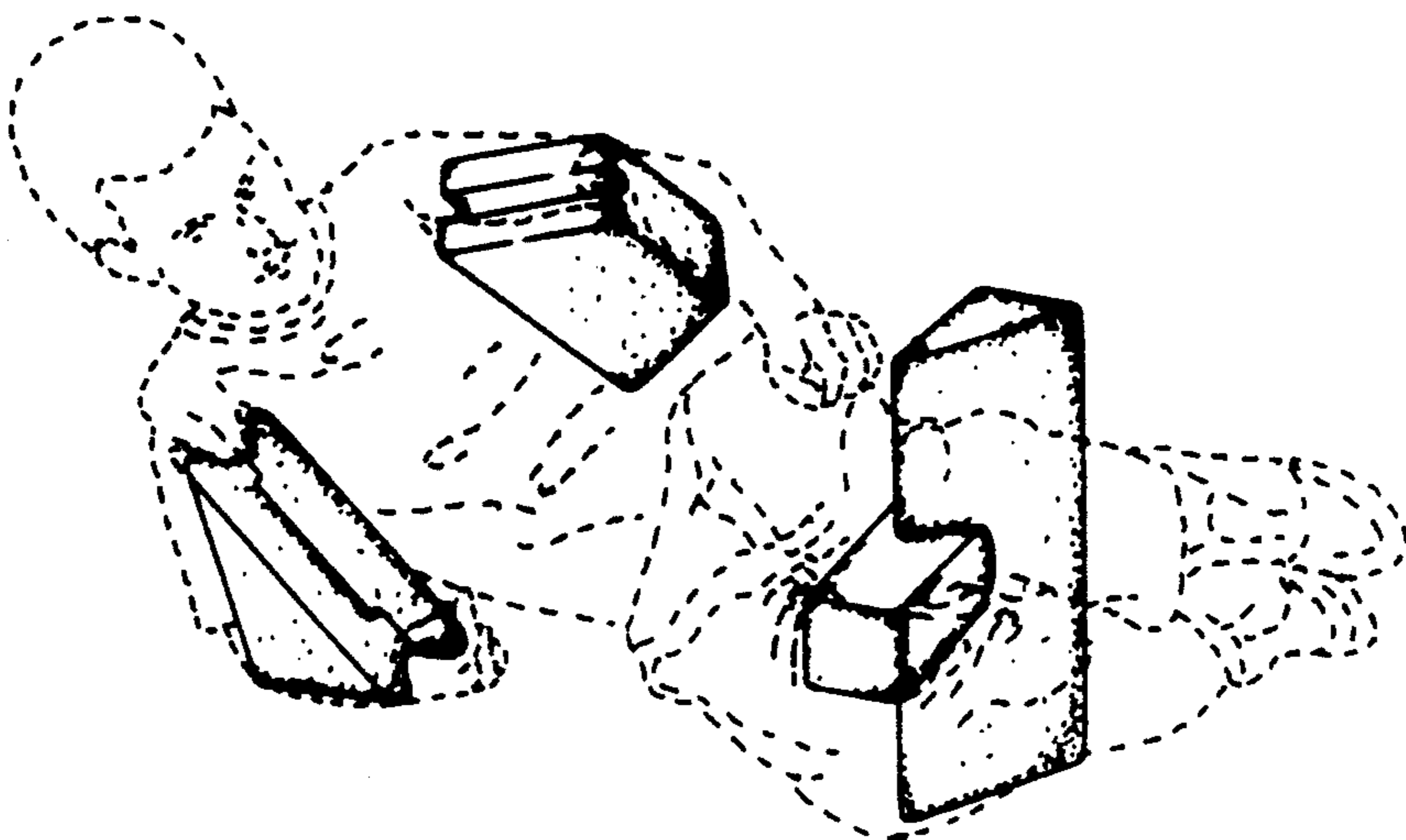

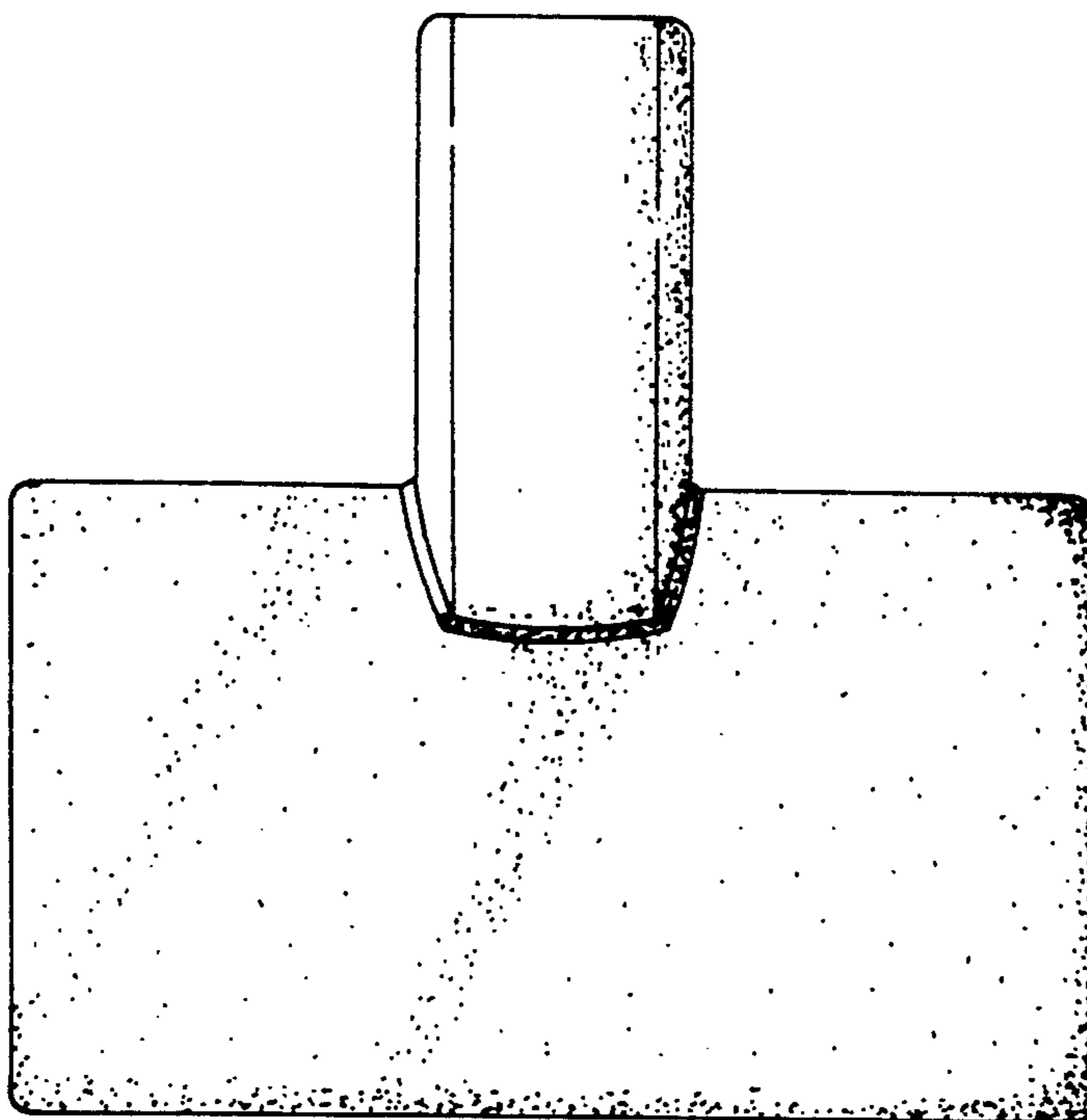

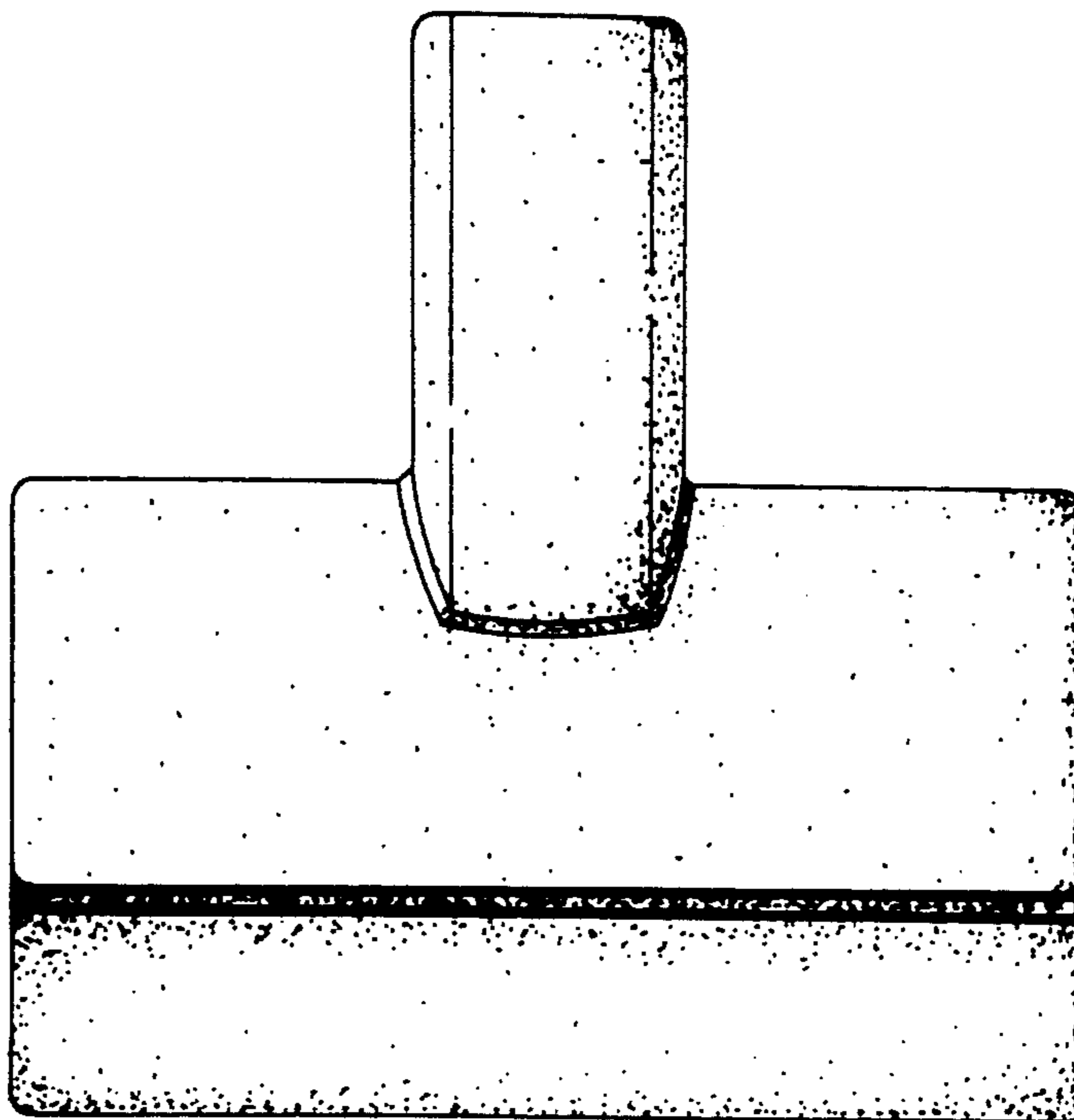

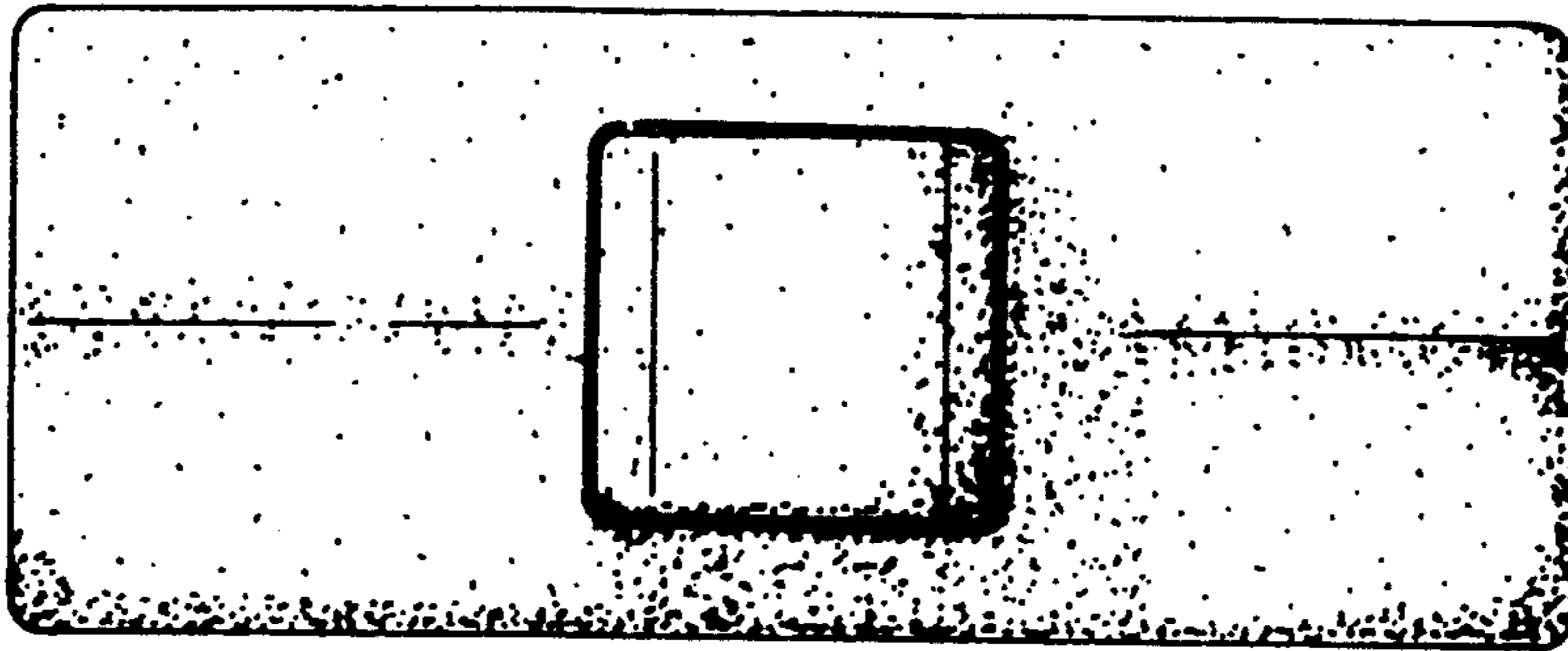

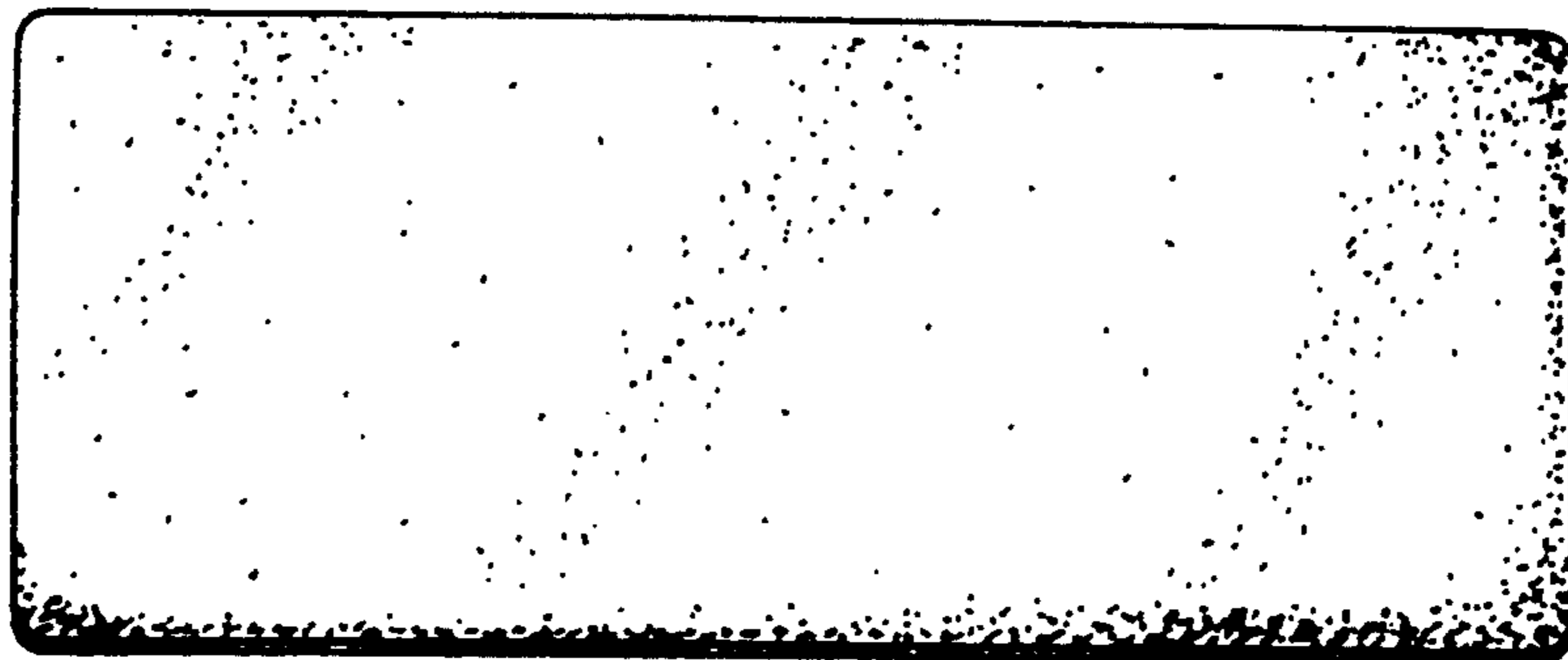

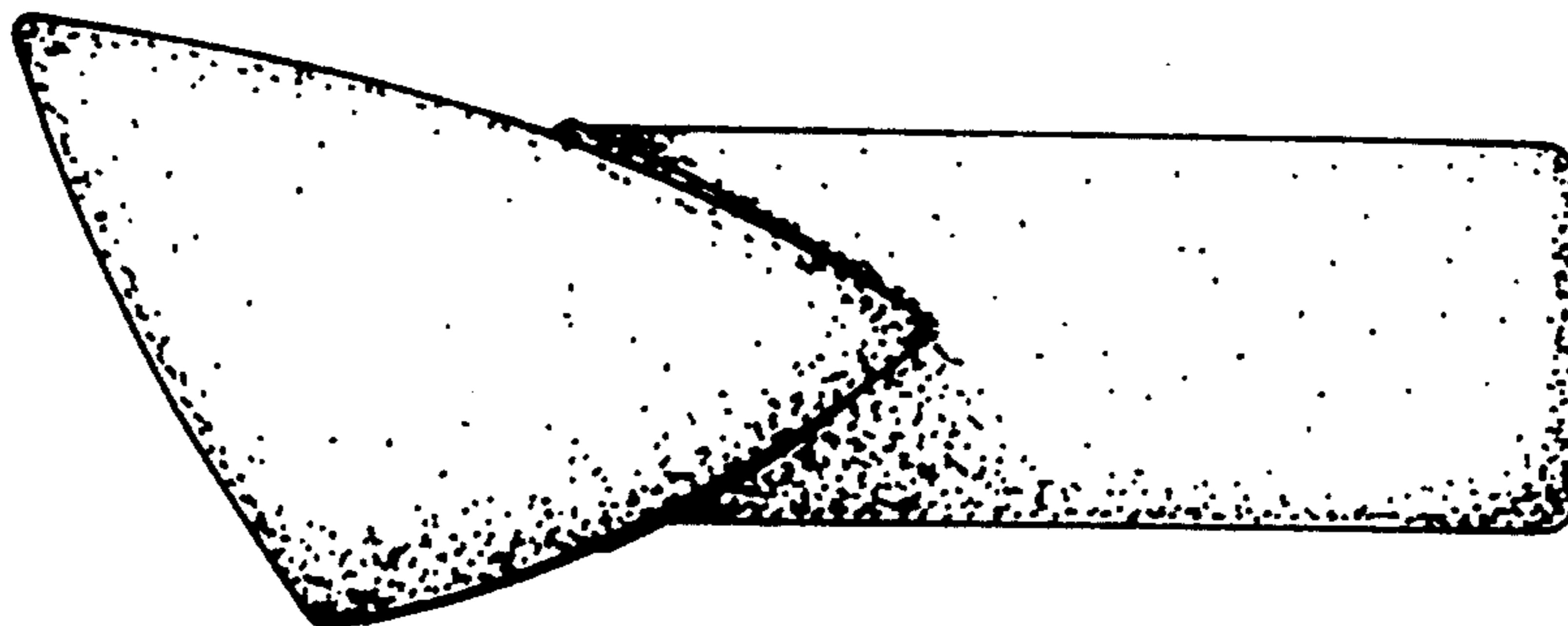

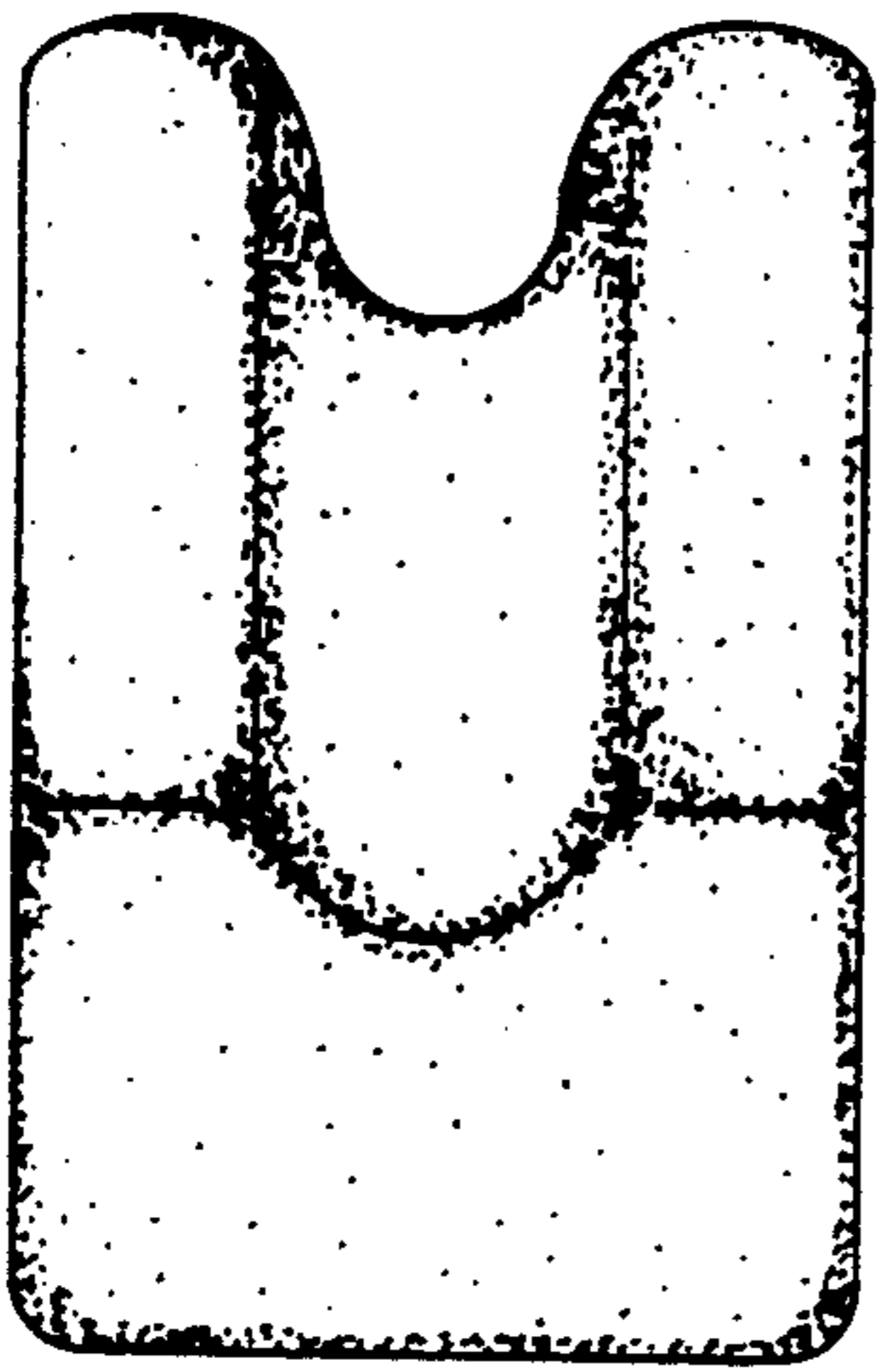

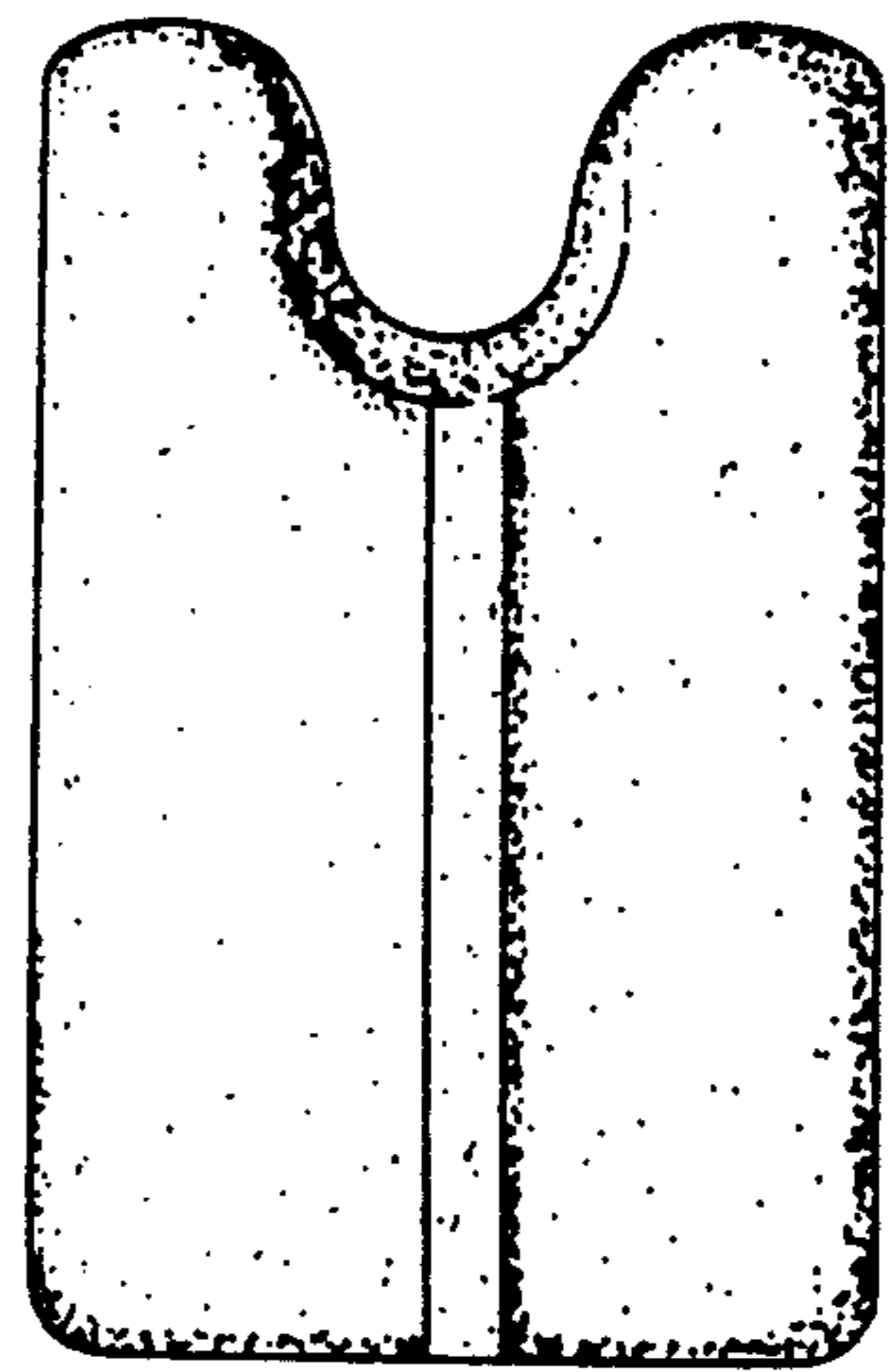

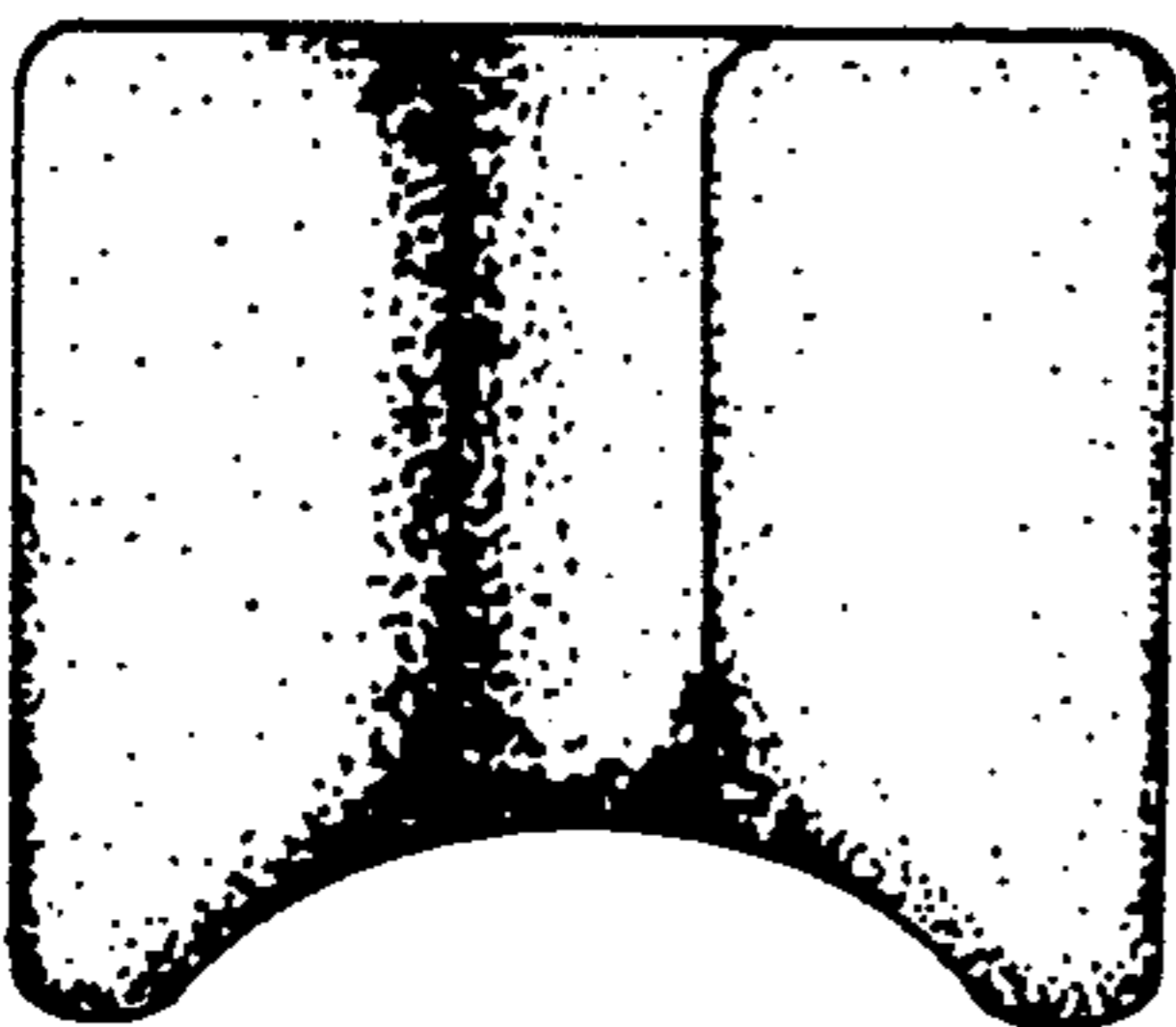

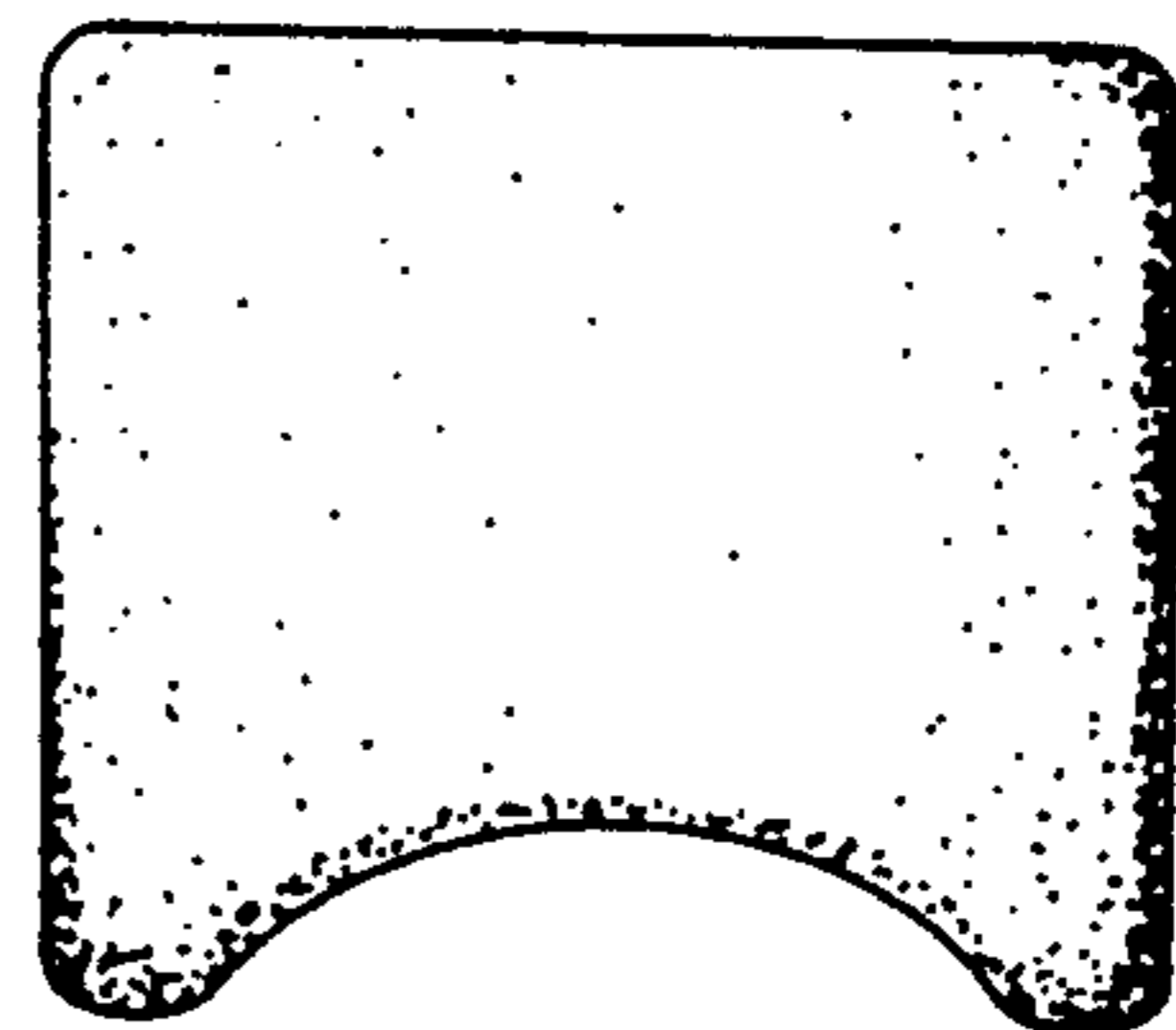

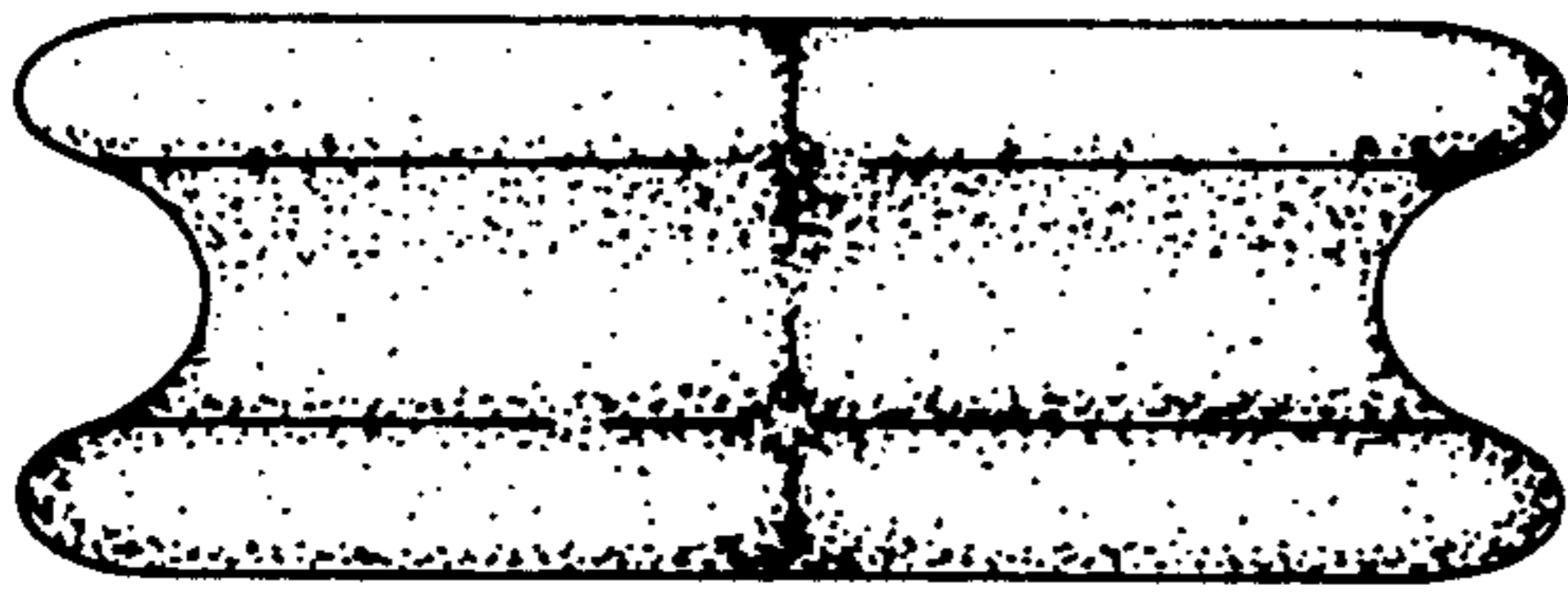

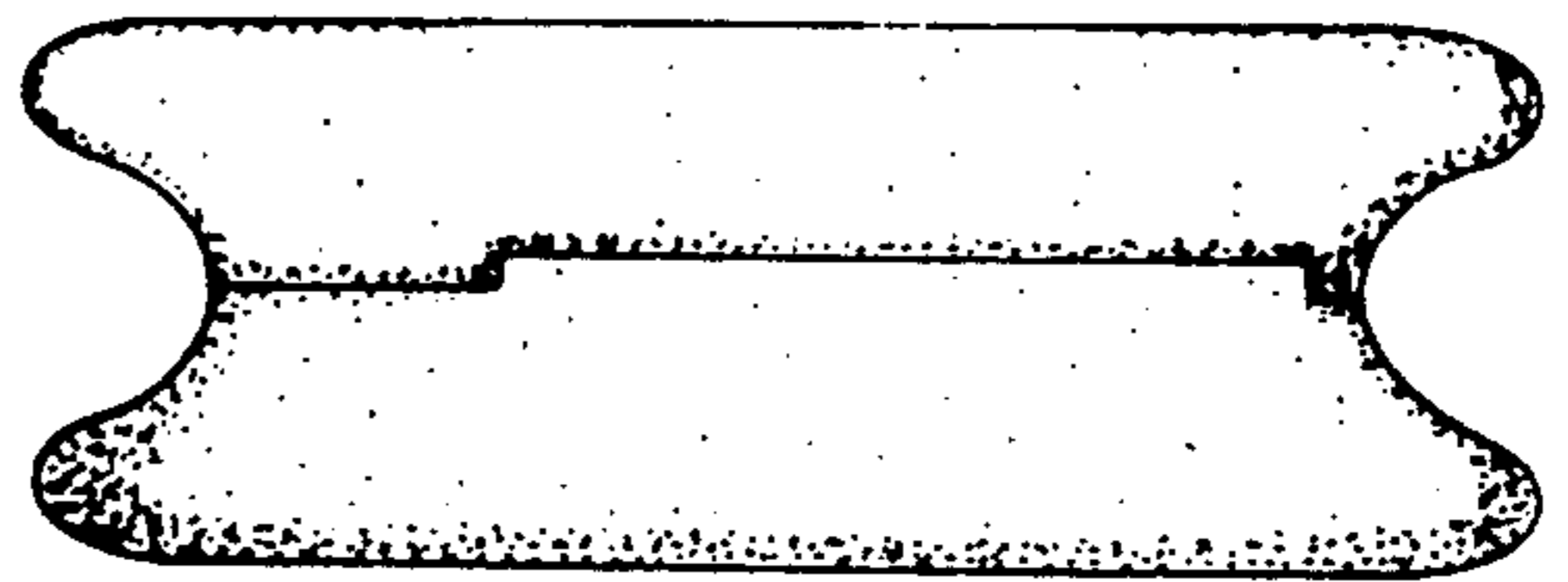

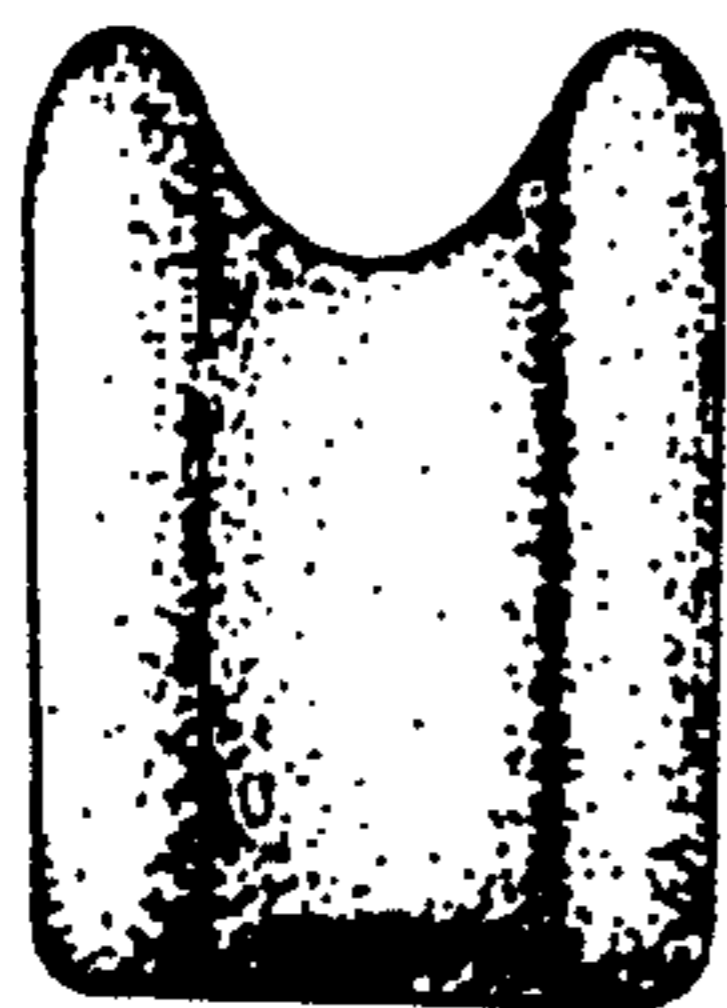

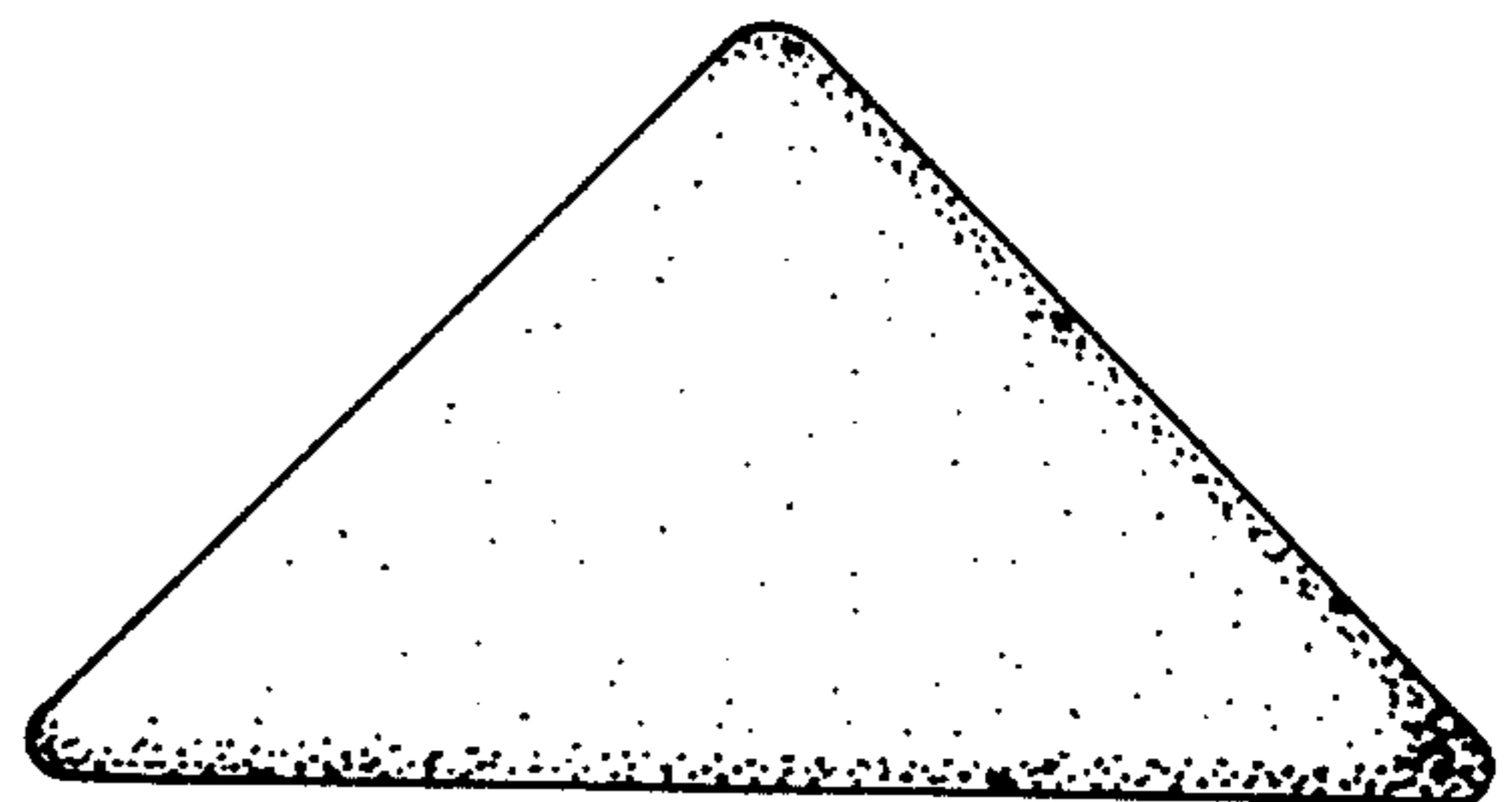
