[57] **CLAIM**

The ornamental design for a pair of supports for use on curtain rods or stairs rails, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the right hand support of the pair of supports showing my new design; FIG. 2 is a right-side elevational view thereof; FIG. 3 is a left-side elevational view thereof; FIG. 4 is a front side elevational view thereof; FIG. 5 is a rear side elevational view thereof; FIG. 6 is a plan view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a perspective view of the opposite support of the pair; FIG. 9 is a right-side elevational view thereof; FIG. 10 is a left-side elevational view thereof; FIG. 11 is a front side elevational view thereof; FIG. 12 is a rear side elevational view thereof; FIG. 13 is a plan view thereof; FIG. 14 is a bottom view thereof; and, FIG. 15 is a top plan view of the pair of supports in use with the broken line showing of a rod being for illustrative purposes only and forming no part of the claimed design. The pair of supports has been shown separately for clarity of illustration.

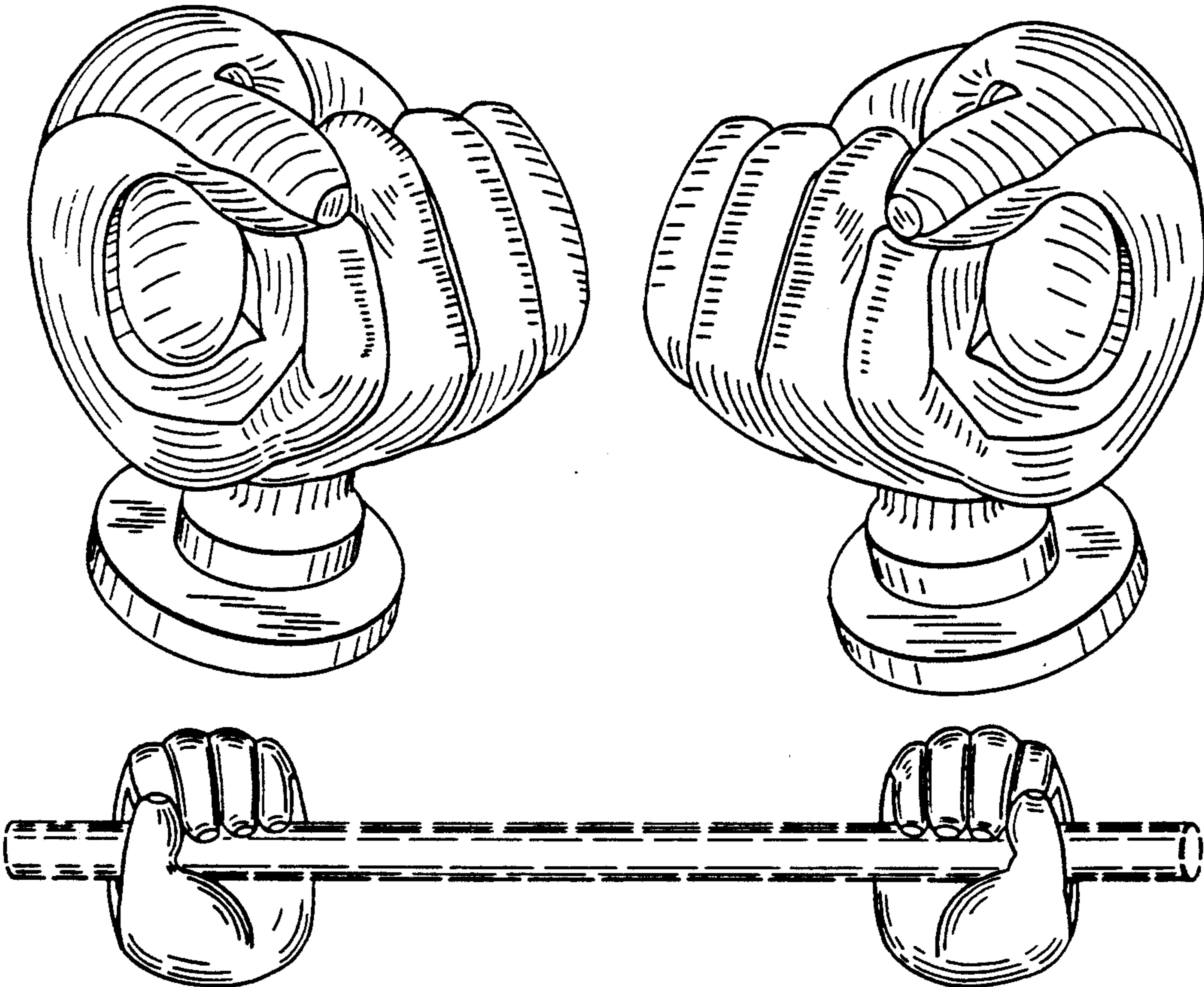

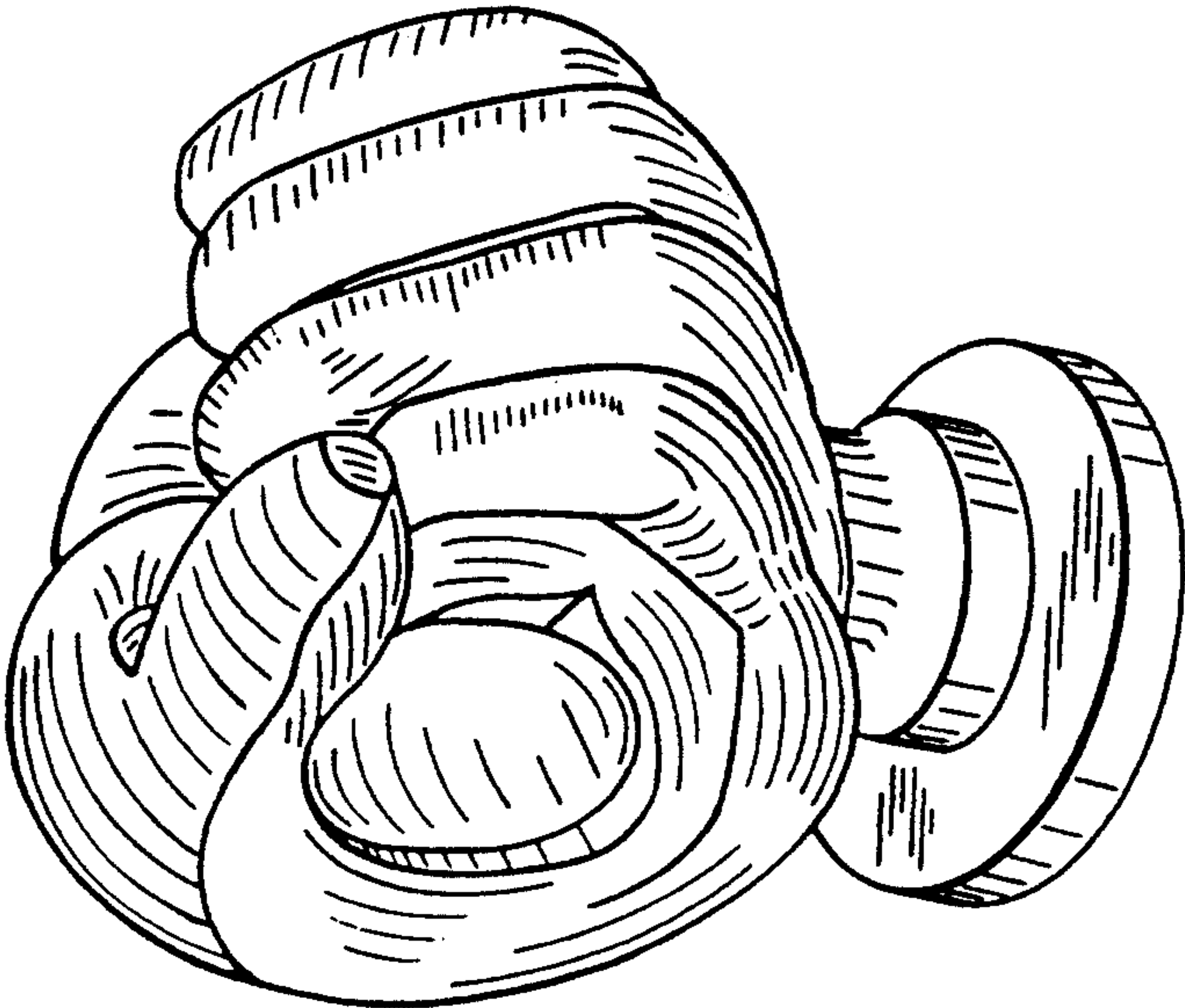

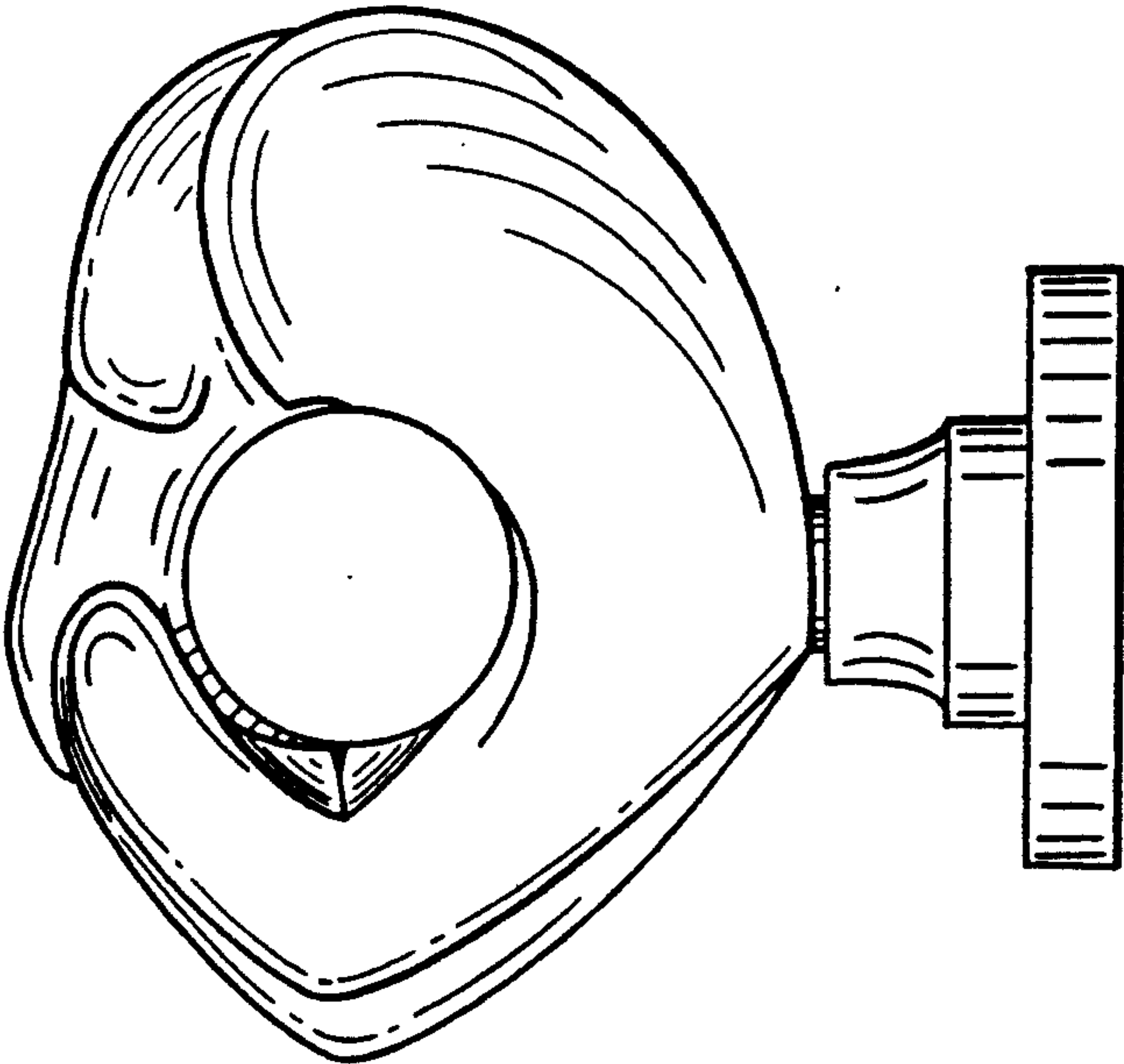

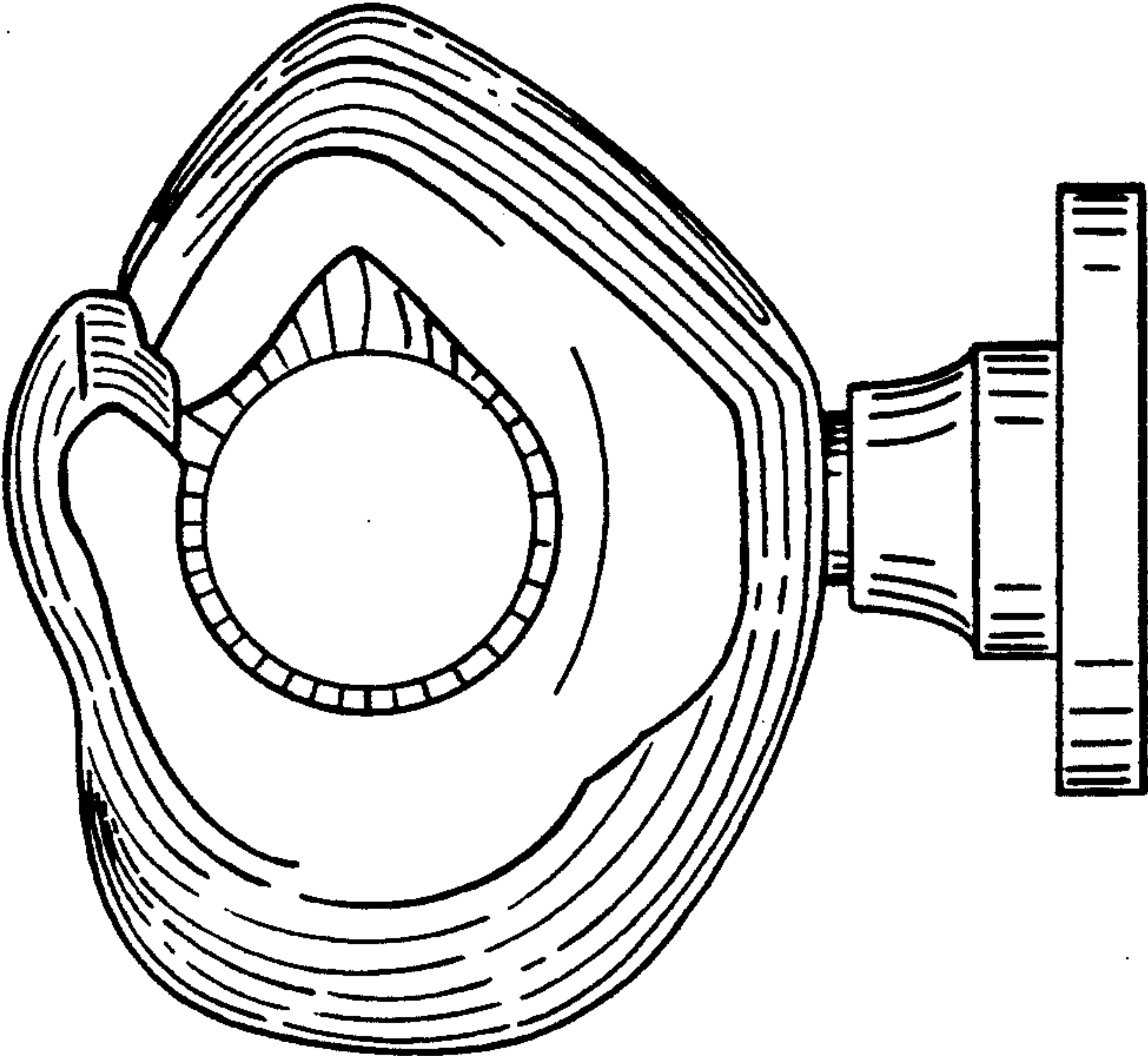

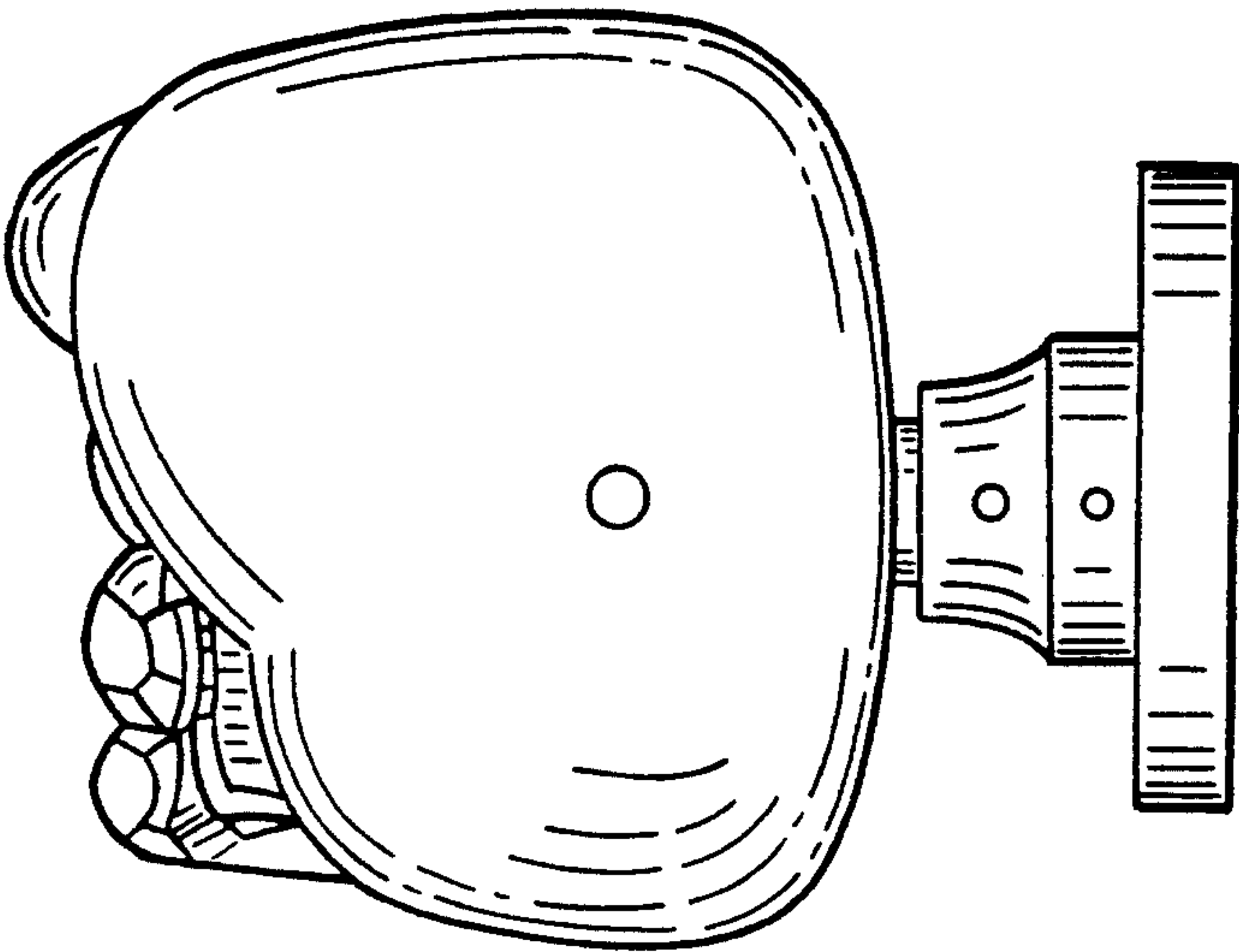

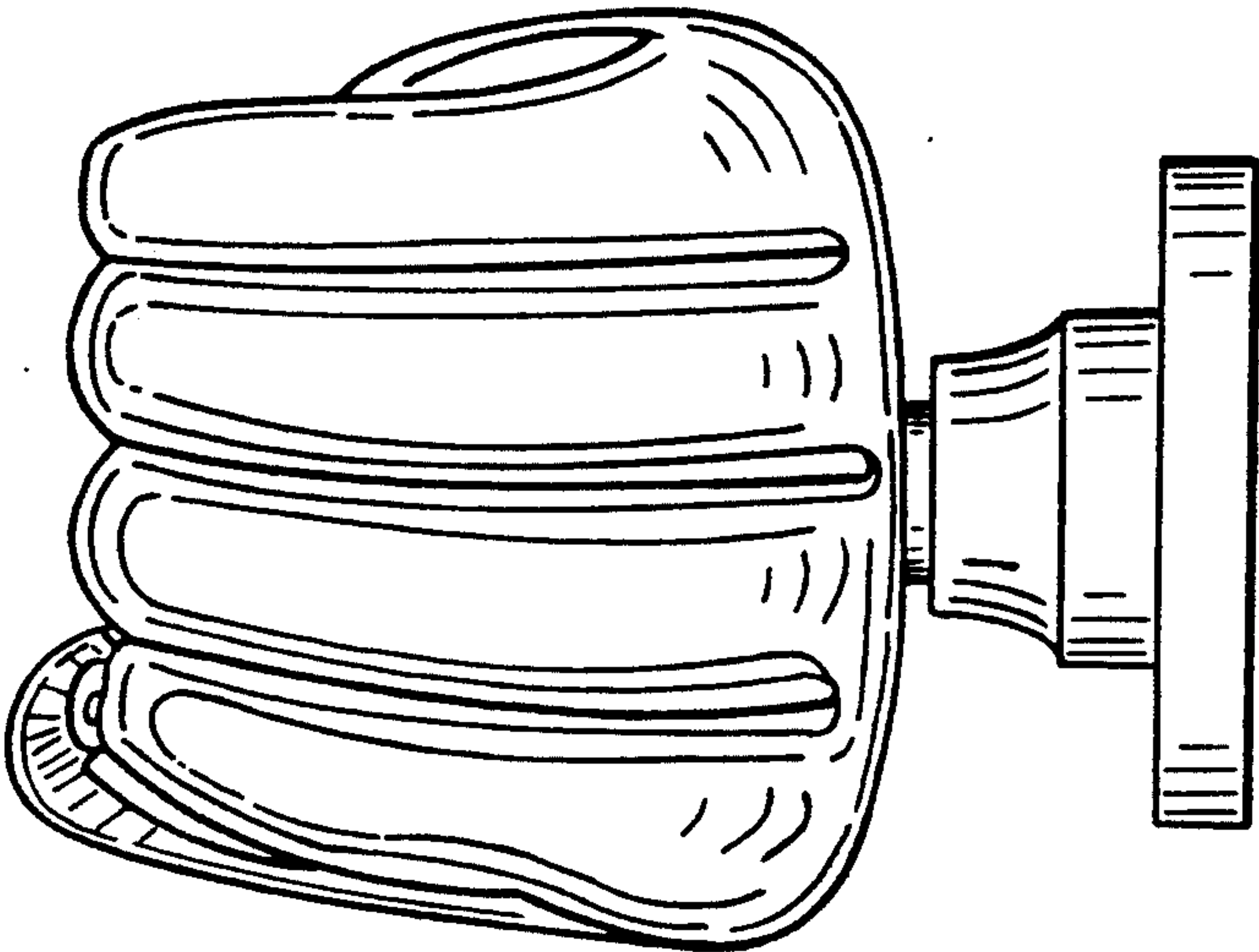

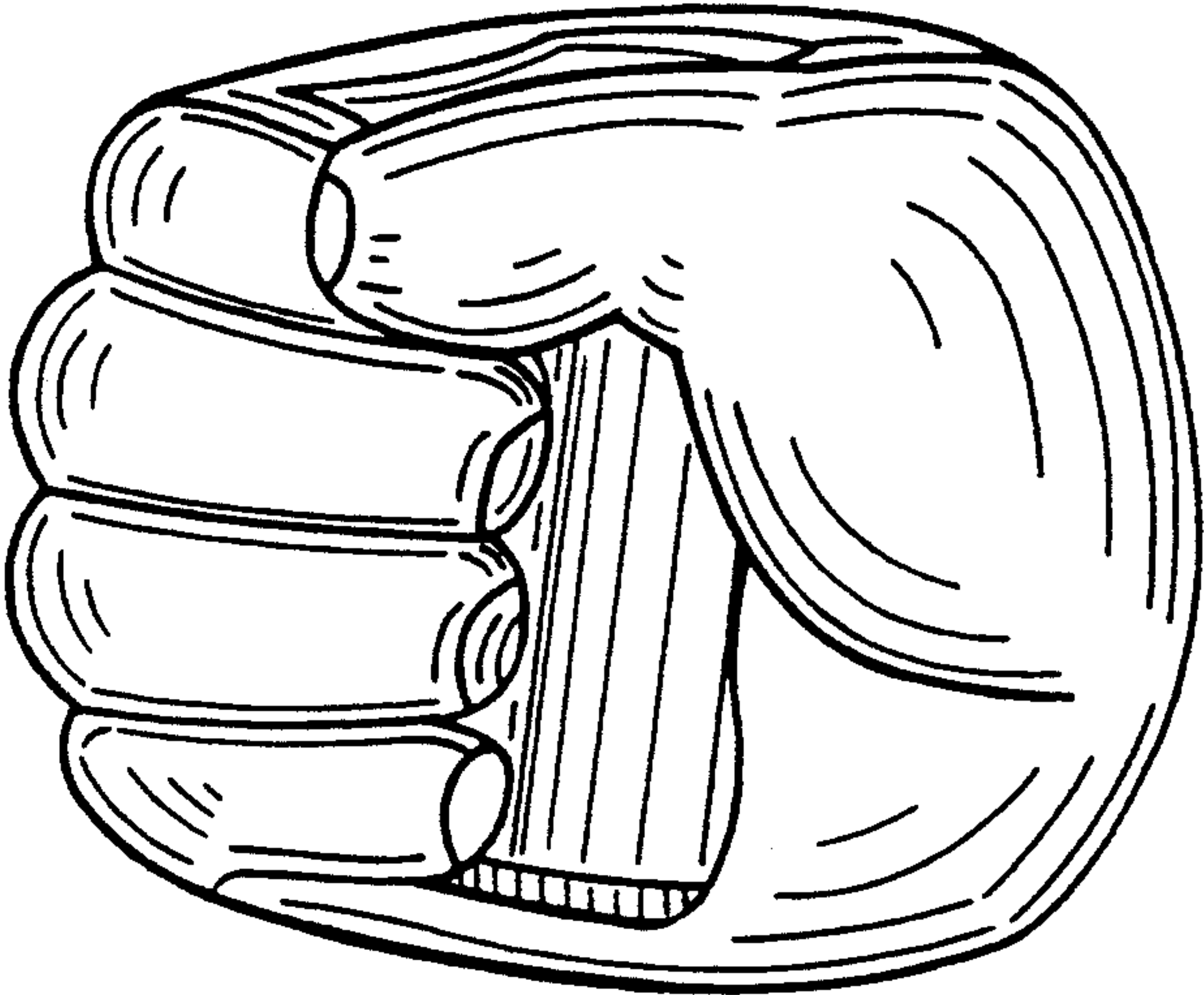

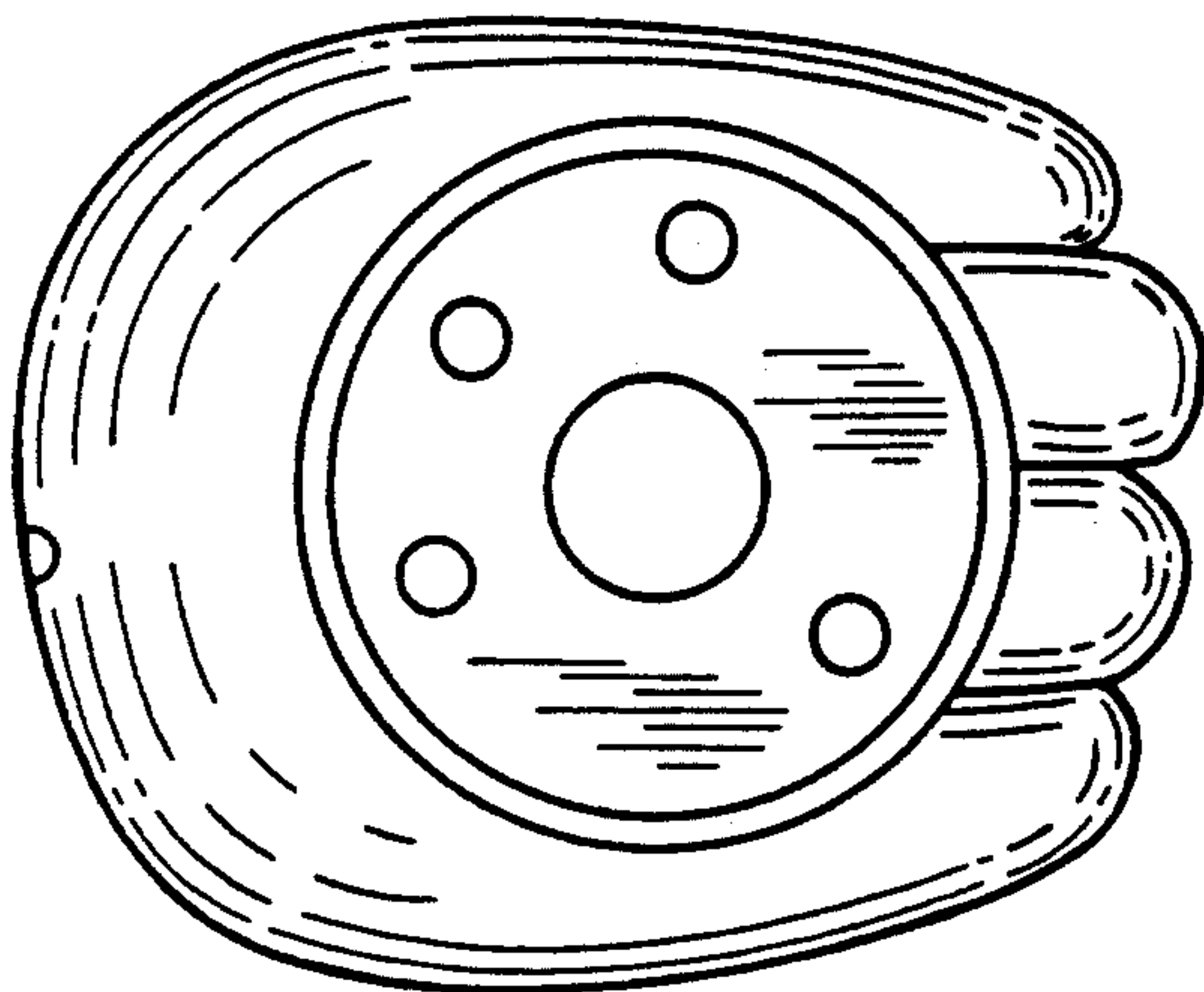

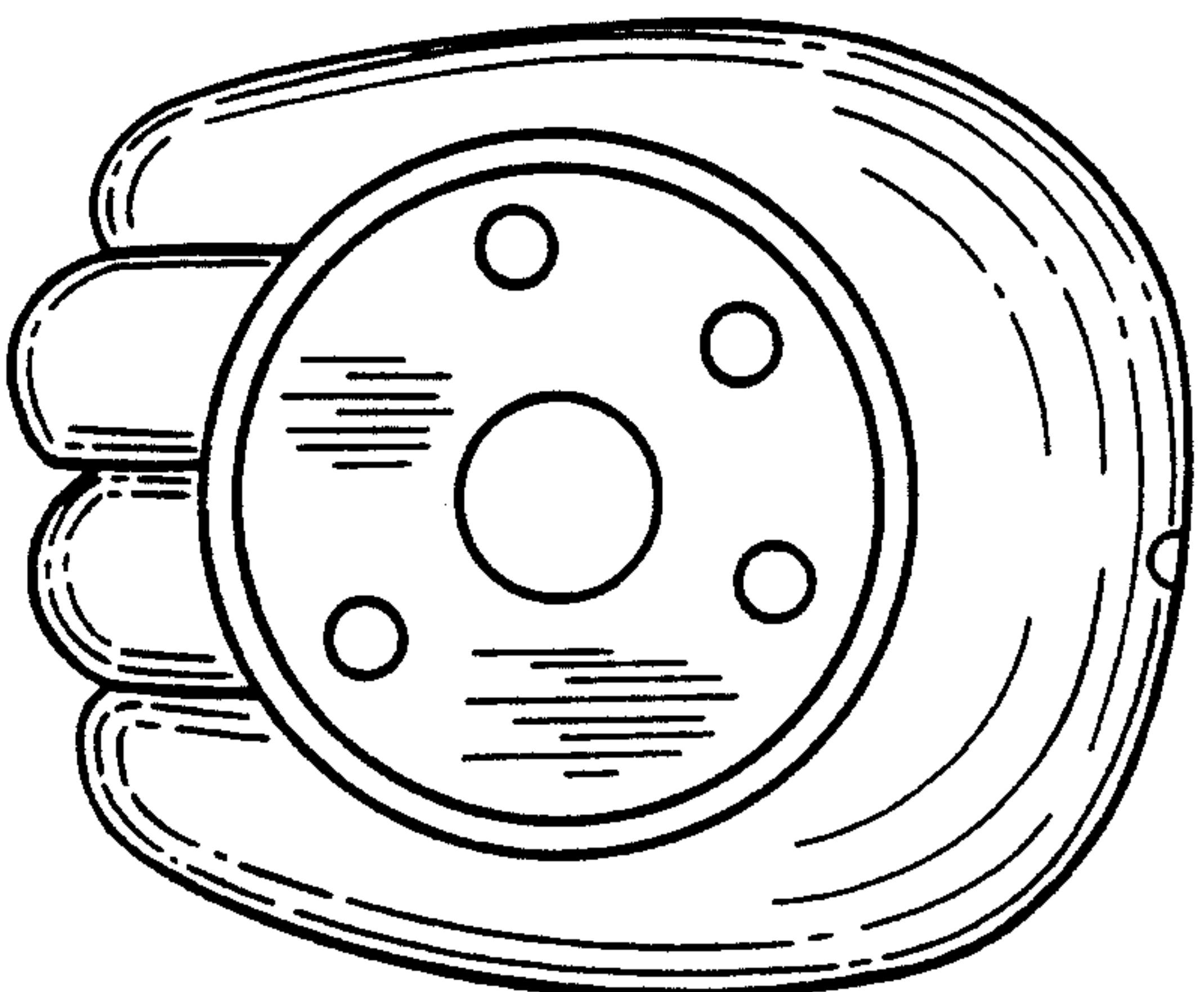

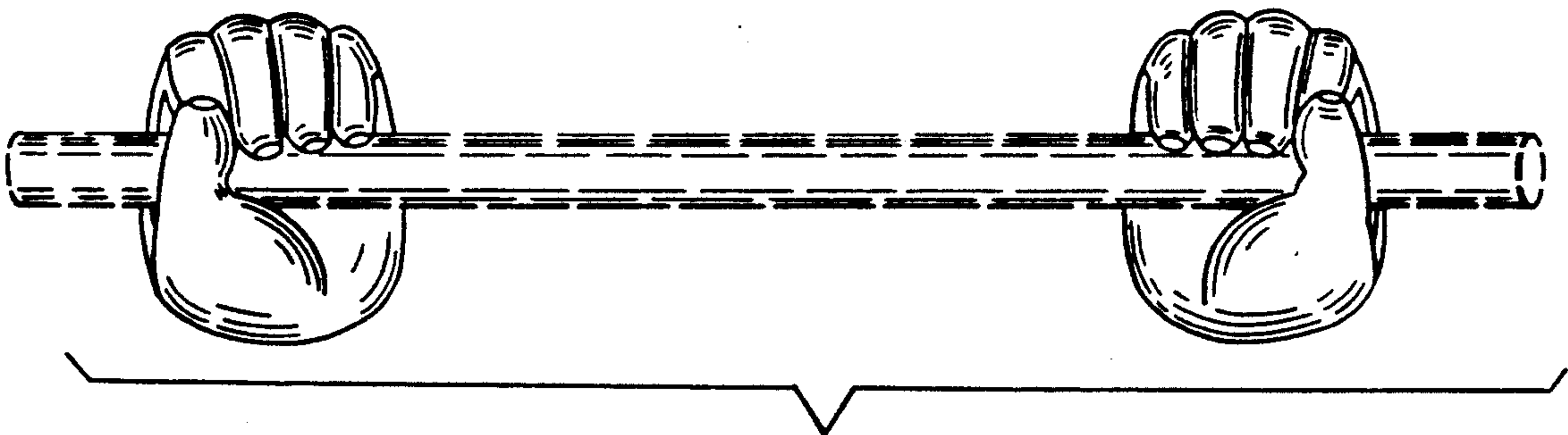

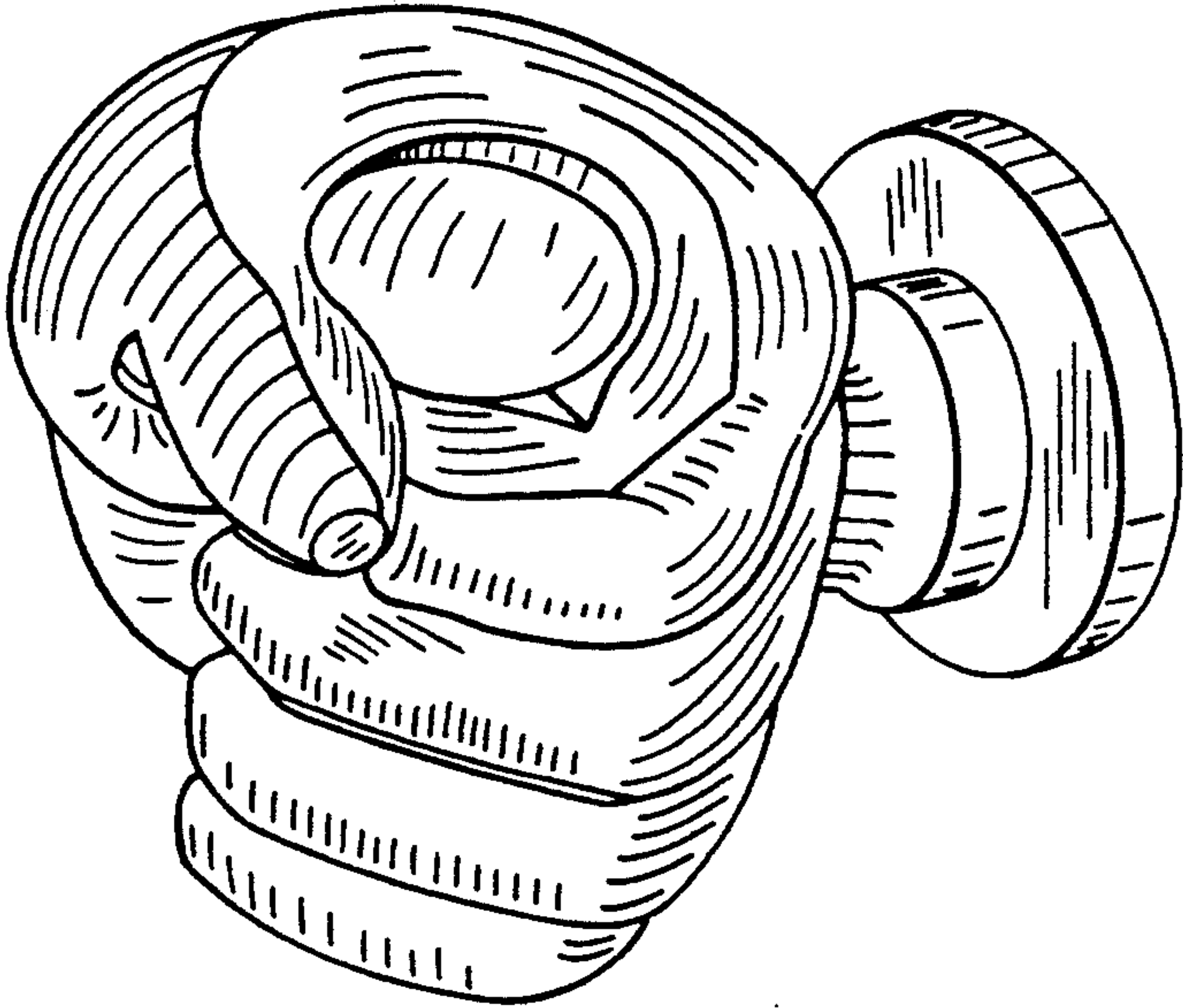

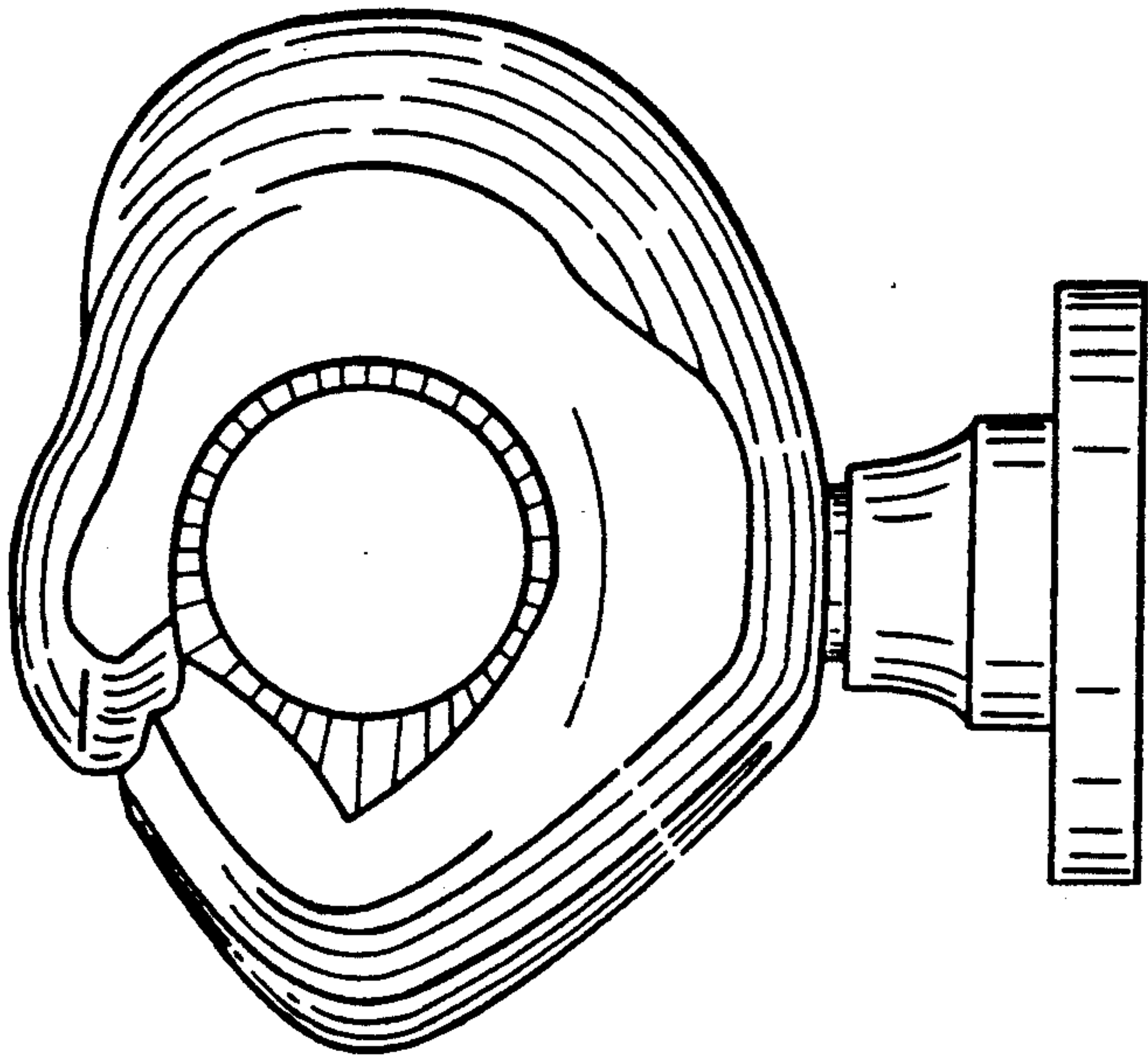

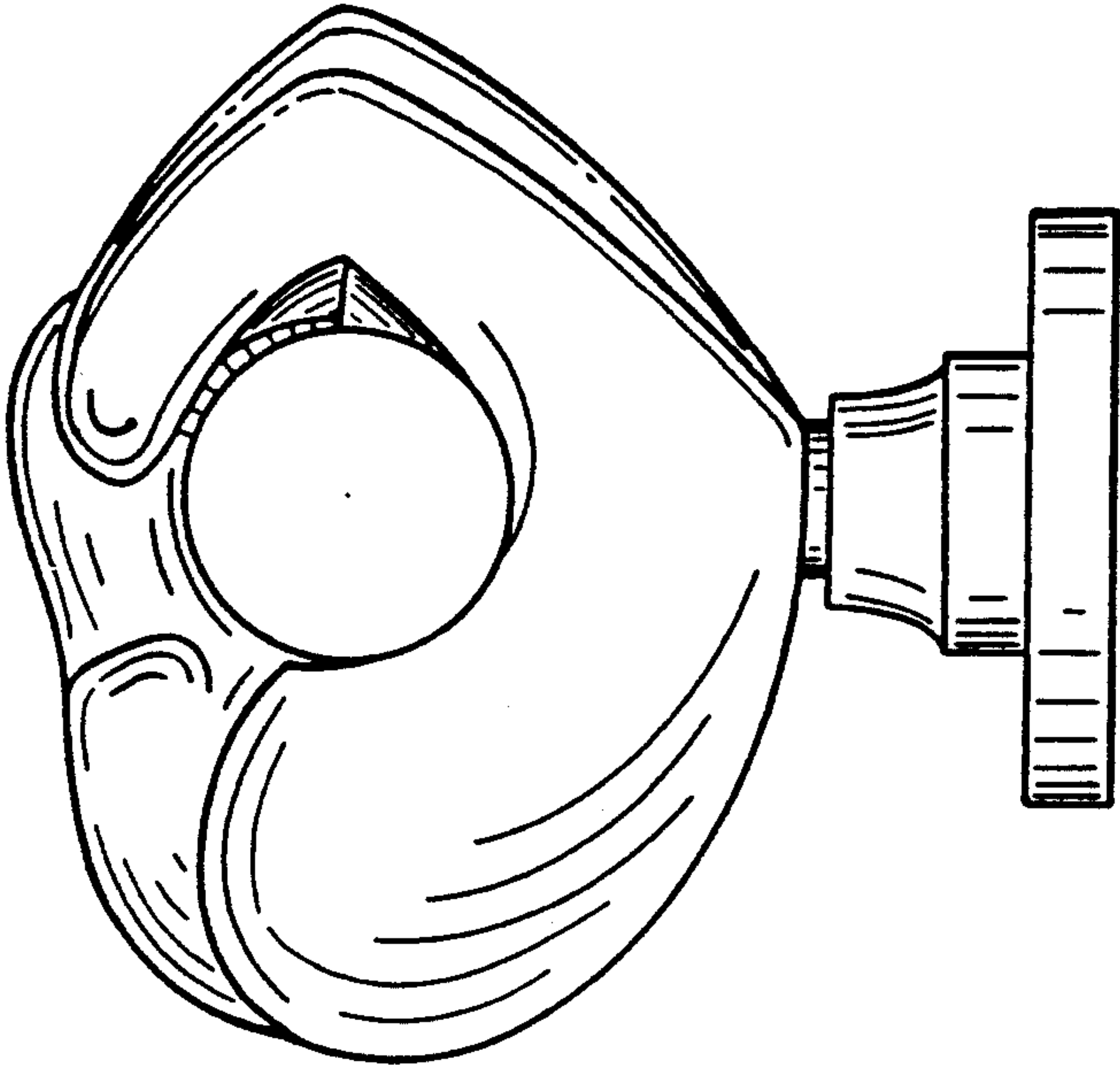

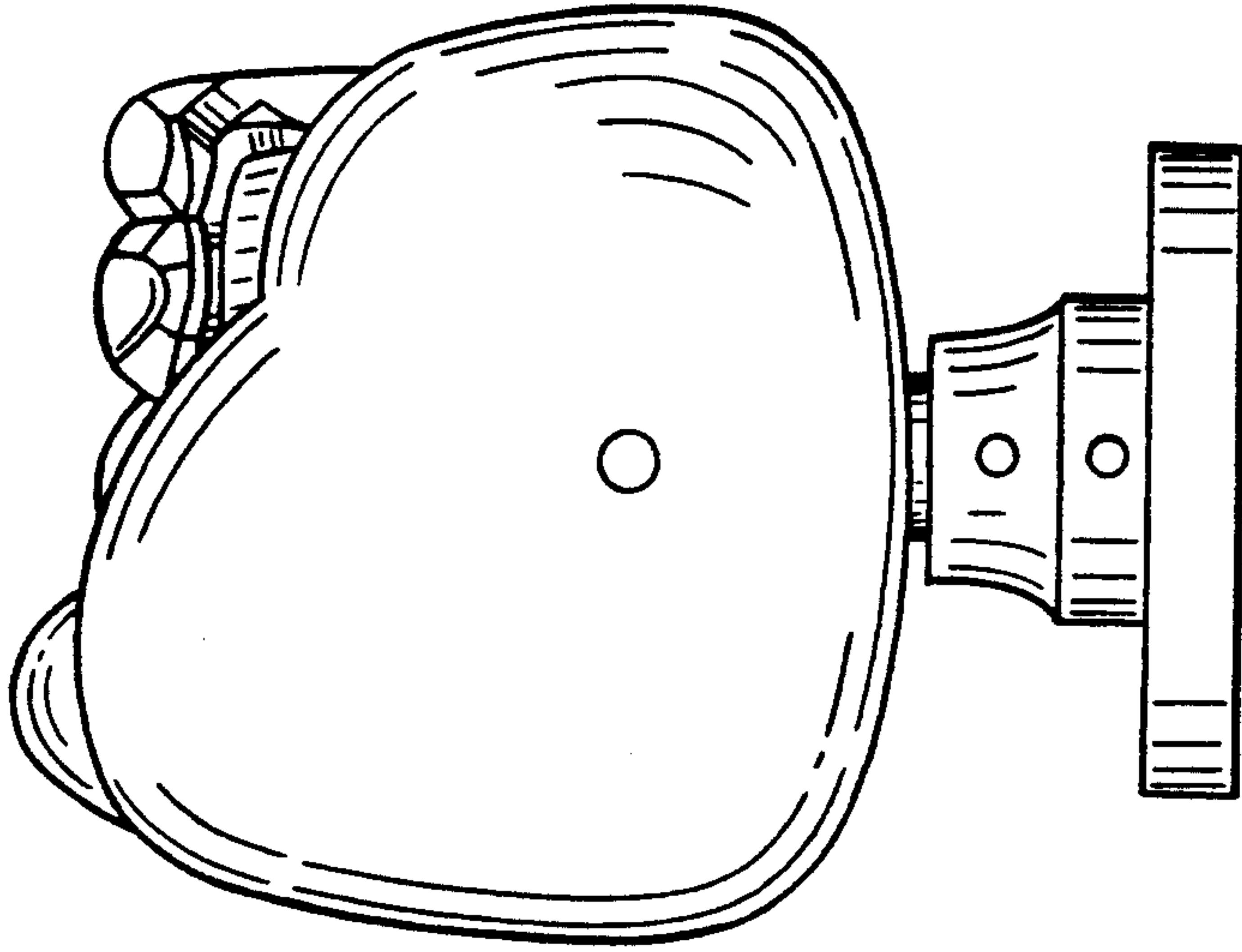

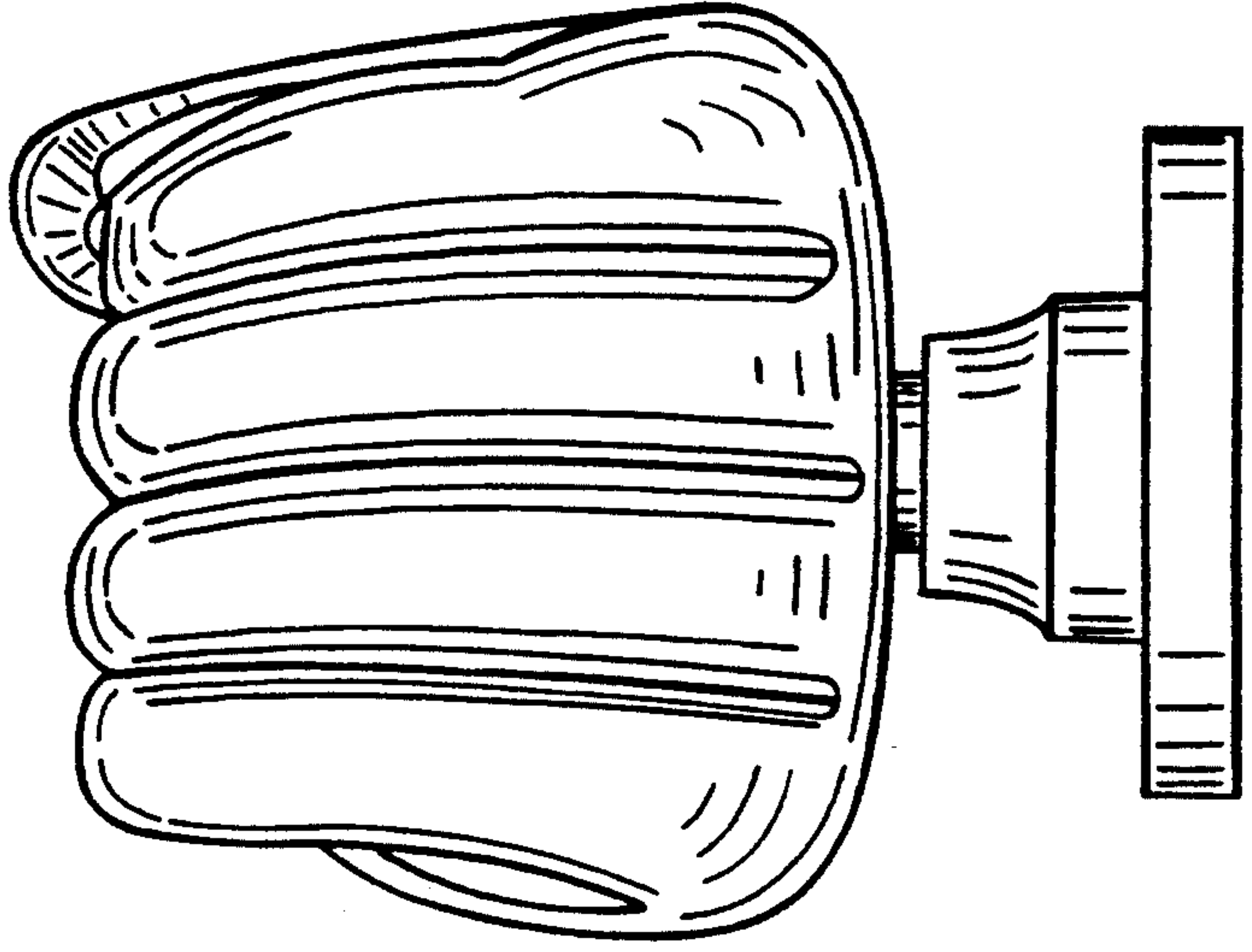
