The ornamental design for a telephone handset, as shown and described.

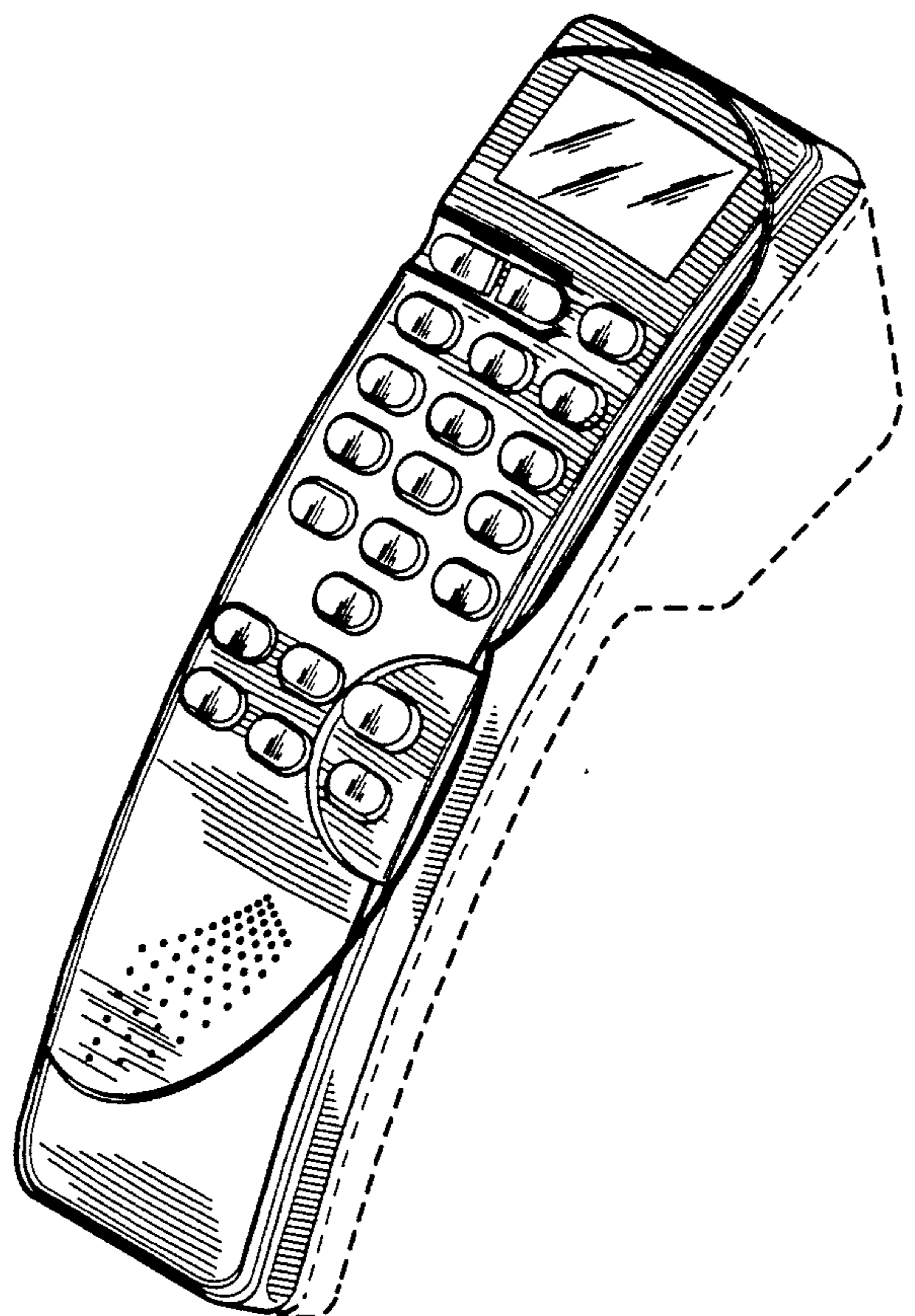
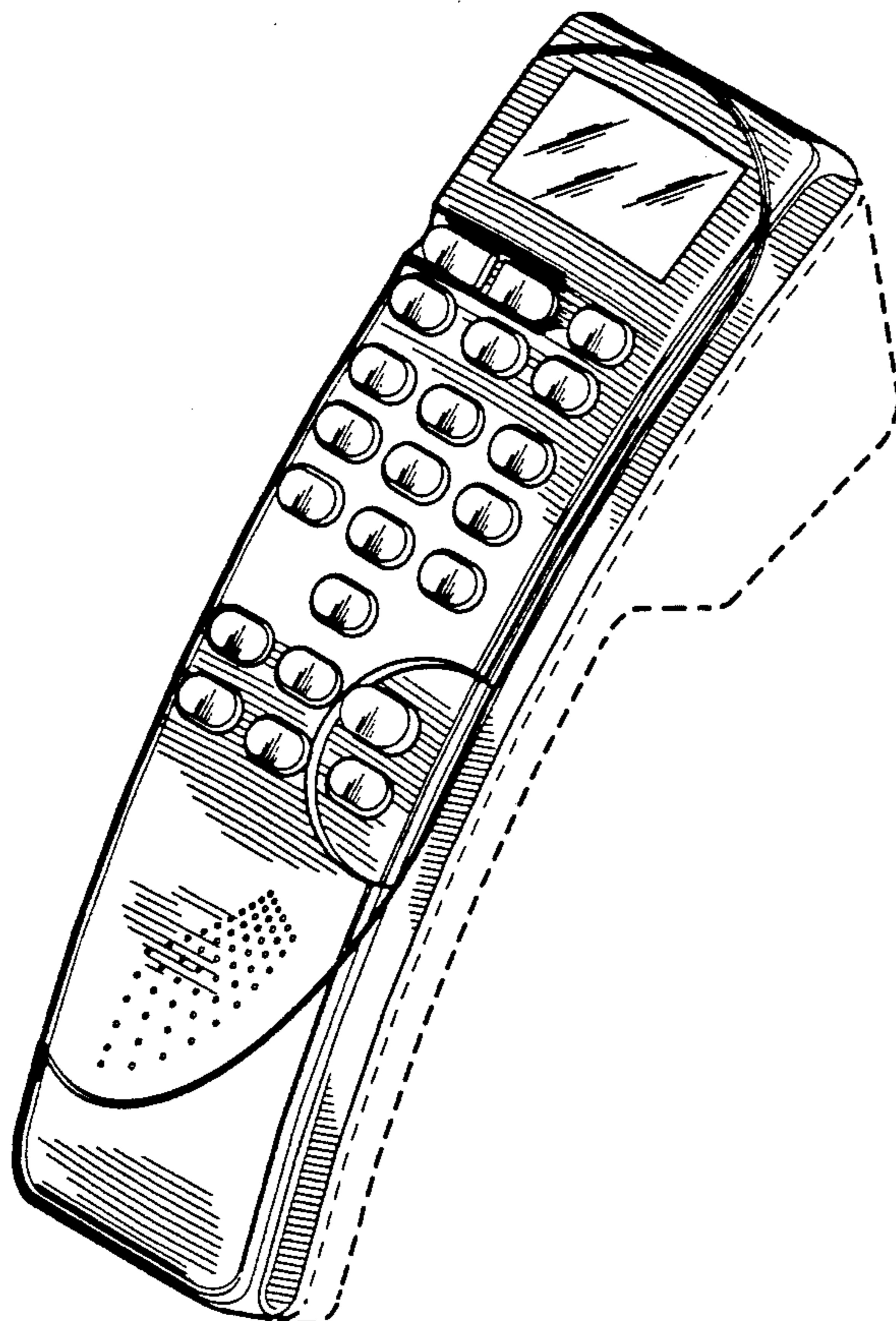
### DESCRIPTION

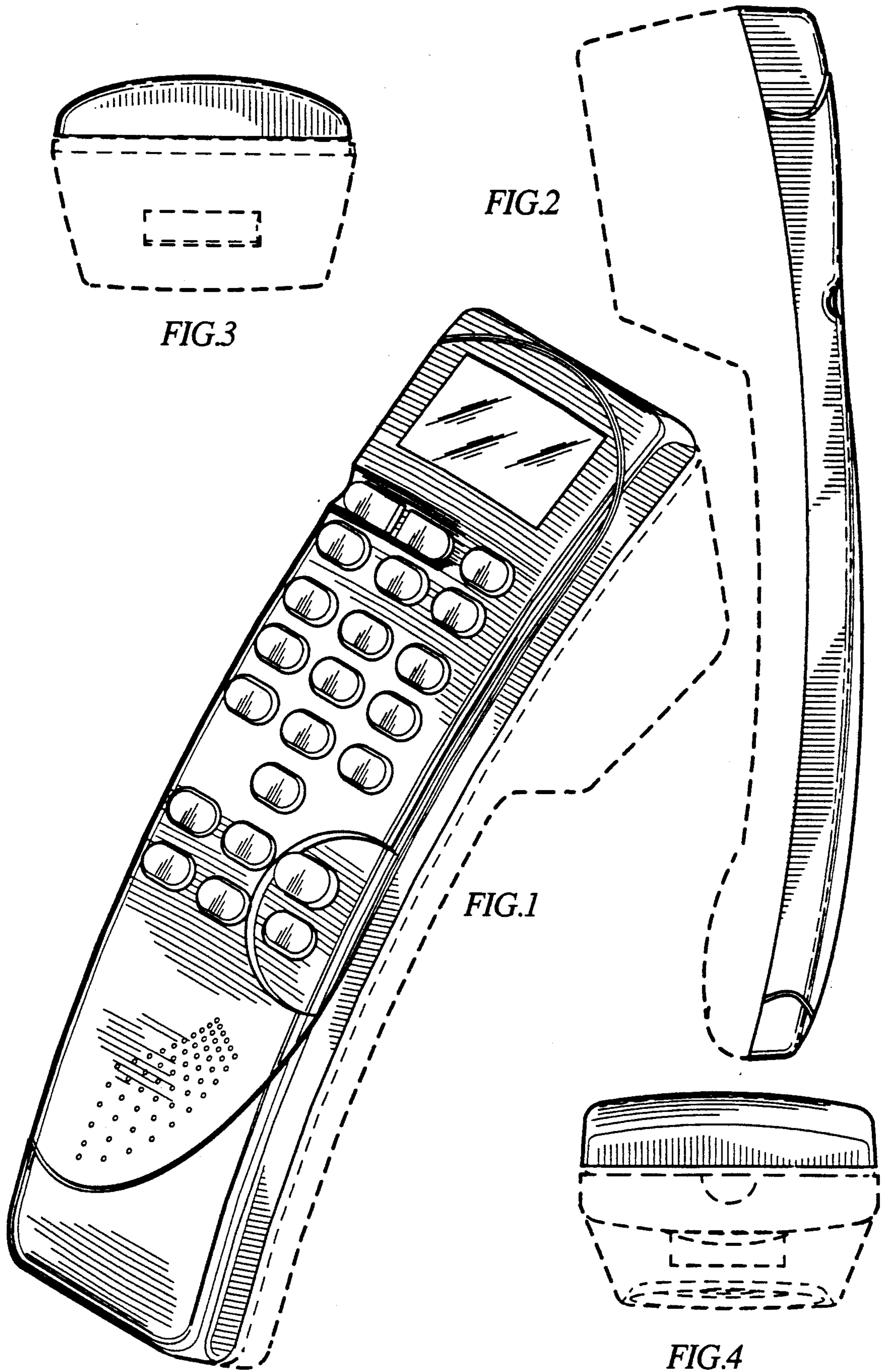

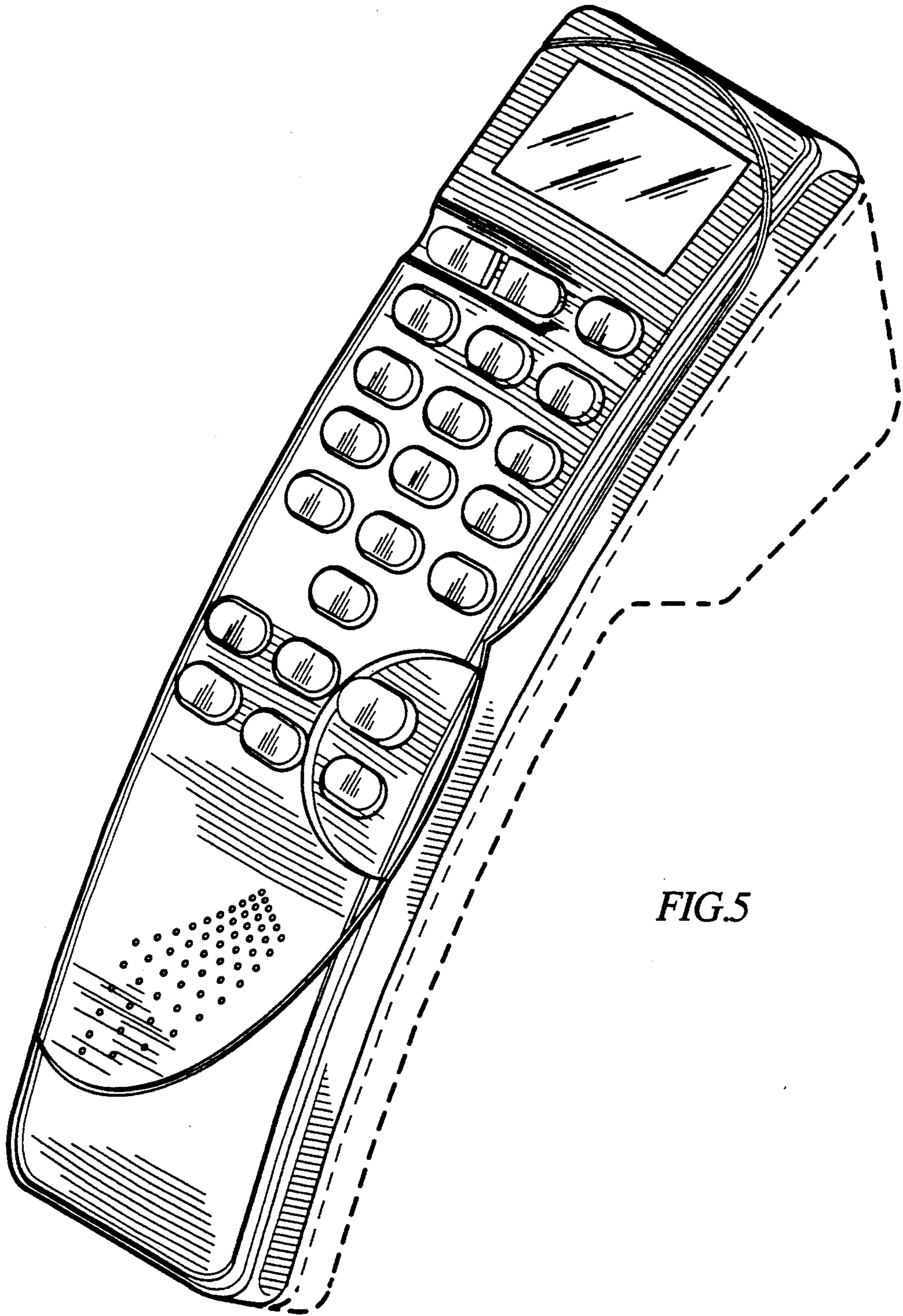
