The ornamental design for a male erection sustainer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the male erection sustainer design of the present invention;  
 FIG. 2 is a front elevational view thereof, the rear elevational view being identical;  
 FIG. 3 is a side elevational view thereof; and,  
 FIG. 4 is a bottom plan view thereof, the top view being identical.

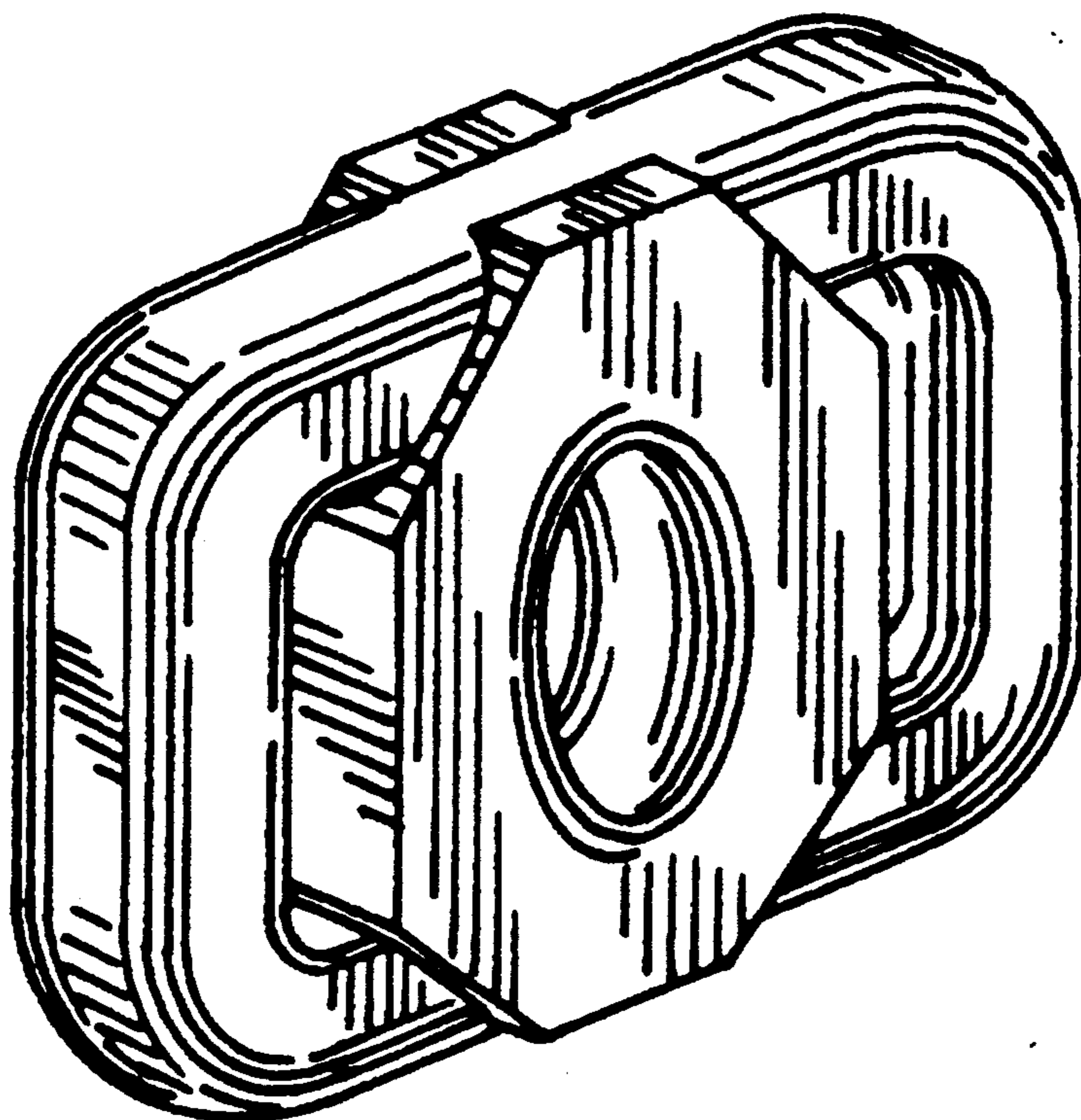

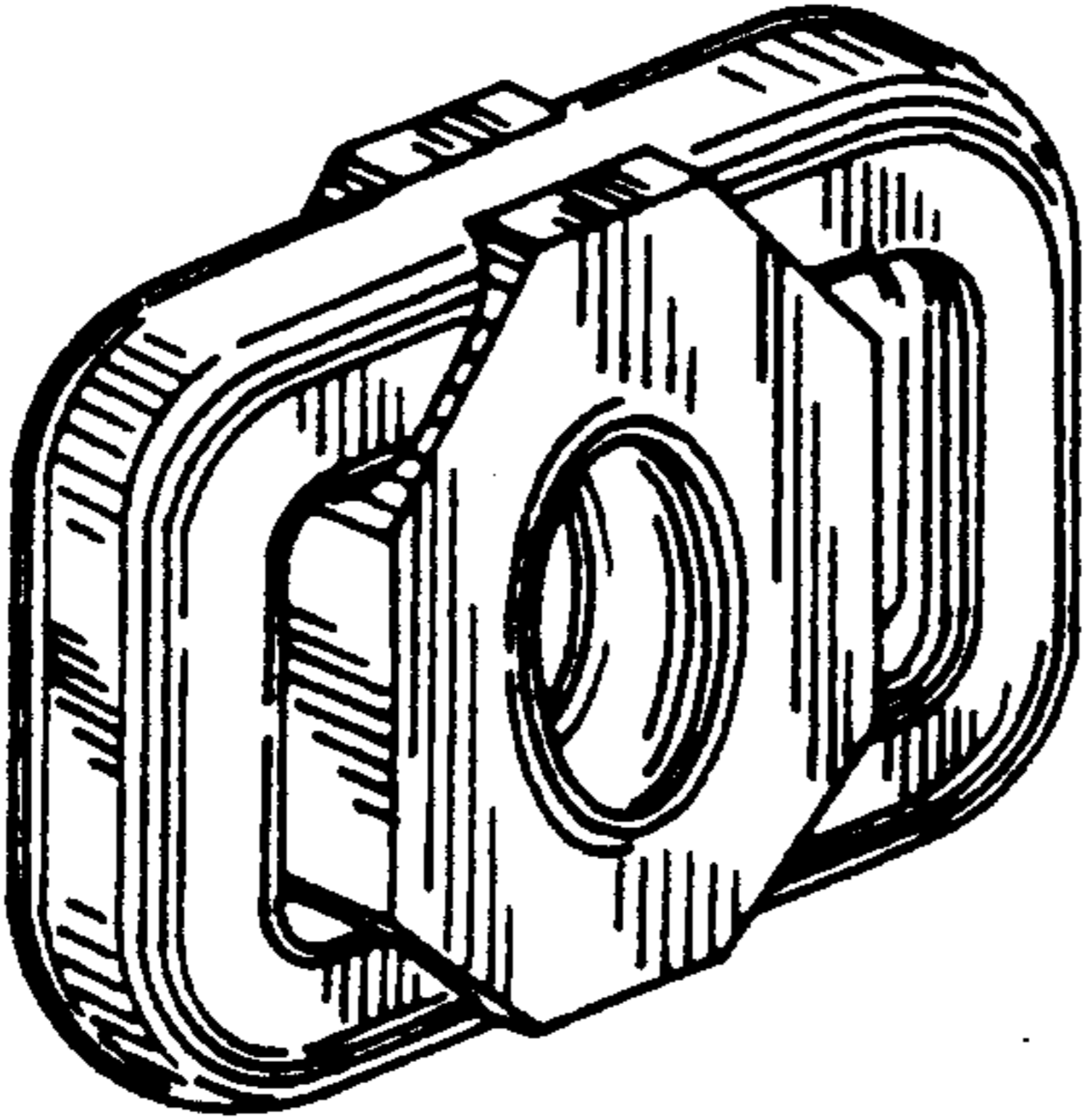
